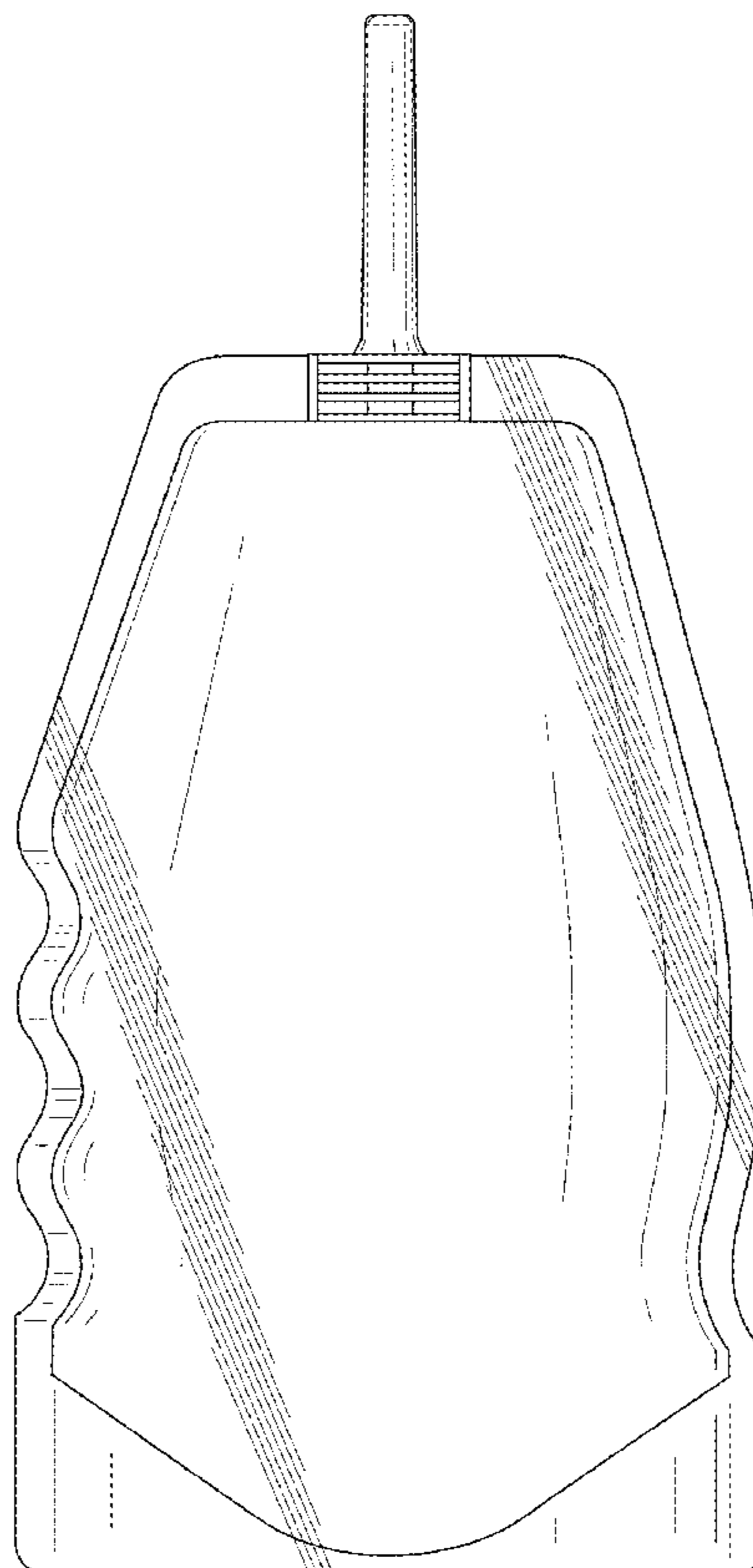
(57) **CLAIM**

I claim, the ornamental design for a hygienic douche, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a hygienic douche;
 FIG. 2 is a left side view of the hygienic douche of FIG. 1;
 FIG. 3 is a right side view of the hygienic douche in a ready-for-use position;
 FIG. 4 is a top plan view of the hygienic douche shown in FIG. 3;
 FIG. 5 is a bottom plan view of the hygienic douche shown in FIG. 3; and,
 FIG. 6 is a perspective view of the hygienic douche in a ready-for-use position.
 The broken lines shown in FIG. 4 and FIG. 6 illustrate portions of the hygienic douche that form no part of the claimed design.

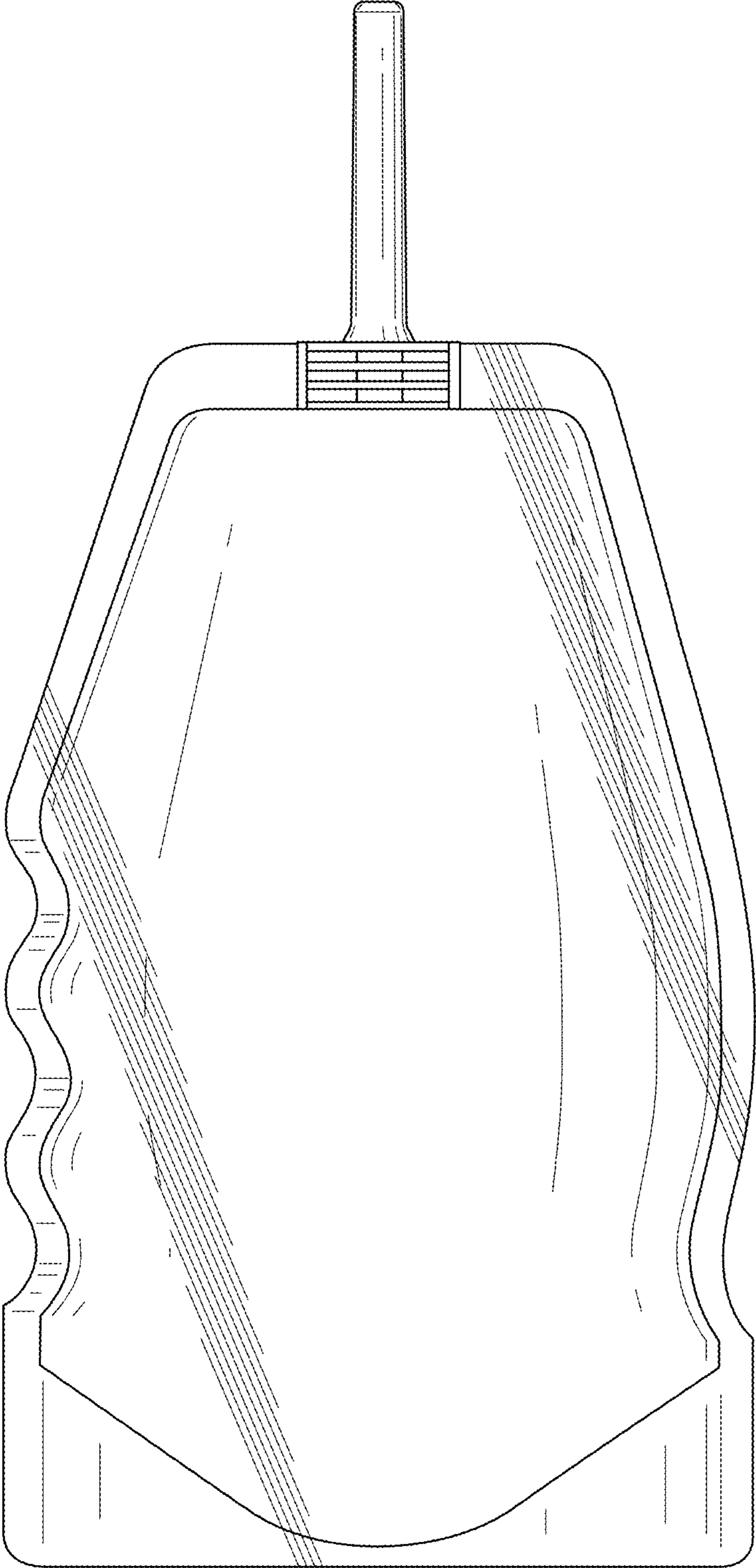

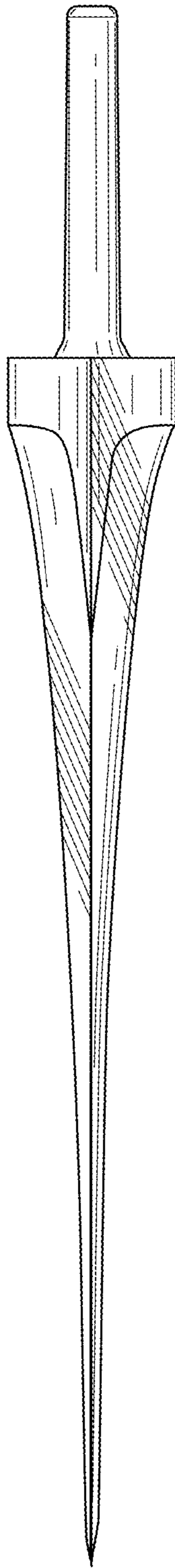

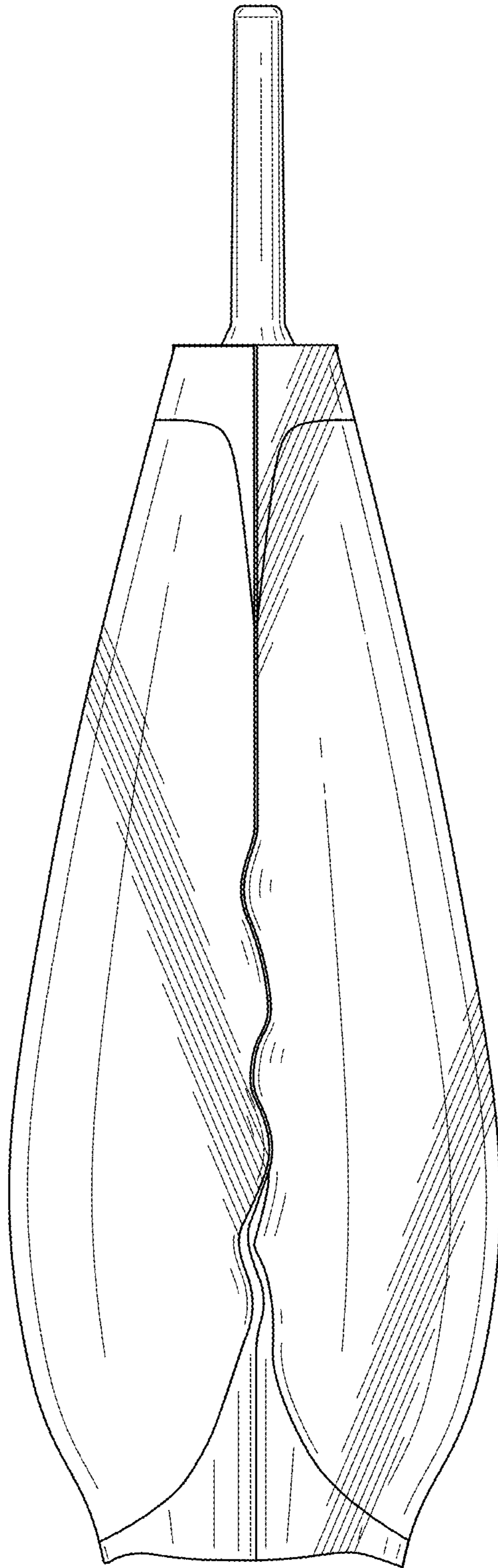

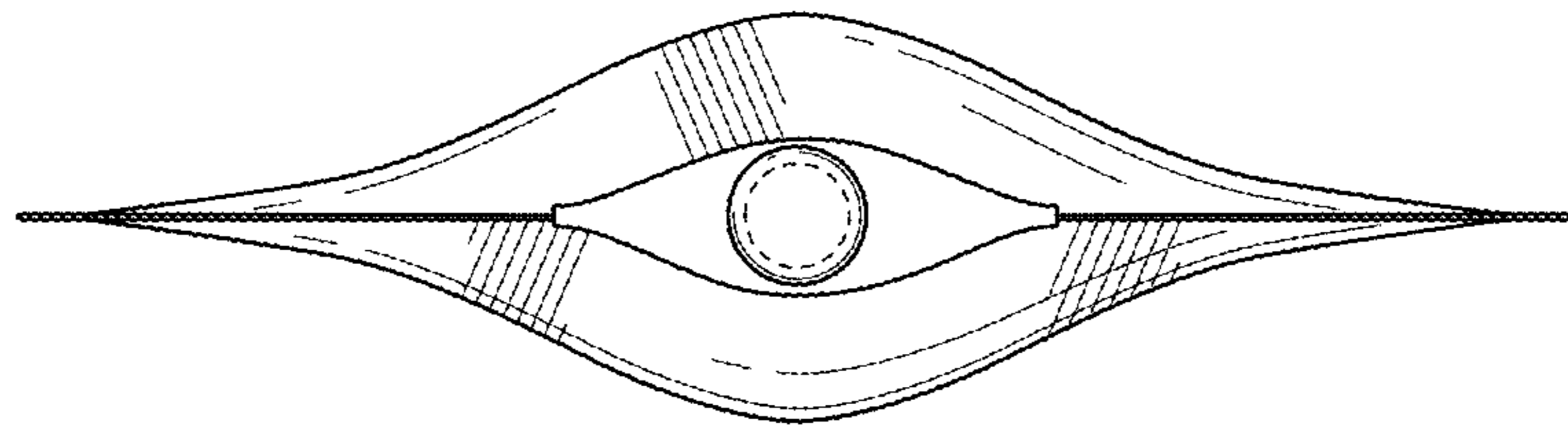

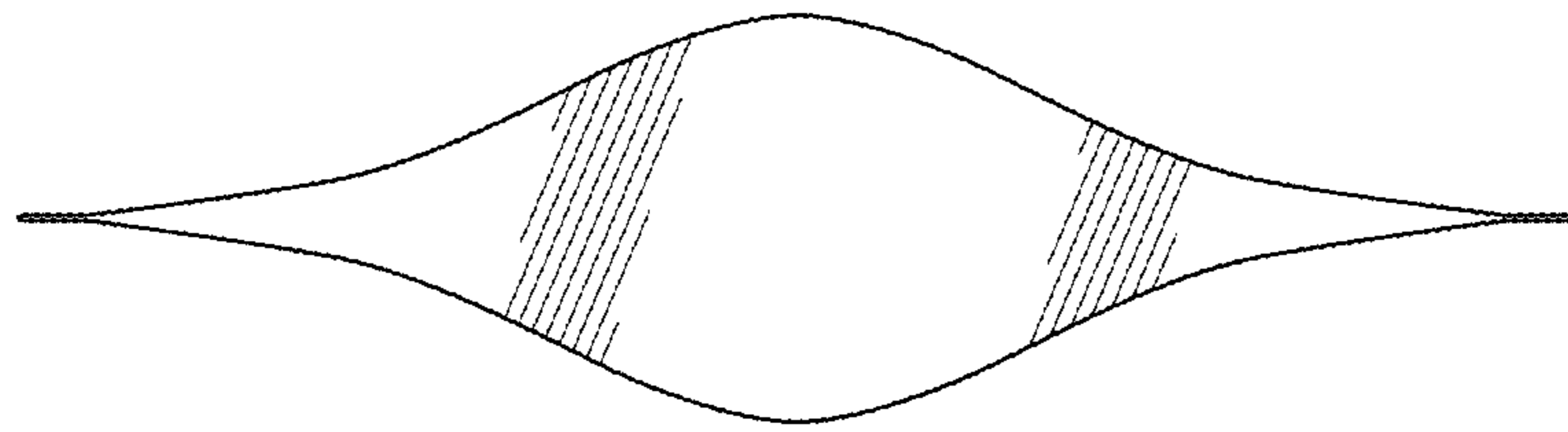

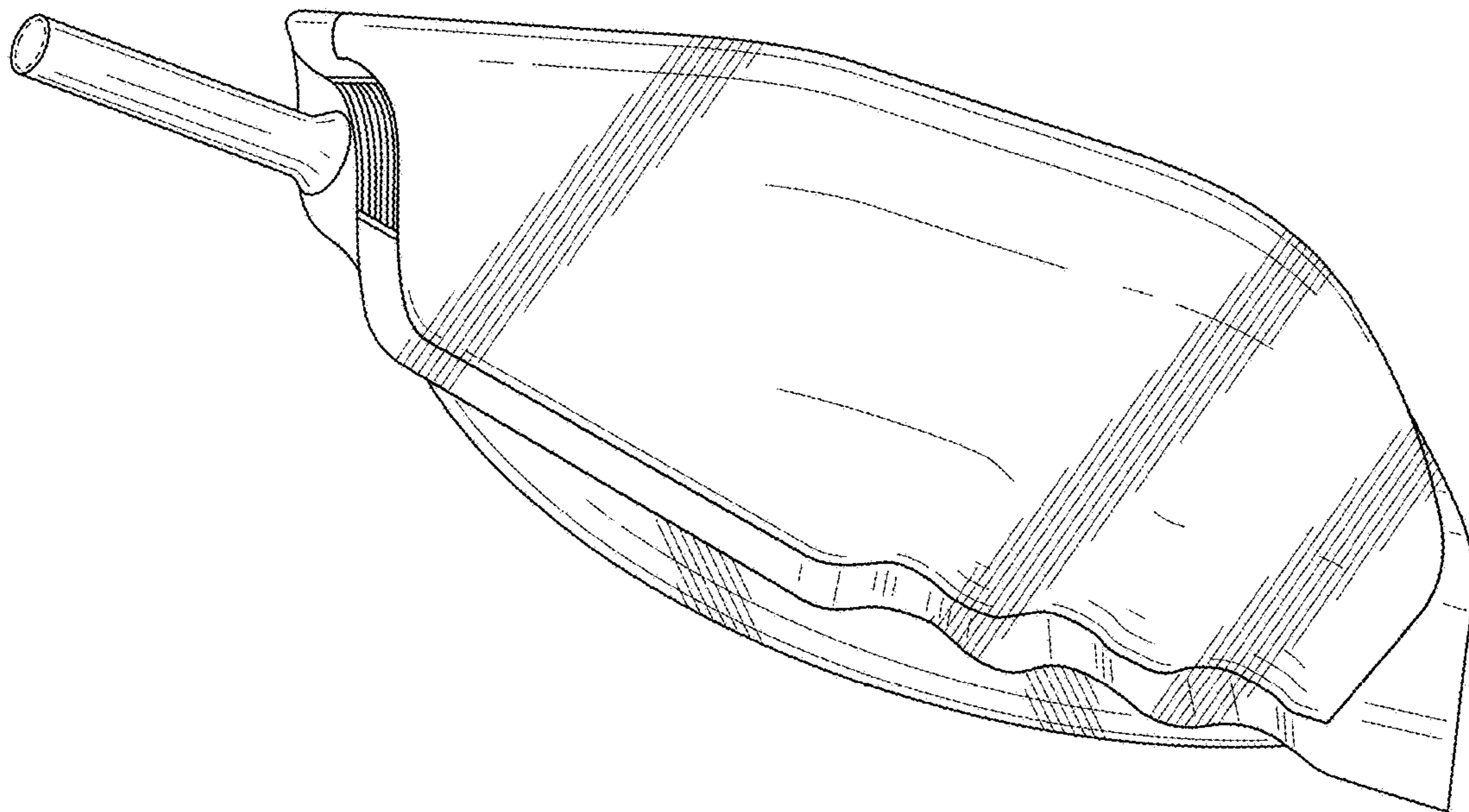
