(57) **CLAIM**

I claim the ornamental design for a neck laceration protector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the neck laceration protector of the claimed design;
FIG. 2 is a front elevational view of the claimed design shown in FIG. 1;
FIG. 3 is a top elevational view of the claimed design shown in FIG. 1;
FIG. 4 is a bottom elevational view of the claimed design shown in FIG. 1;
FIG. 5 is a right side elevational view of the claimed design shown in FIG. 1;
FIG. 6 is a left side elevational view of the claimed design shown in FIG. 1;
FIG. 7 is a back elevational view of the claimed design shown in FIG. 1; and,
FIG. 8 is a perspective view of the claimed design of FIG. 1, showing how it is used.

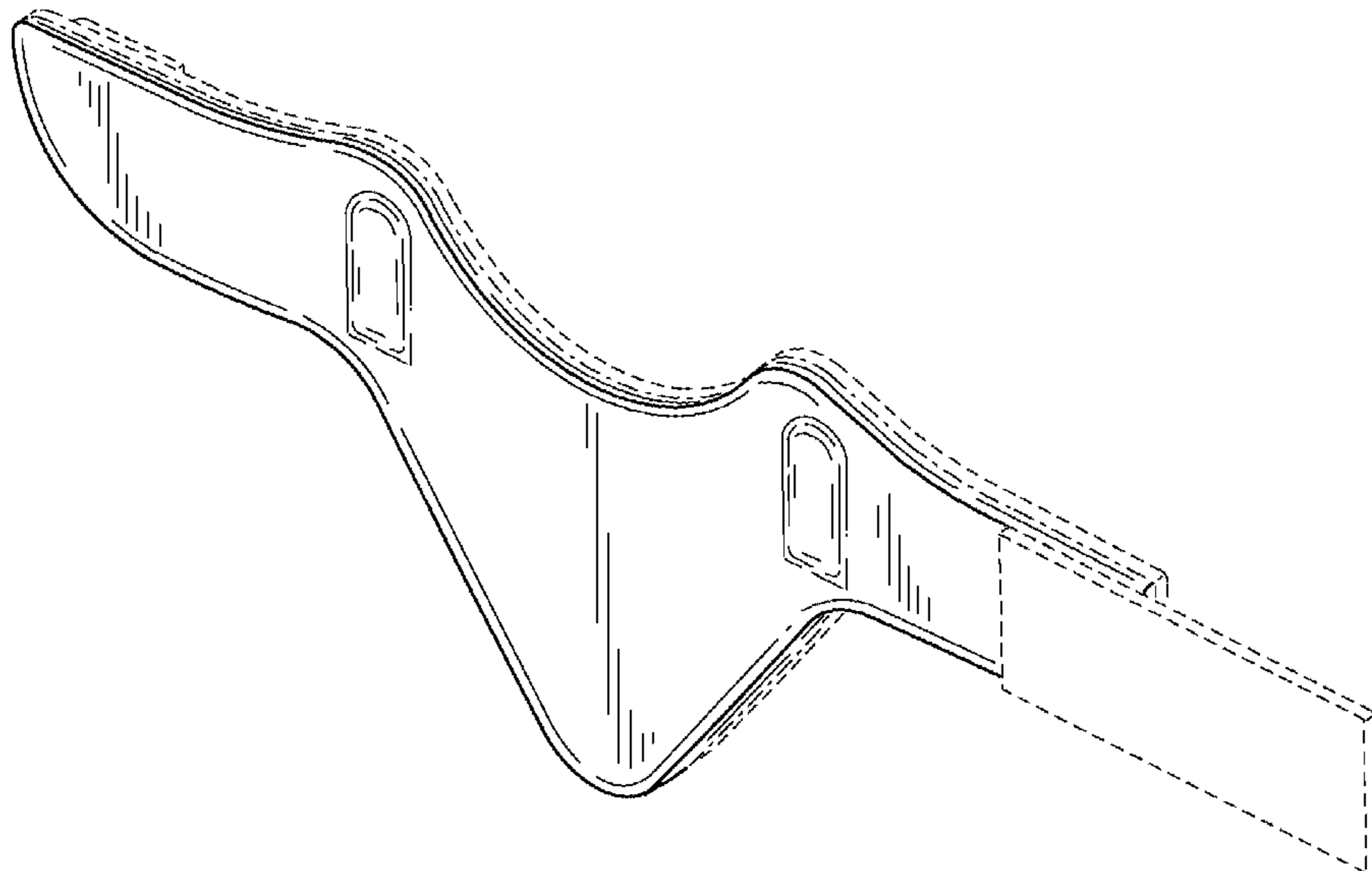

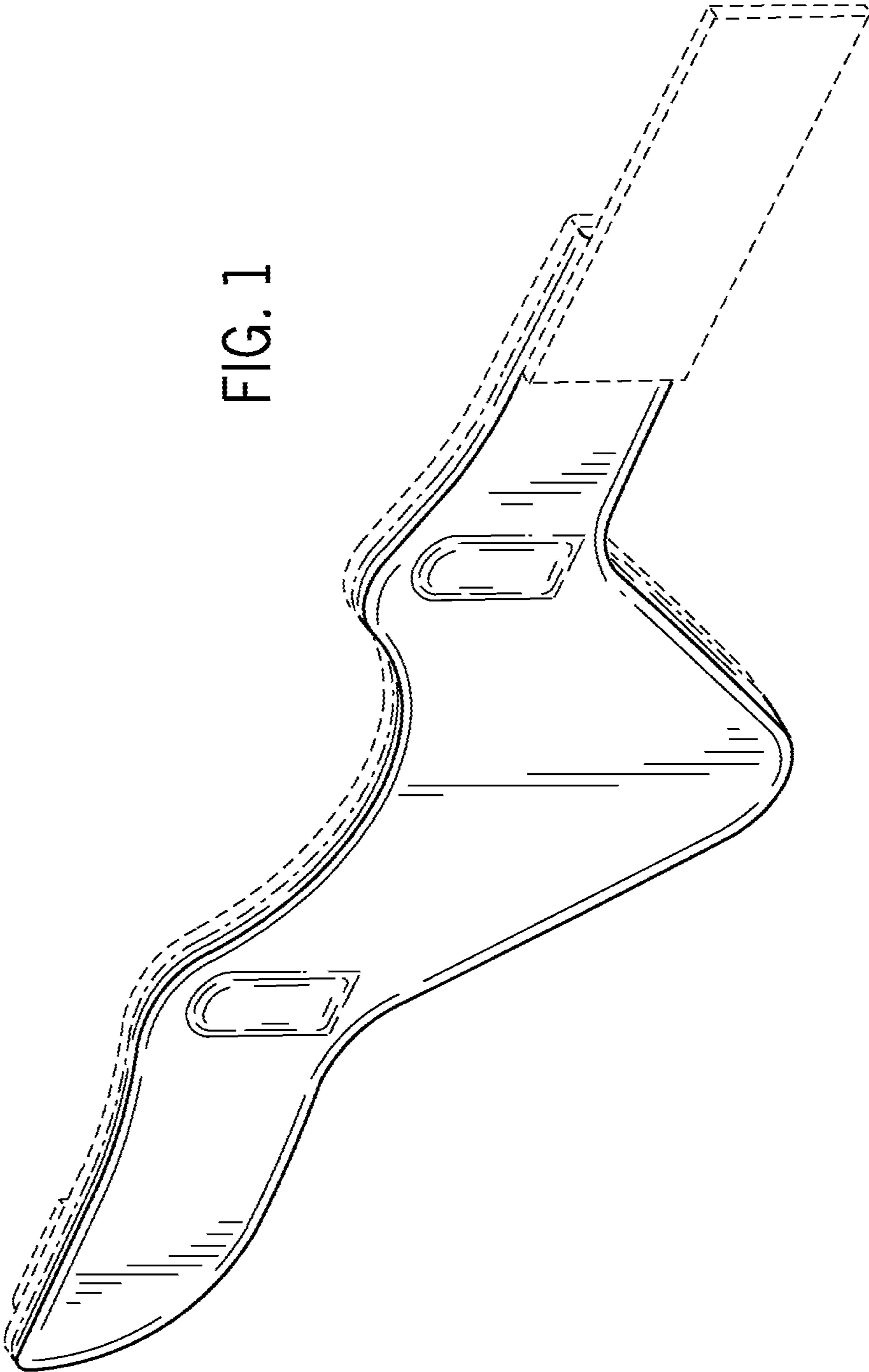

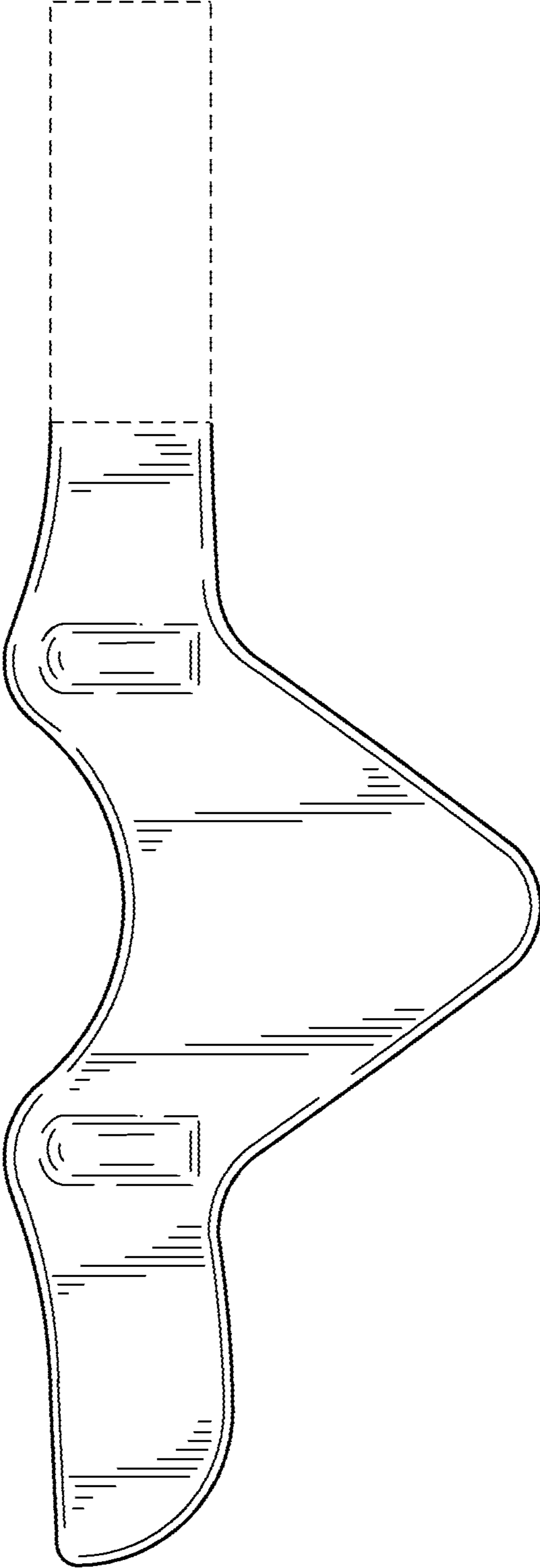
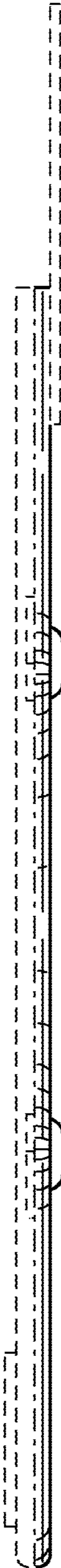

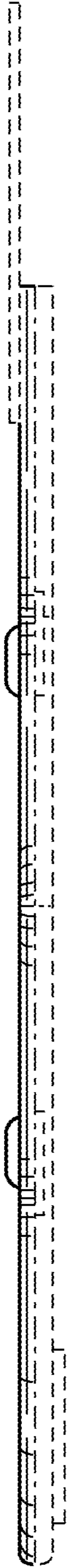

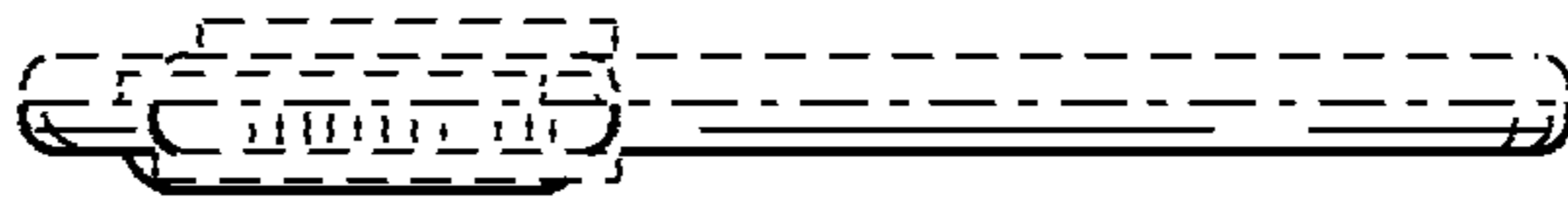

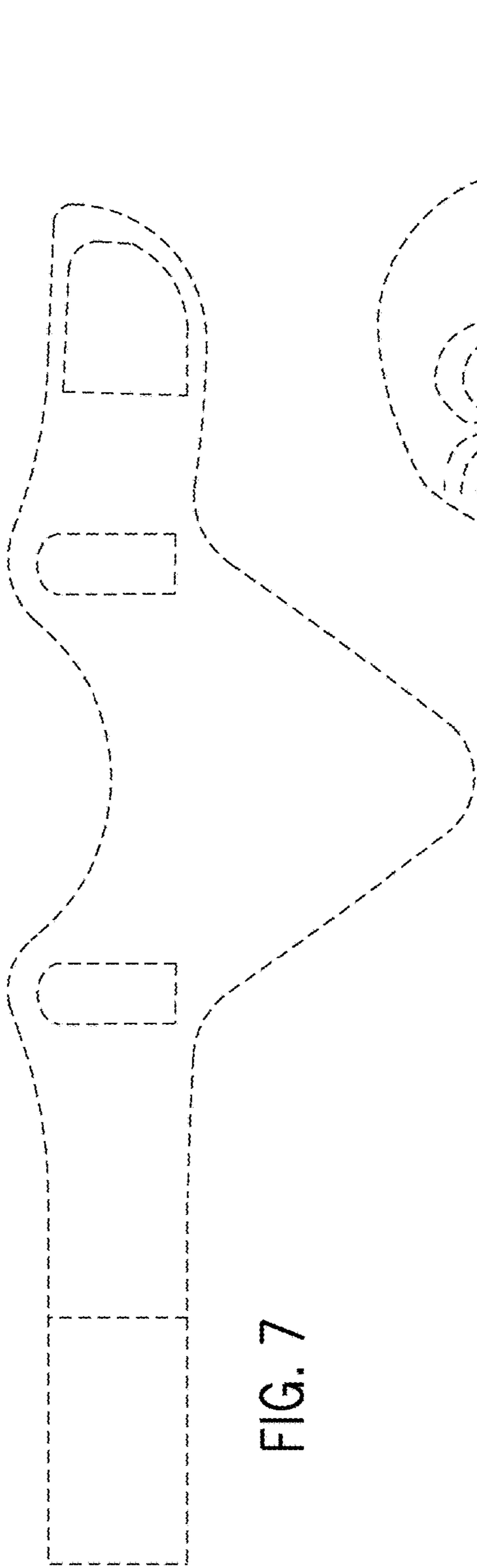

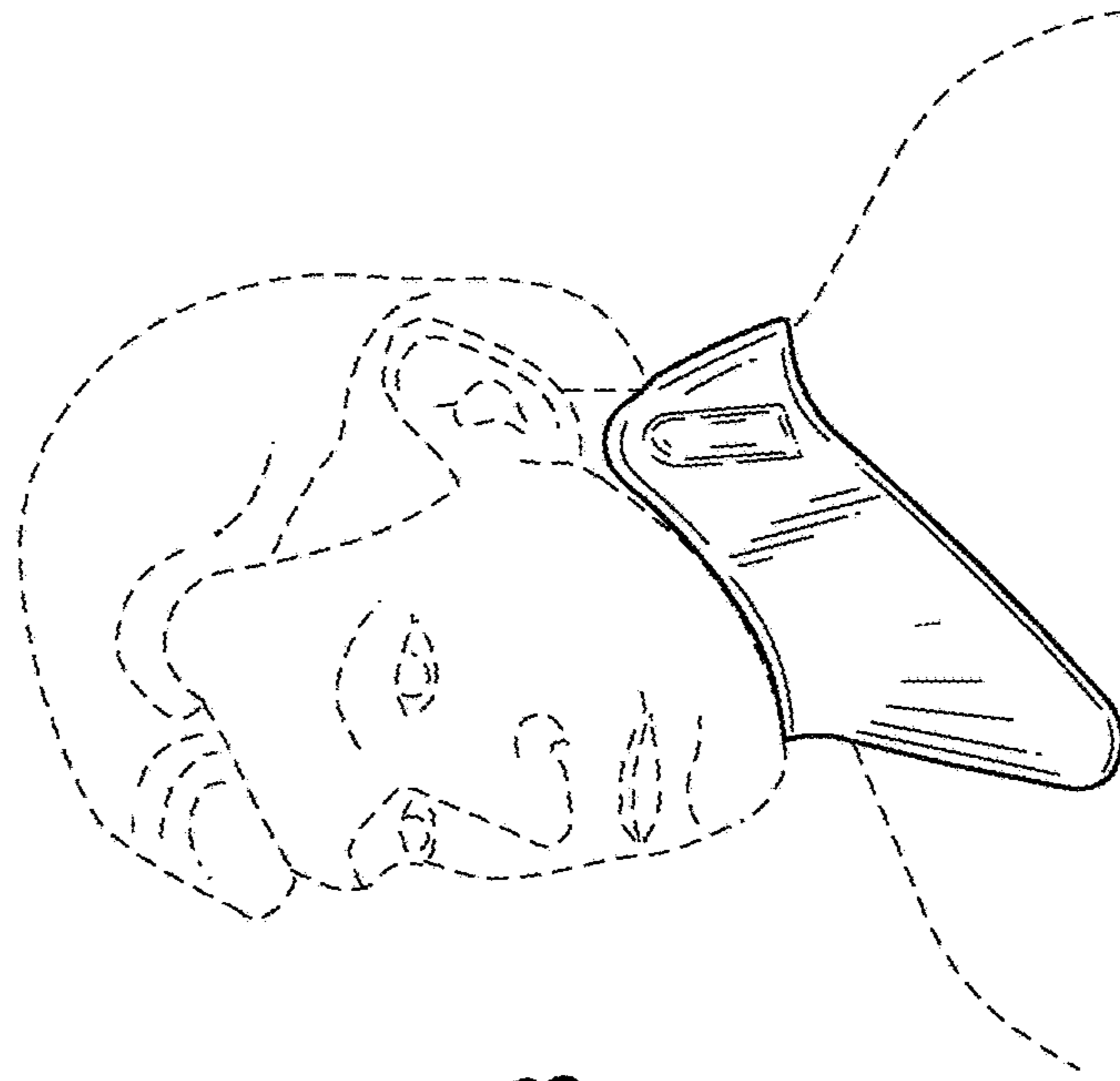
