(57) **CLAIM**

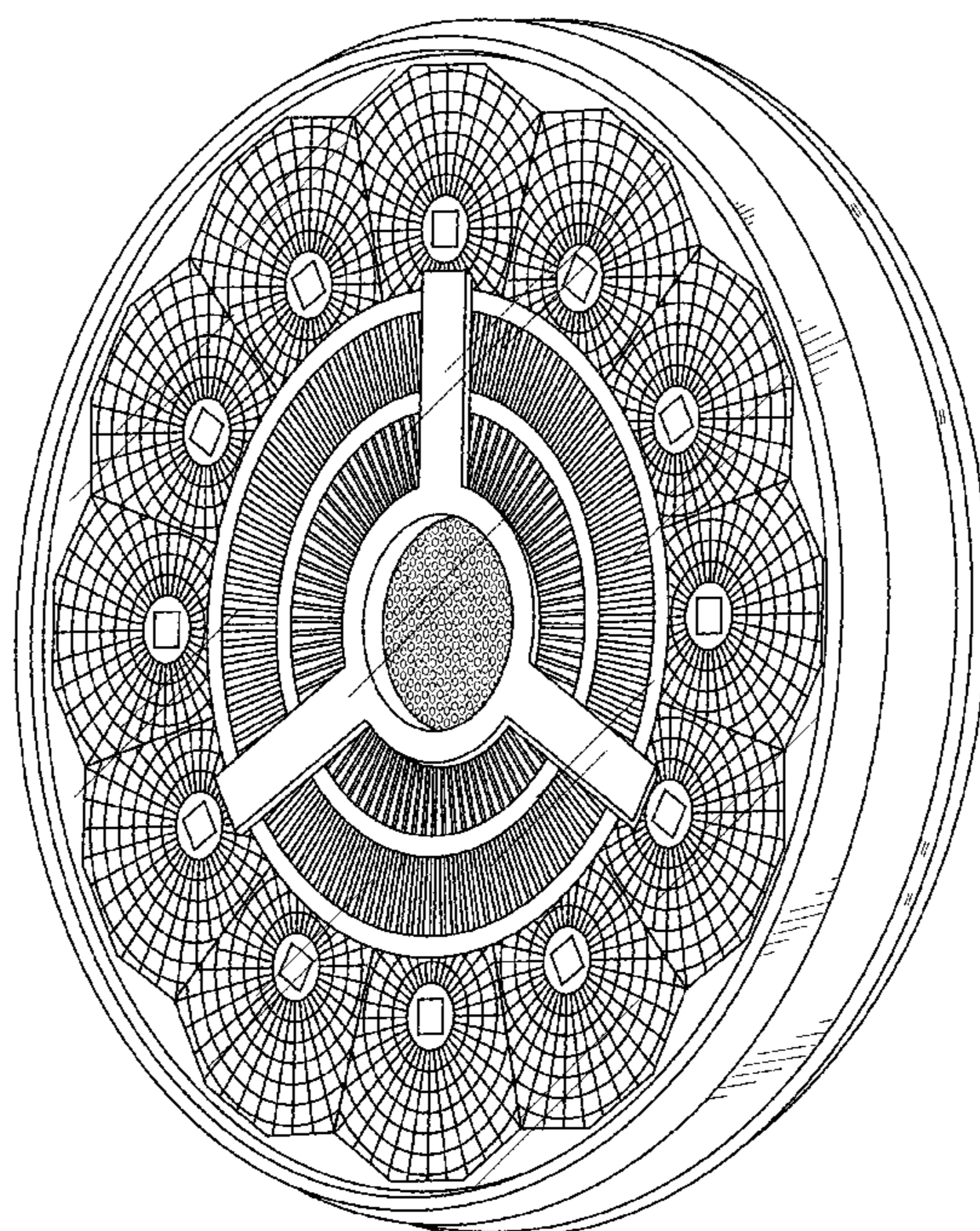
The ornamental design for a LED light, as shown and described.

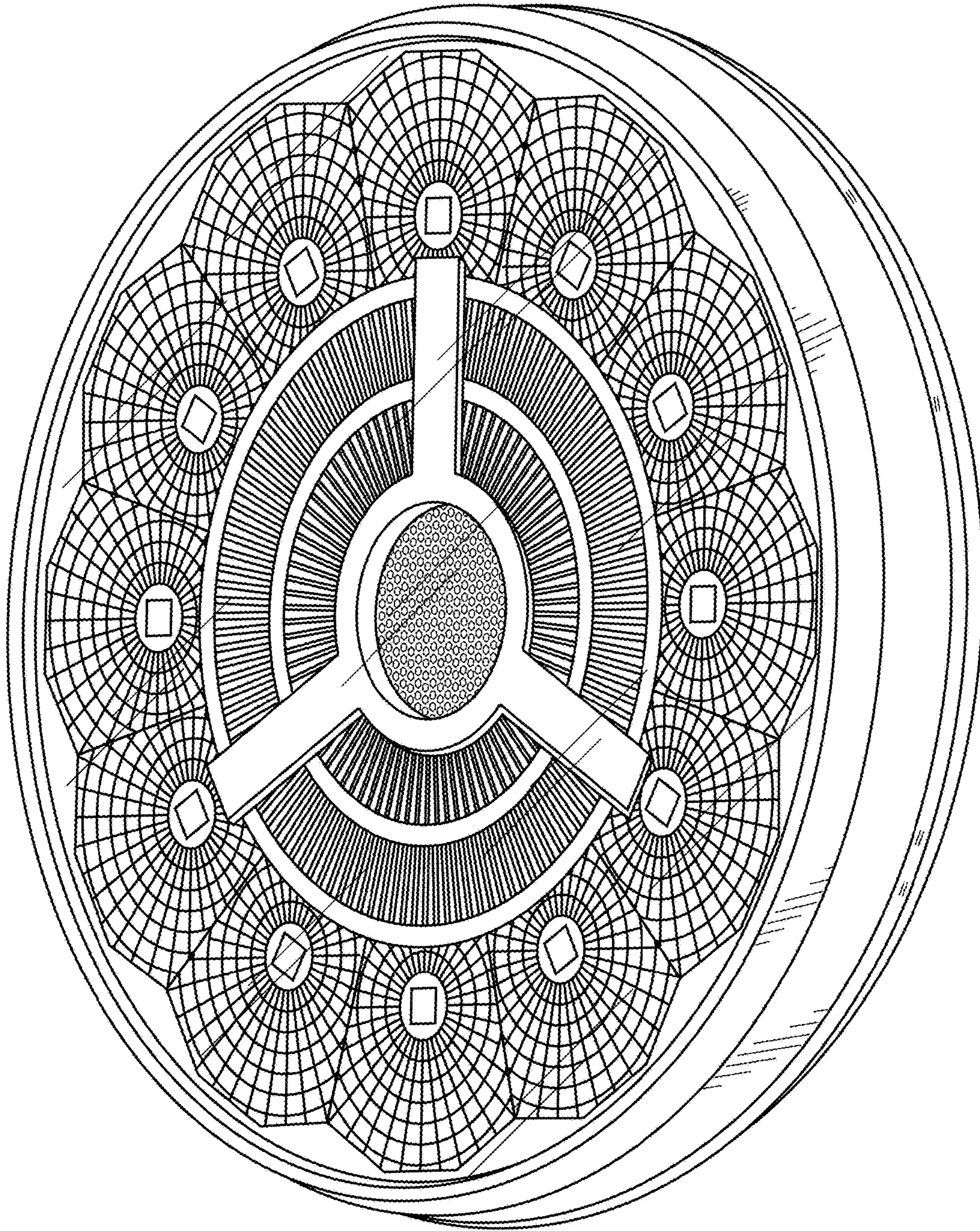

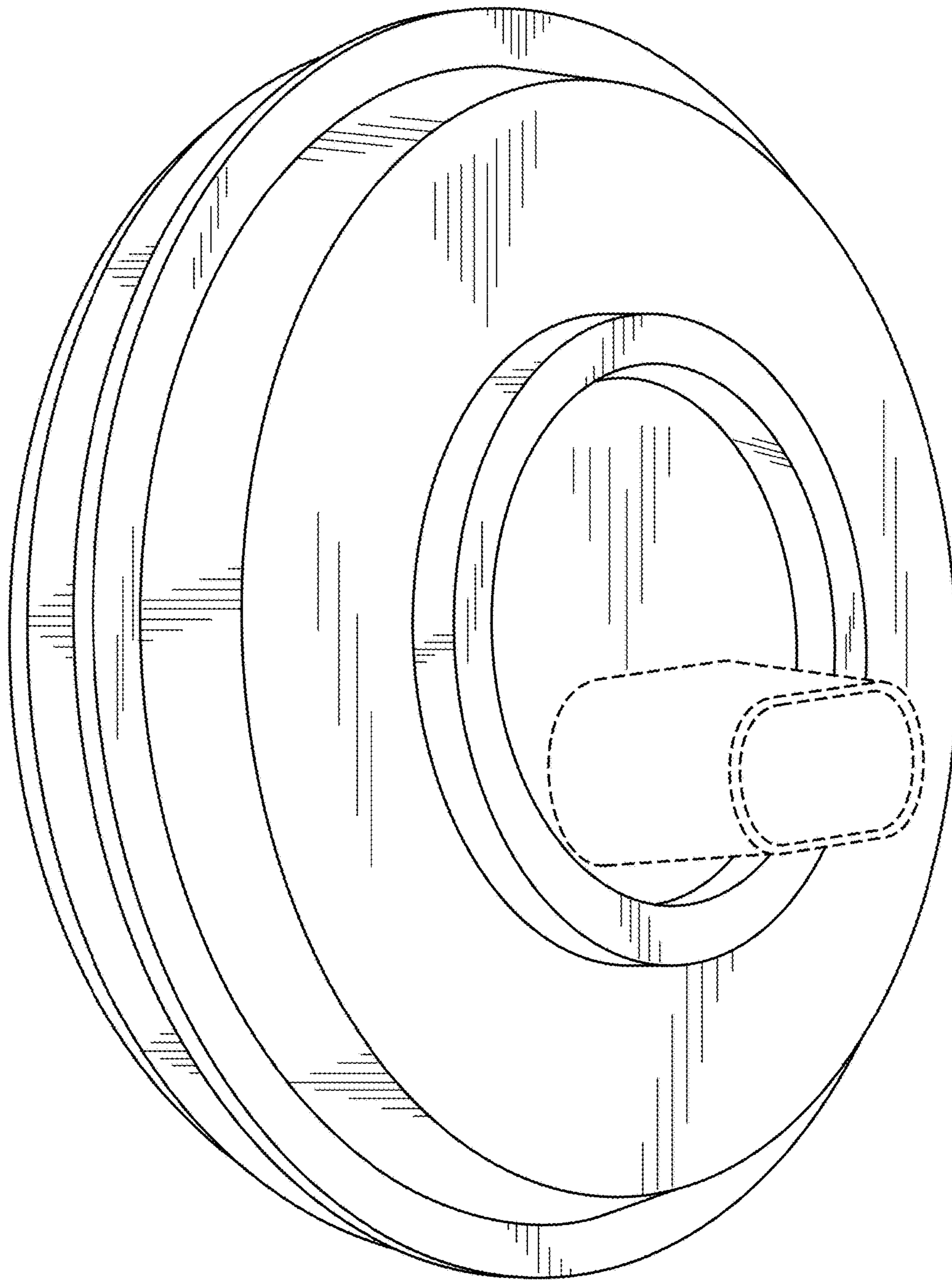

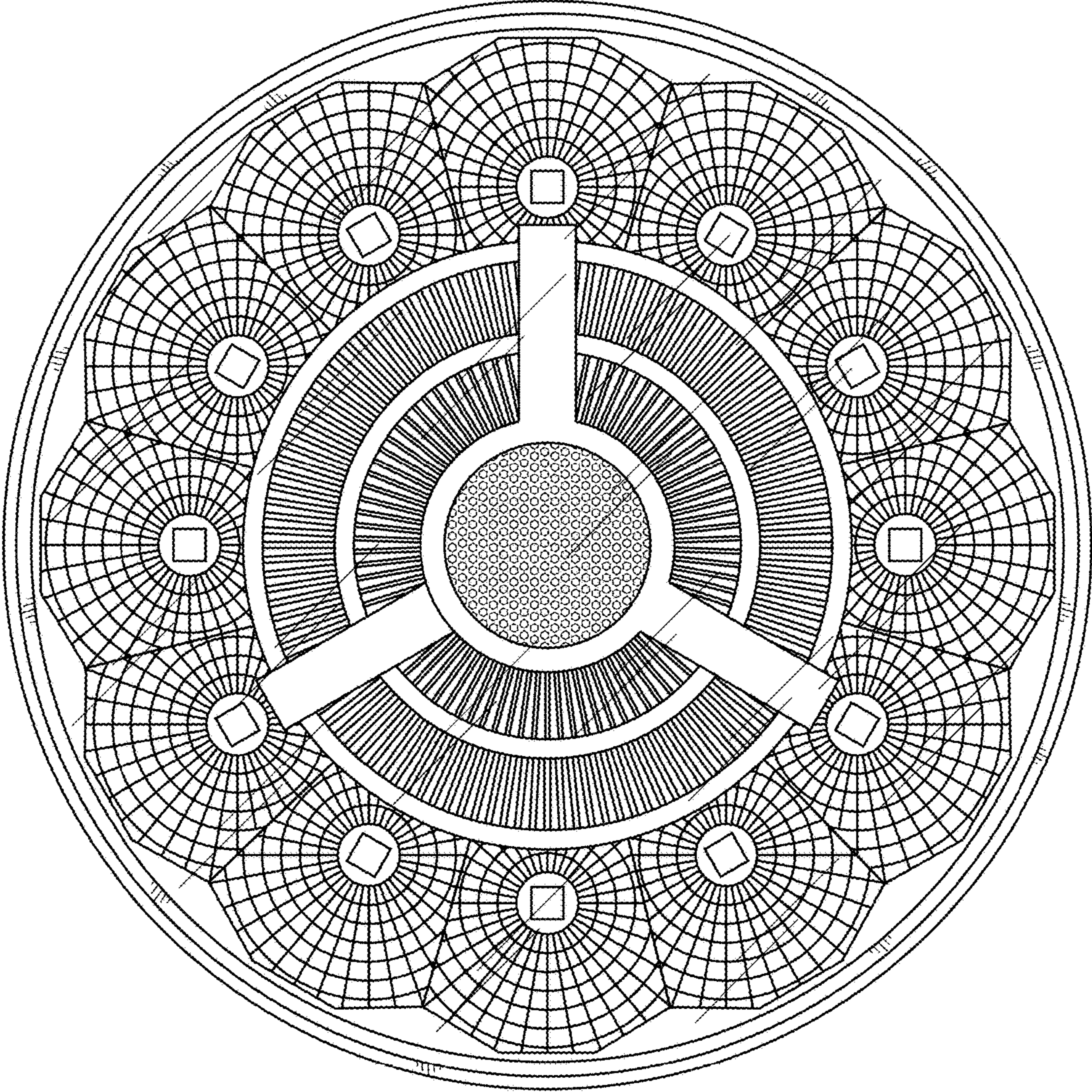

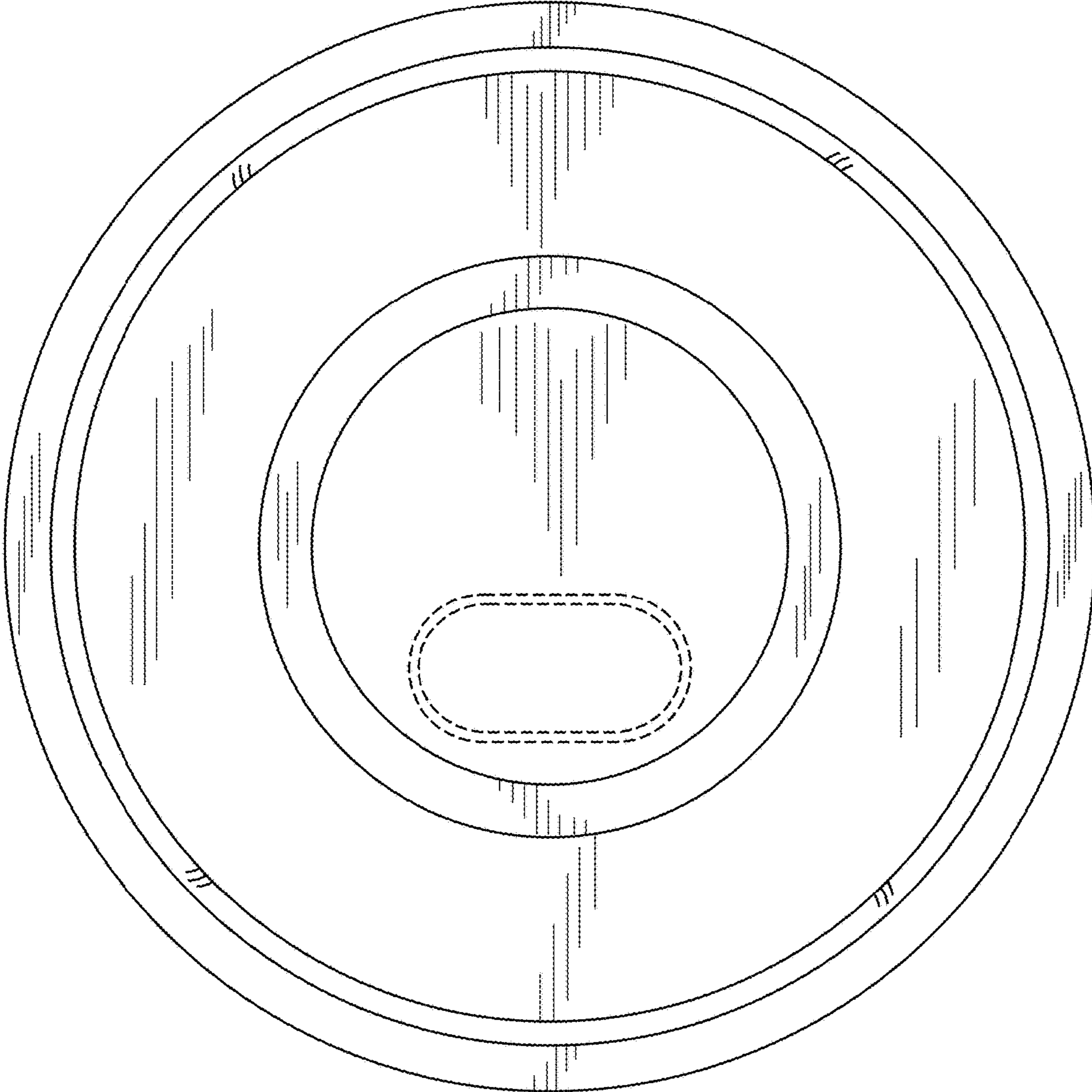

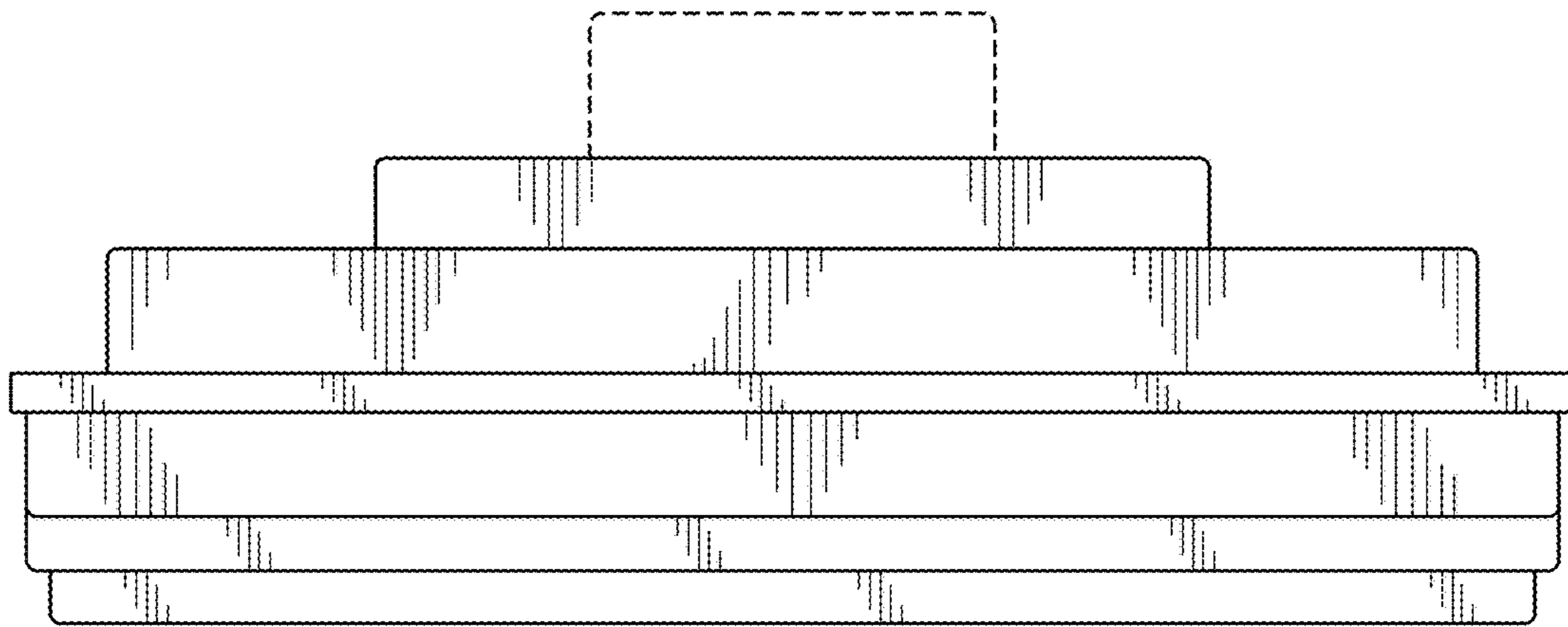

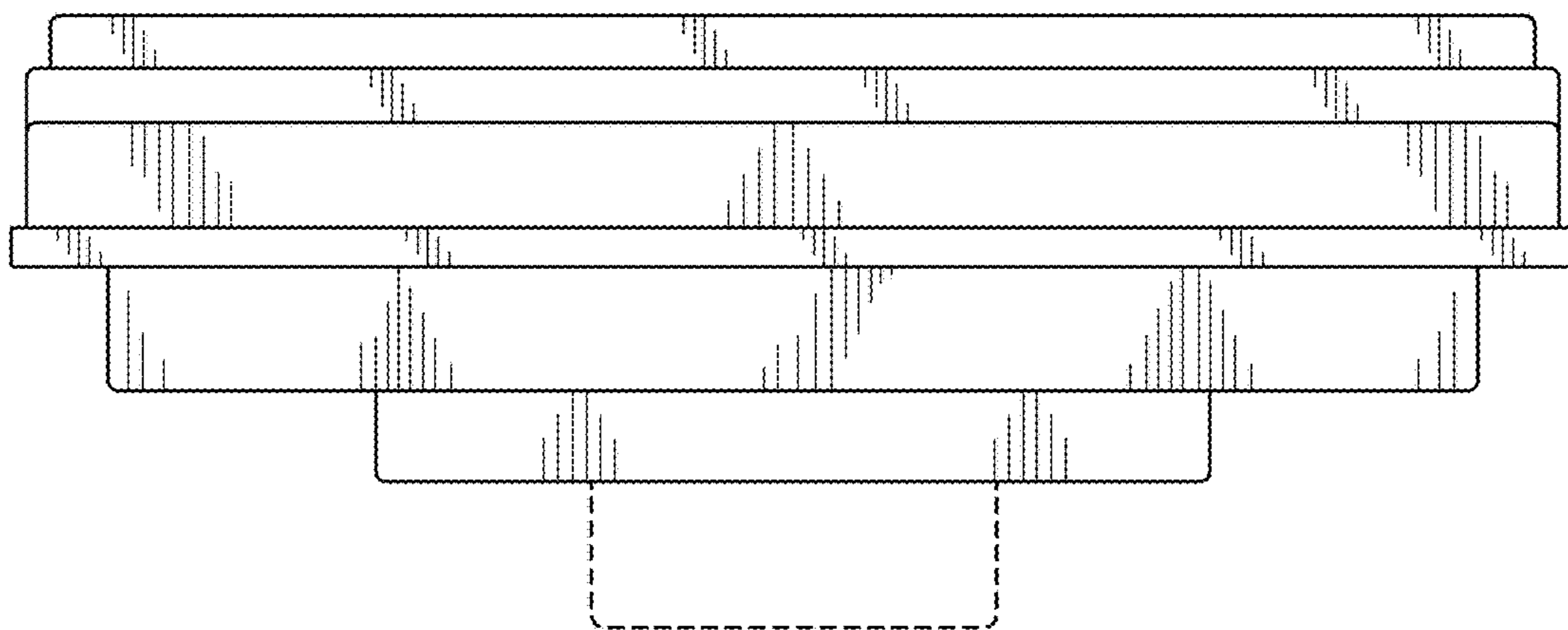

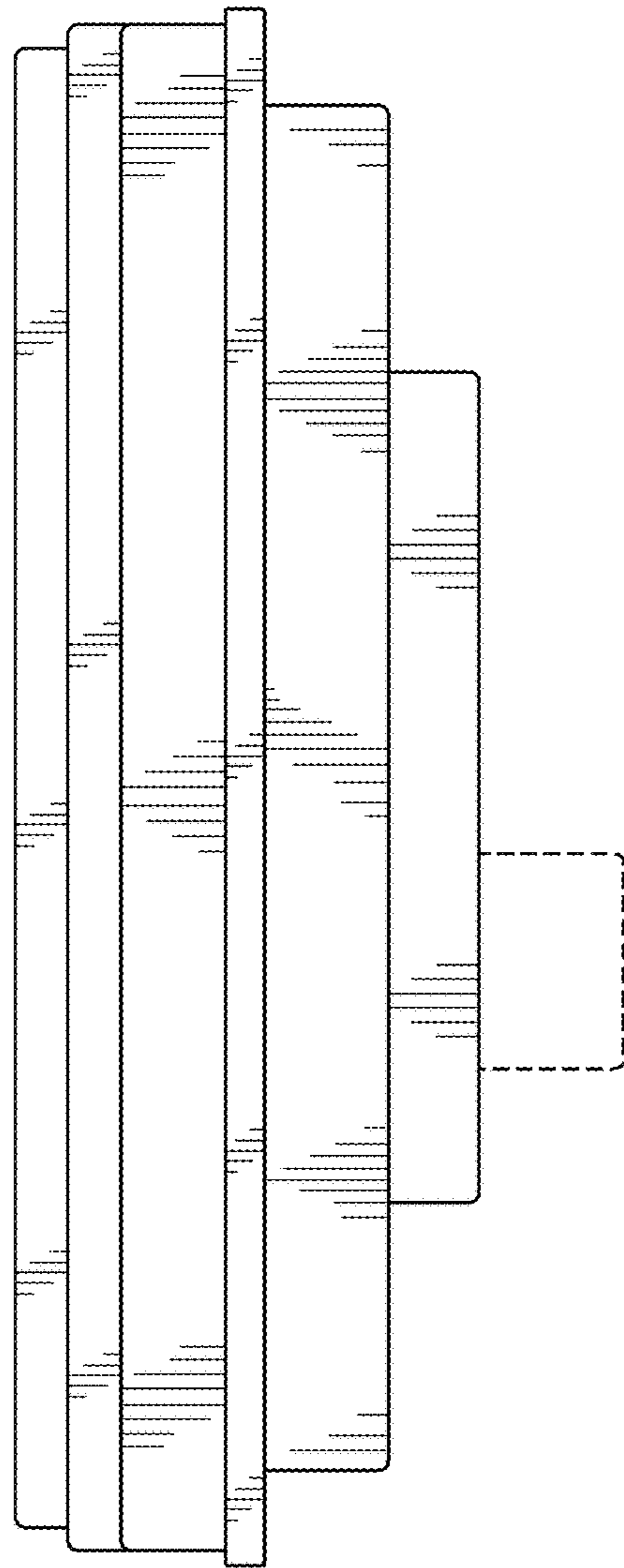

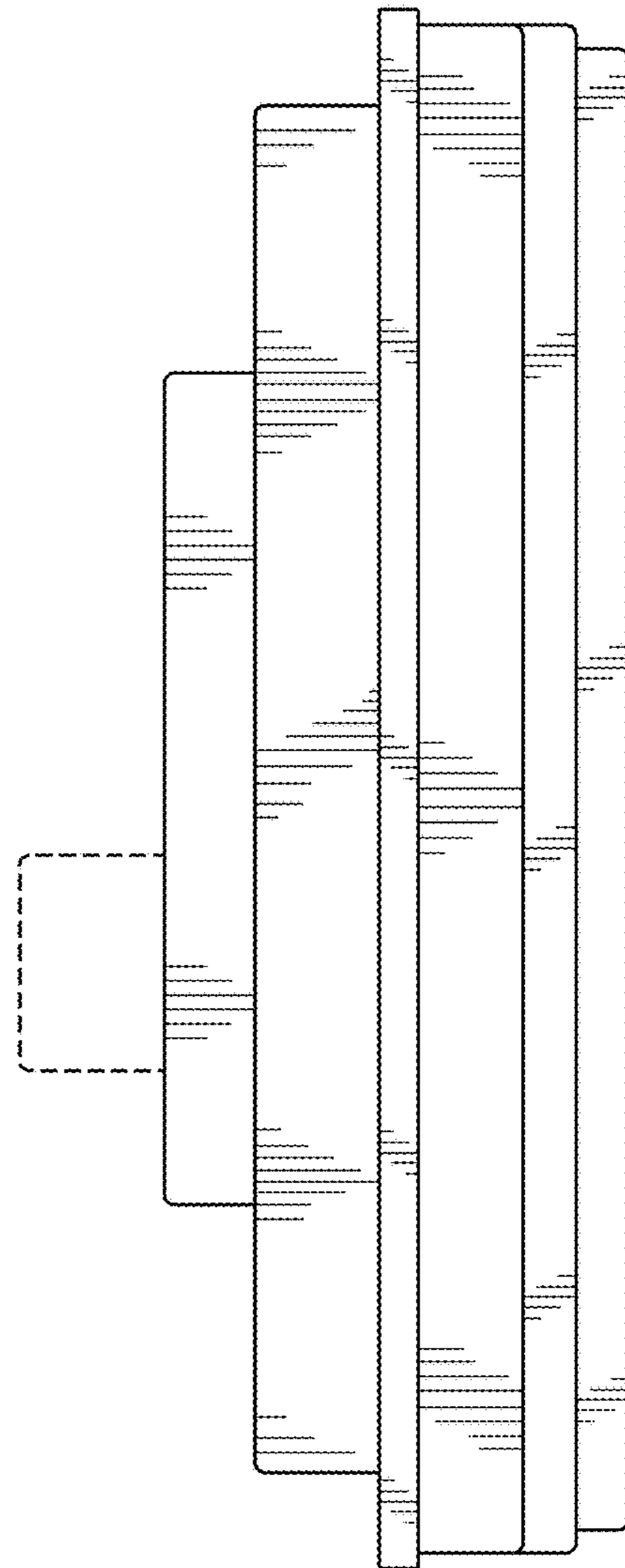
