(57) **CLAIM**

The ornamental design for a battery cover for a lift truck, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the battery cover for a lift truck as viewed from the right rear and above with the rear of the cover defined by an operator's position on the lift truck;

FIG. 3 is a front elevational view thereof;

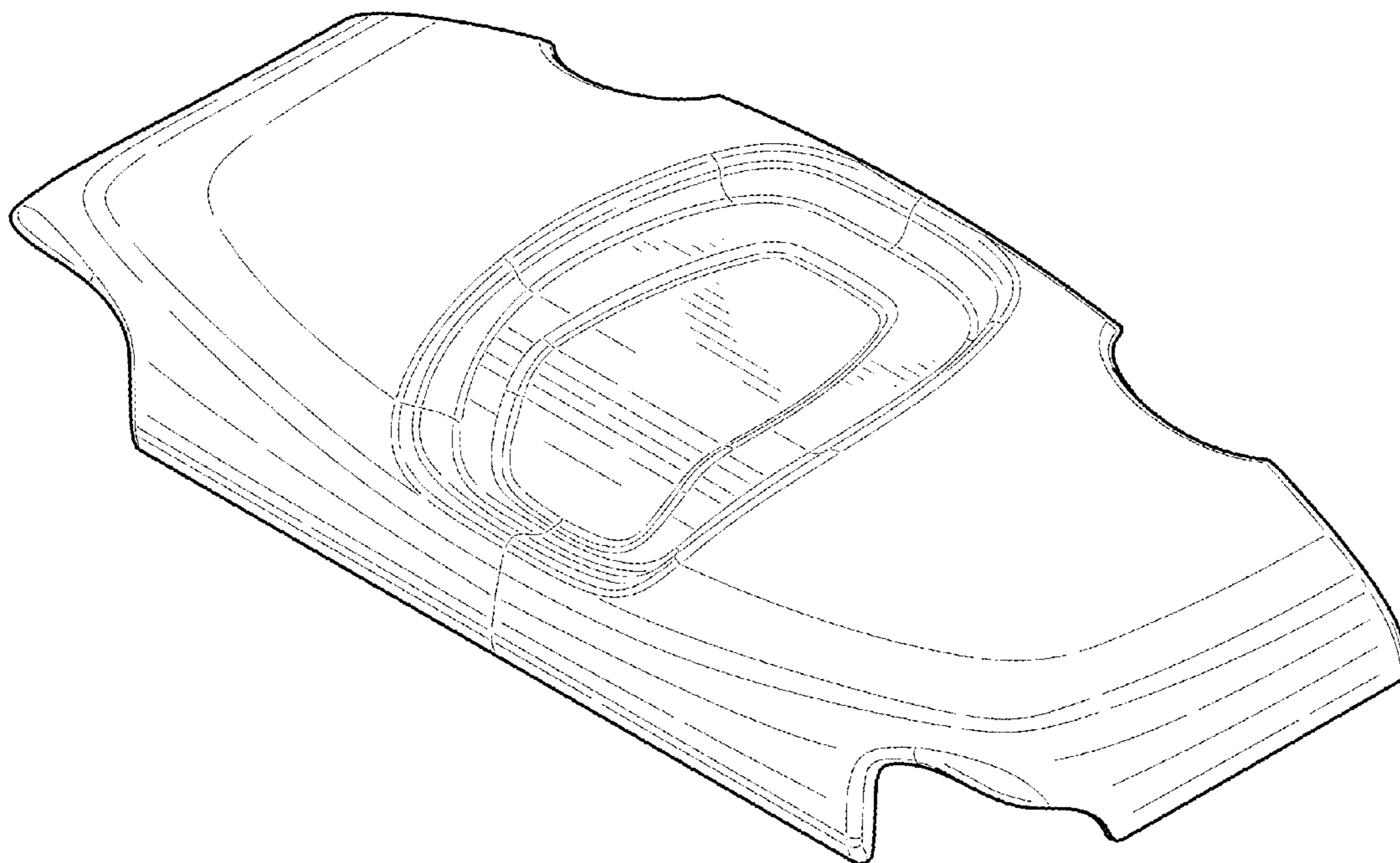
FIG. 4 is a left side elevational view thereof;

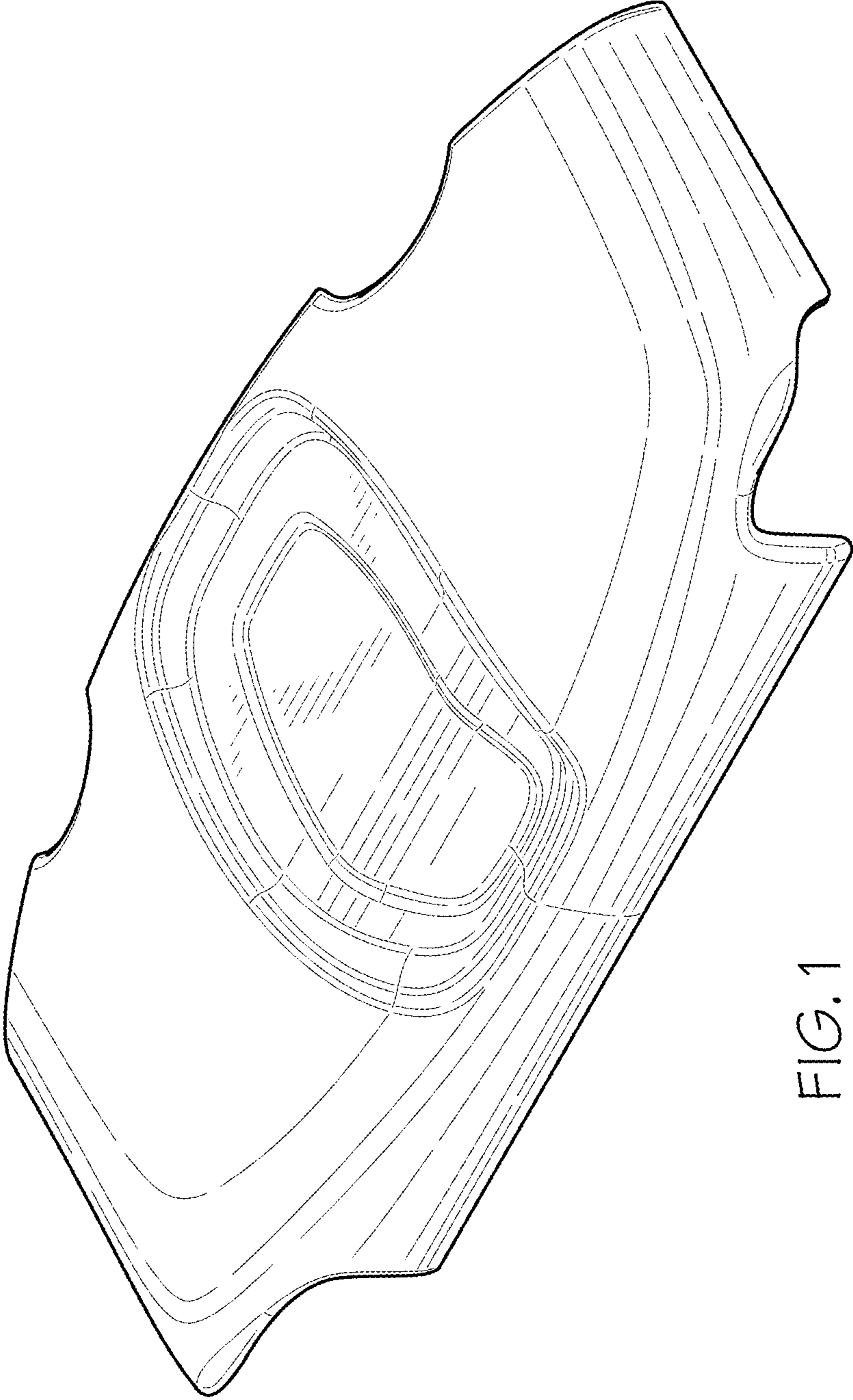

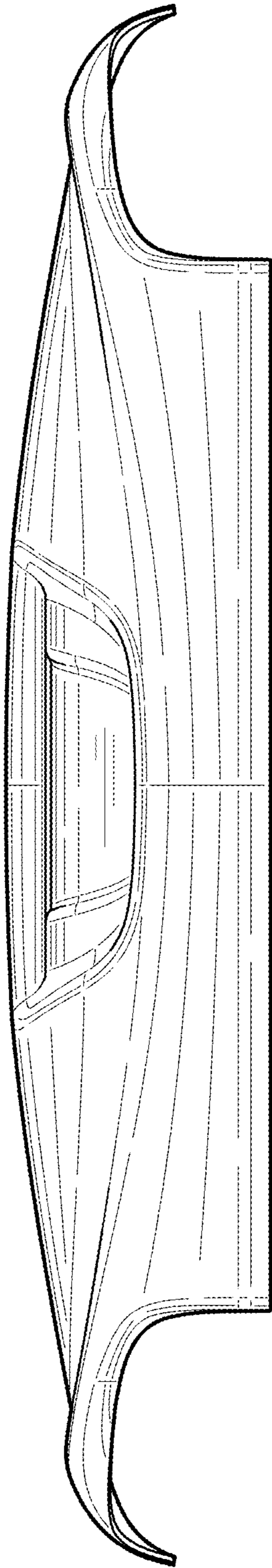

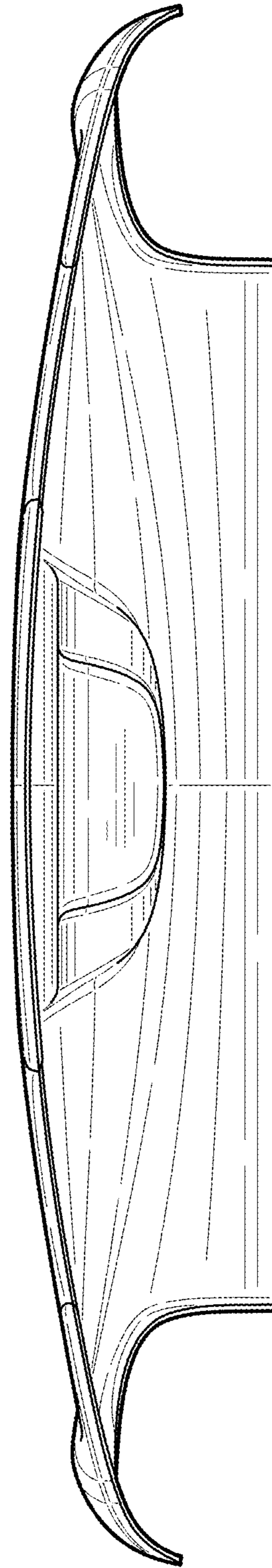

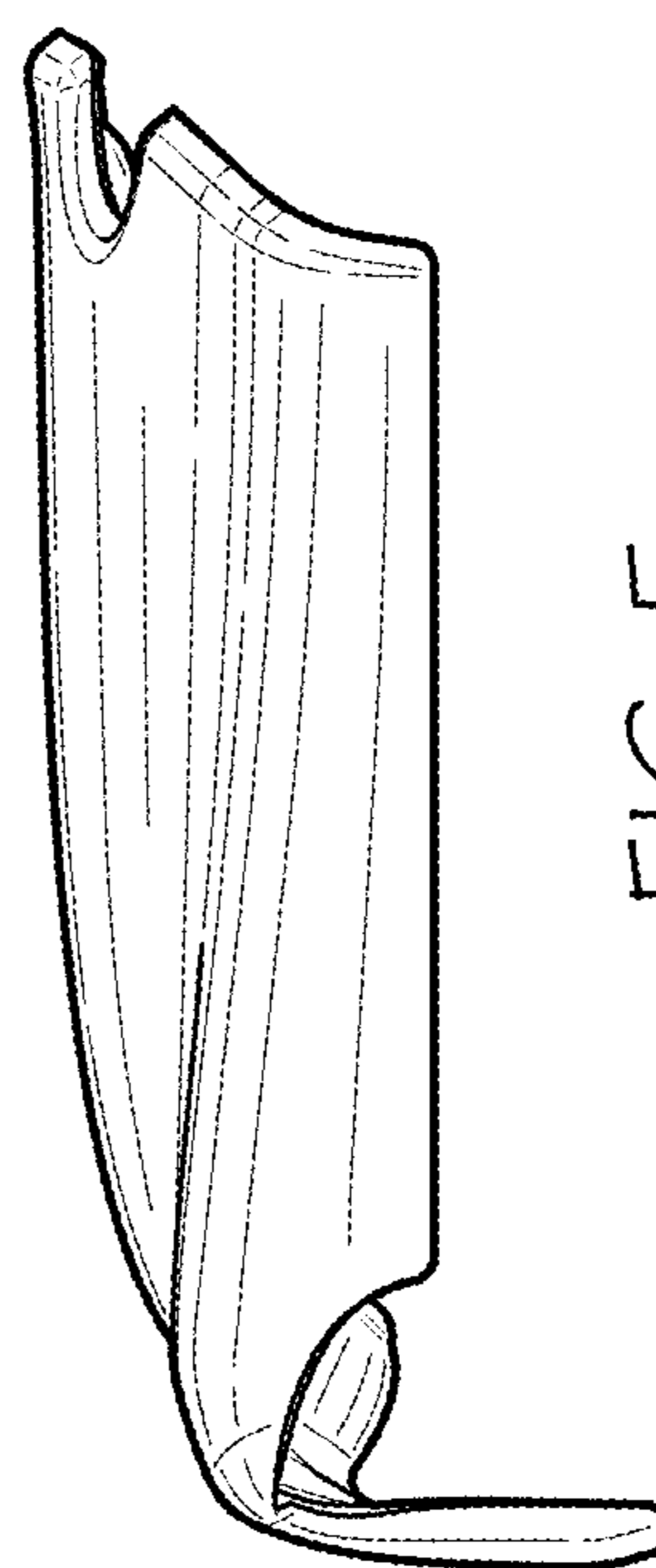

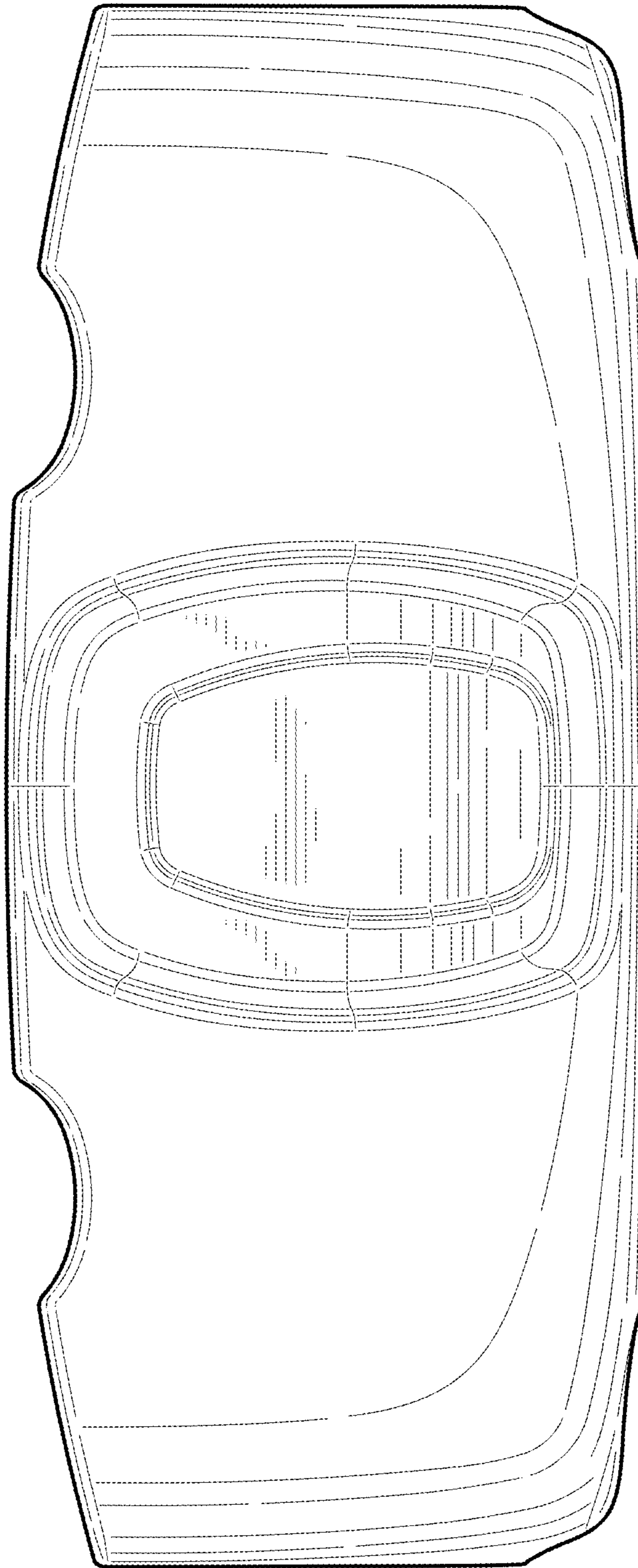

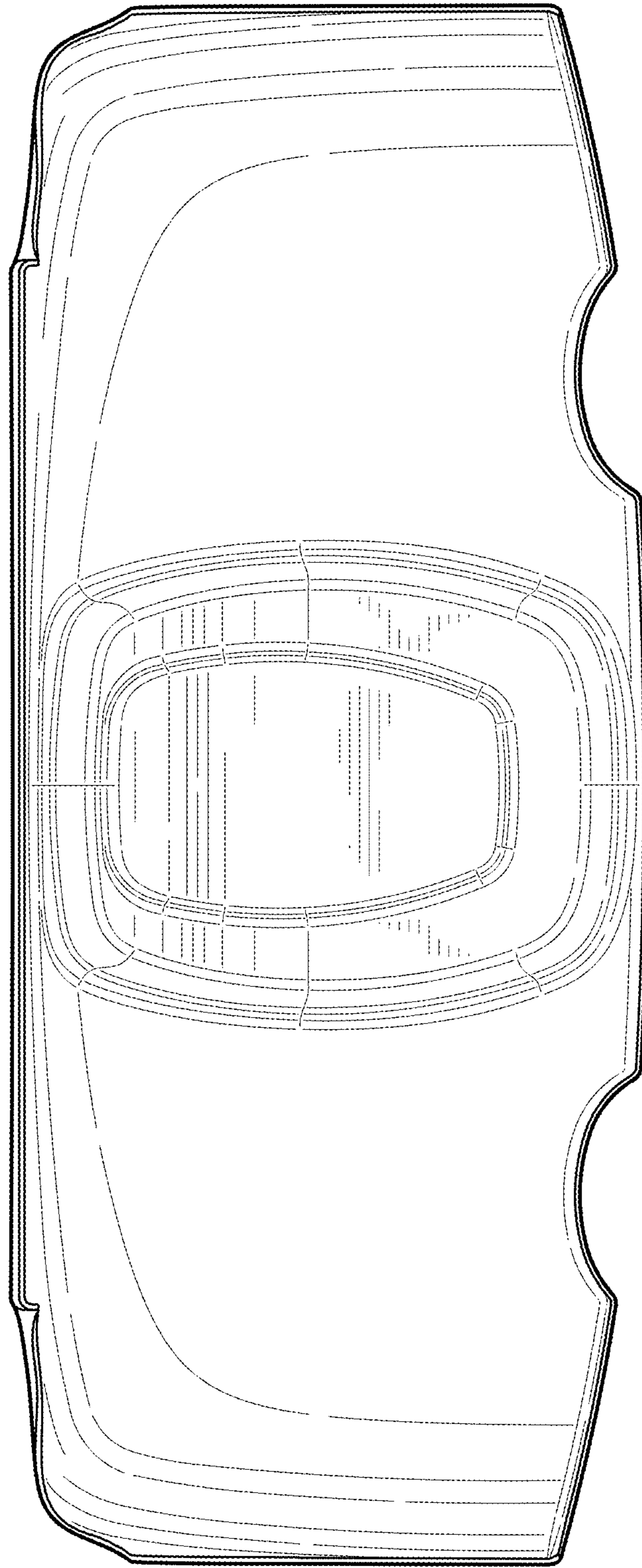
