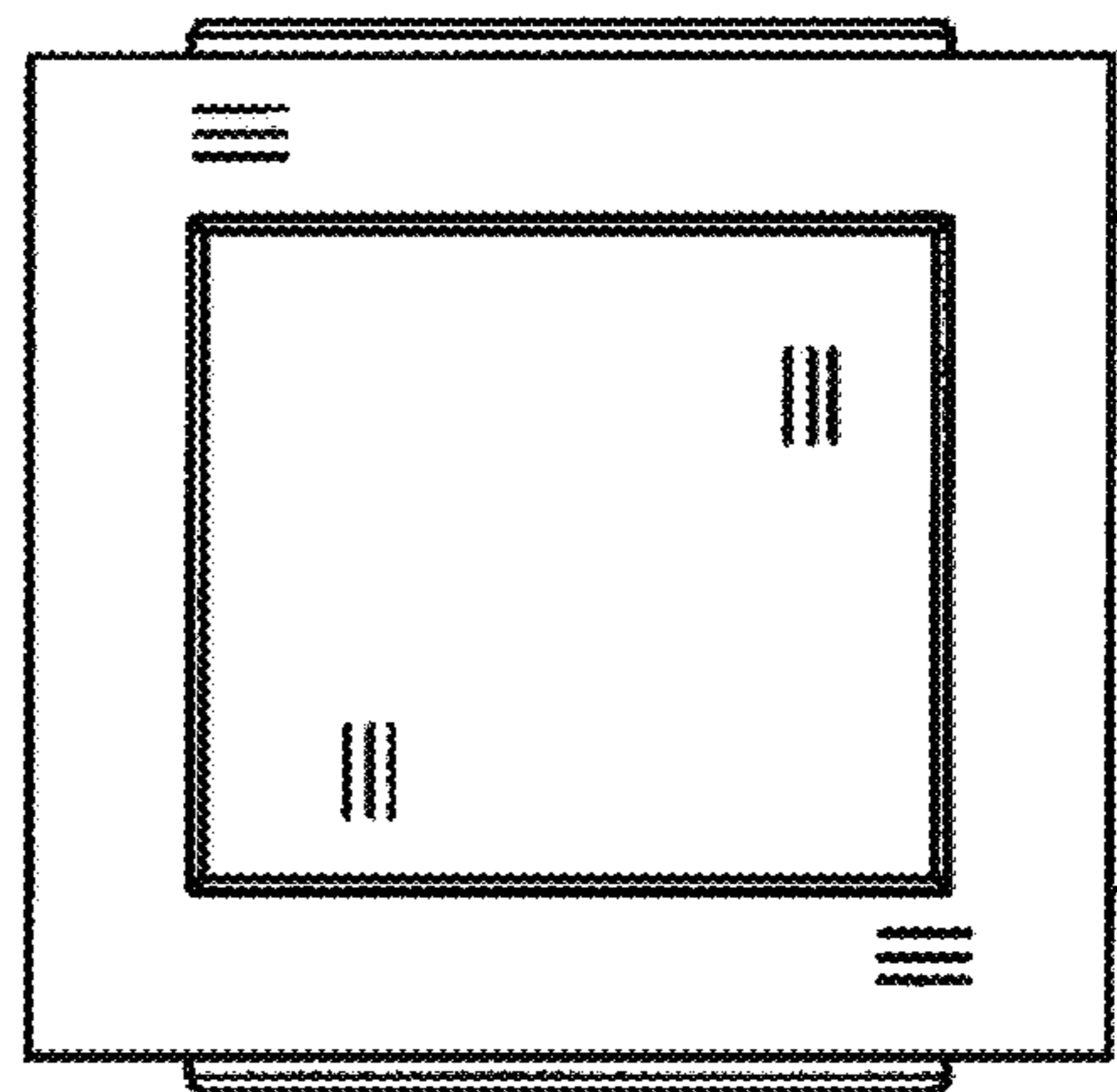
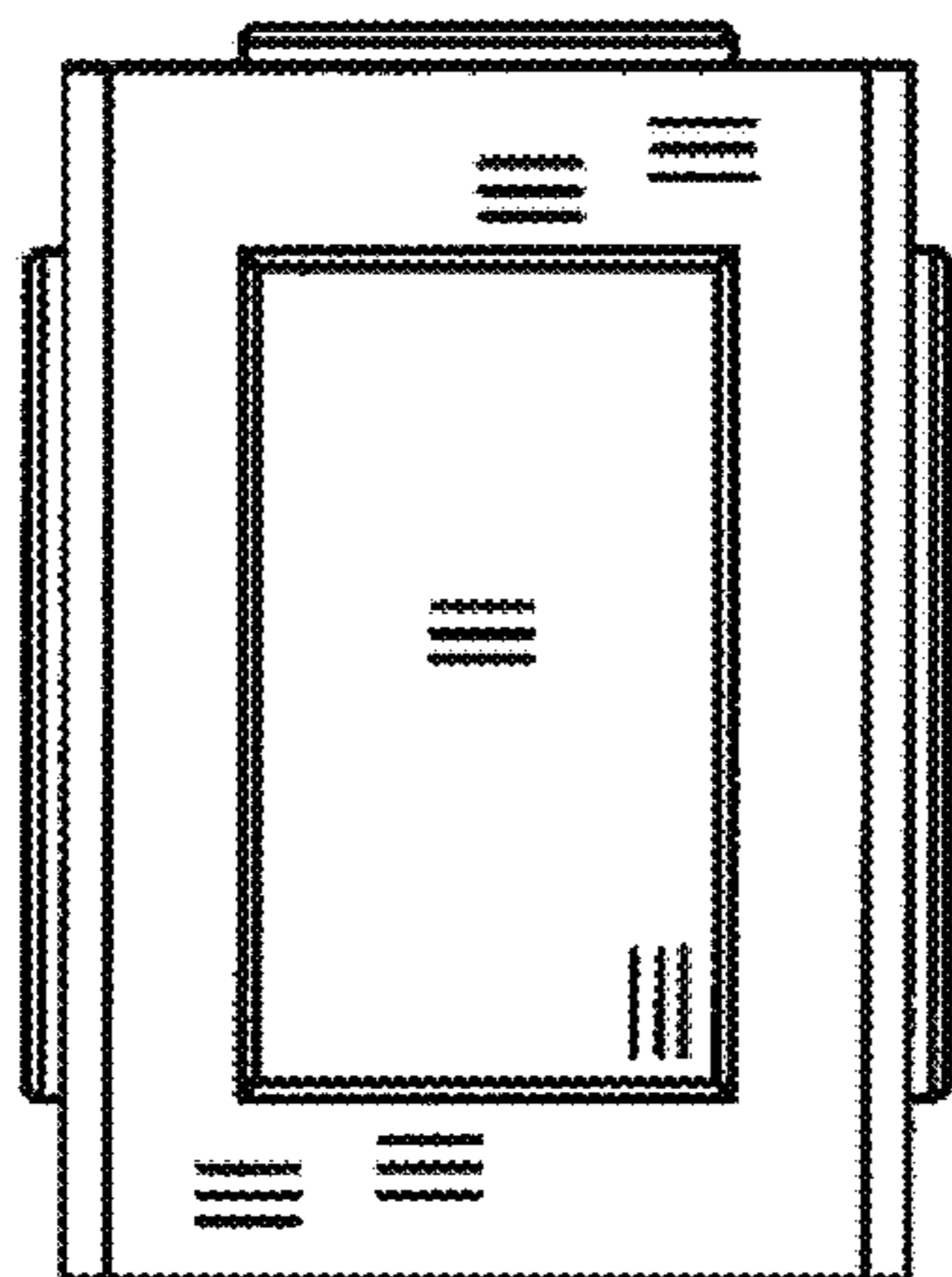
FIG. 1 is a right end view of the present design an urn.

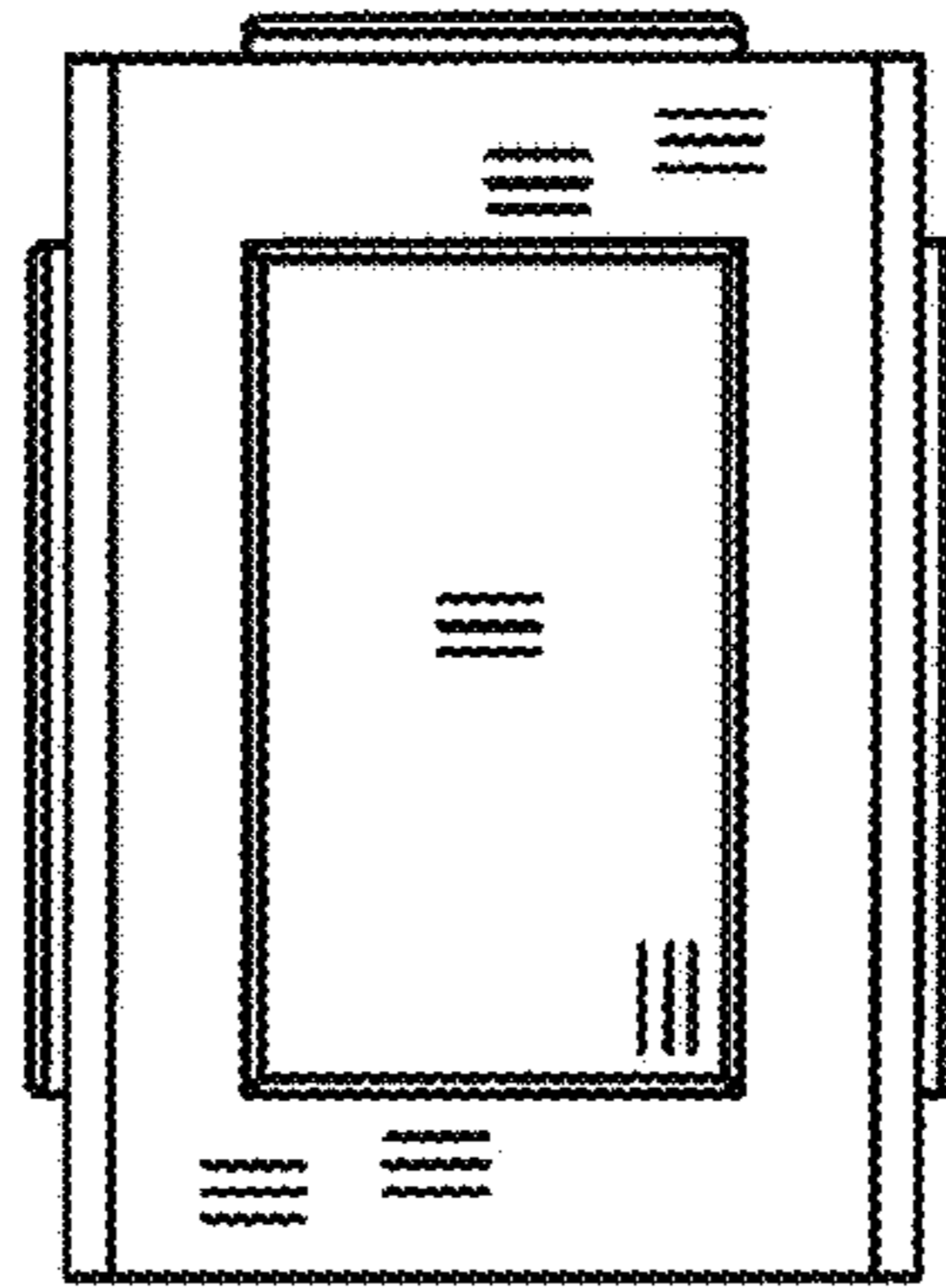

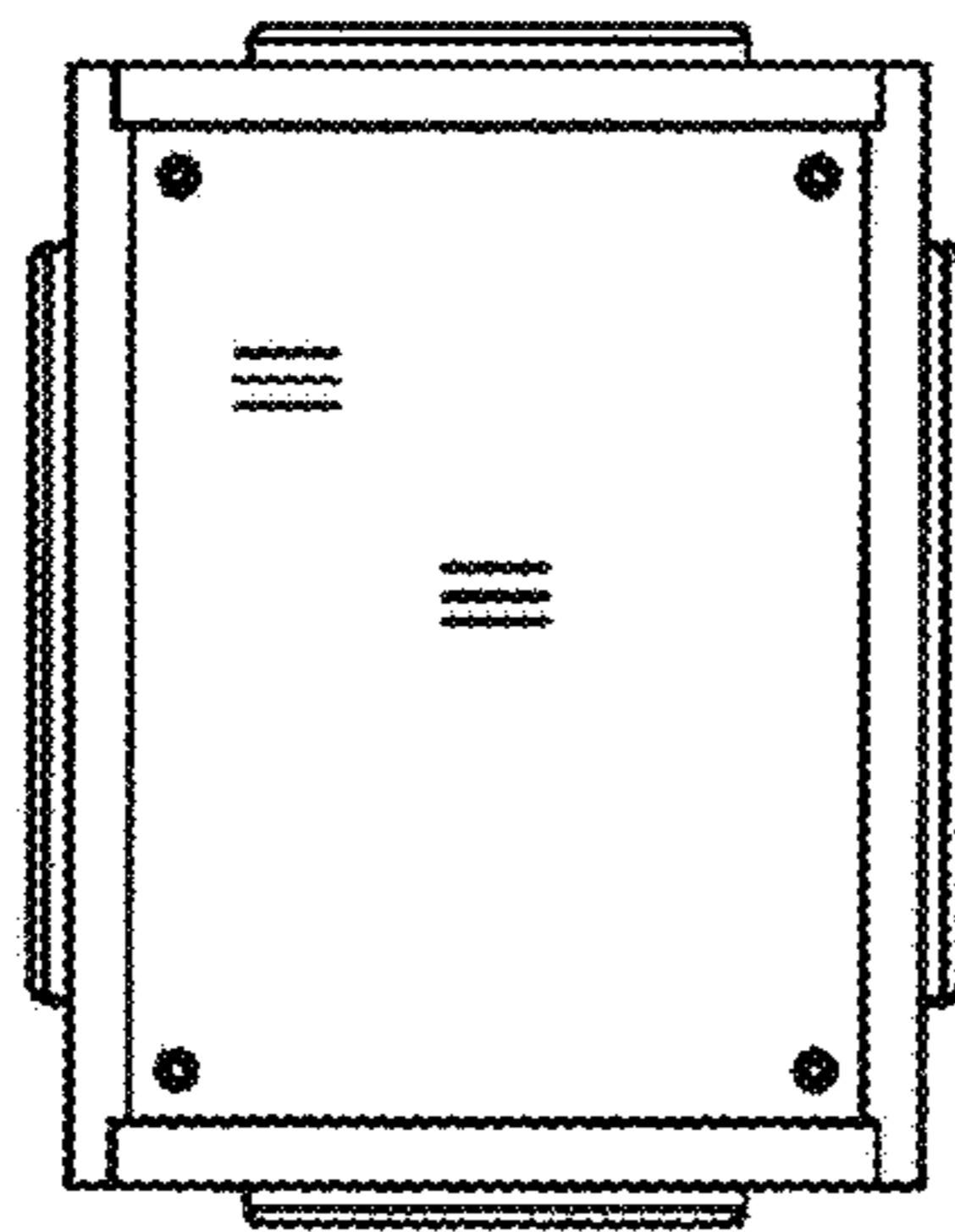

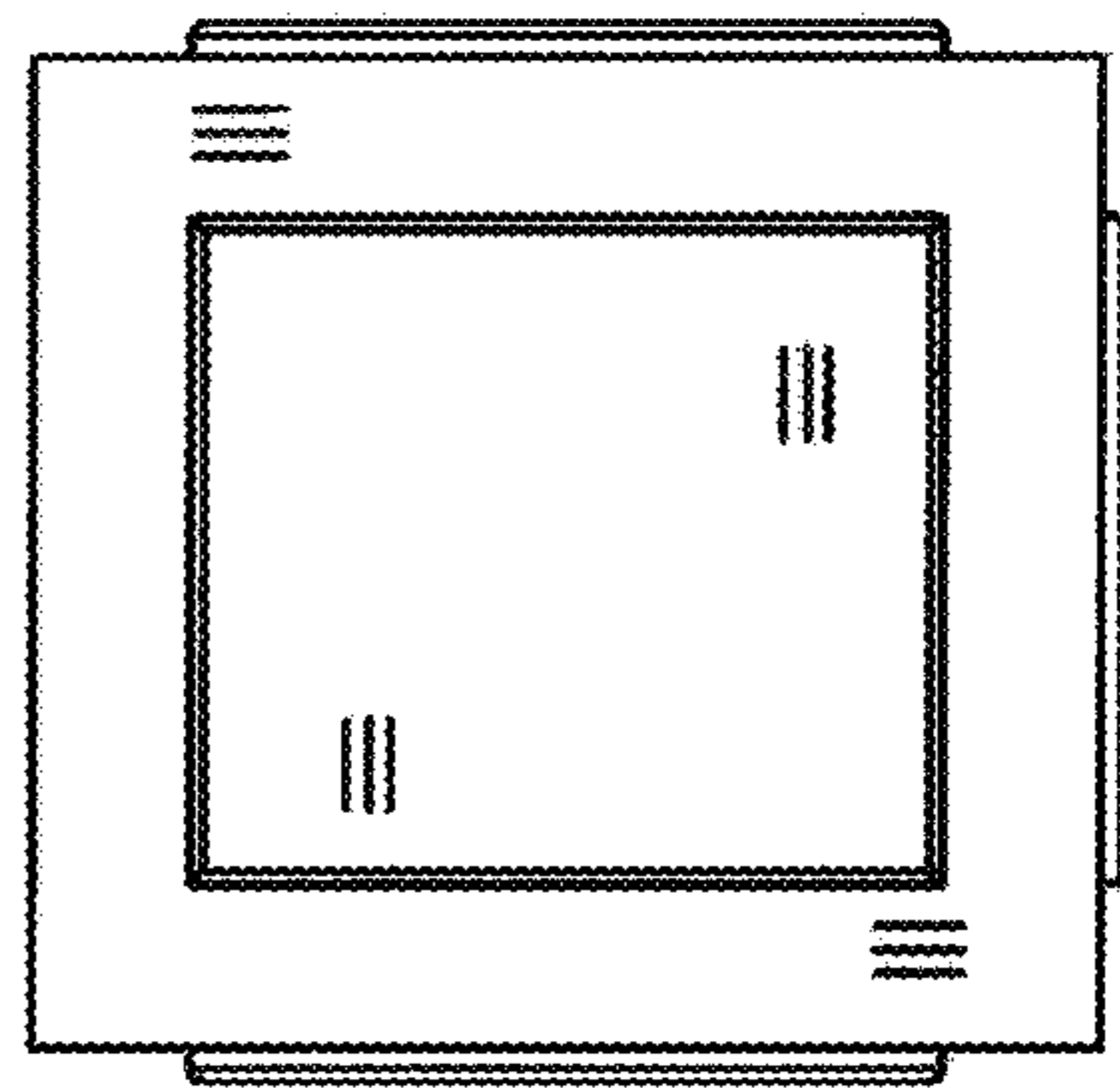

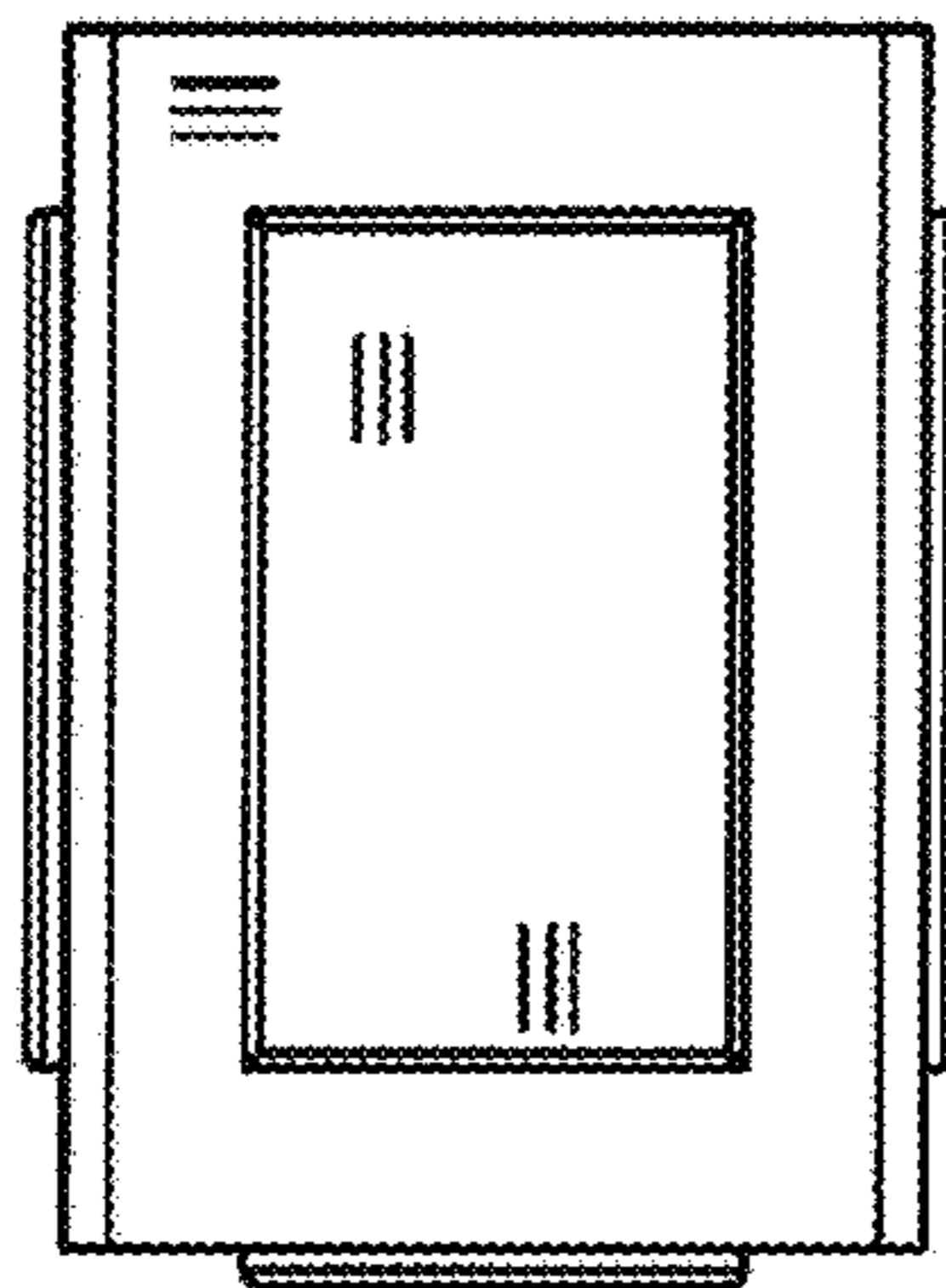

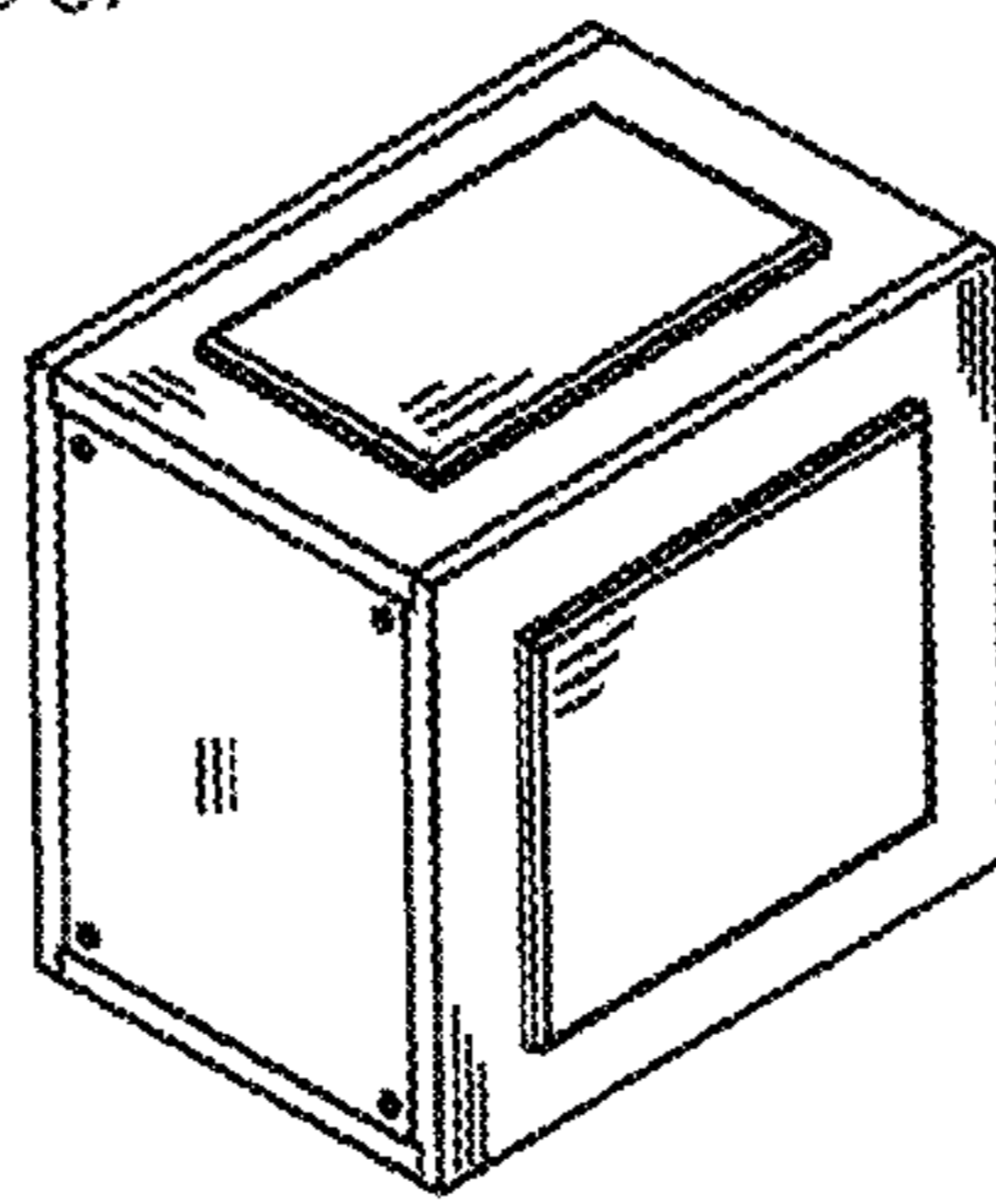
