FIG. 1 is a front perspective view of fishing waders, worn by a user. Broken lines are for illustrative purposes only and form no part of the claimed design.

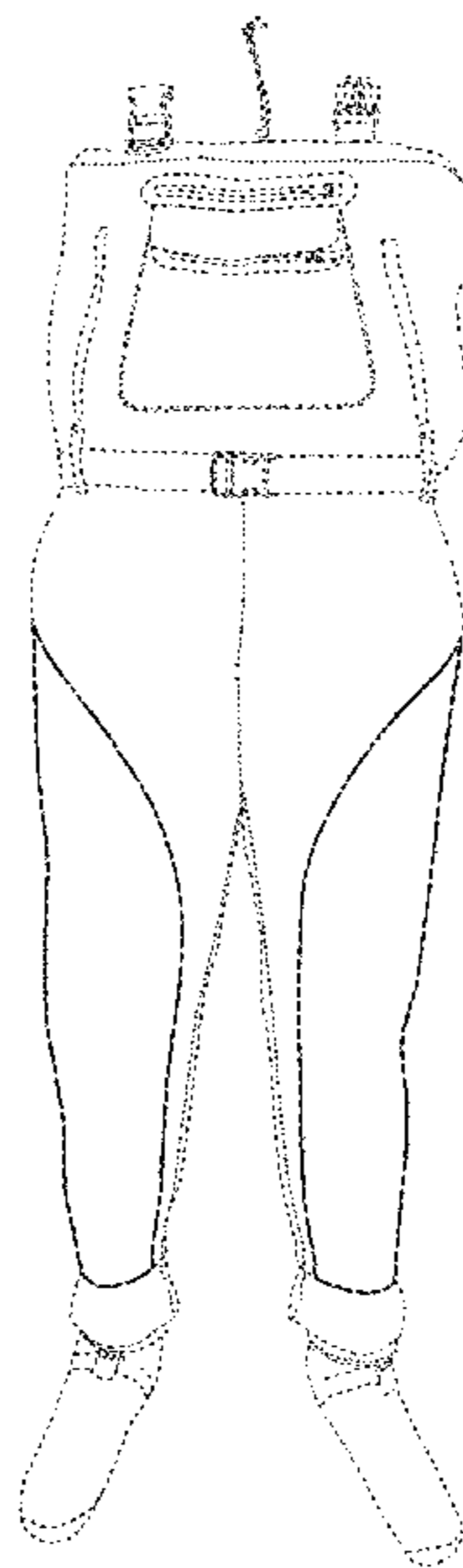
FIG. 2 is a front perspective view of the waders of FIG. 1. Broken lines are for illustrative purposes only and form no part of the claimed design.

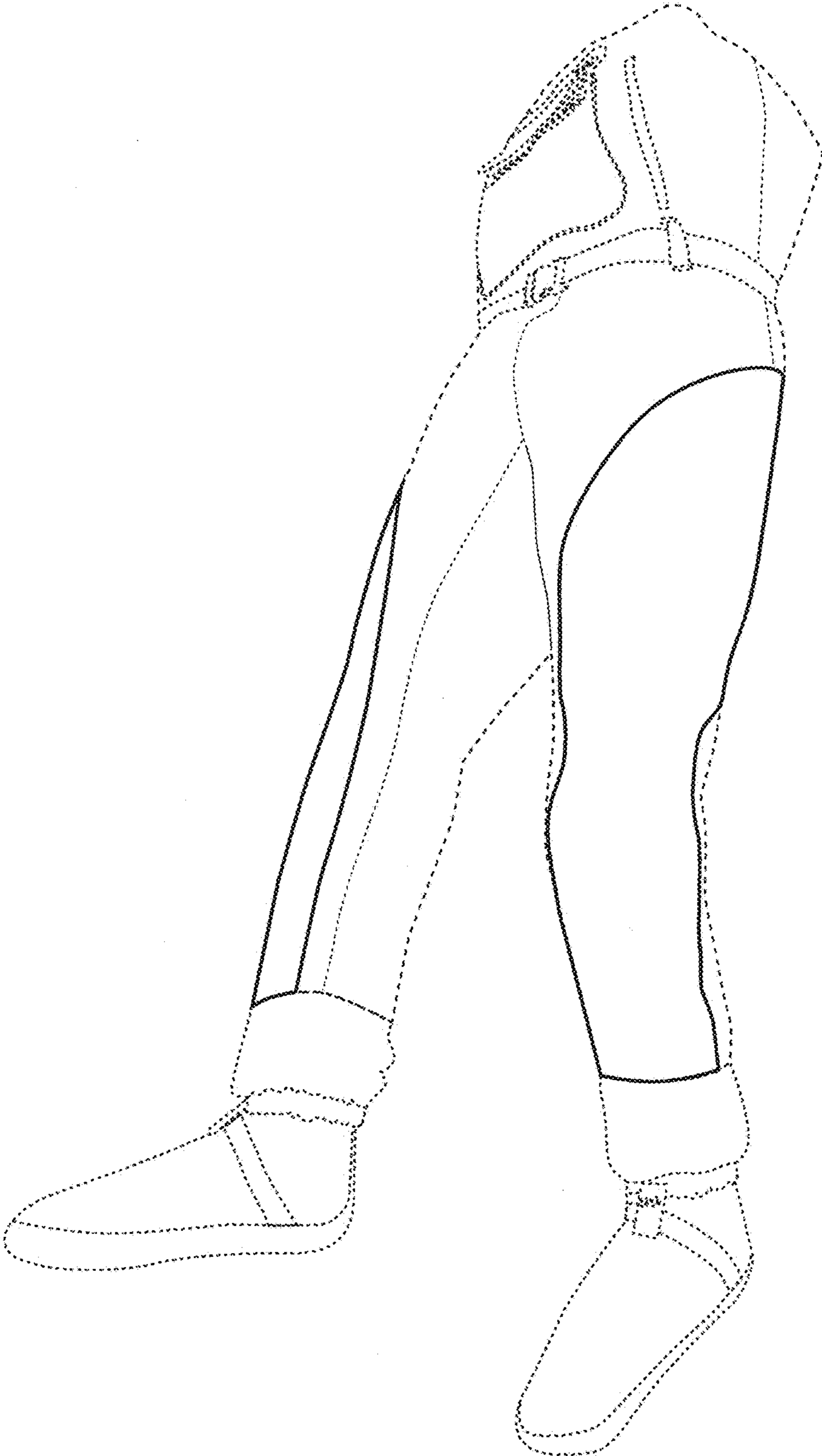

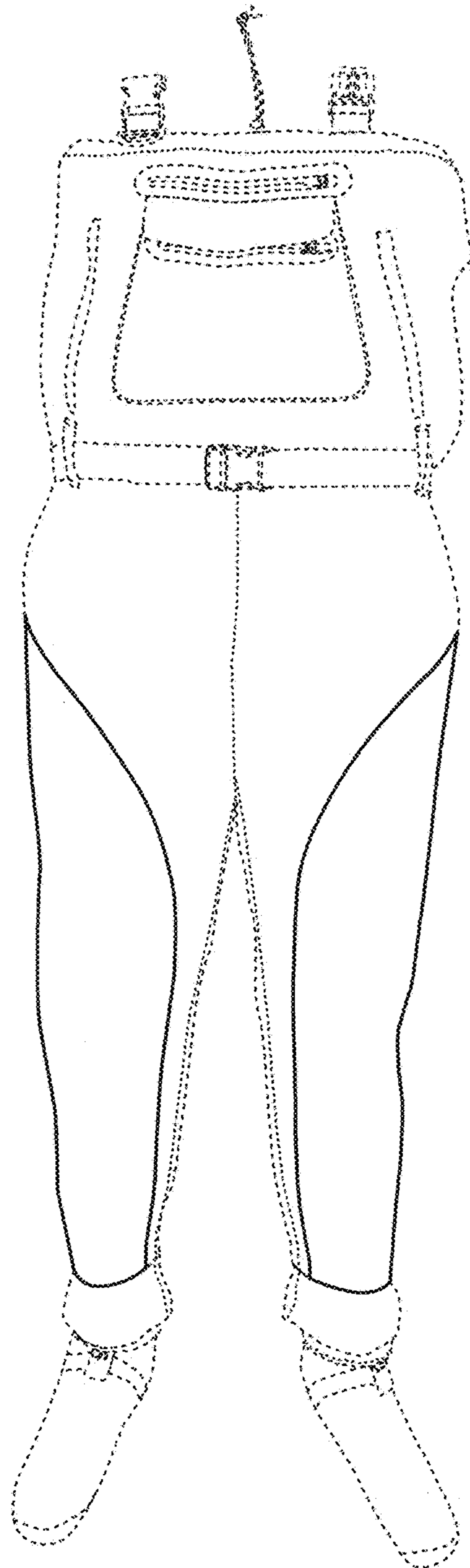

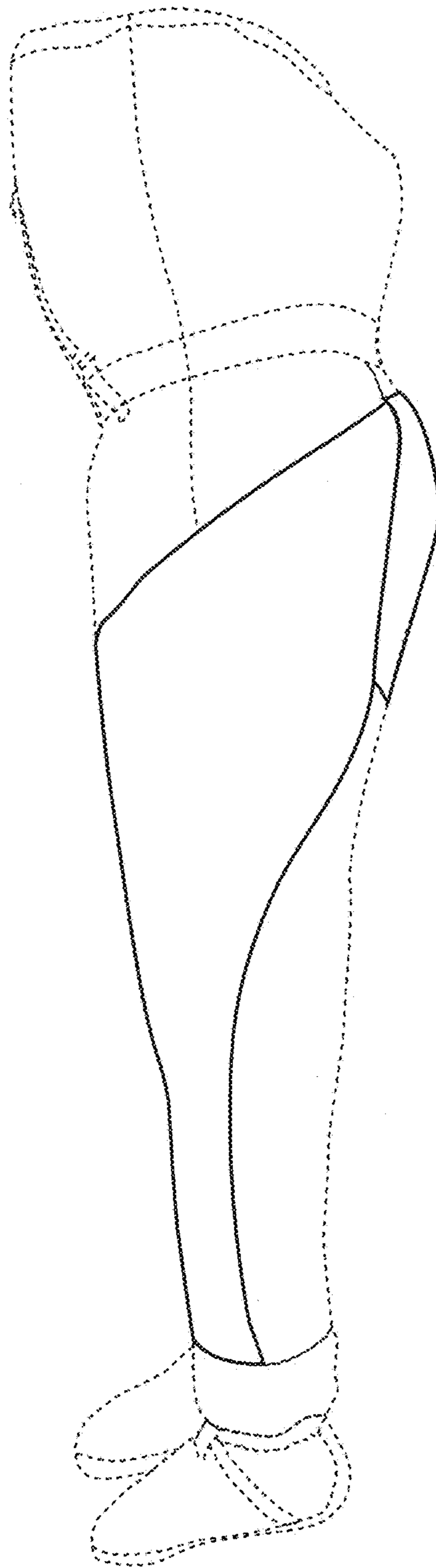

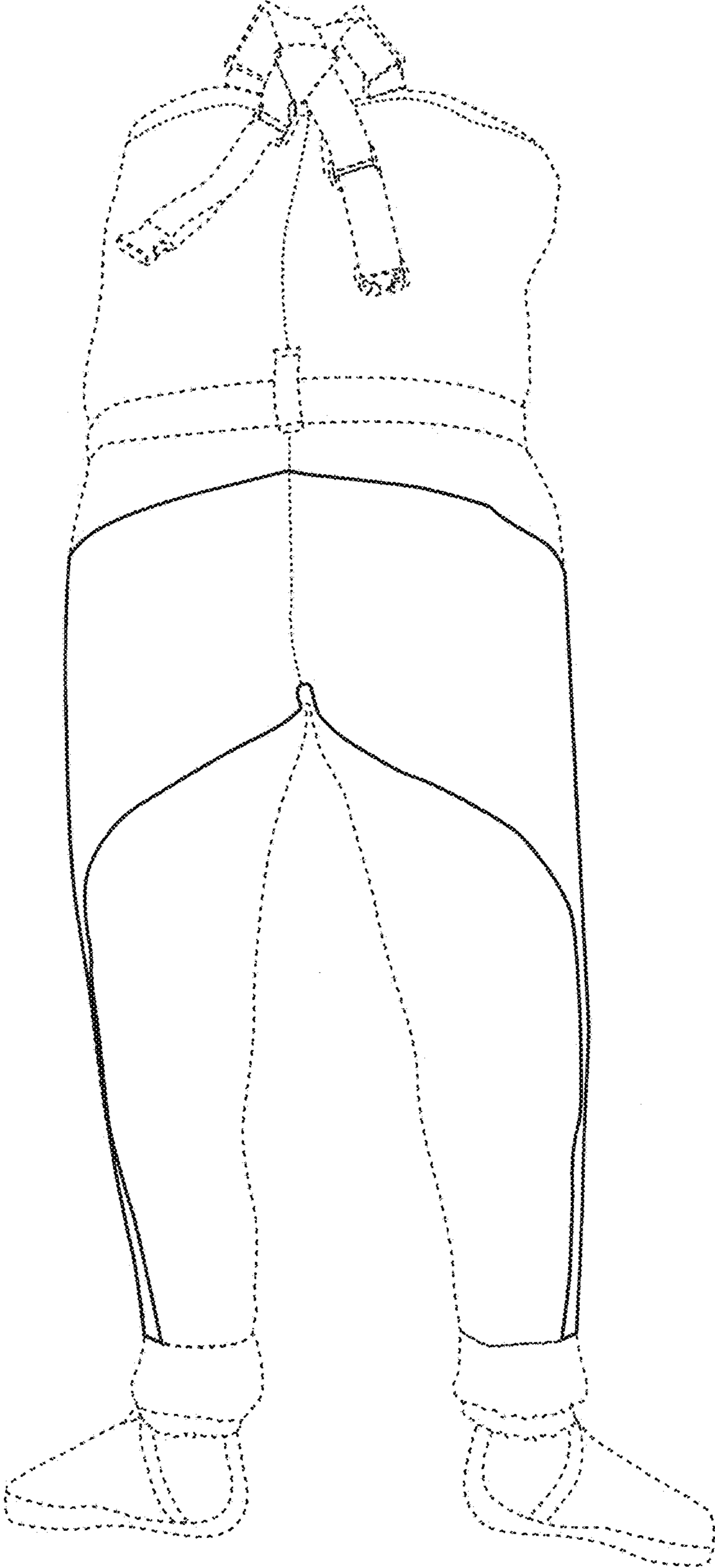

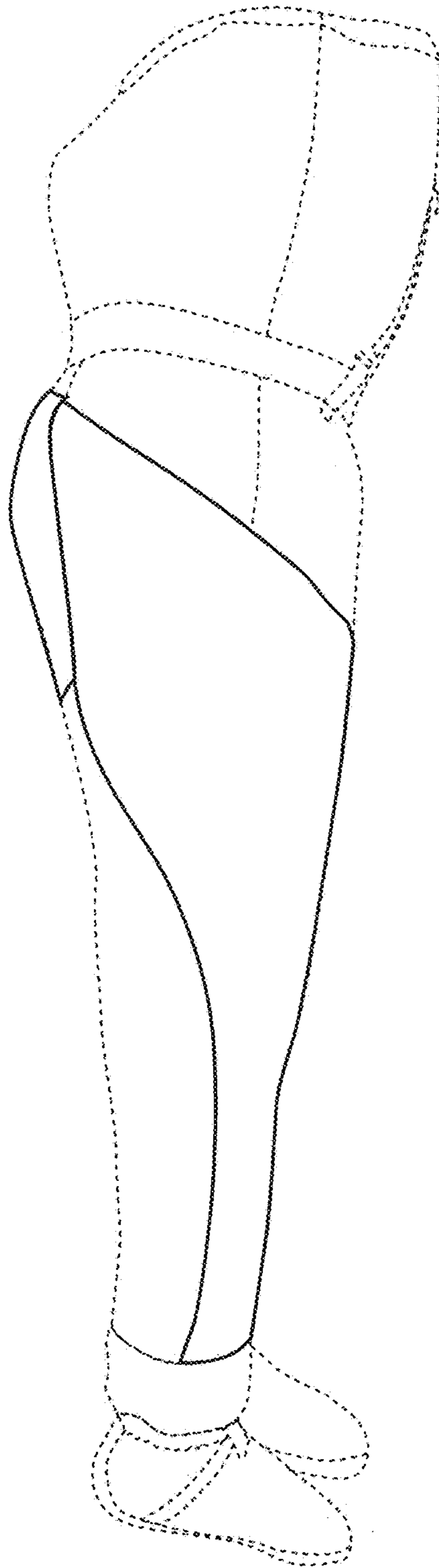
