The ornamental design for a keychain device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a keychain device showing our new design thereof;

FIG. 2 is a front view of the keychain device shown in FIG. 1;

FIG. 3 is a rear side view of the keychain device shown in FIG. 1;

FIG. 4 is a first side view of the keychain device shown in FIG. 1;

FIG. 5 is a second side view of the keychain device shown in FIG. 1;

FIG. 6 is a top view of the keychain device shown in FIG. 1; and,

FIG. 7 is a bottom view of the keychain device shown in FIG. 1.

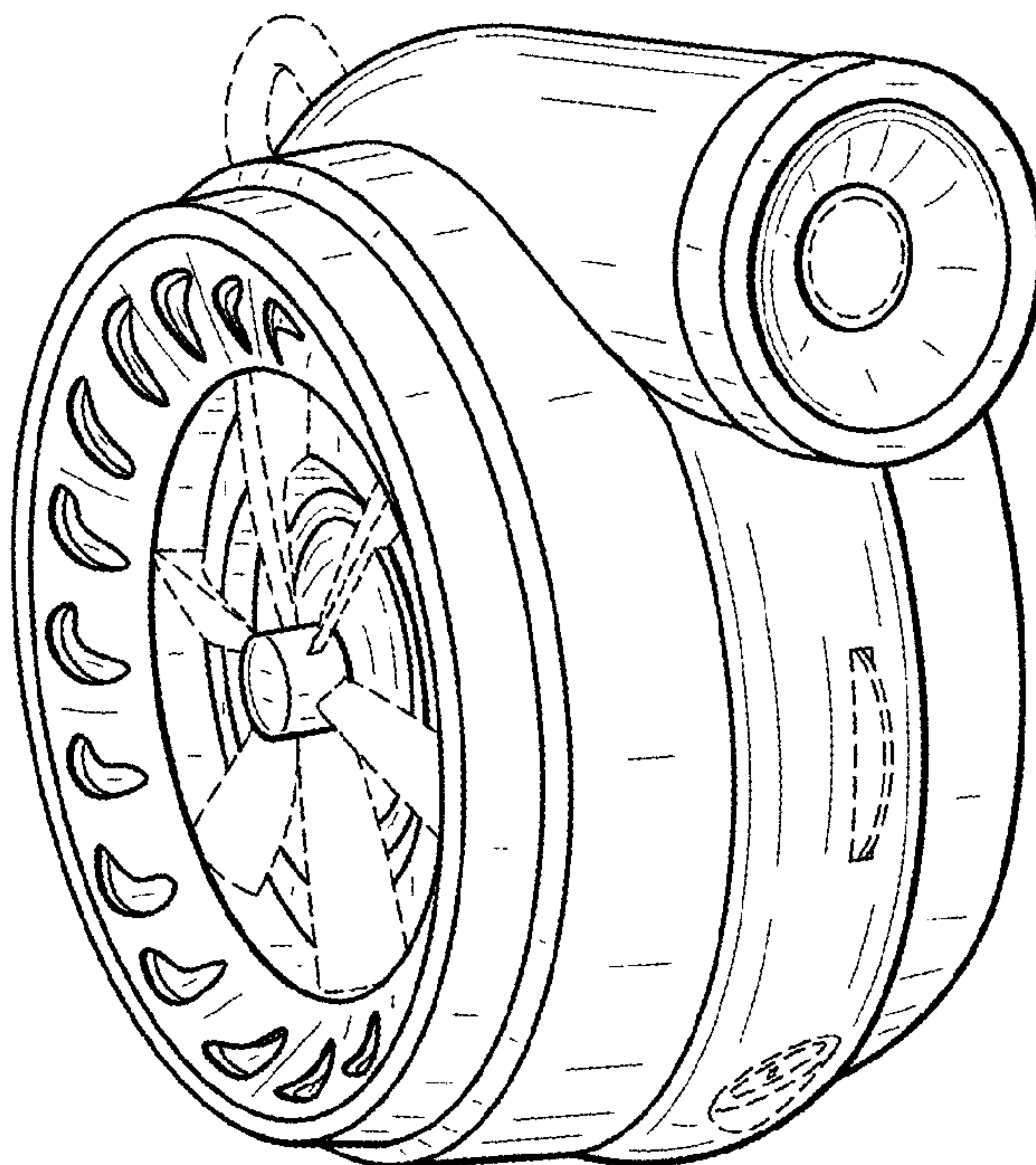

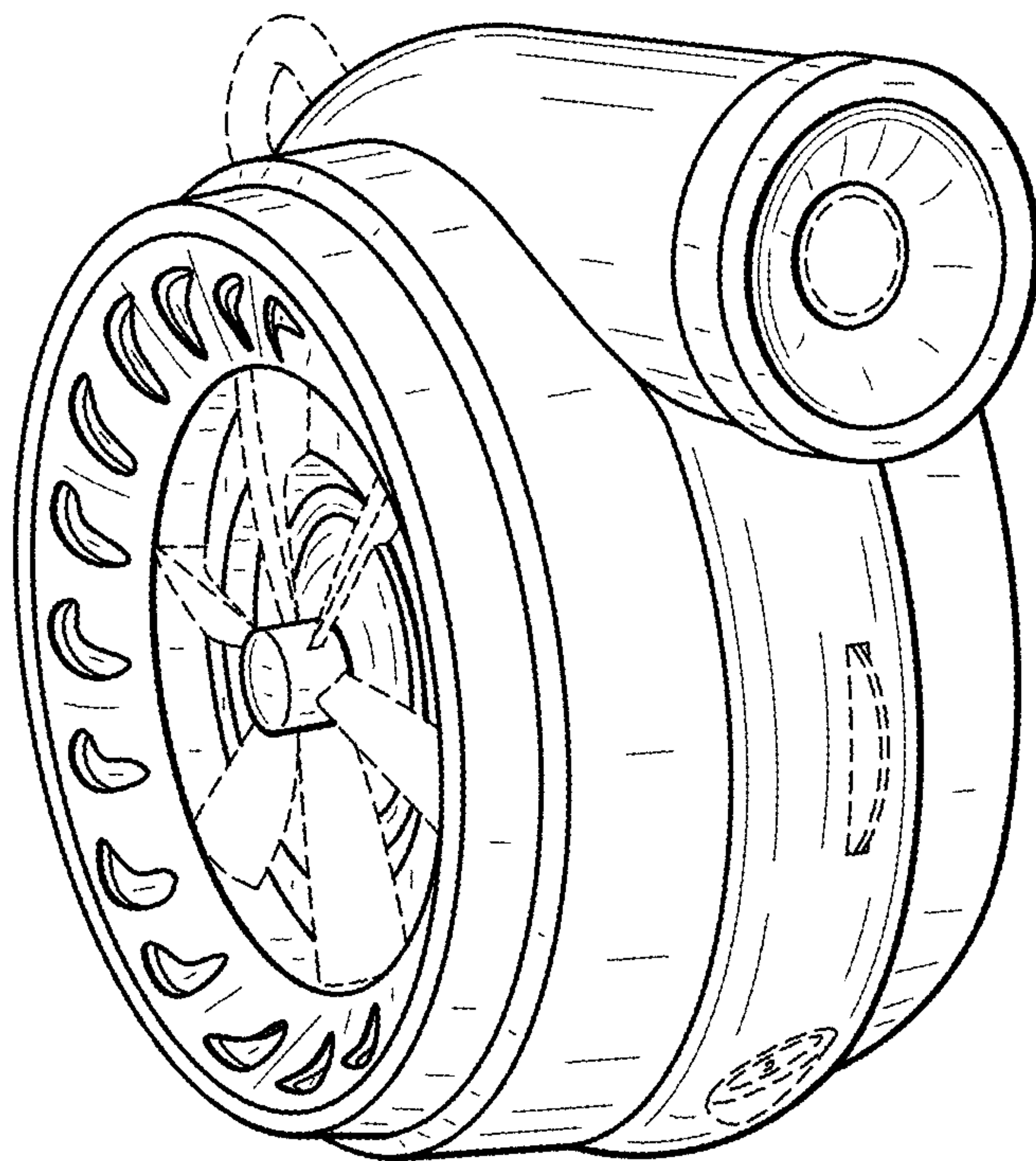

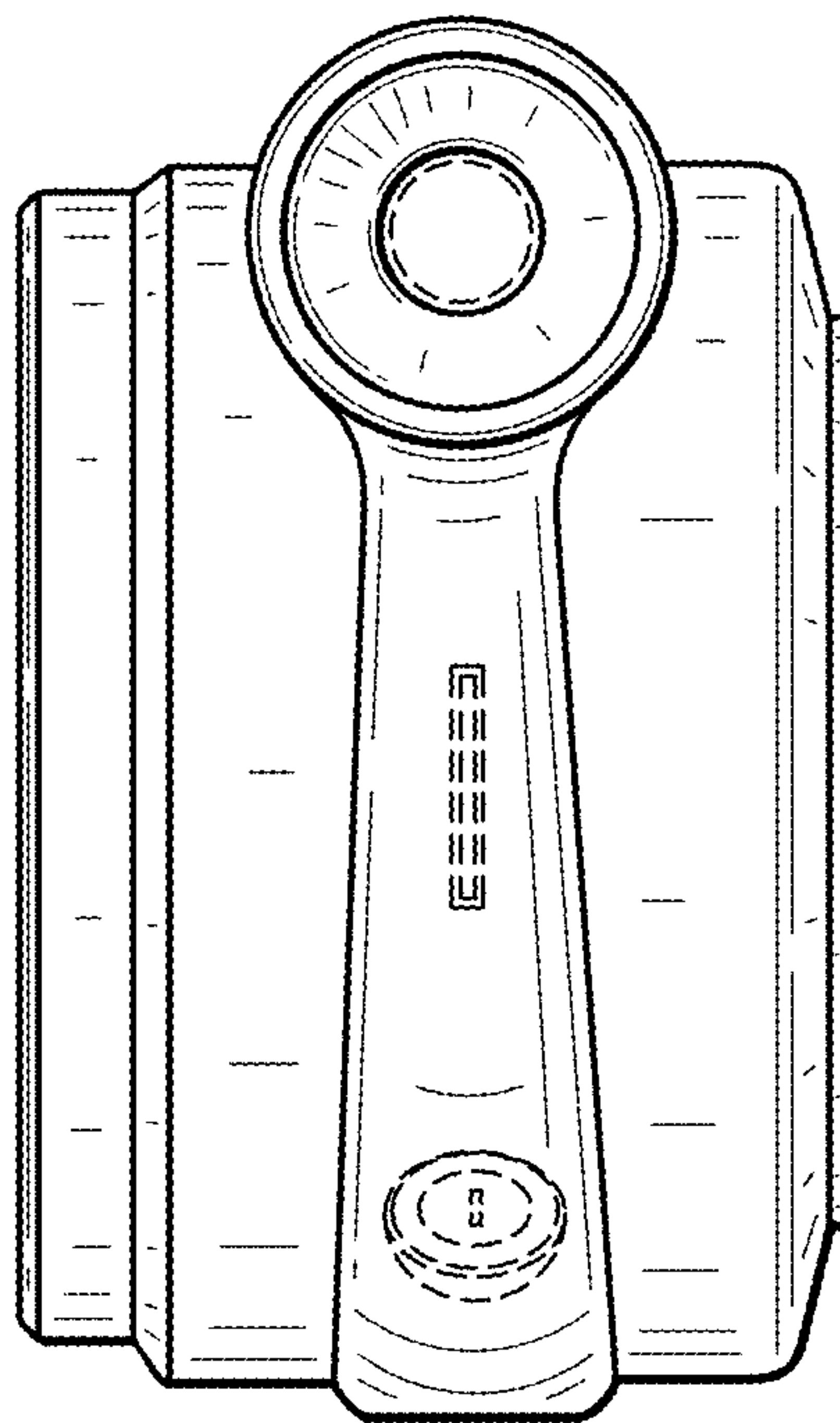

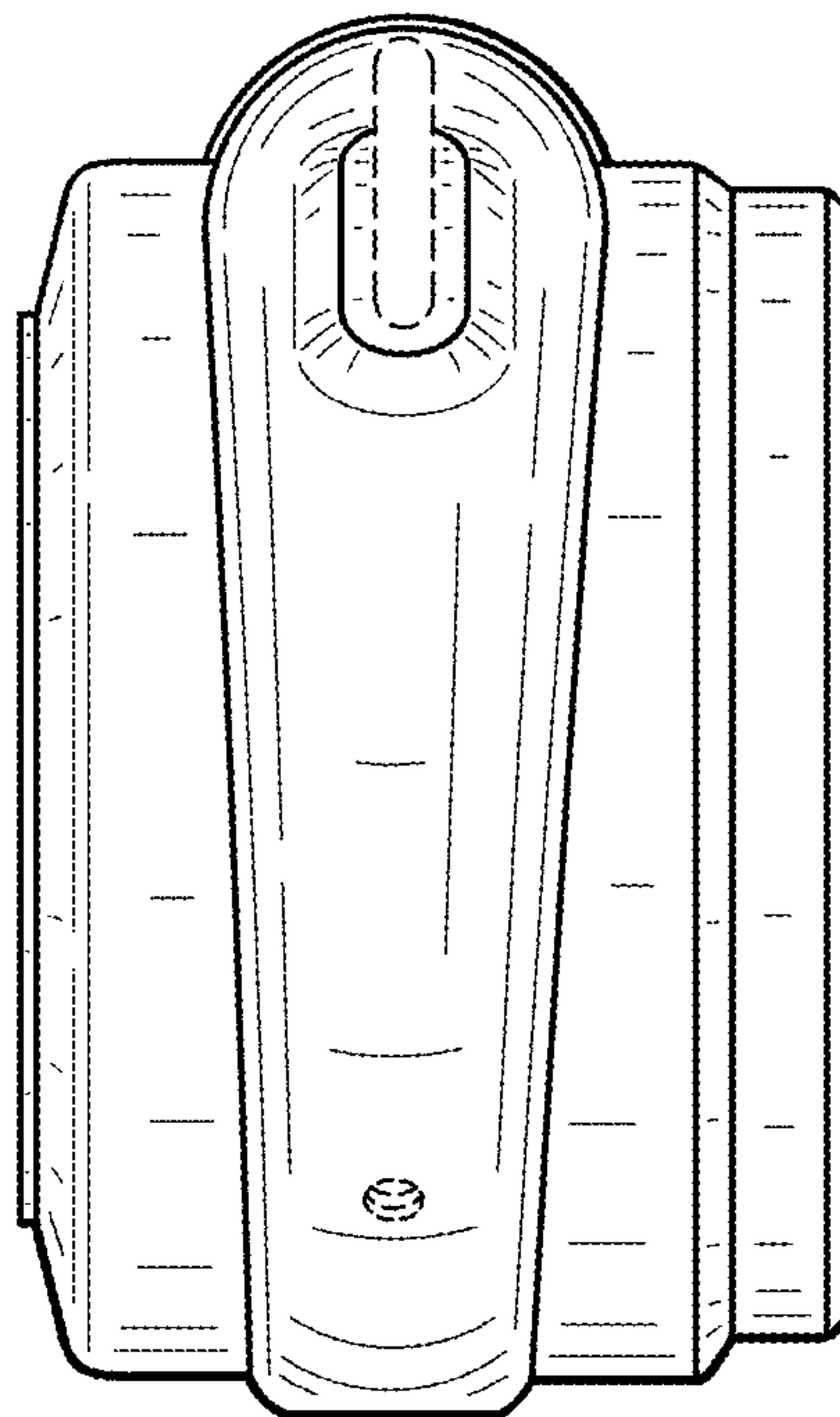

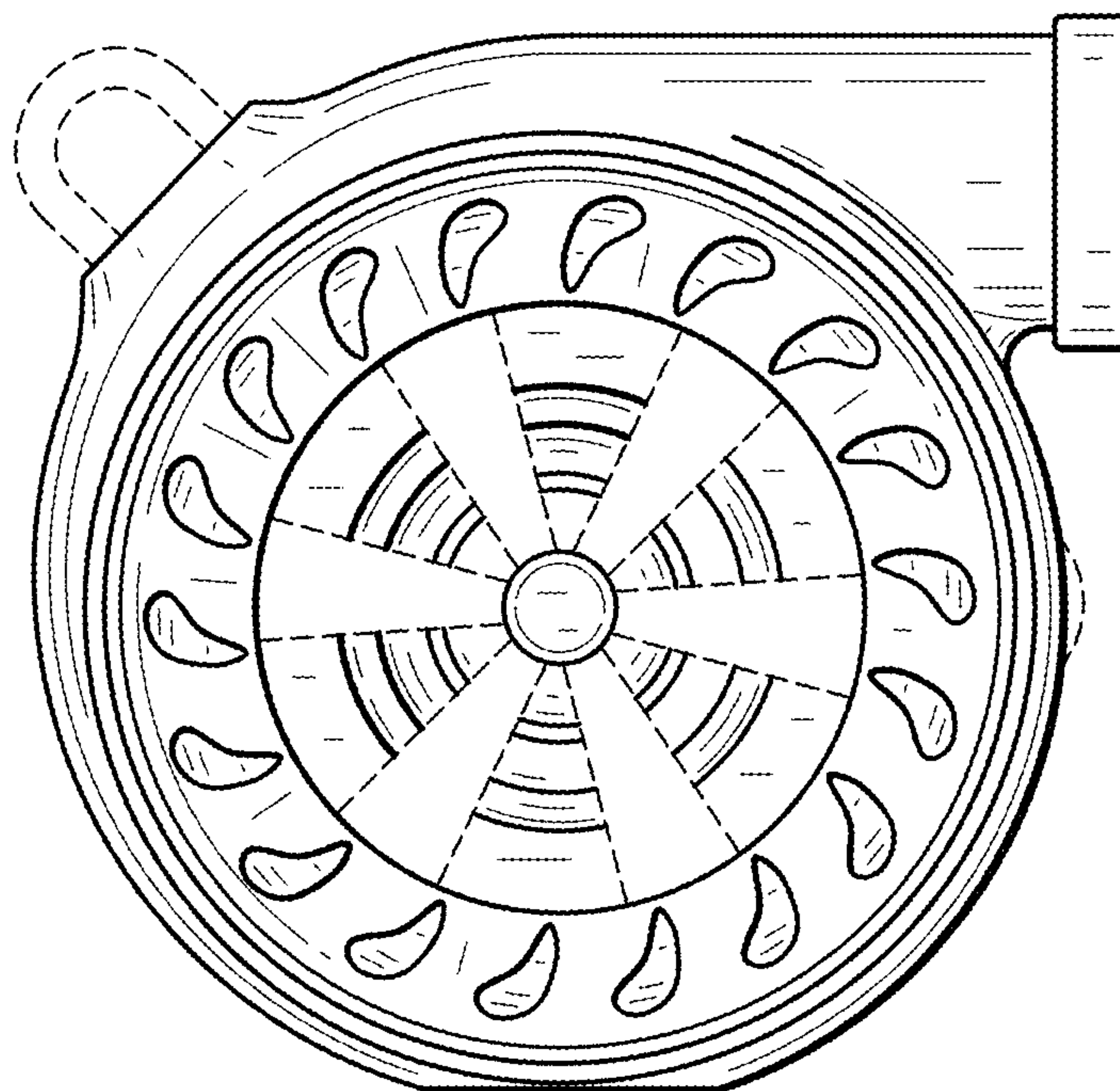

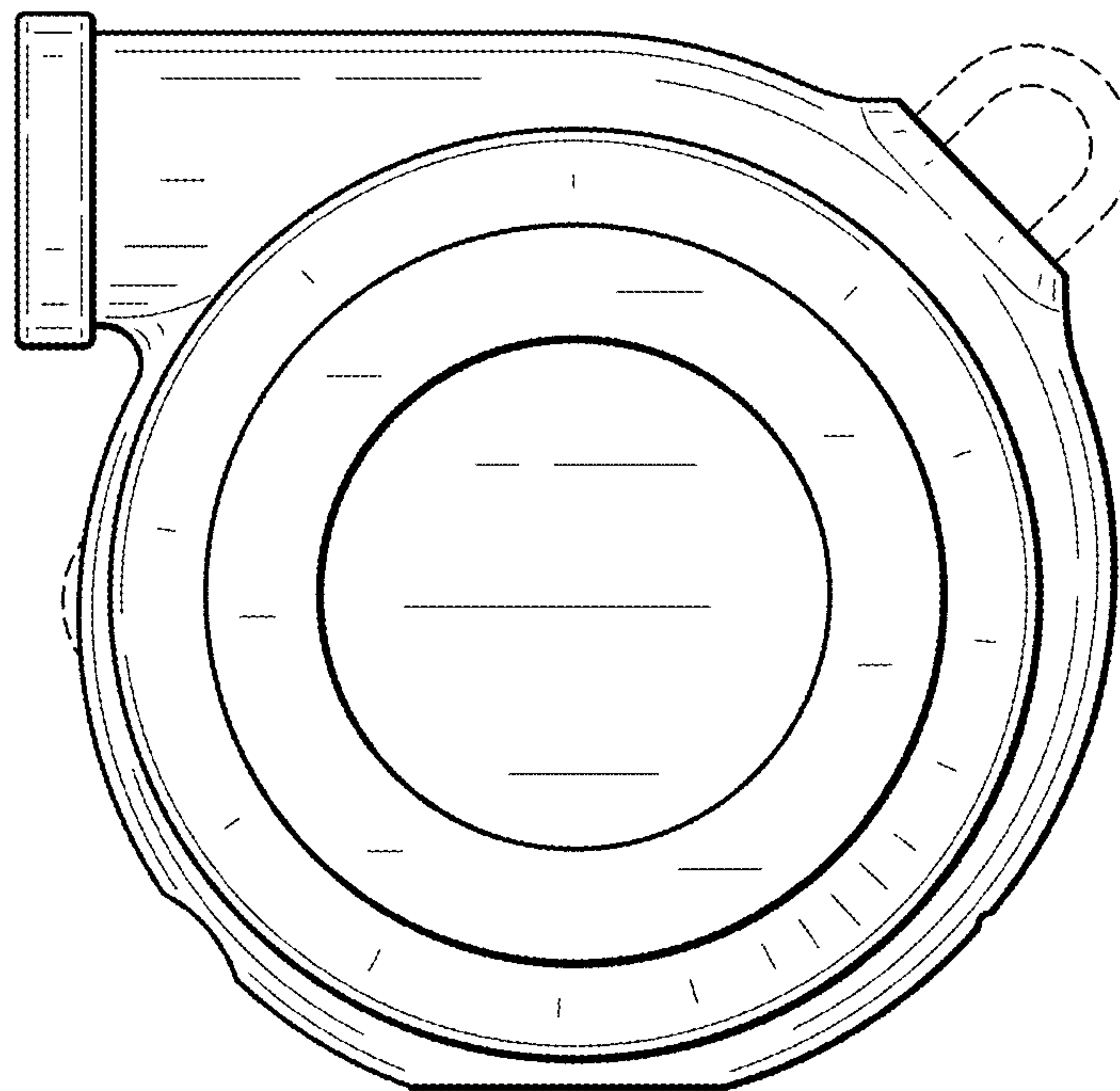

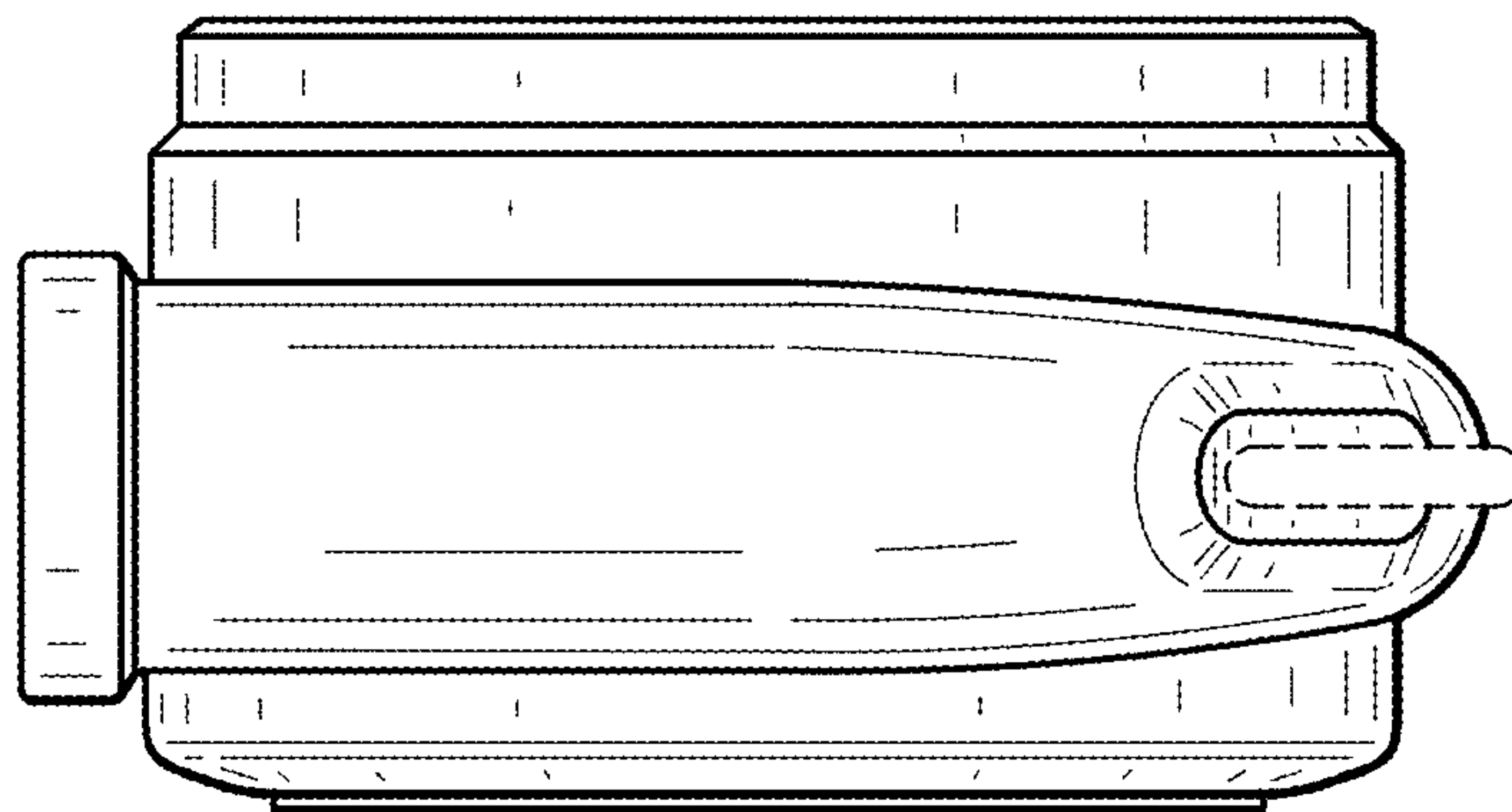
