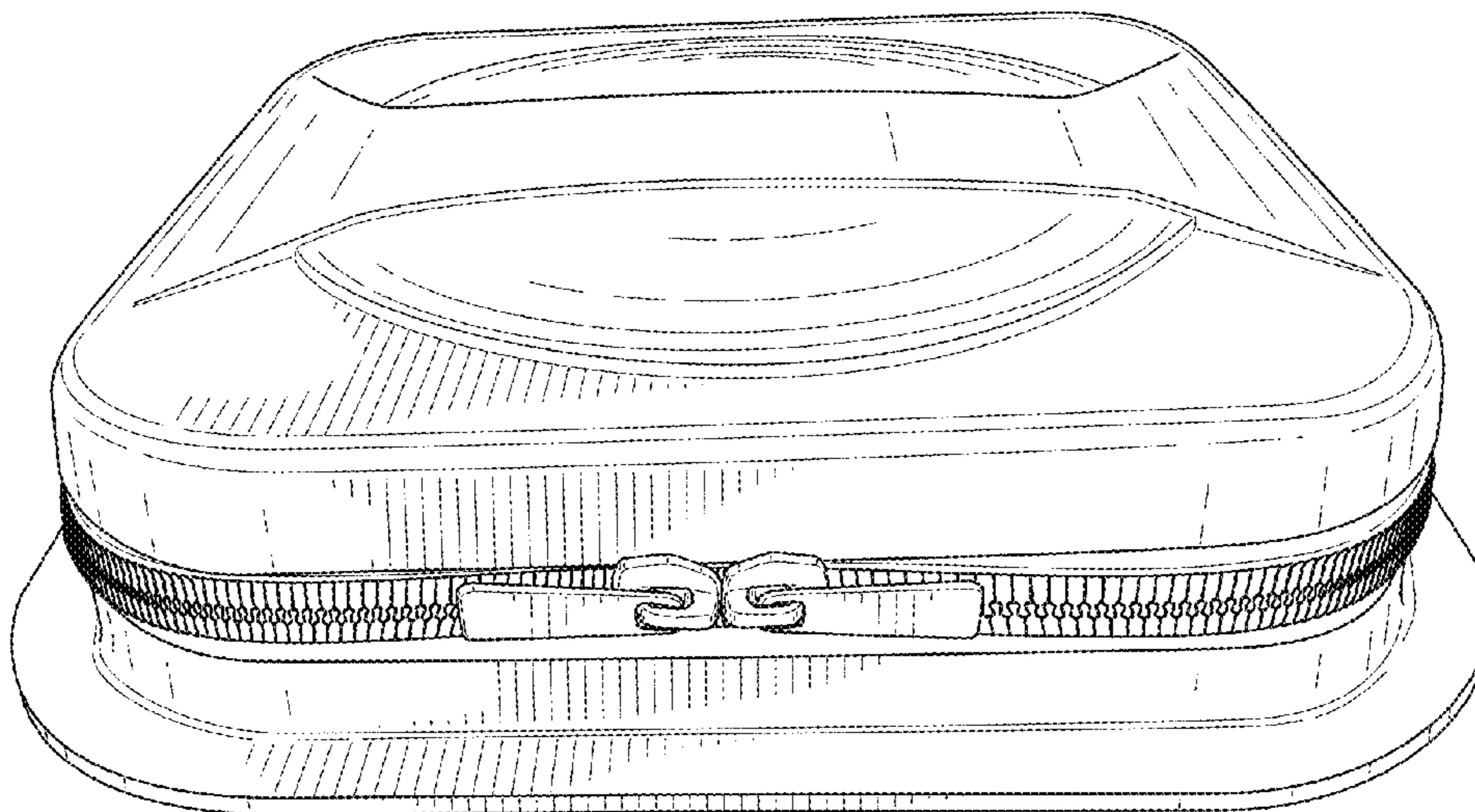
(57) **CLAIM**

We claim, the ornamental design for a molded cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a molded cover, showing my new design;
FIG. 2 is a top plan view of the molded cover of FIG. 1;
FIG. 3 is a front view of the embodiment shown in FIG. 1;
FIG. 4 is a back view of the embodiment shown in FIG. 1;

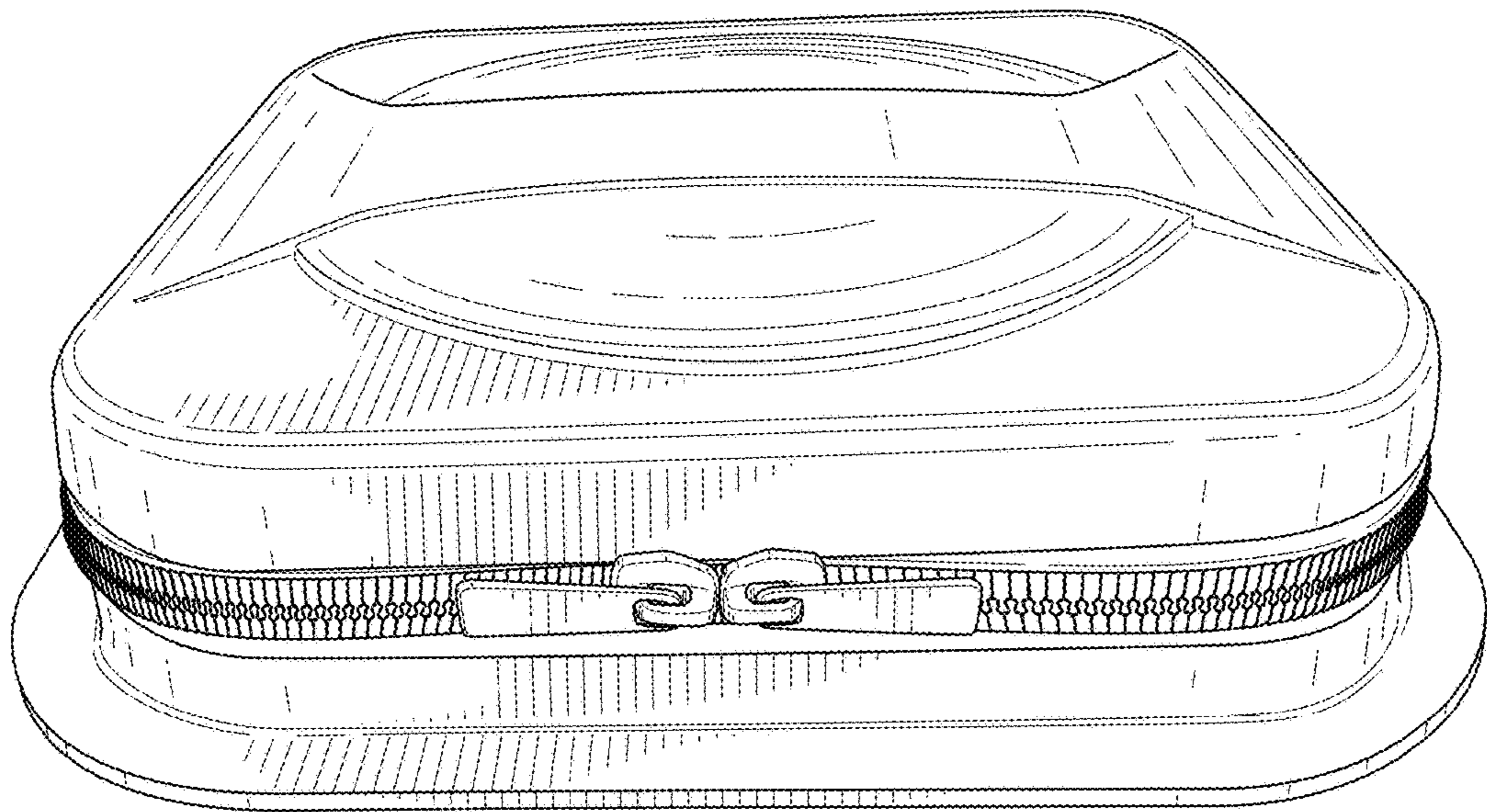

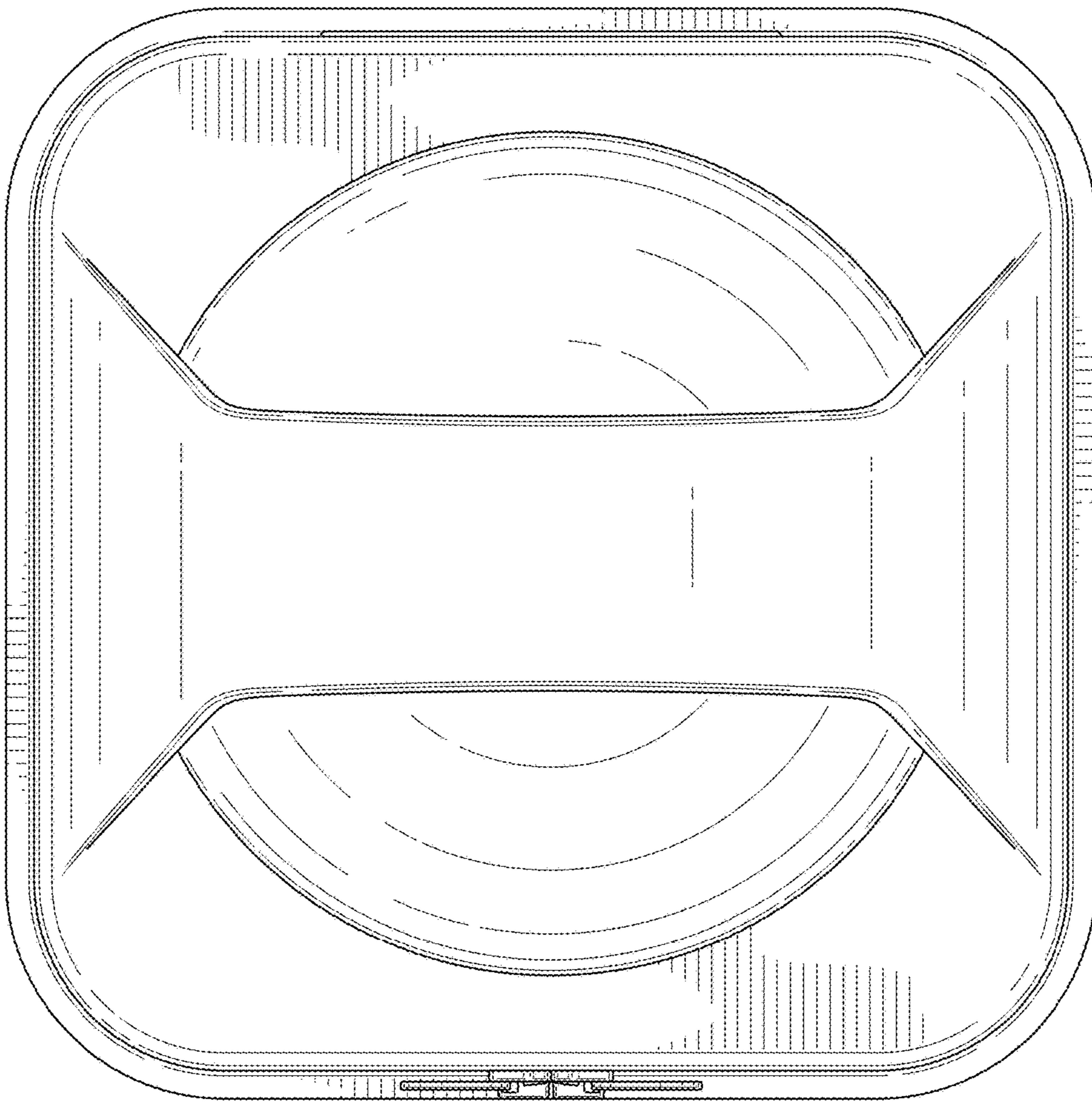

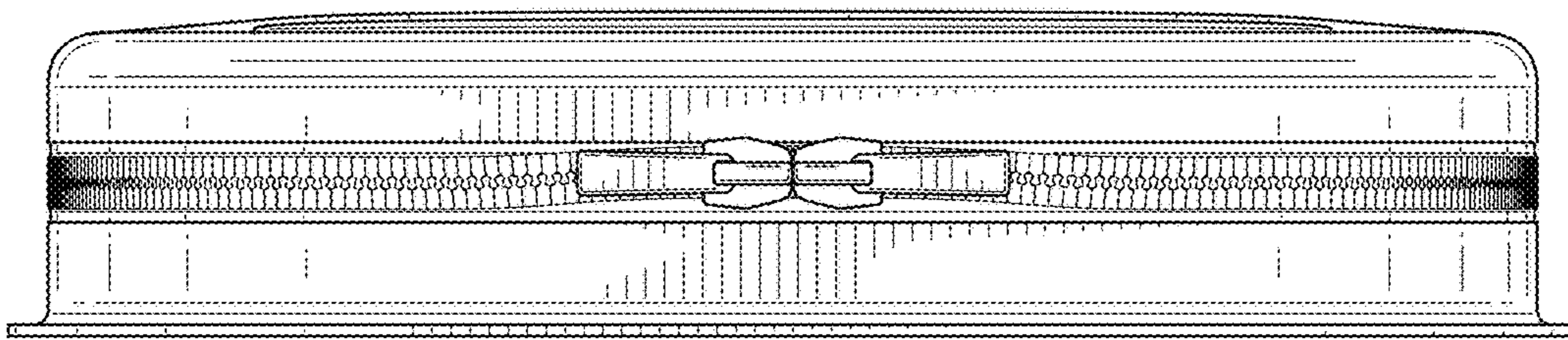

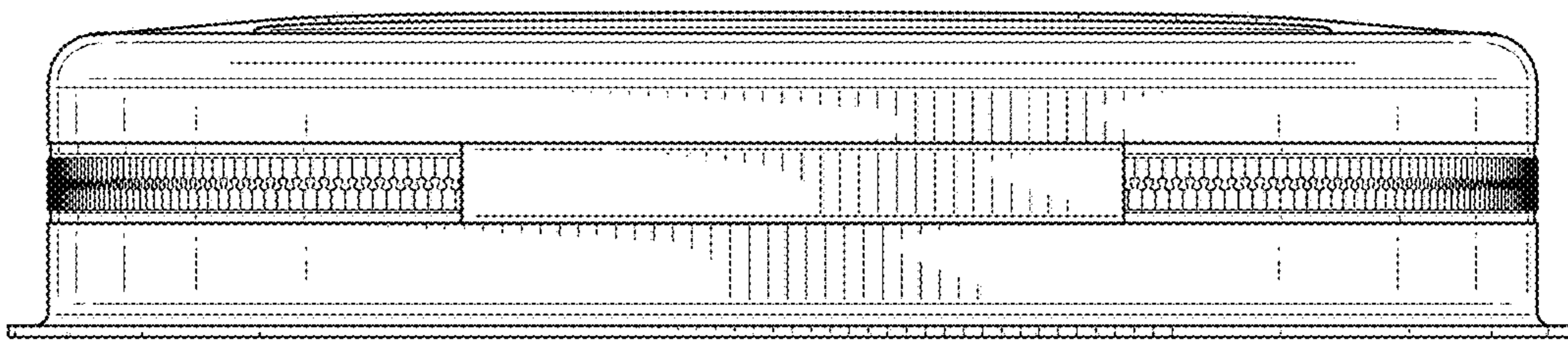

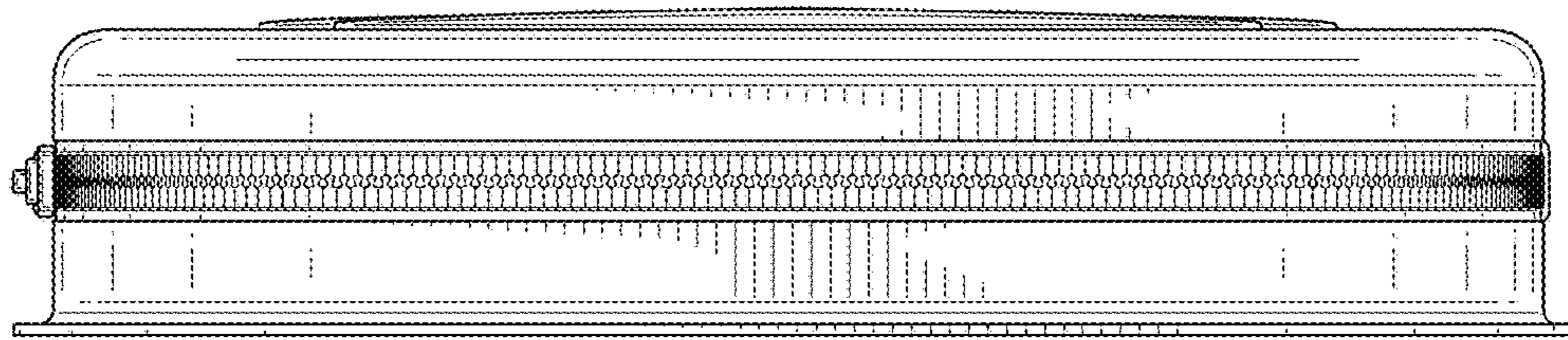

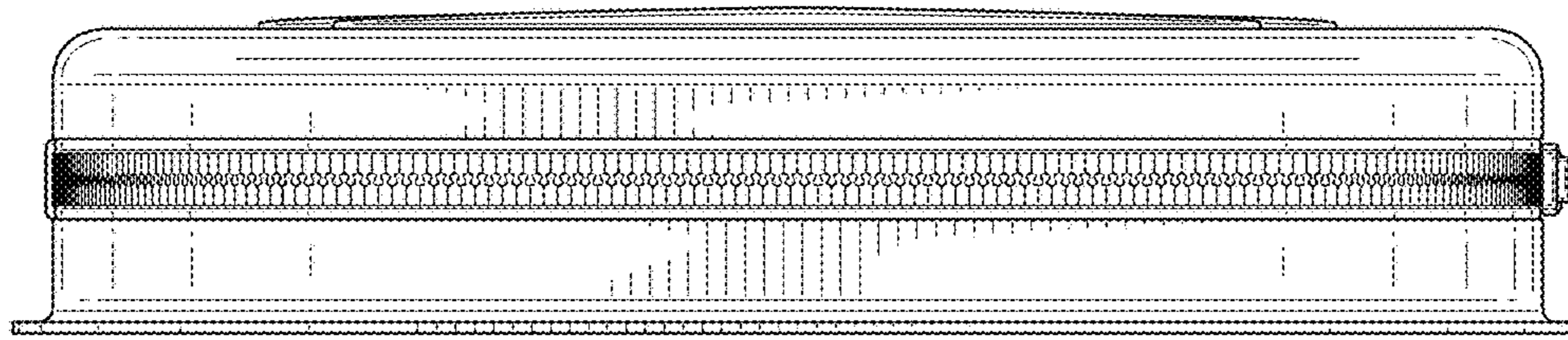
