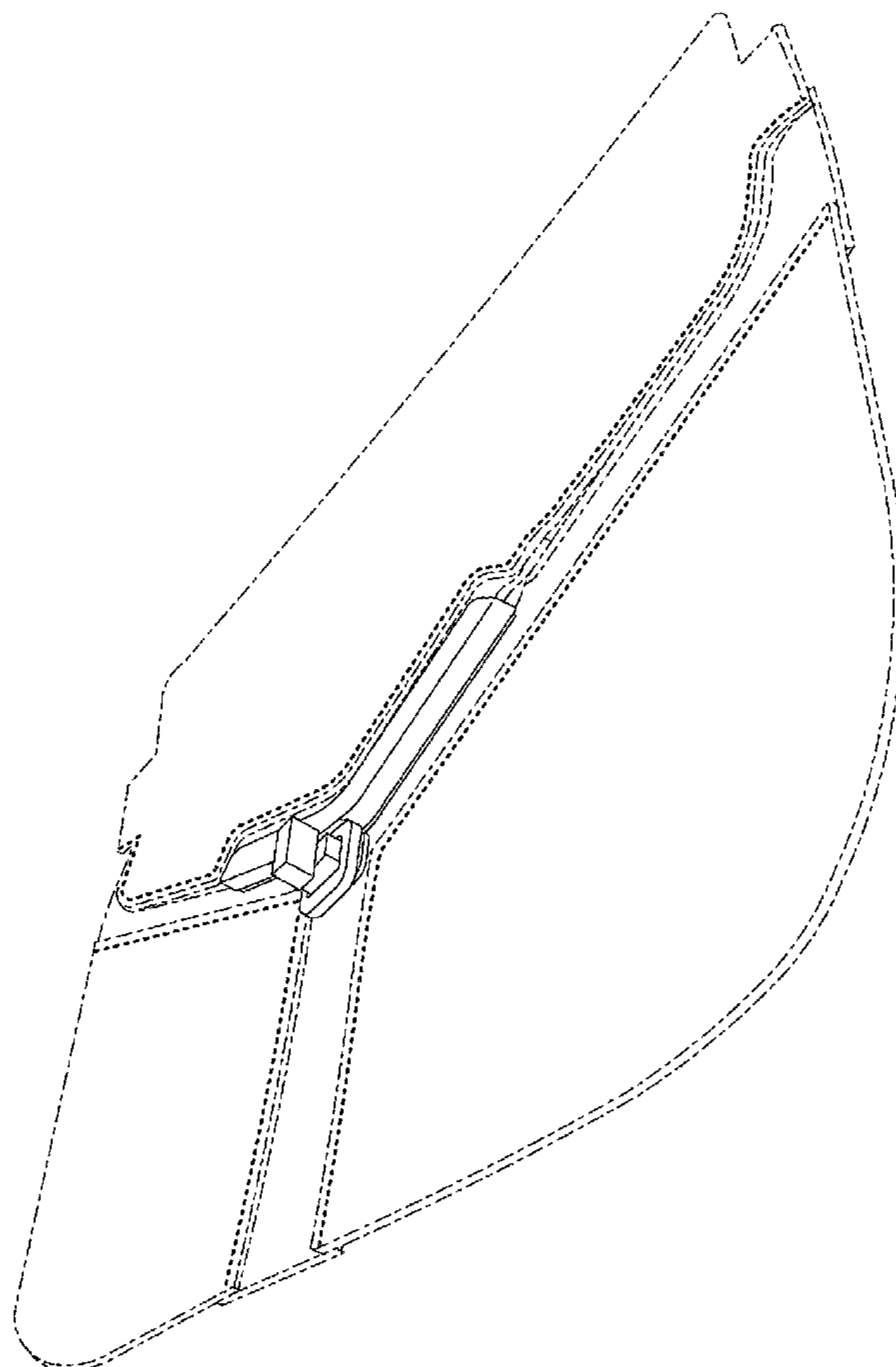
(57) **CLAIM**

I claim the ornamental design for a lock for a handbag, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a lock for a handbag in closed condition;  
FIG. 2 is a front elevation view of the lock;  
FIG. 3 is a top view of the lock;  
FIG. 4 is a bottom view of the lock;  
FIG. 5 is a left side elevation view of the lock;  
FIG. 6 is a right side elevation view of the lock;  
FIG. 7 is a rear elevation view of the lock; and,  
FIG. 8 is a front elevation view of the lock in open condition.  
The broken lines showing the handbag are for the purposes of illustrating environment and forms no part of the claimed design.

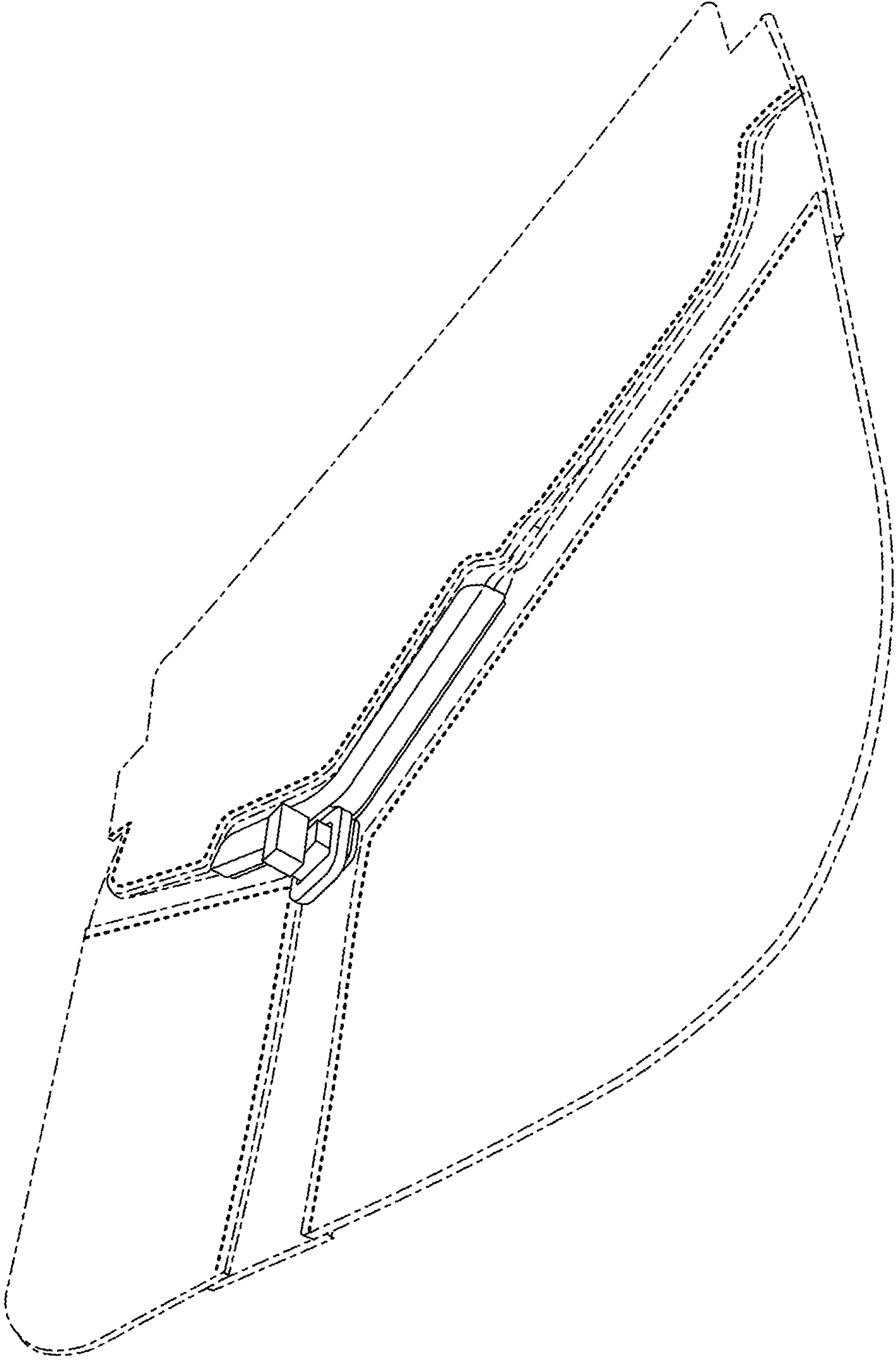
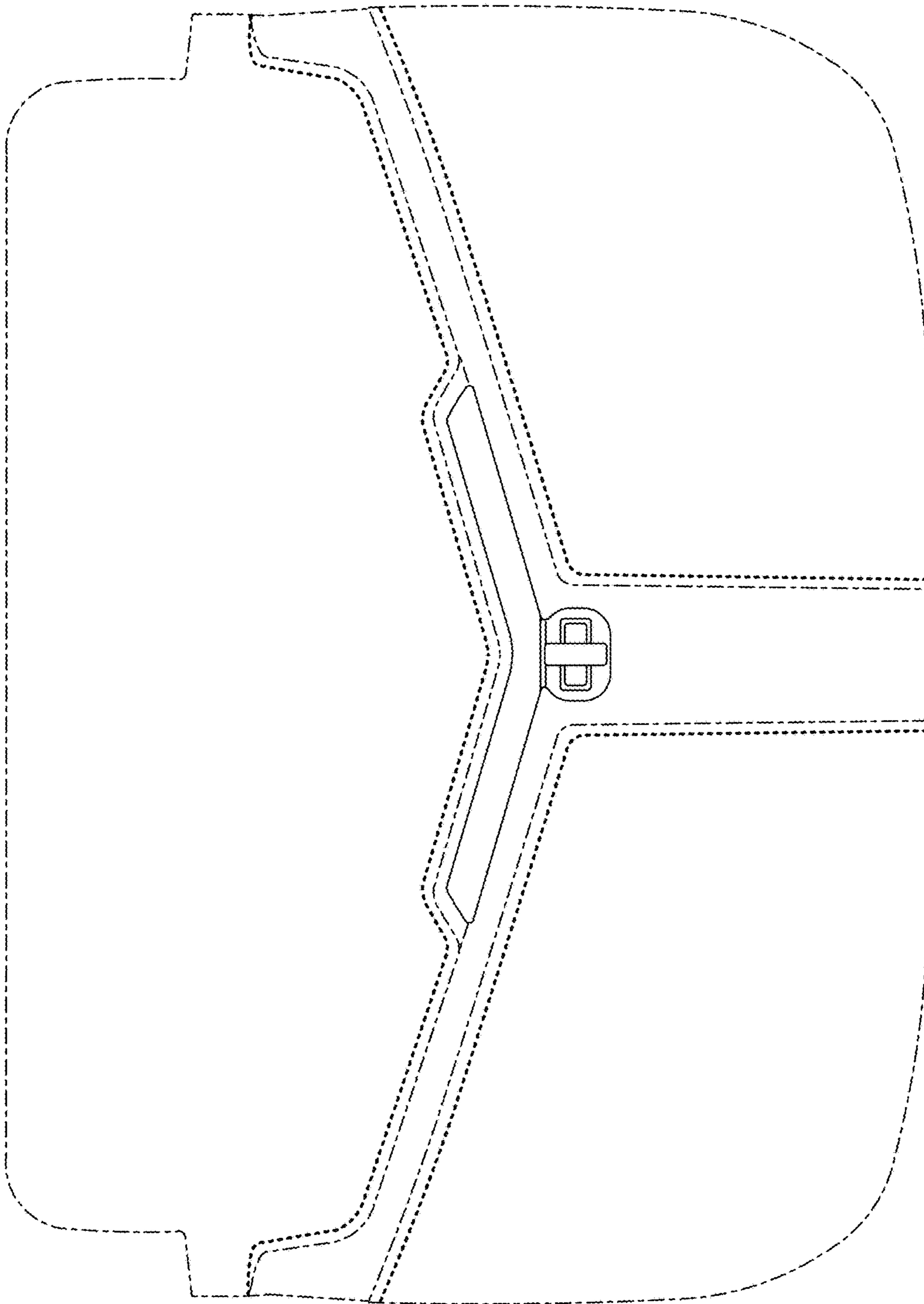

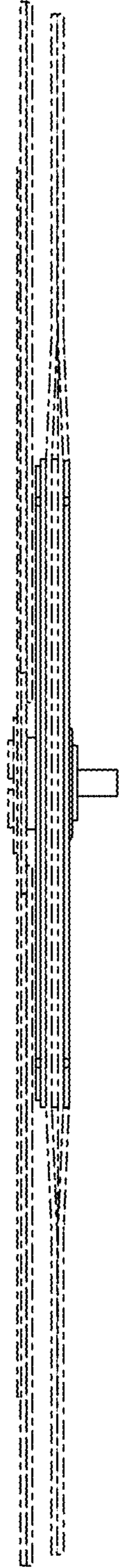

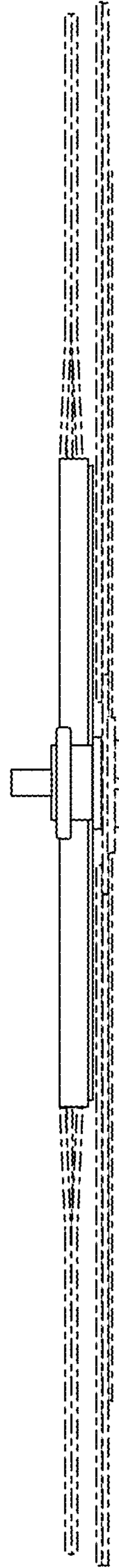

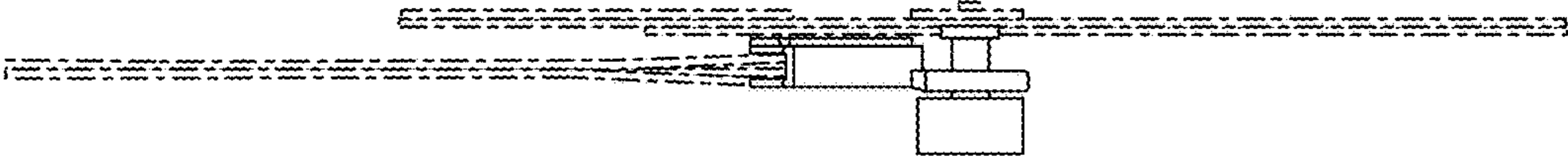

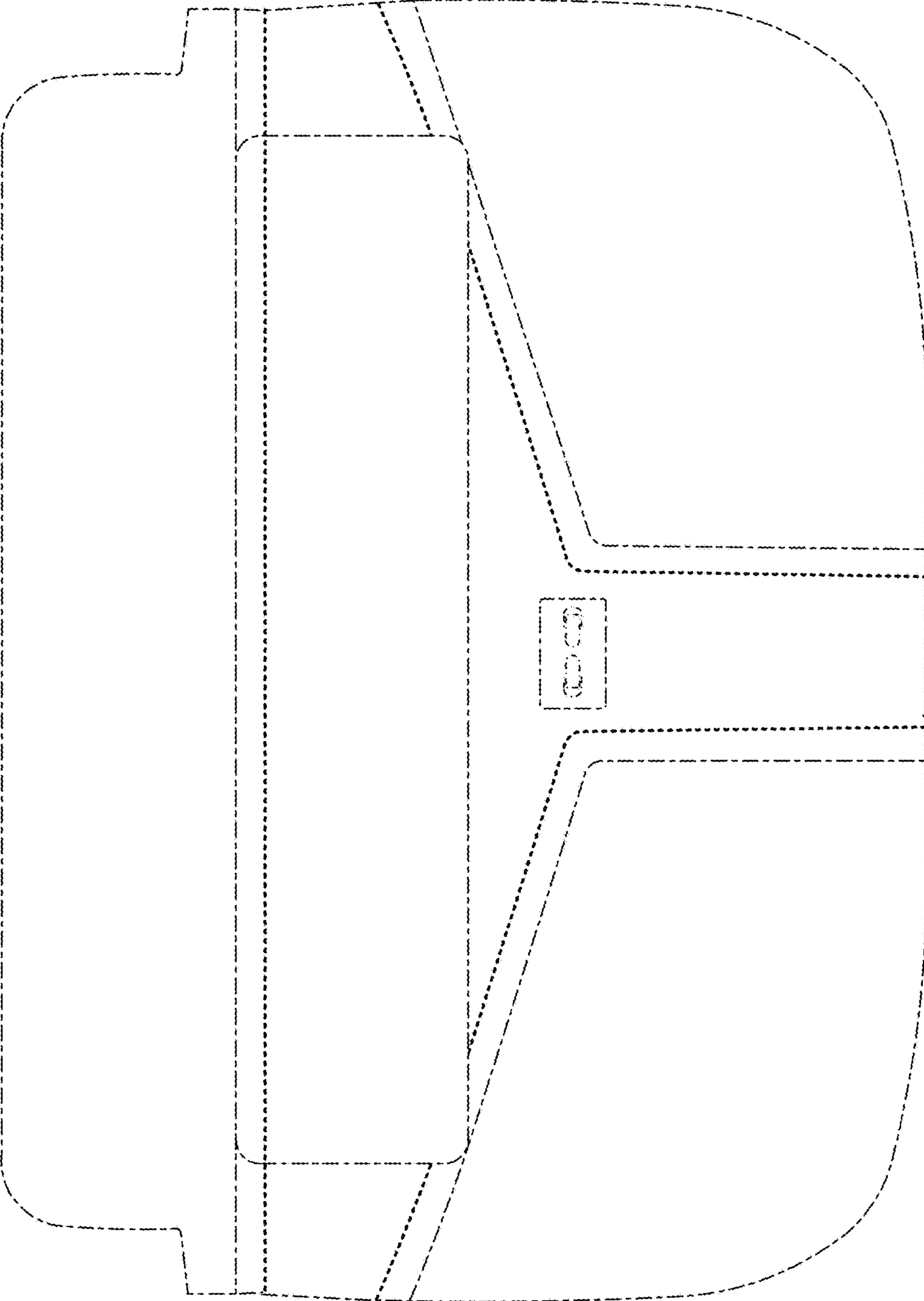
