(57) **CLAIM**

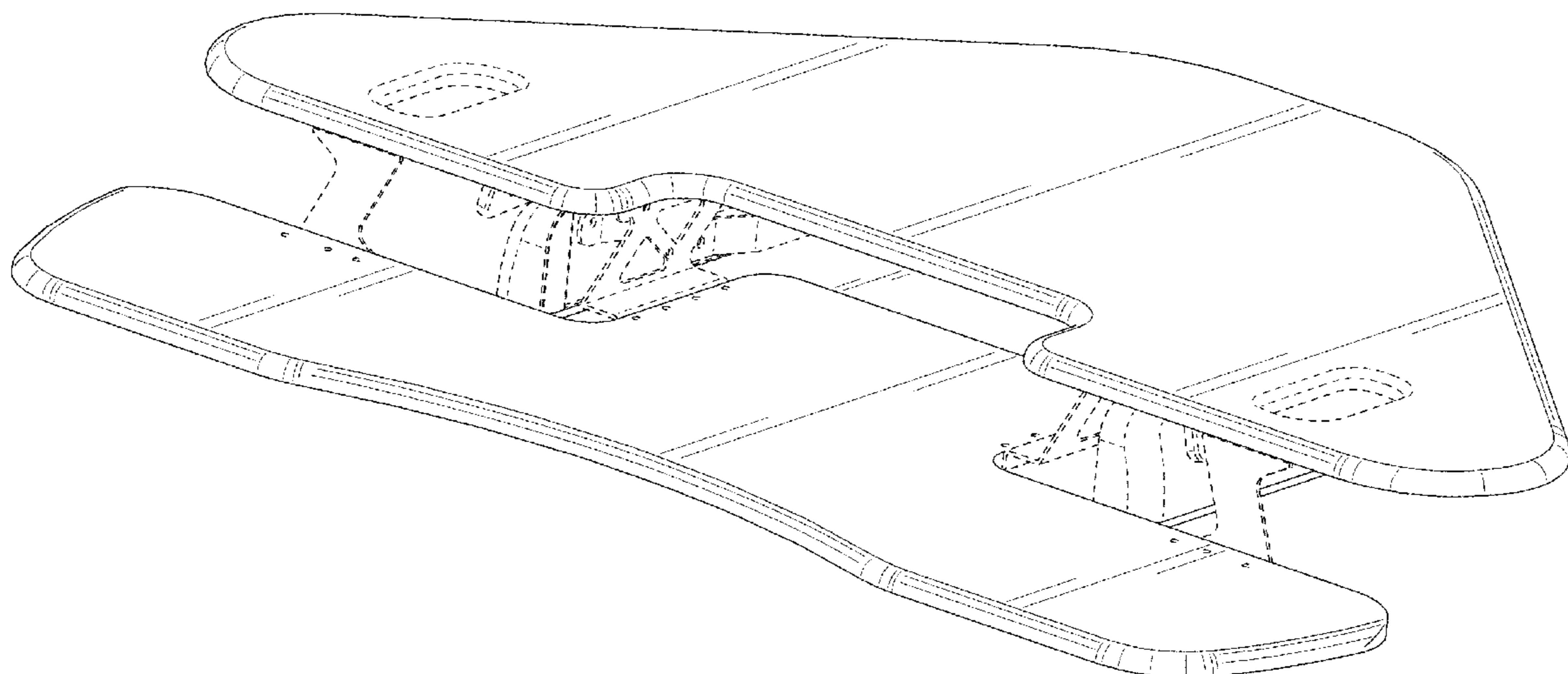
The ornamental design for a desk, as shown and described.

**DESCRIPTION**

FIG. 1 is a front-right perspective view of a desk according  
to the claimed design shown in a lowered position;

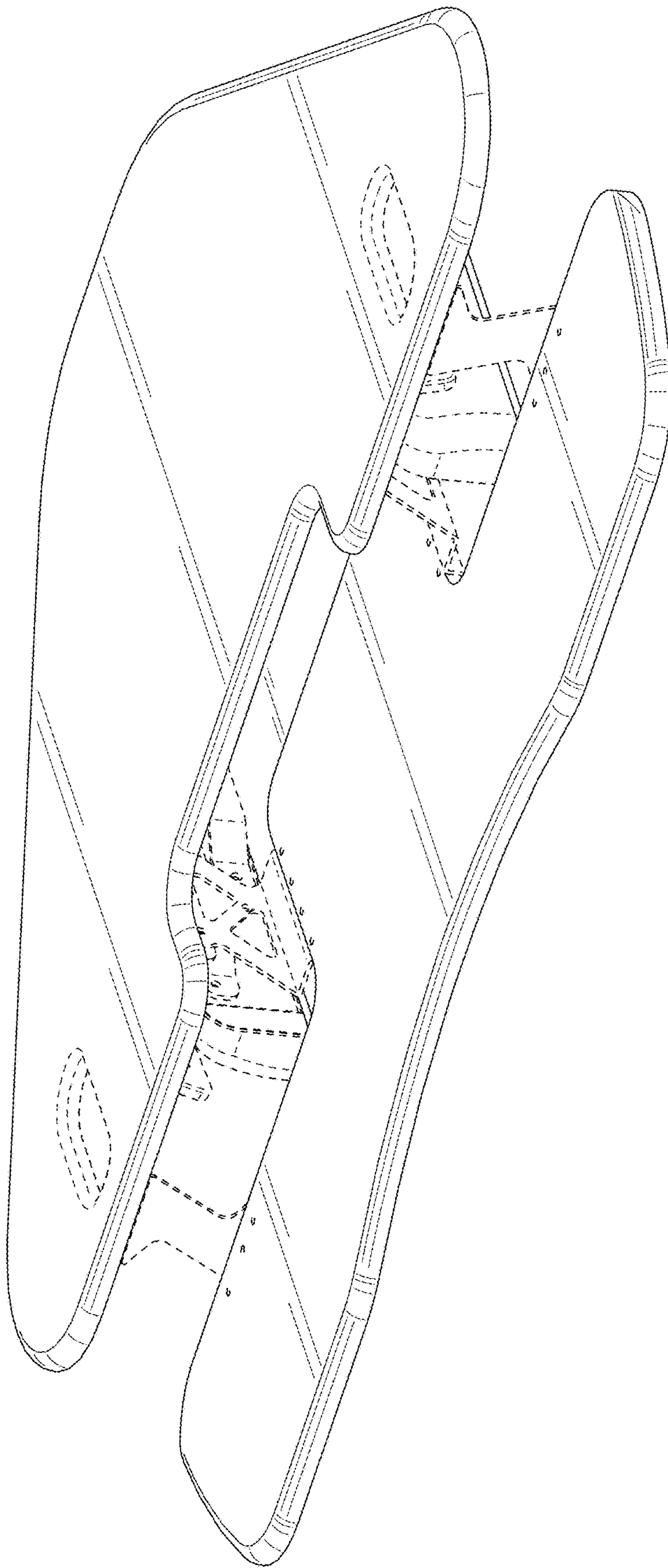

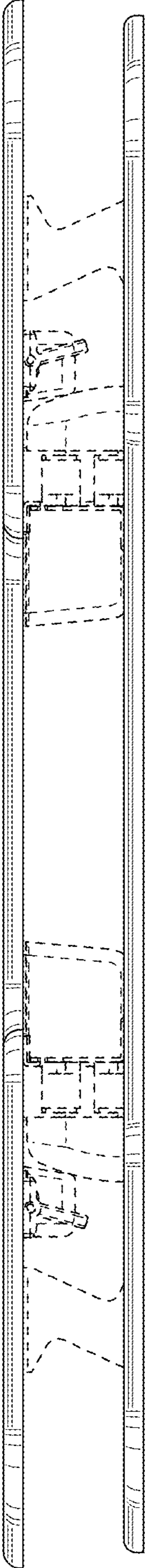

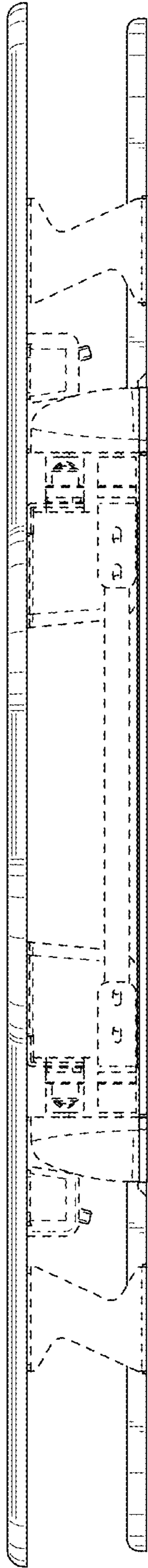

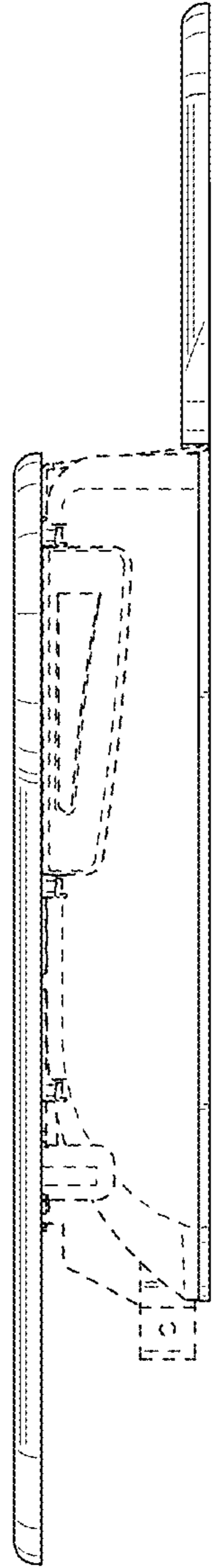

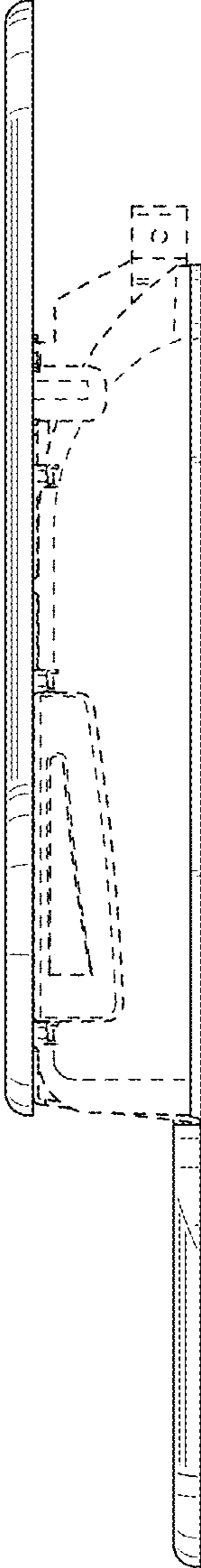

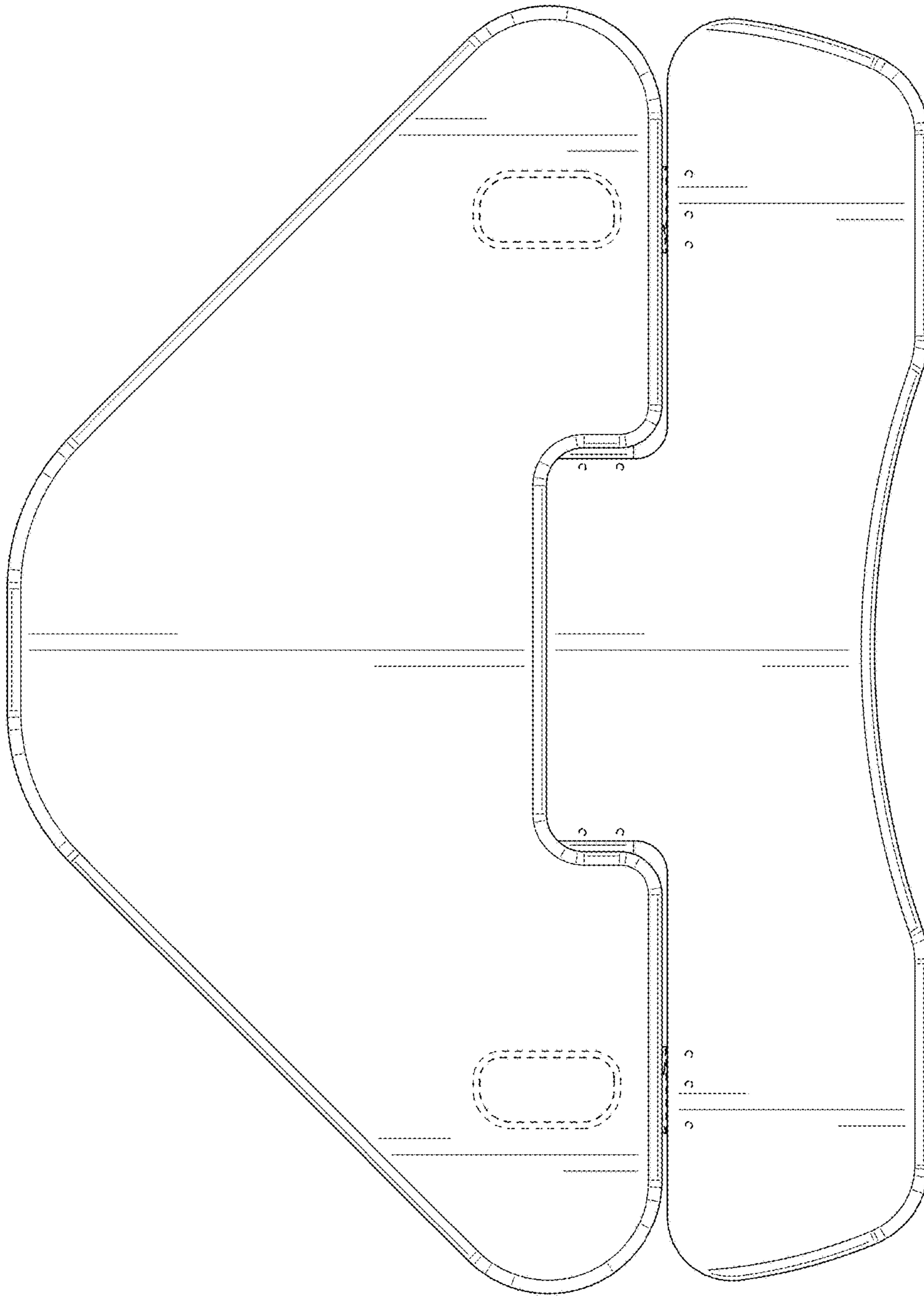

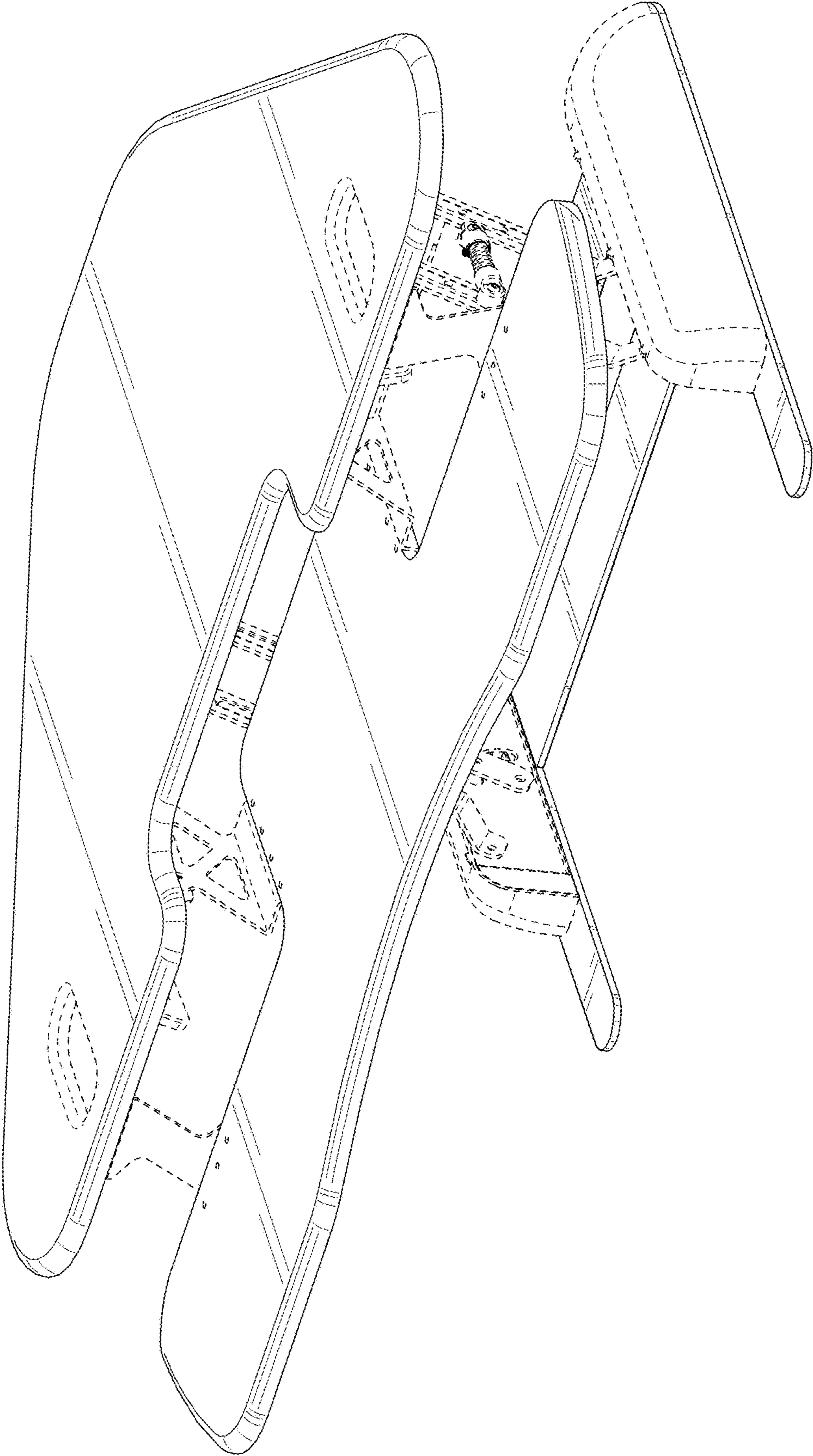
