(57) **CLAIM**

The ornamental design for a demolition tool head, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of the demolition tool head according to the new design.

The portions of the demolition tool and demolition tool head shown in broken lines are environmental only and form no part of the claimed design.

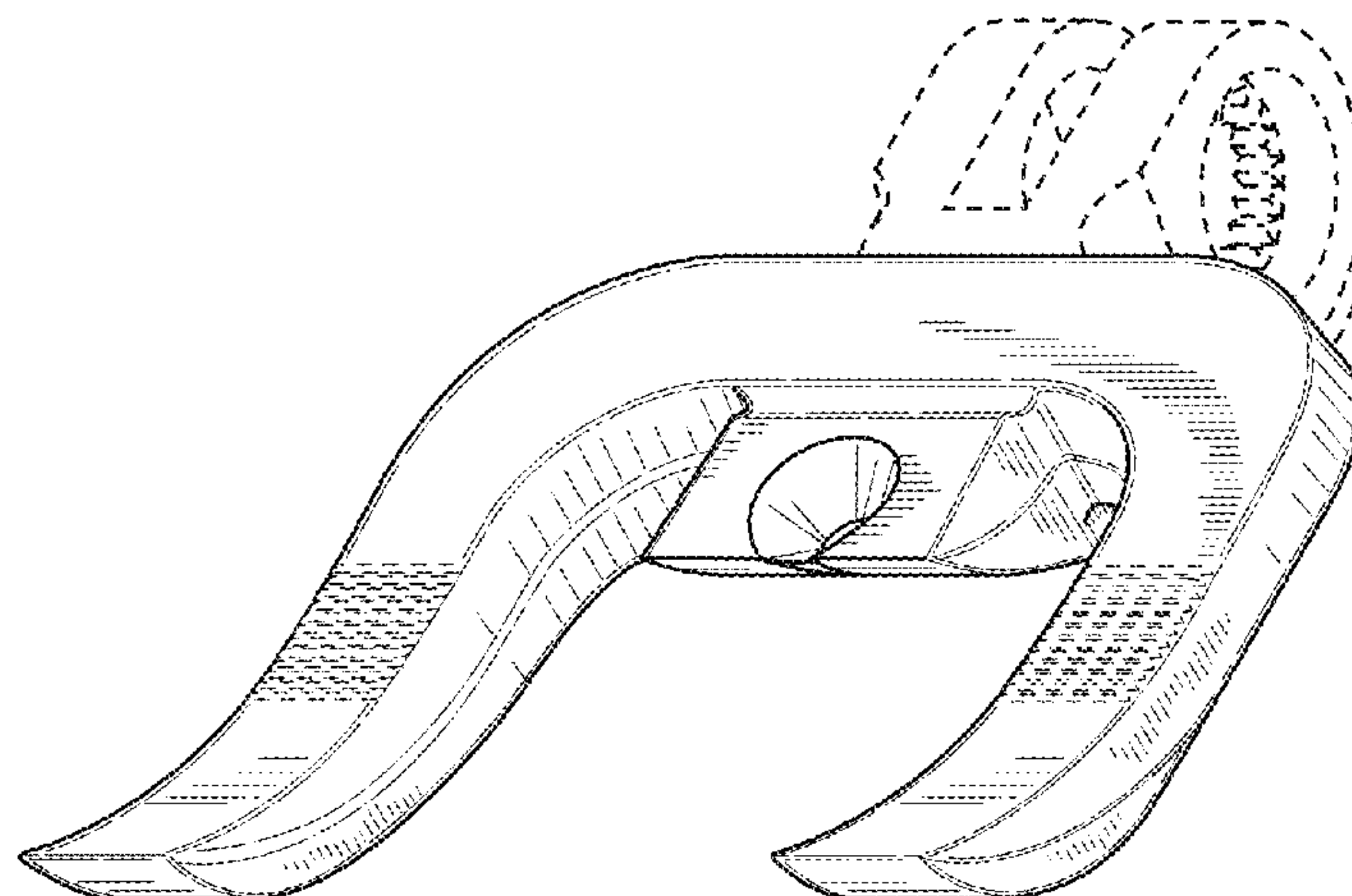

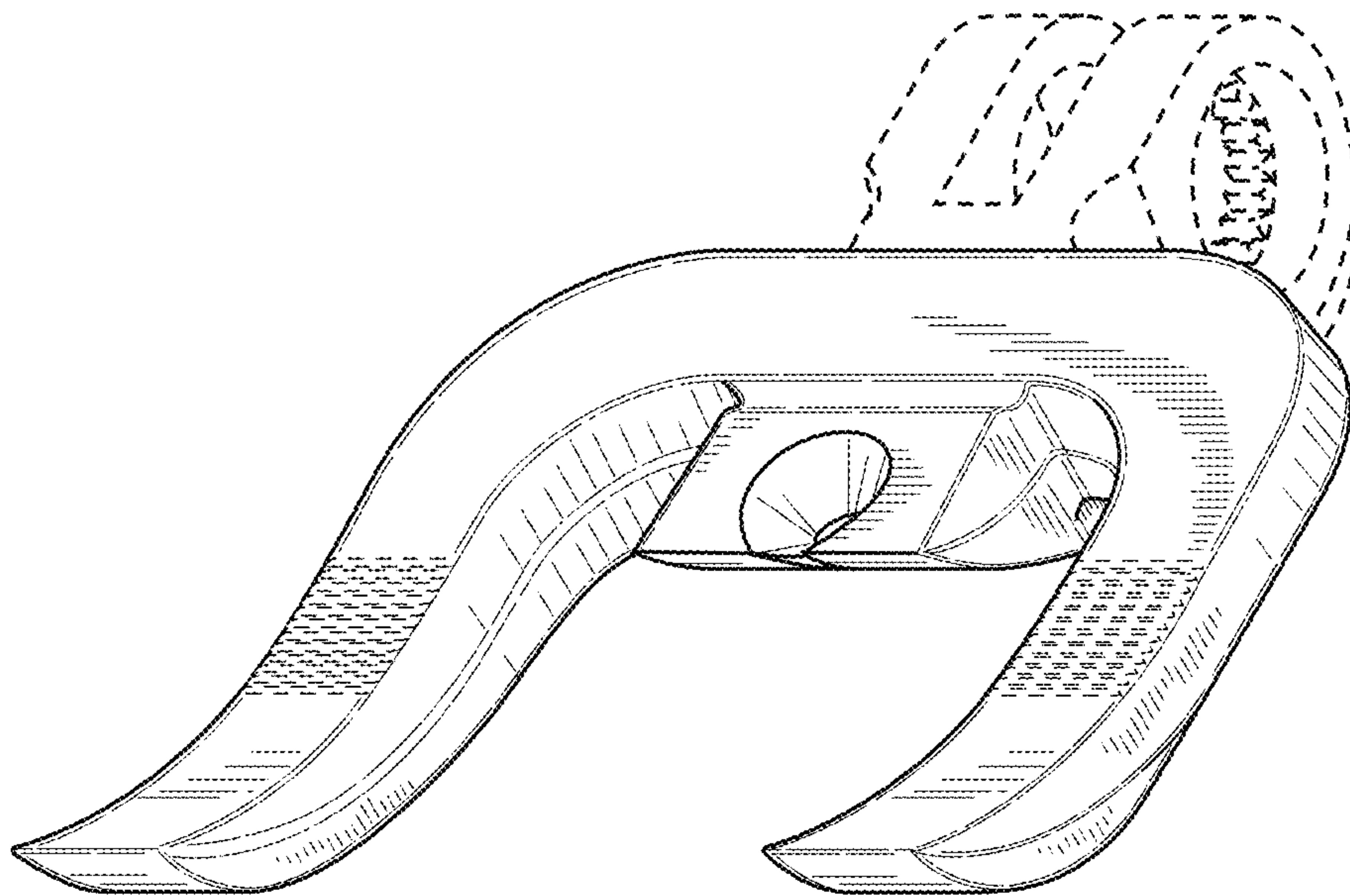

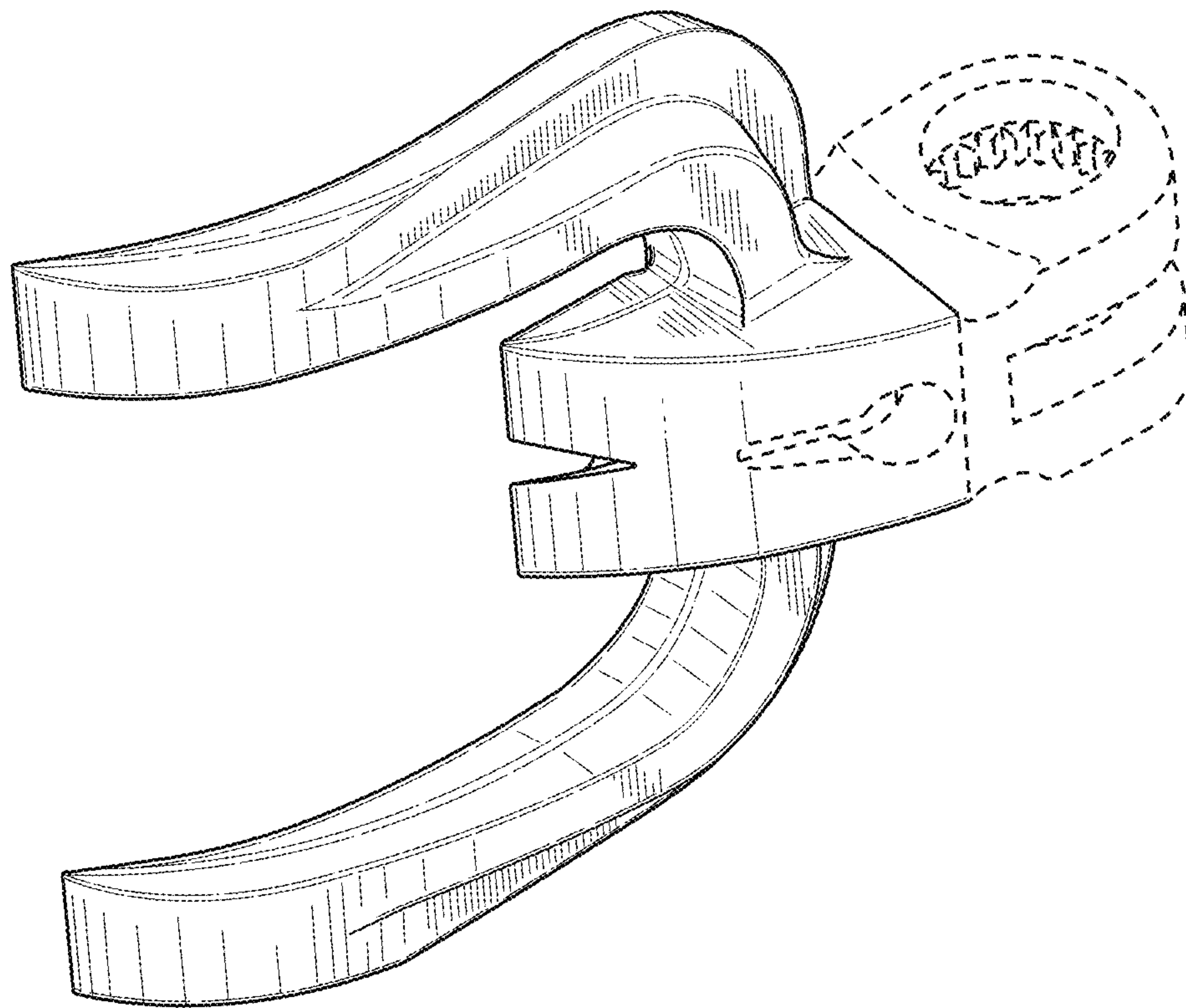

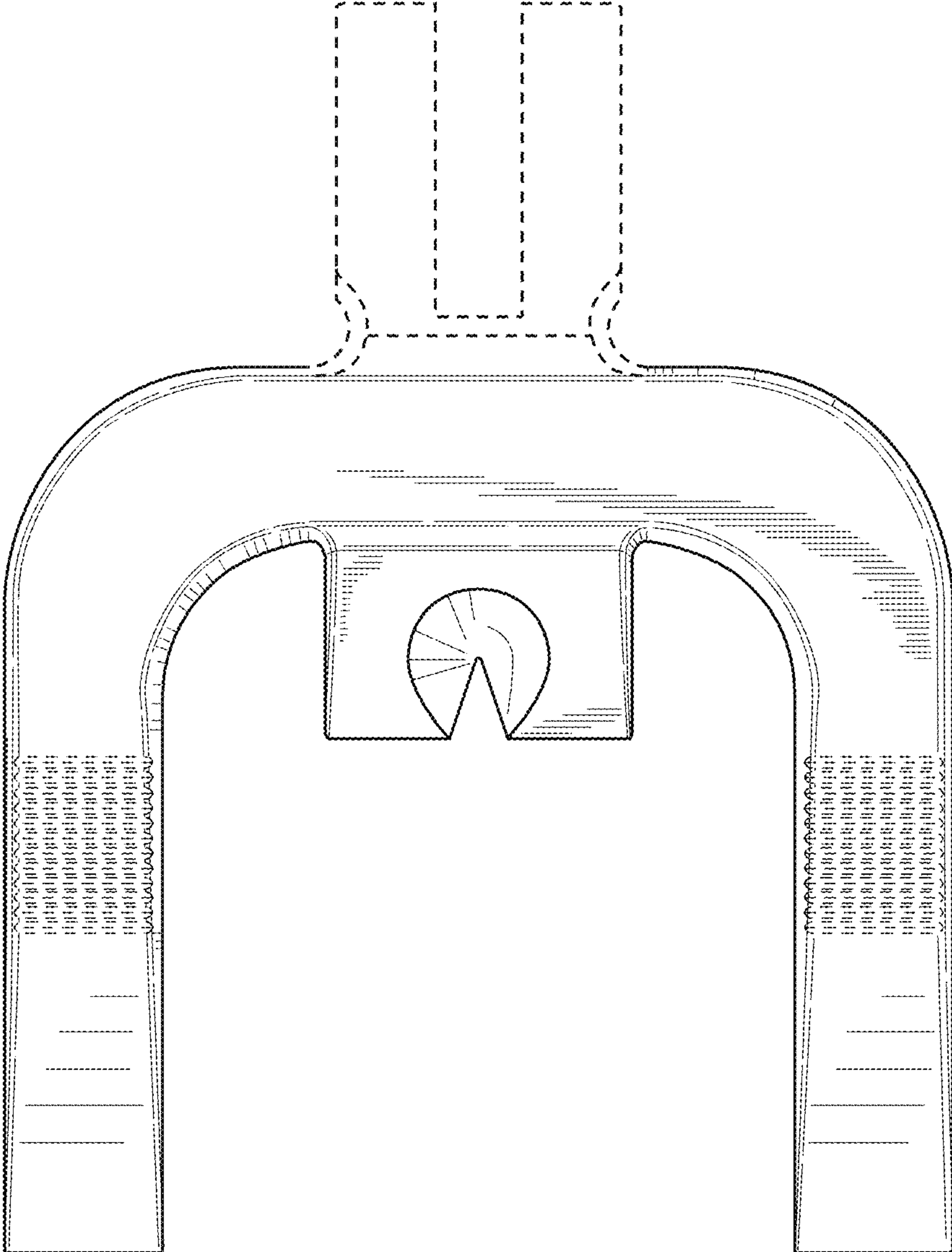

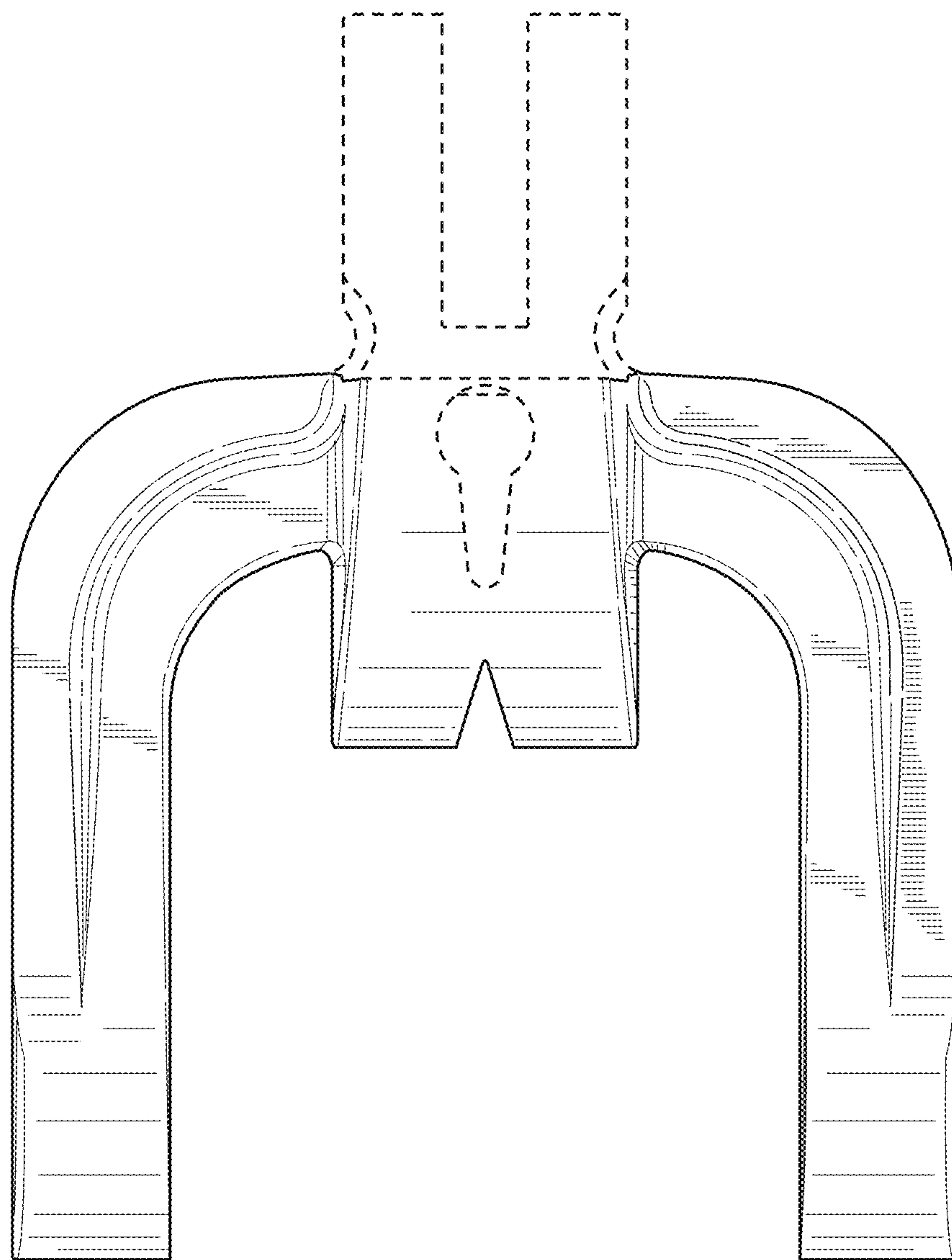

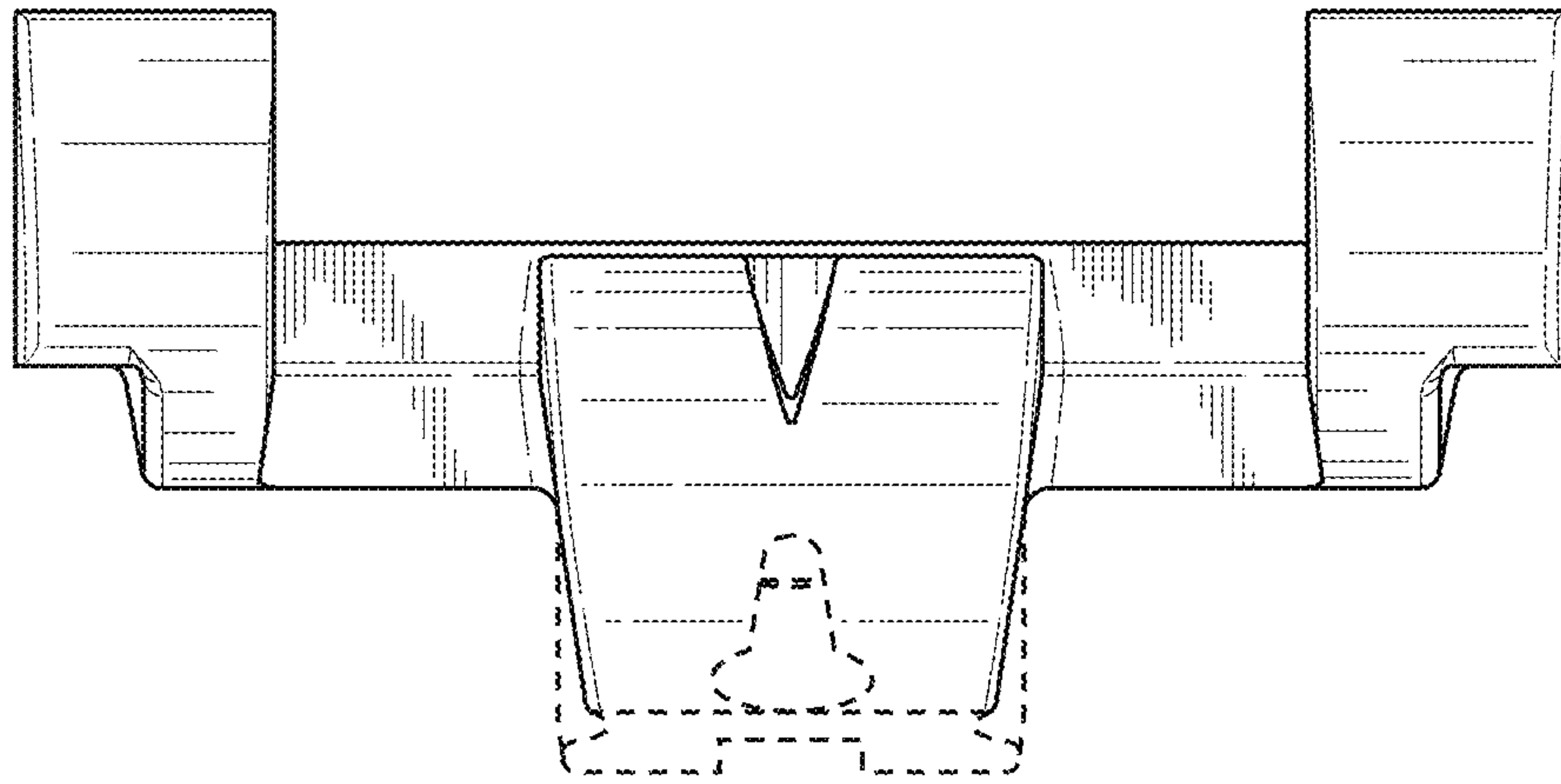

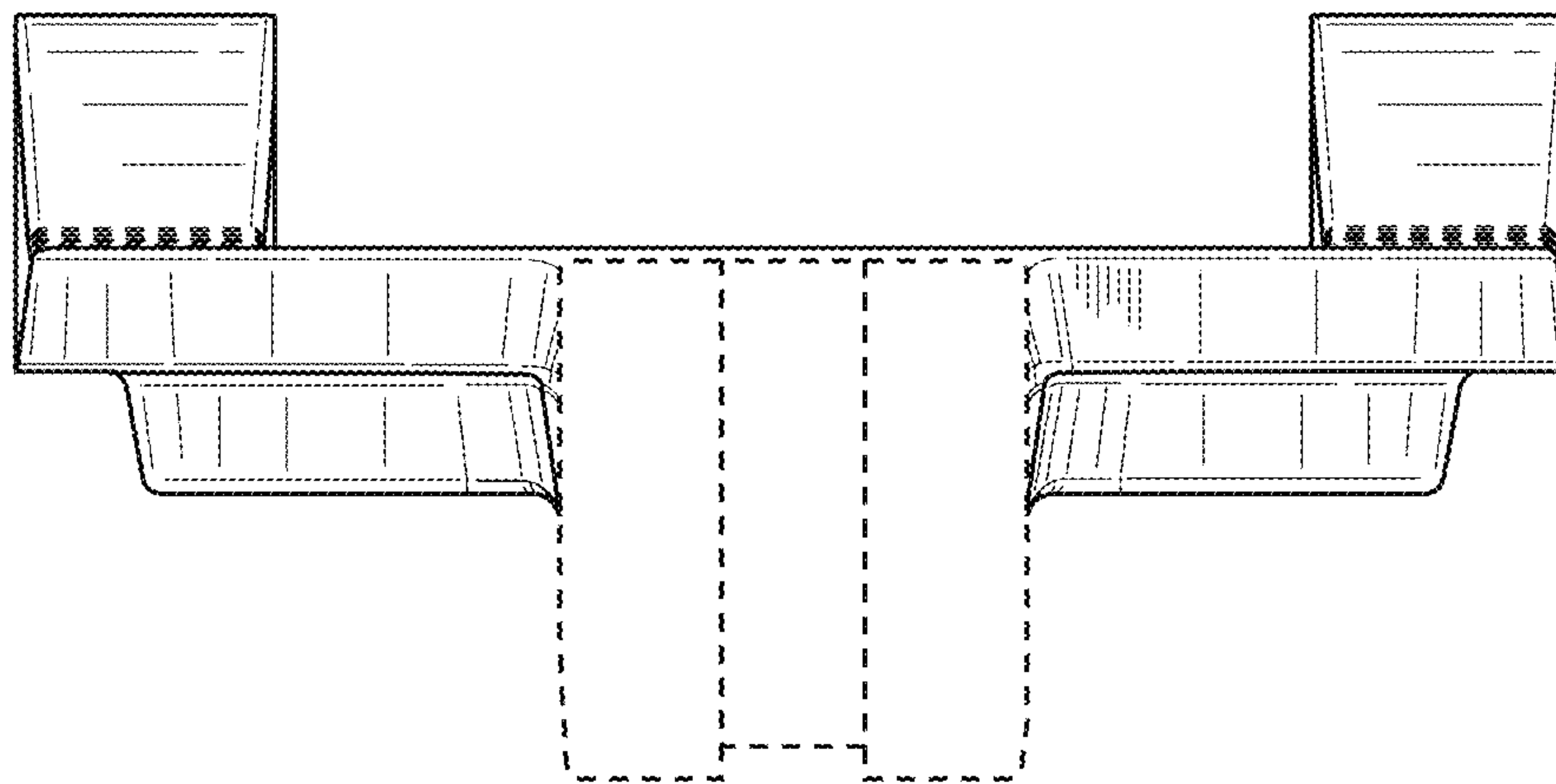

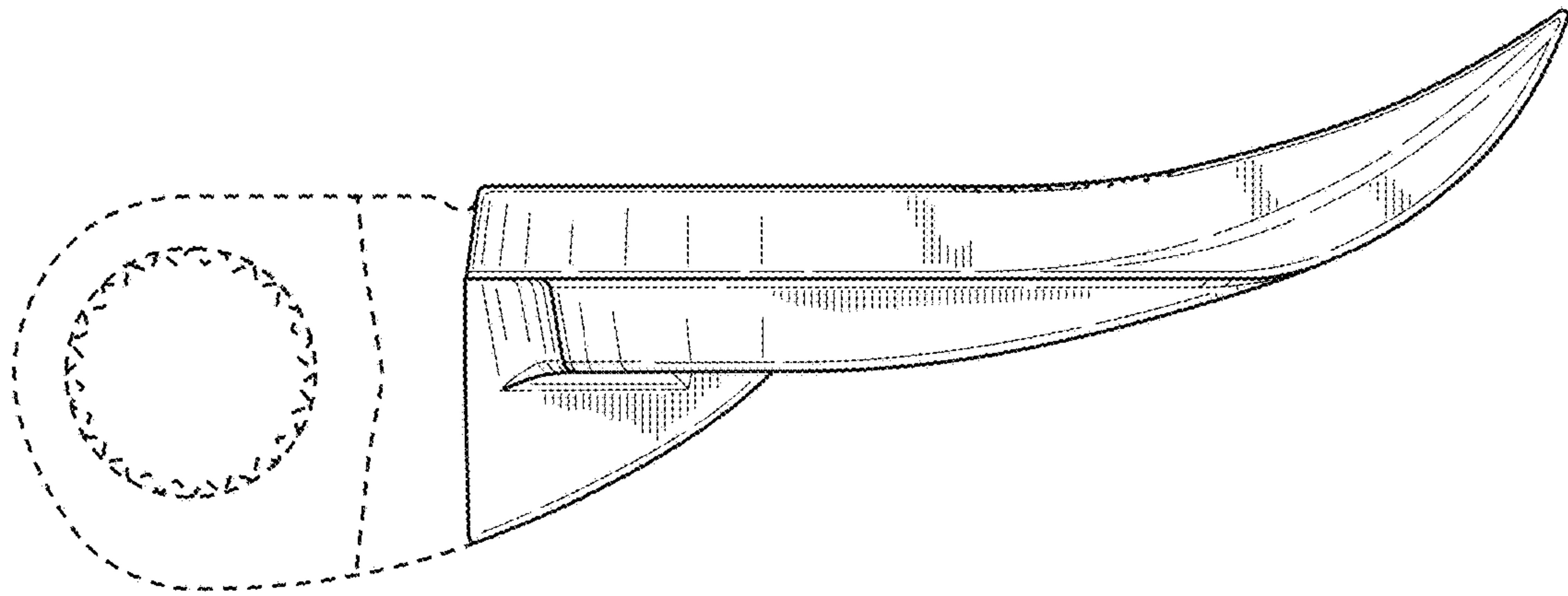

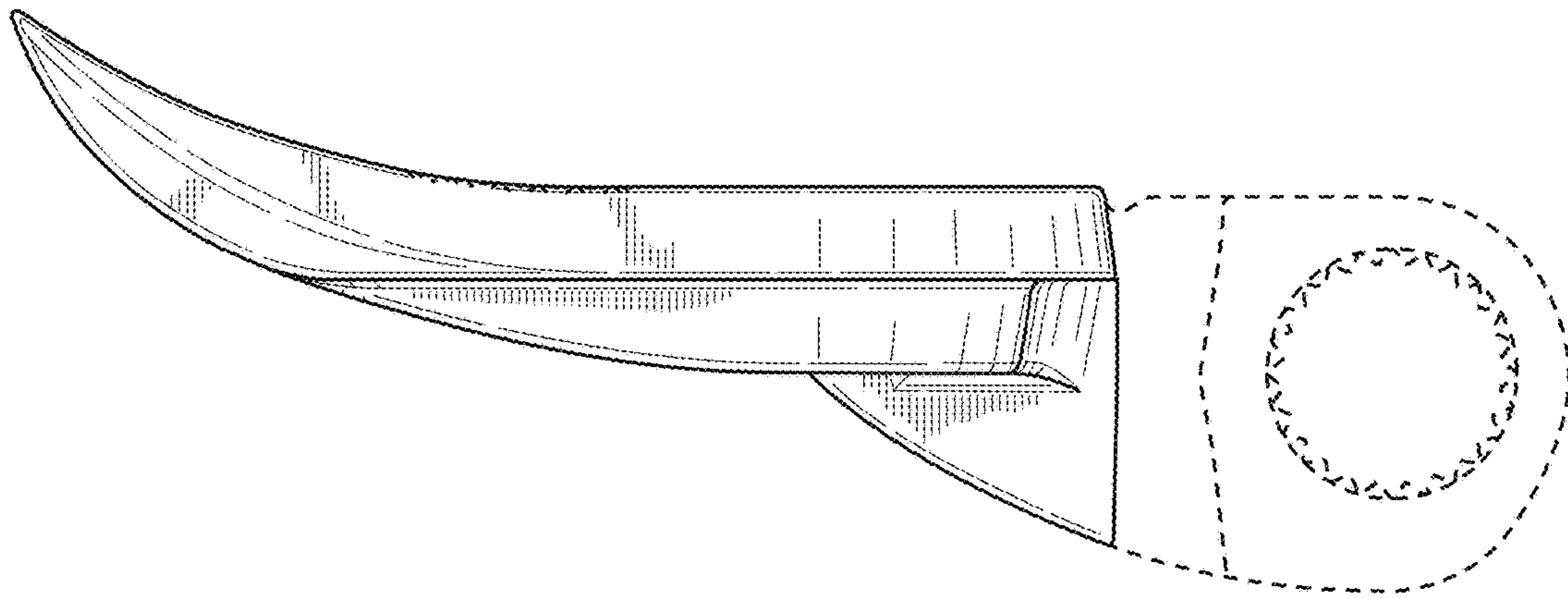

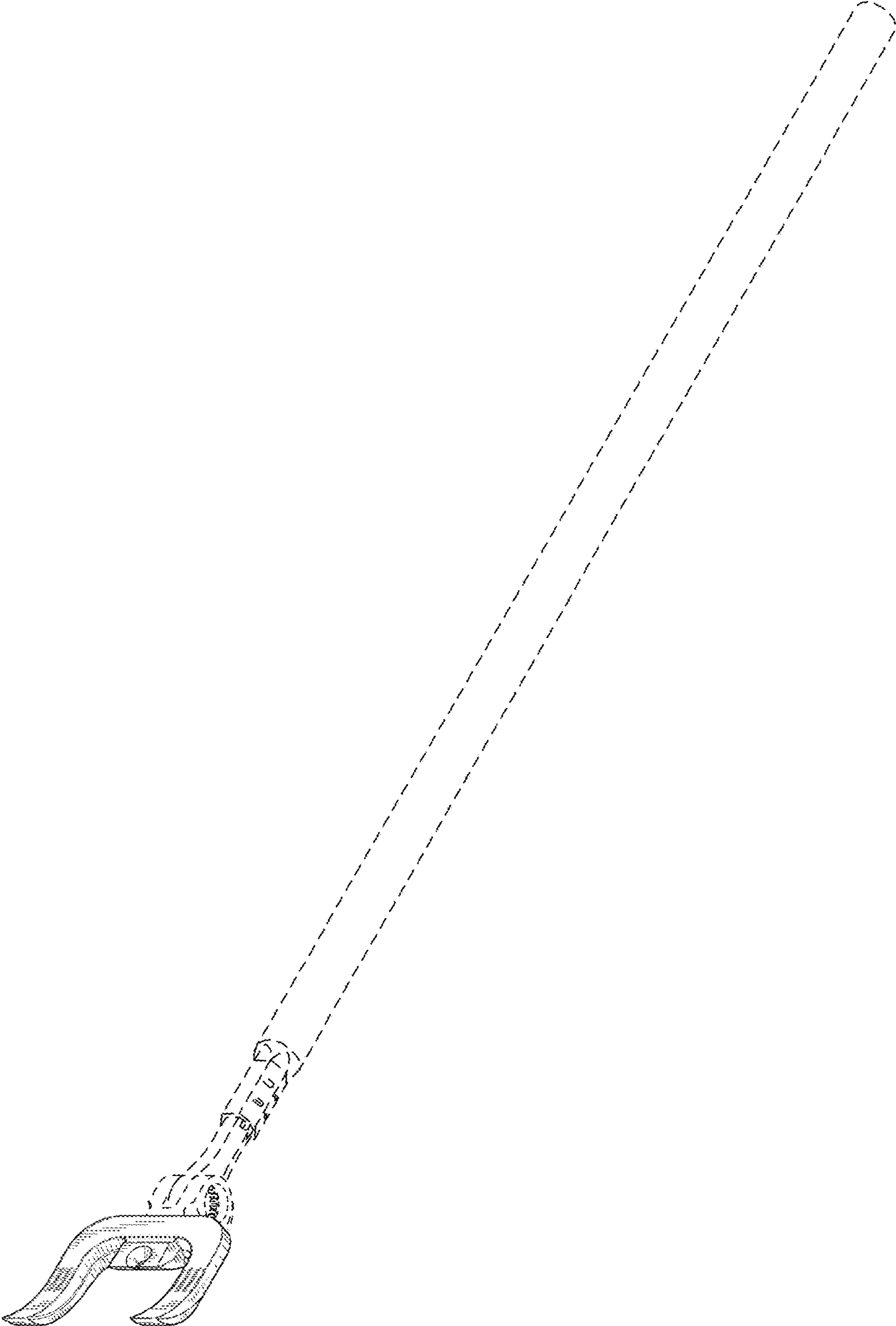
