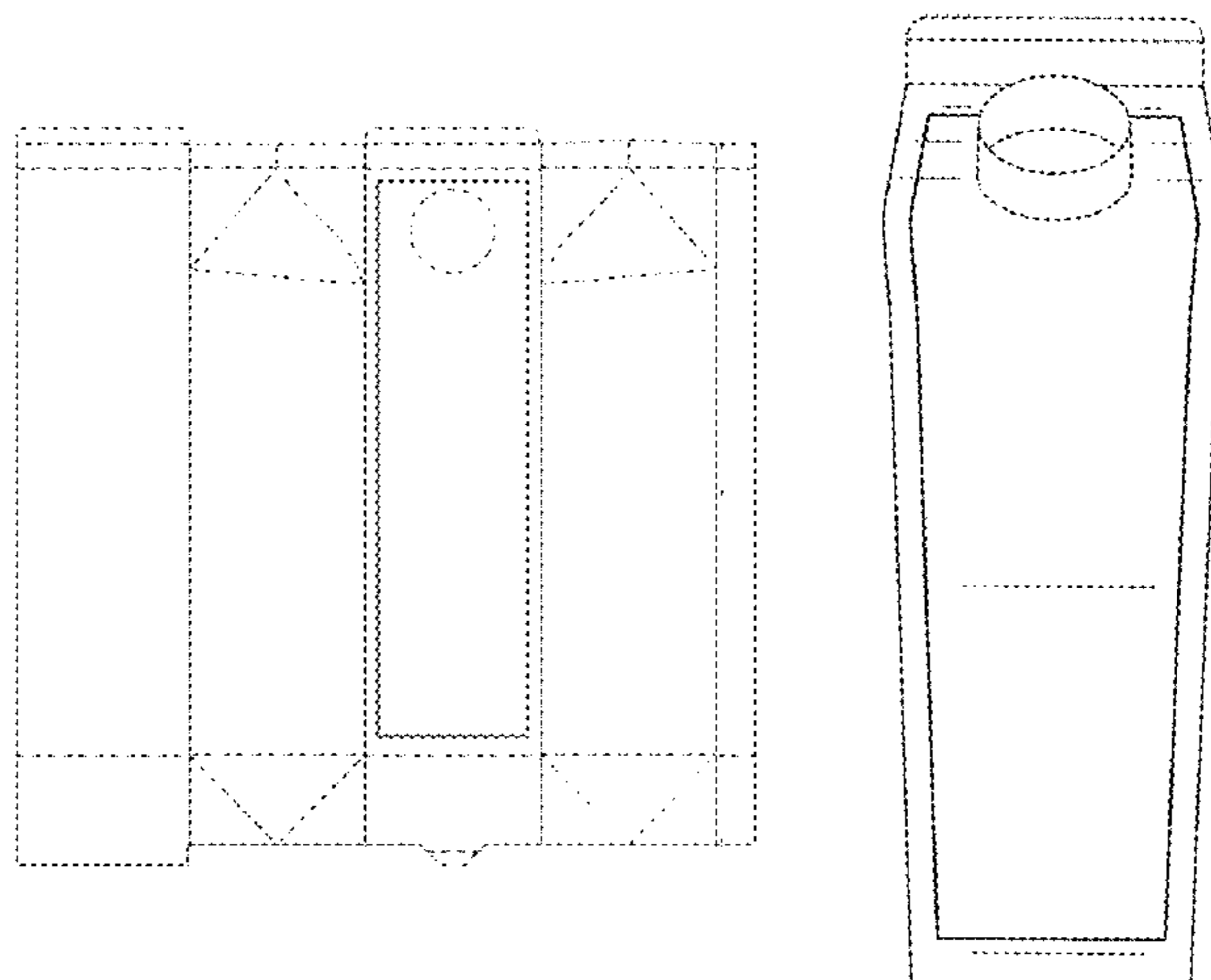
(57) **CLAIM**

The ornamental design for a packaging and blank therefor,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a plan view of a packaging and blank therefor  
shown in an unfolded state showing our new design.  
FIG. 2 is a rear elevational view of the packaging and blank  
therefor shown in an erected configuration.  
FIG. 3 is a front elevational view thereof.  
FIG. 4 is left side elevational view thereof, the other side  
being a mirror image thereof.  
FIG. 5 is a rear plan view of the packaging and blank  
therefor shown in FIG. 1 in a folded state; and,  
FIG. 6 is a front plan view of the packaging and blank  
therefor shown in FIG. 5.

environmental purposes only and form no part of the

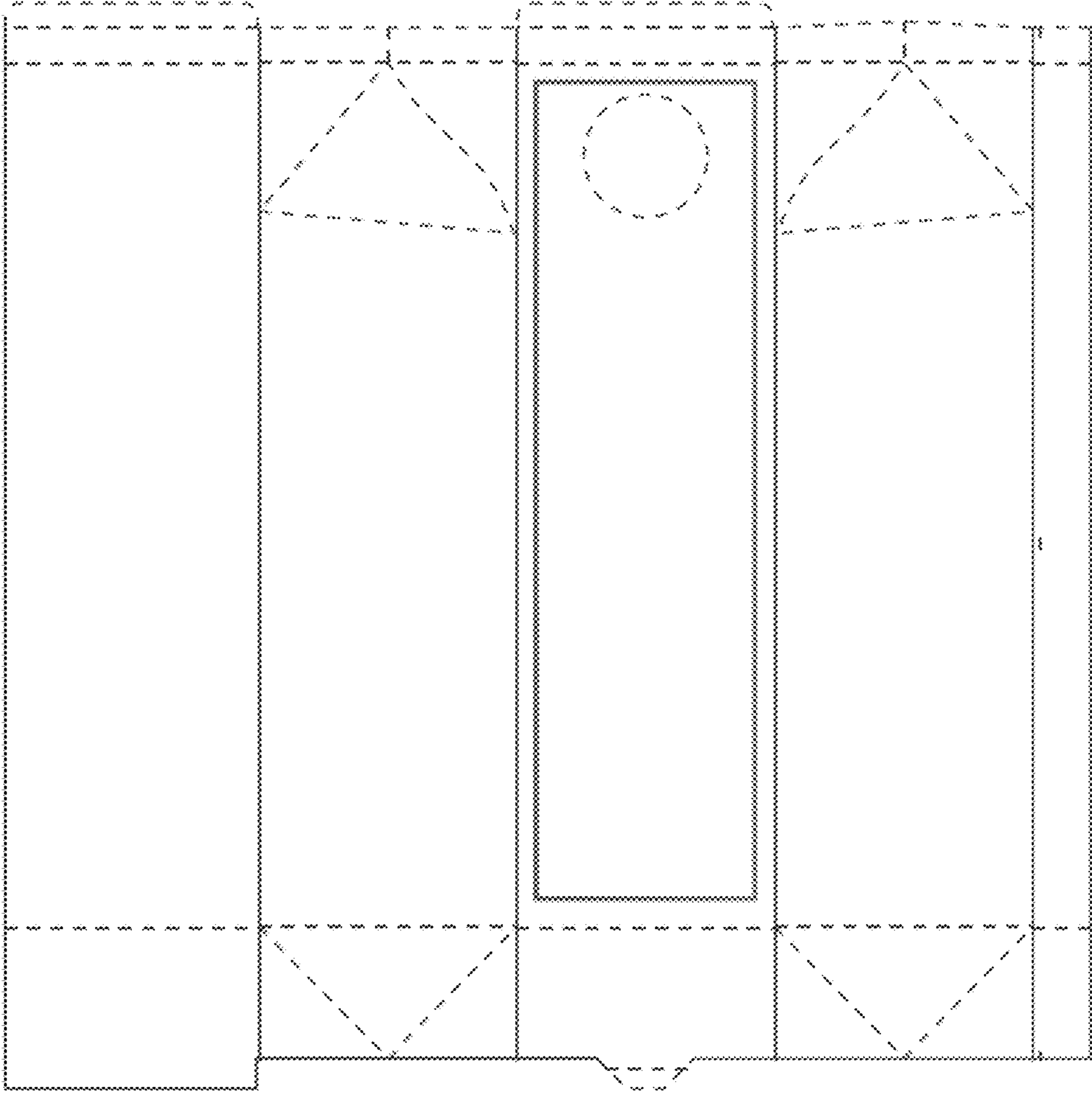

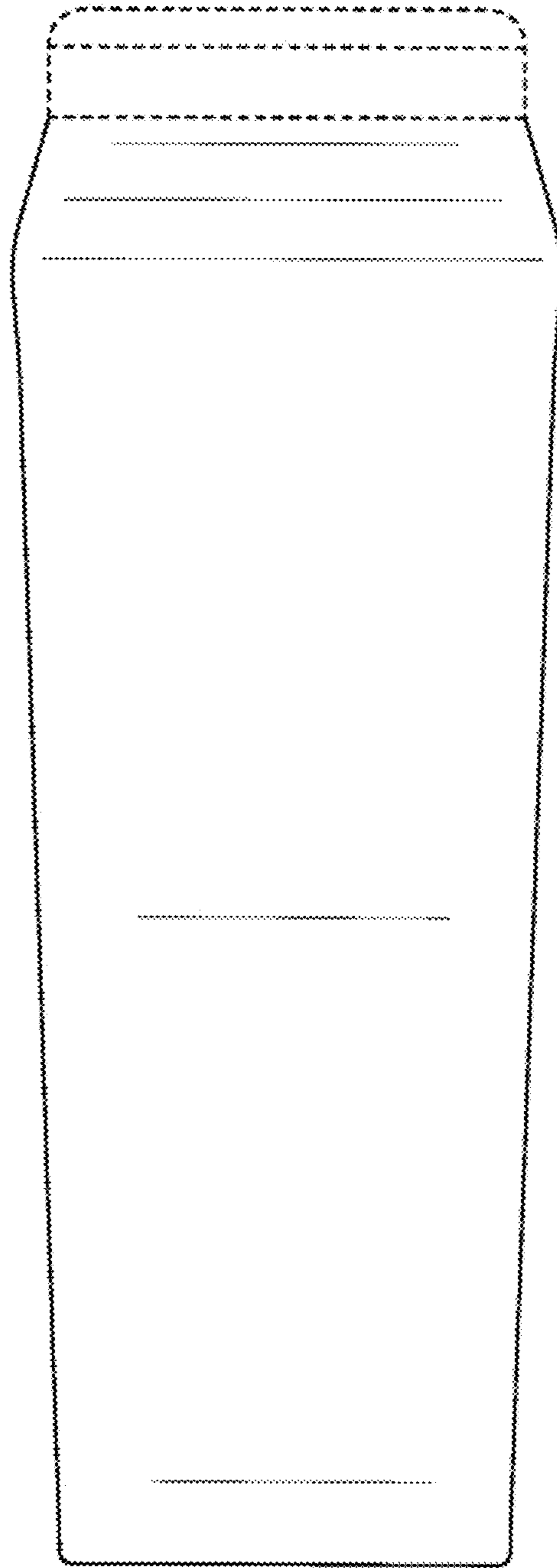

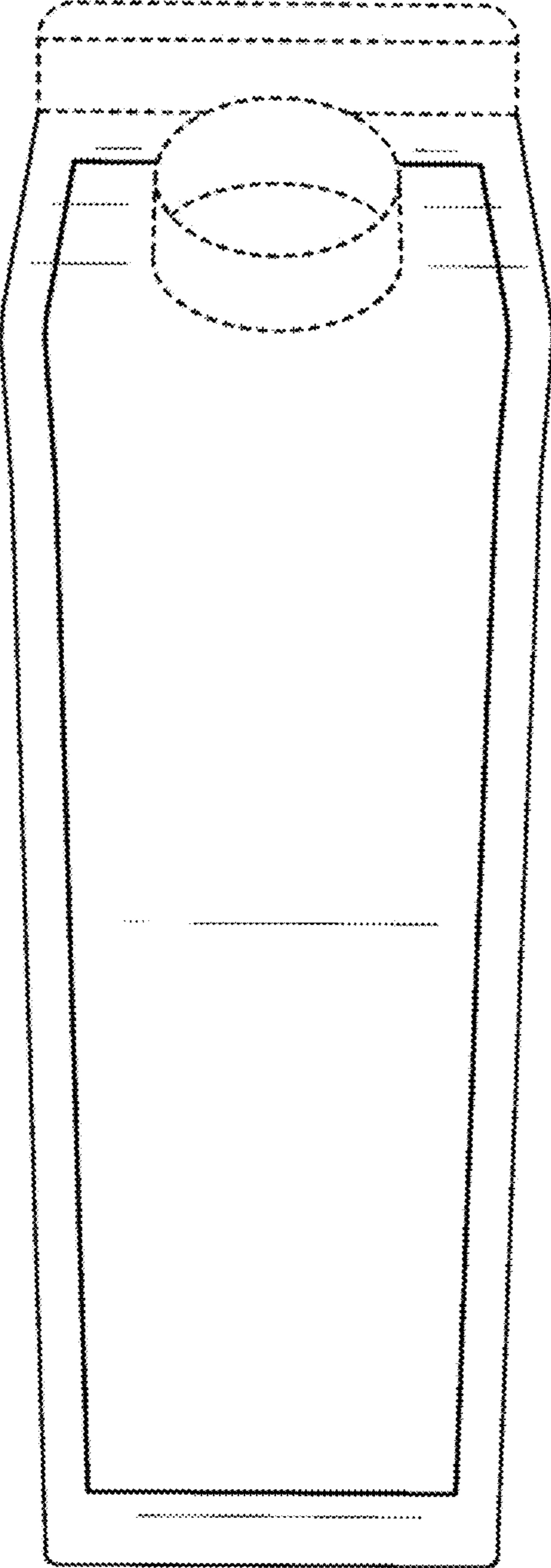

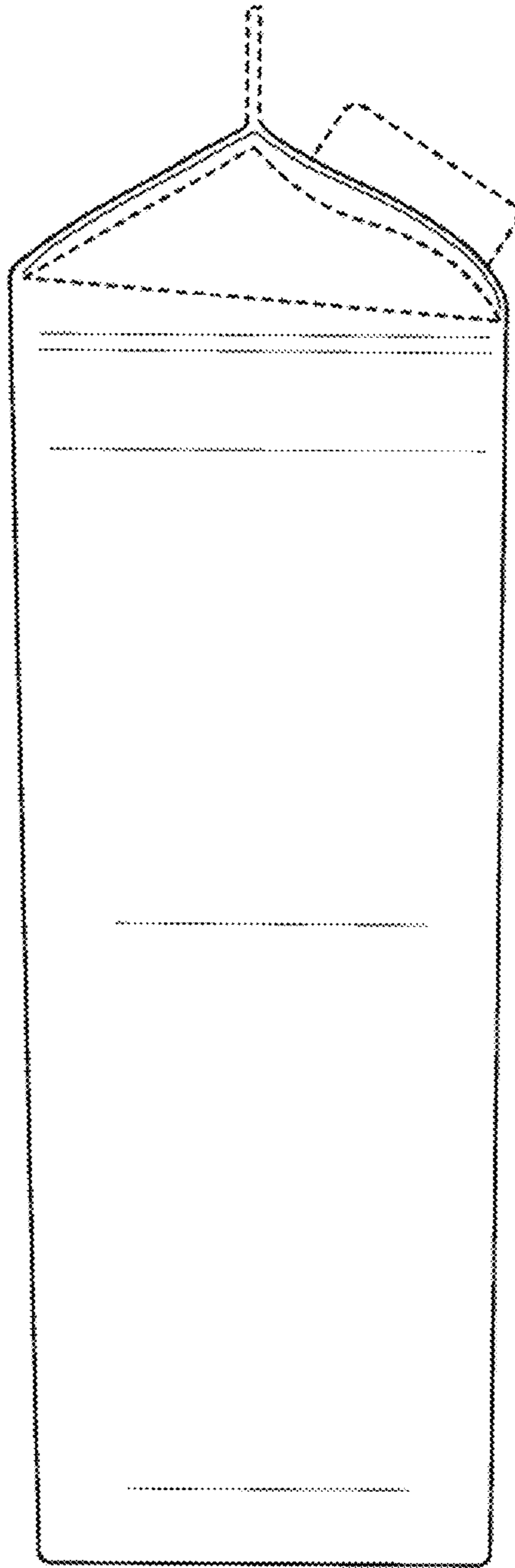

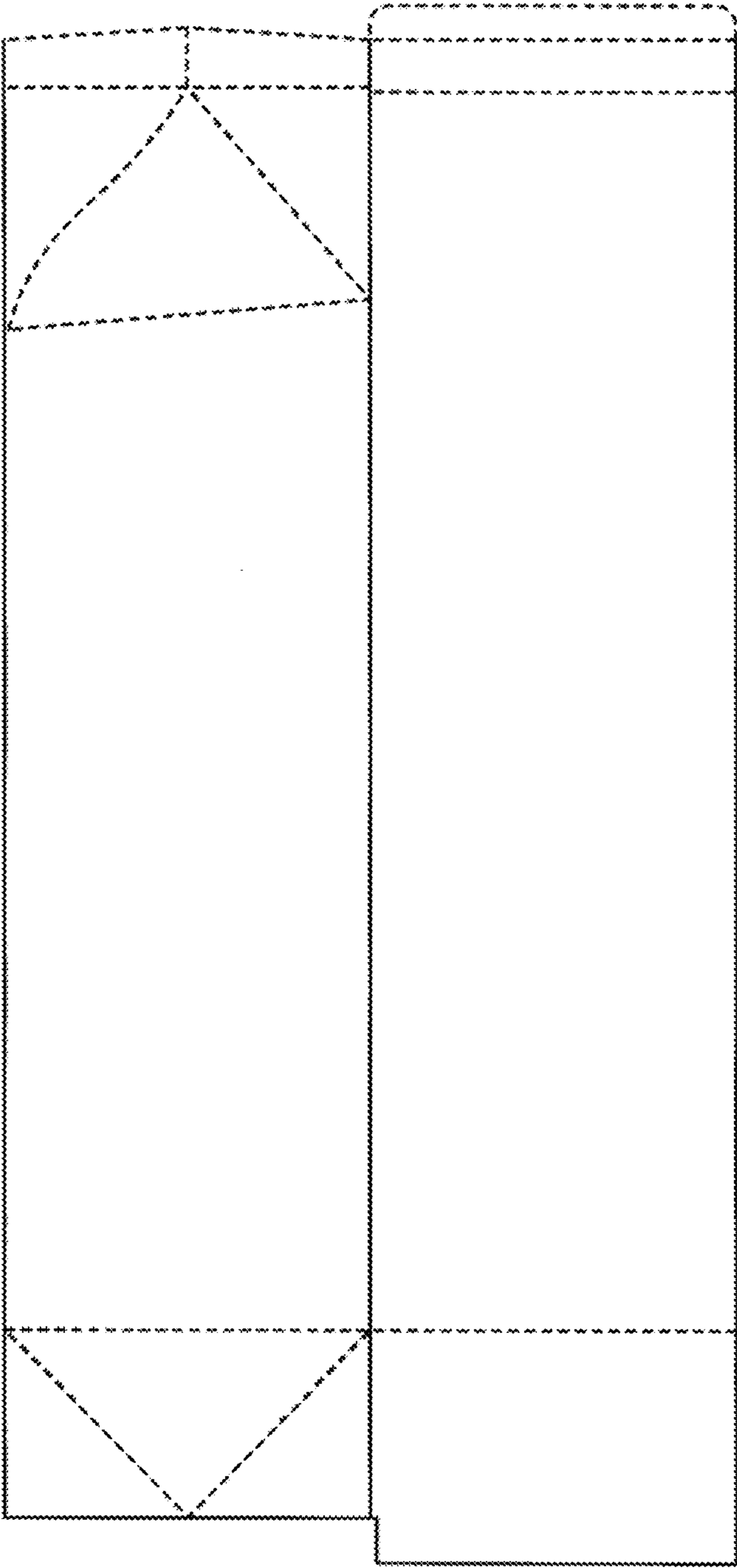

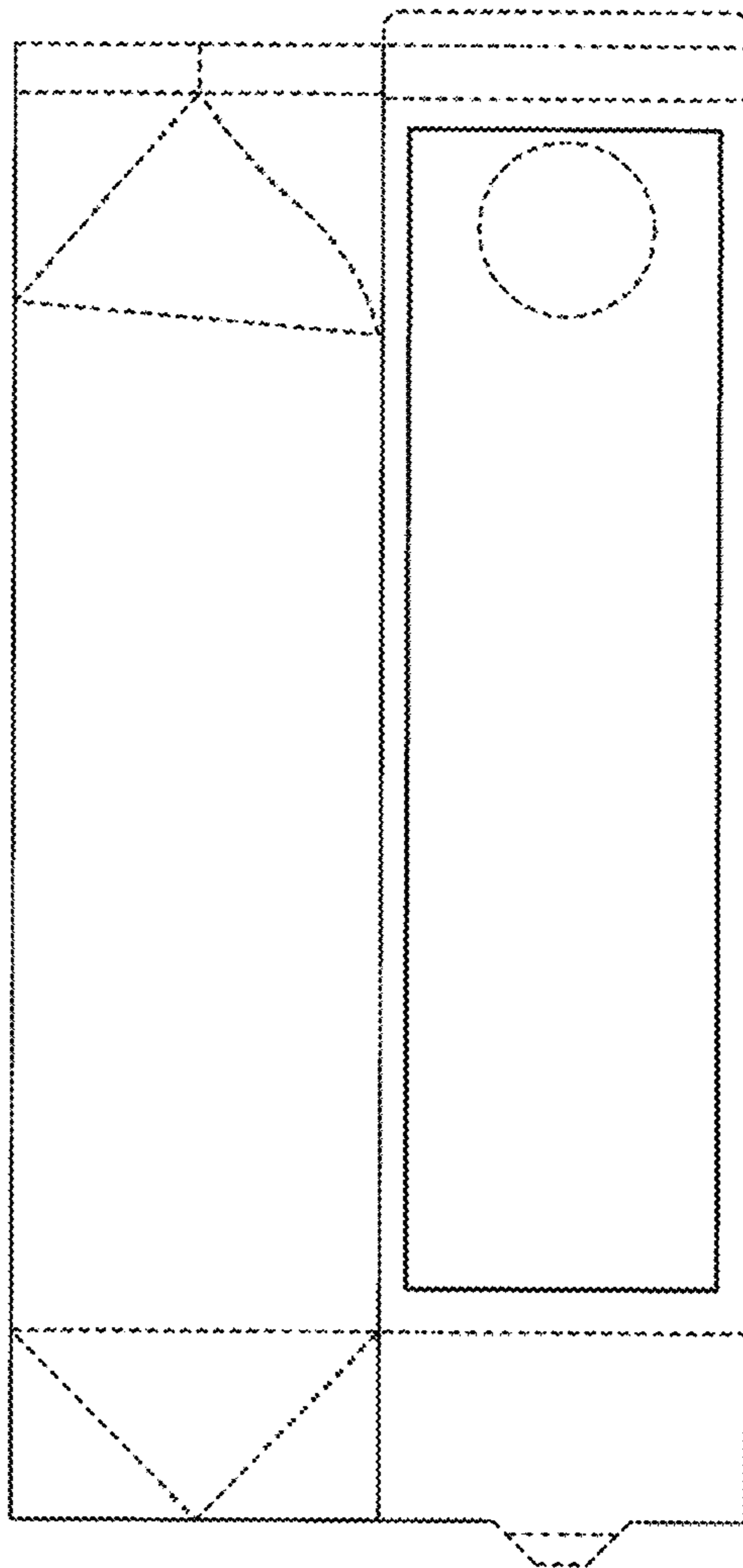
