FIG. 3 is a color right side view thereof;

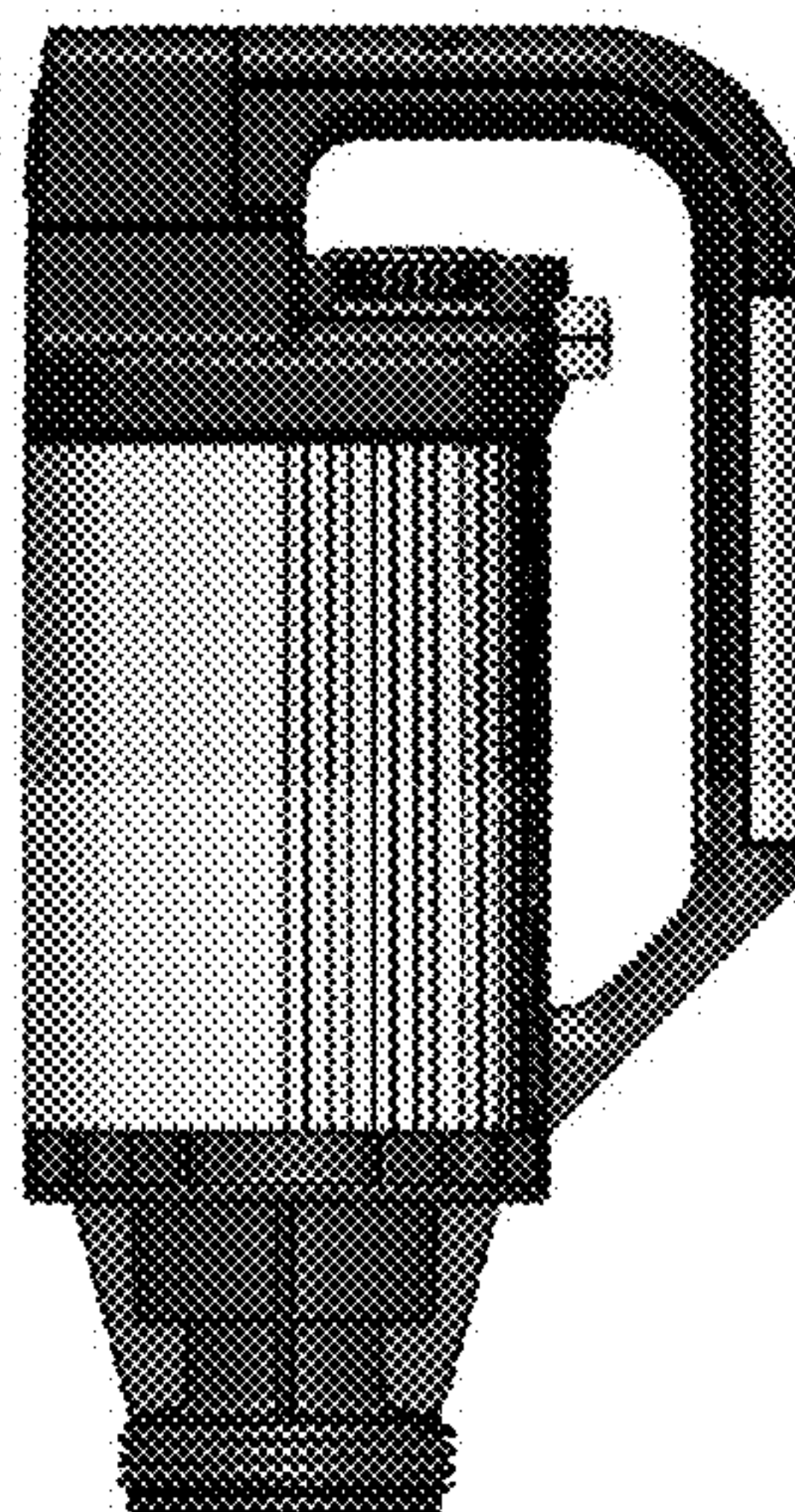
FIG. 4 is a color rear view thereof;

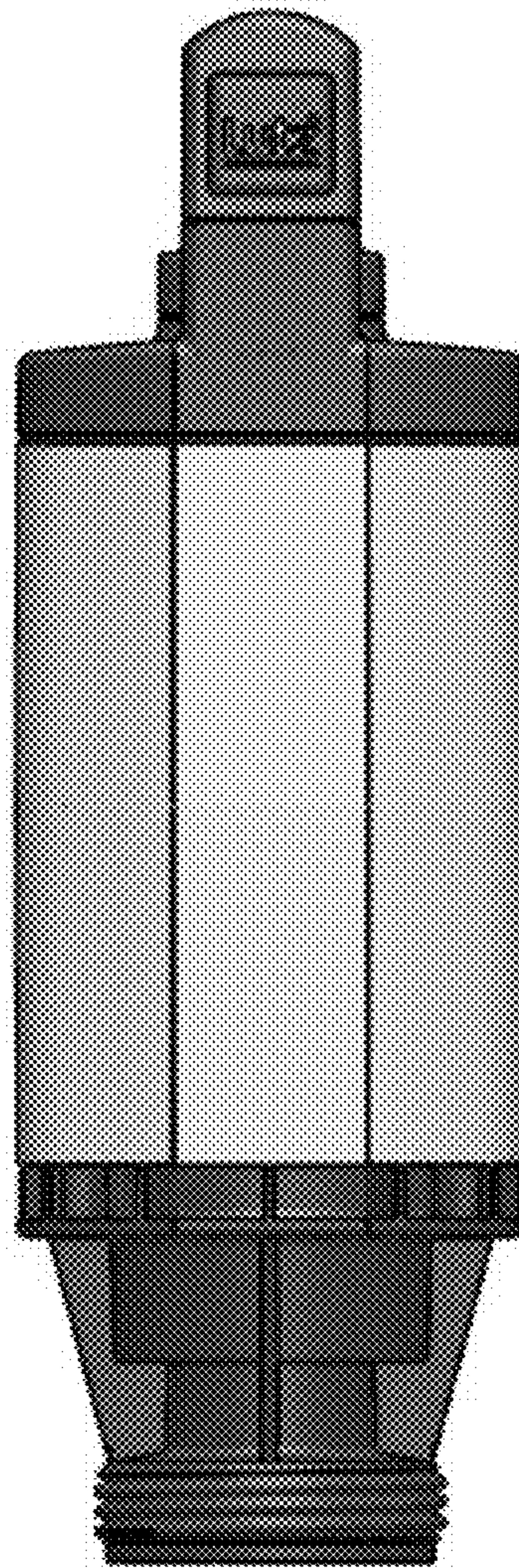

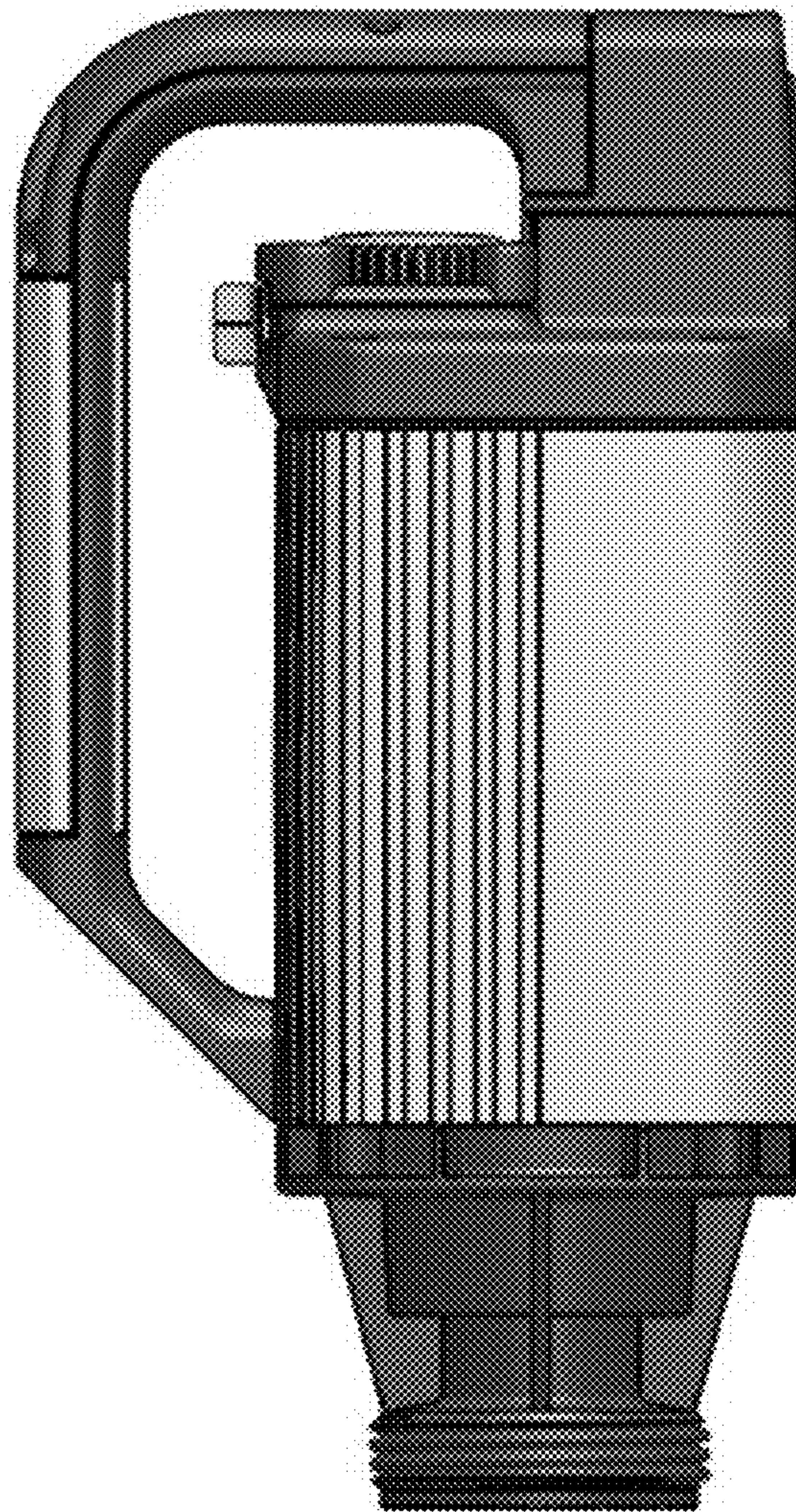

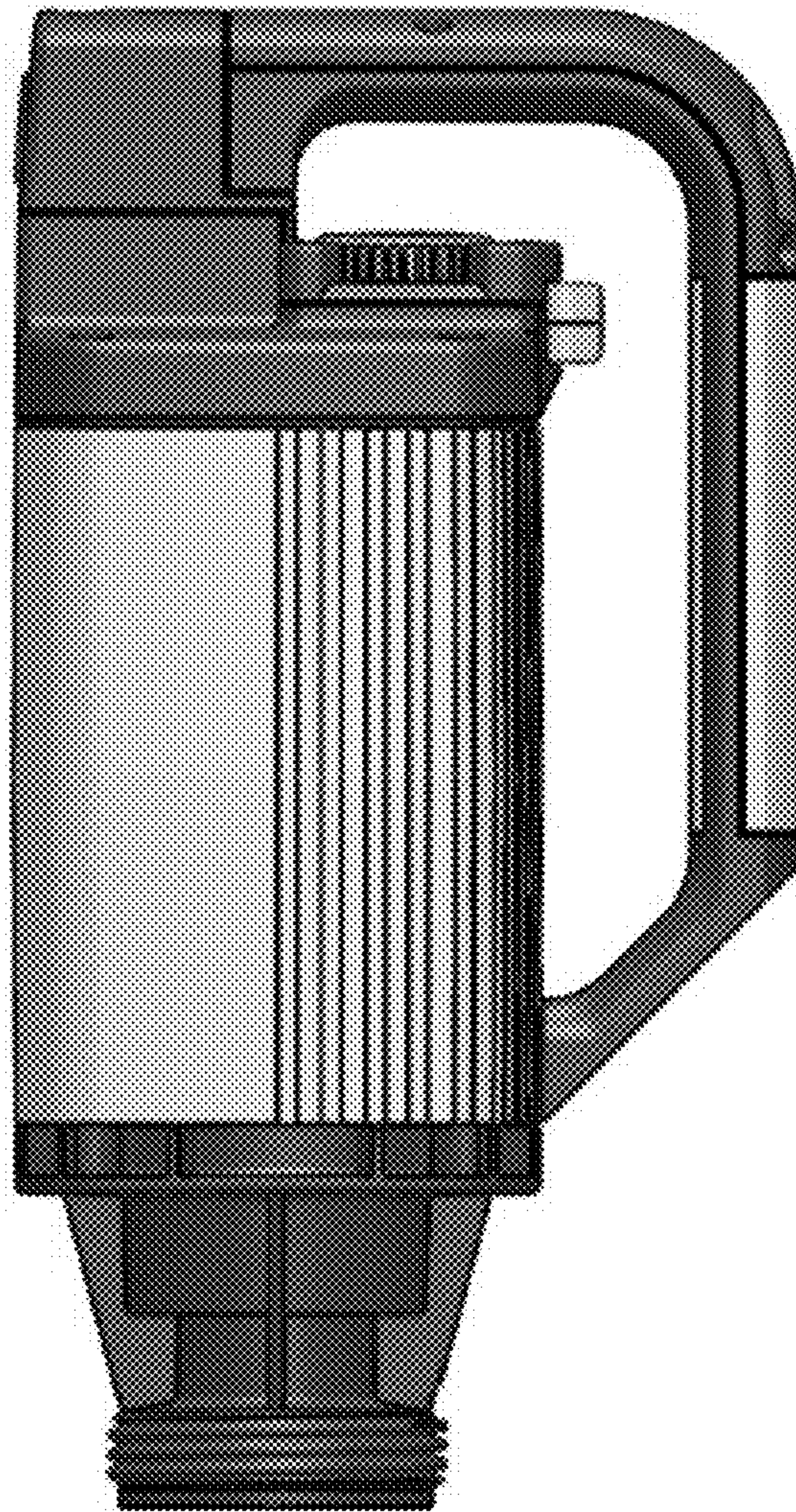

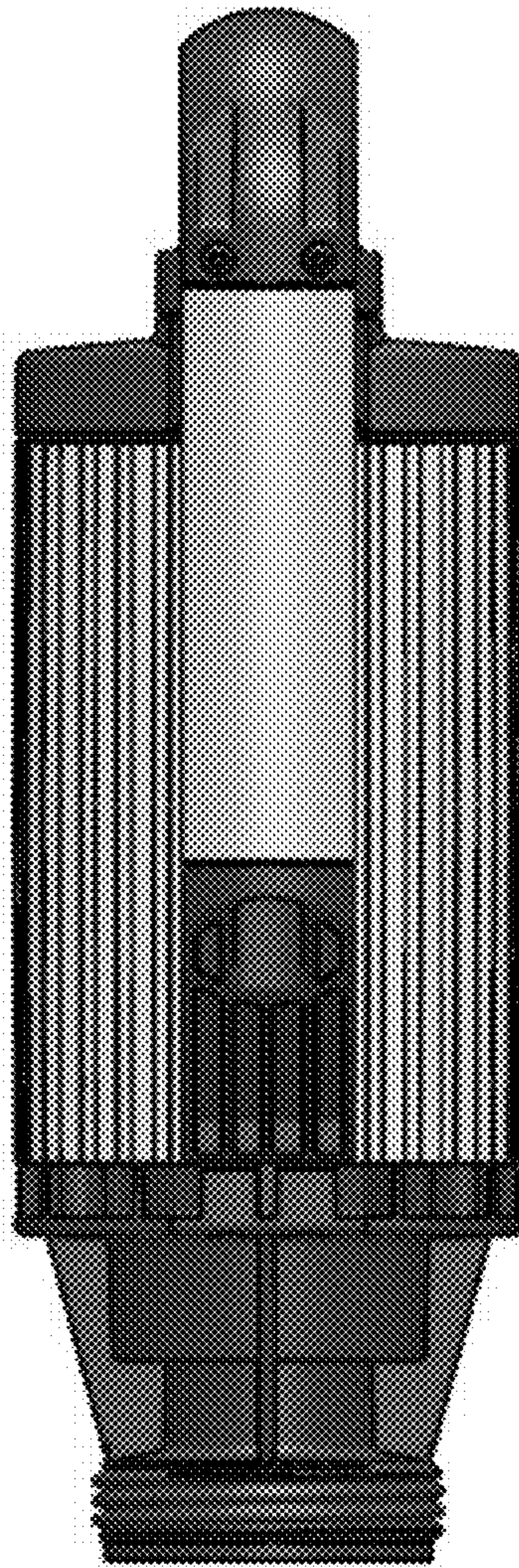

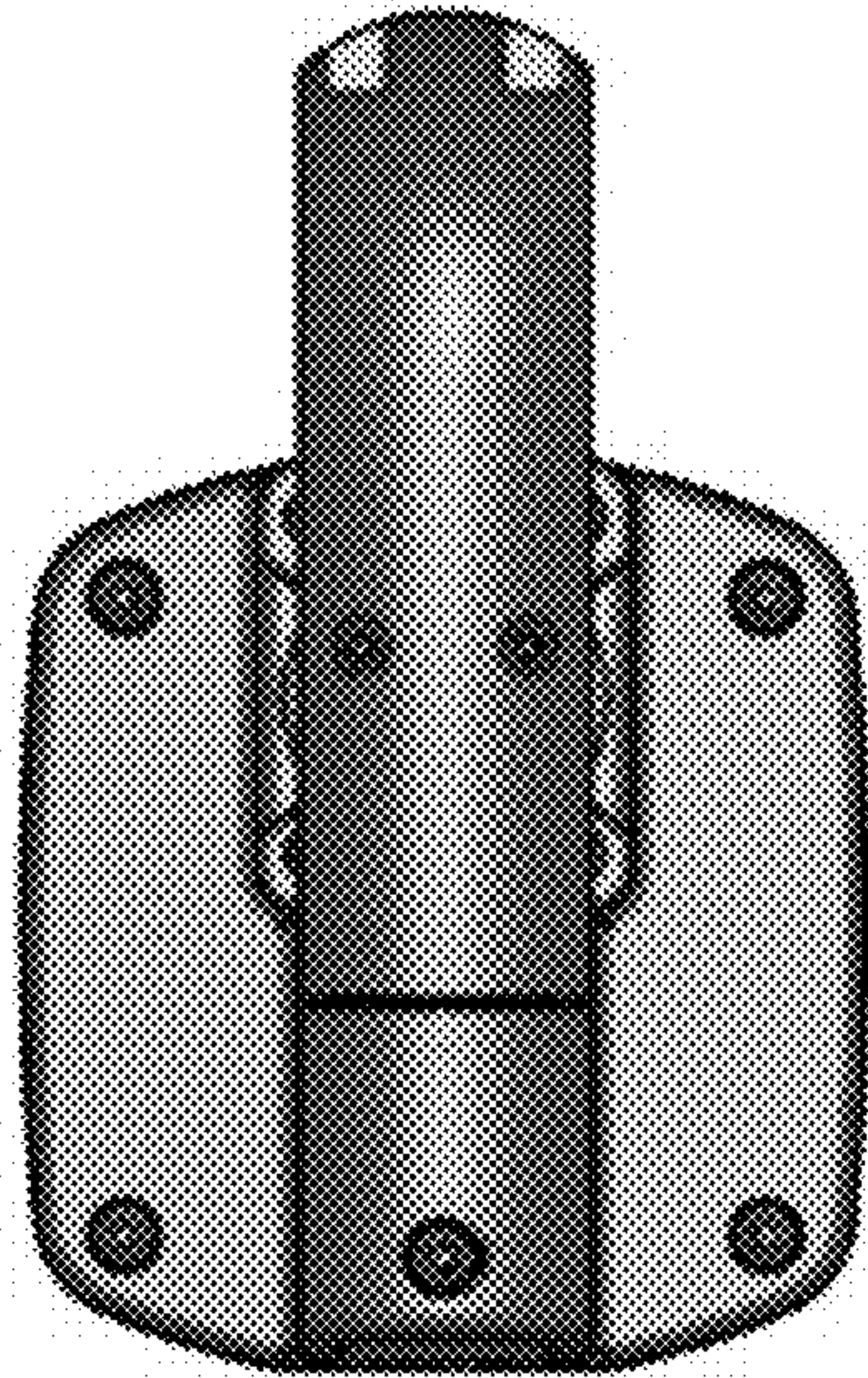

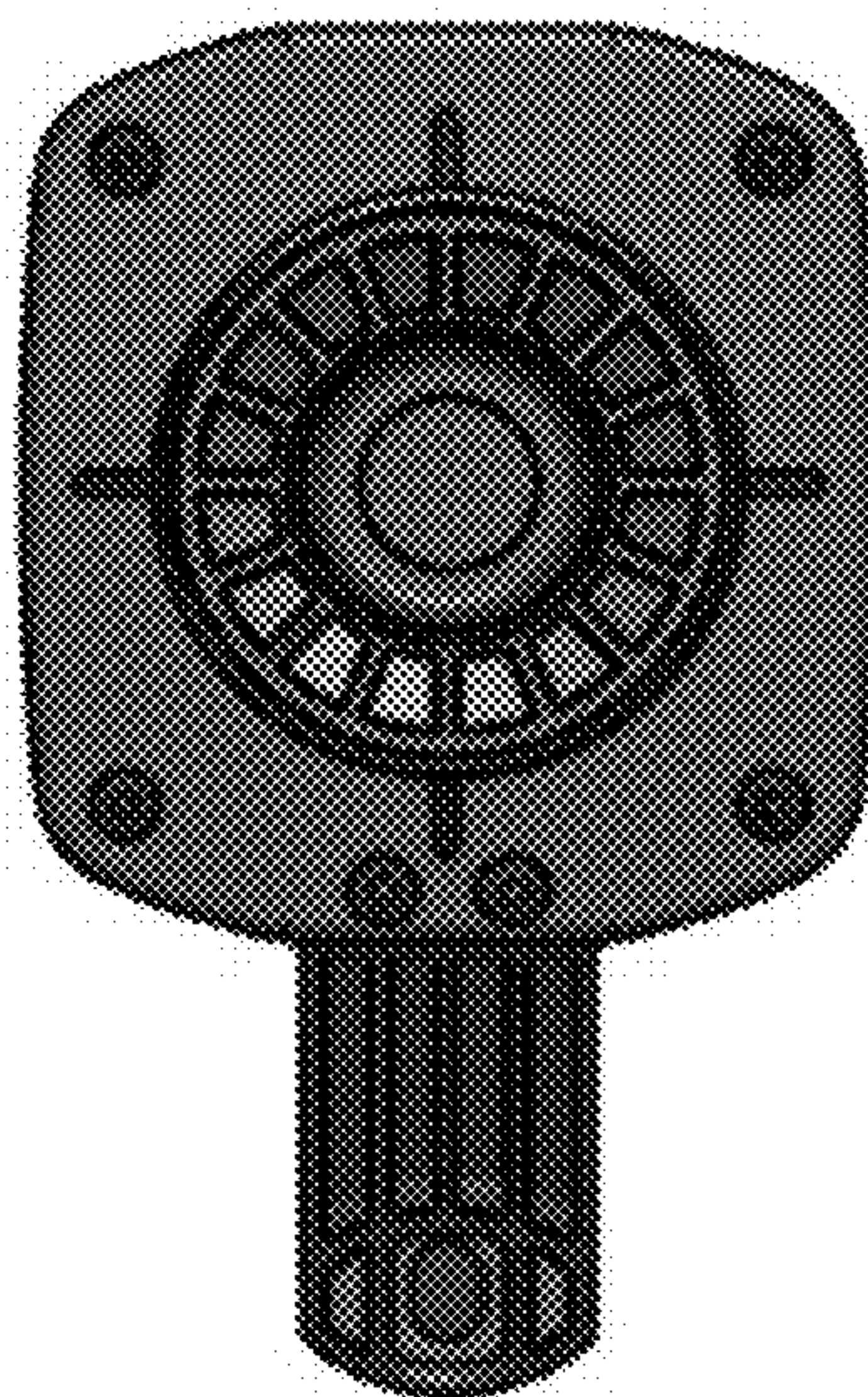
