The ornamental design for a television receiver, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a television receiver showing
our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof where the right side view
is a mirror image; and,
FIG. 5 is a top plan view thereof where the bottom plan view
is a mirror image.
The broken lines depict portions of the television receiver
that form no part of the claimed design. The dash-dot broken
lines define the bounds of the claimed design and form no
part thereof.

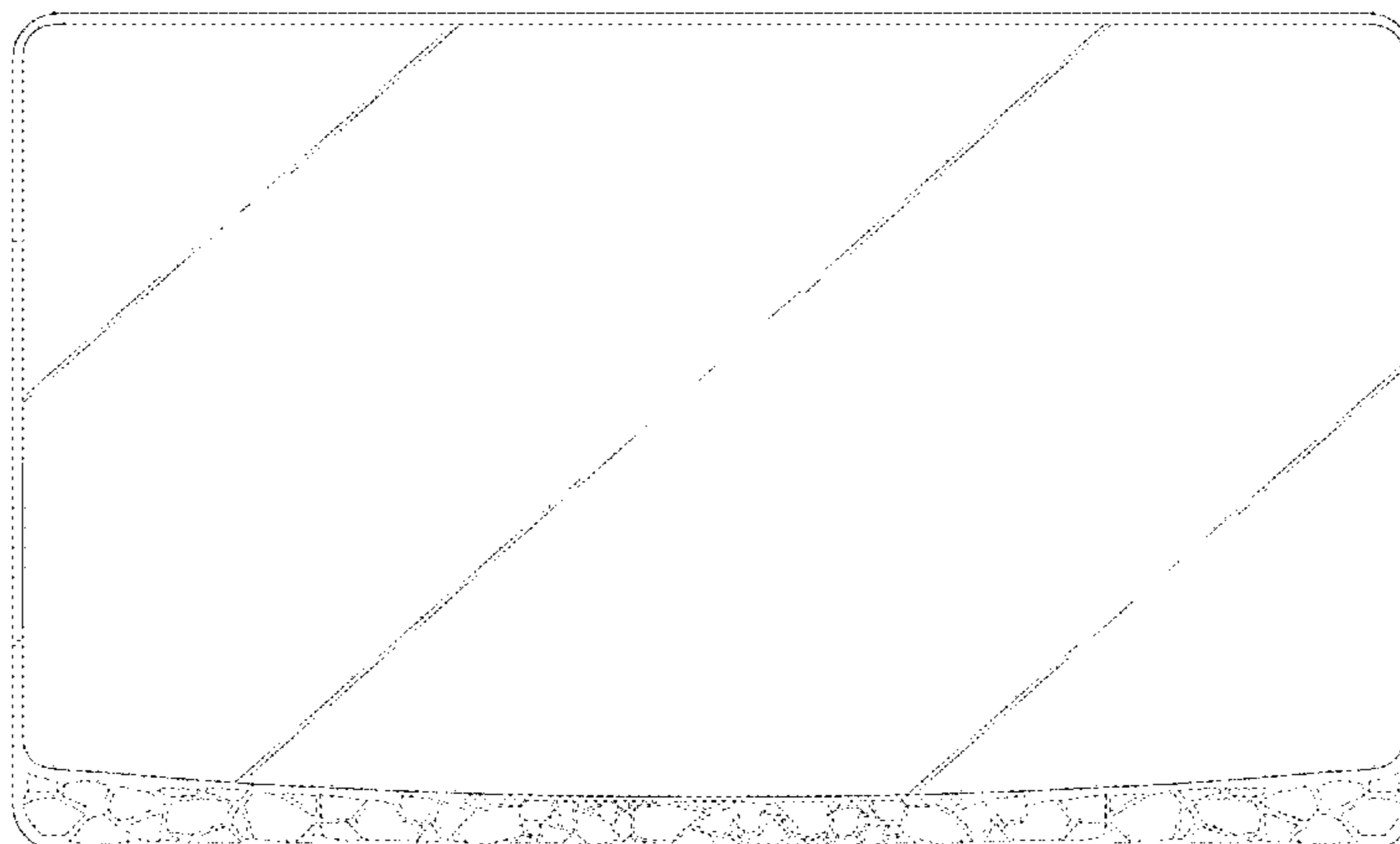

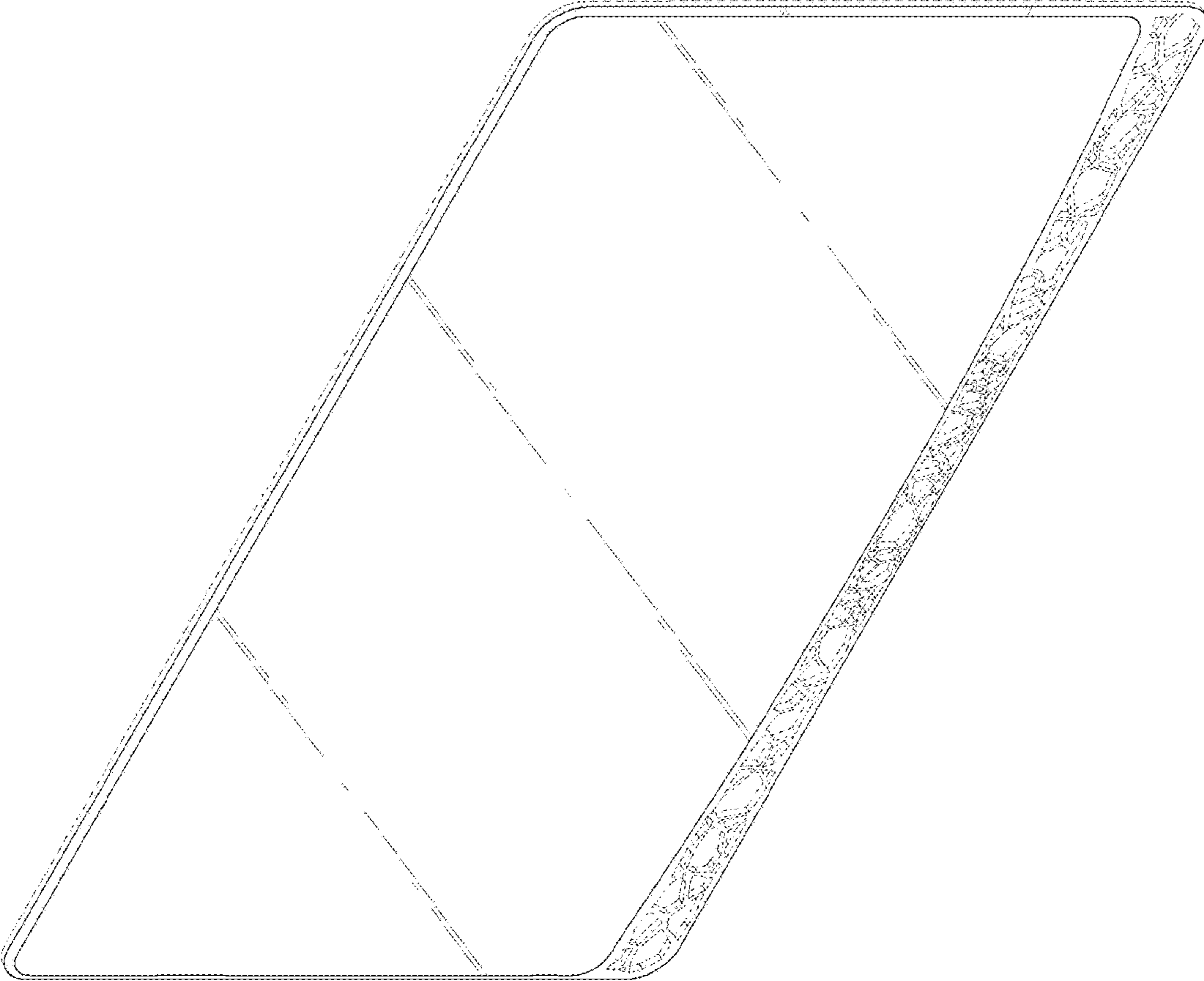

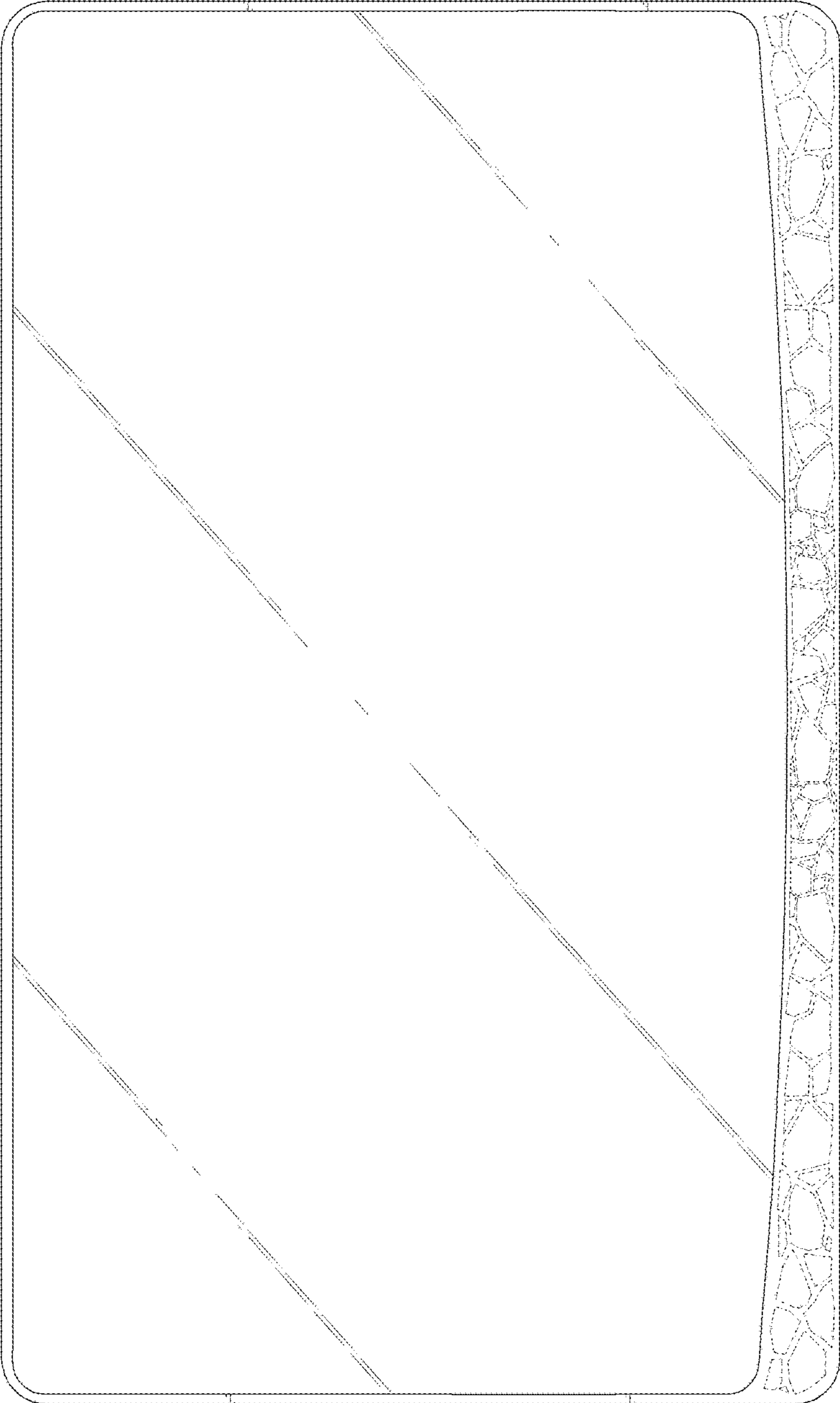

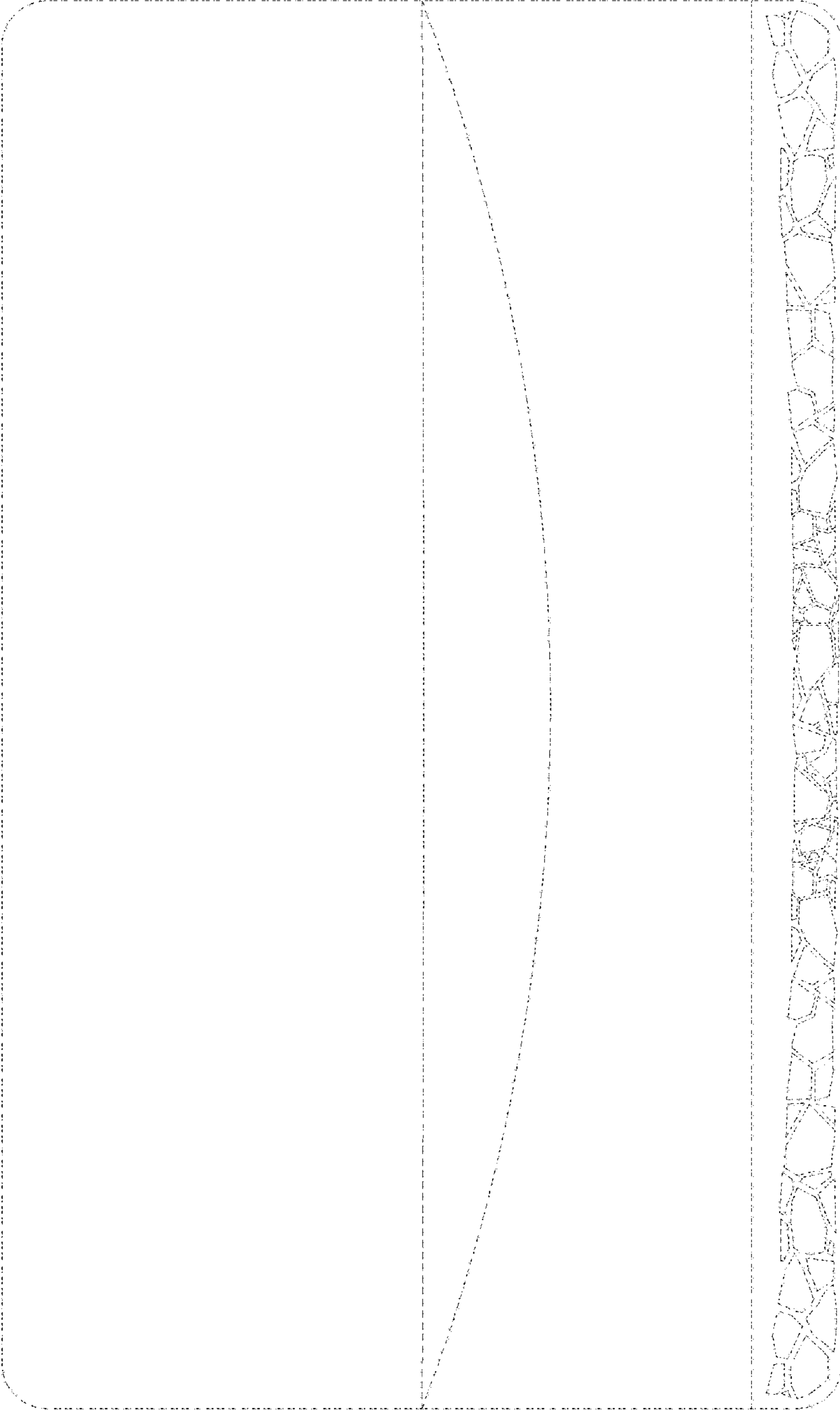

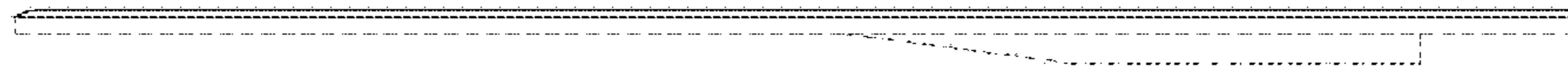
