DESCRIPTION

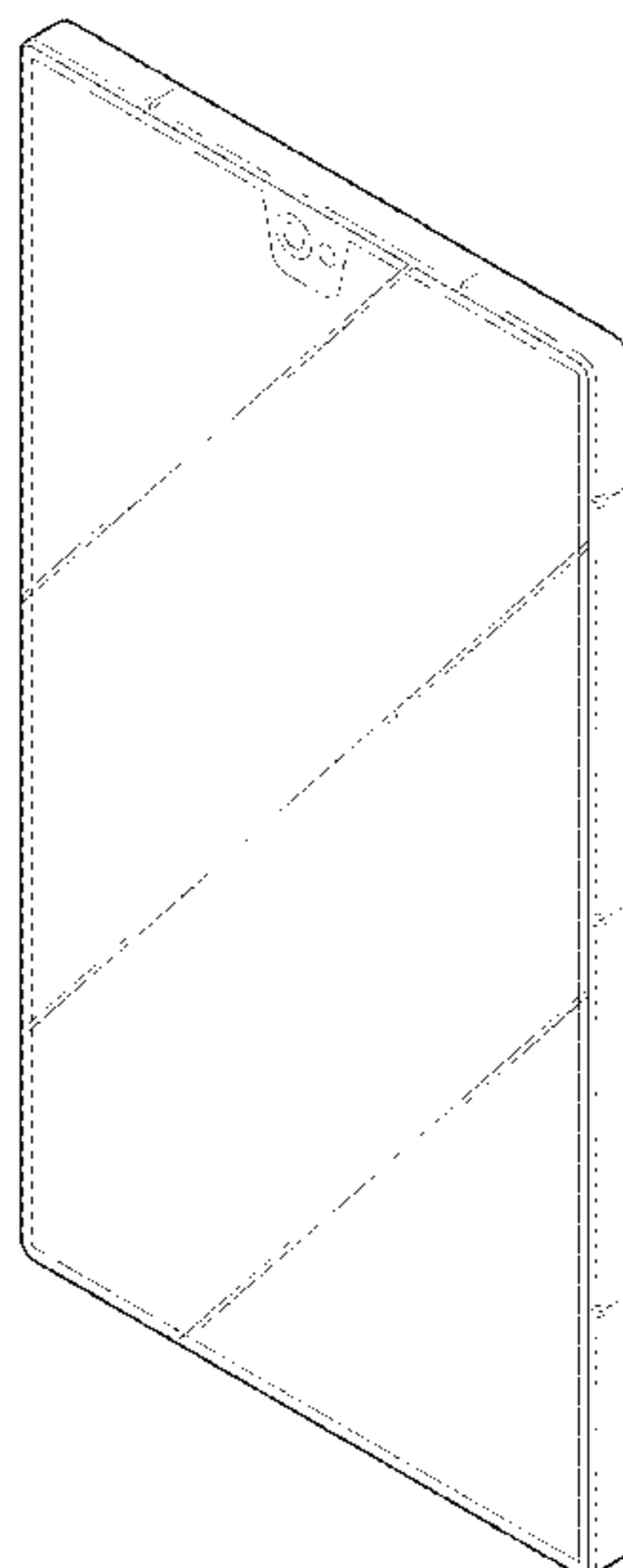
FIG. 1 is a perspective view of the mobile phone showing our new design;

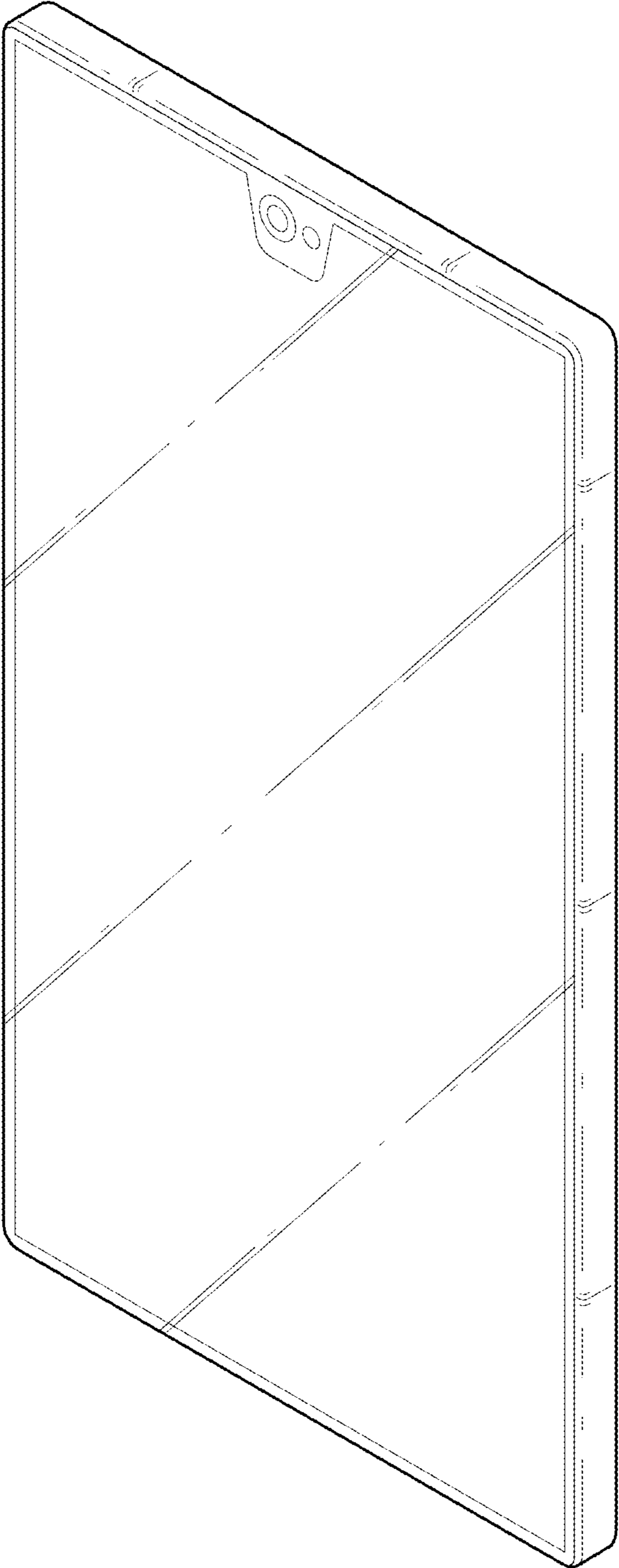

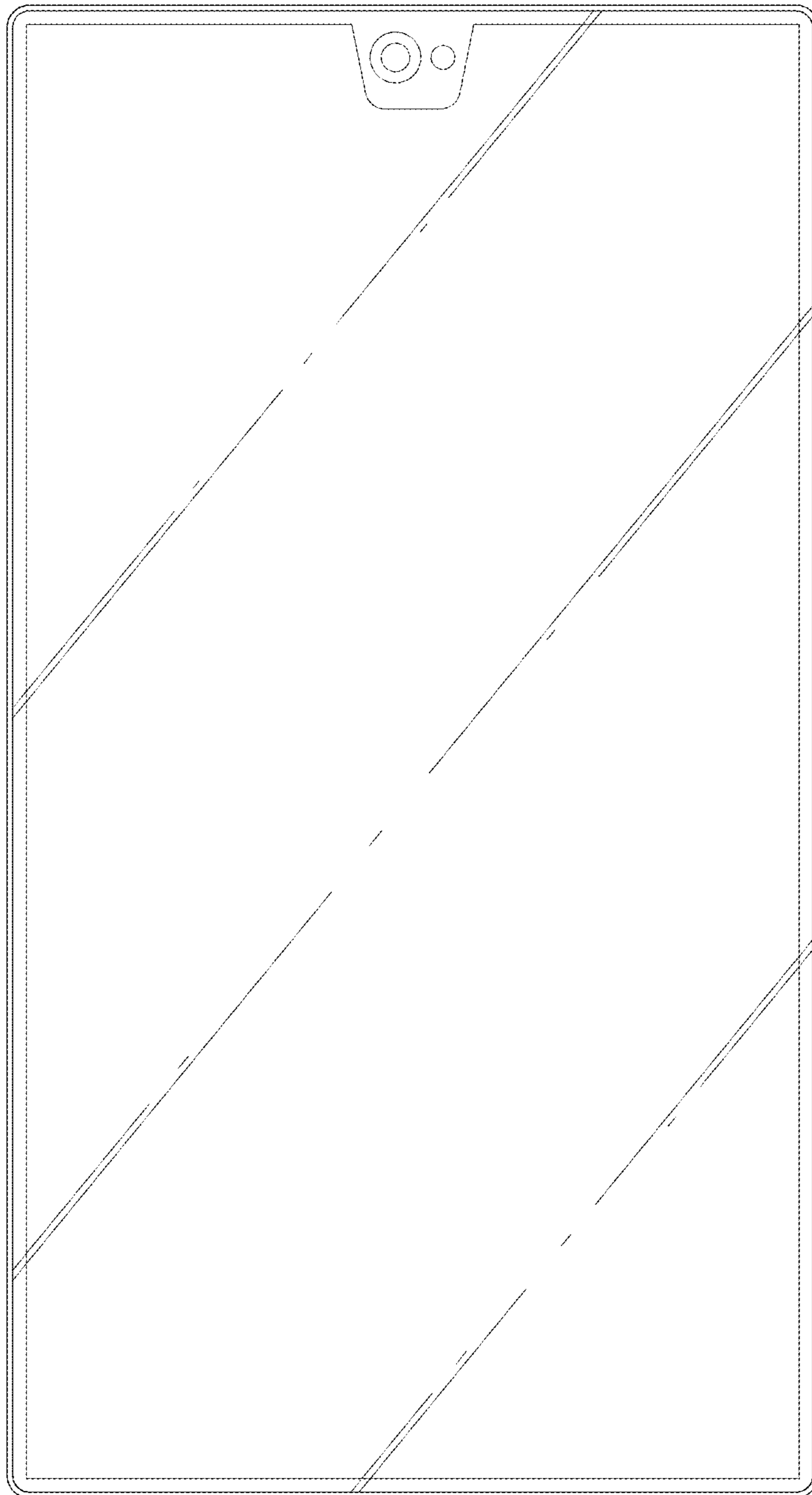

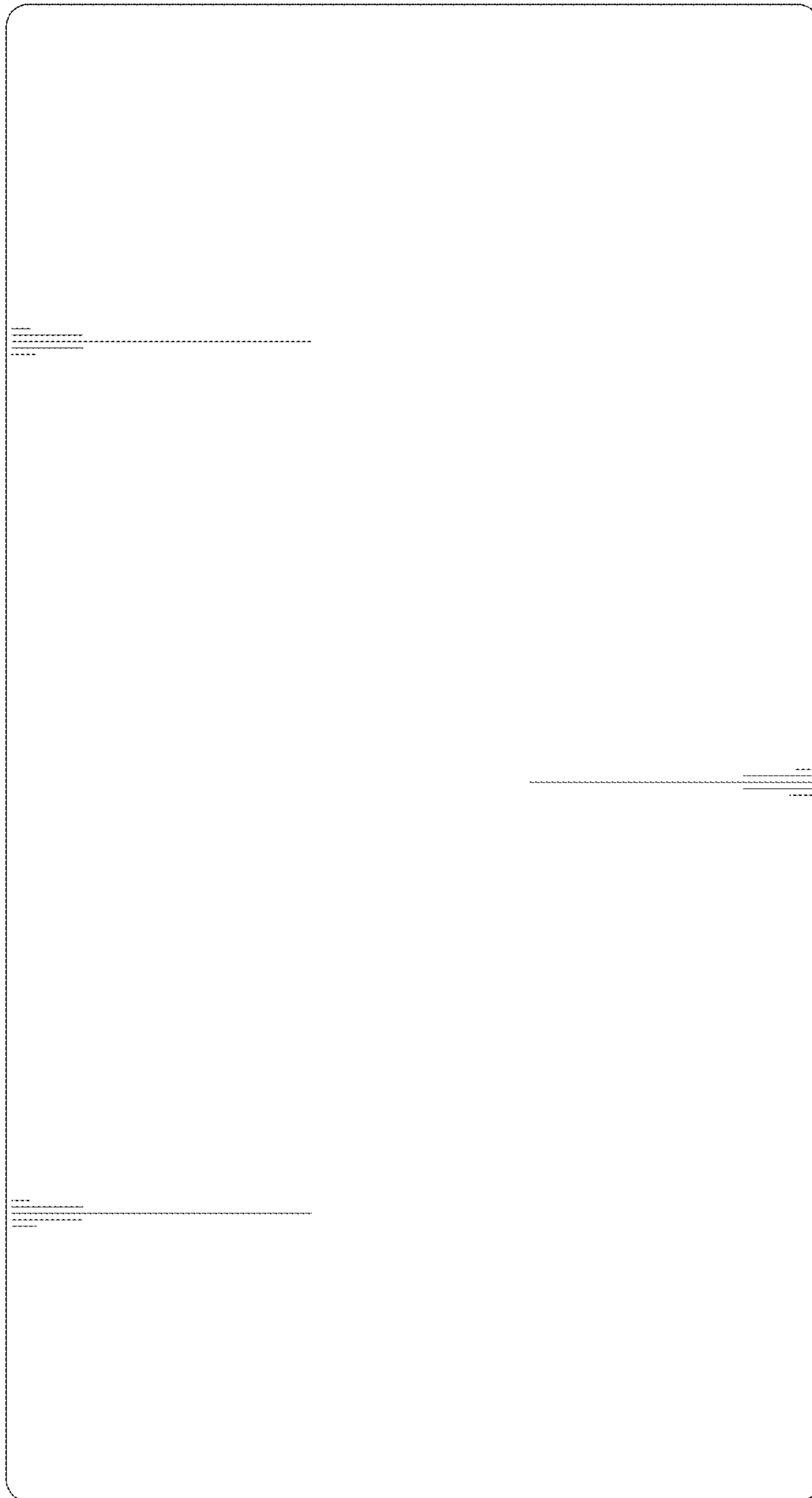

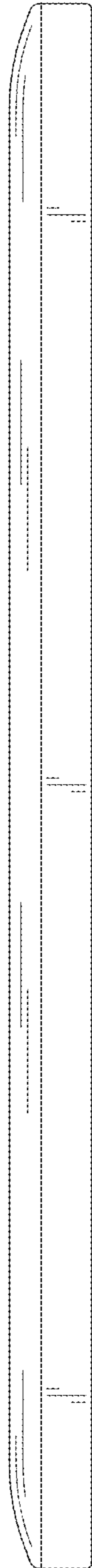

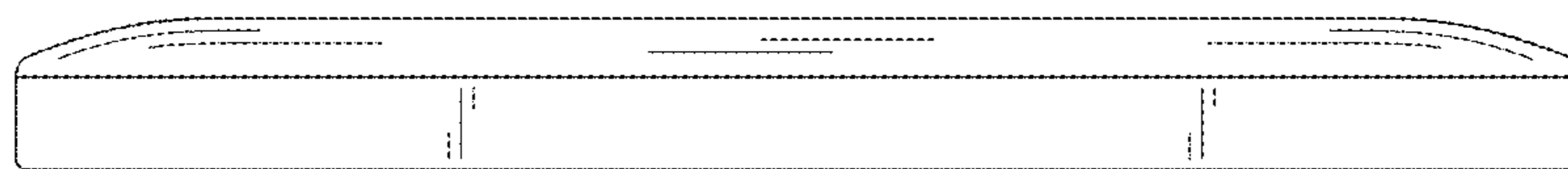
