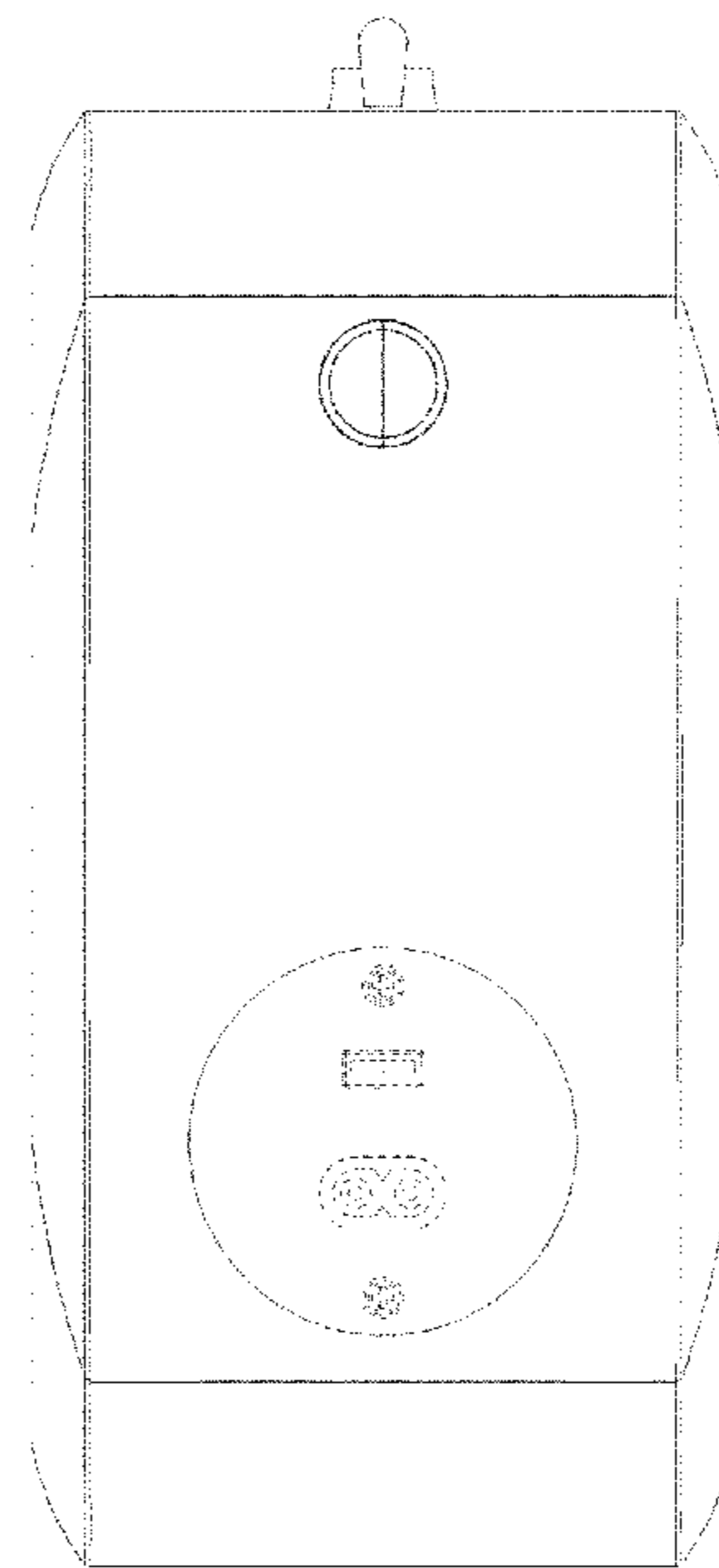
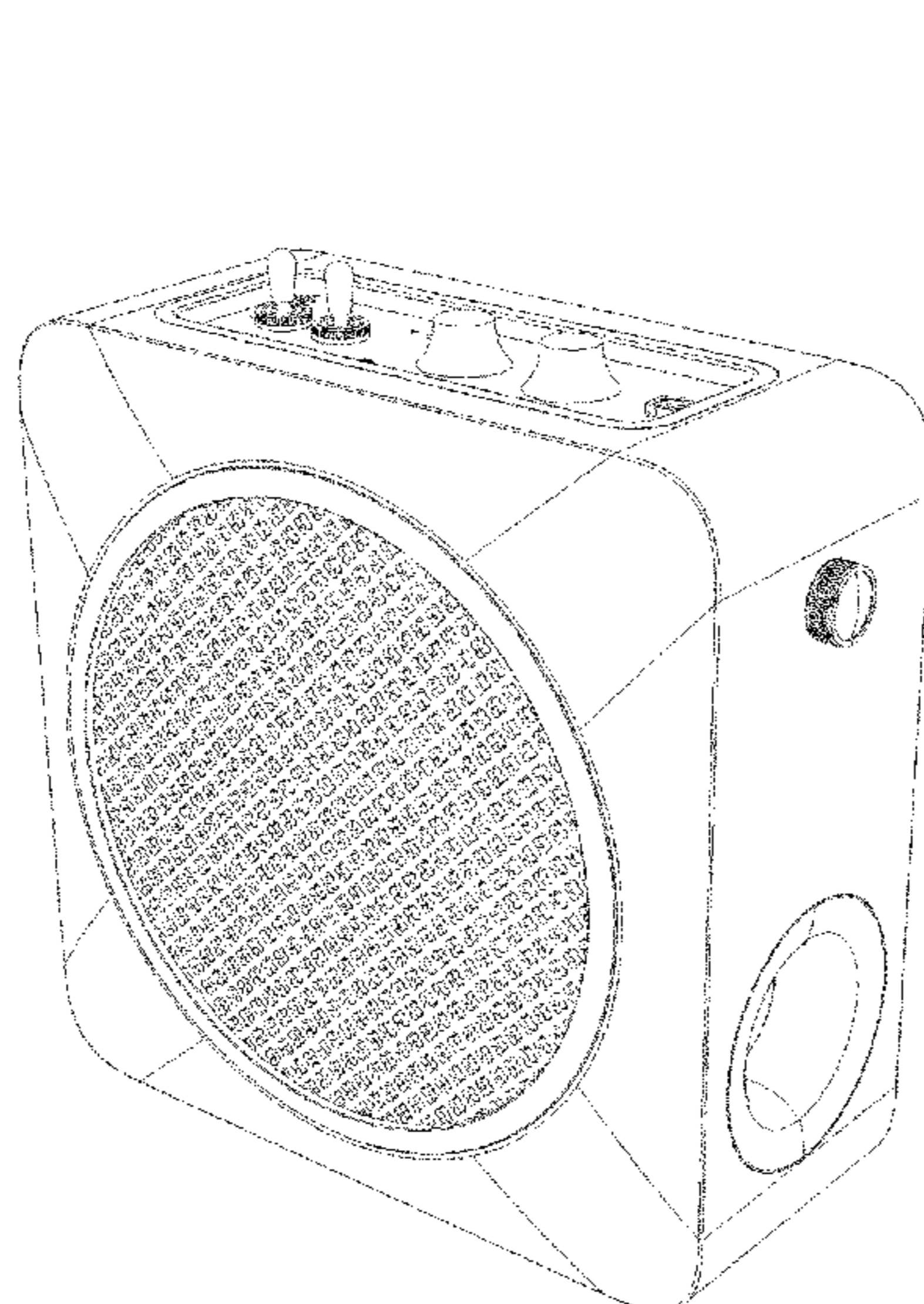
(57) **CLAIM**

What is claimed is the ornamental design for a portable bluetooth speaker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the portable bluetooth speaker;
FIG. 2 is a front view of the portable bluetooth speaker;
FIG. 3 is a back view of the portable bluetooth speaker;
FIG. 4 is a right side view of the portable bluetooth speaker;
FIG. 5 is a left side view of the portable bluetooth speaker;
FIG. 6 is a top view of the portable bluetooth speaker; and,
FIG. 7 is a bottom view of the portable bluetooth speaker.

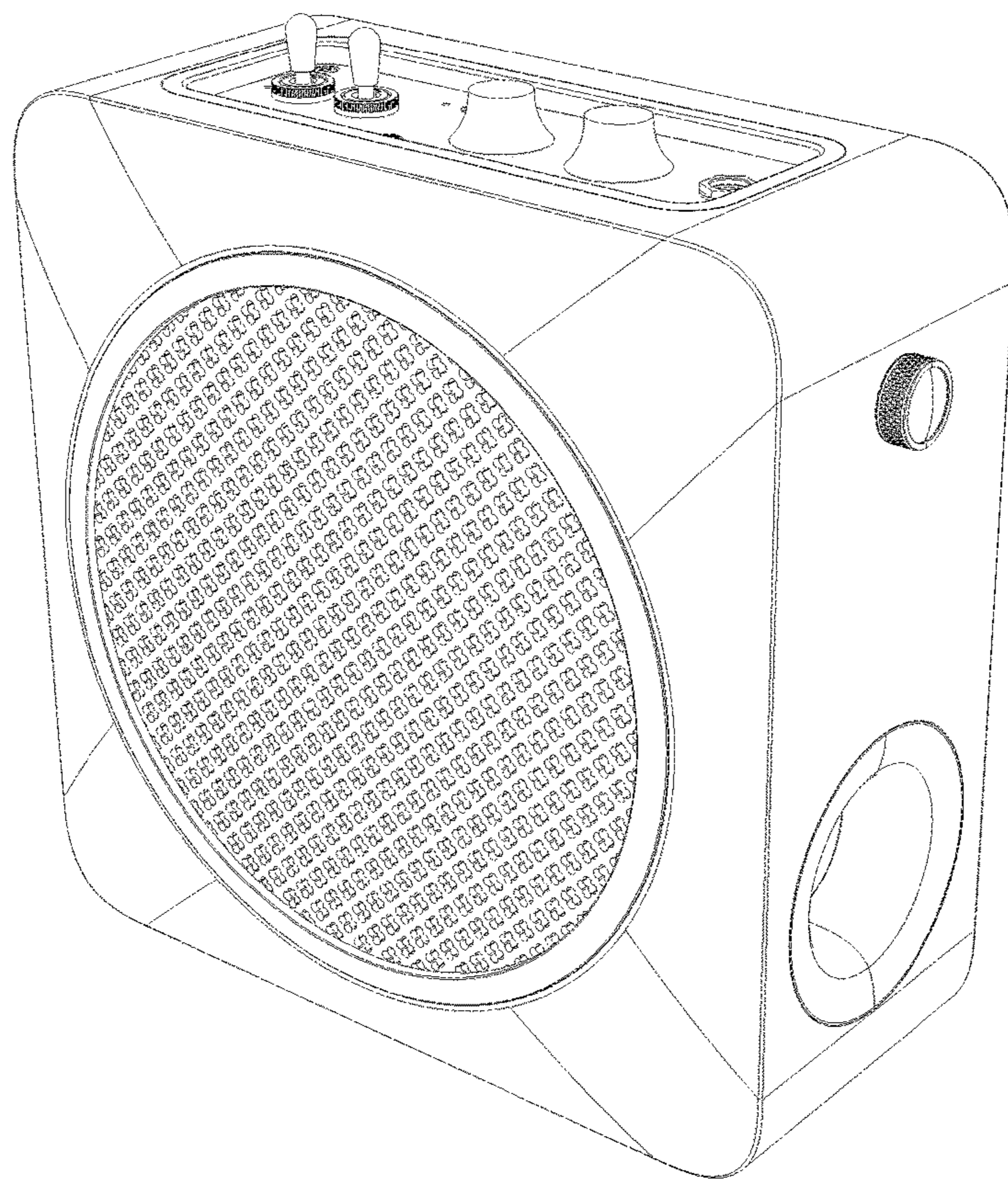

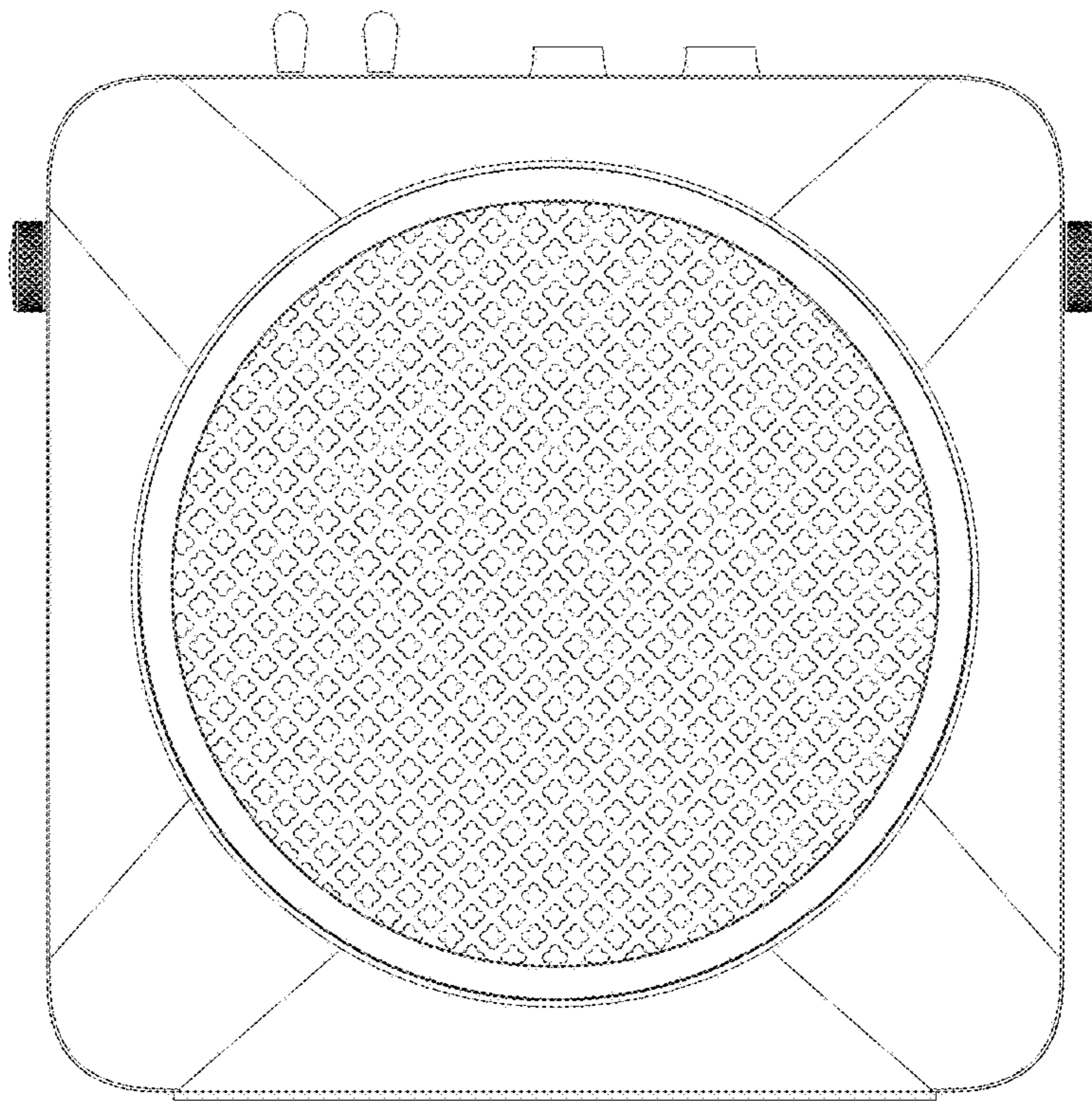

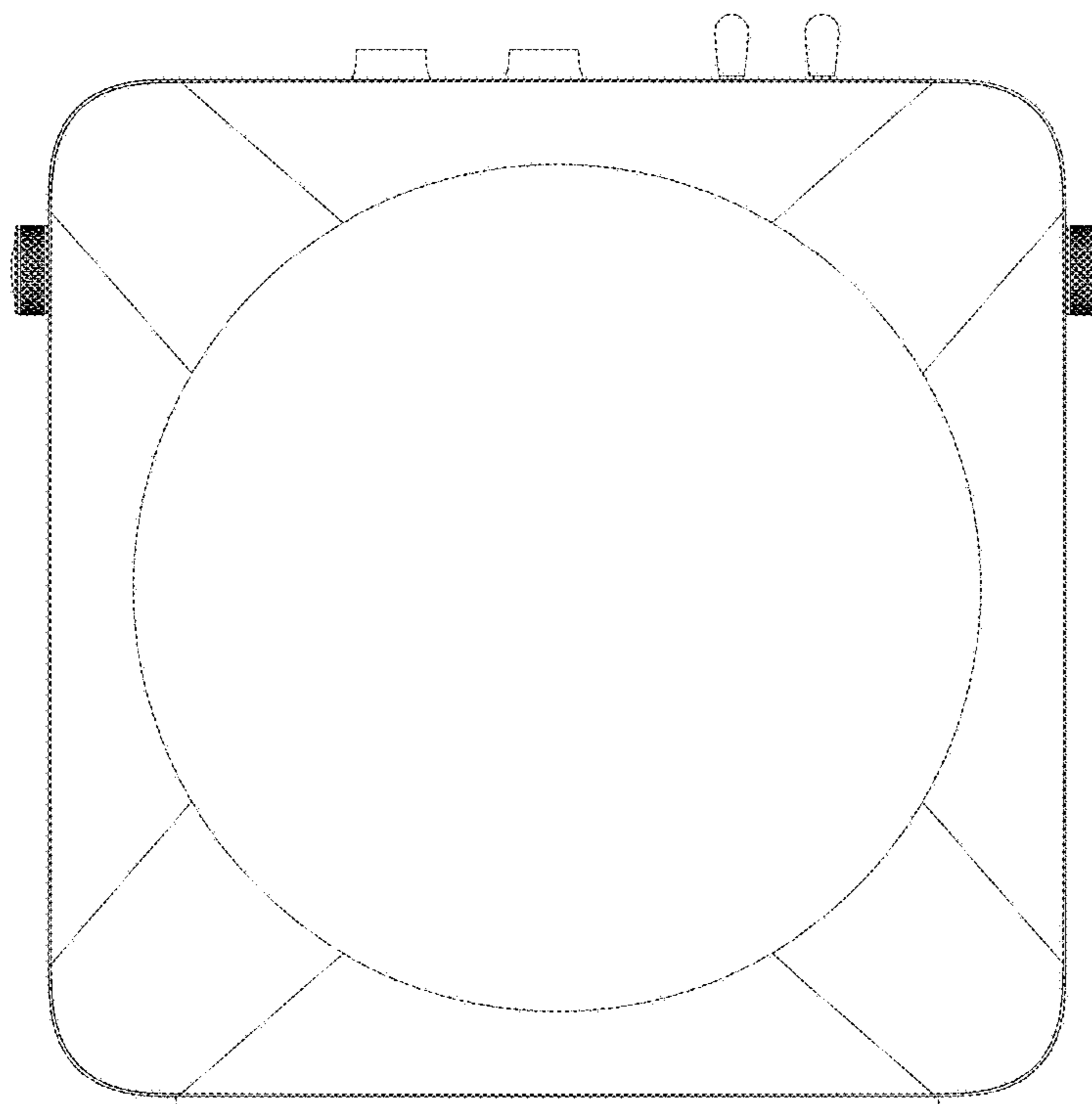

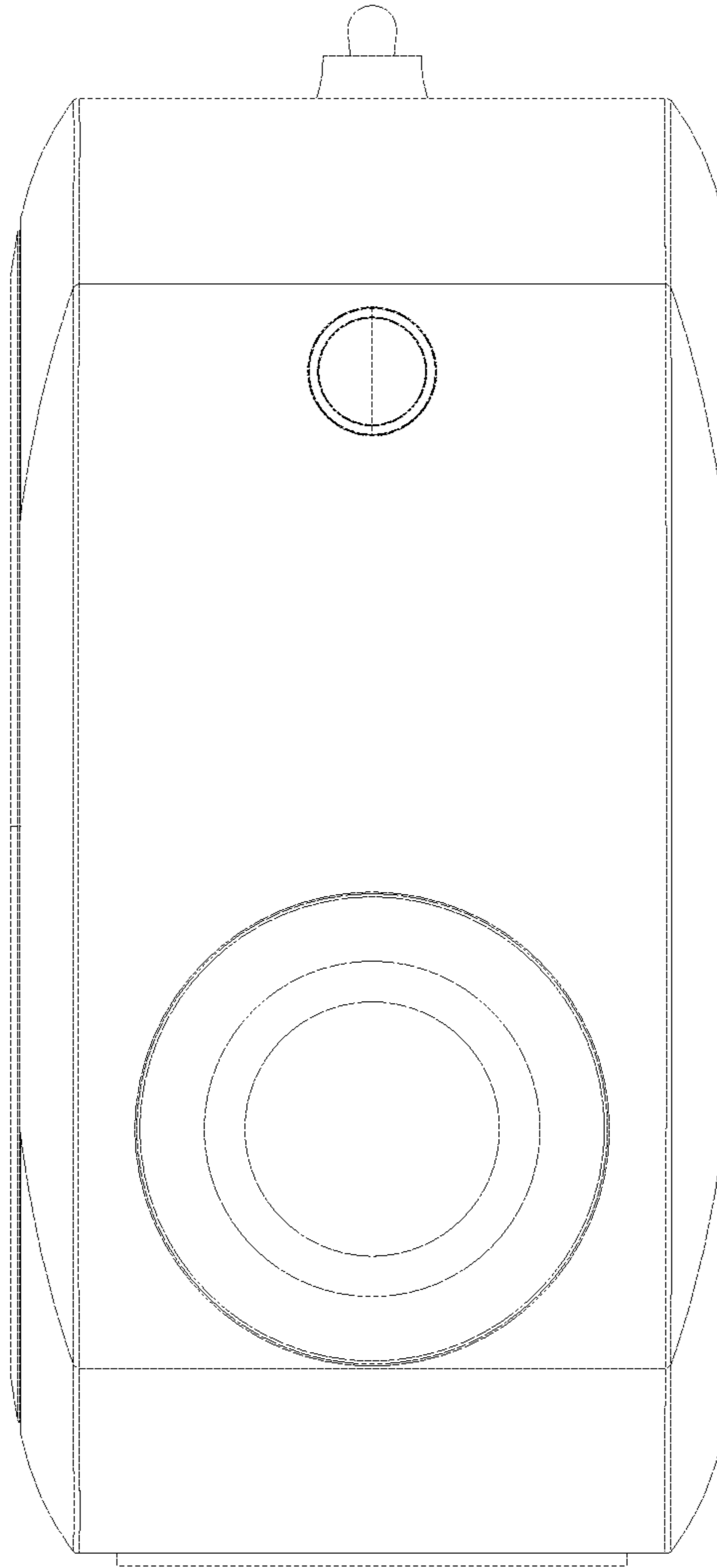

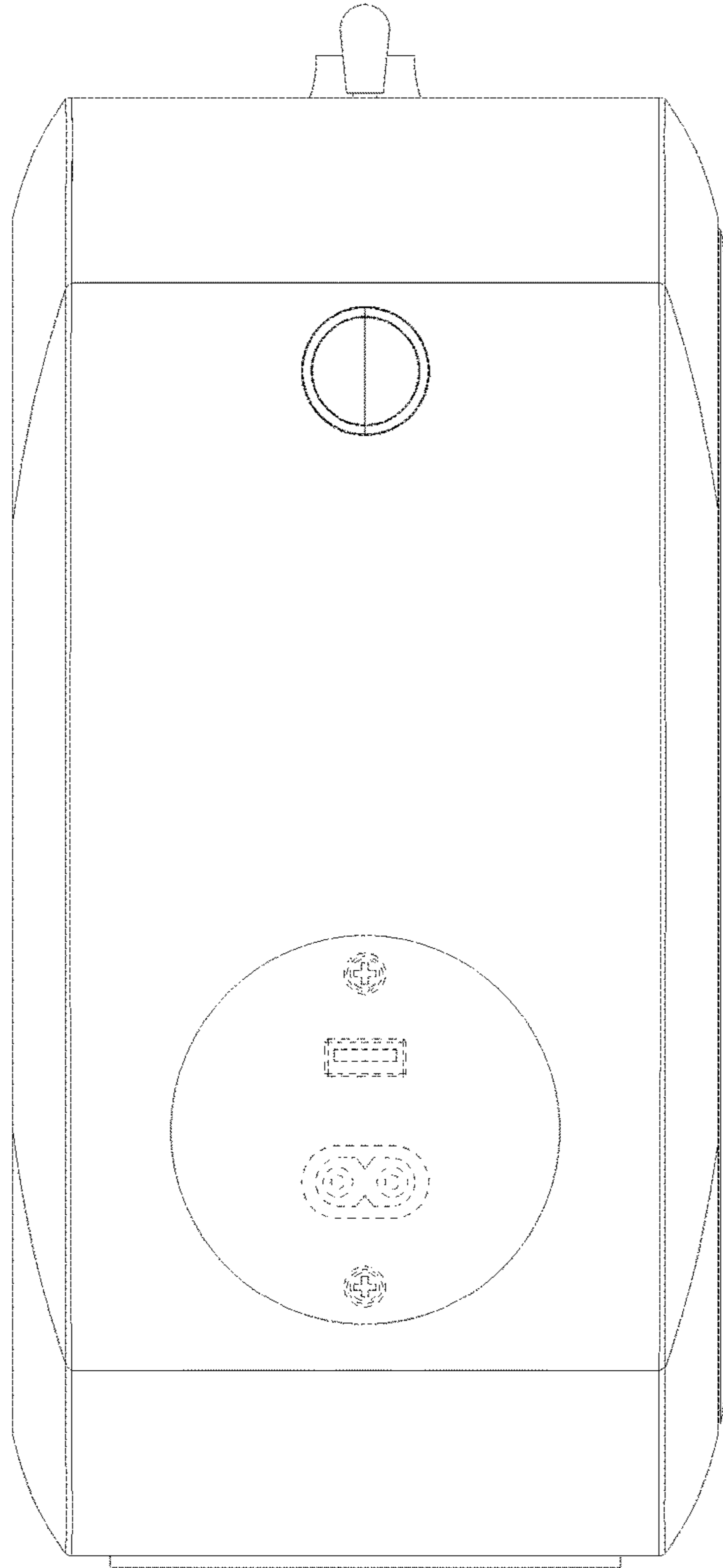

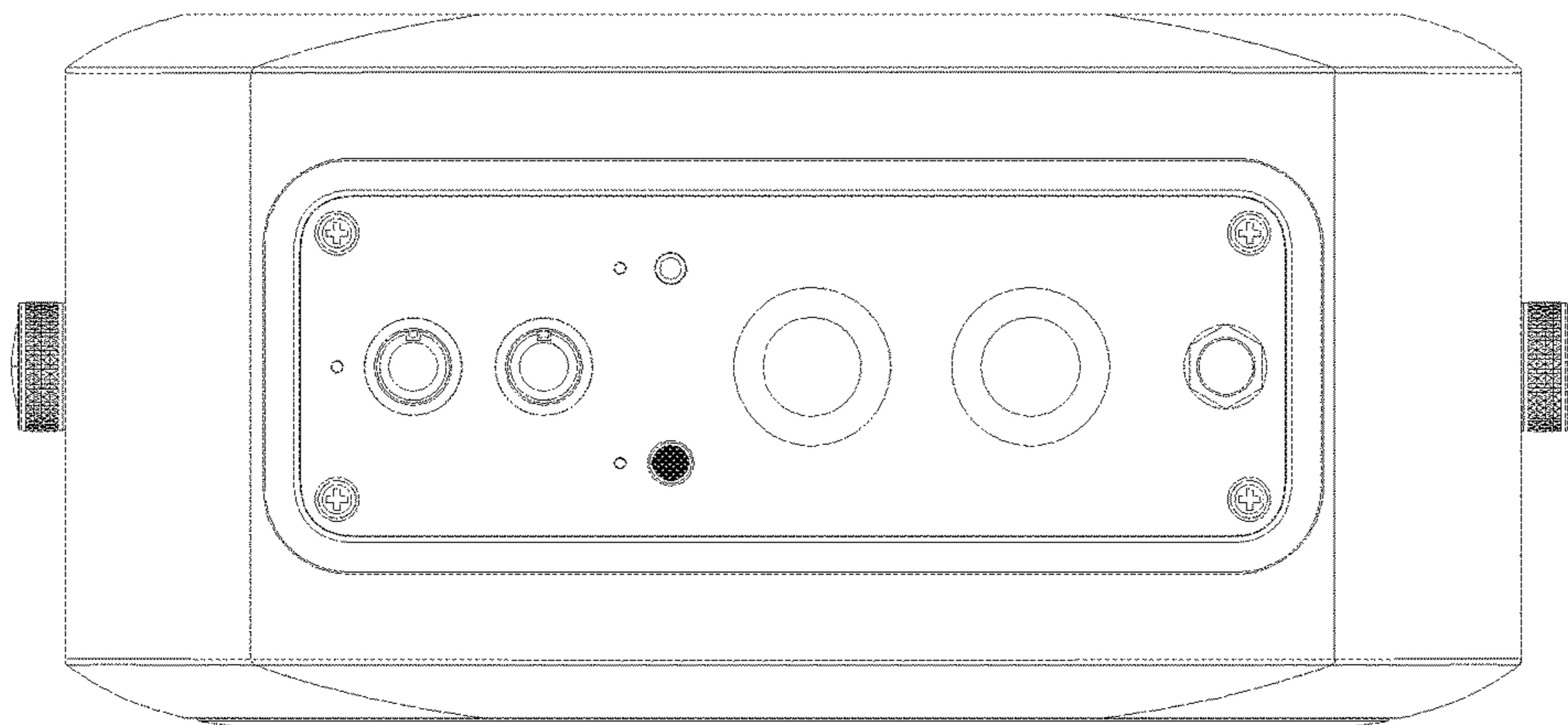

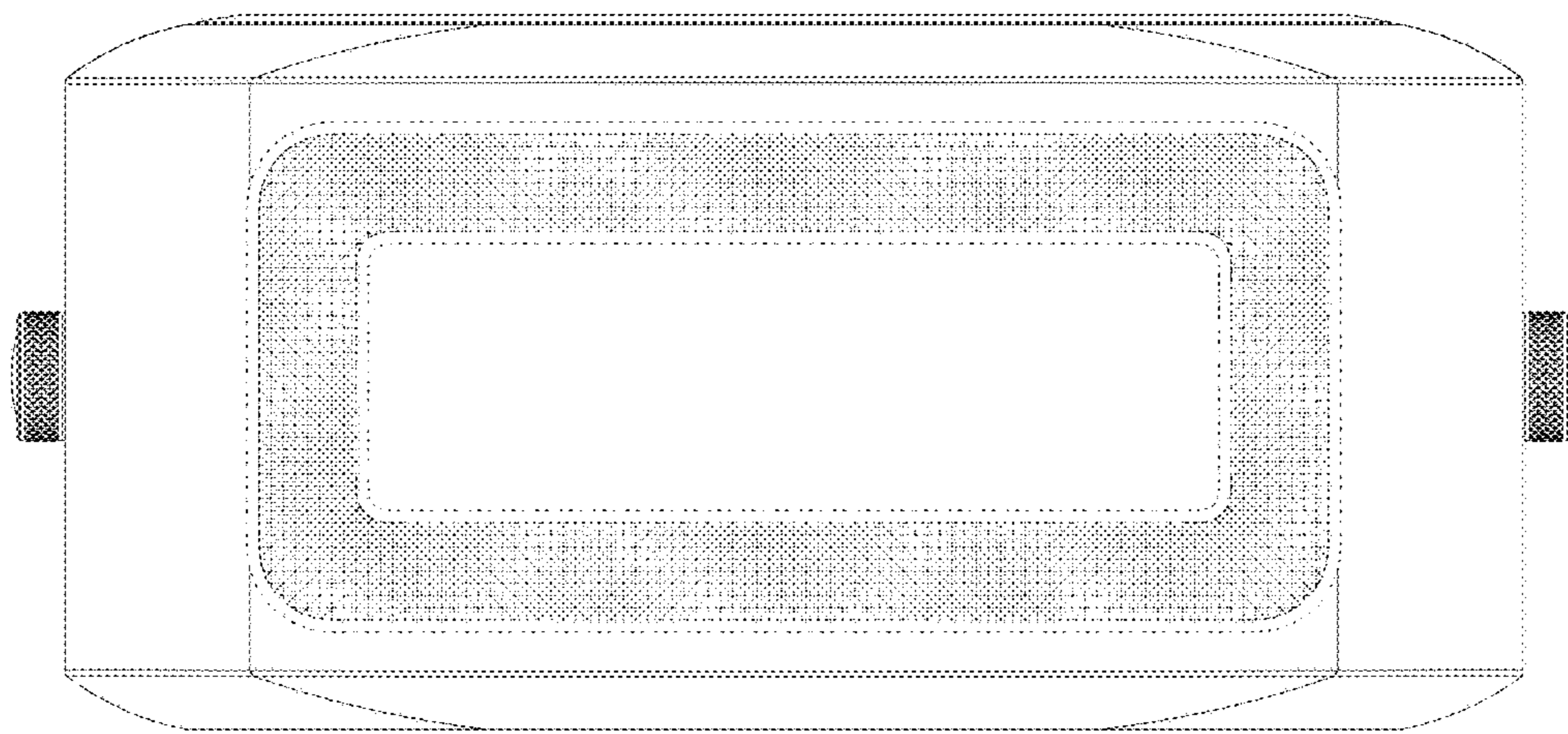
