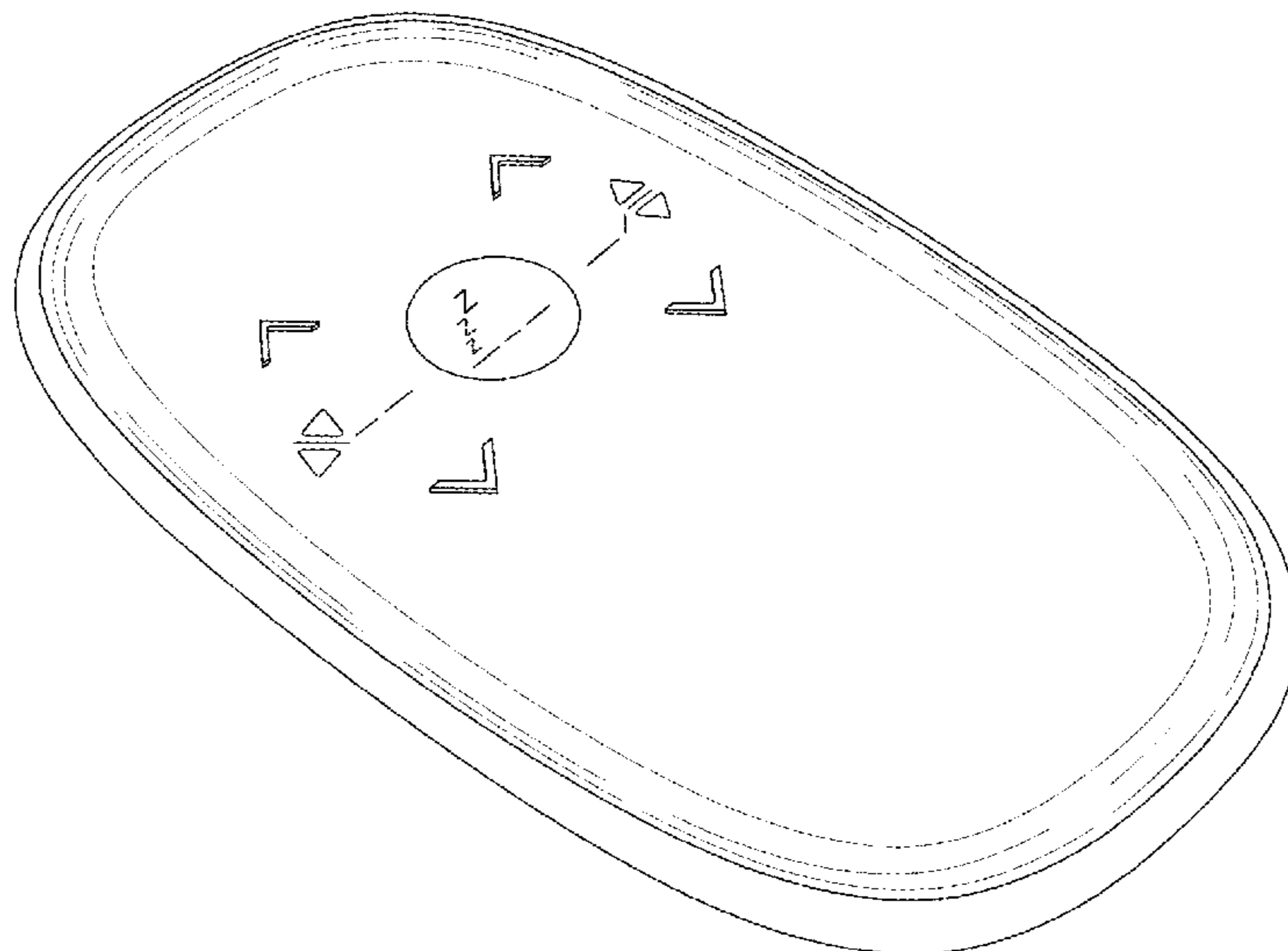
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the remote control of the present invention;

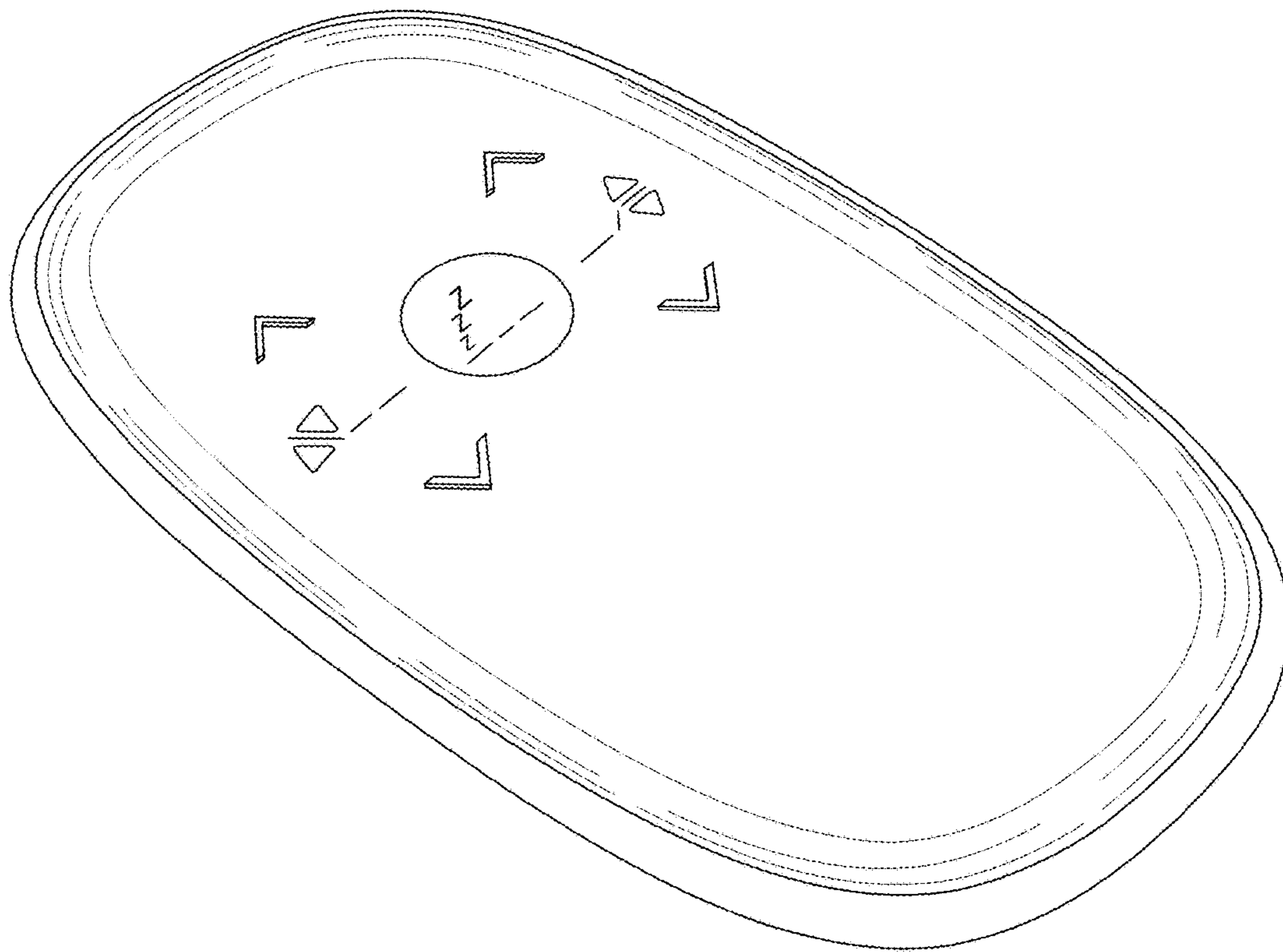

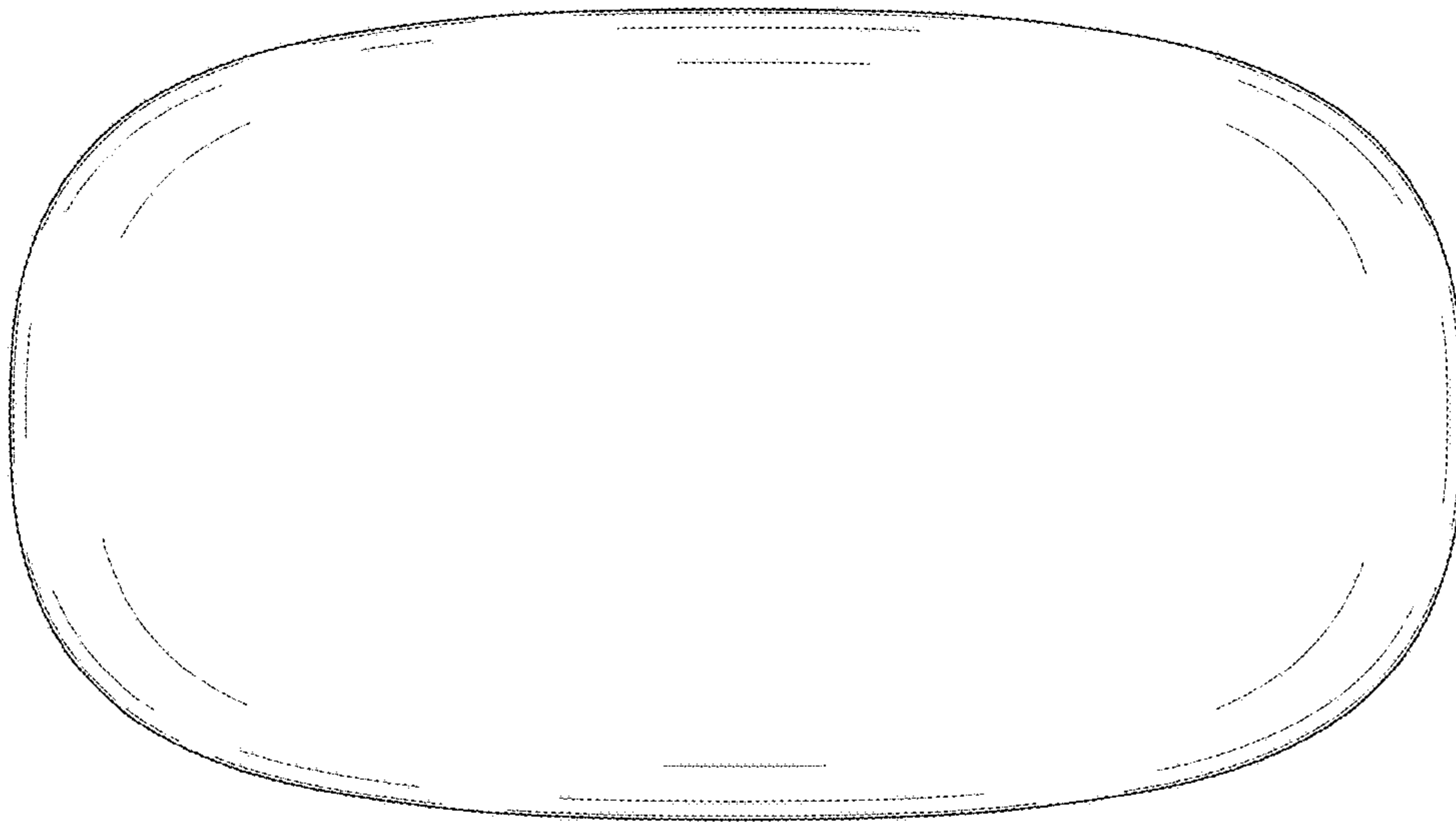

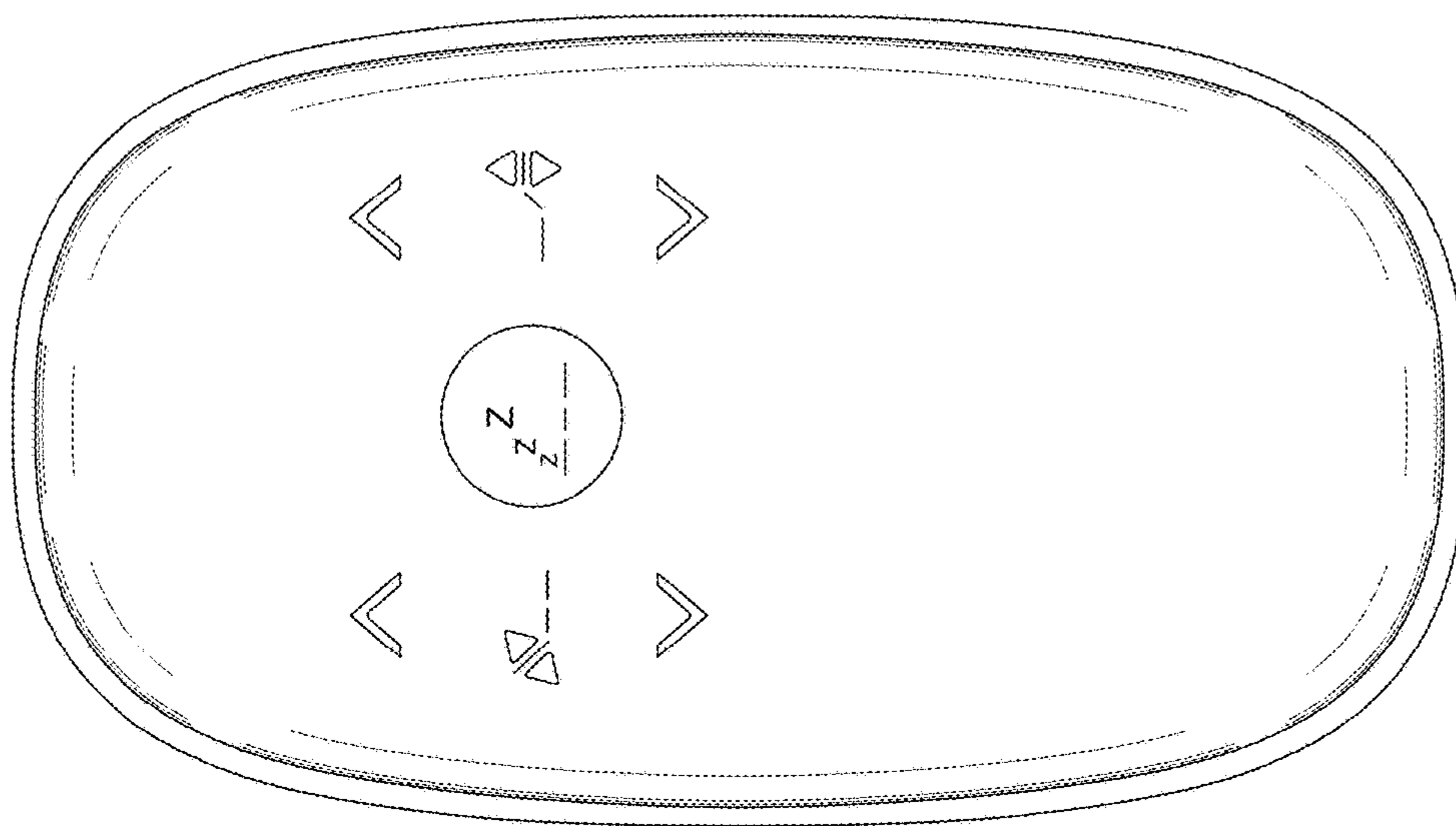

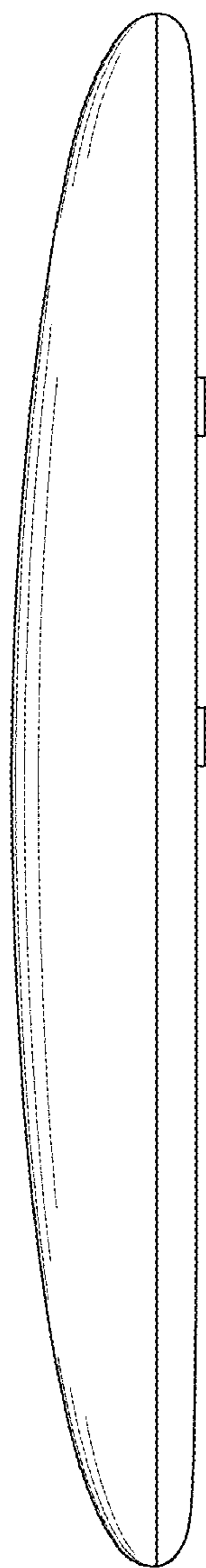

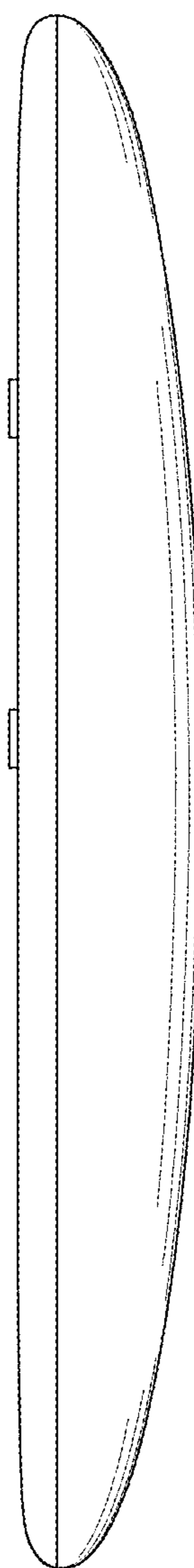

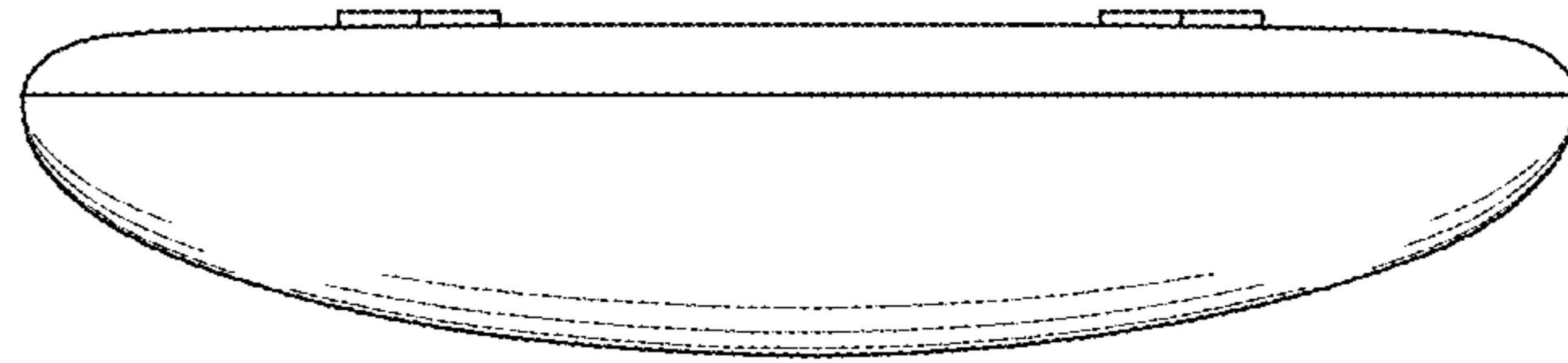

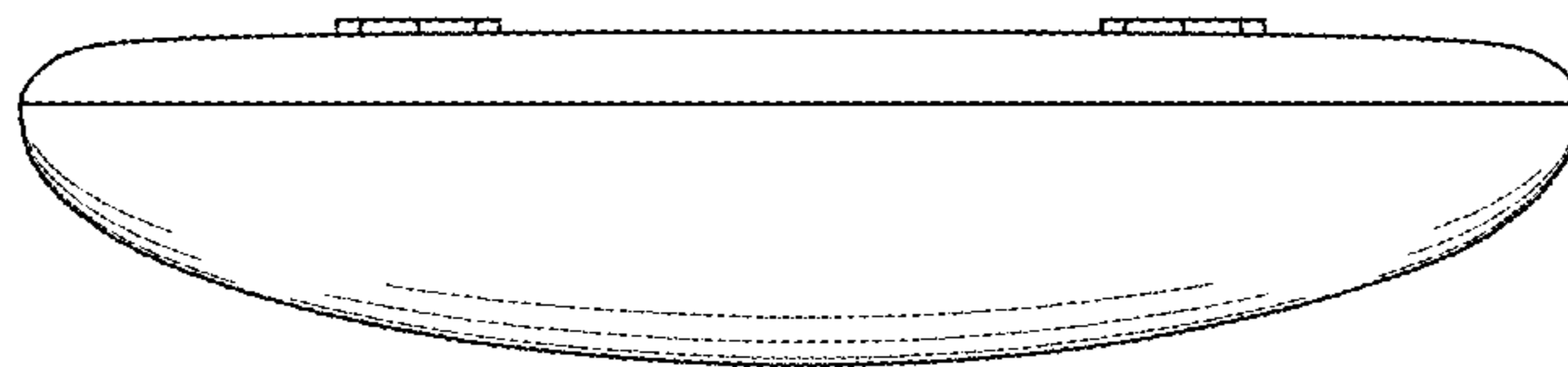
