FIG. 3 is a rear view for the ear mount in accordance with the embodiment of the present design.

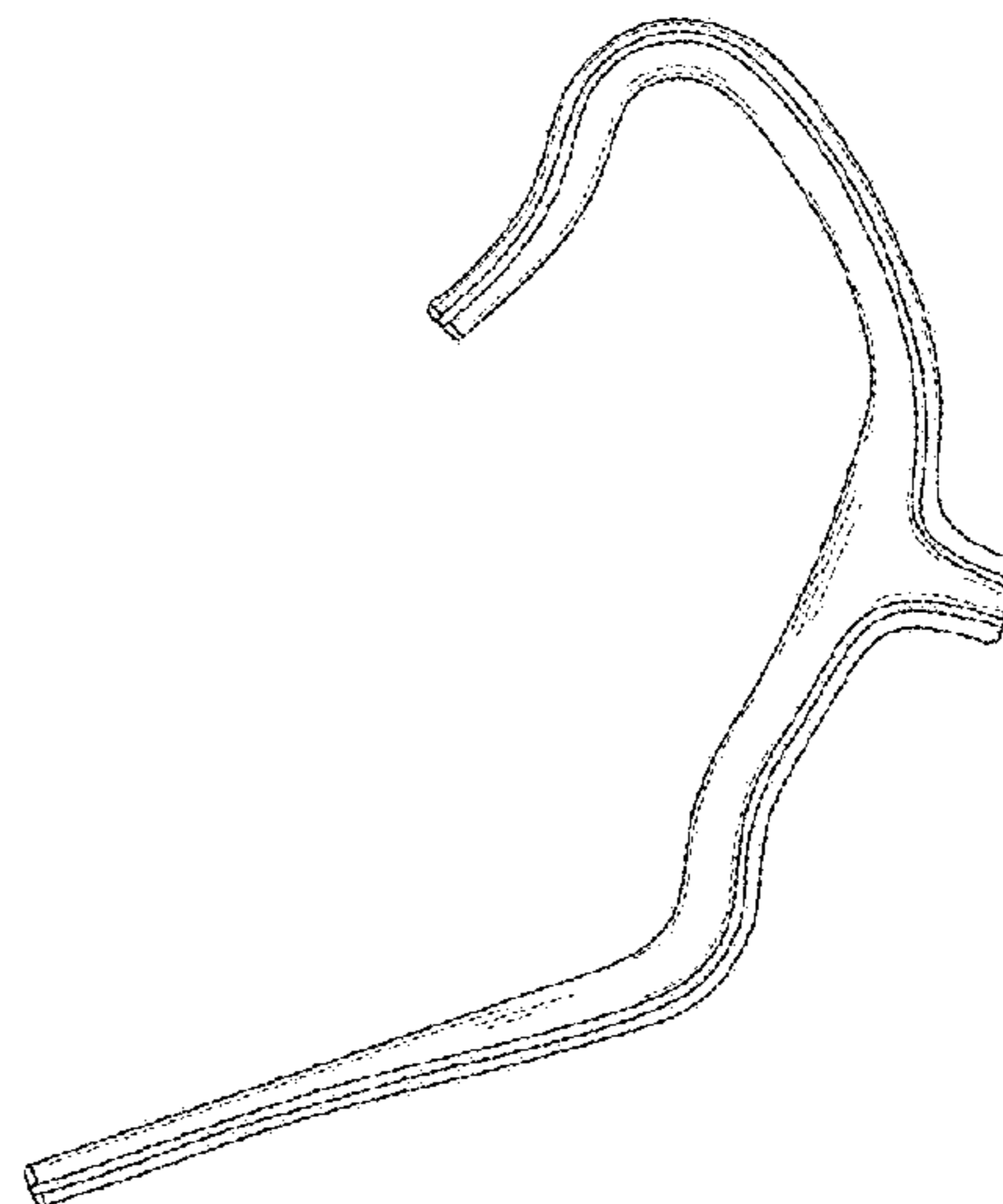
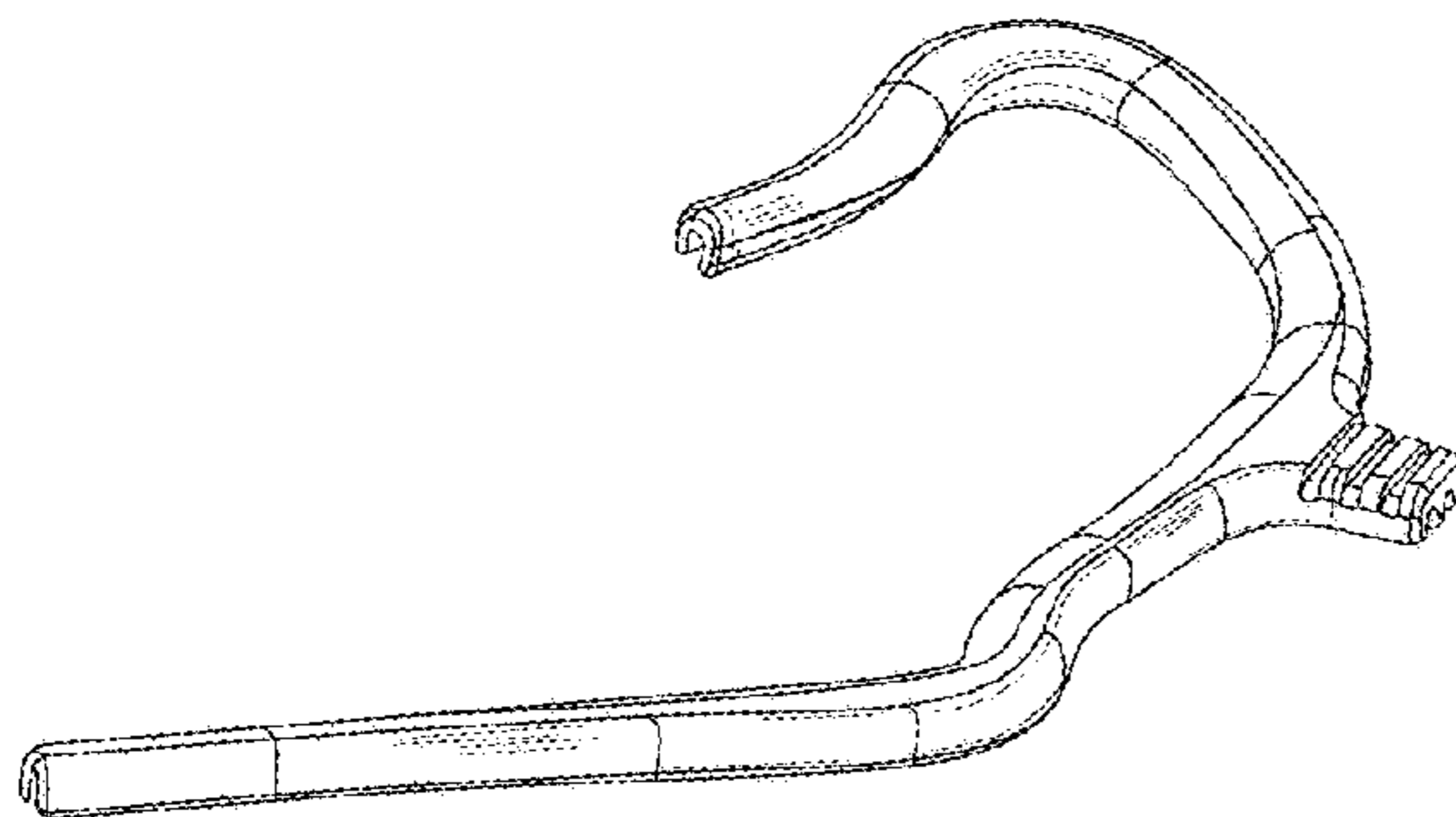
FIG. 4 is a top view for the ear mount in accordance with the embodiment of the present design.

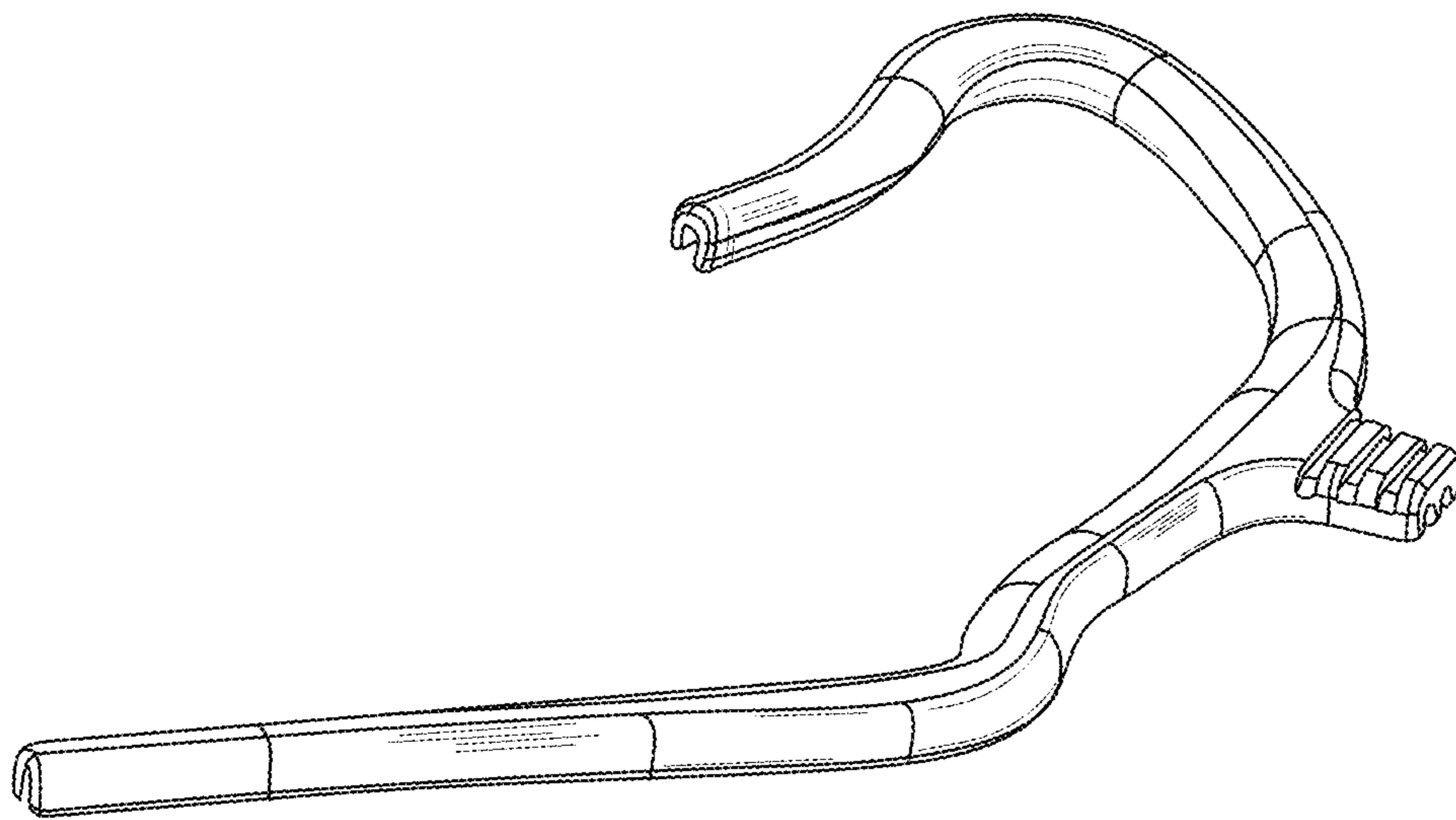

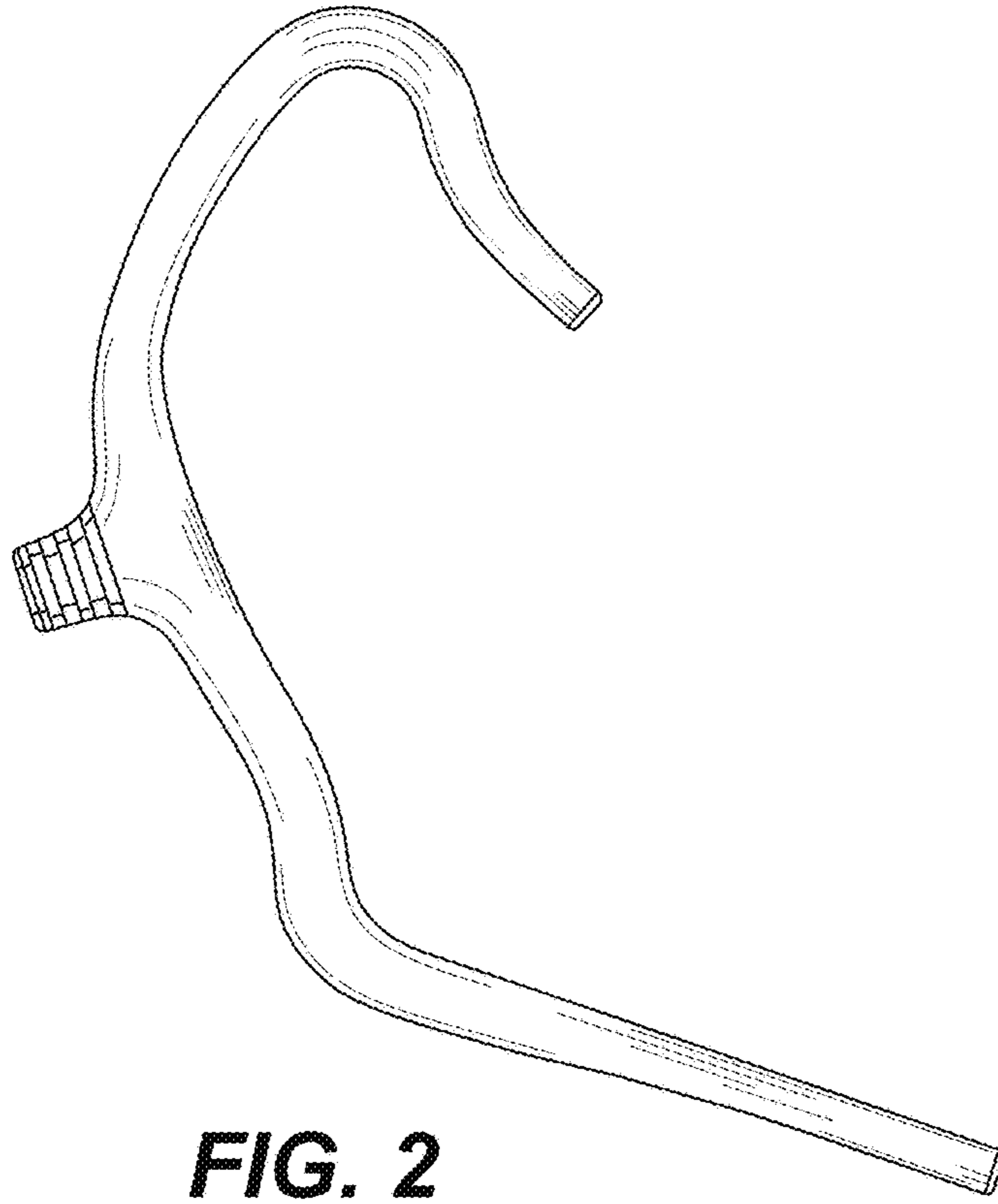

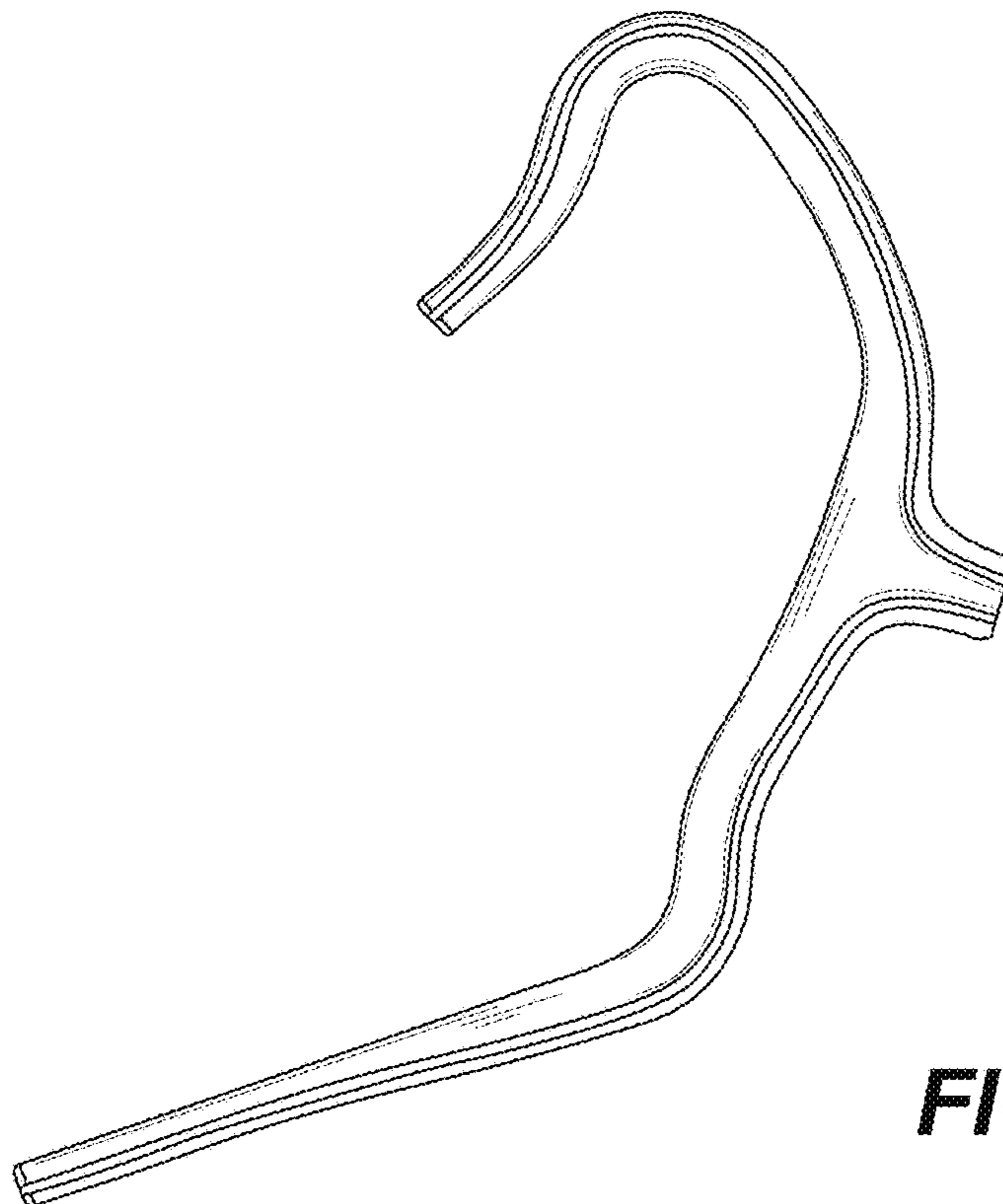

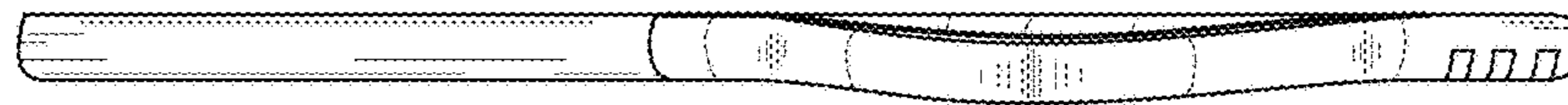

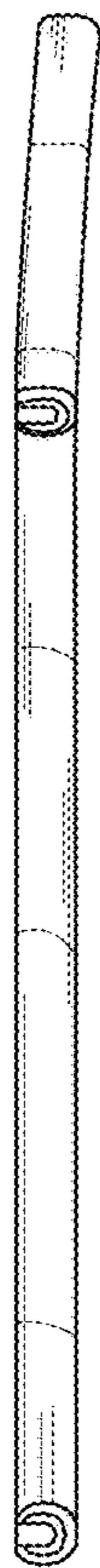
