shown and described.

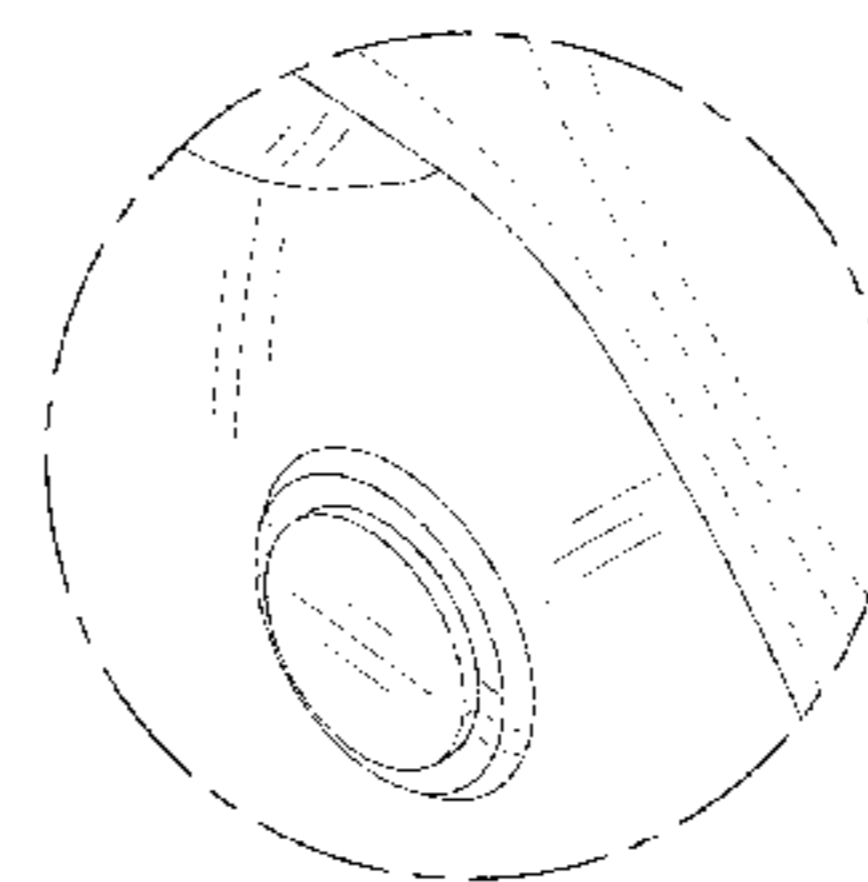
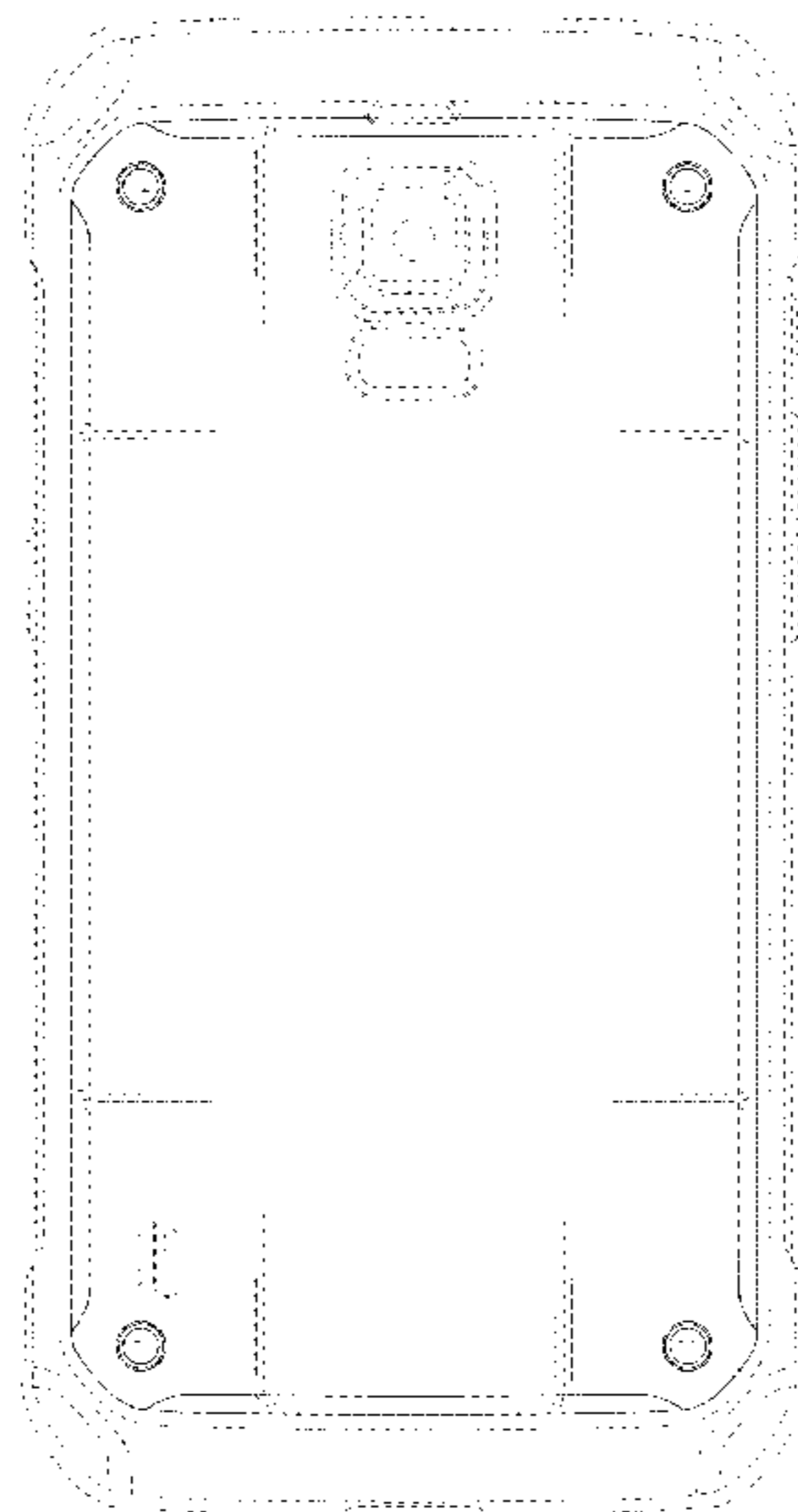
DESCRIPTION

FIG. 1 is a rear perspective view of a mobile terminal
showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a right-side view thereof;
FIG. 5 is a left-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is an enlarged view of the encircled portion in FIG.
1.

The broken lines in the figures that are immediately adjacent
to the shaded areas and define unshaded regions represent
the bounds of the claim. All other broken lines, that is, the
features within broken line boundaries and broken lines

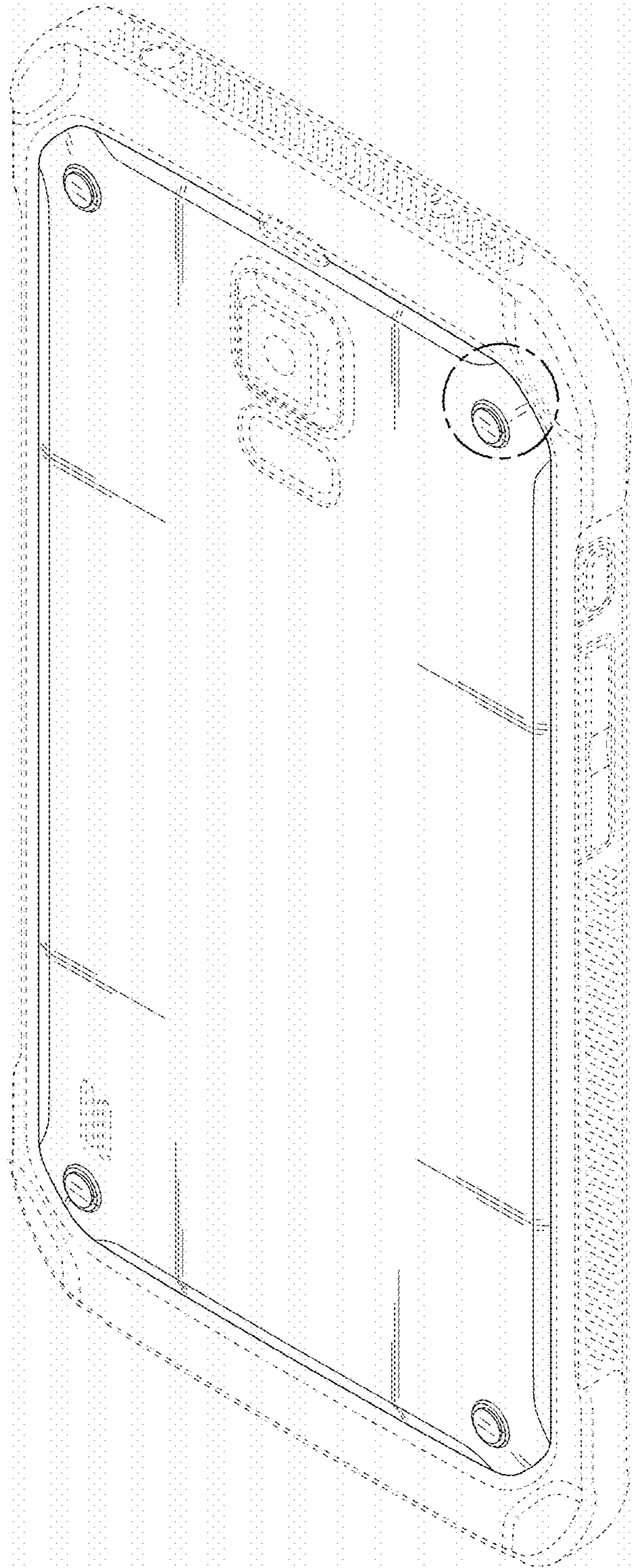

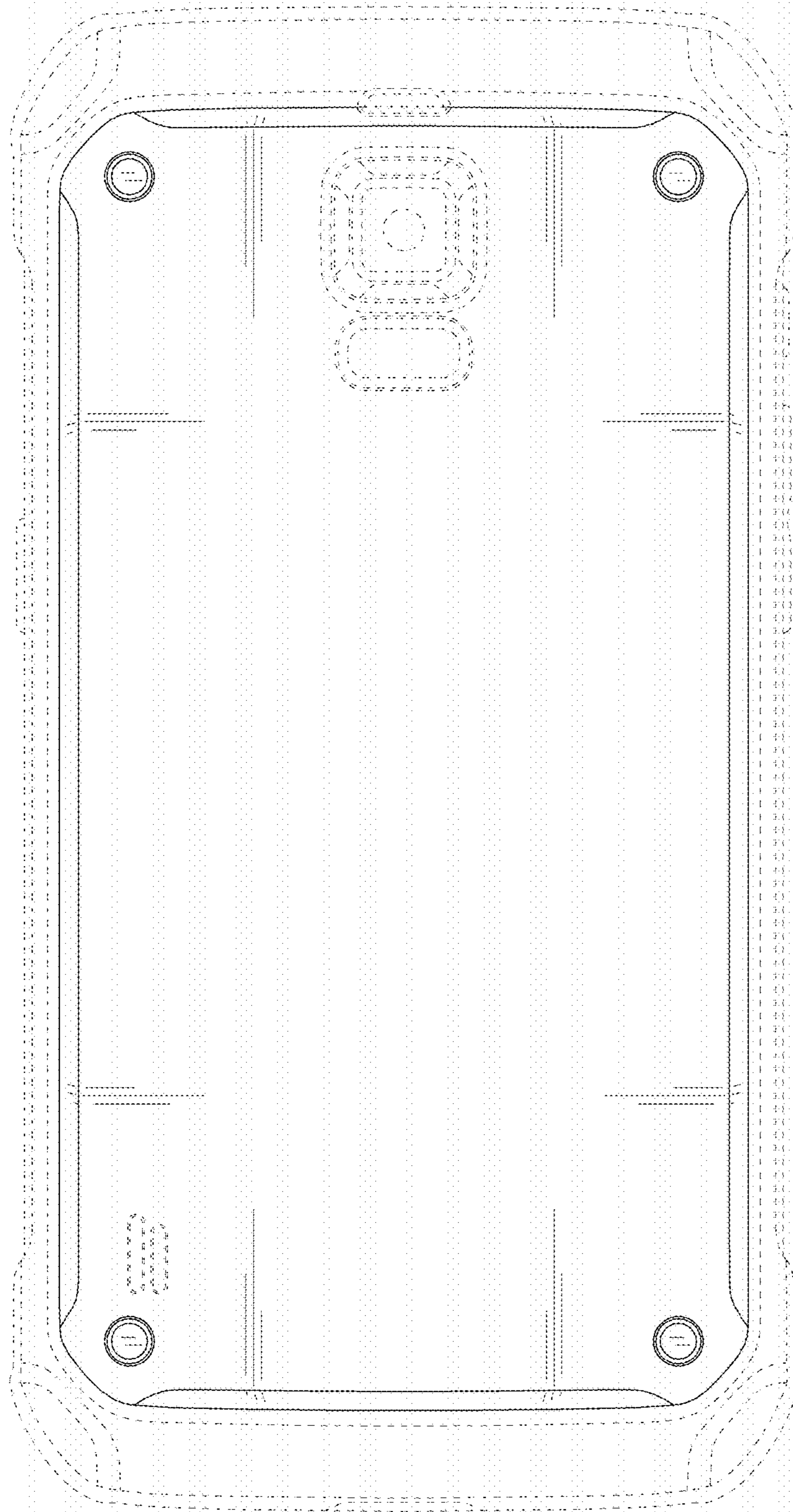

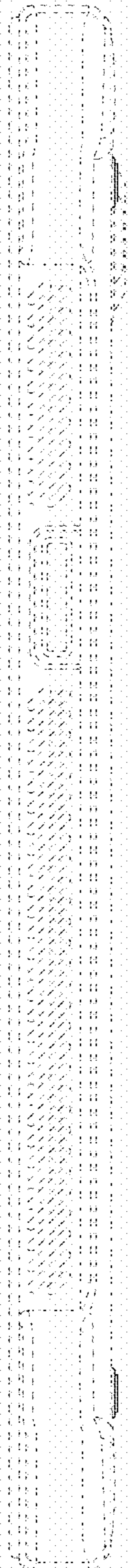

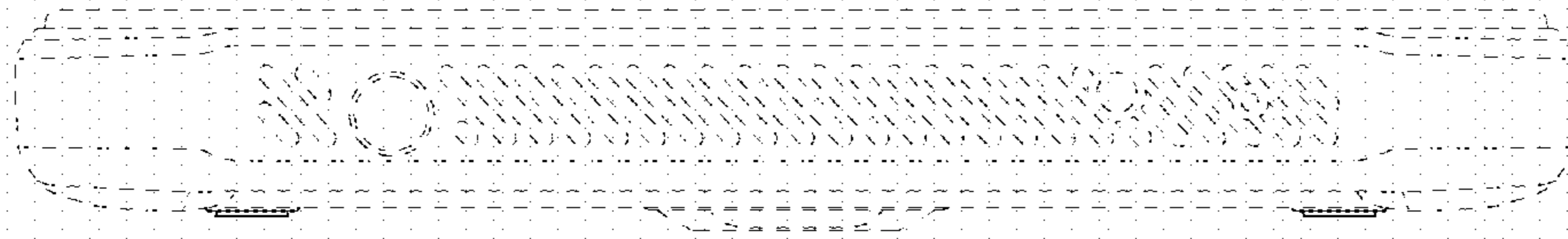

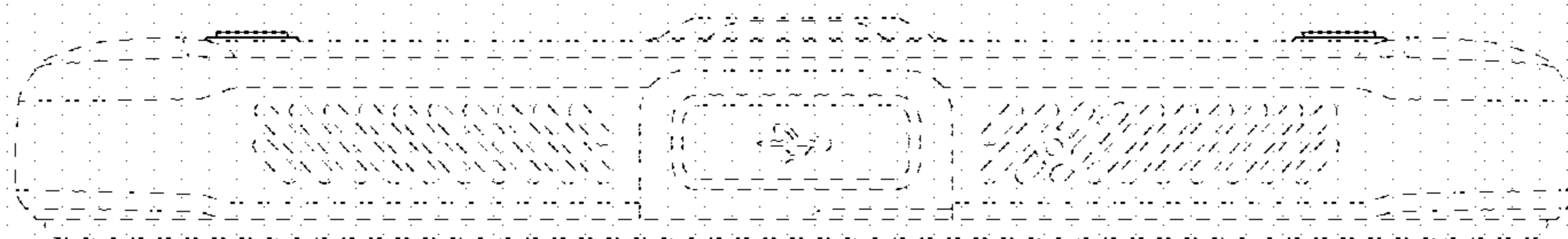
