(57) **CLAIM**

The ornamental design for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of an electronic device showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left-side elevation view thereof;

FIG. 5 is a right-side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a bottom left rear perspective view thereof;

FIG. 9 is an enlarged view of the portion A encircled in FIG. 1;

FIG. 10 is an enlarged view of the portion B encircled in FIG. 1;

FIG. 11 is an enlarged view of the portion C encircled in FIG. 2; and,

FIG. 12 is an enlarged view of the portion D encircled in FIG. 3.

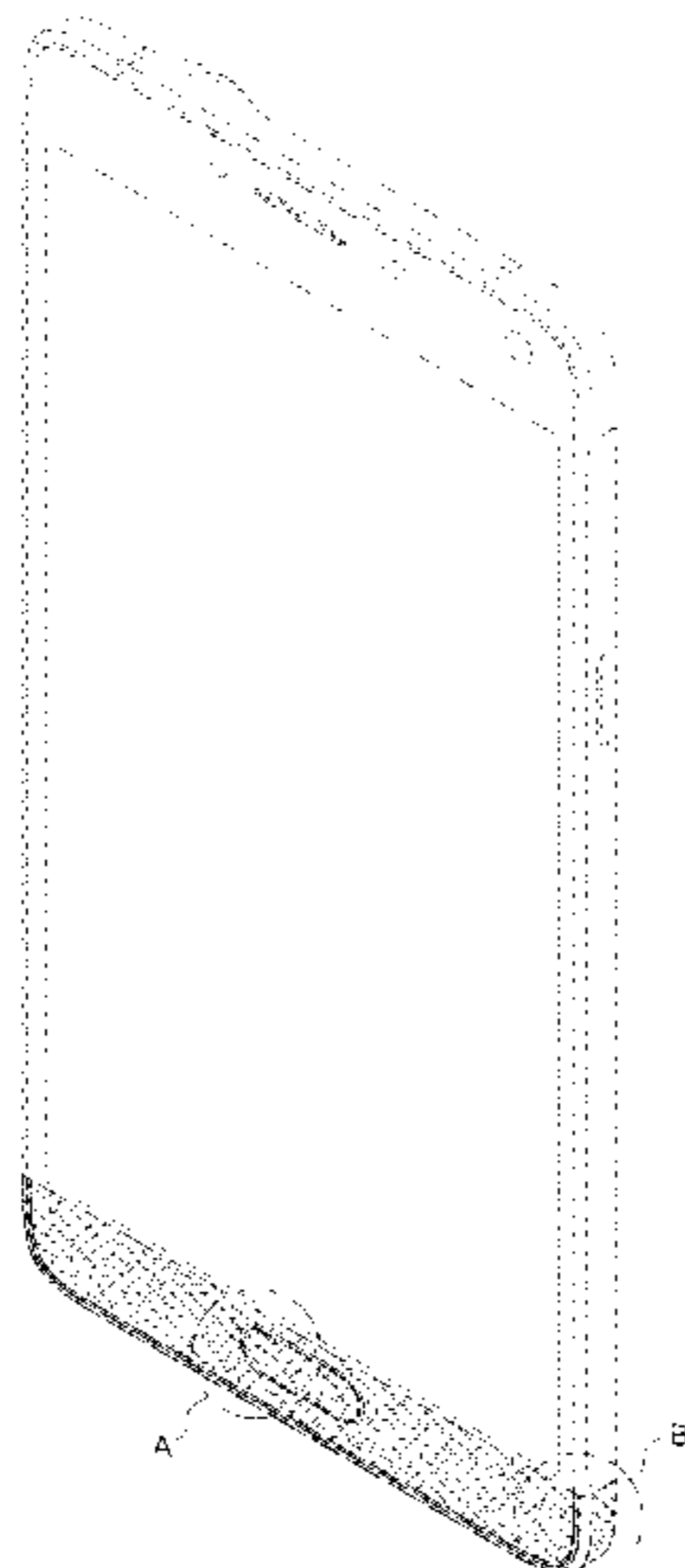
The stippled areas represent areas of contrasting color to adjacent non-stippled areas. No particular colors are being claimed.

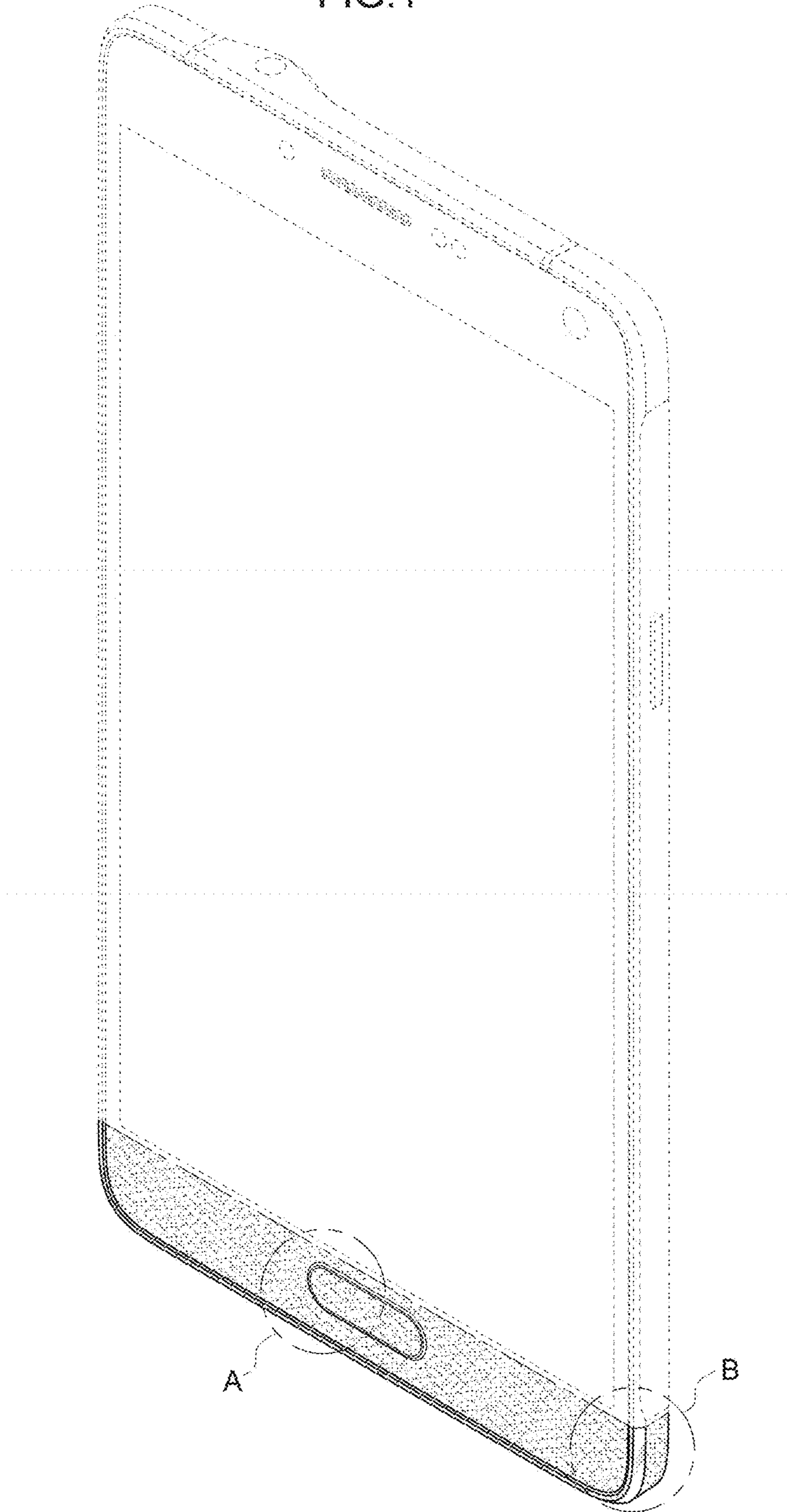

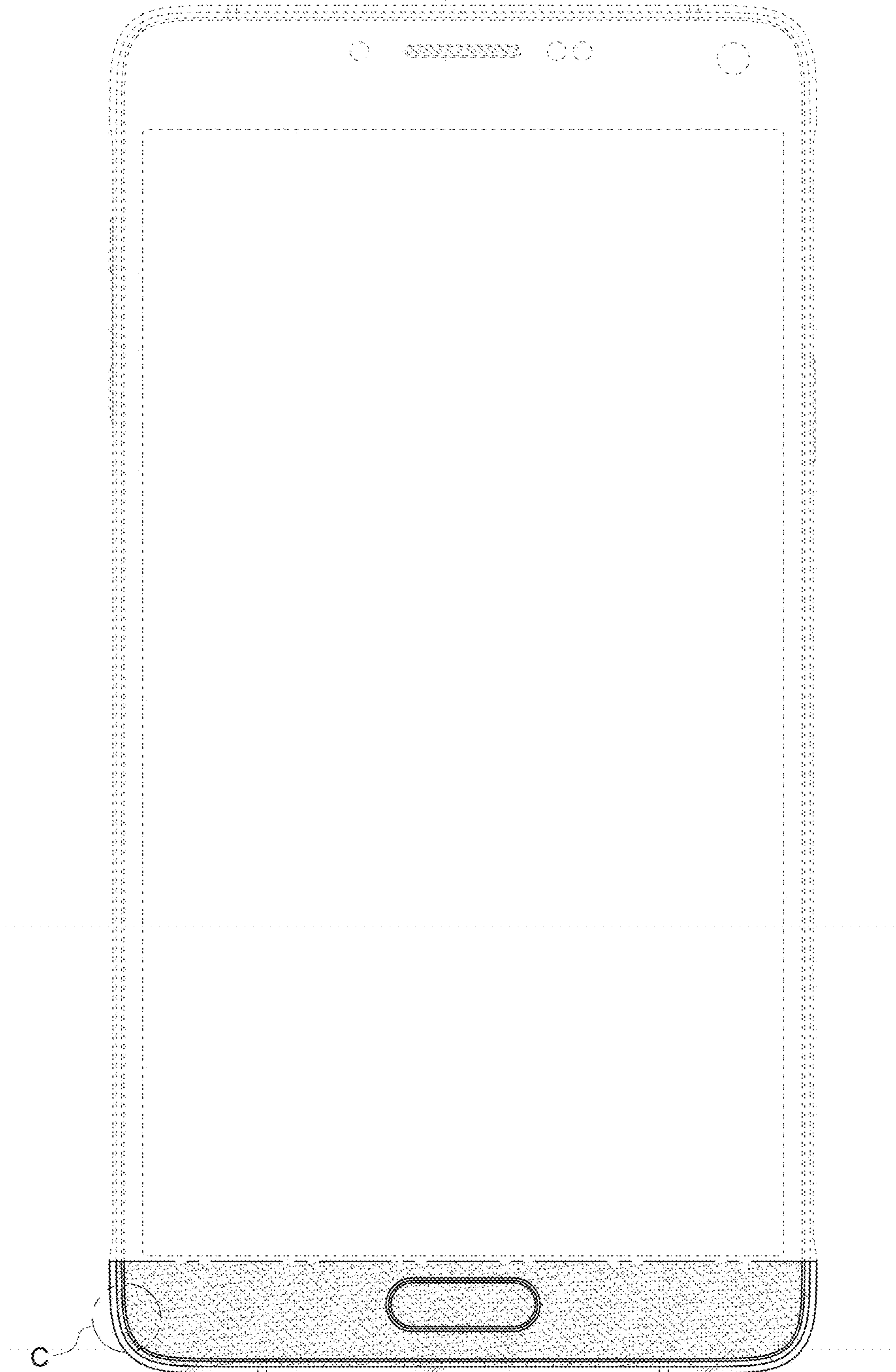

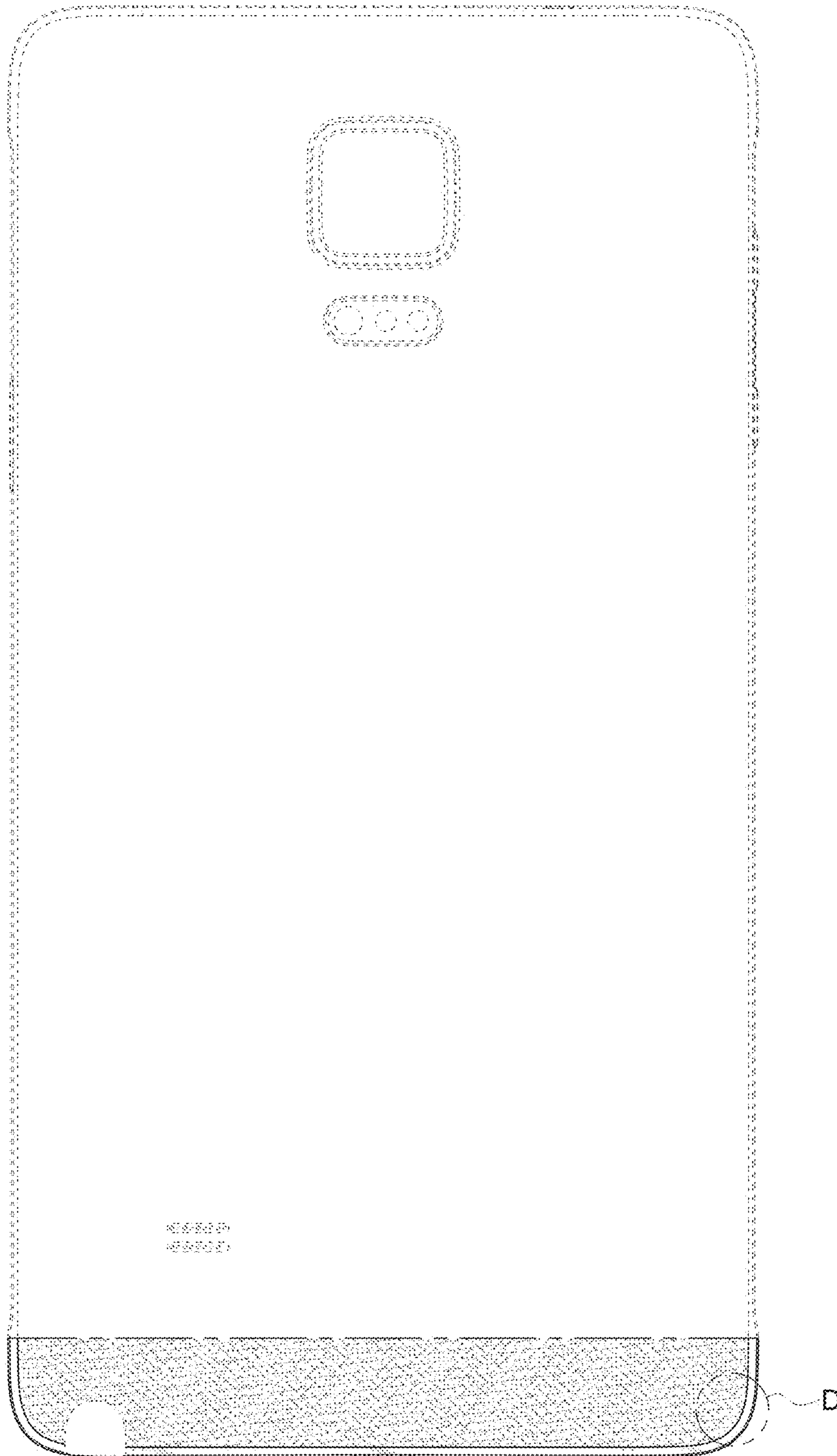

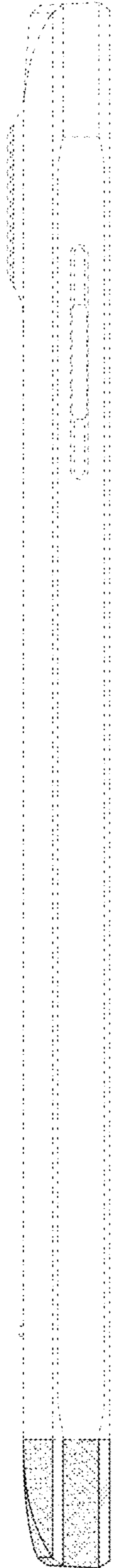

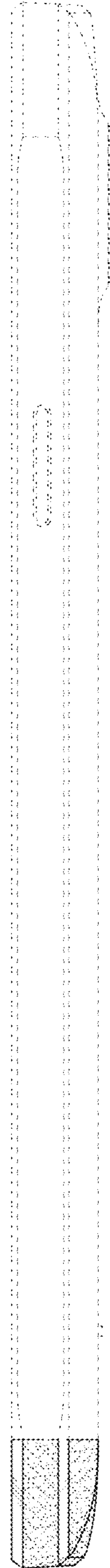

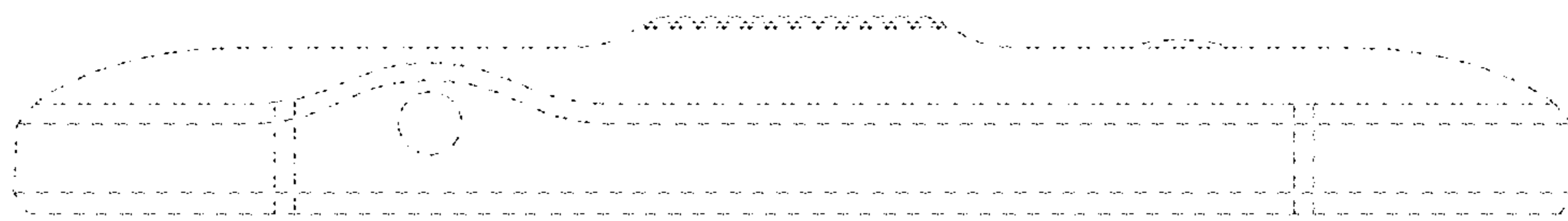

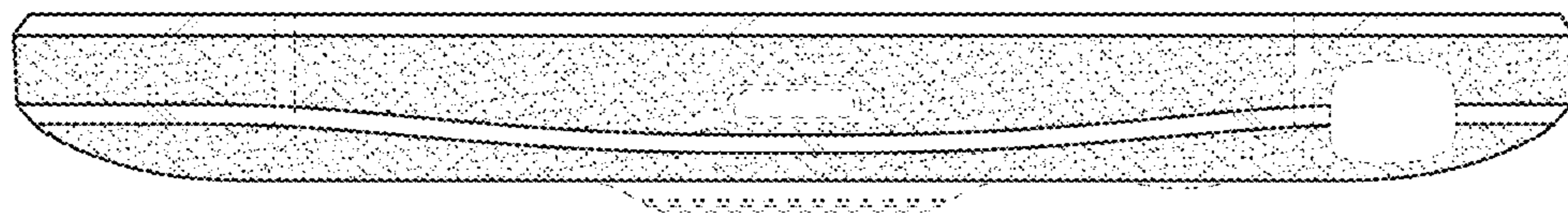

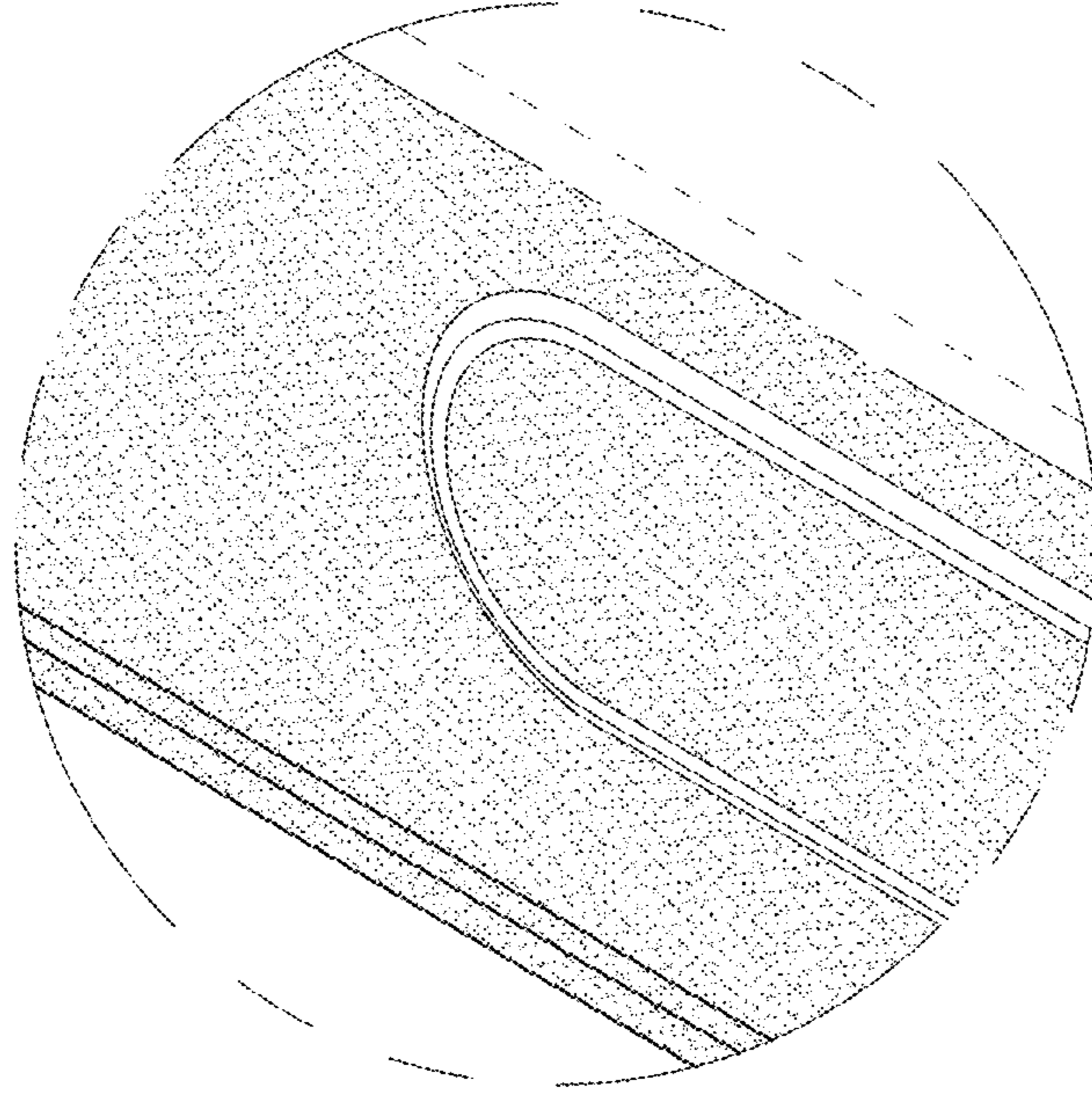

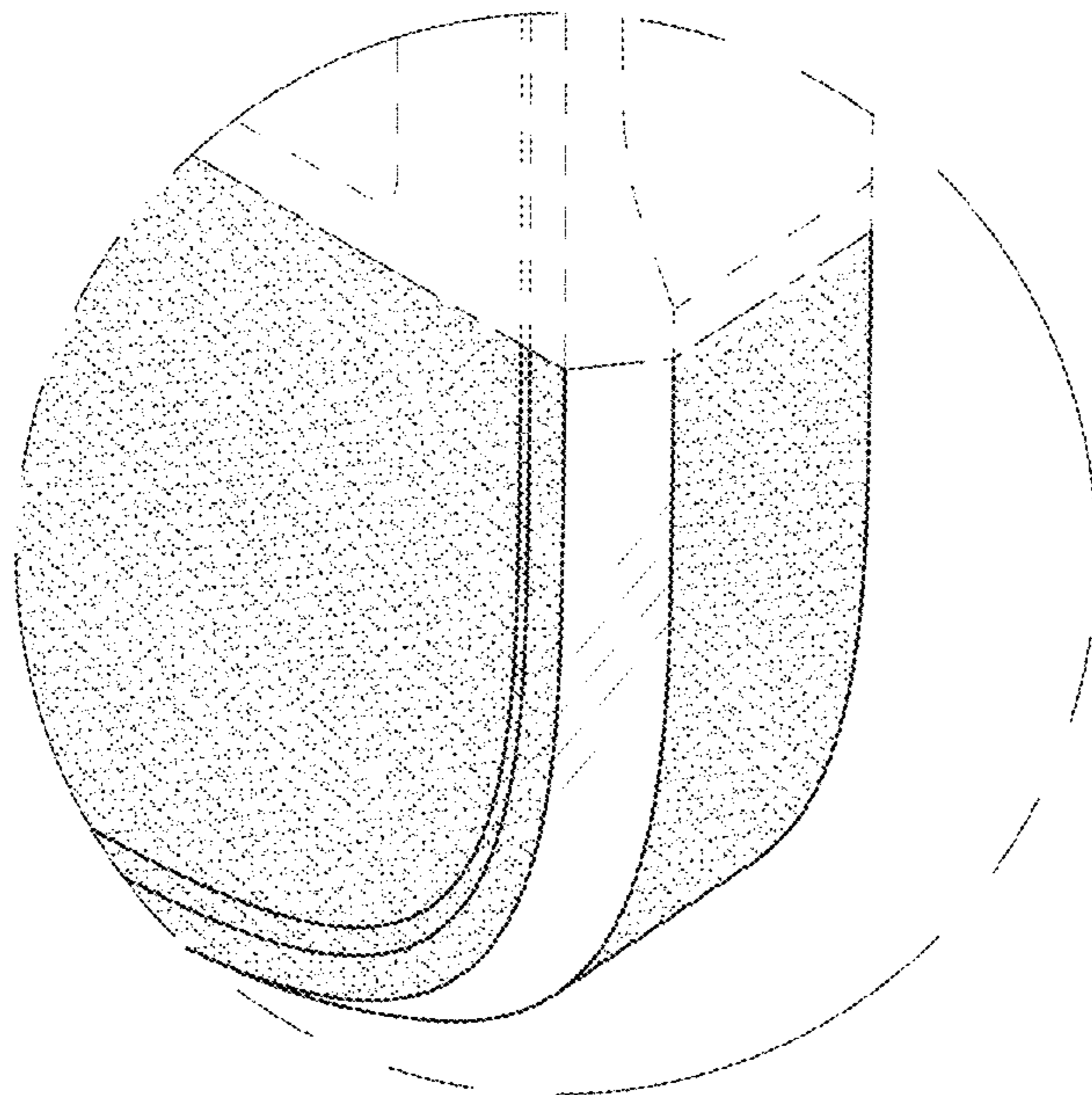

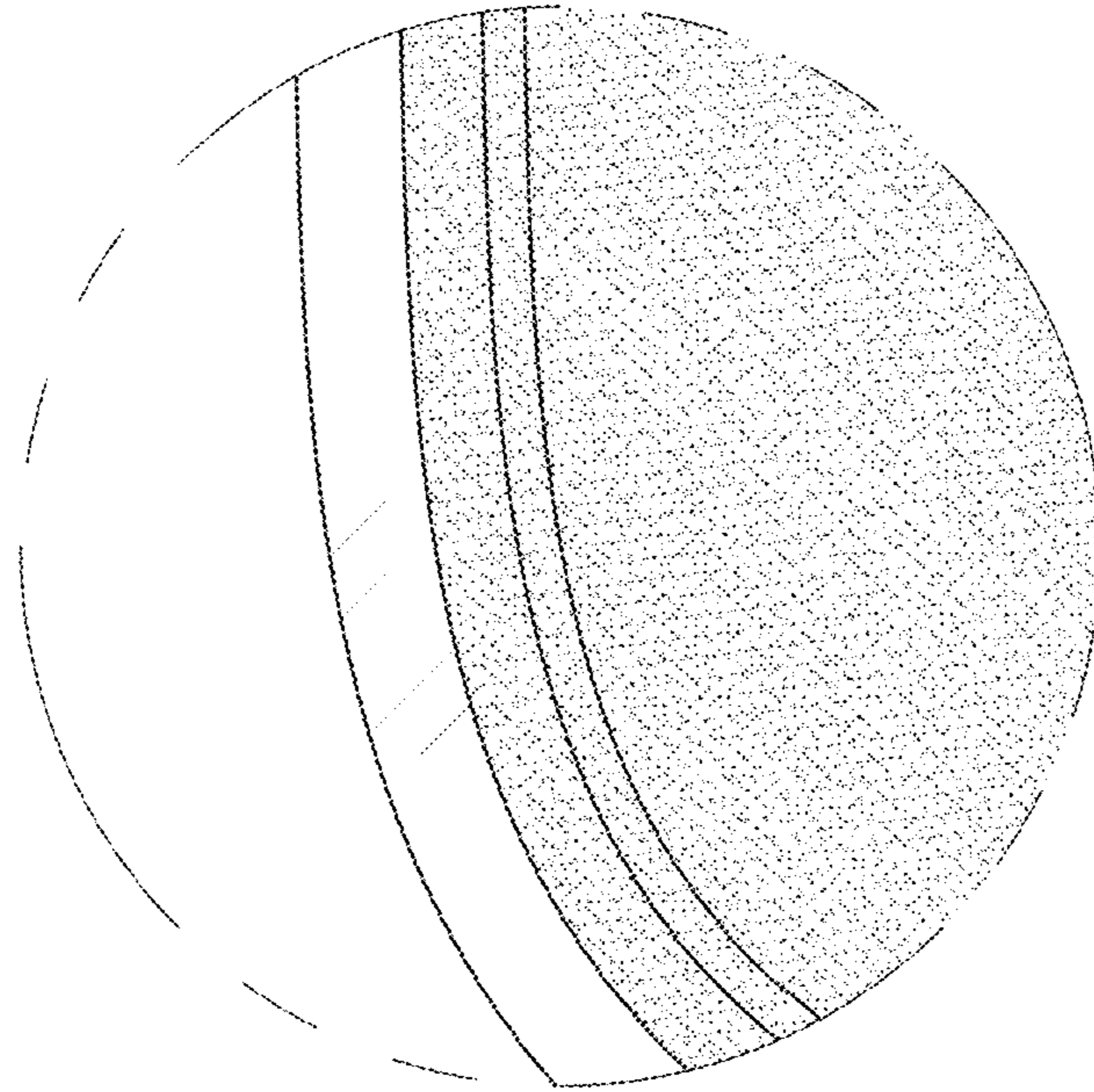
