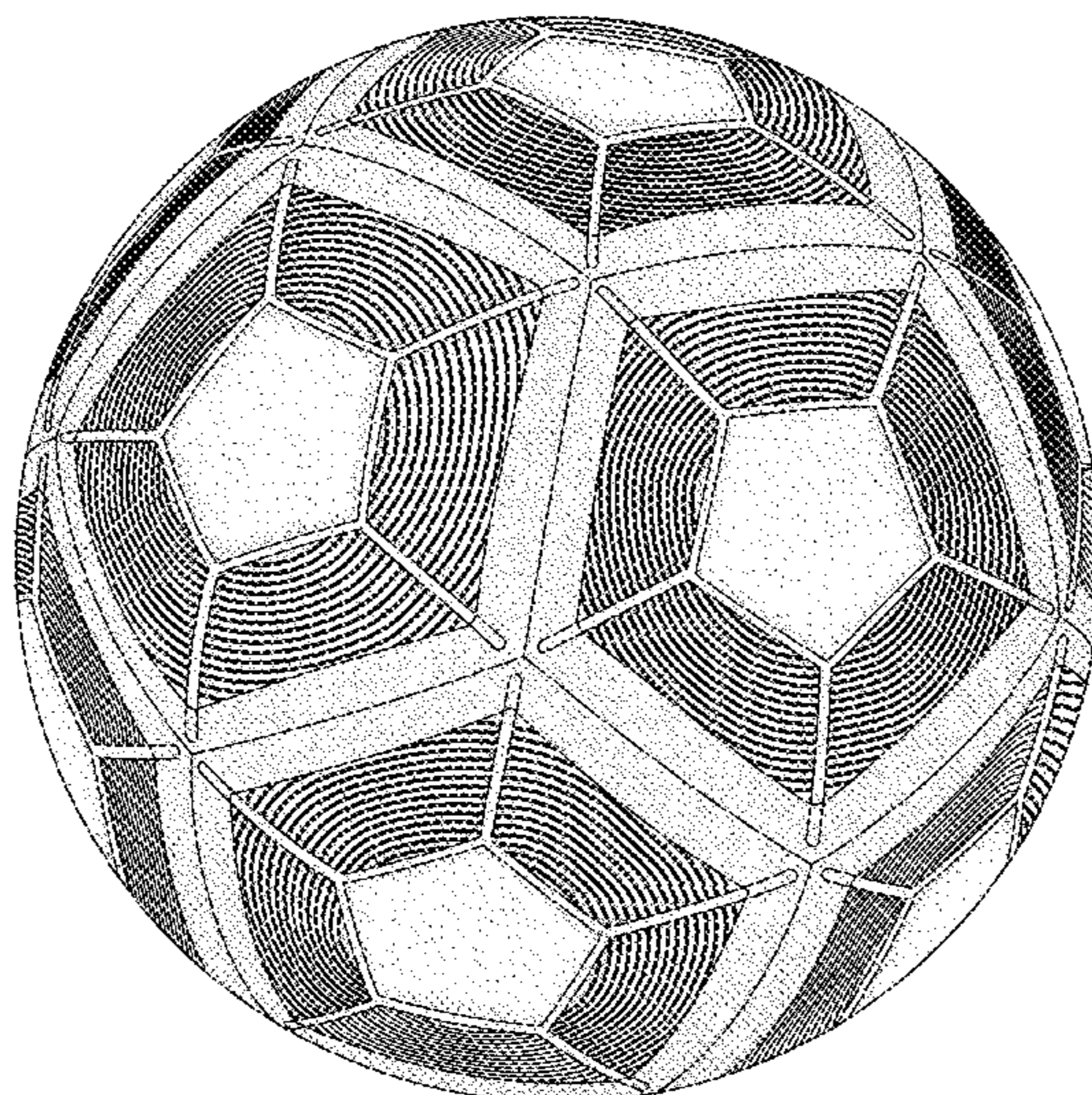
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a ball with surface ornamentation pattern showing our new design;

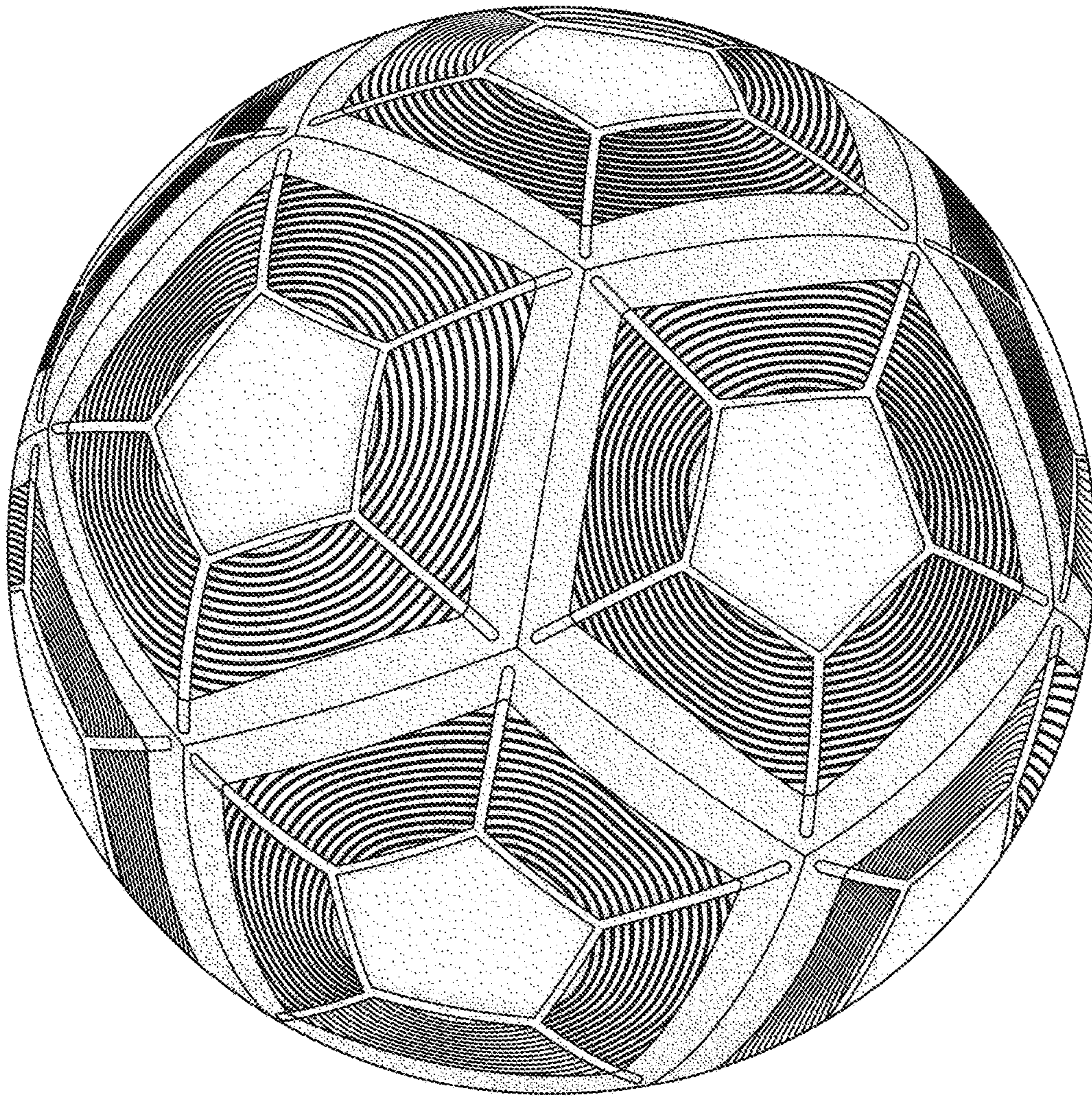

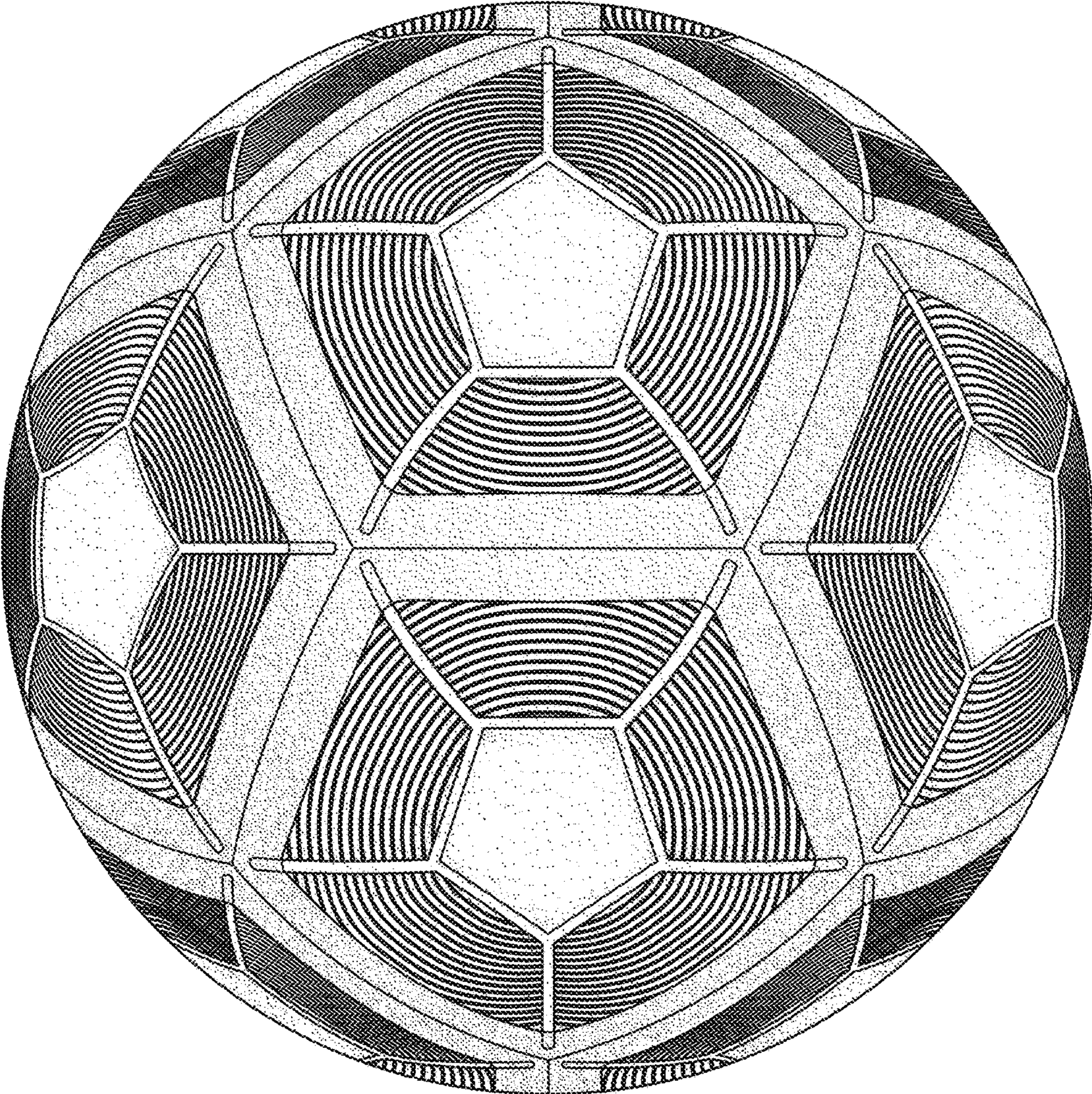

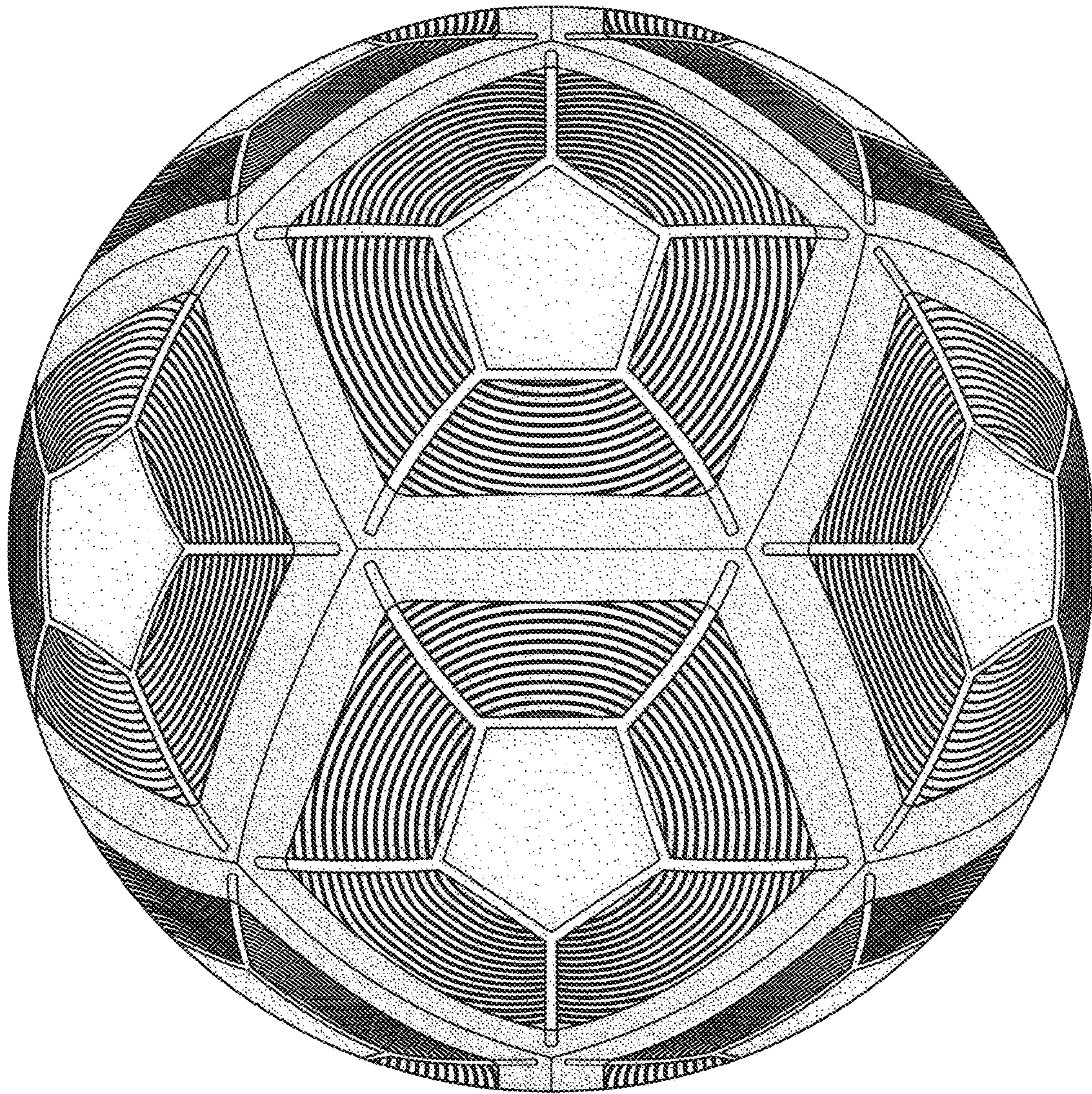

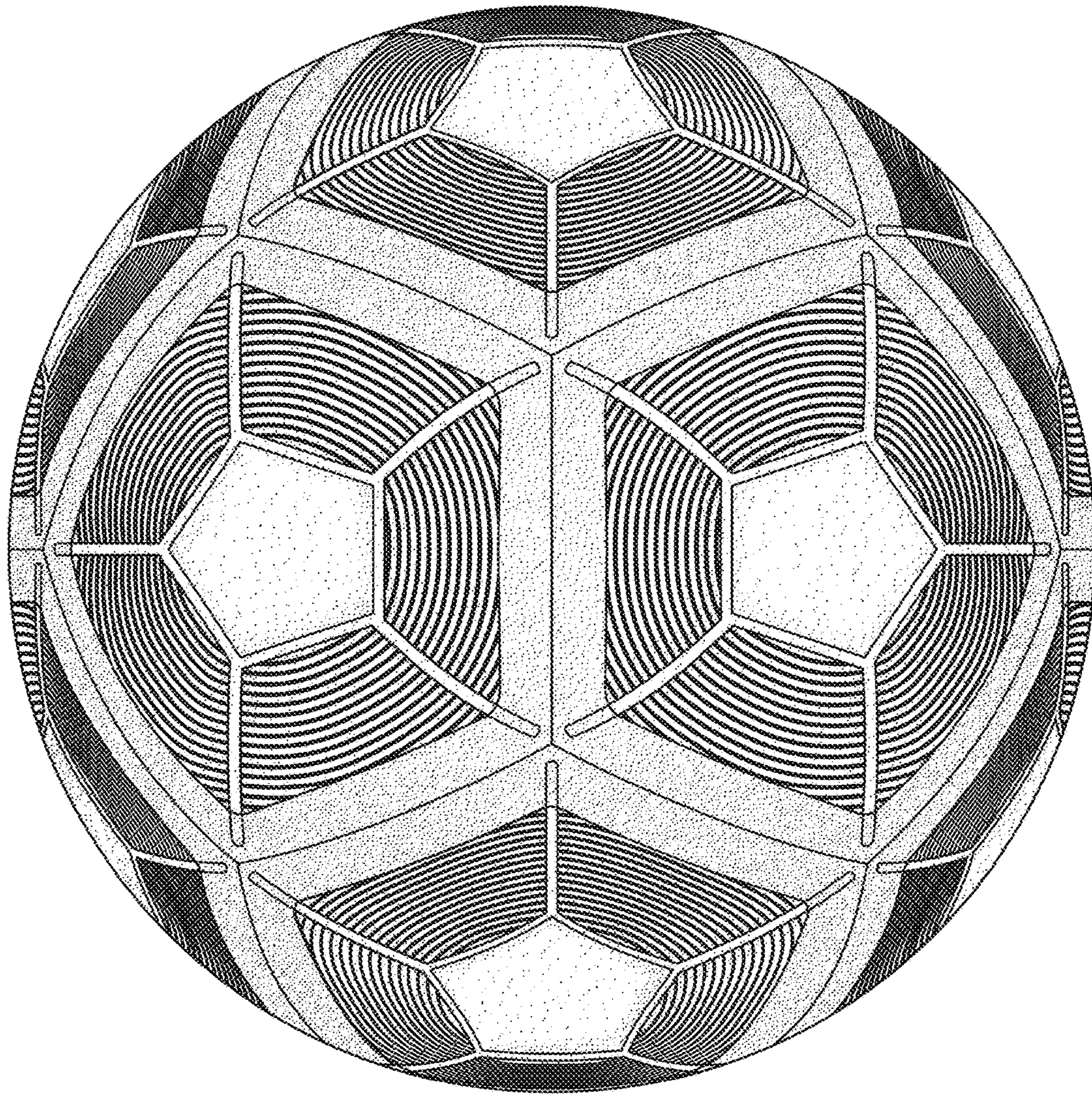

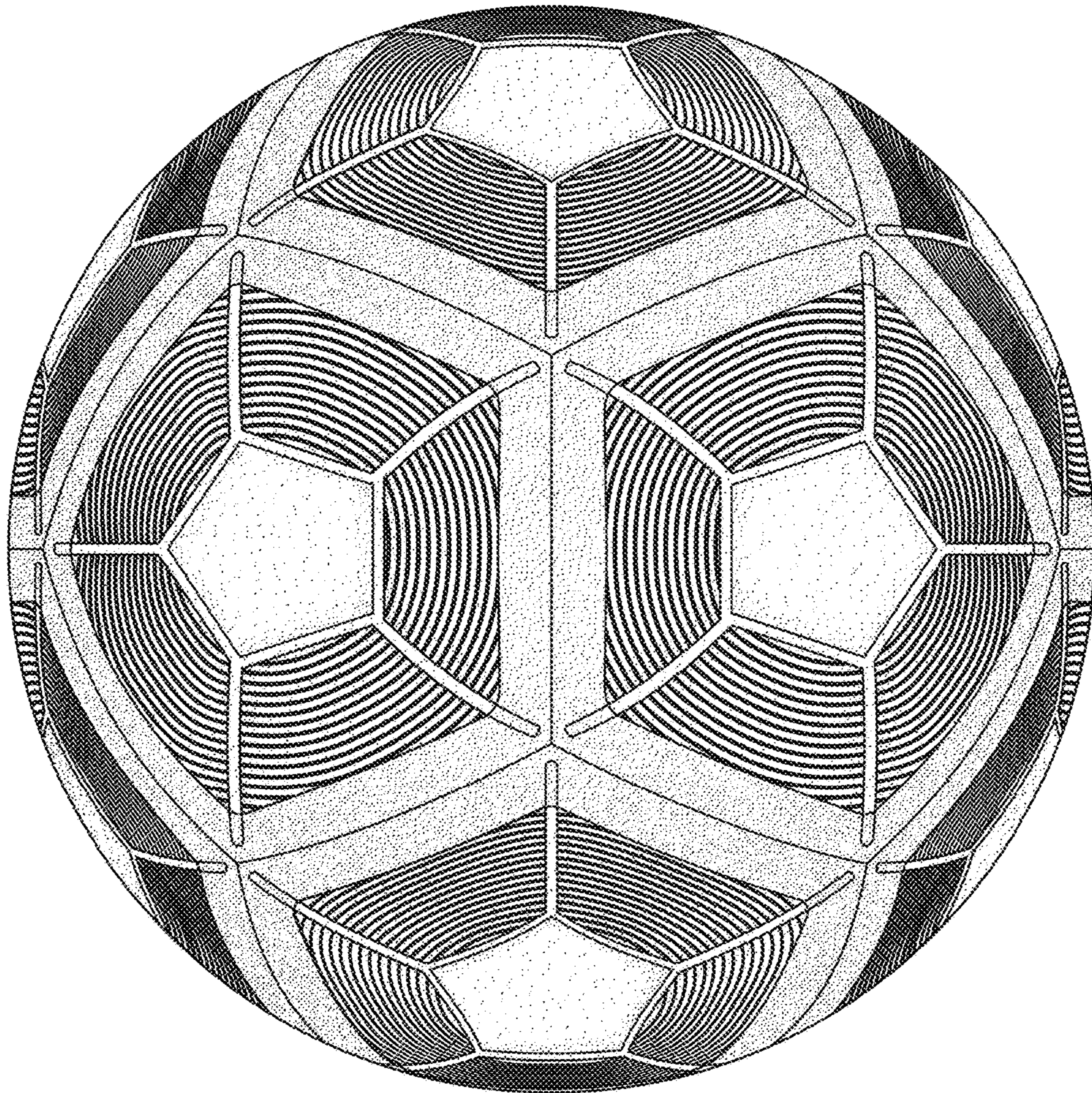

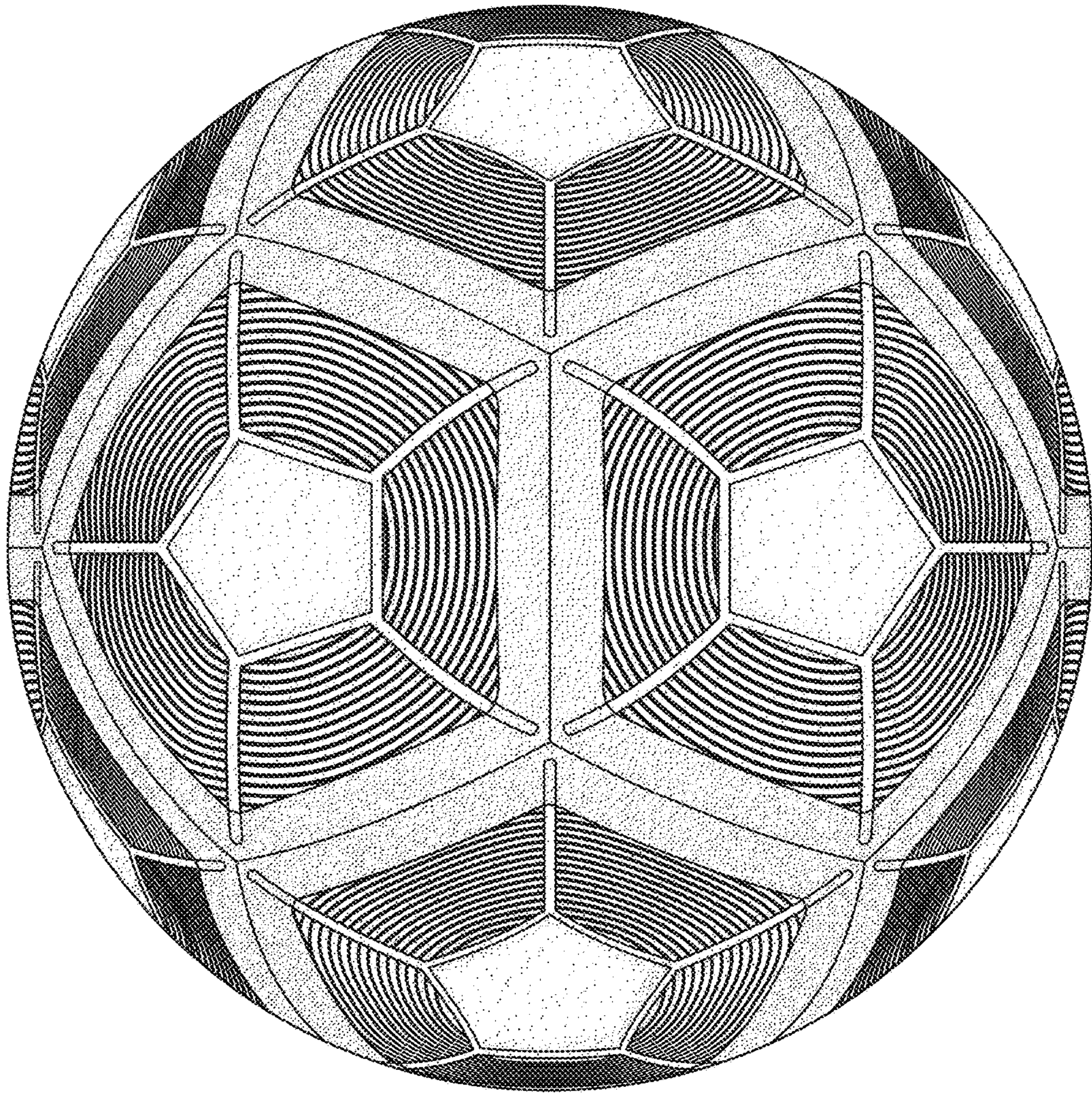

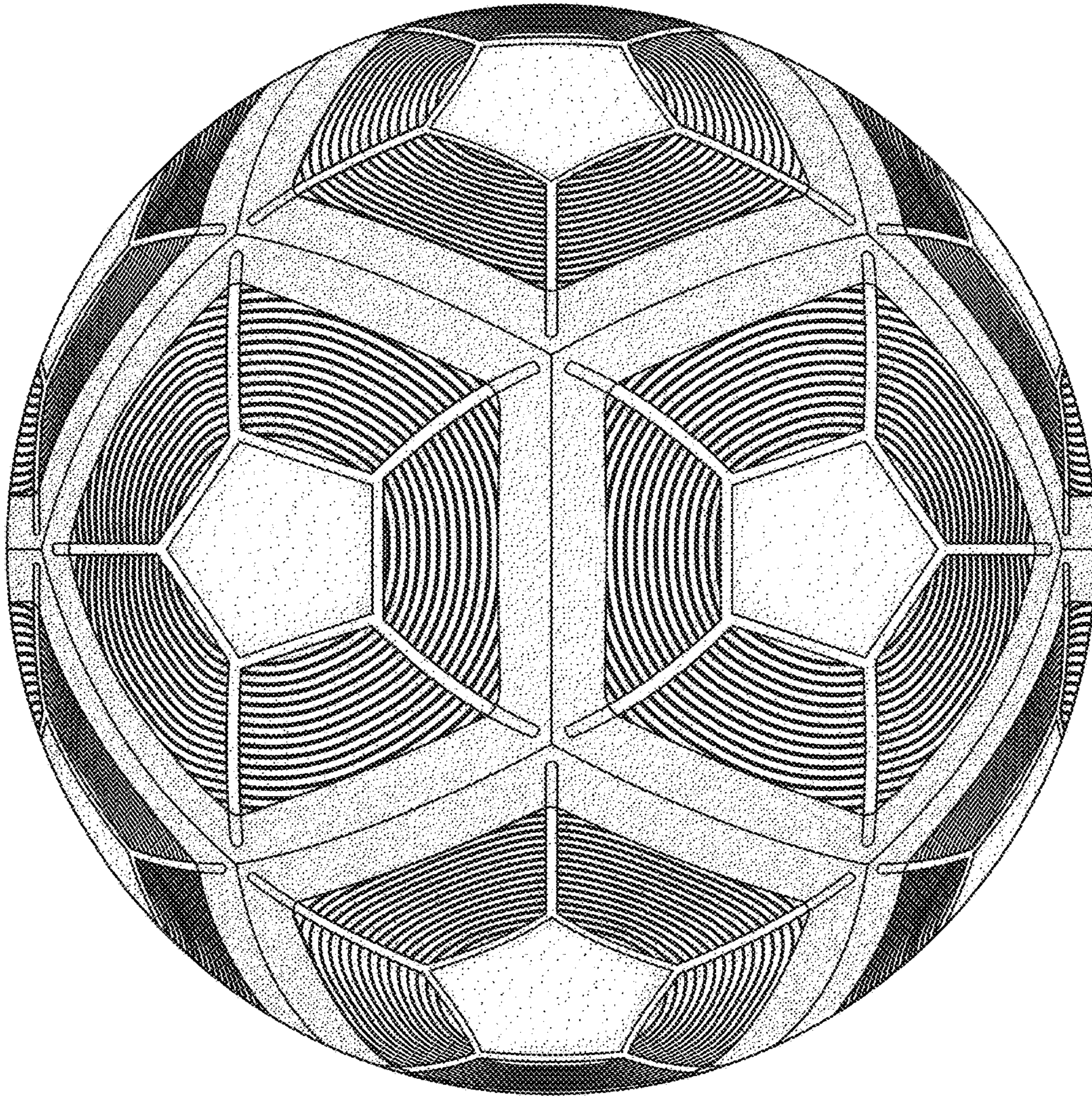

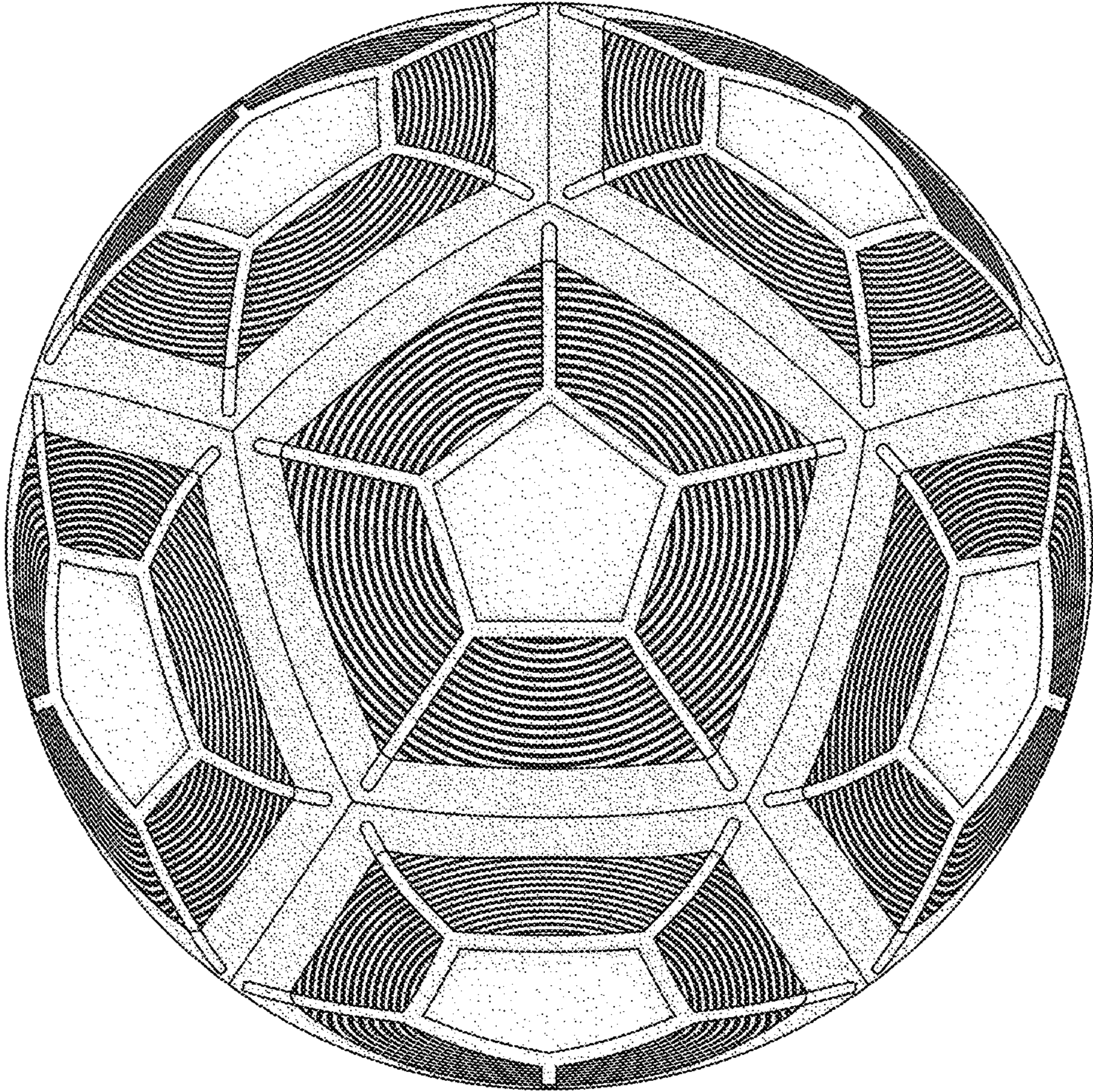
