(57) **CLAIM**

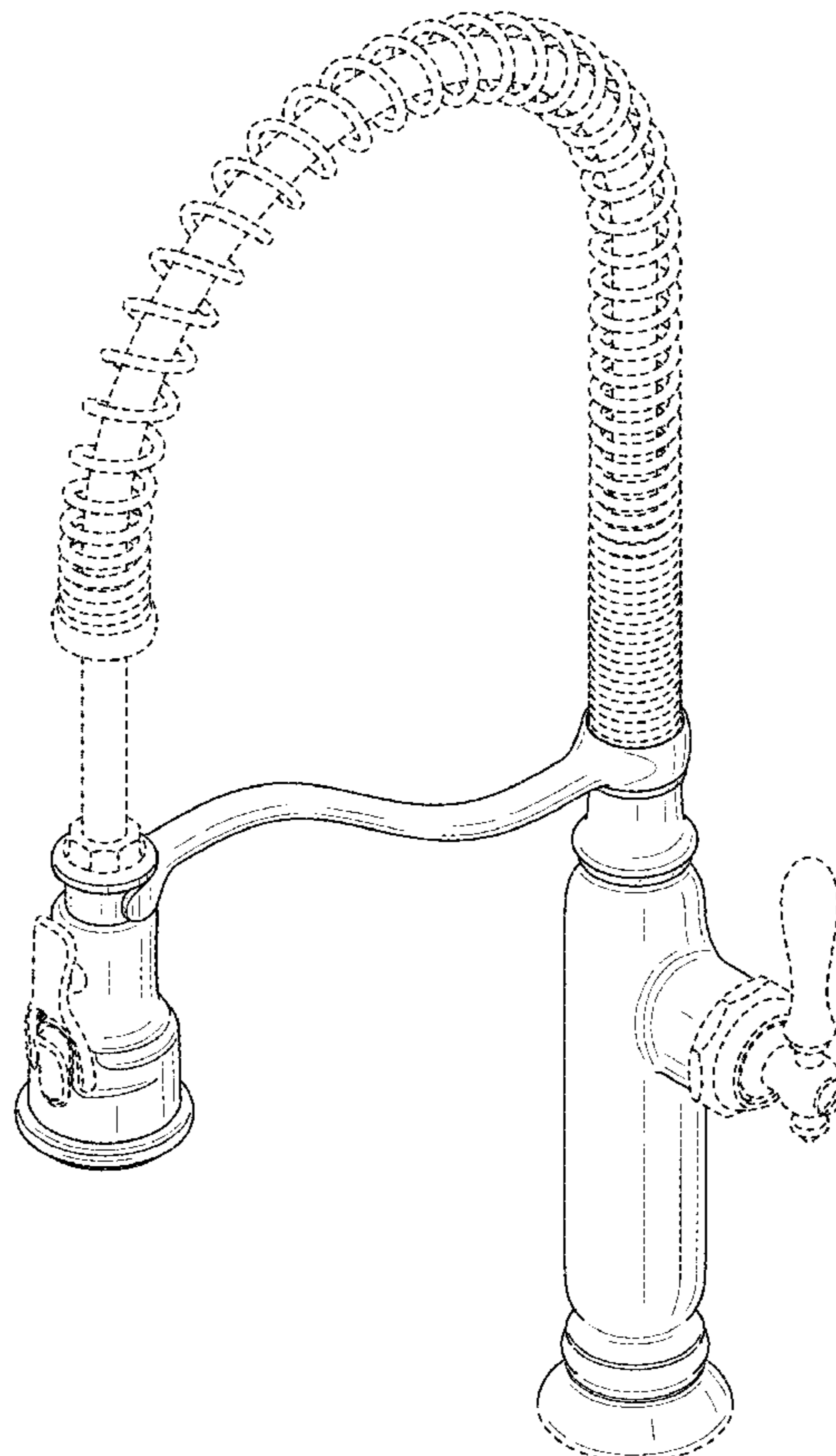
I claim the ornamental design for a faucet, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of another embodiment of the claimed design;

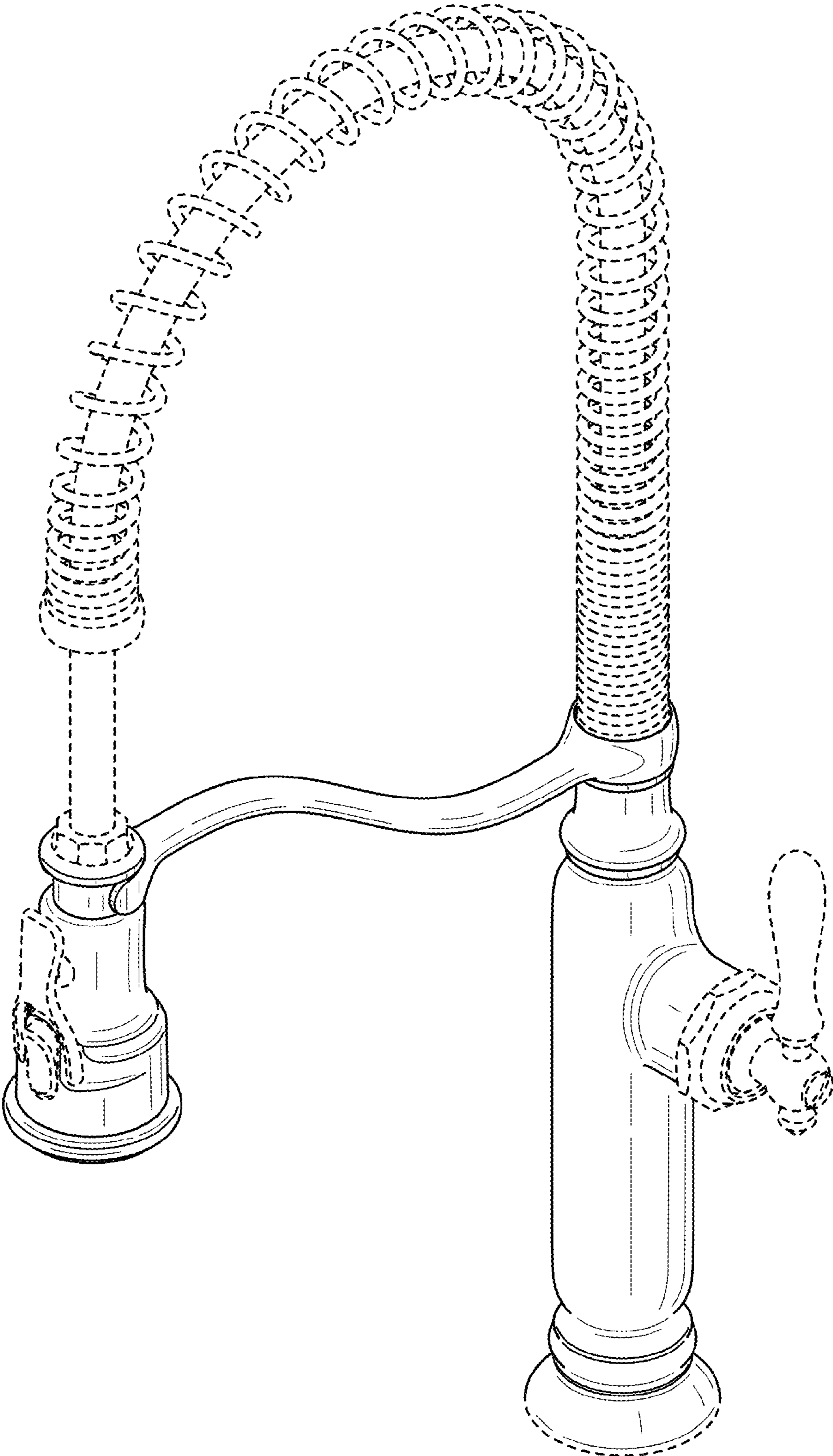

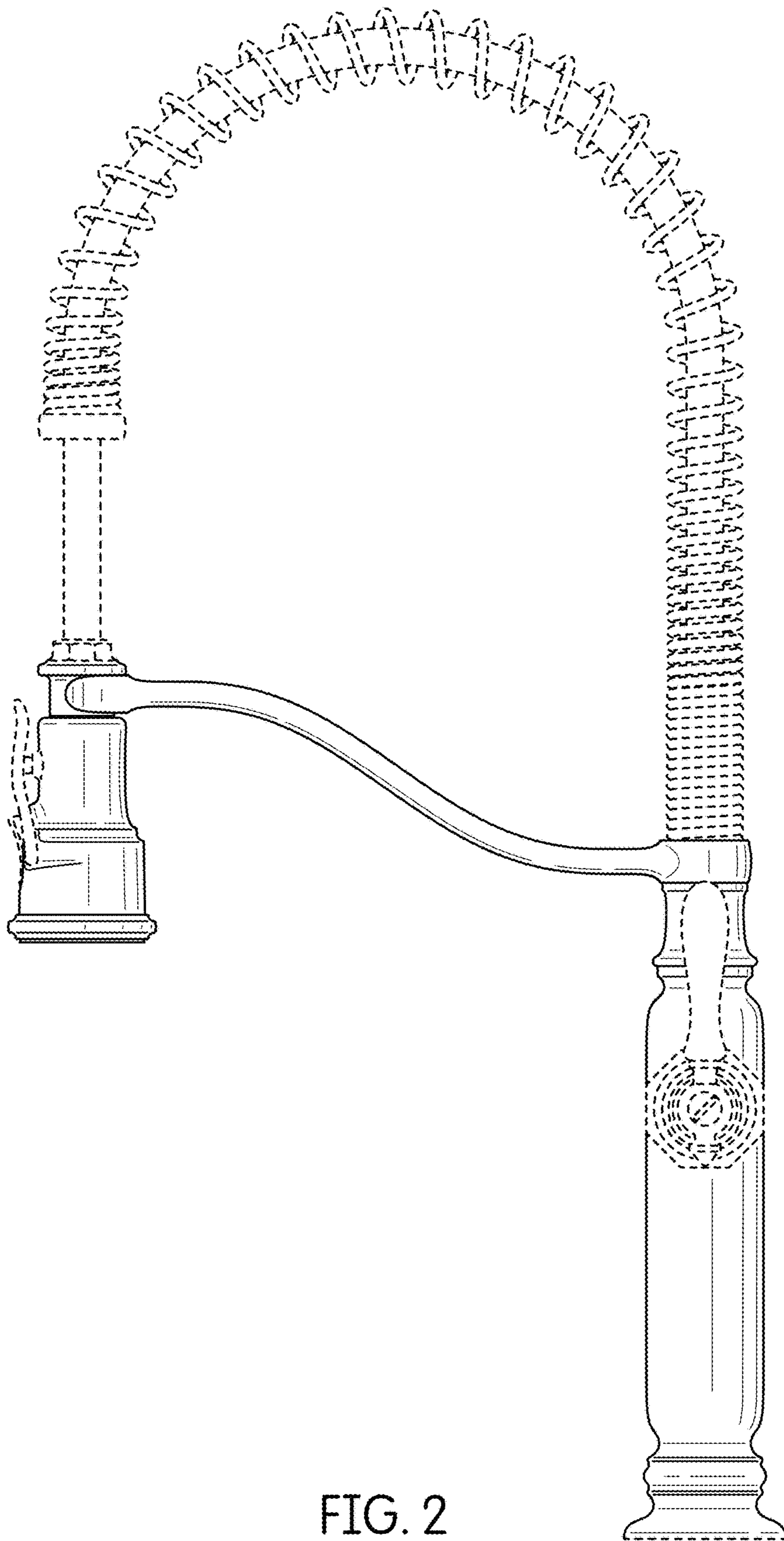

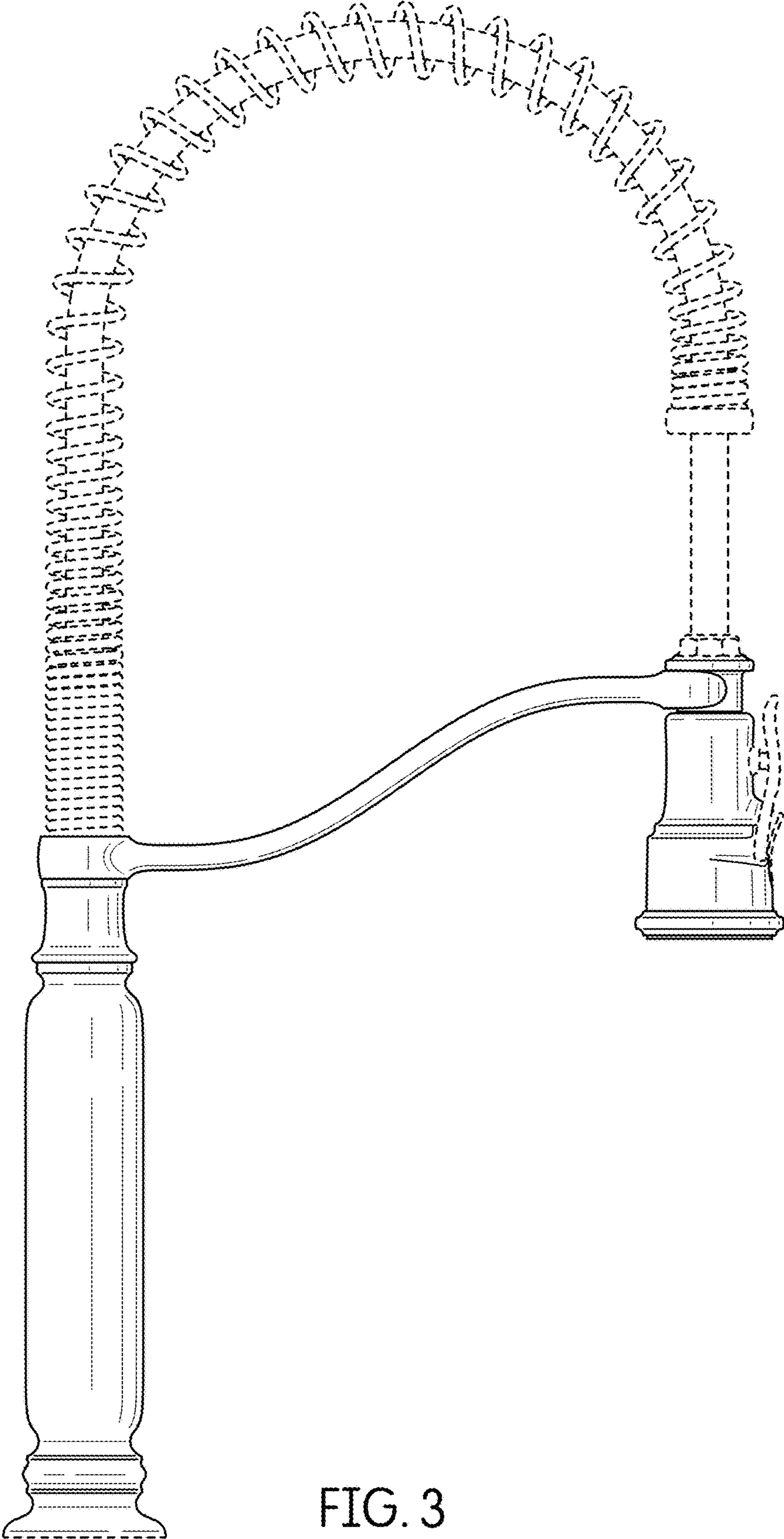

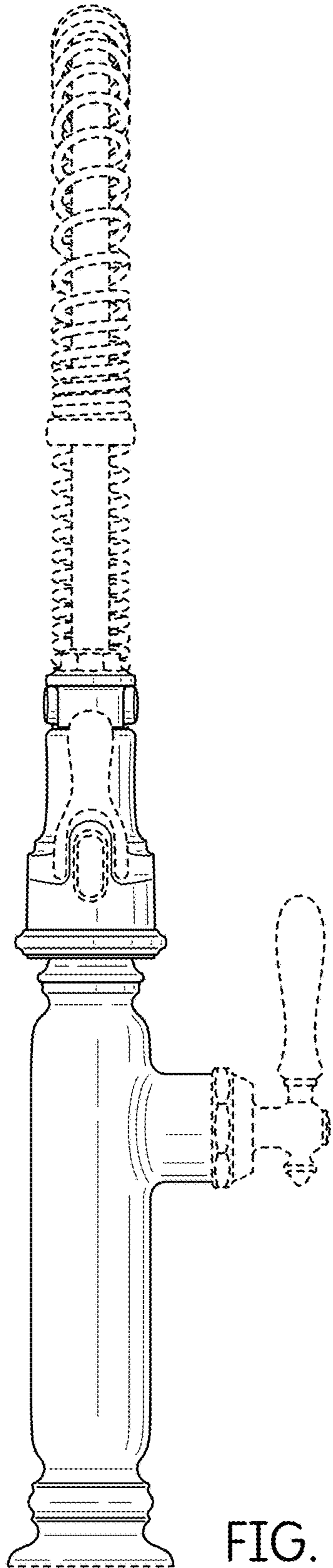

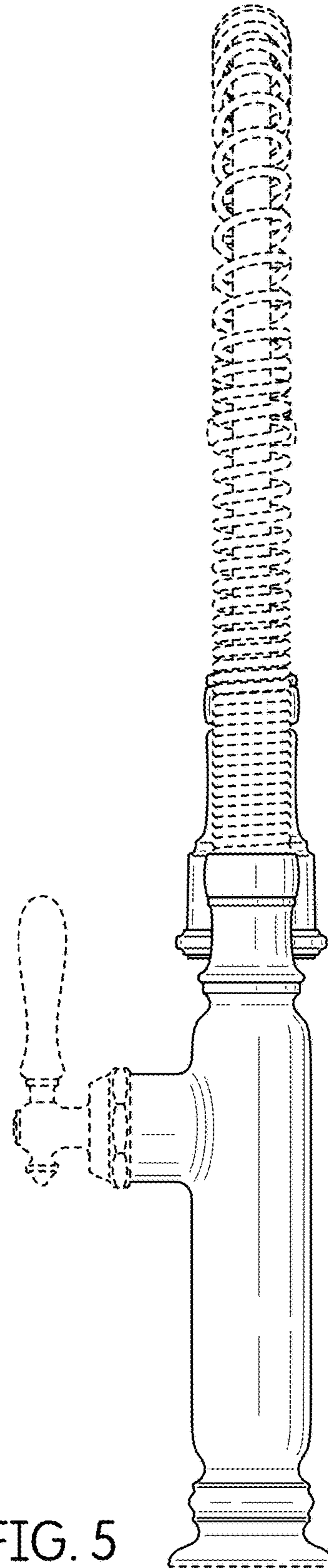

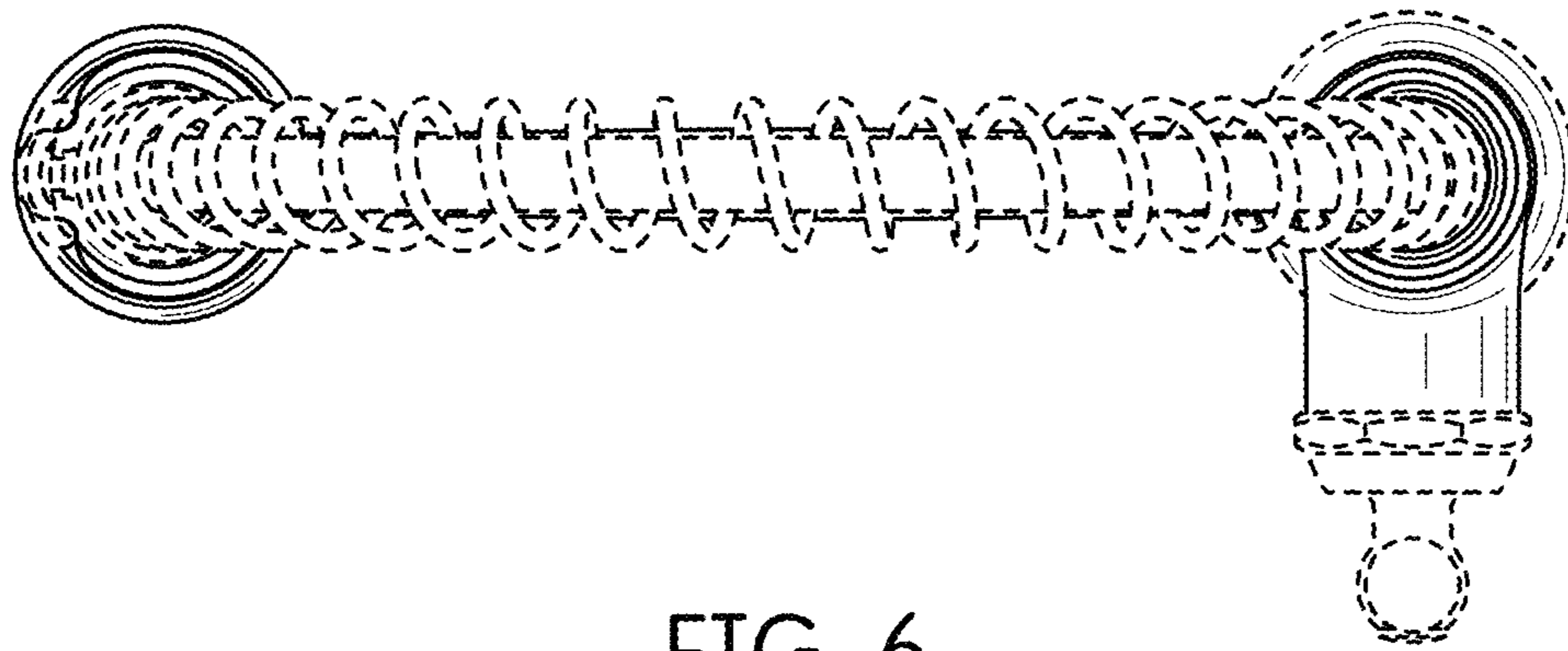

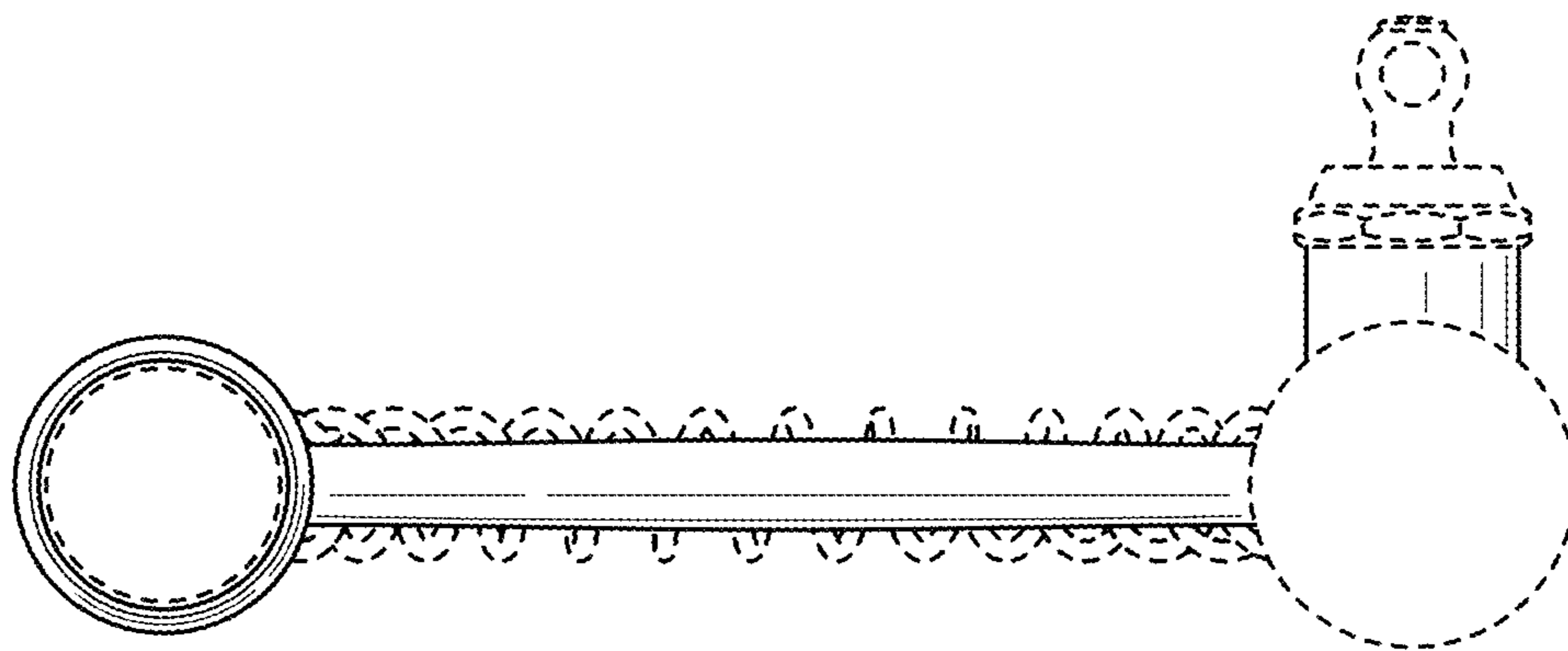
