(57) **CLAIM**
I claim the ornamental design for the flatpack gutter pack, as shown and described.

DESCRIPTION
FIG. 1 is a rear view of the flatpack gutter pack;
FIG. 2 is a top view of the flatpack gutter pack;
FIG. 3 is a bottom view of the flatpack gutter pack;
FIG. 4 is a front view of the flatpack gutter pack;
FIG. 5 is a right side view of the flatpack gutter pack;
FIG. 6 is a left side view of the flatpack gutter pack; and,
FIG. 7 is a perspective view of the assembled flatpack gutter pack showing my new design.
The broken lines in the drawings represent creases in the flatpack gutter pack that form no part of the claim.

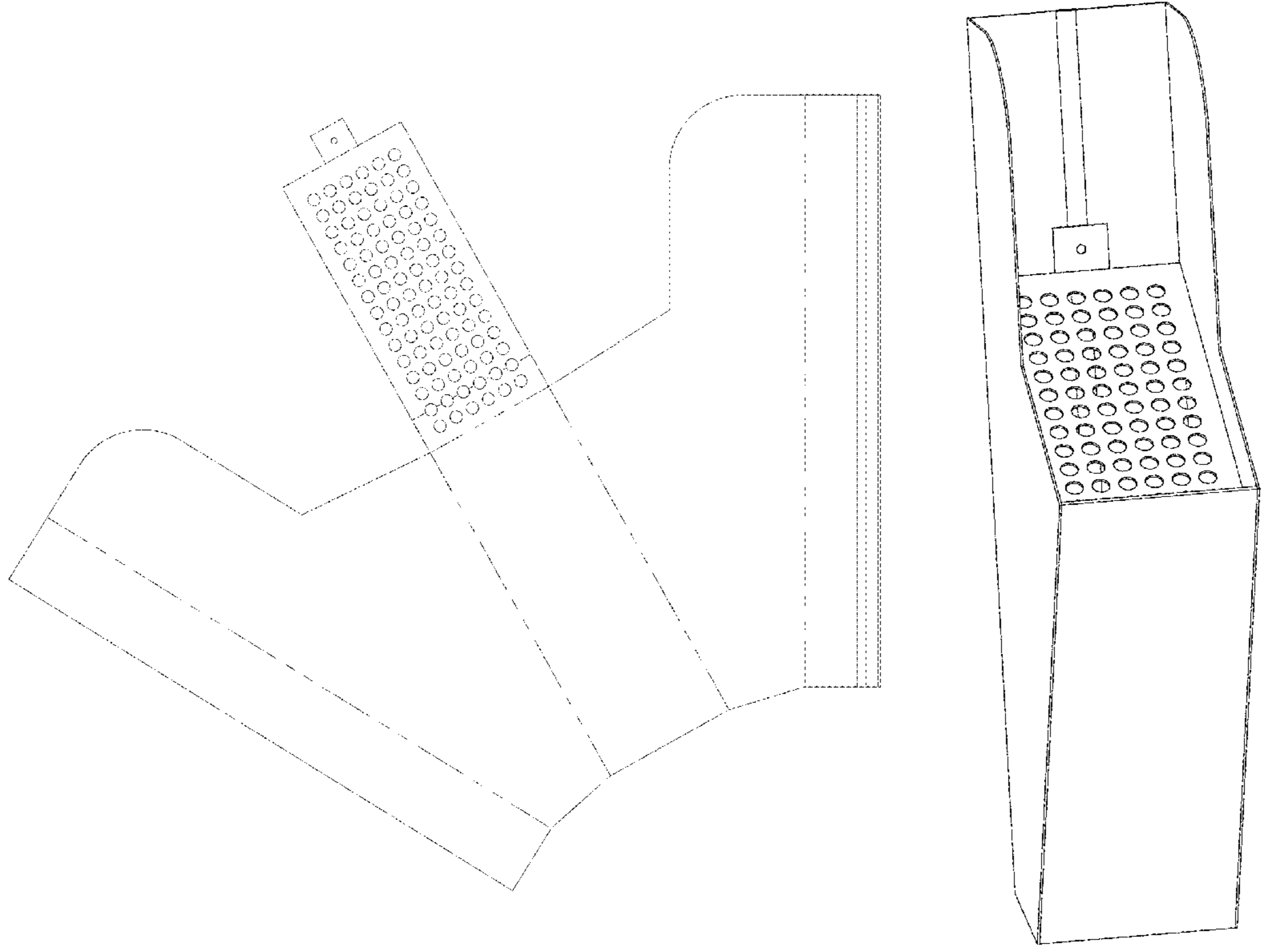

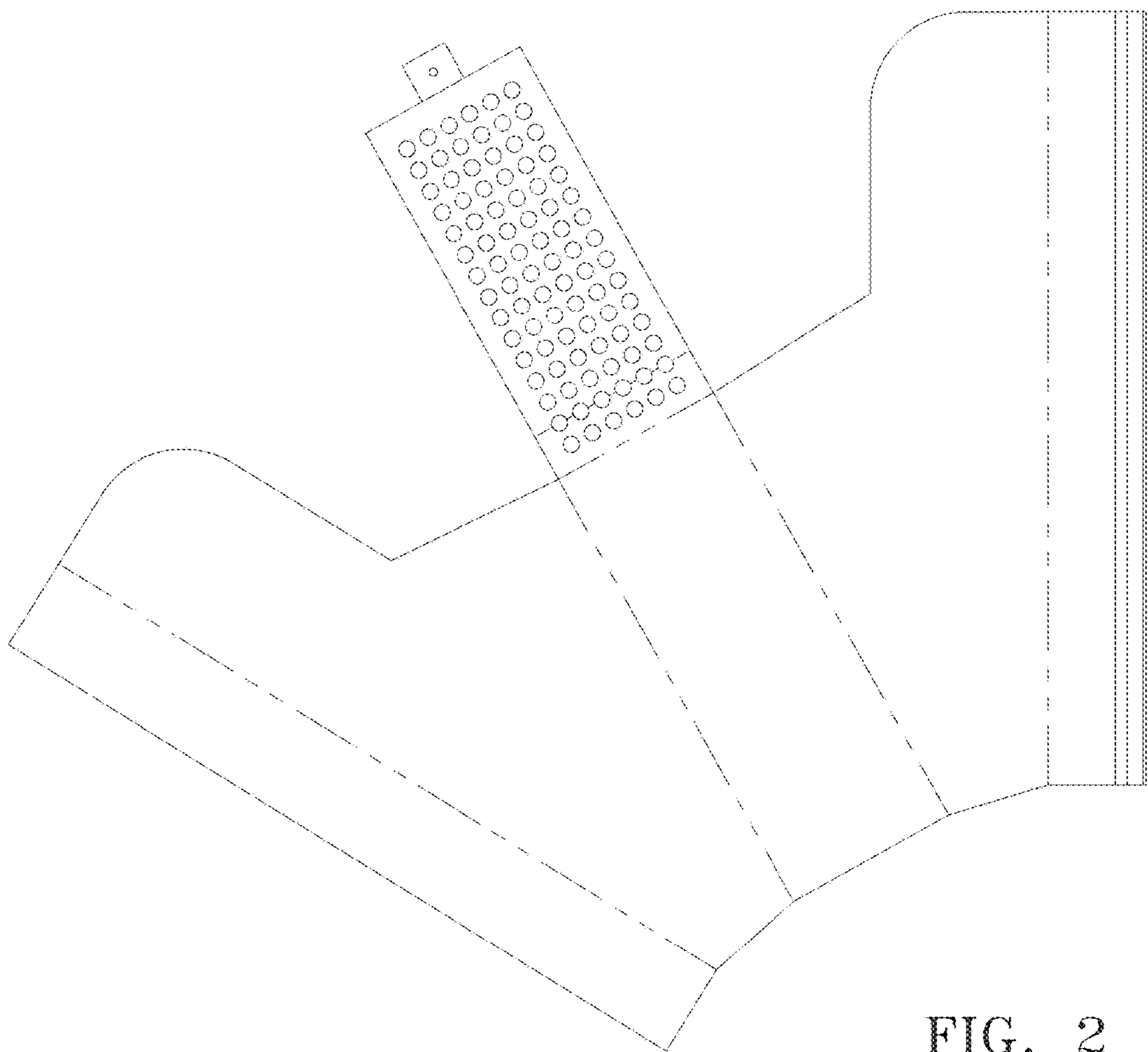

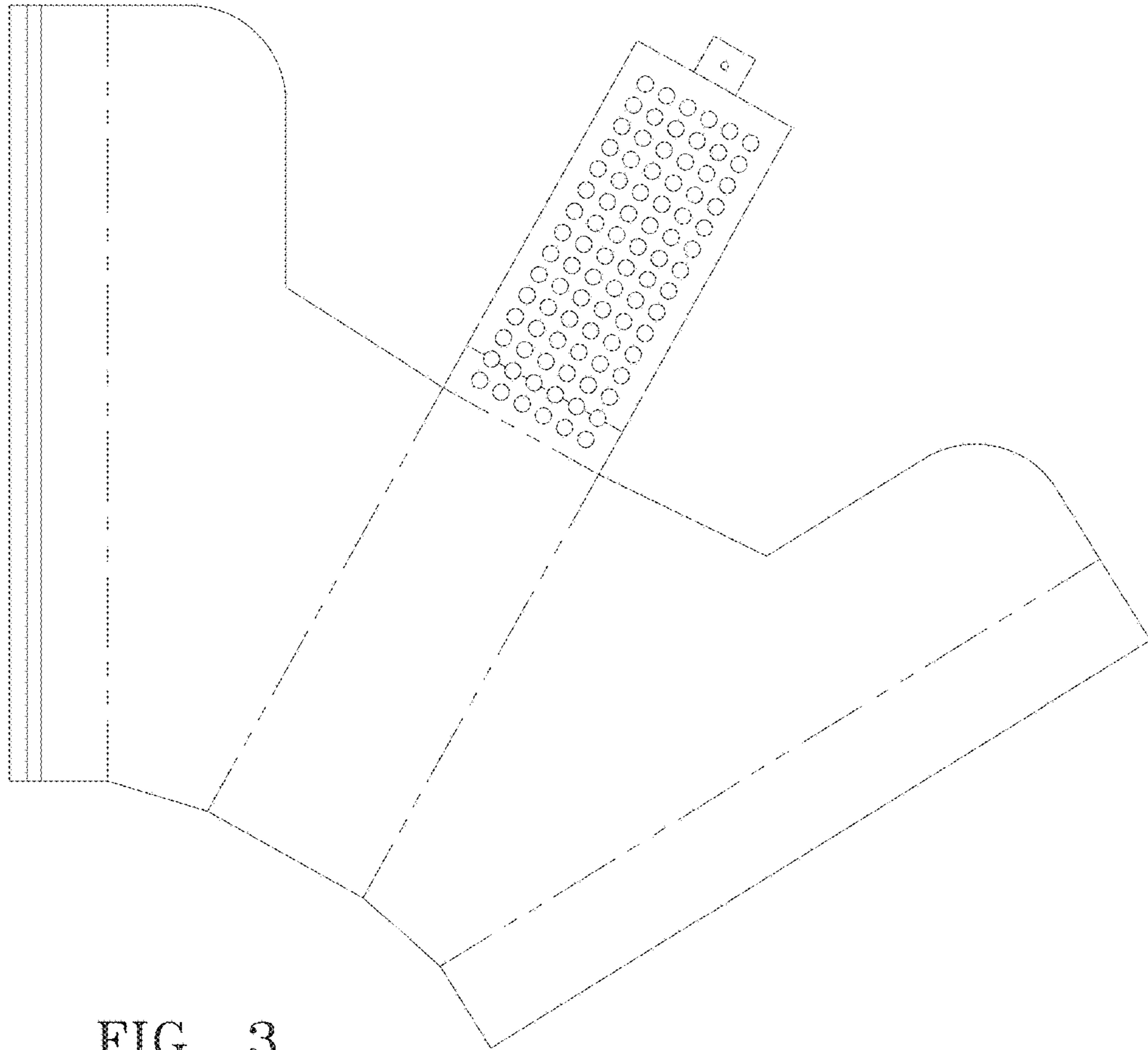

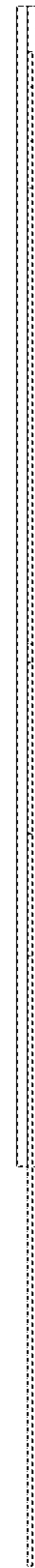

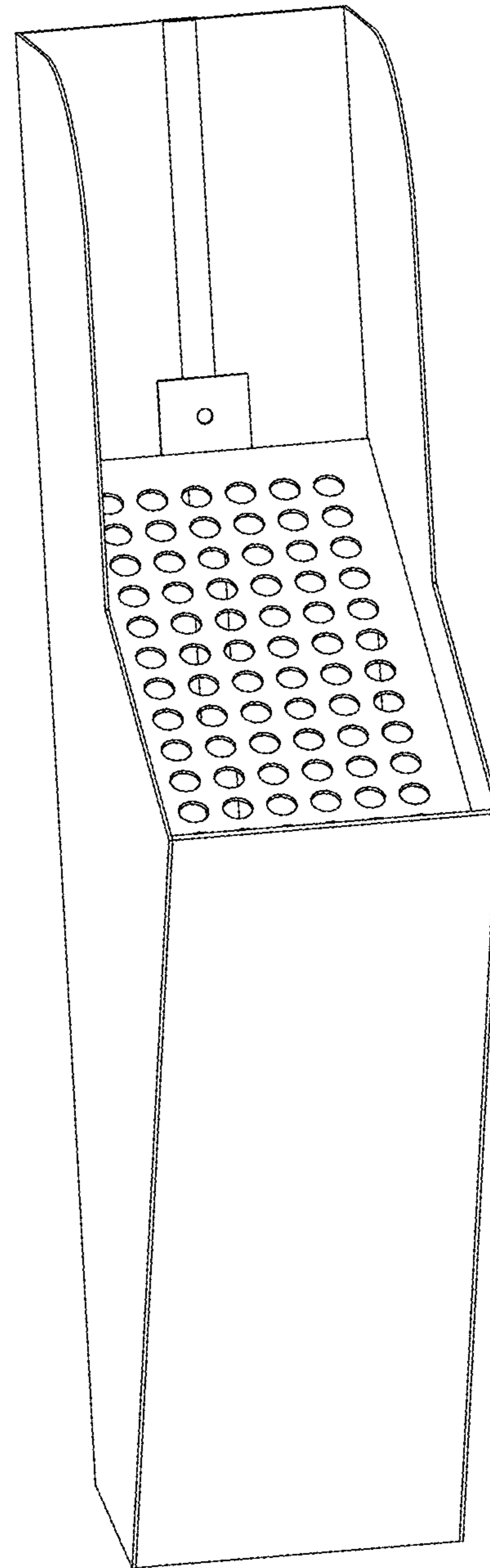
