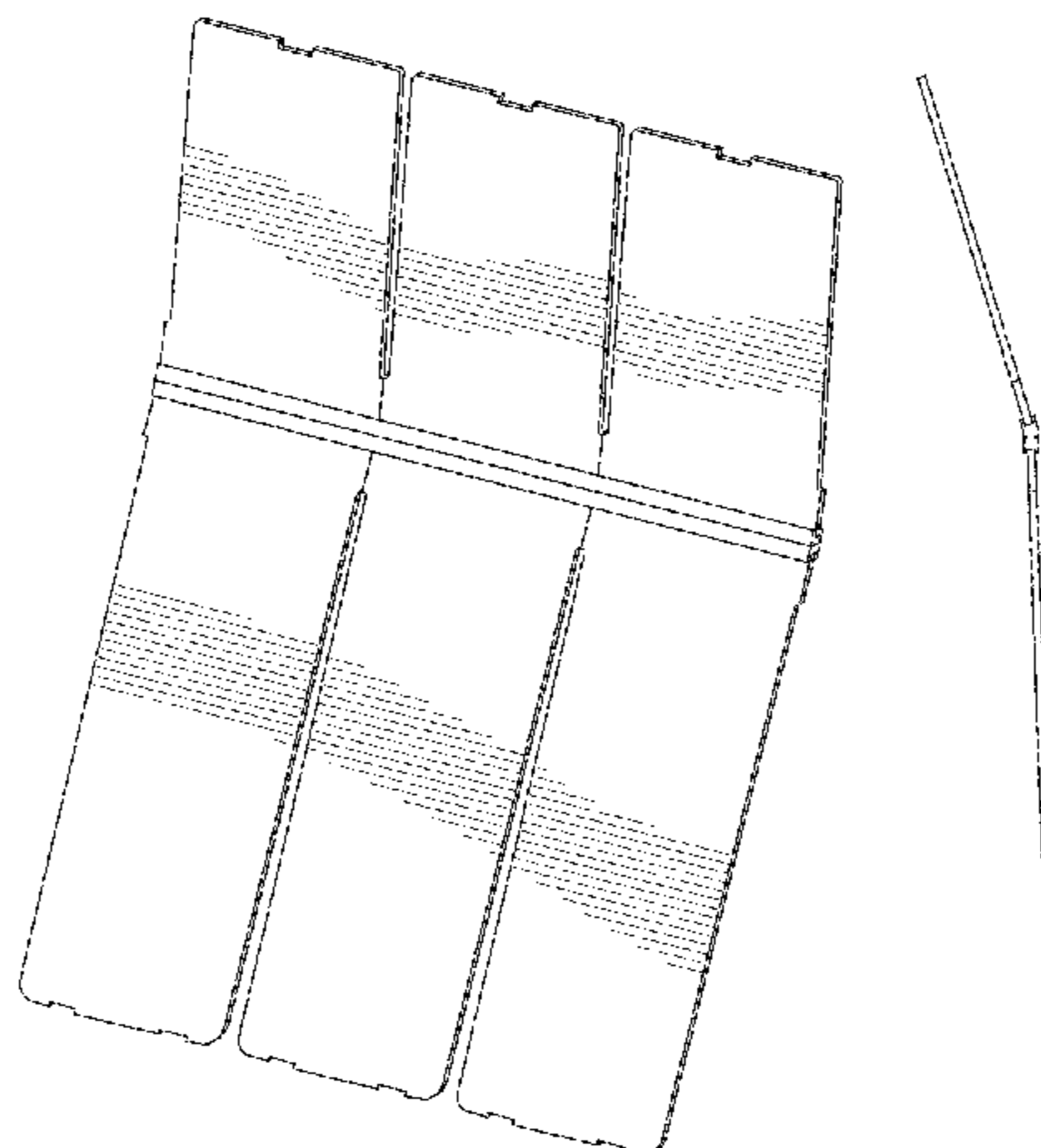

## DESCRIPTION

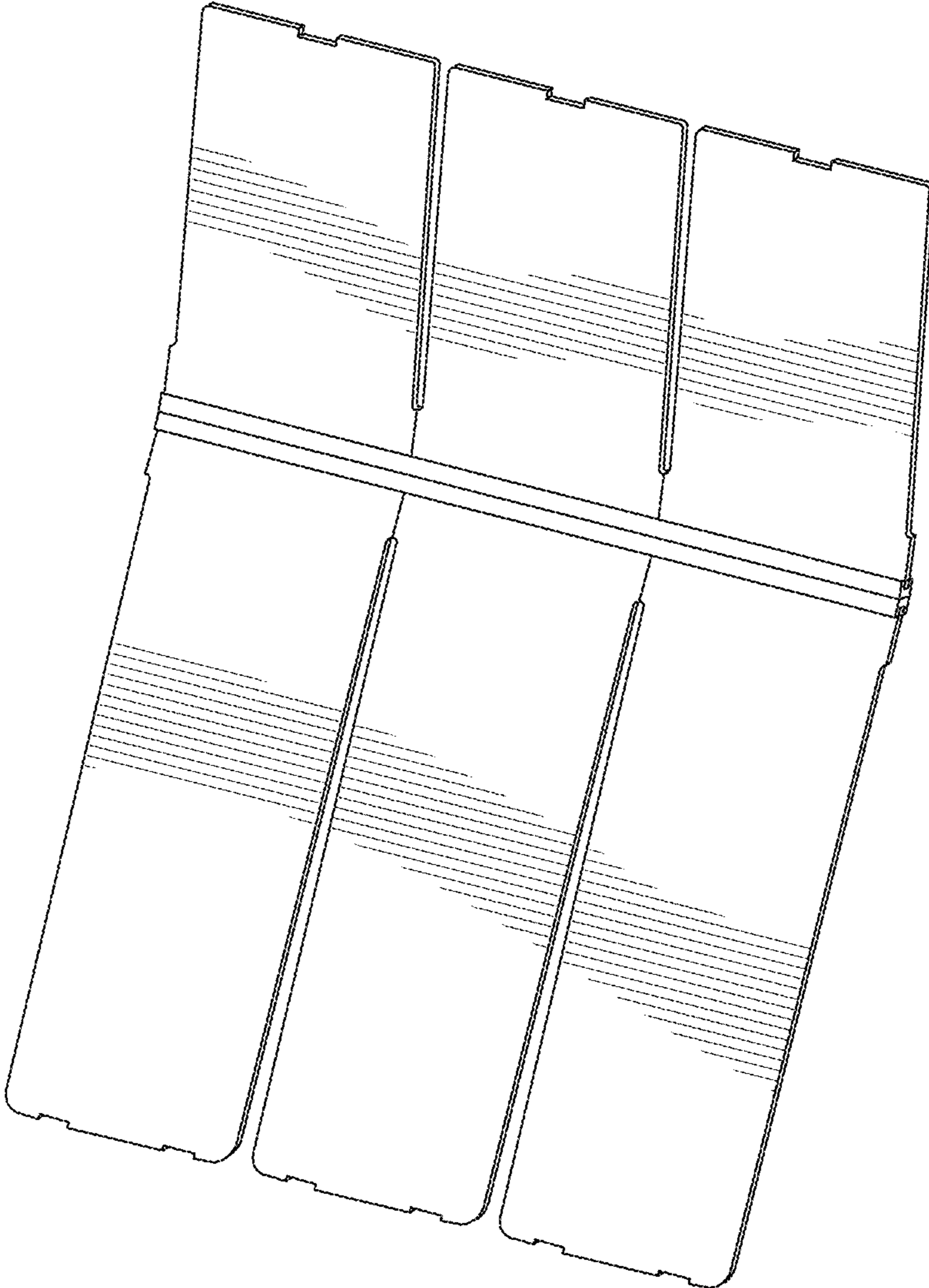

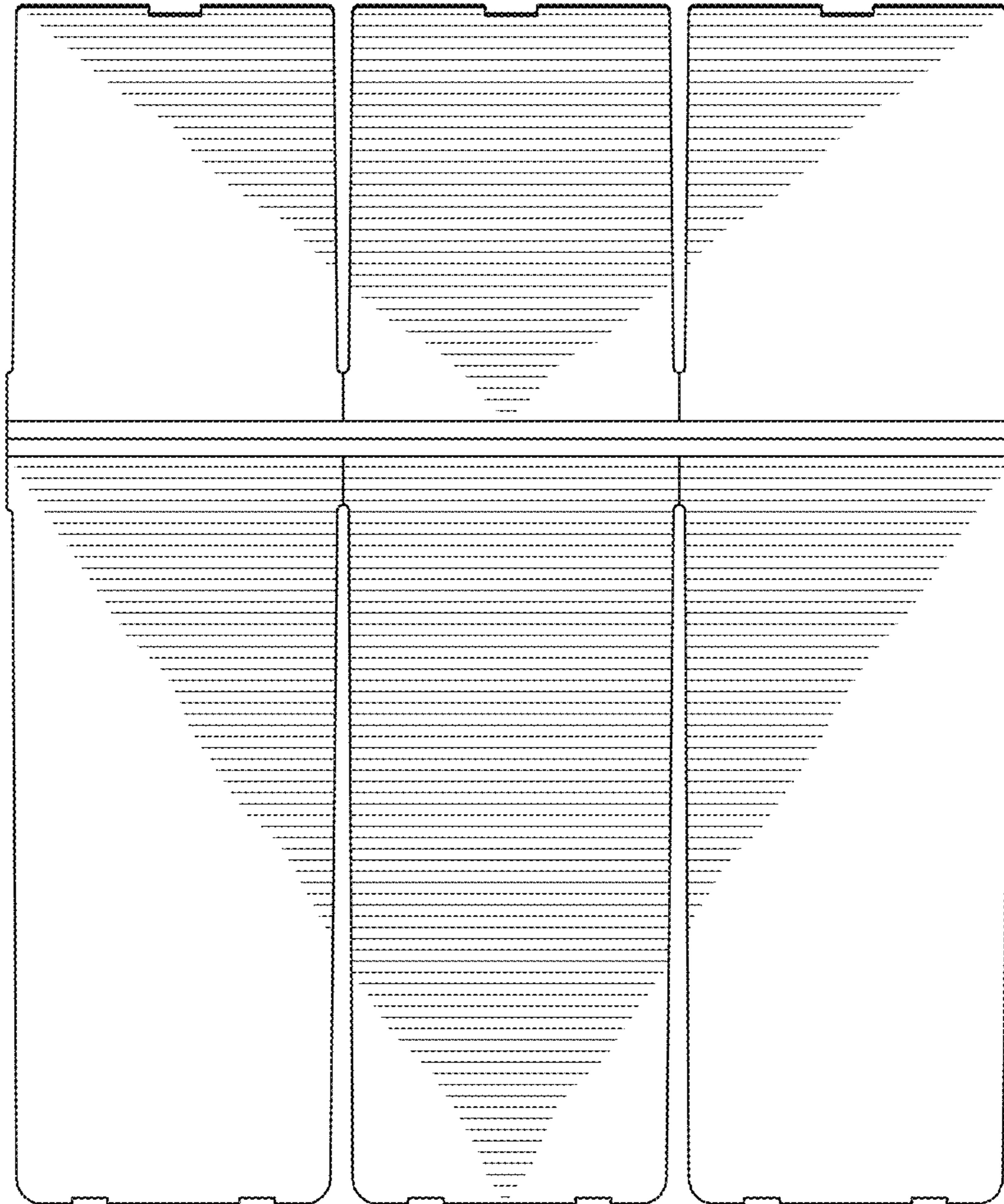
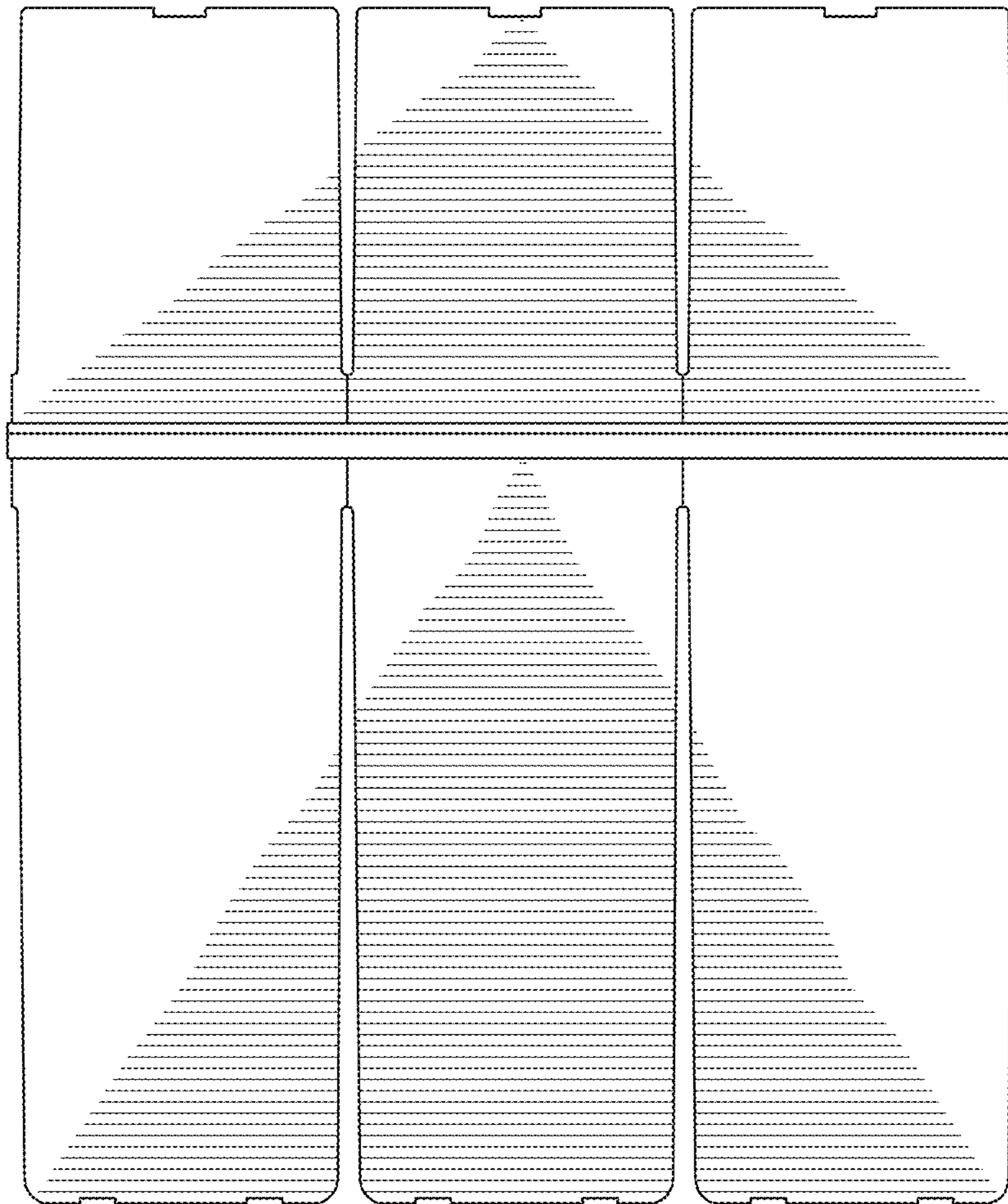

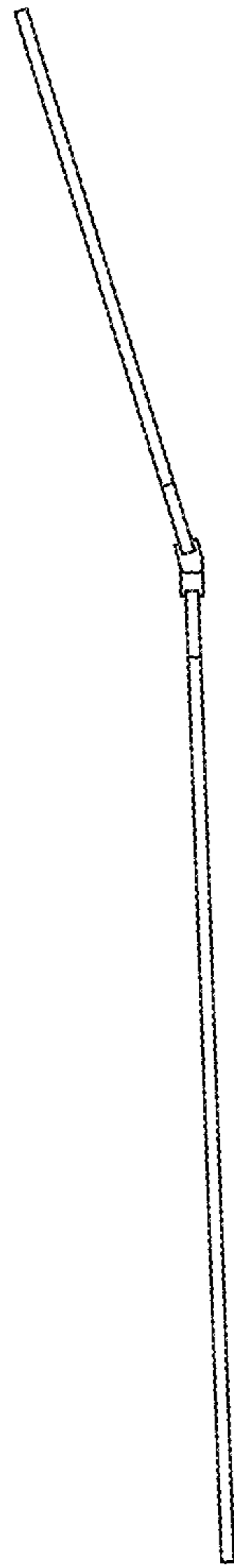

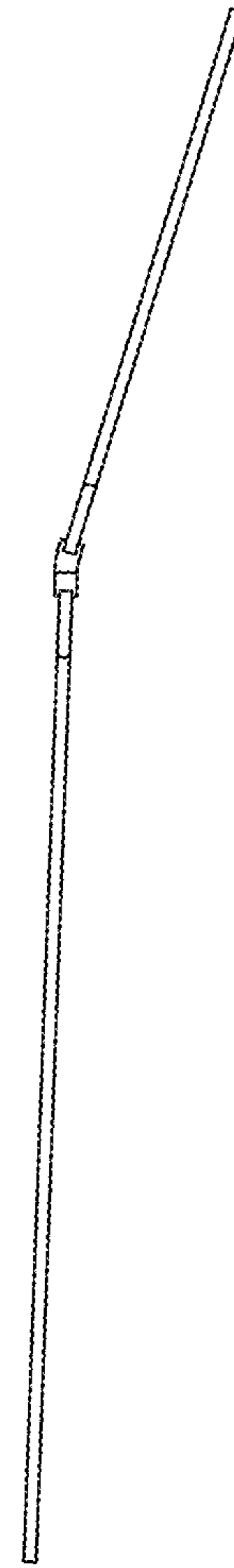

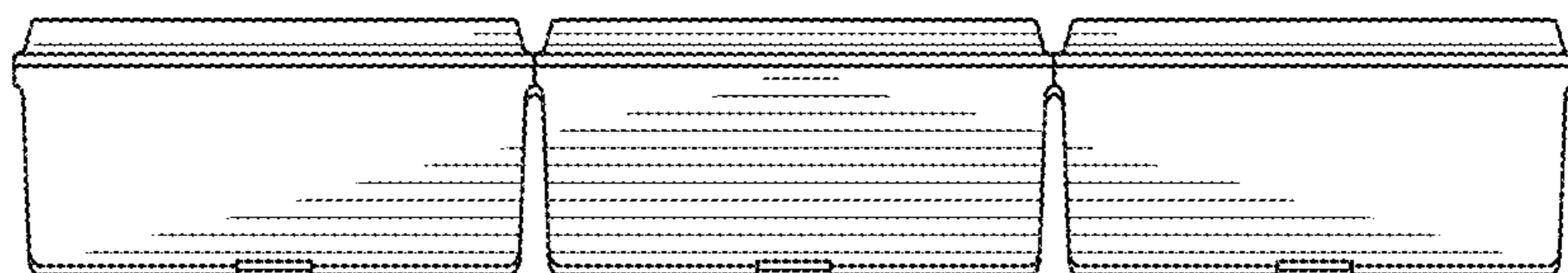

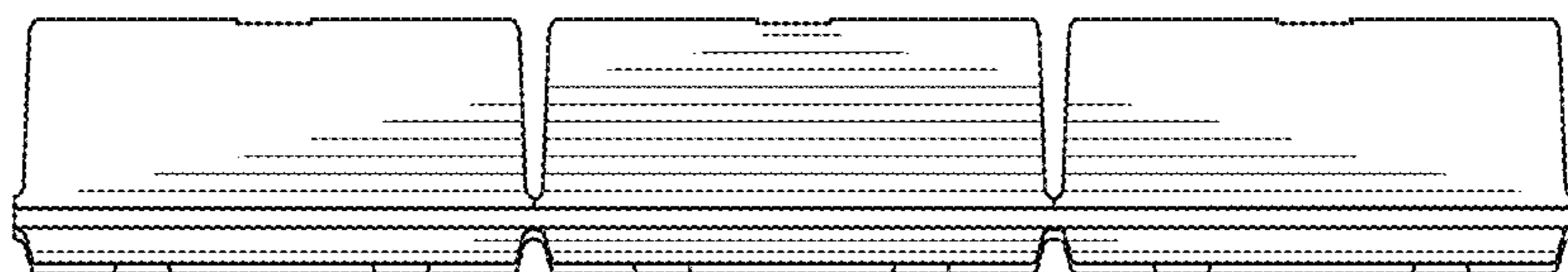

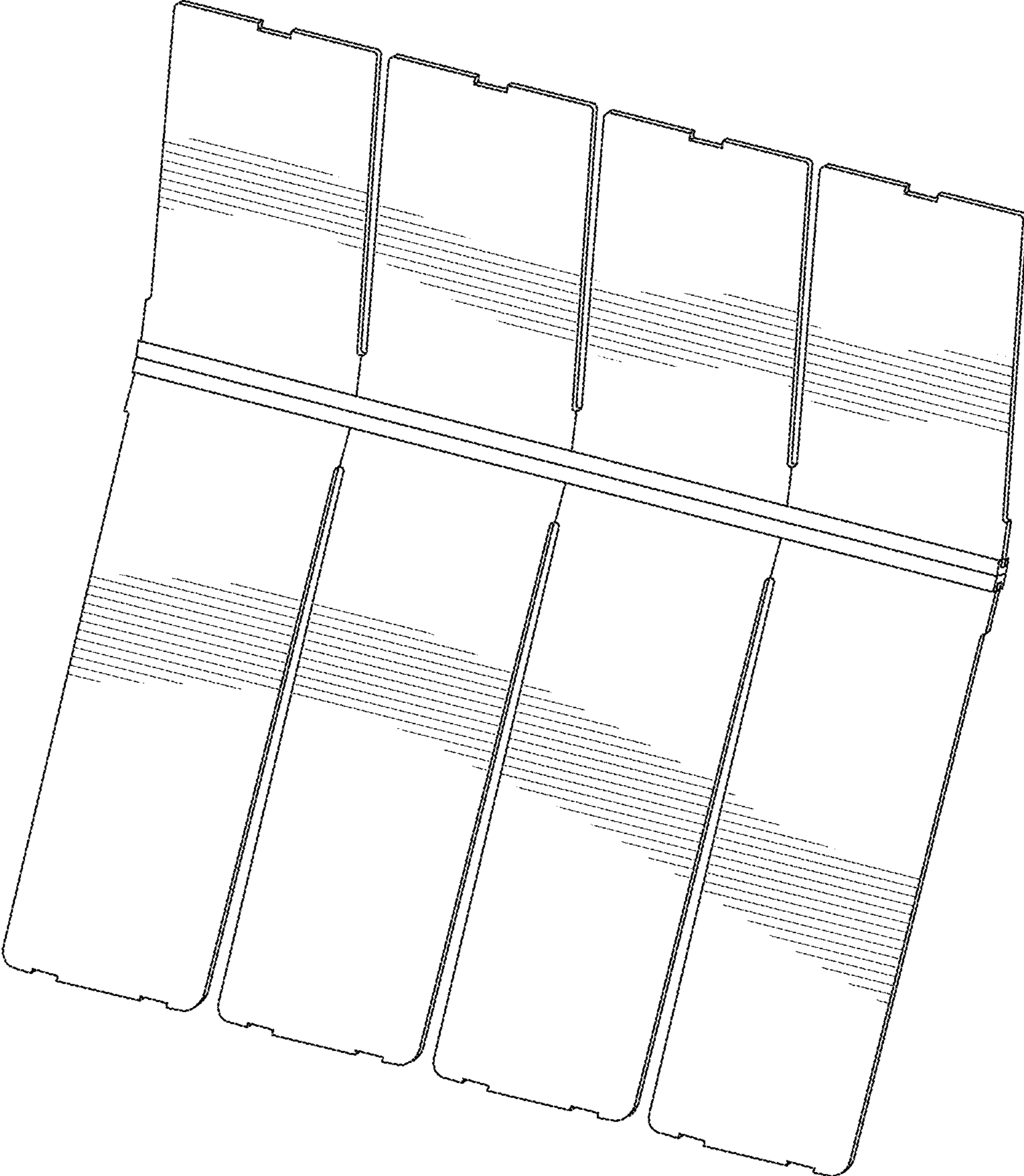

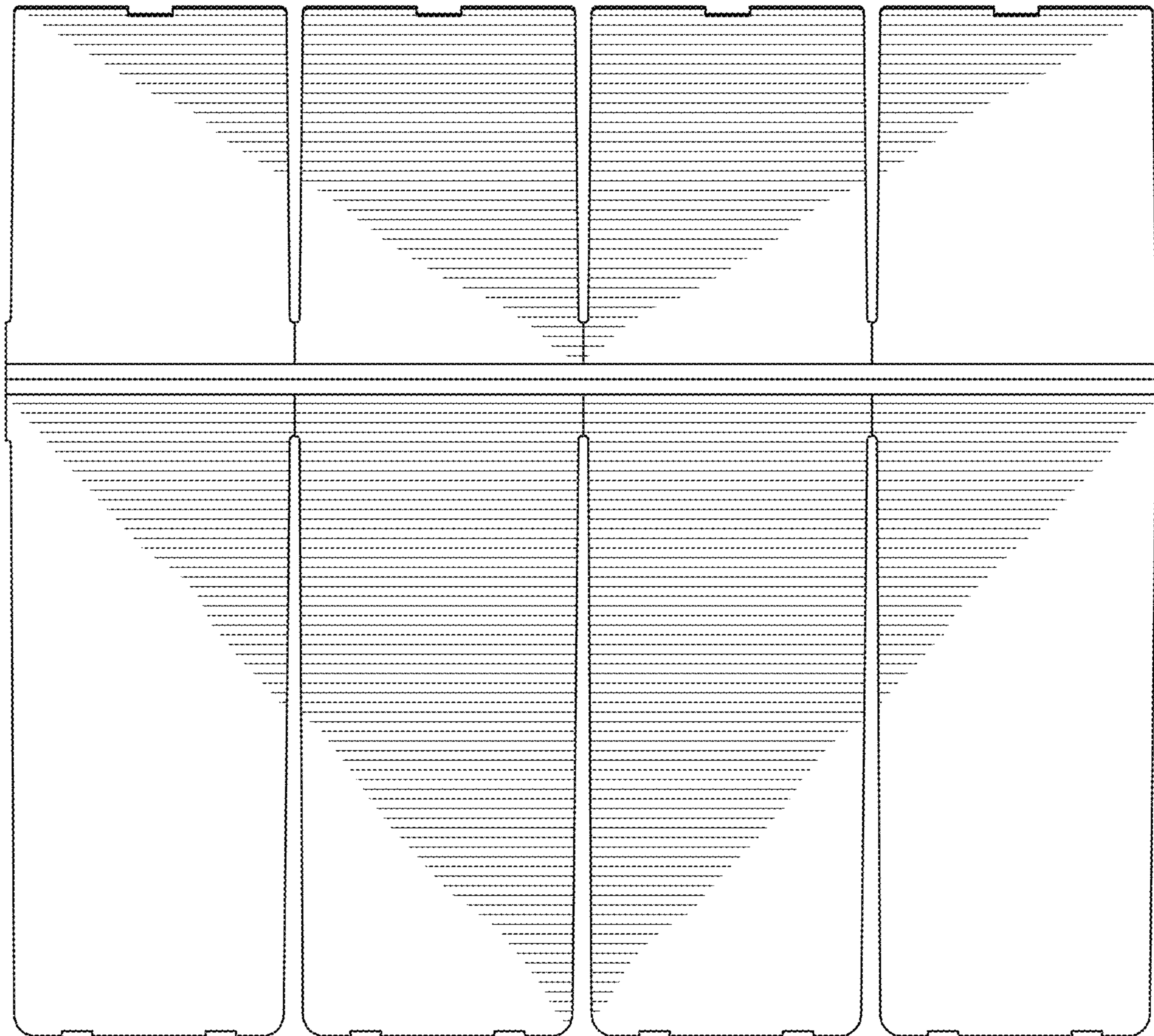
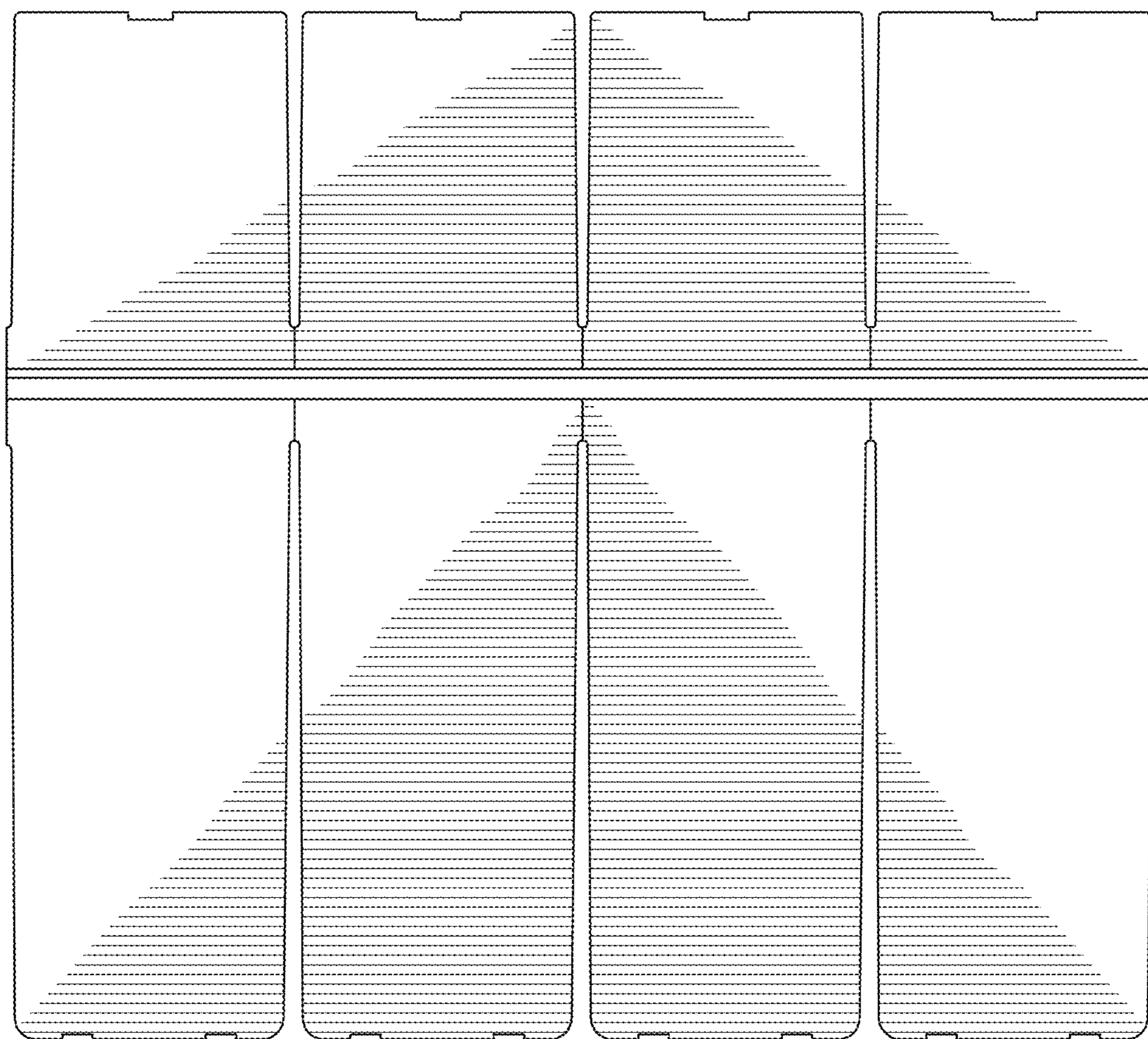

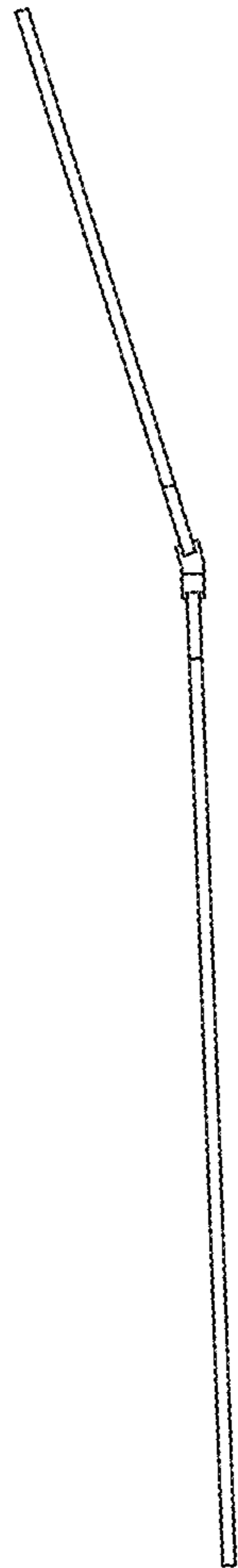

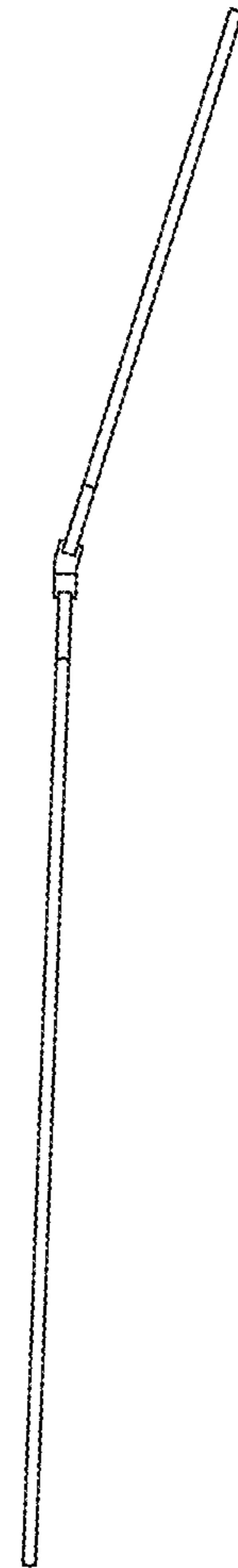

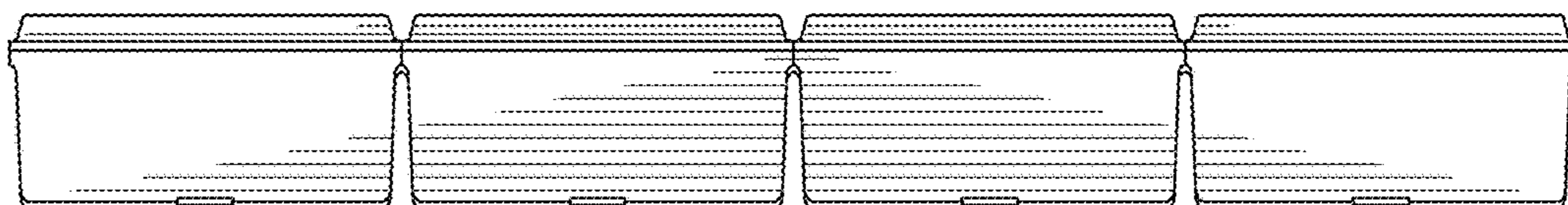

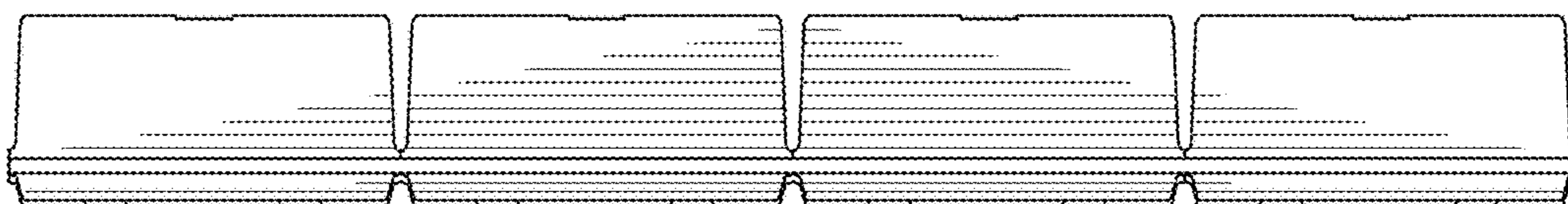

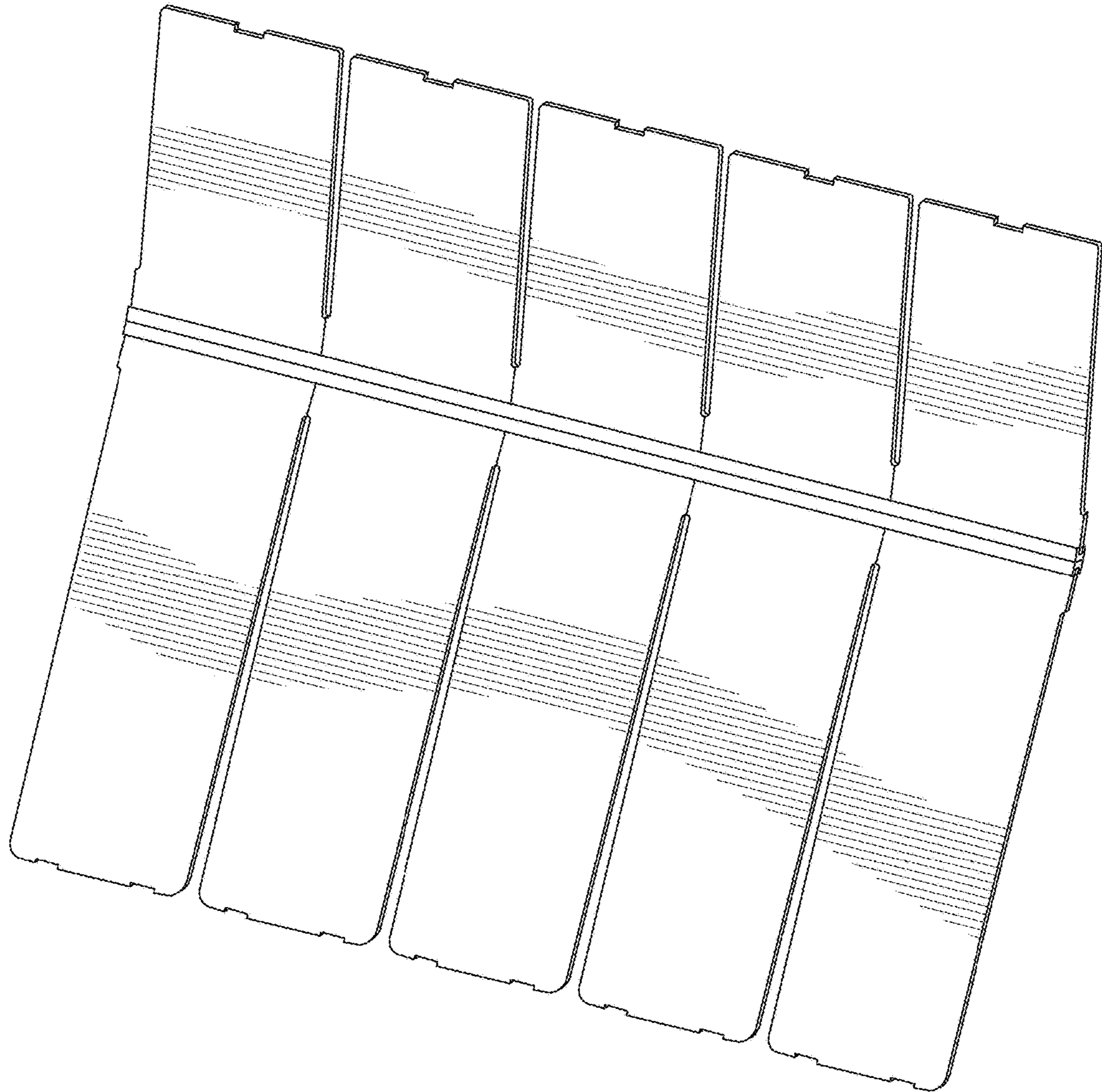

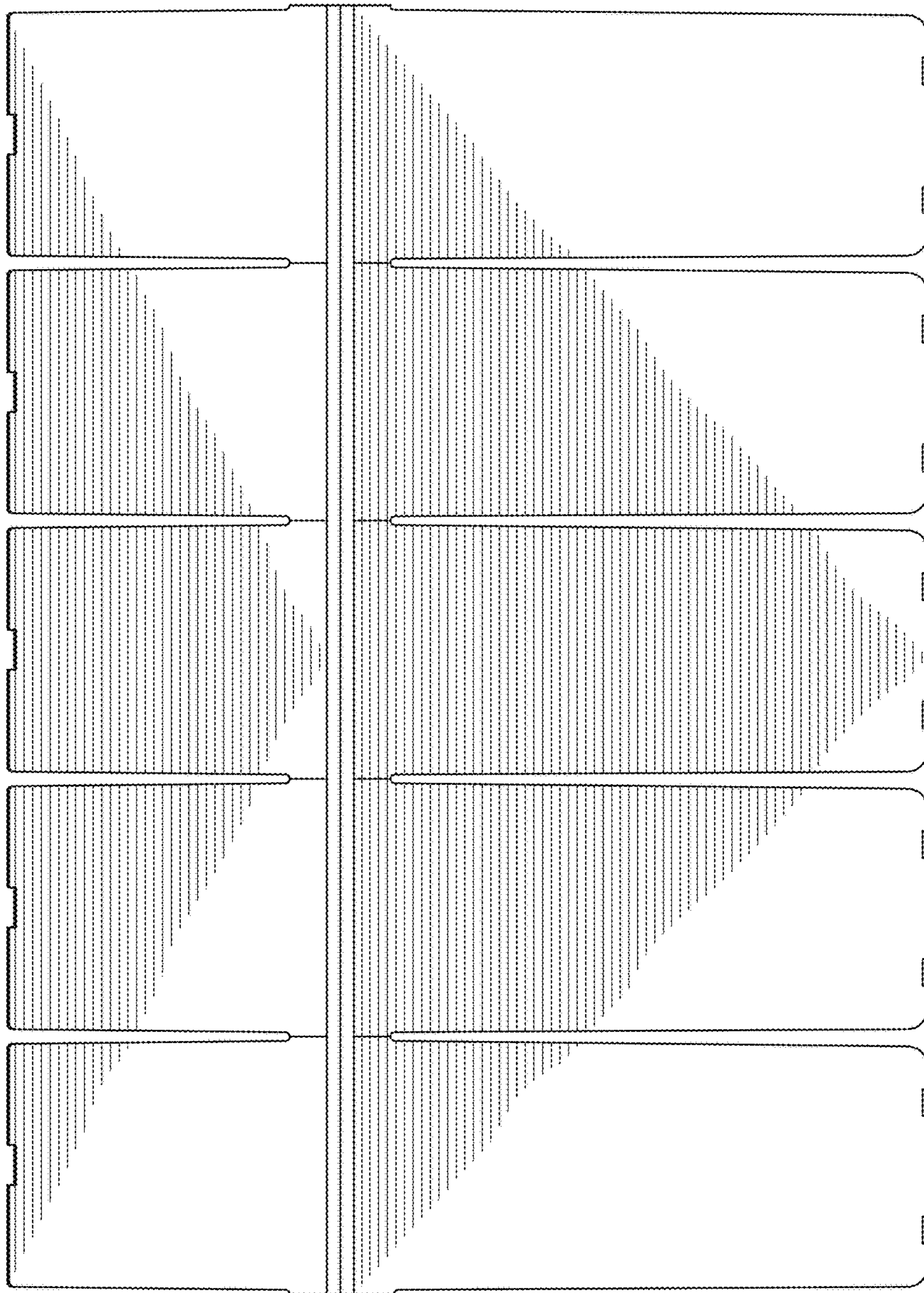

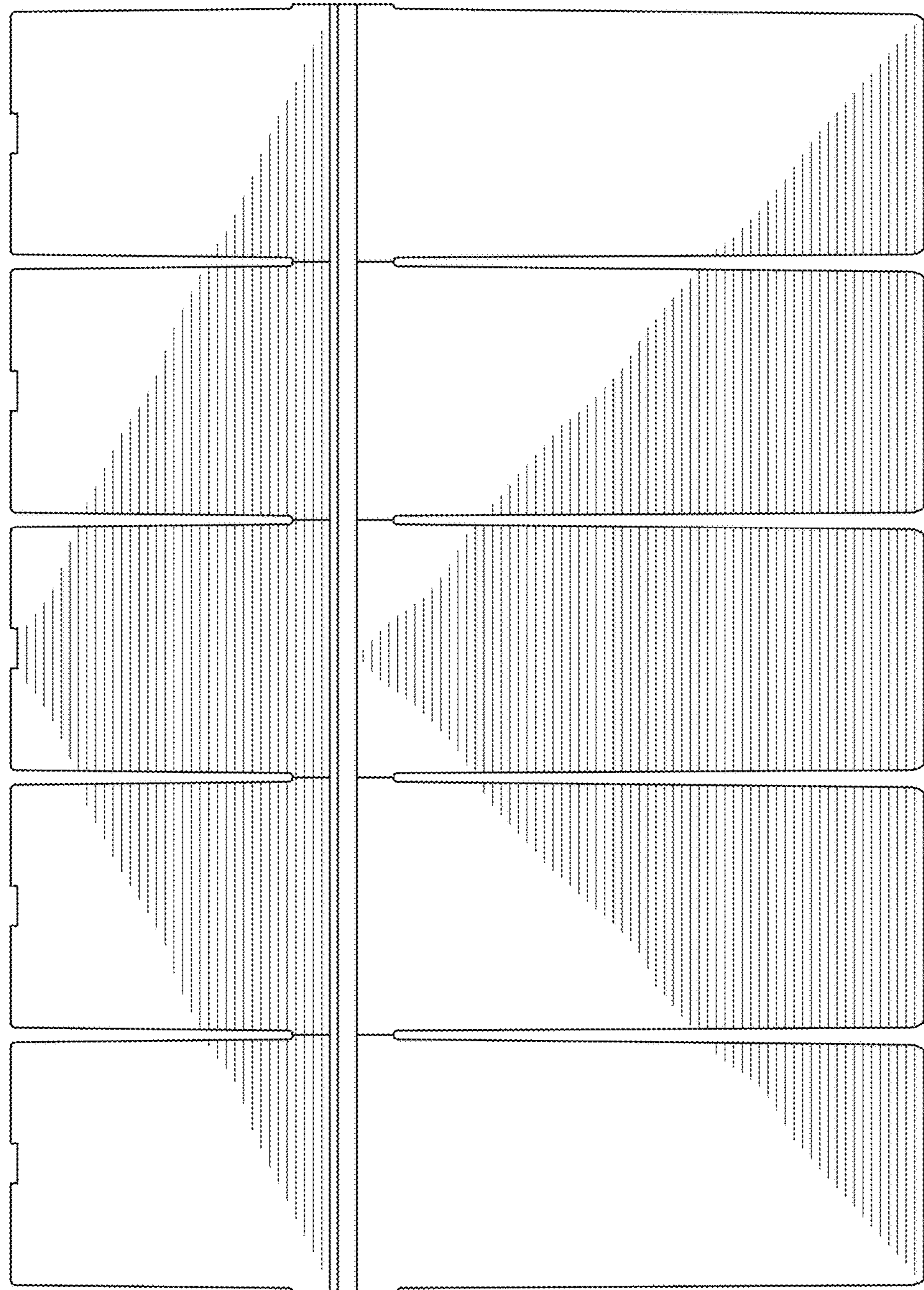

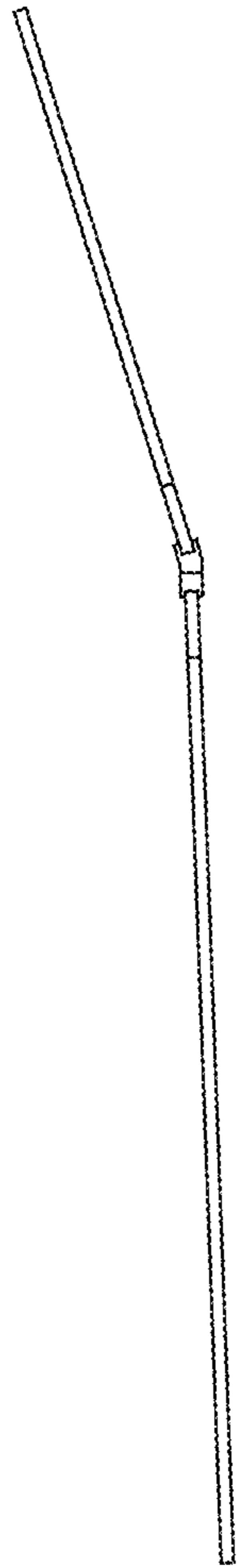

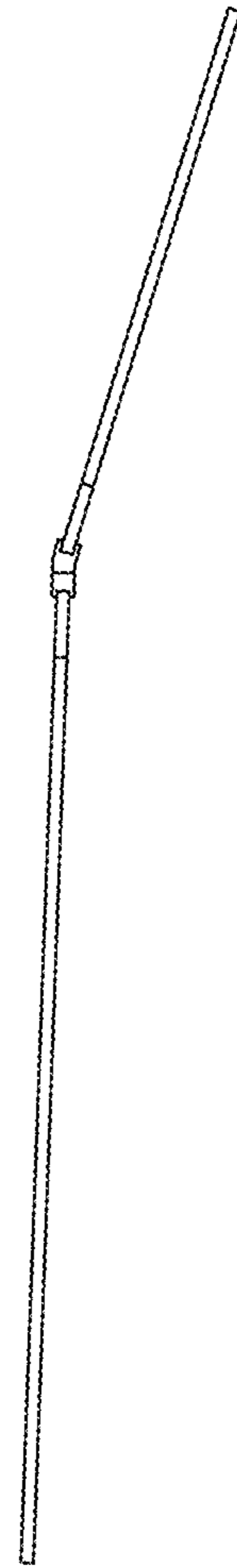
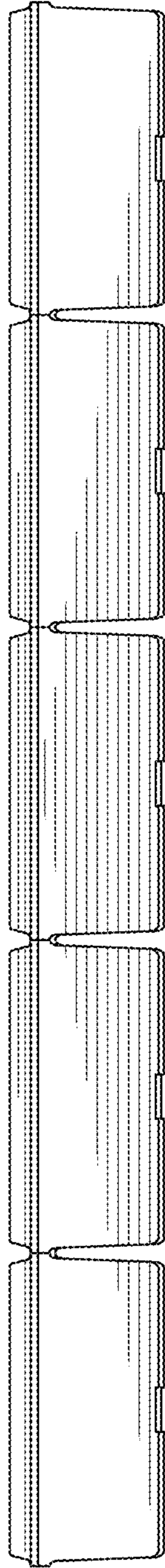
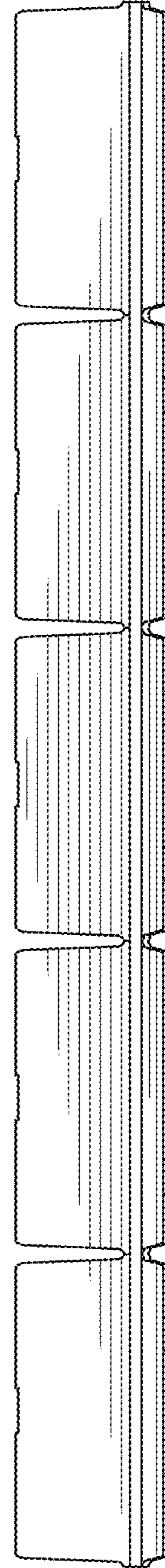
