1.2 is a top view;

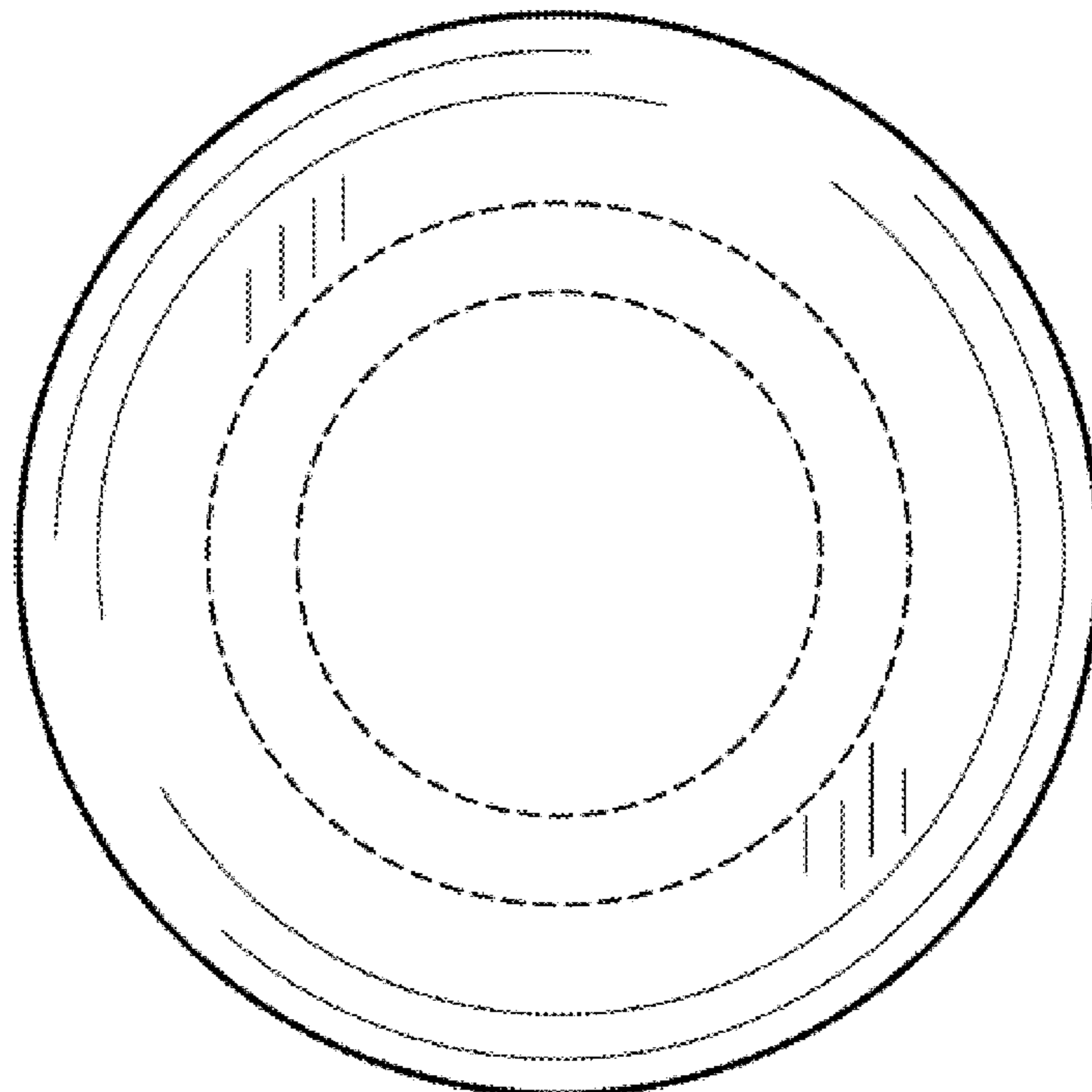
1.3 is a front-right perspective view;

1.4 is a right side view; and

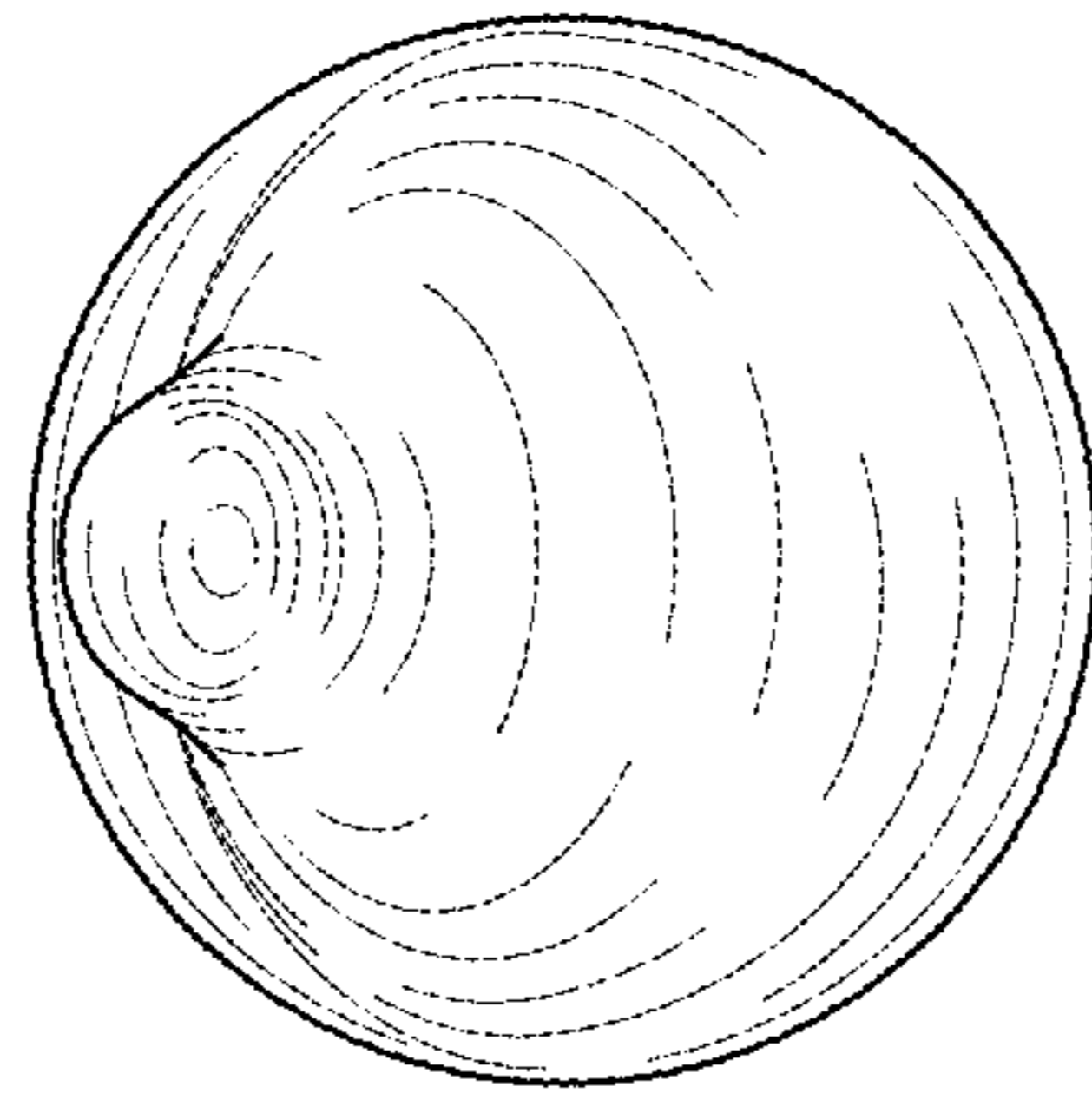
1.5 is a front view.

The portion of the applicator shown in broken lines forms no part of the claimed design.

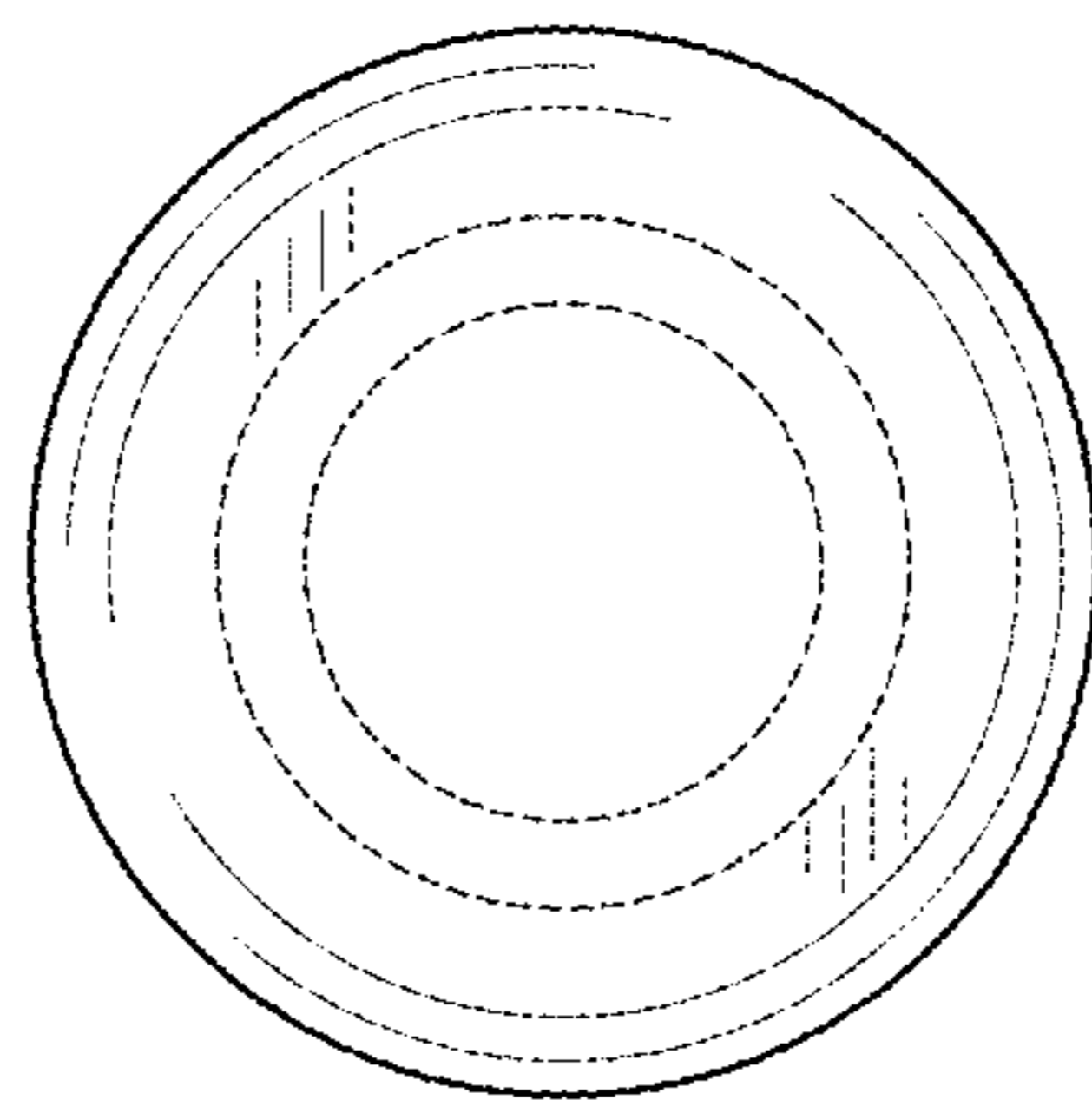

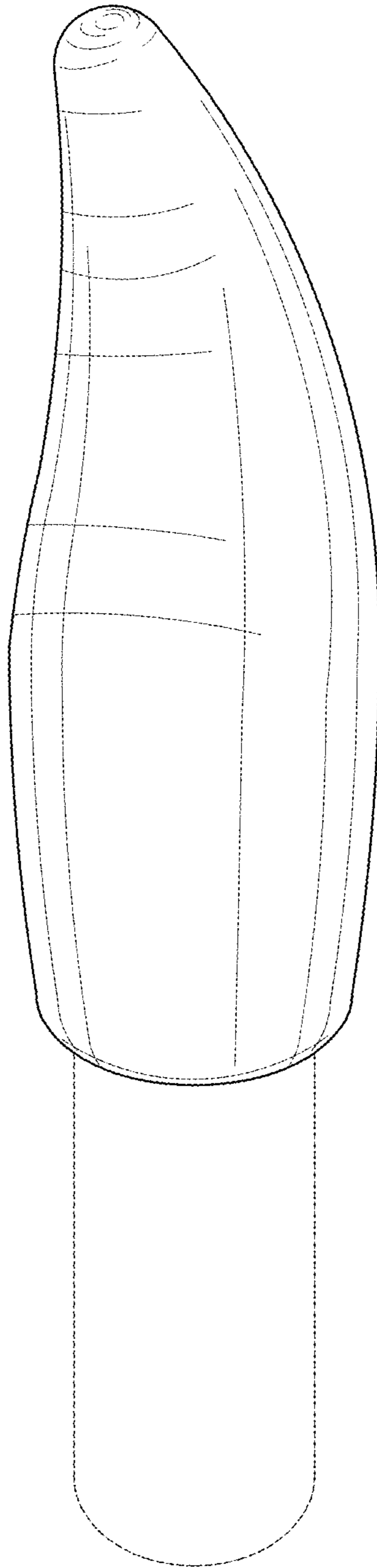

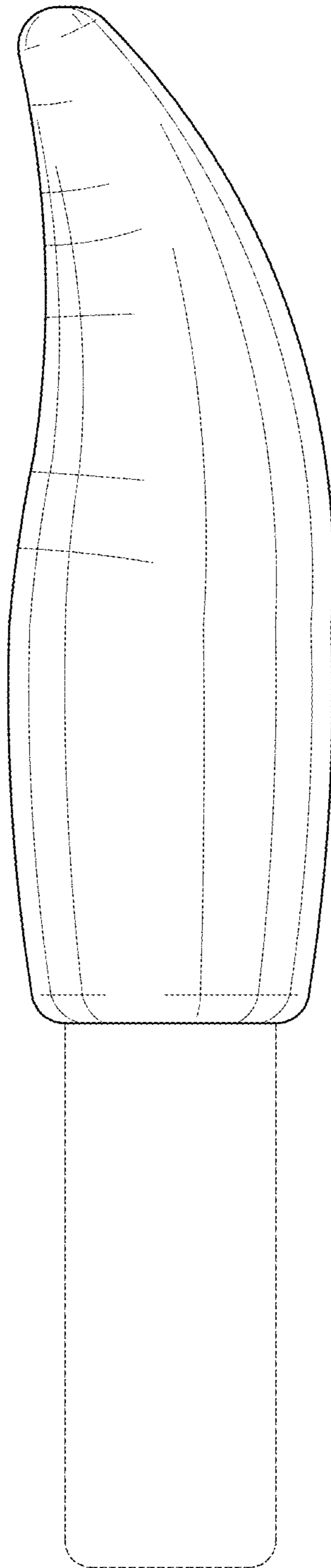
