(57) **CLAIM**

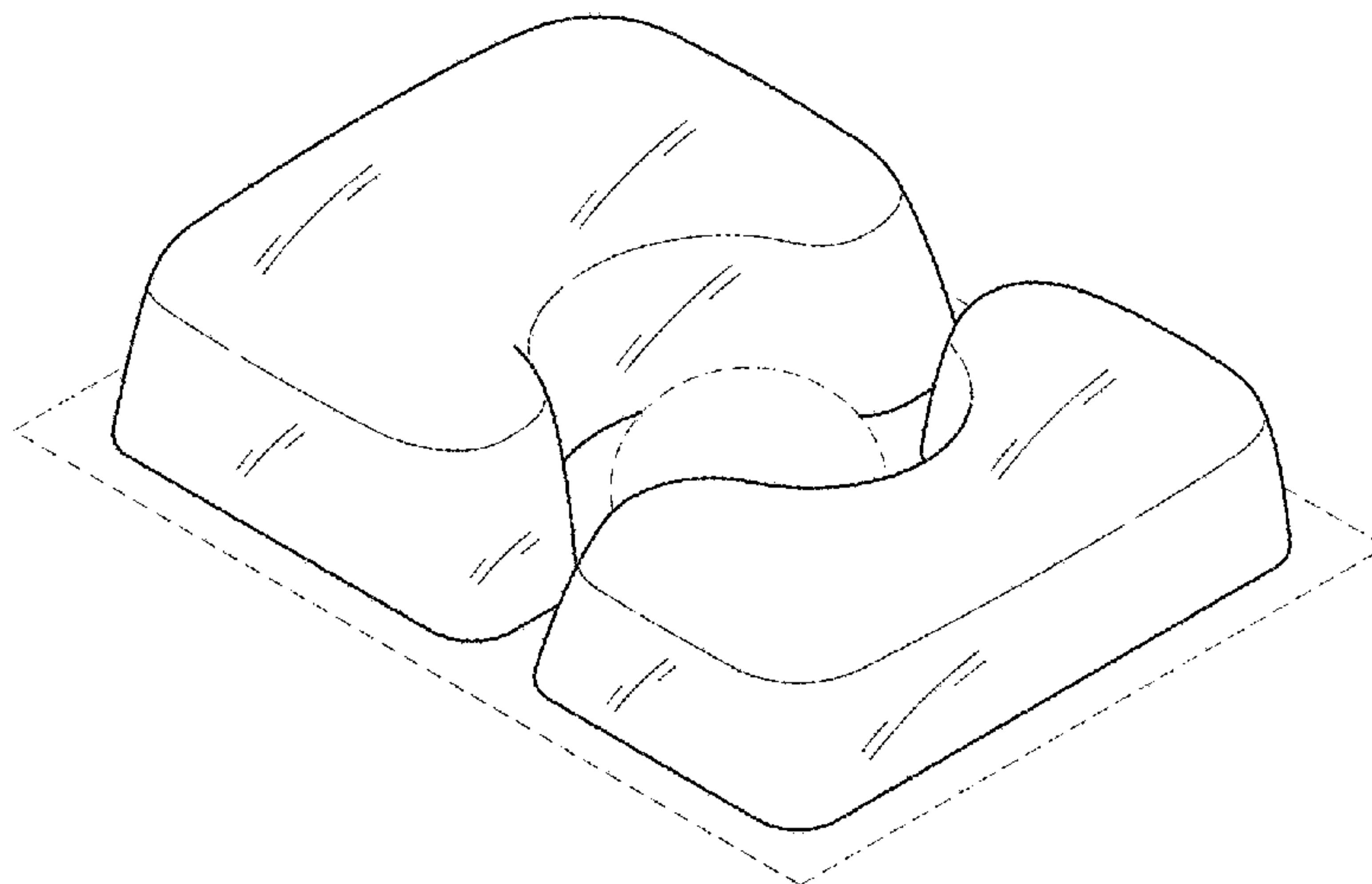
The ornamental design for a capsule containing washing products, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a capsule containing washing products of the present invention;  
FIG. 2 is a side view of the capsule containing washing products of FIG. 1;  
FIG. 3 is the other side view of the capsule containing washing products of FIG. 1;  
FIG. 4 is a back view of the capsule containing washing products of FIG. 1;  
FIG. 5 is a front view of the capsule containing washing products of FIG. 1;  
FIG. 6 is a top view of the capsule containing washing products of FIG. 1; and,  
FIG. 7 is a bottom view of the capsule containing washing products of FIG. 1.

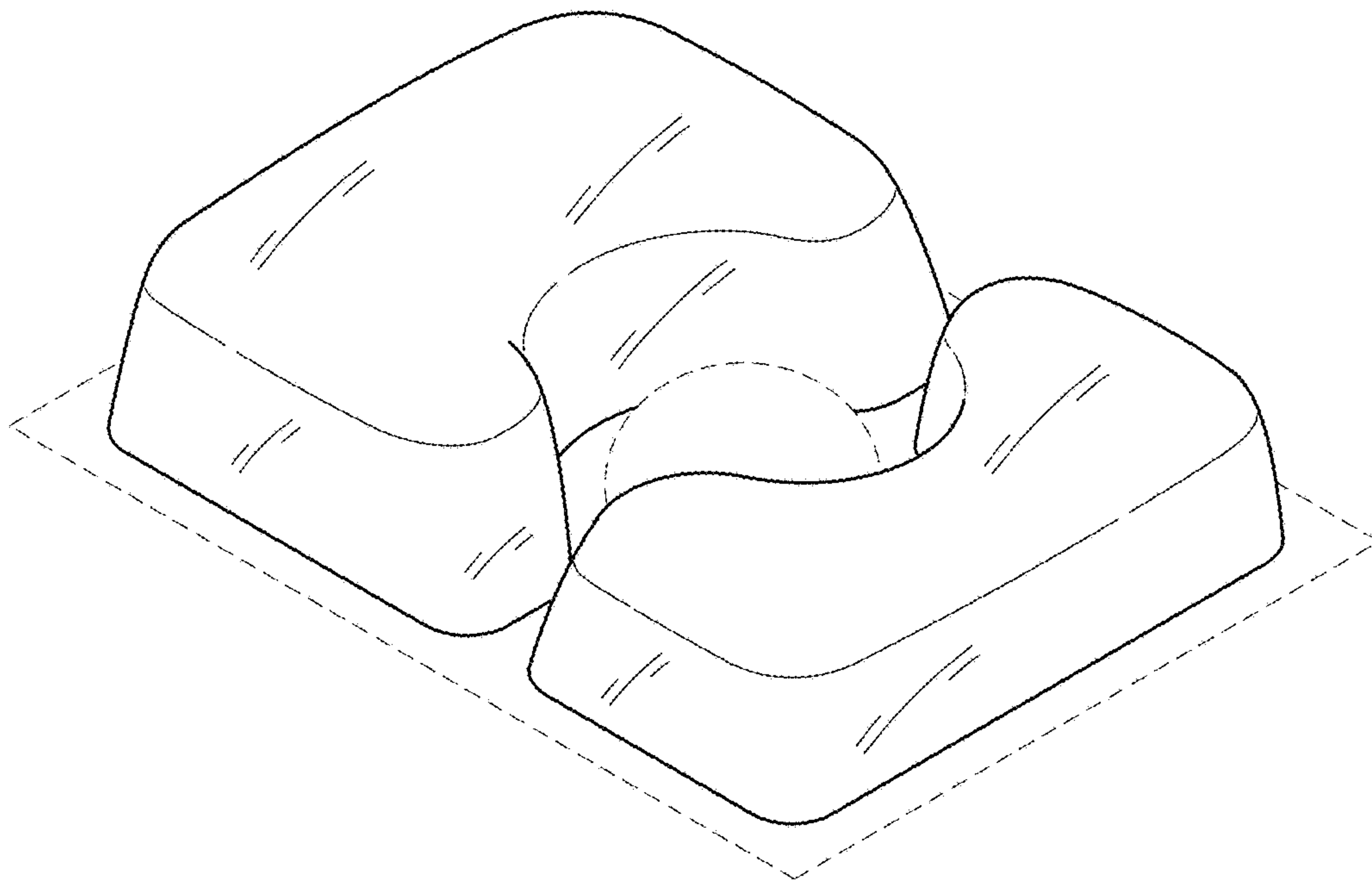

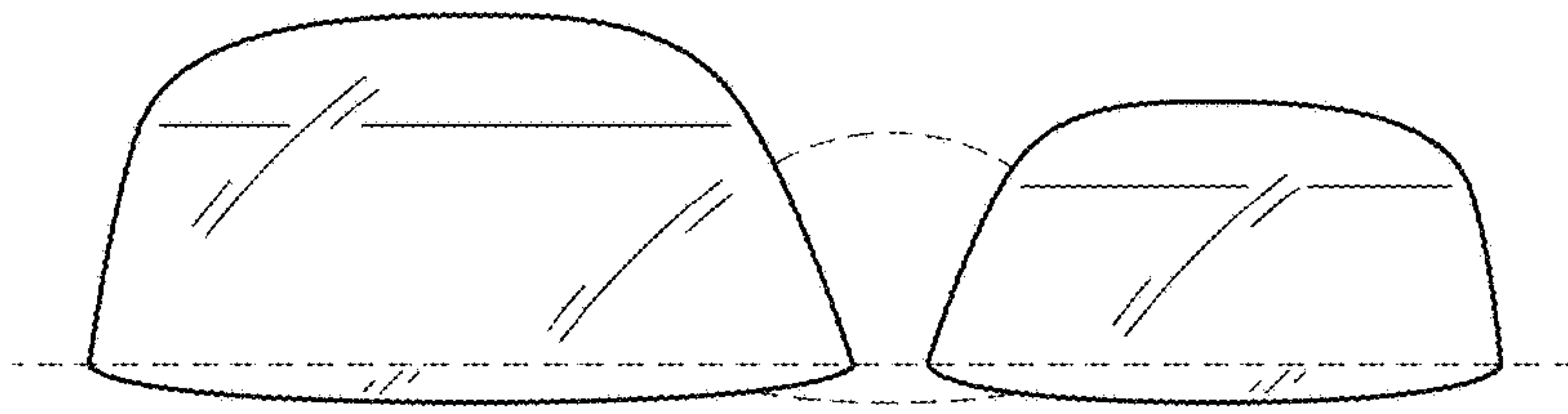

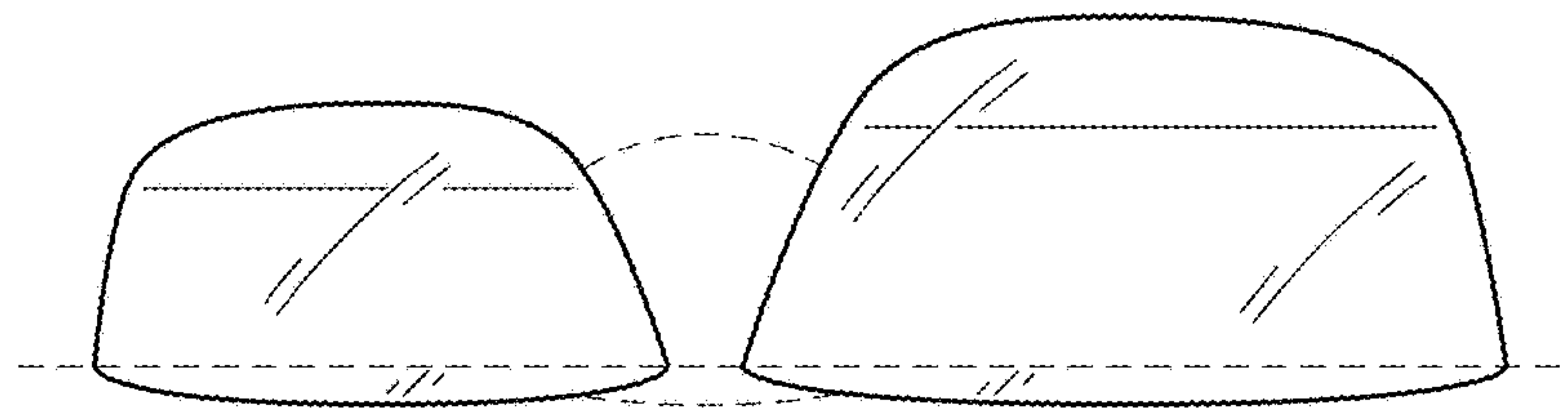

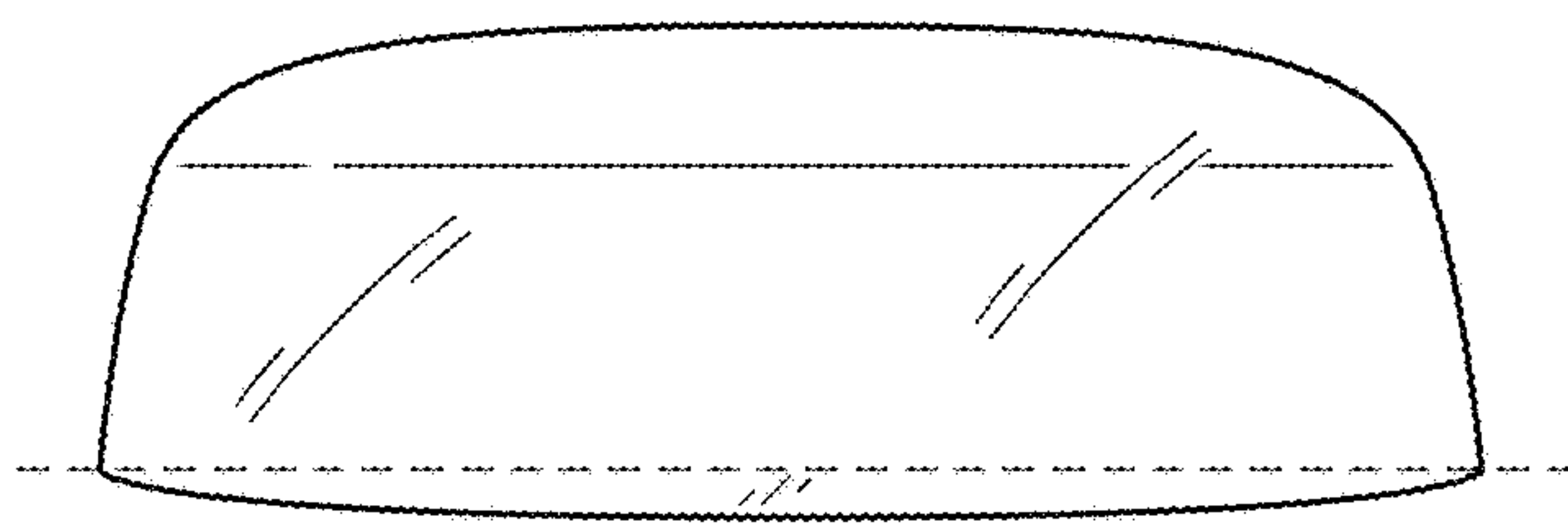

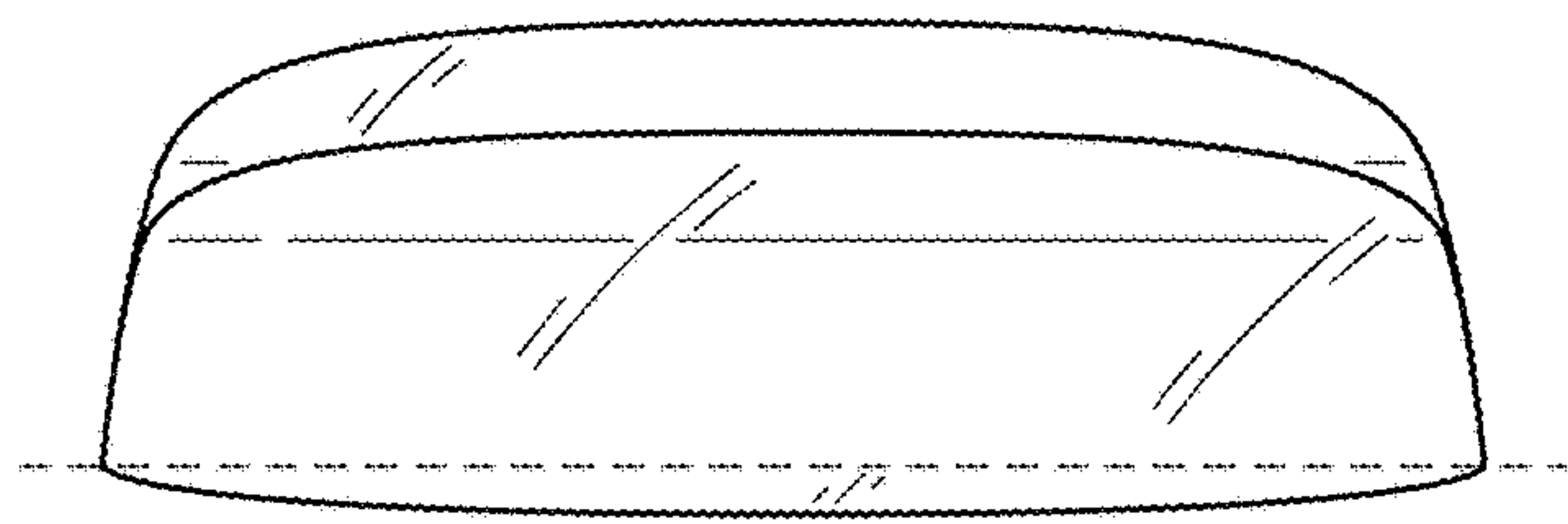

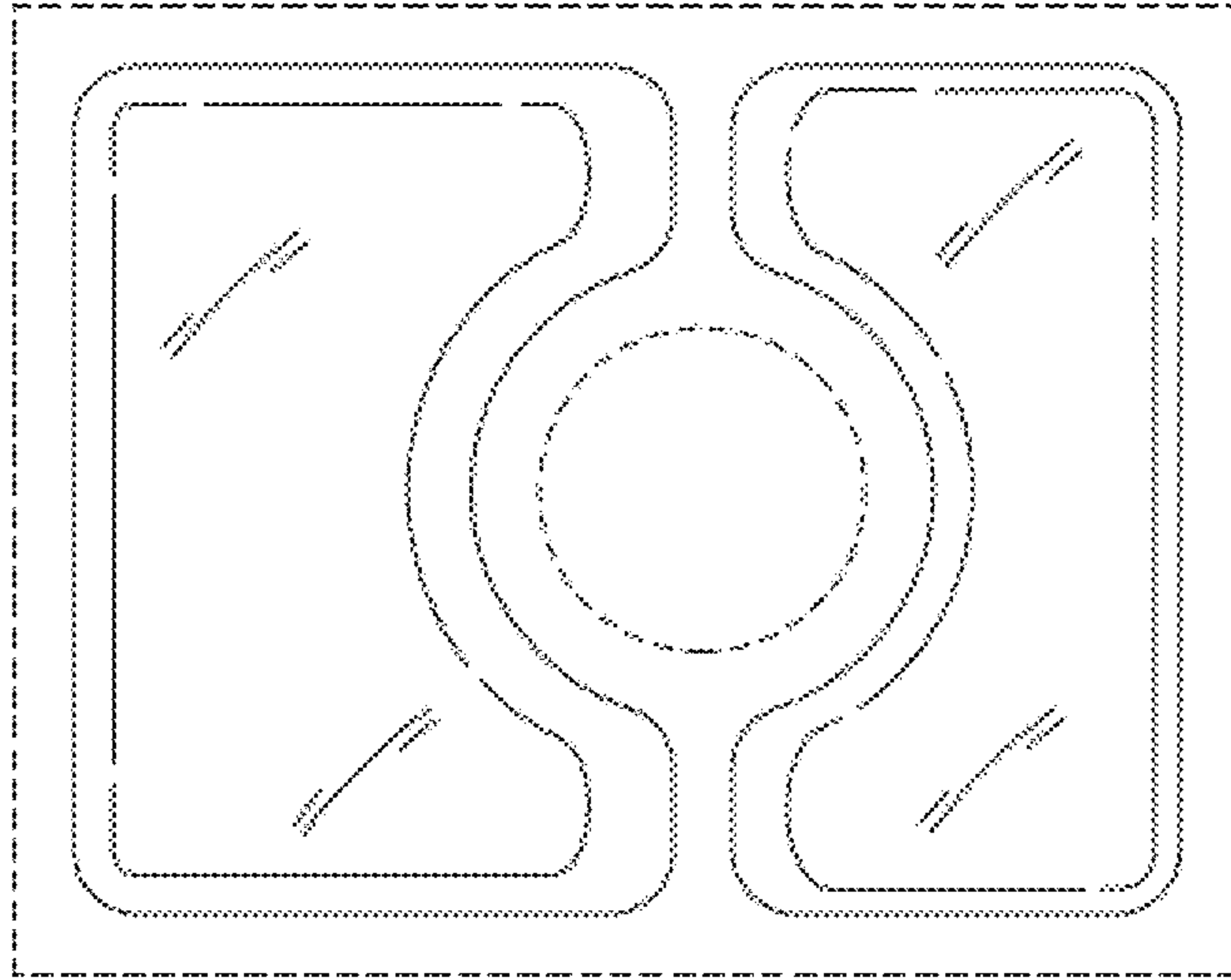

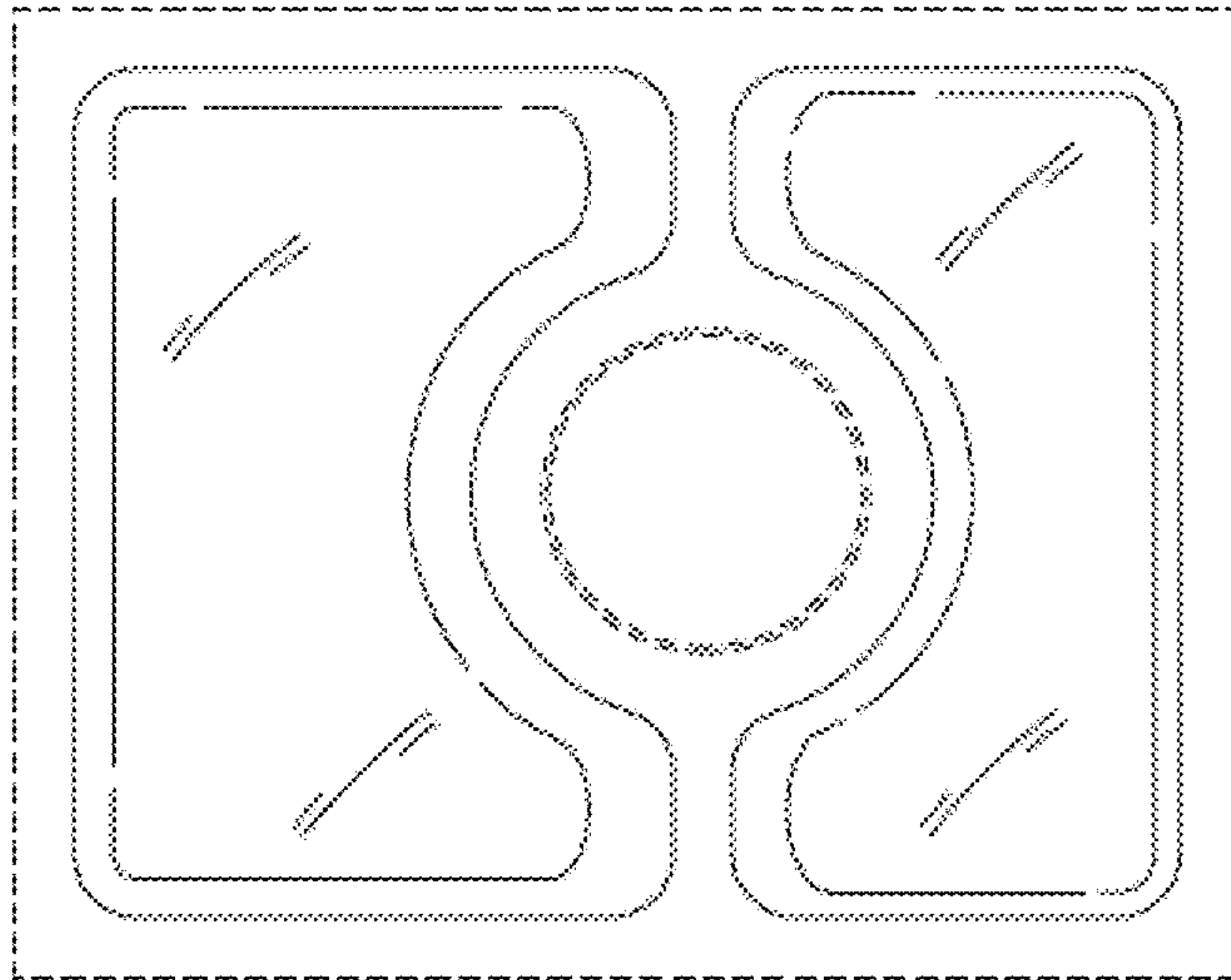
