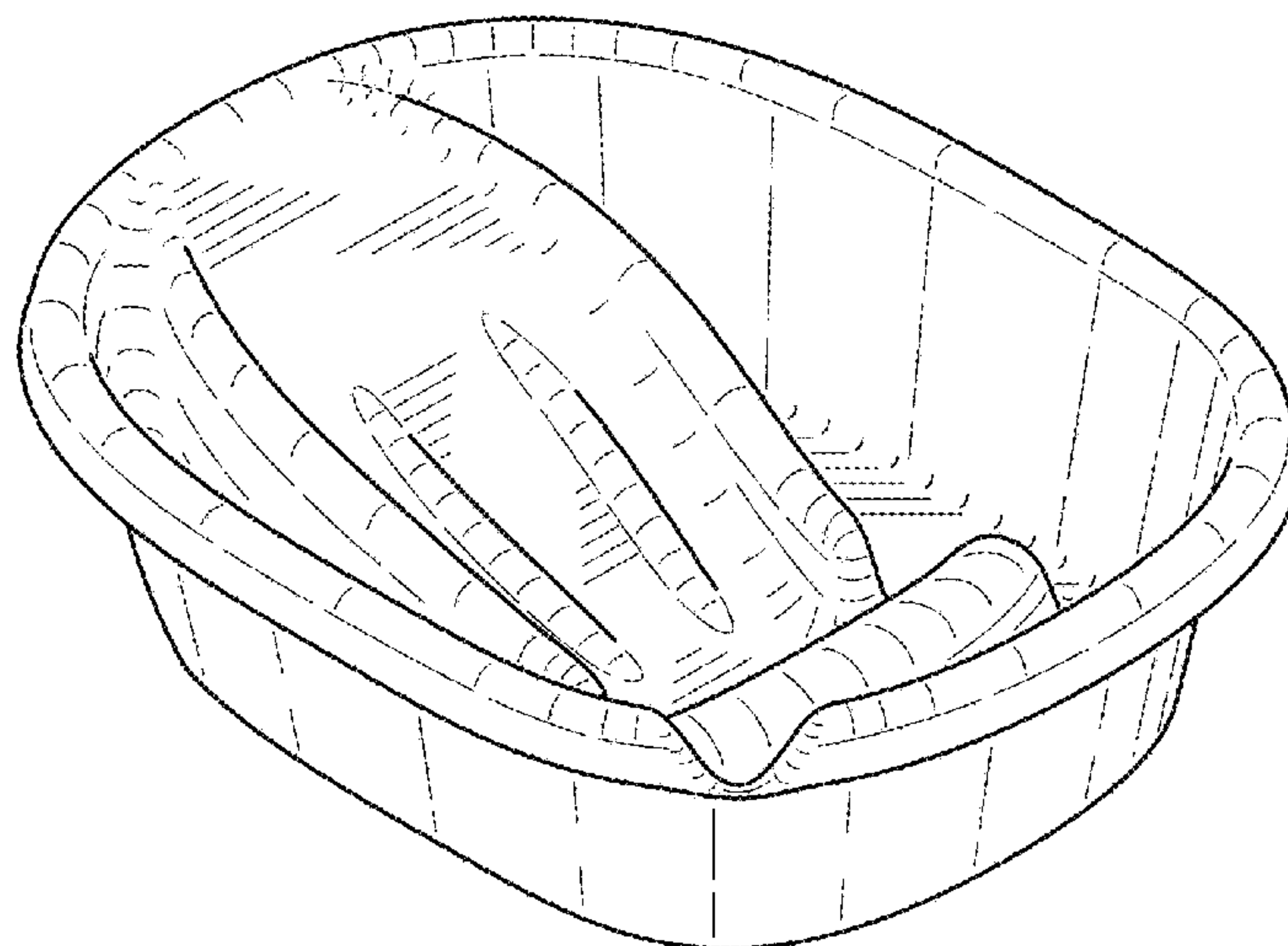
FIG. 1 is a front, top perspective view of the infant bath tub showing our new design;

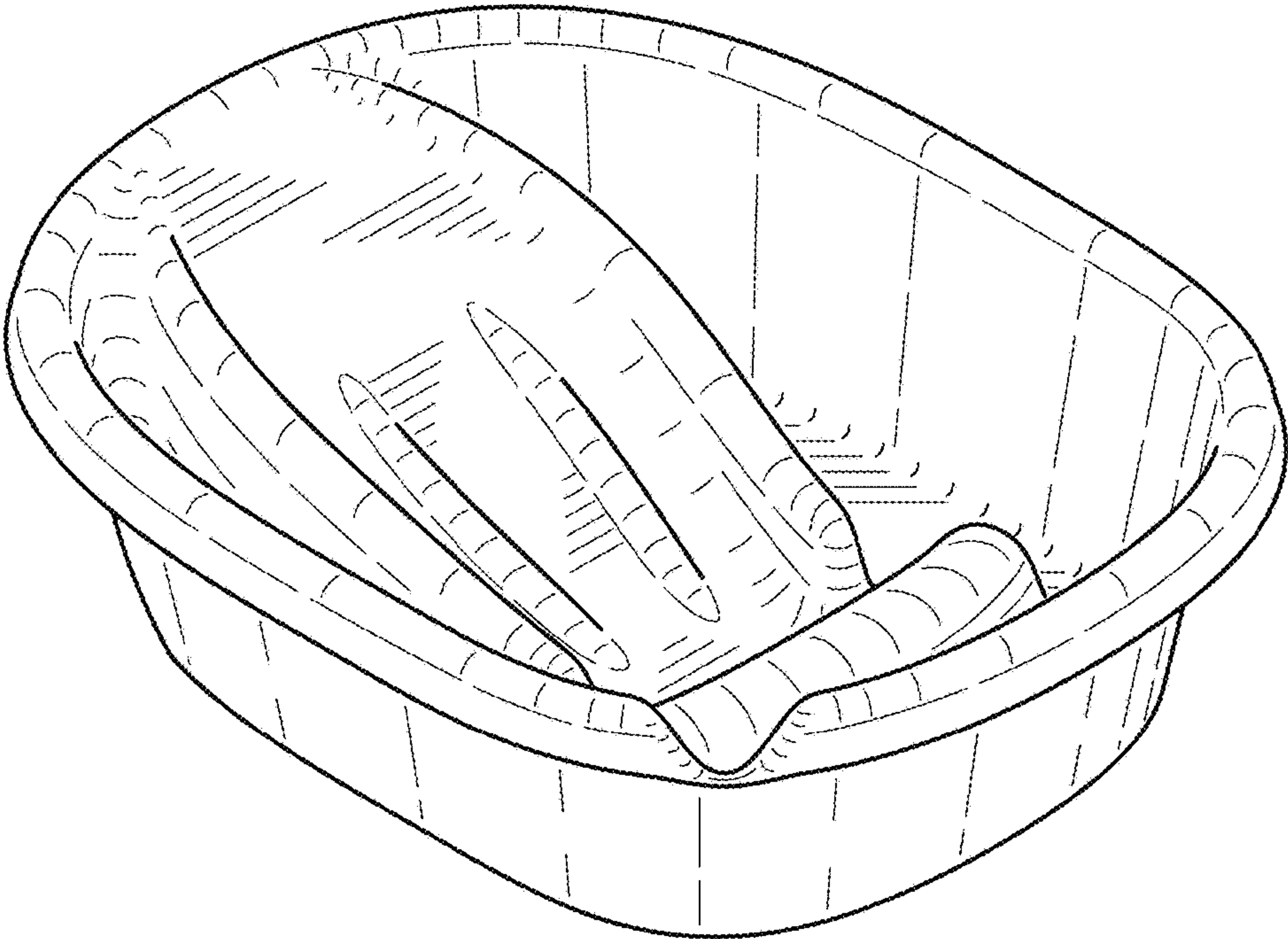

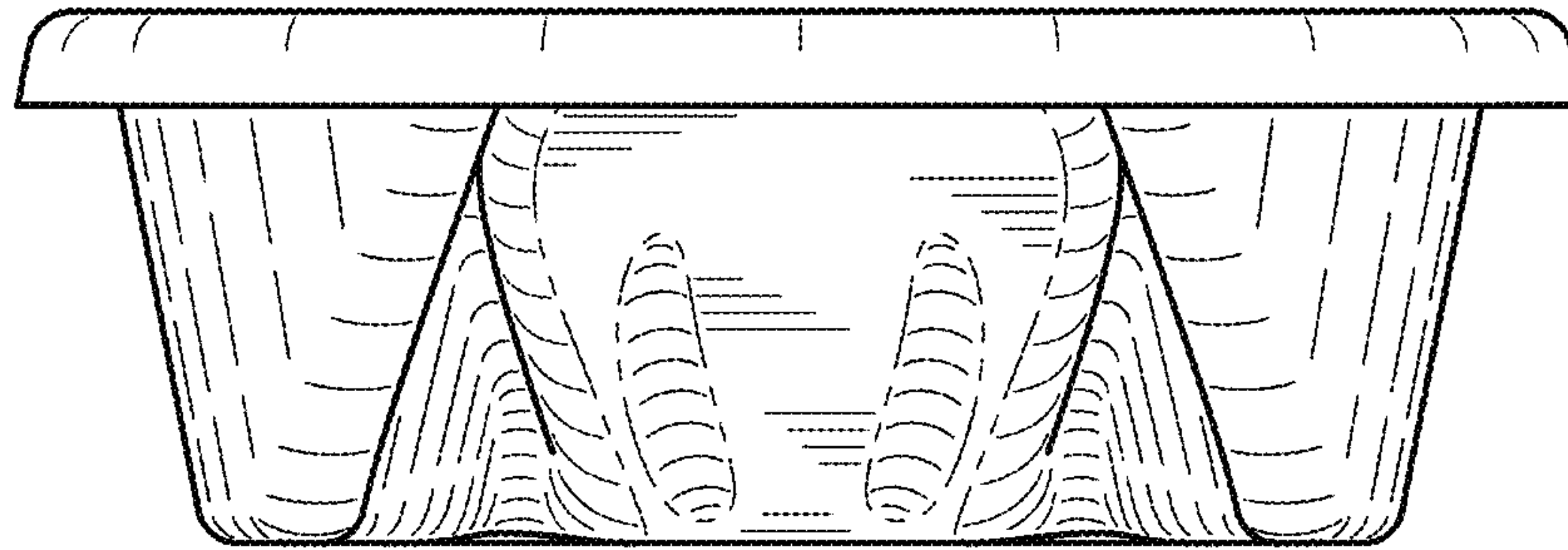

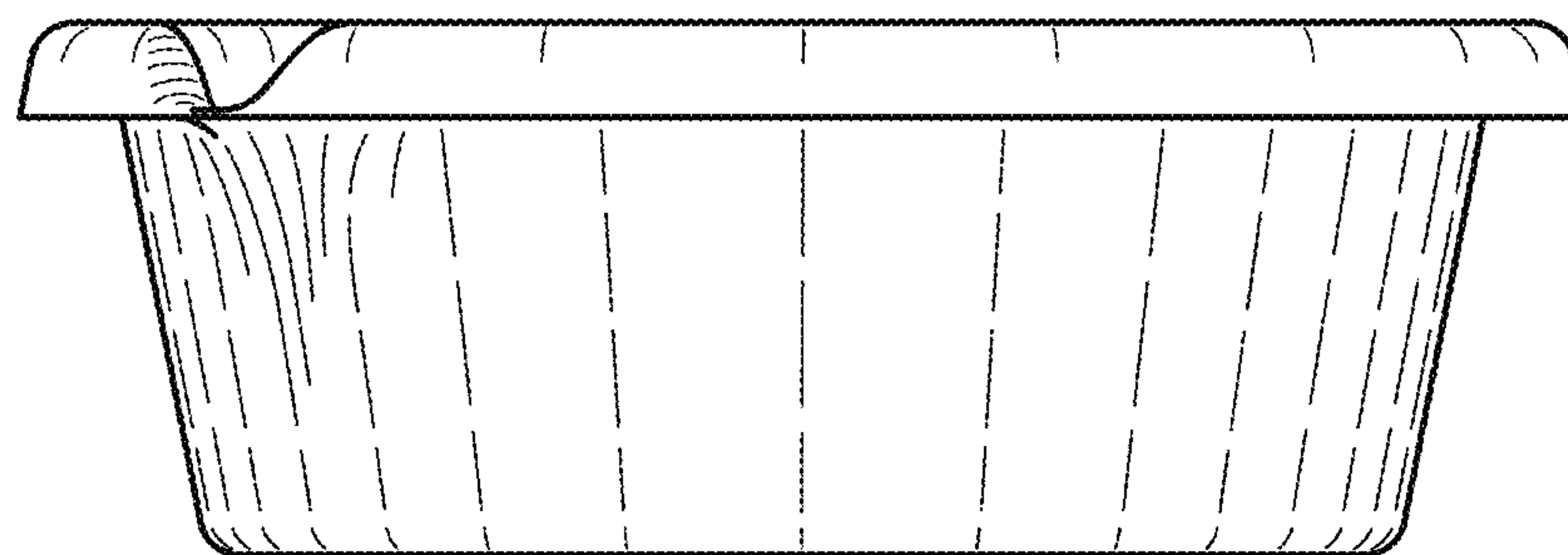

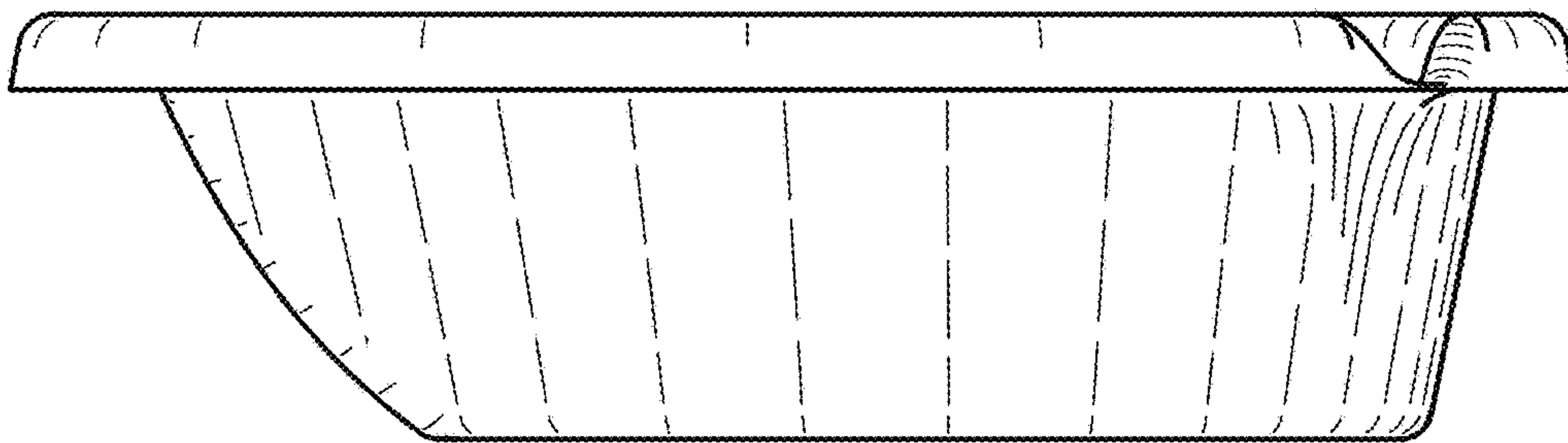

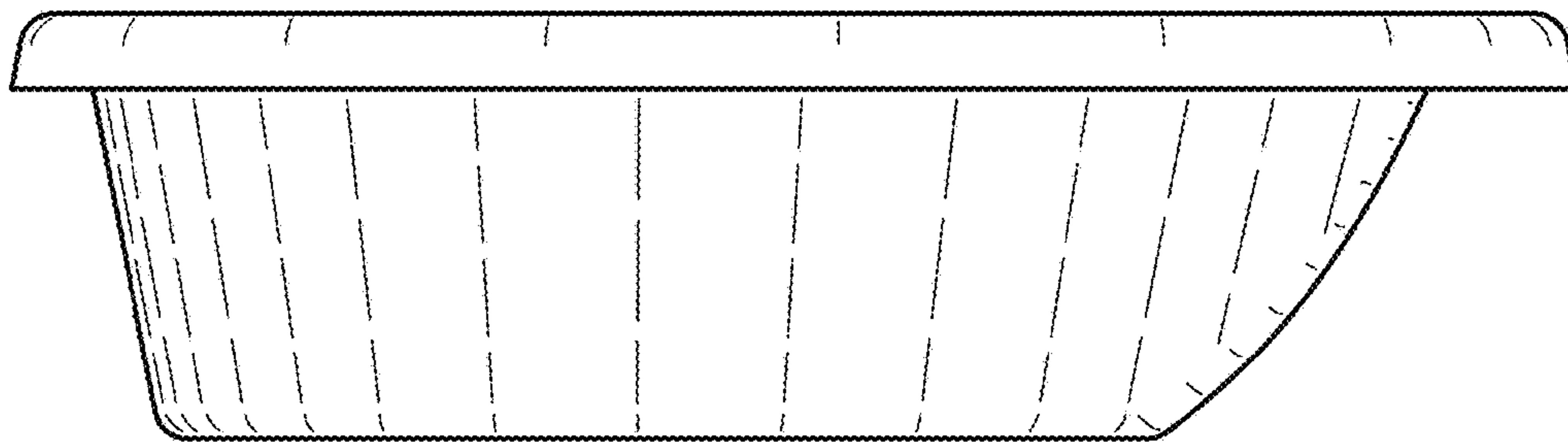

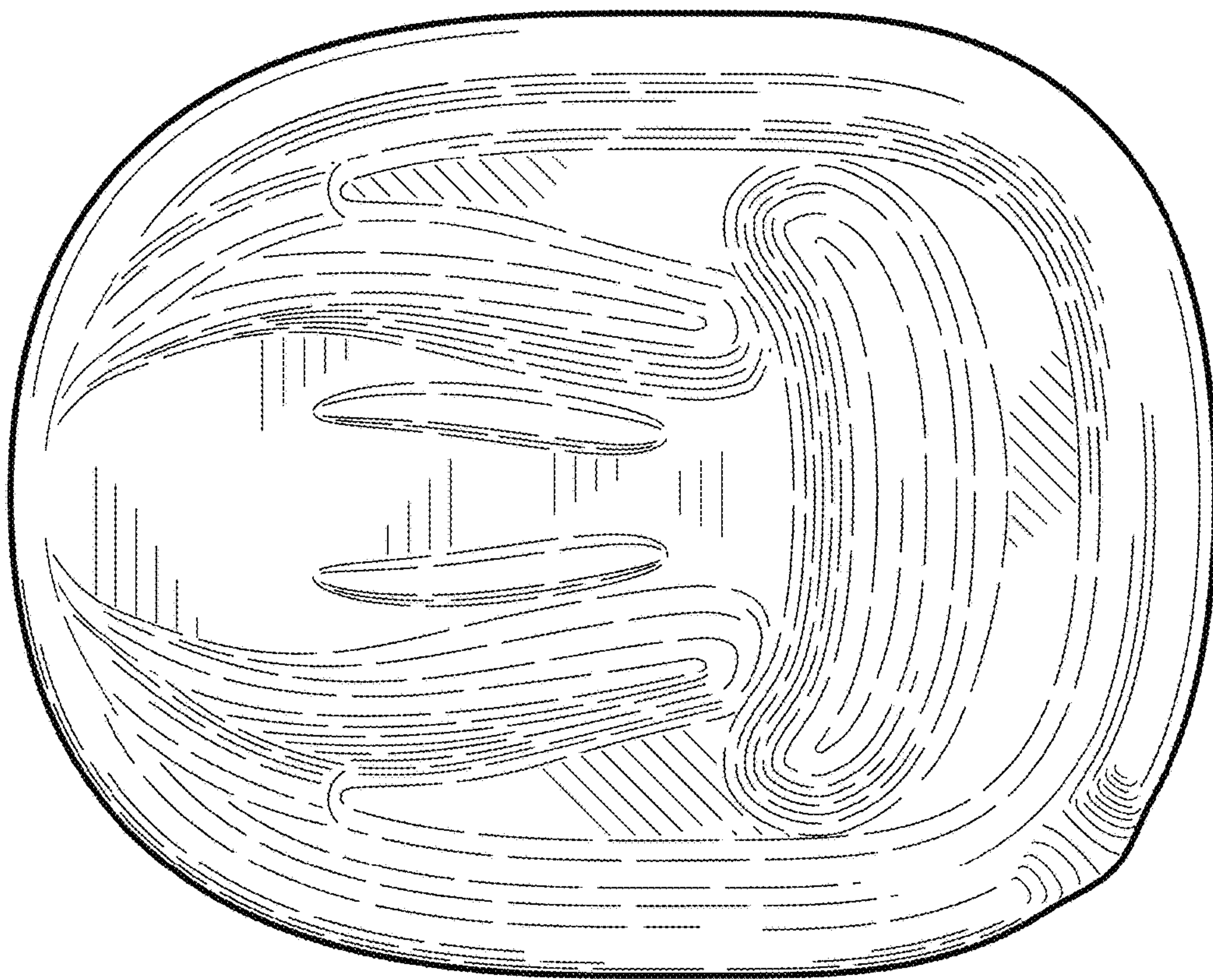

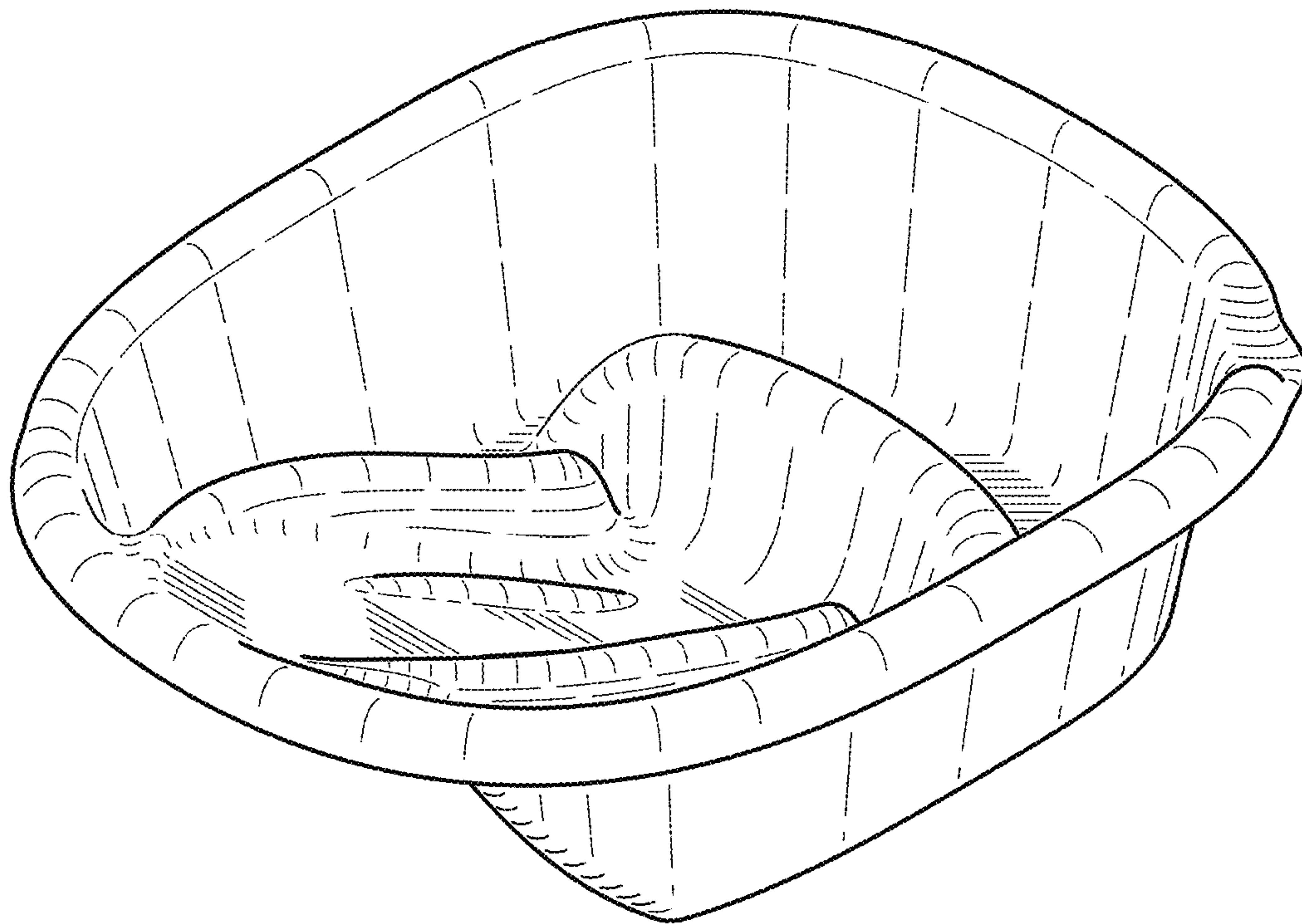

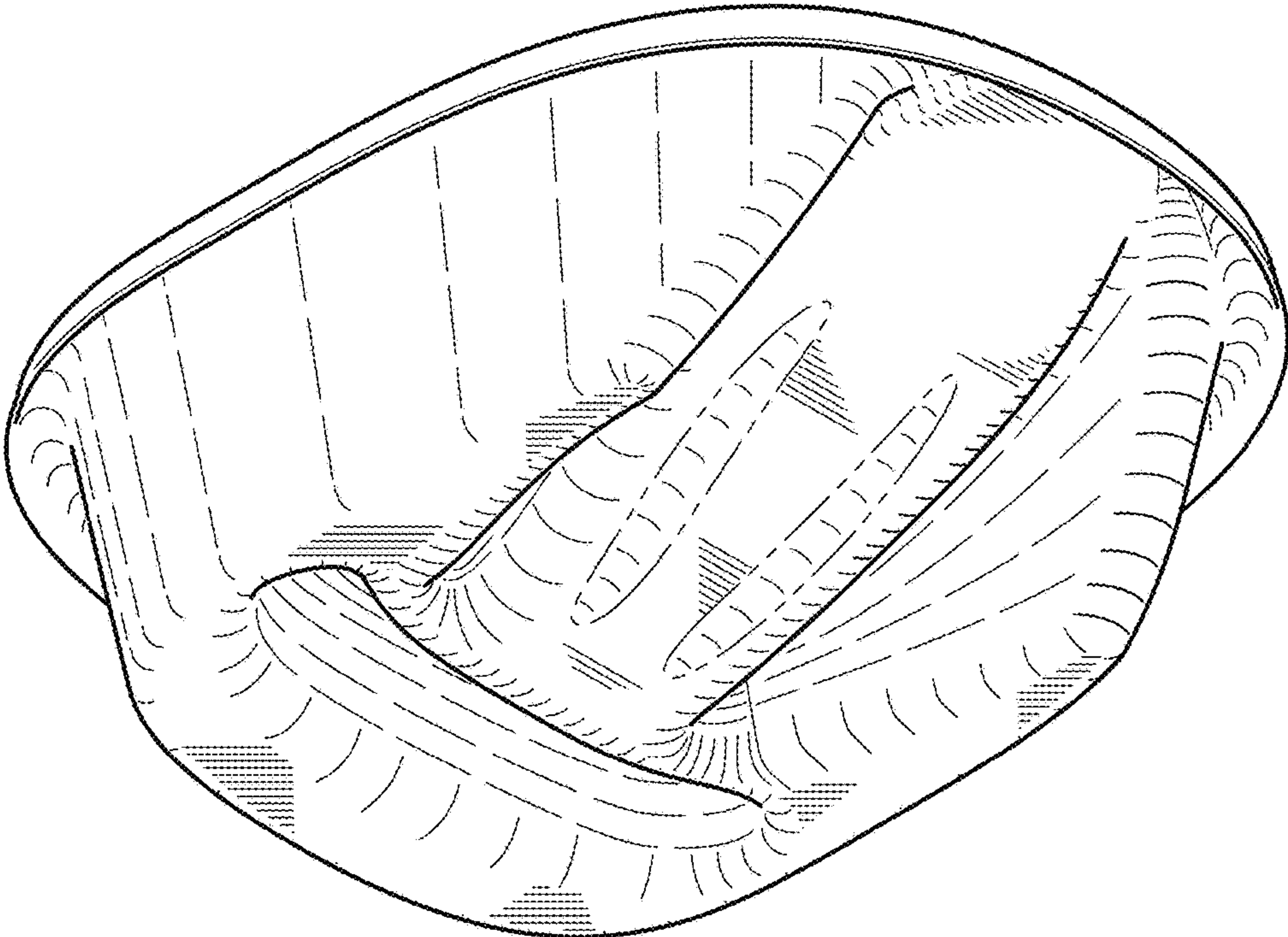

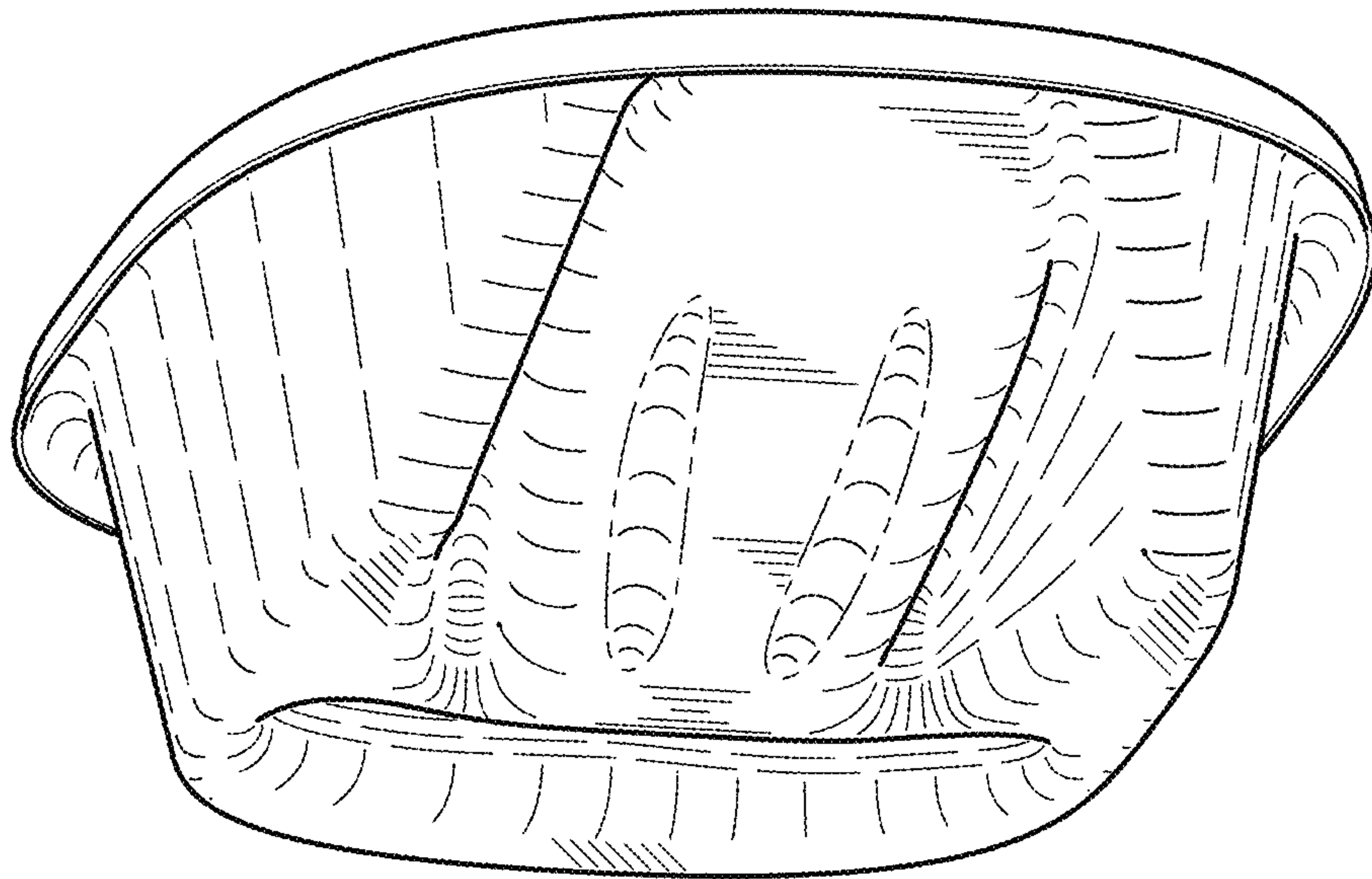

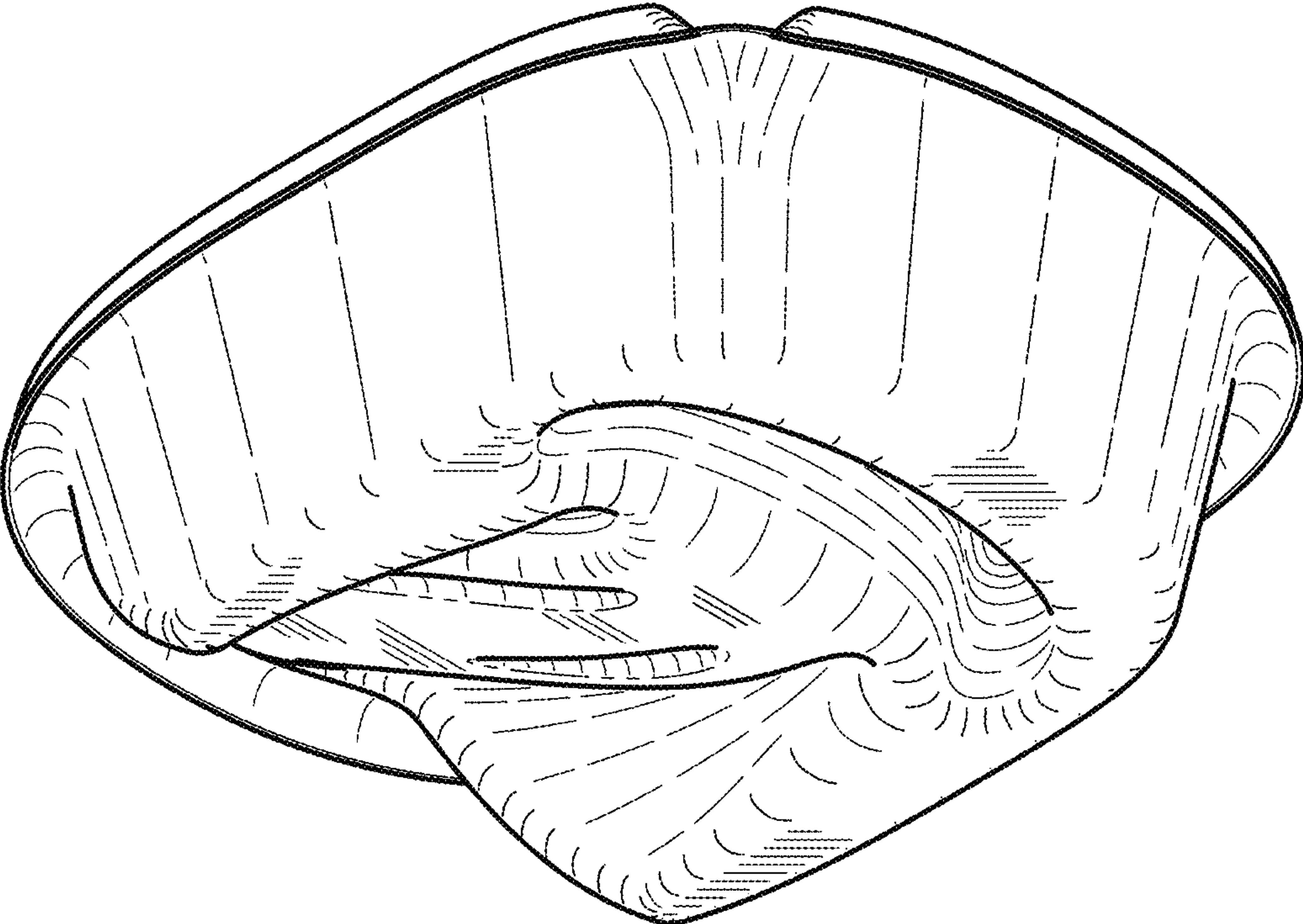

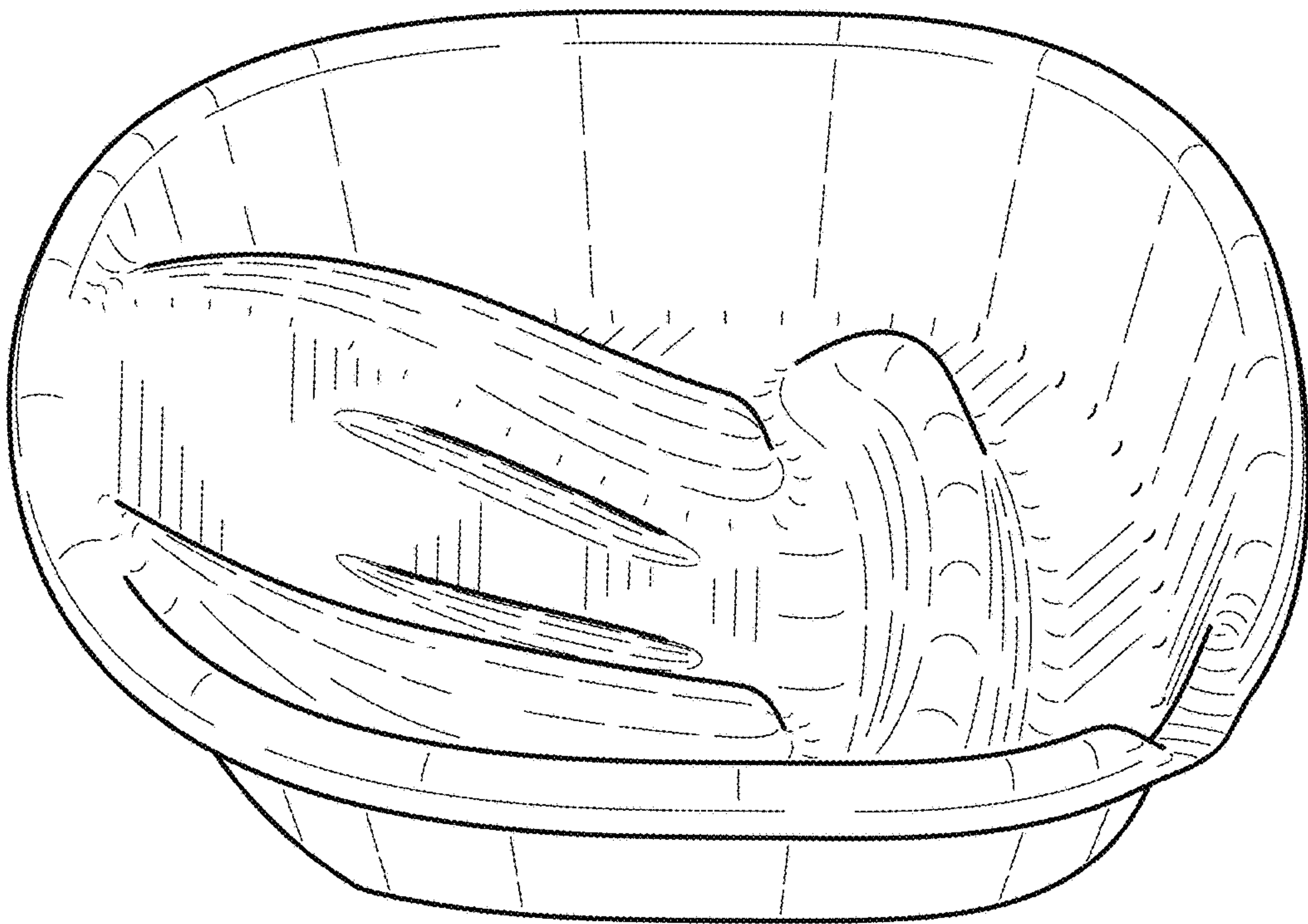

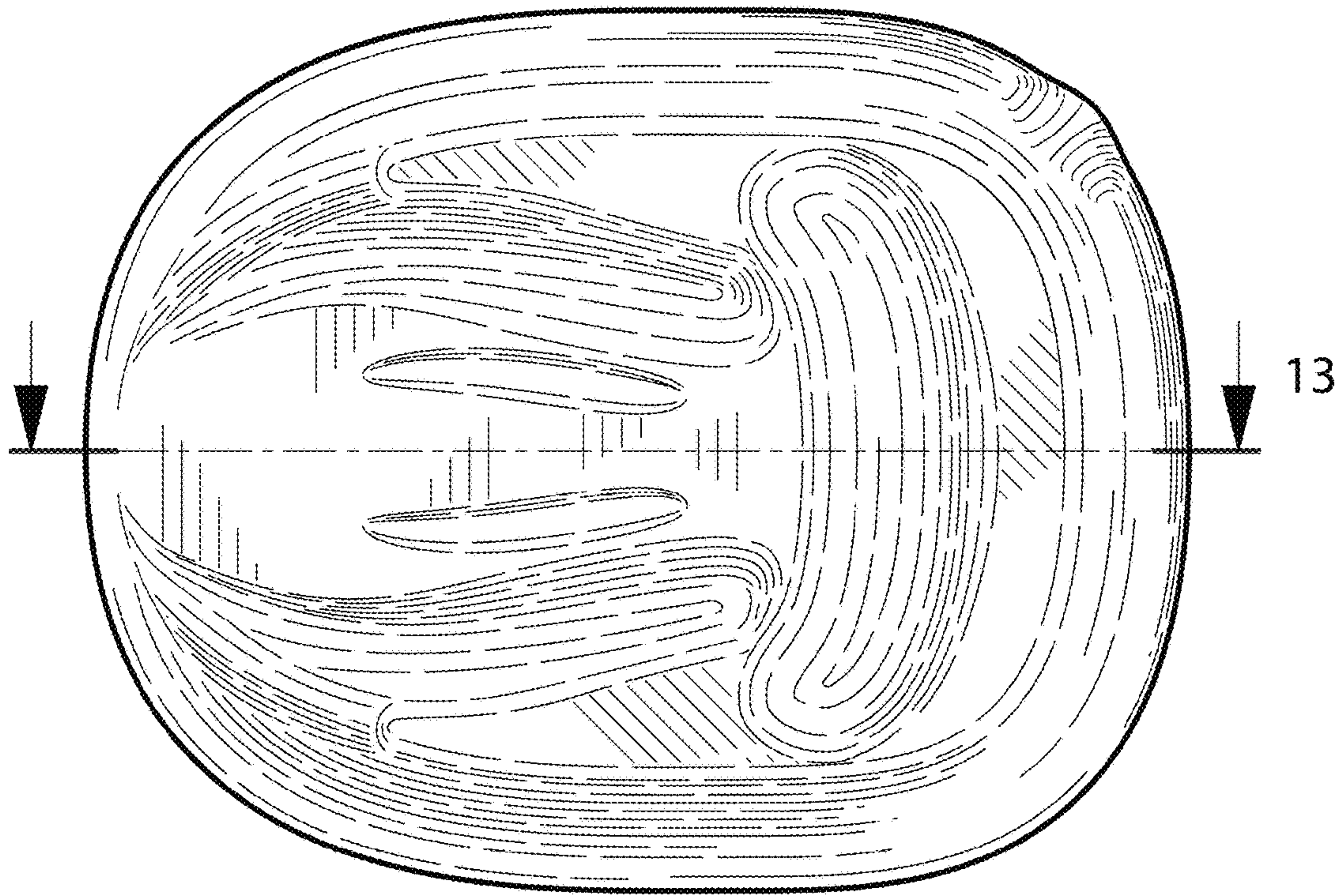

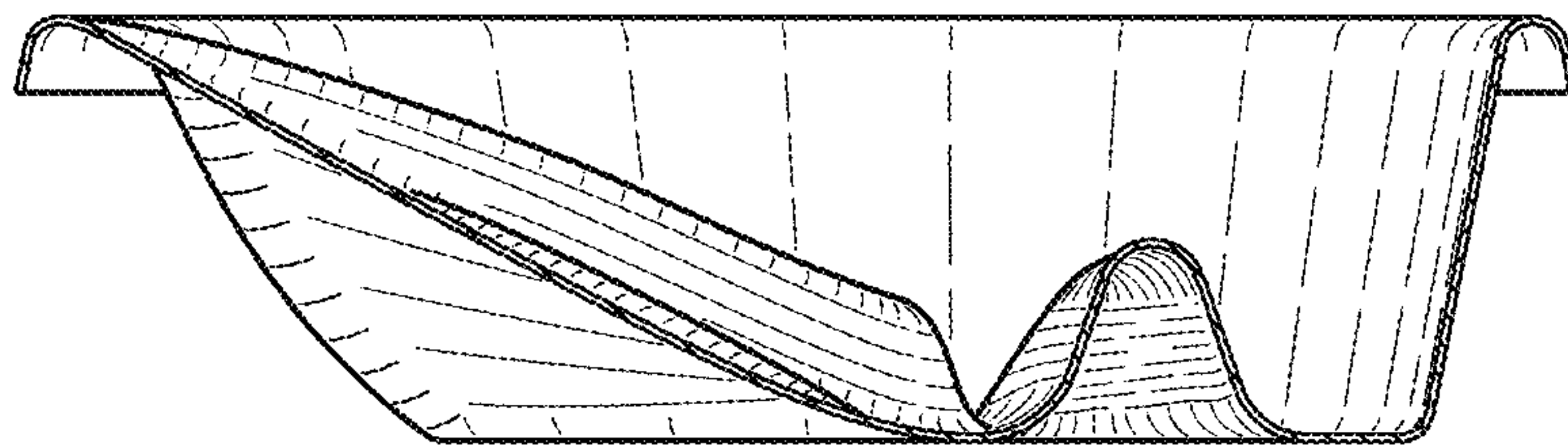
