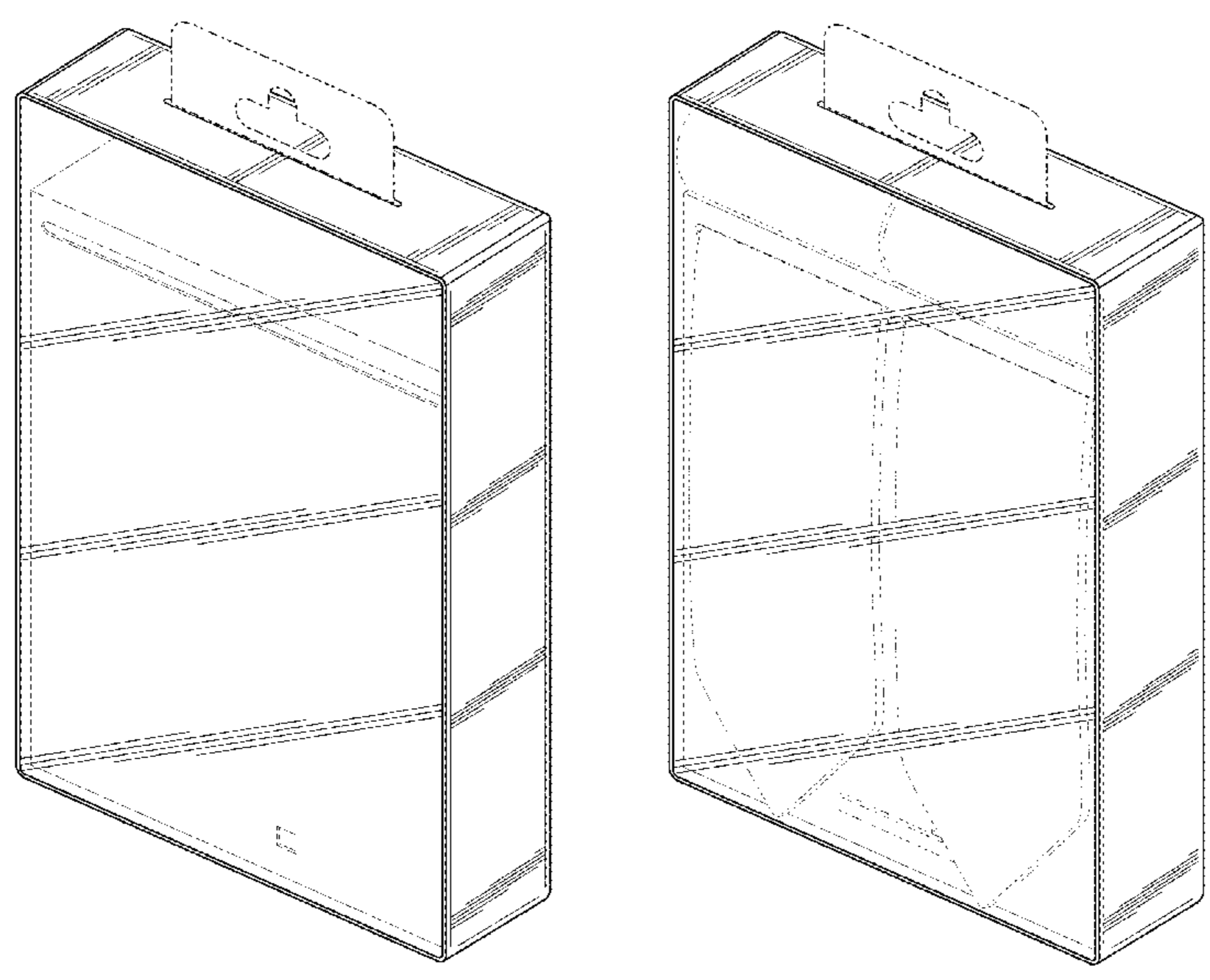

(57) **CLAIM**
The ornamental design for a wide box set for ties, as shown and described.

DESCRIPTION
FIG. 1 is a front, top, left perspective view of a wide box set for ties showing my new design;
FIG. 2 is a rear, top, left perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof, the left side elevational view being identical;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view showing my design in the environment of two ties, two rolled handkerchiefs, and a tie clip, the two ties, two rolled handkerchiefs, and tie clip shown in phantom line and forming no part of the design. The broken lines shown in drawings are included for the purpose of illustrating unclaimed portions of the wide box set for ties and form no part of the claimed design.

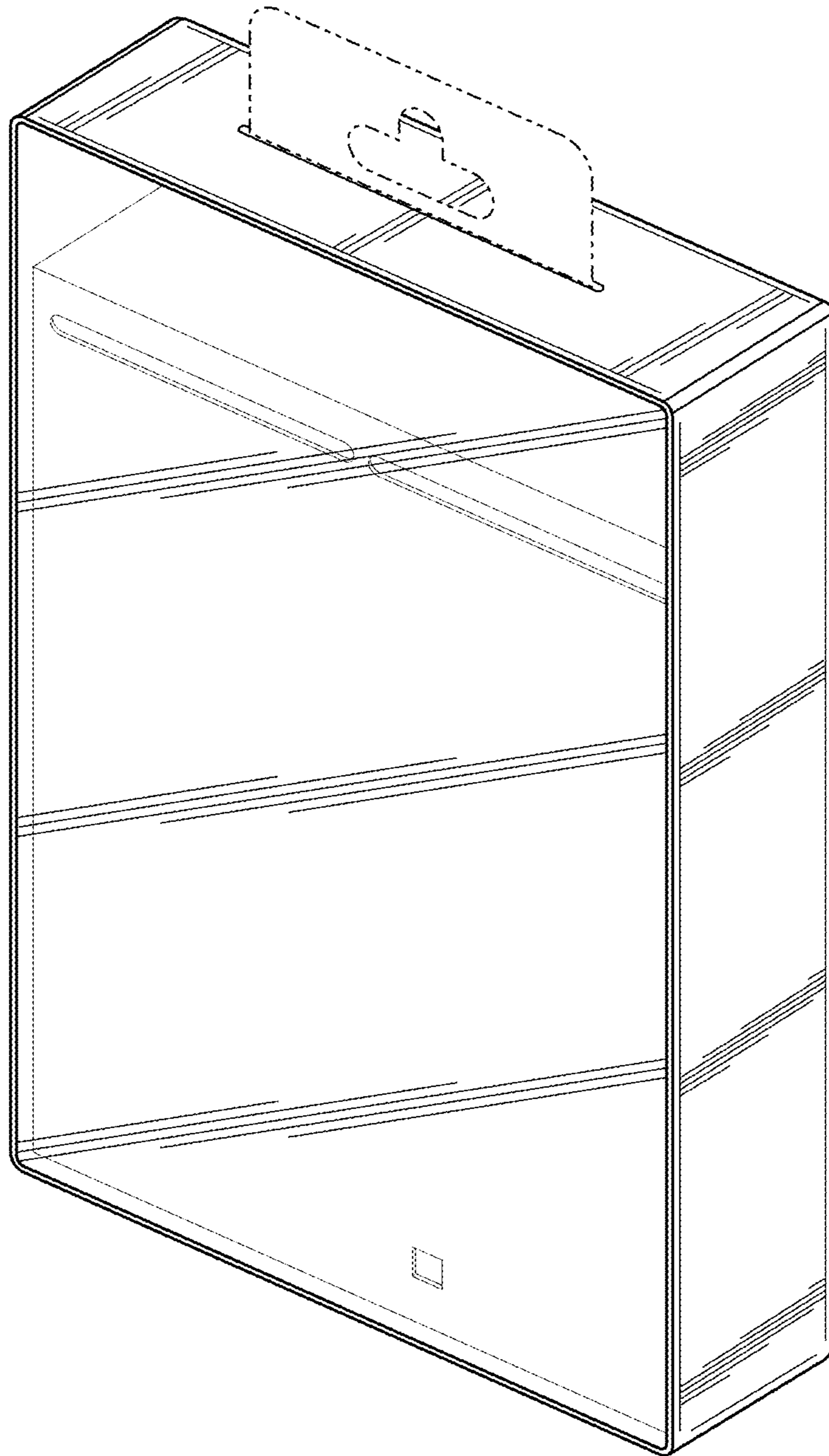

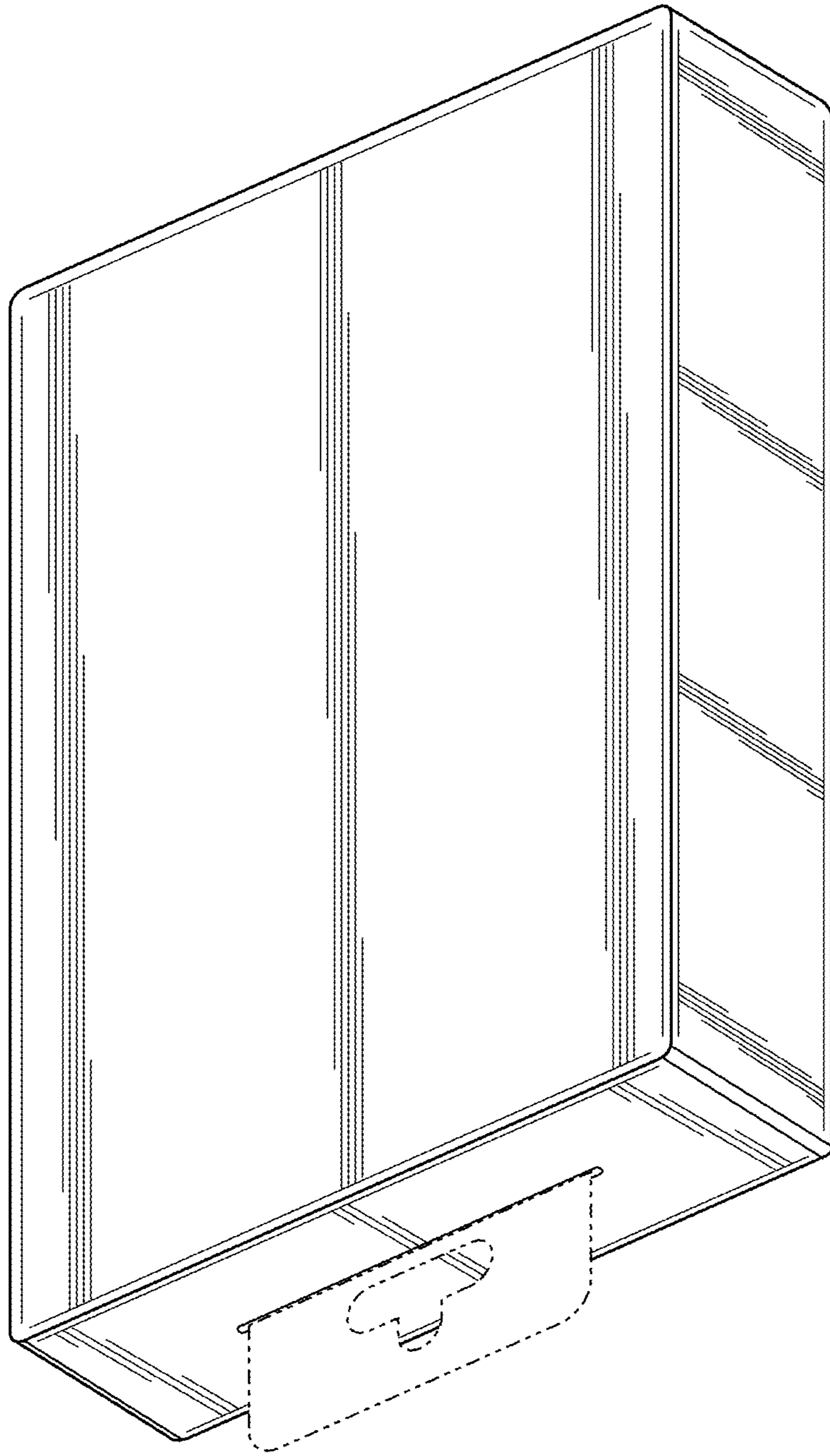

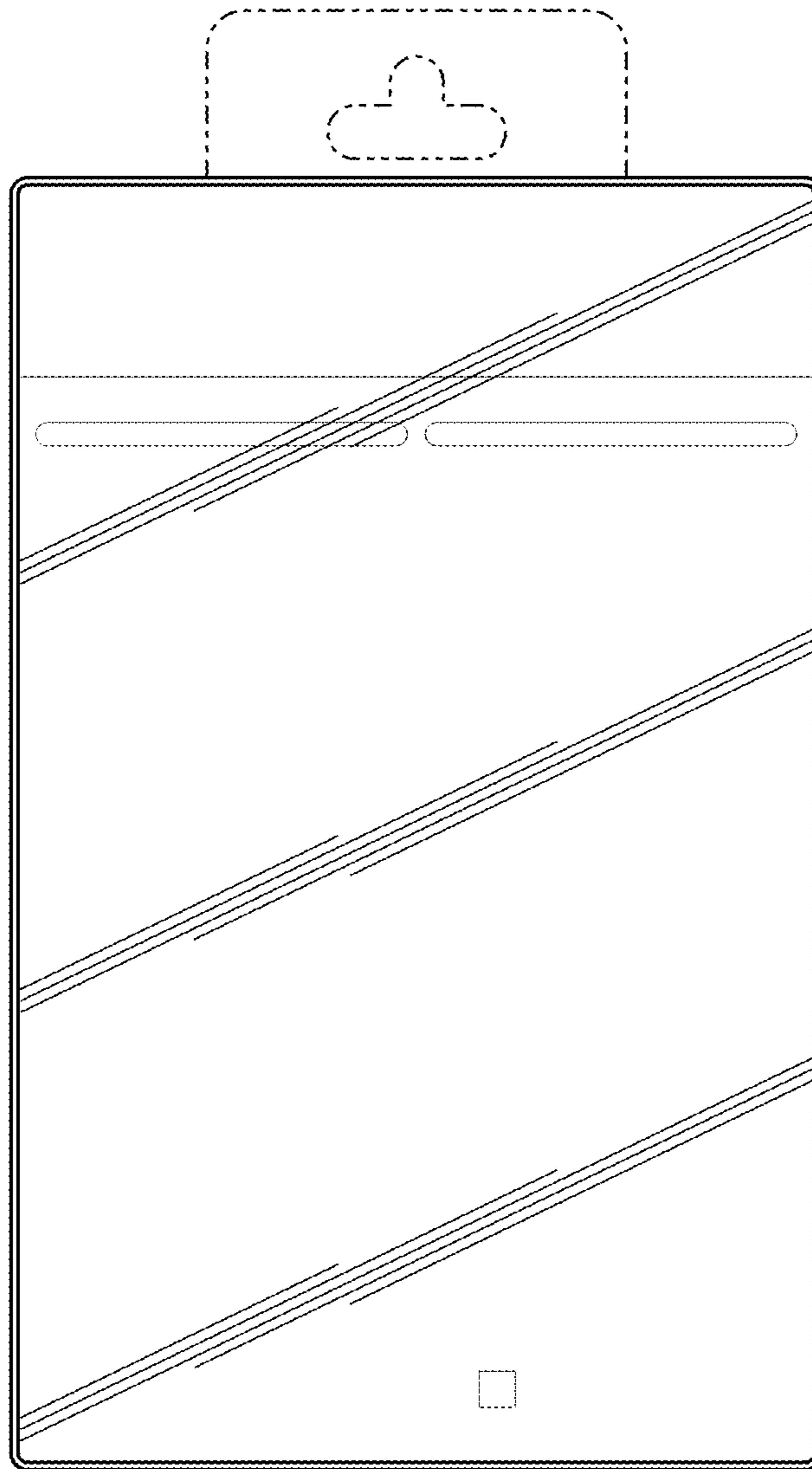

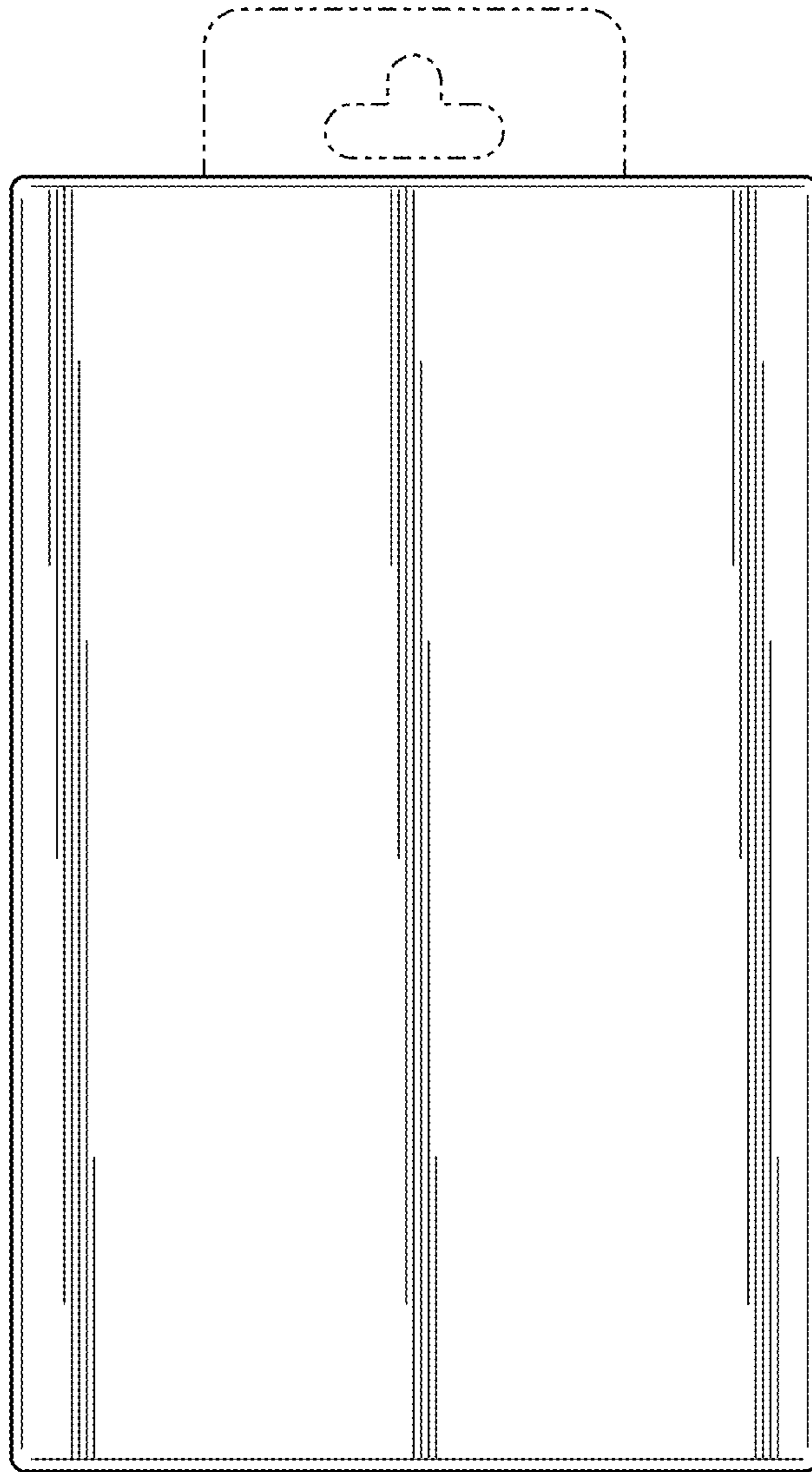

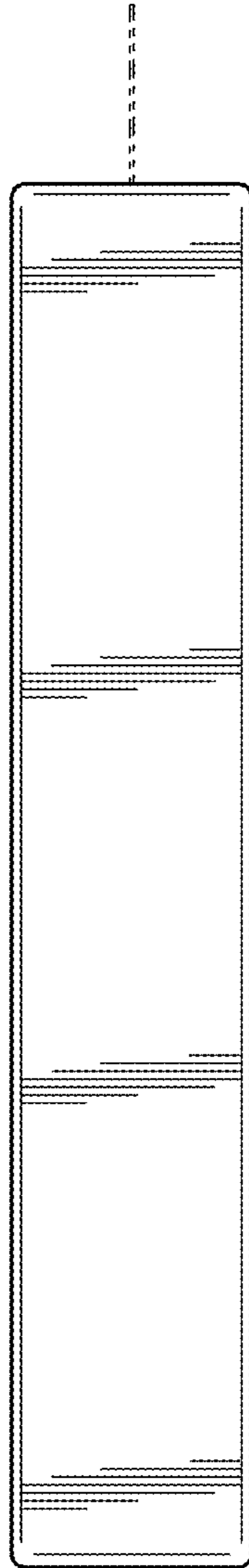

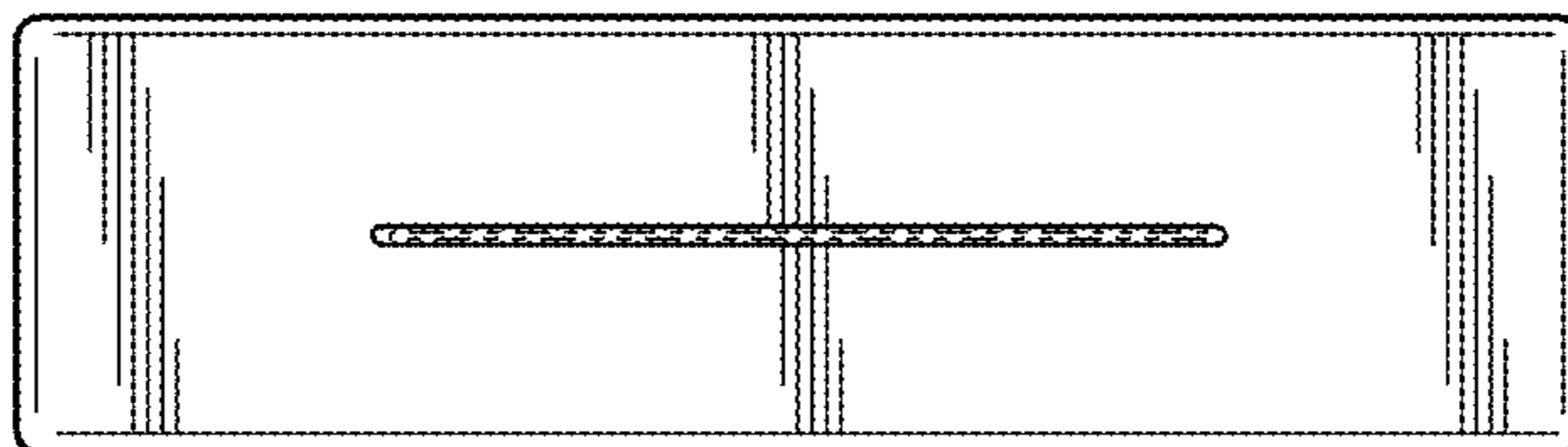

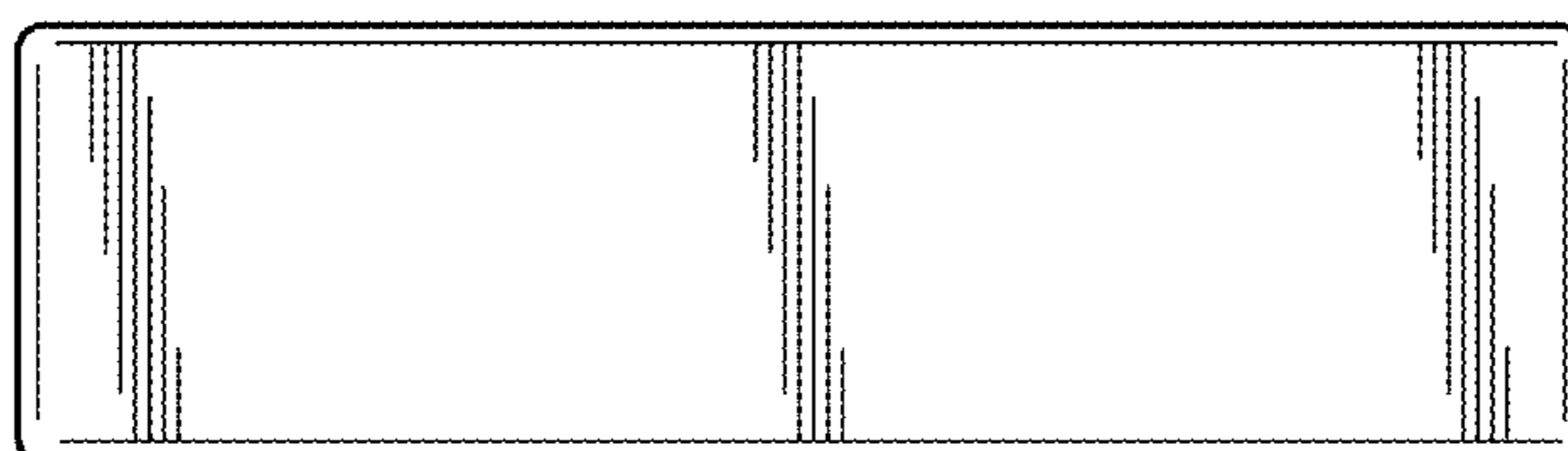

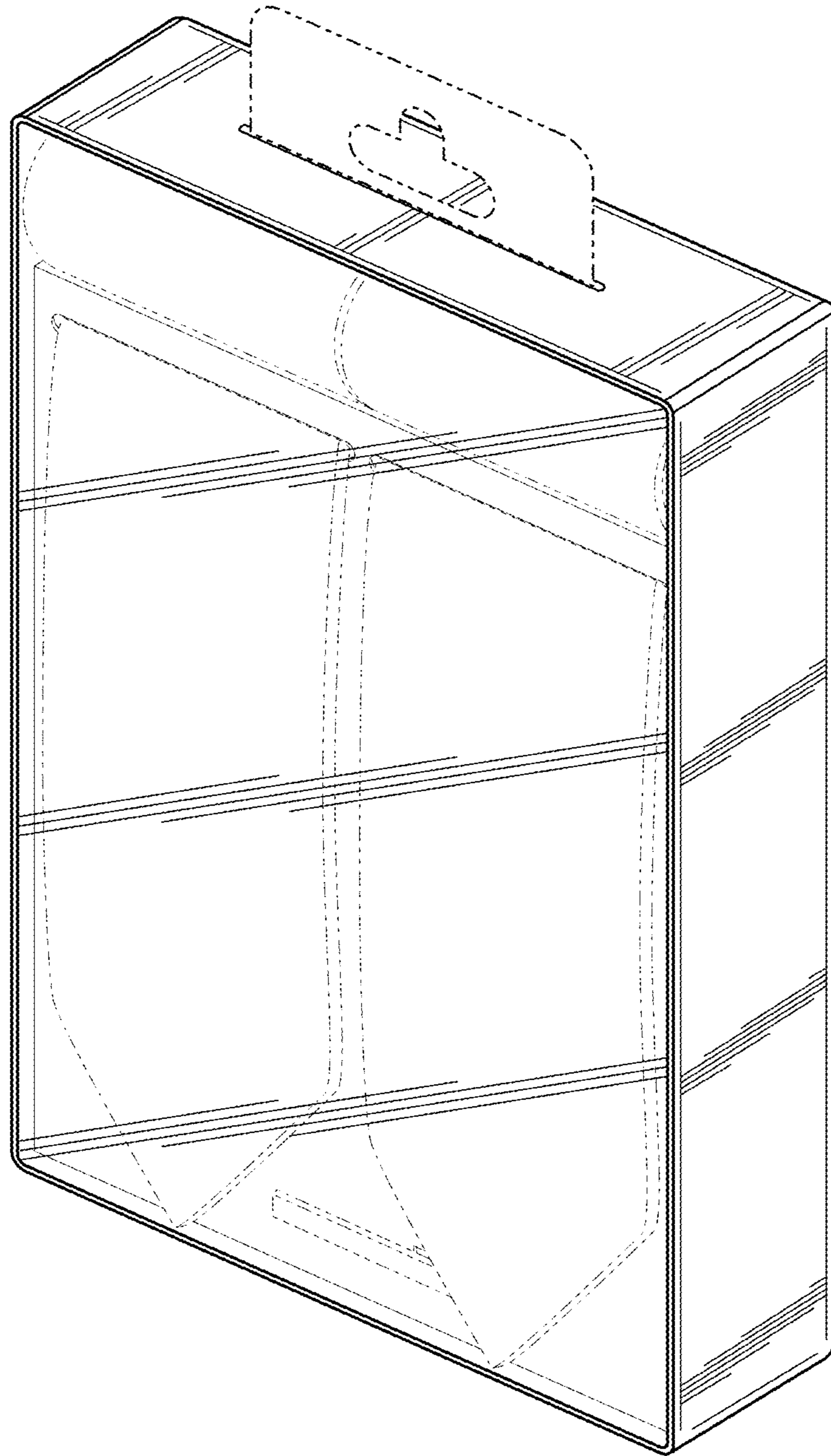
