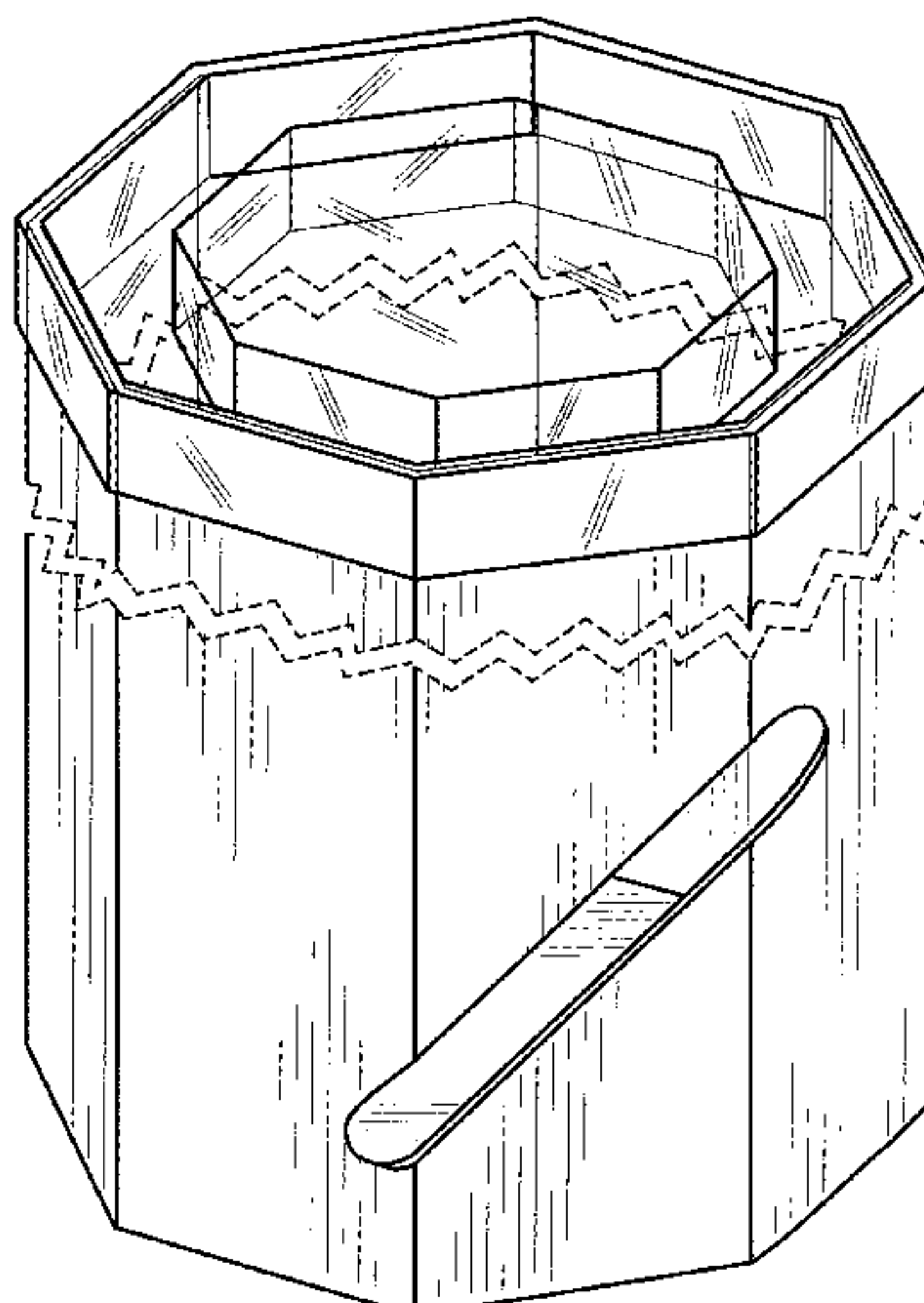
(57) **CLAIM**

The ornamental design for an octagonally shaped product container, as shown and described.

DESCRIPTION

FIG. 1 is an upper left front perspective view of an octagonally shaped product container;
FIG. 2 is a front elevational view of an octagonally shaped product container;
FIG. 3 is a right side elevational view of an octagonally shaped product container;
FIG. 4 is a rear elevational view of an octagonally shaped product container;
FIG. 5 is a left side elevational view of an octagonally shaped product container;
FIG. 6 is a top plan view of an octagonally shaped product container;
FIG. 7 is a bottom plan view of an octagonally shaped product container; and,
FIG. 8 is an enlarged sectional view of an octagonally shaped product container, taken along line 8-8 in FIG. 6.
The jagged broken lines in the drawings indicate that the appearance of any portion of the article between the break lines forms no part of the claimed design.

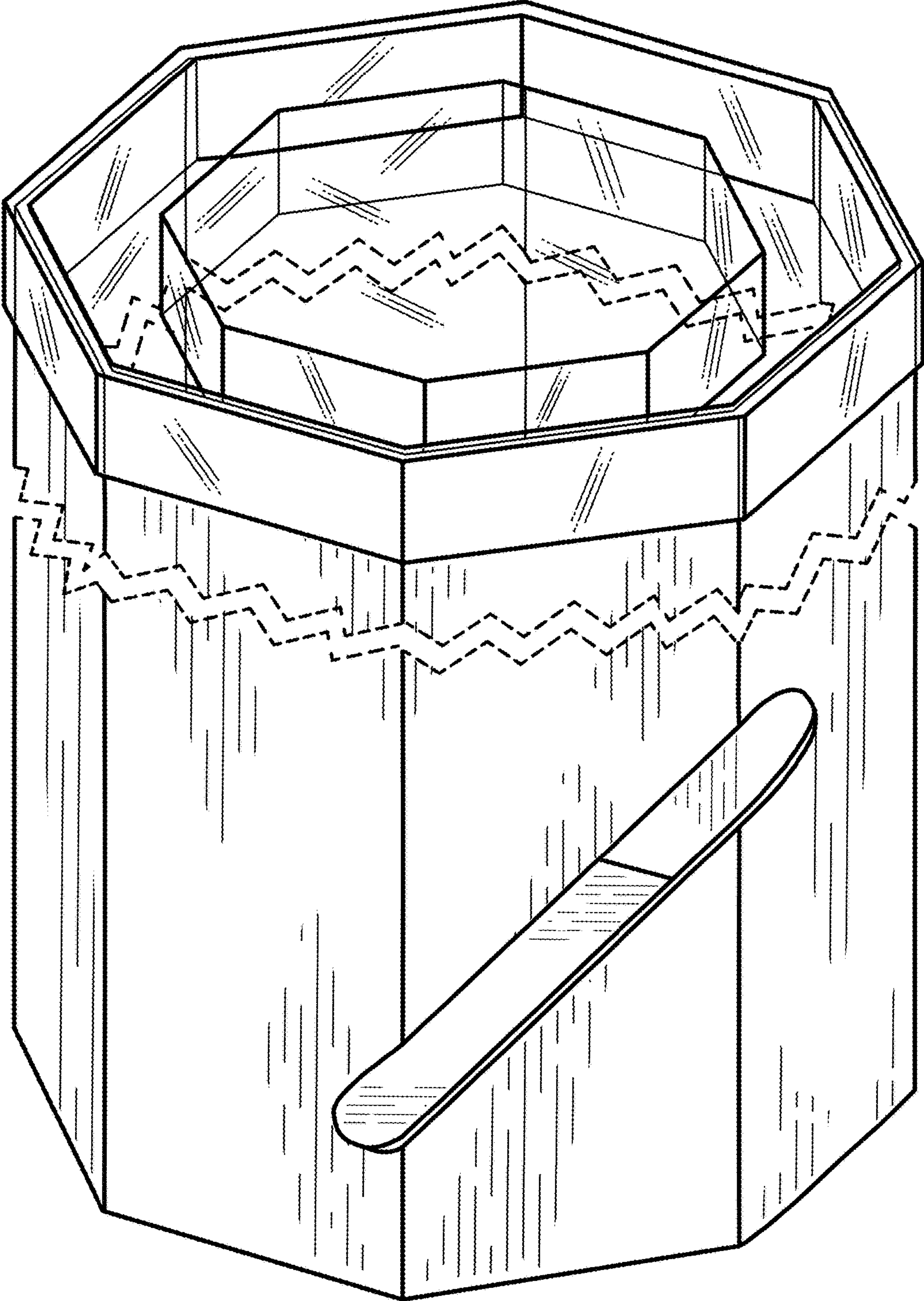

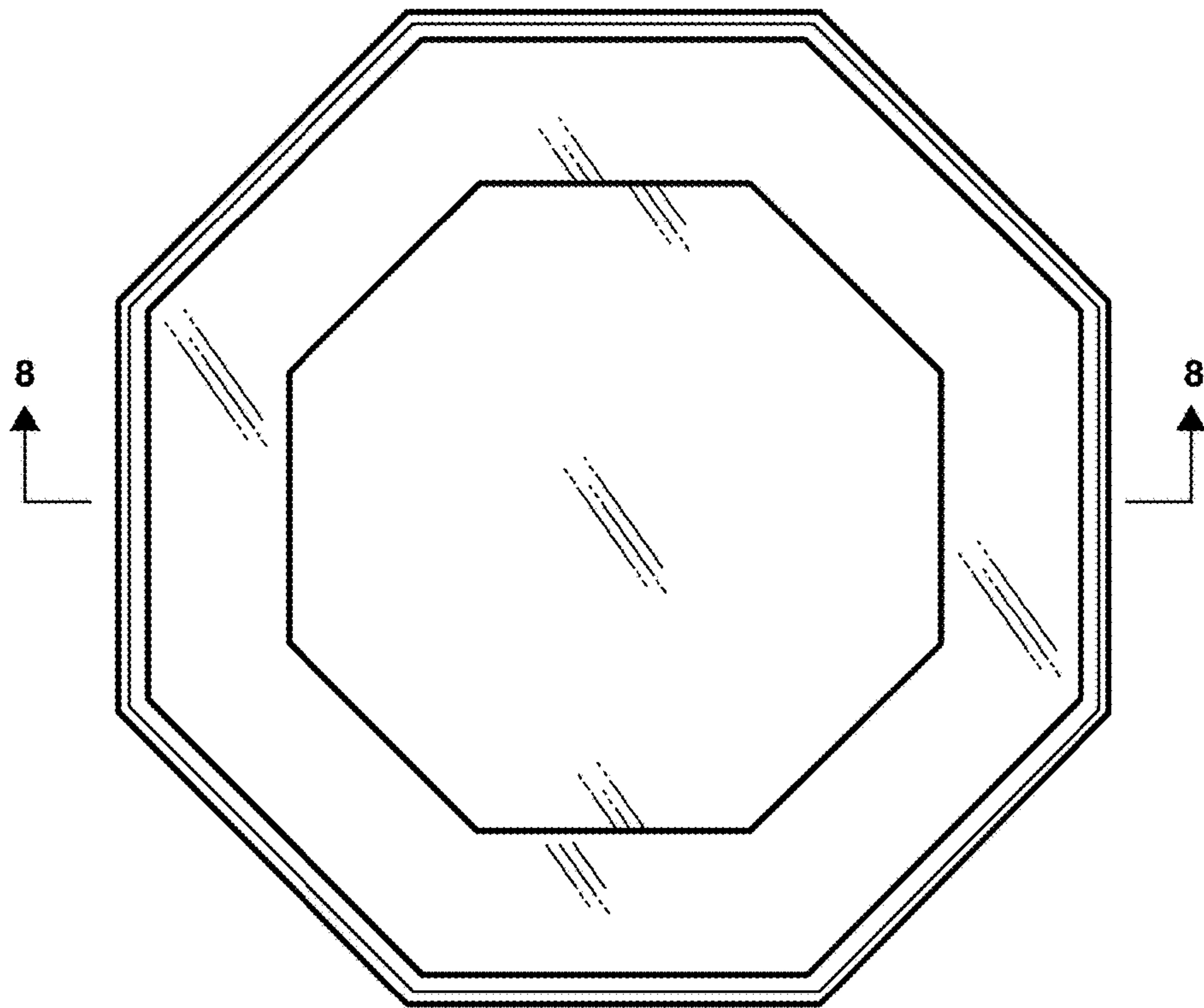

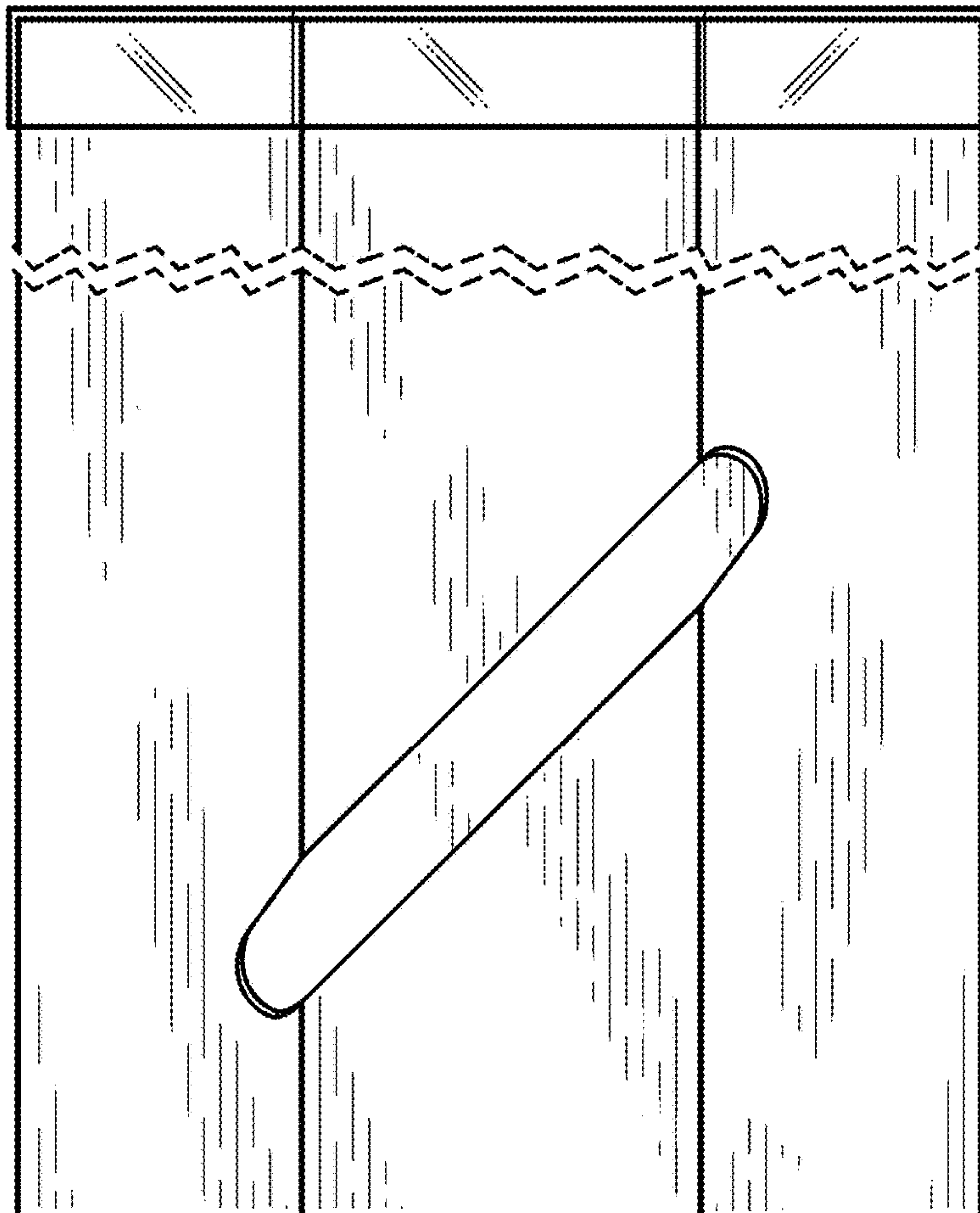

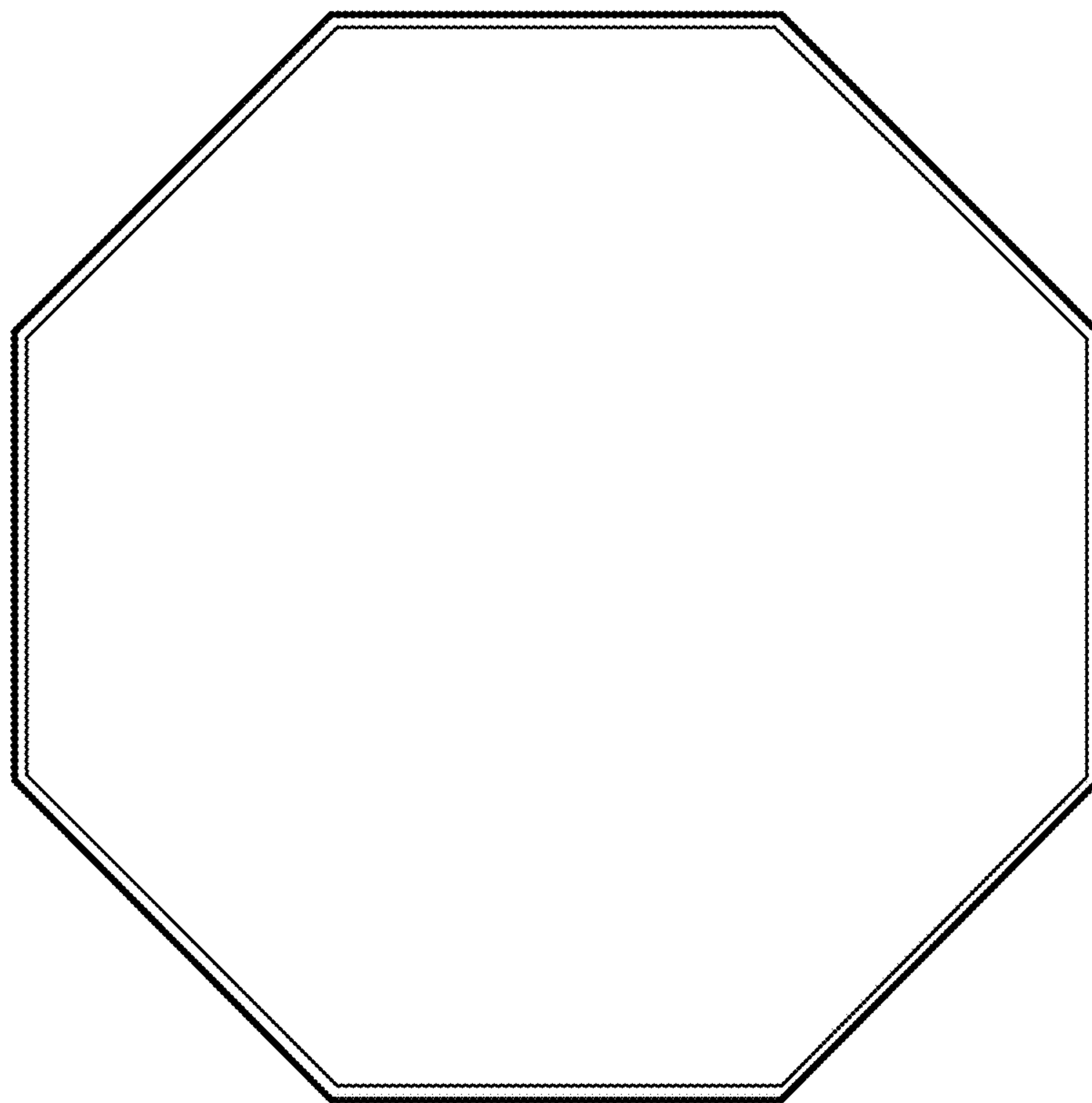
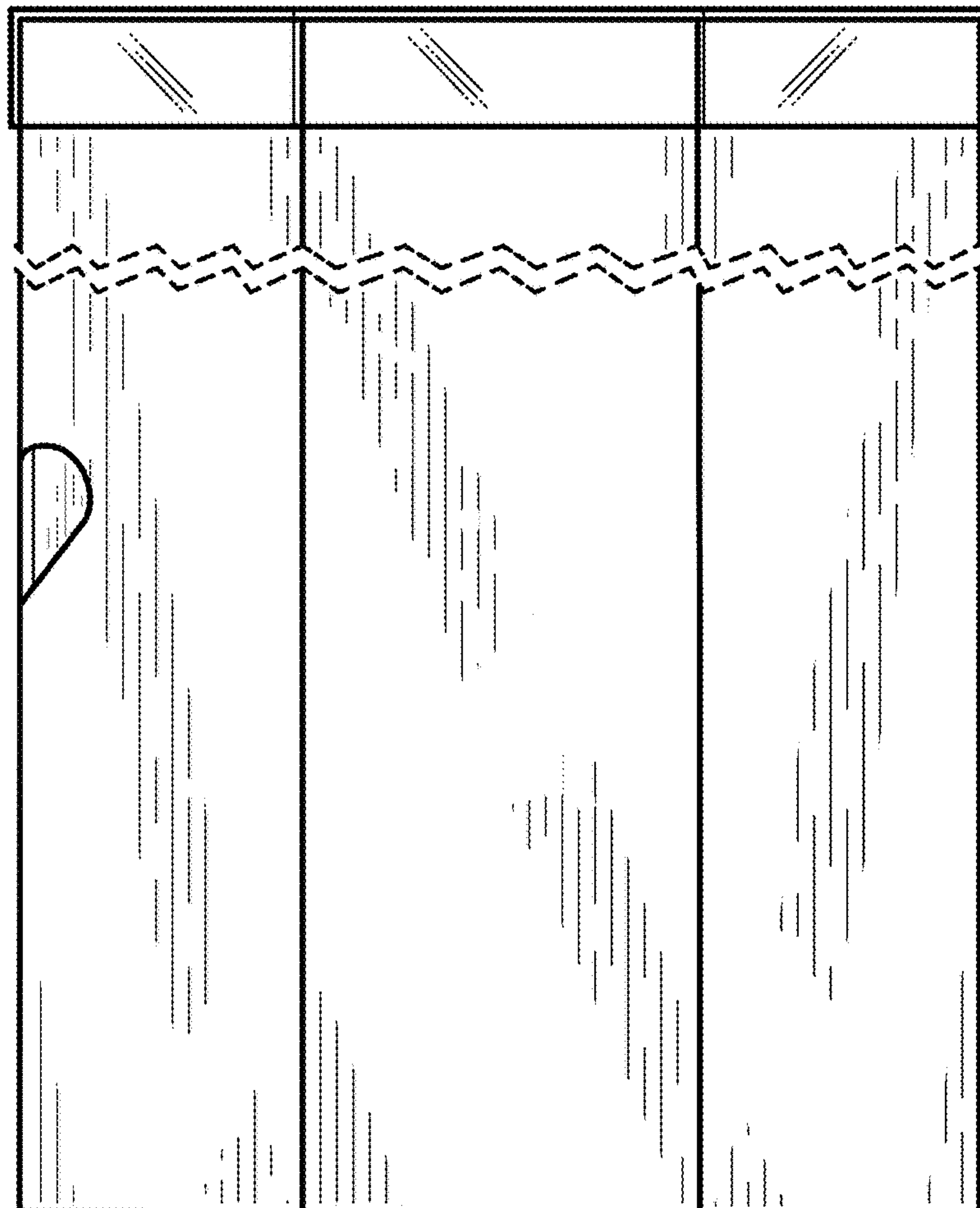

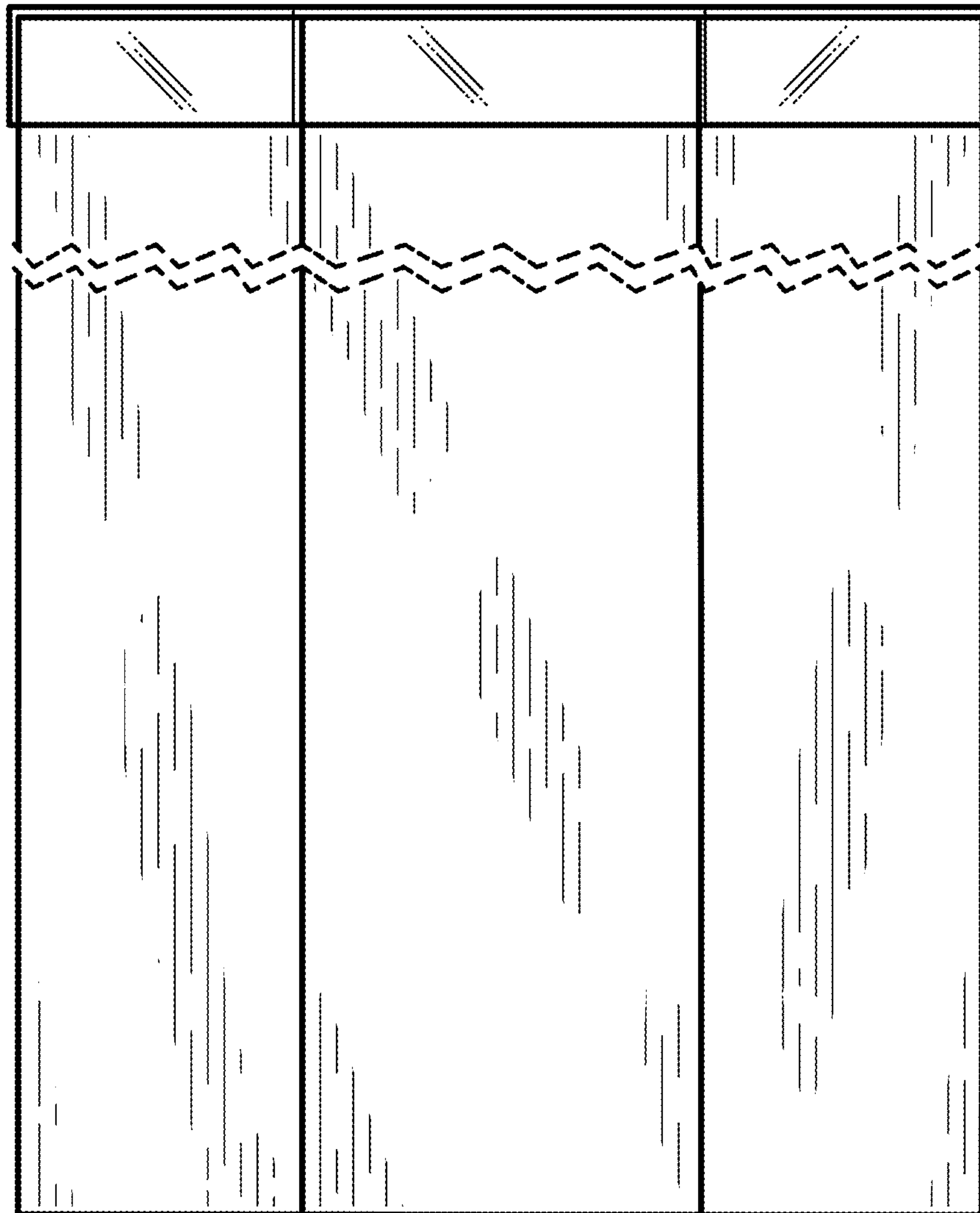

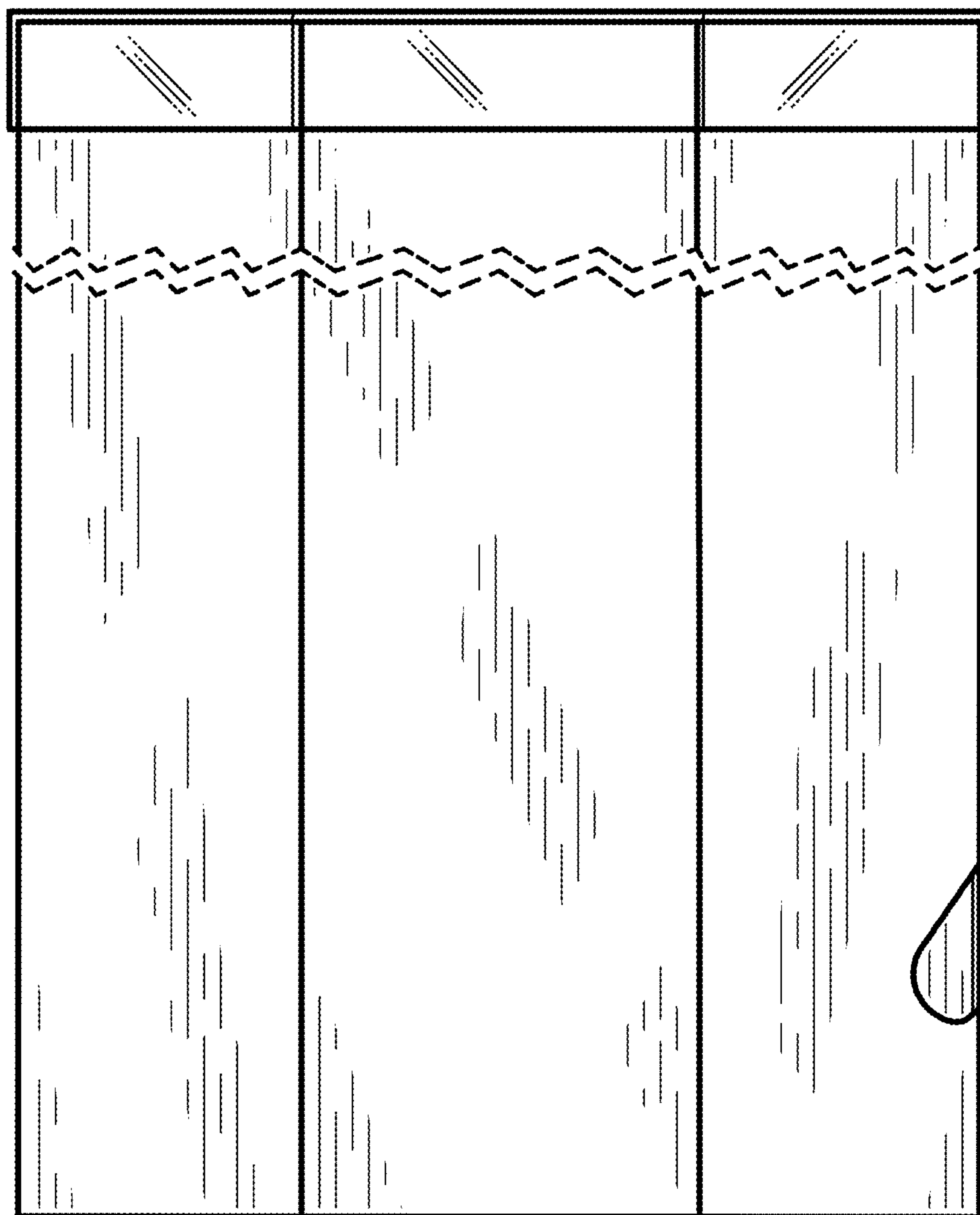

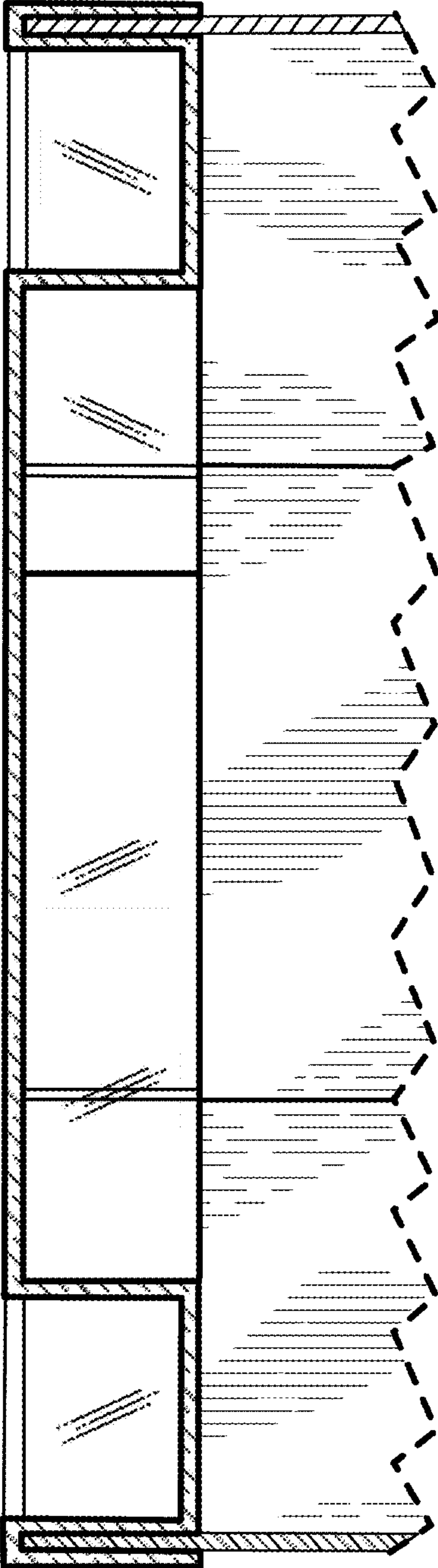
