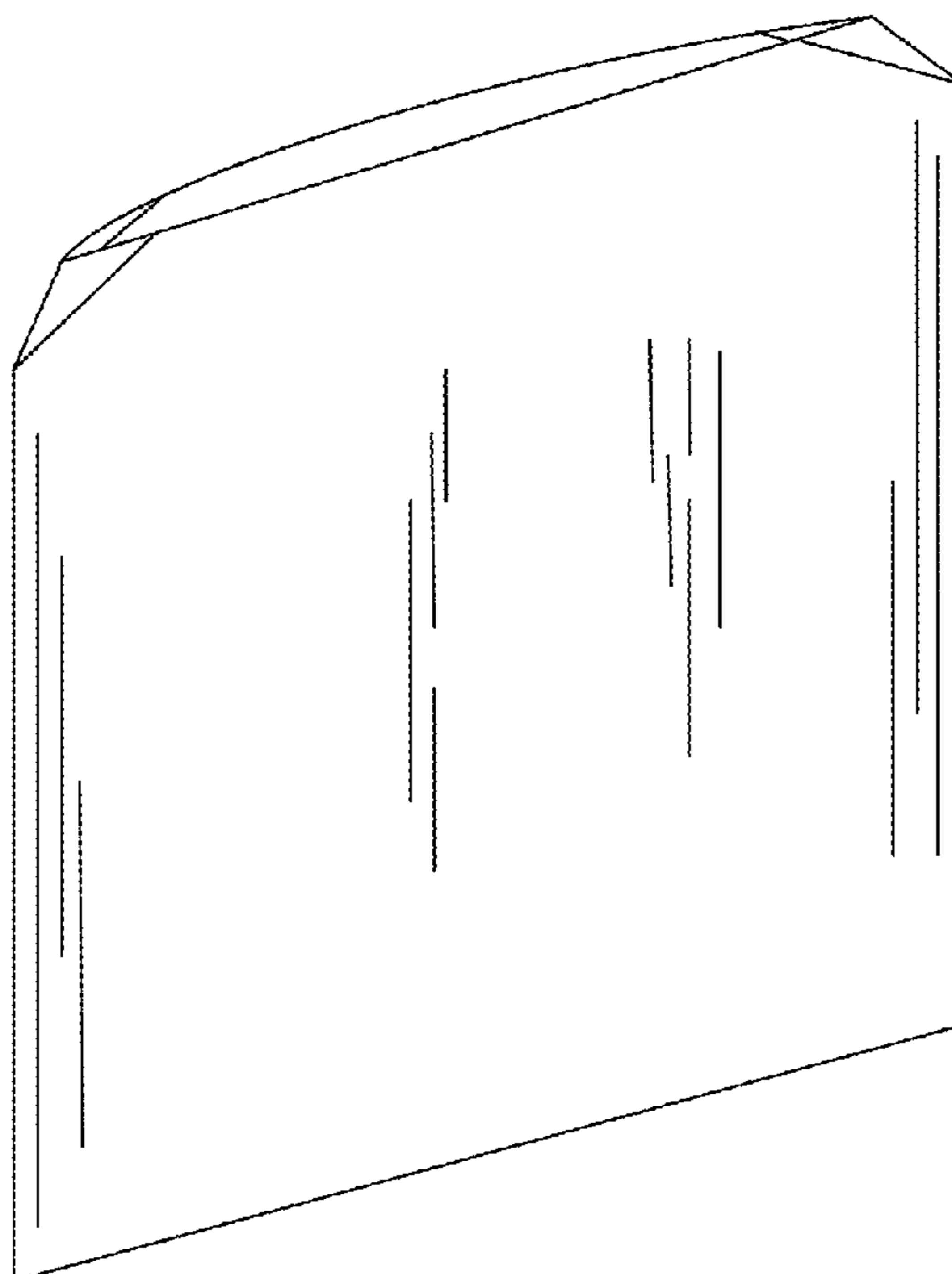
(57) **CLAIM**

I claim the ornamental design for a trash bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a trash bag showing my new design;
FIG. 2 is a front view, the rear view being a mirror image thereof;
FIG. 3 is a side view, the other side being a mirror image thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a front view of the trash bag showing its usage state.
The broken line showing of trash bin and fingers expanding the trash bag is for illustrative purposes only and forms no part of the claimed design.

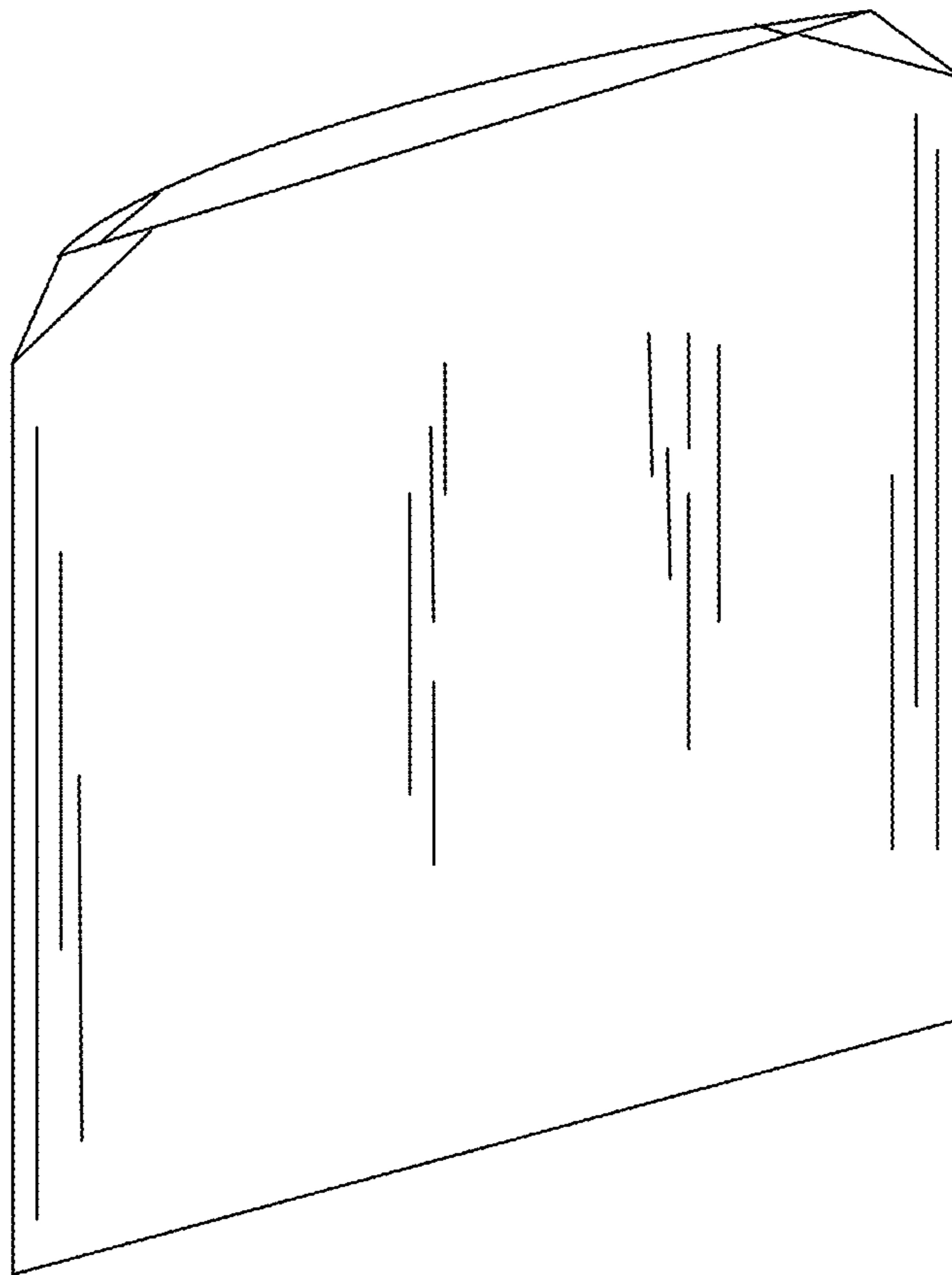

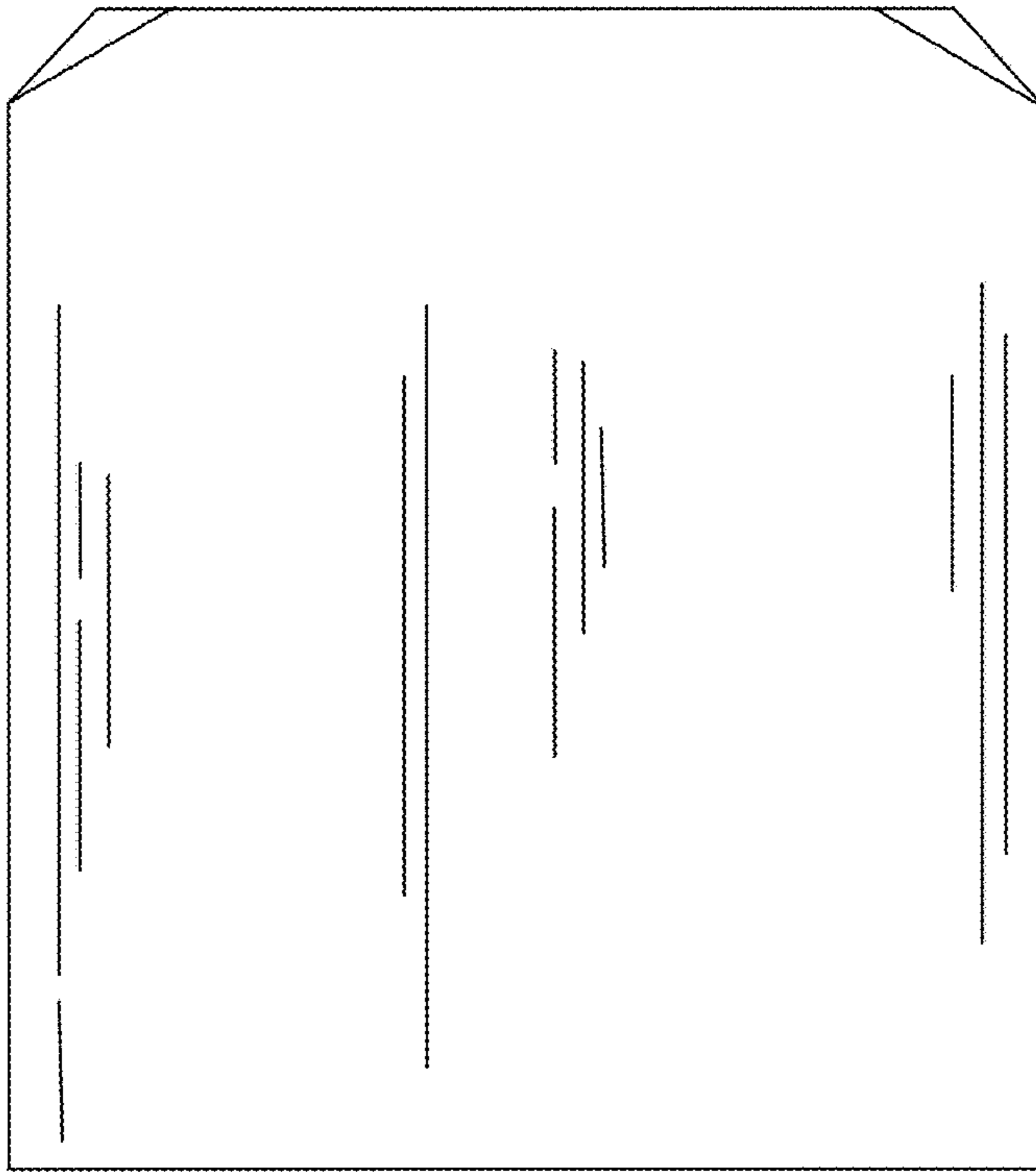

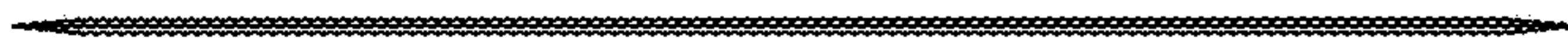

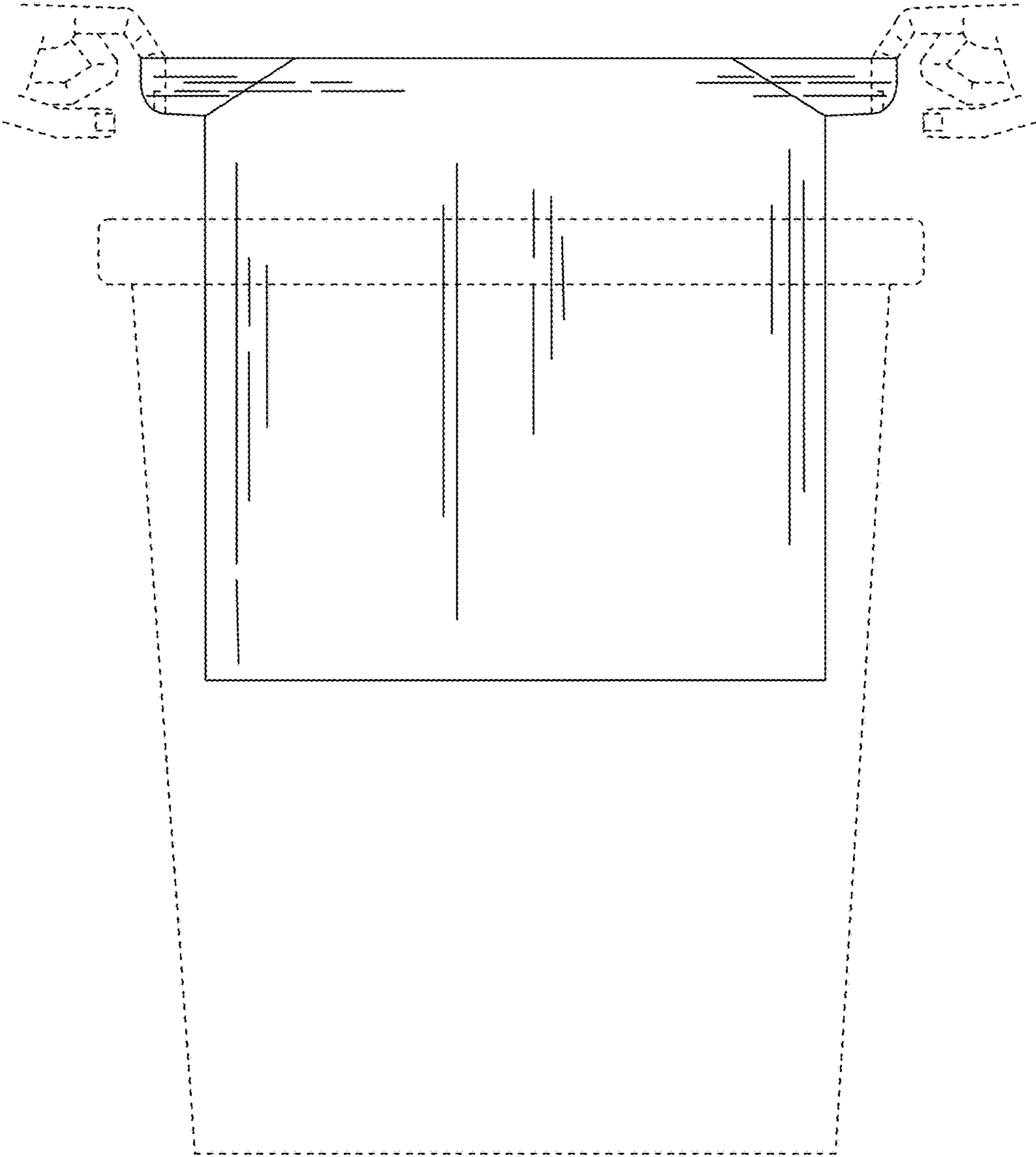
