We claim the ornamental design for an automobile grille or representation thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-right, isometric view of an automobile grille or representation thereof in accordance with the present design.

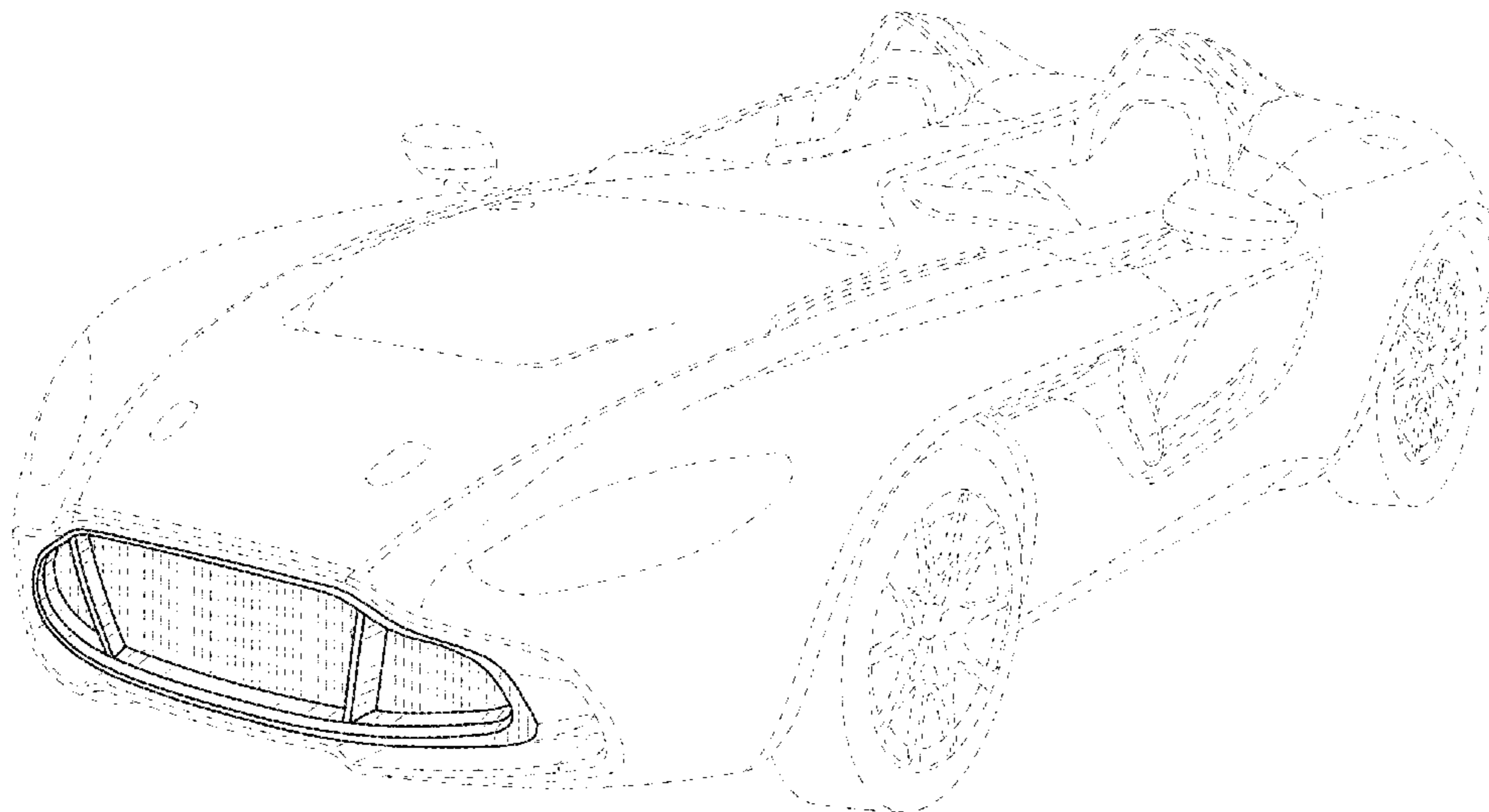
FIG. 2 is a right side elevation view thereof.

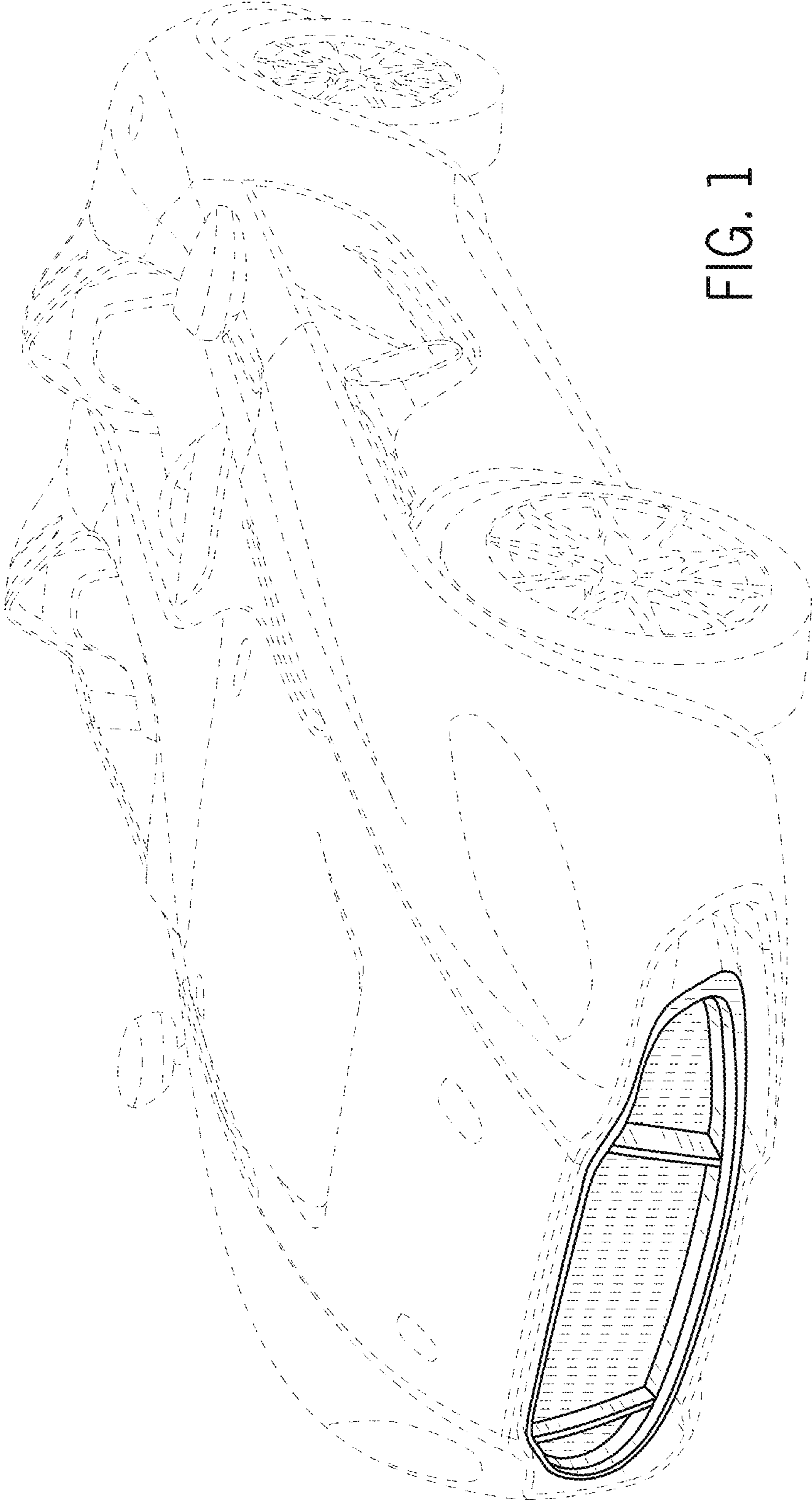

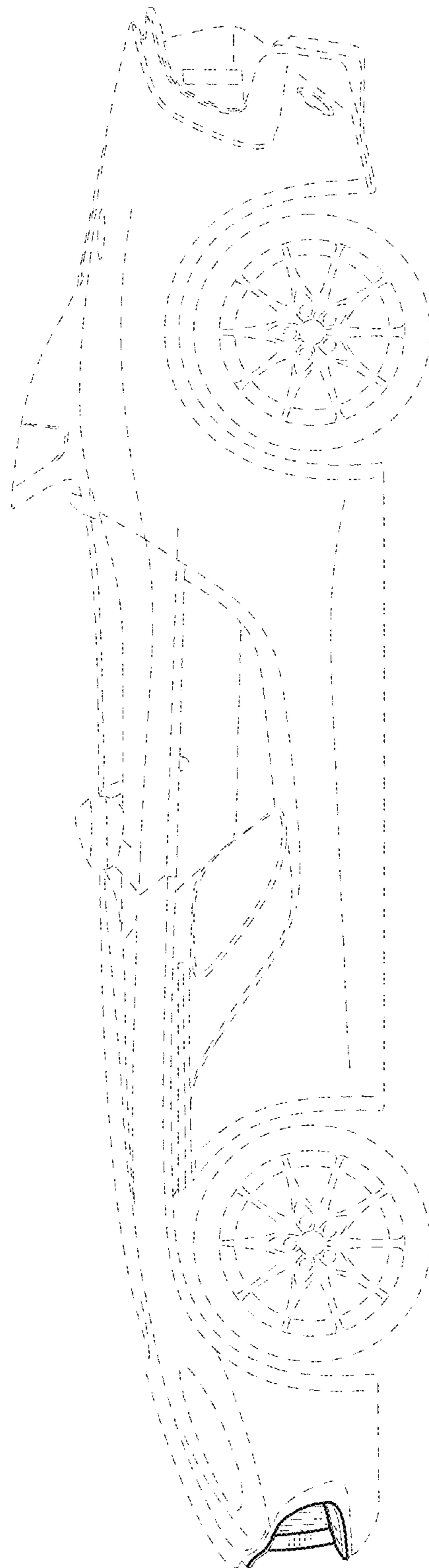

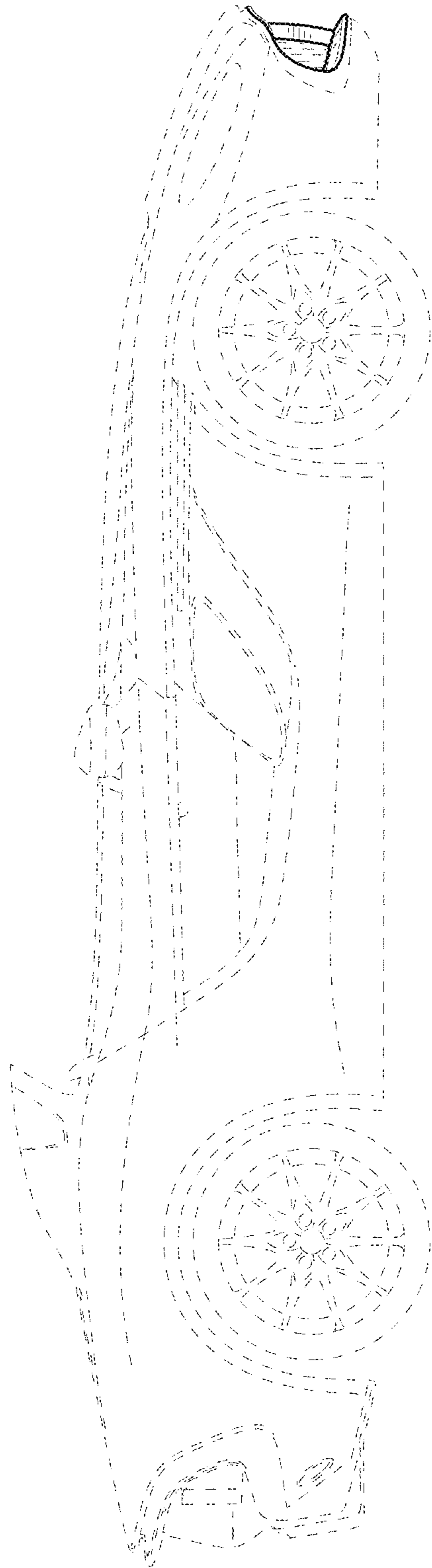

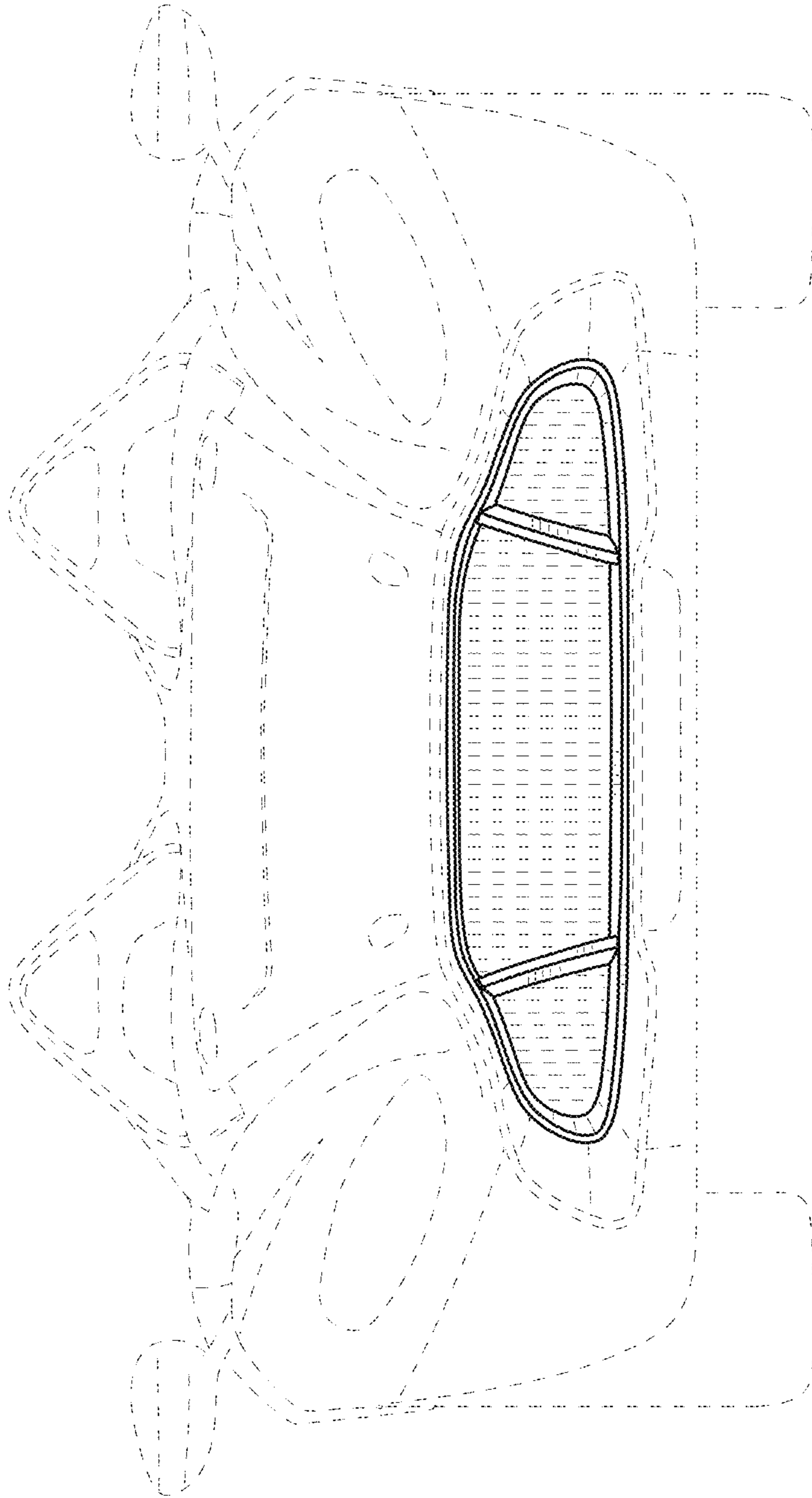
