(57) **CLAIM**

The ornamental design for a tread portion of an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tread portion of an automobile tire;

FIG. 2 is a front view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a partial front view of the tread shown enlarged for clarity of illustration;

FIG. 7 is a sectional view taken in the direction defined by line 7-7 in FIG. 6; and,

FIG. 8 is a sectional view taken in the direction defined by line 8-8 in FIG. 6.

The broken lines illustrate portions of the sidewall, bead, and interior surface of a tire, and form no part of the claimed design.

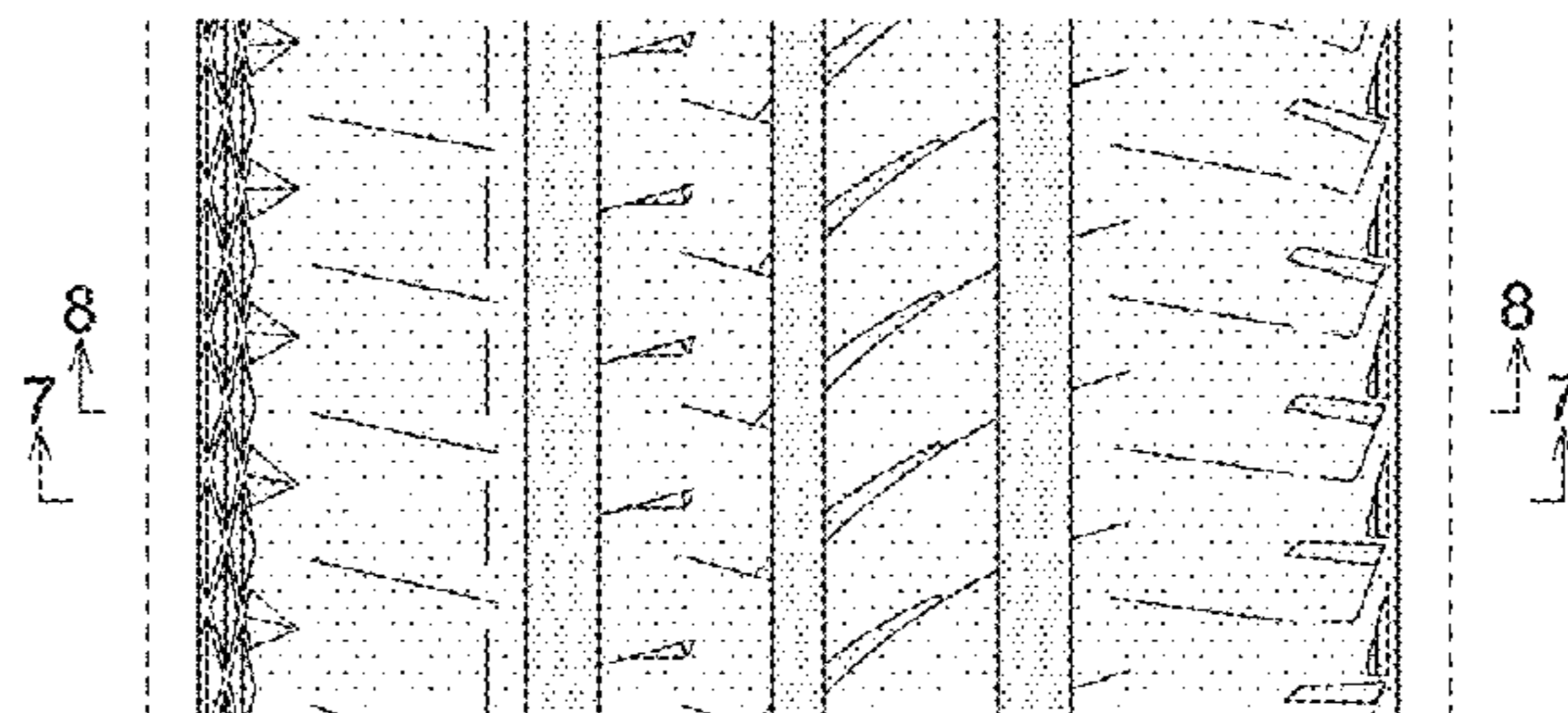
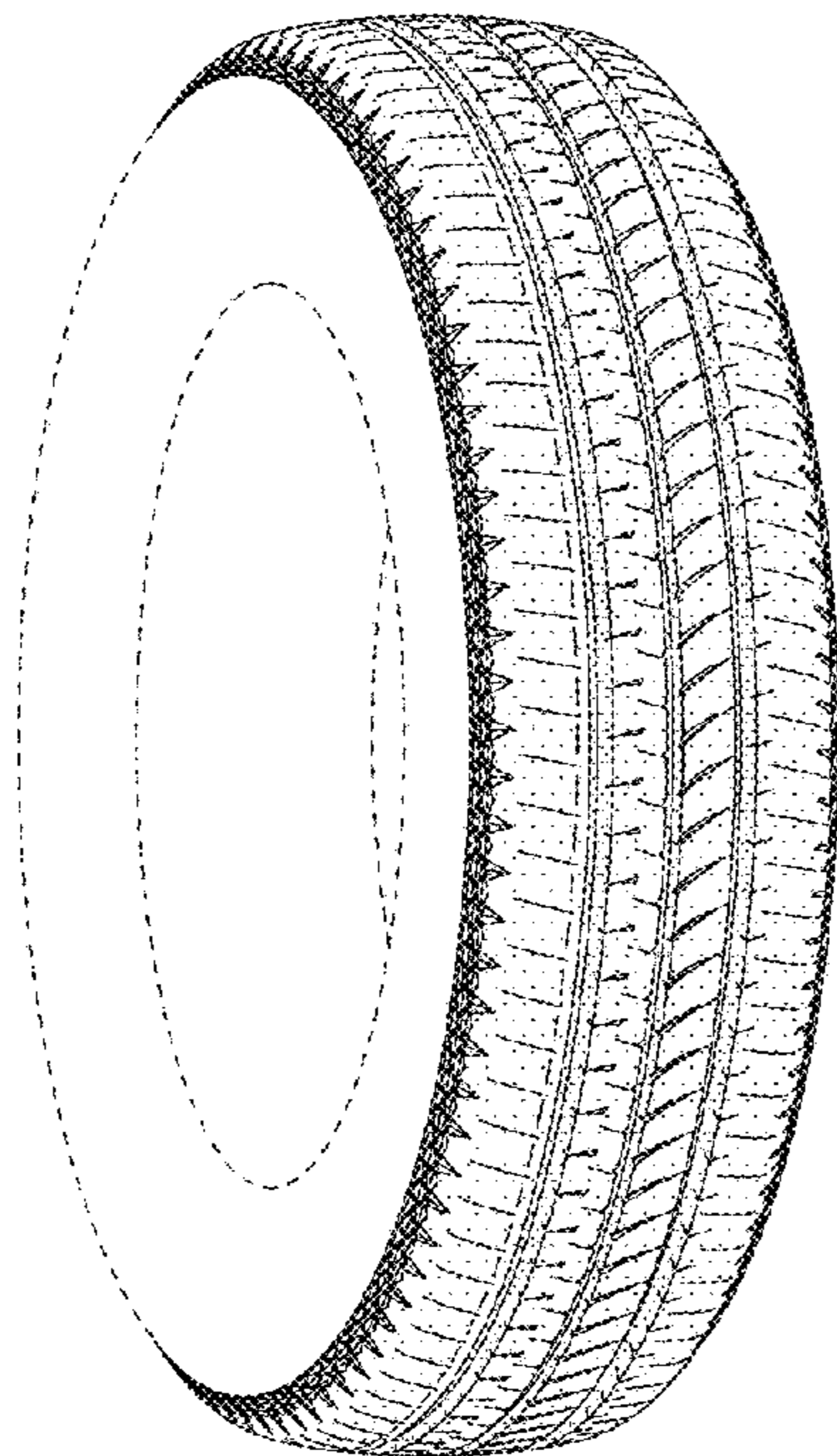

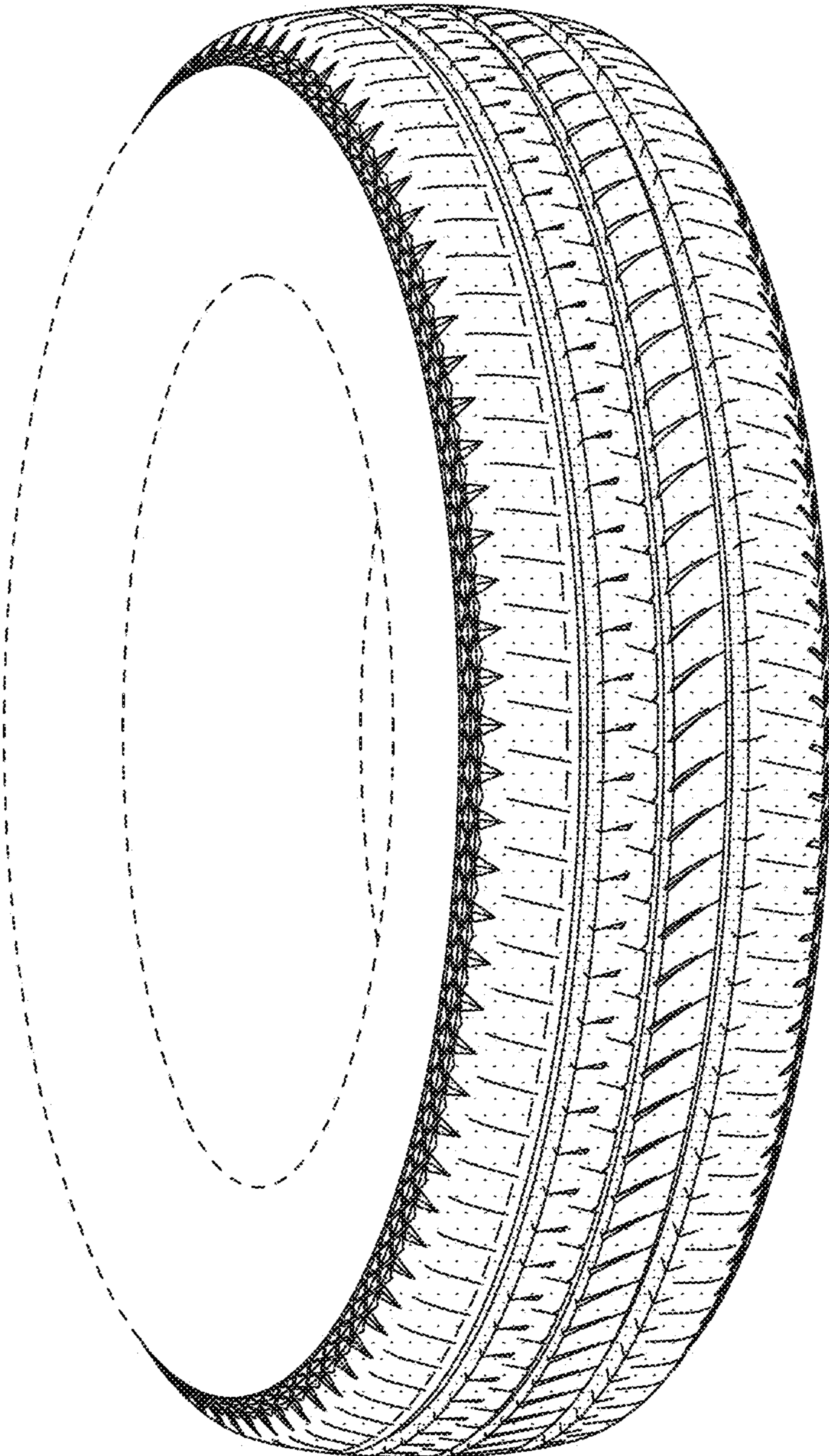

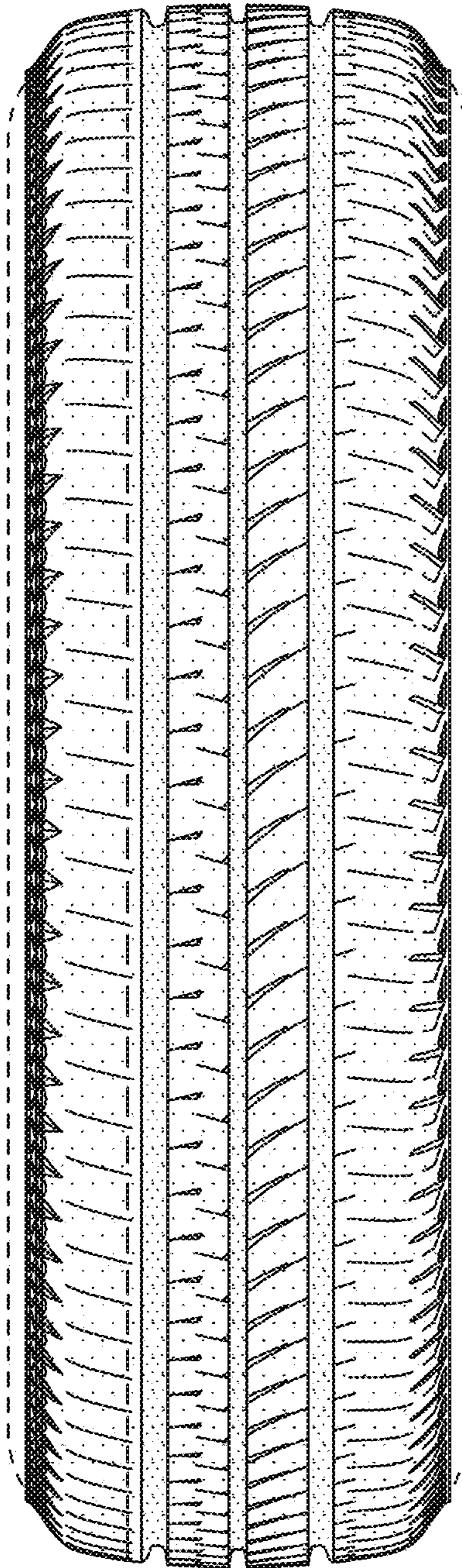

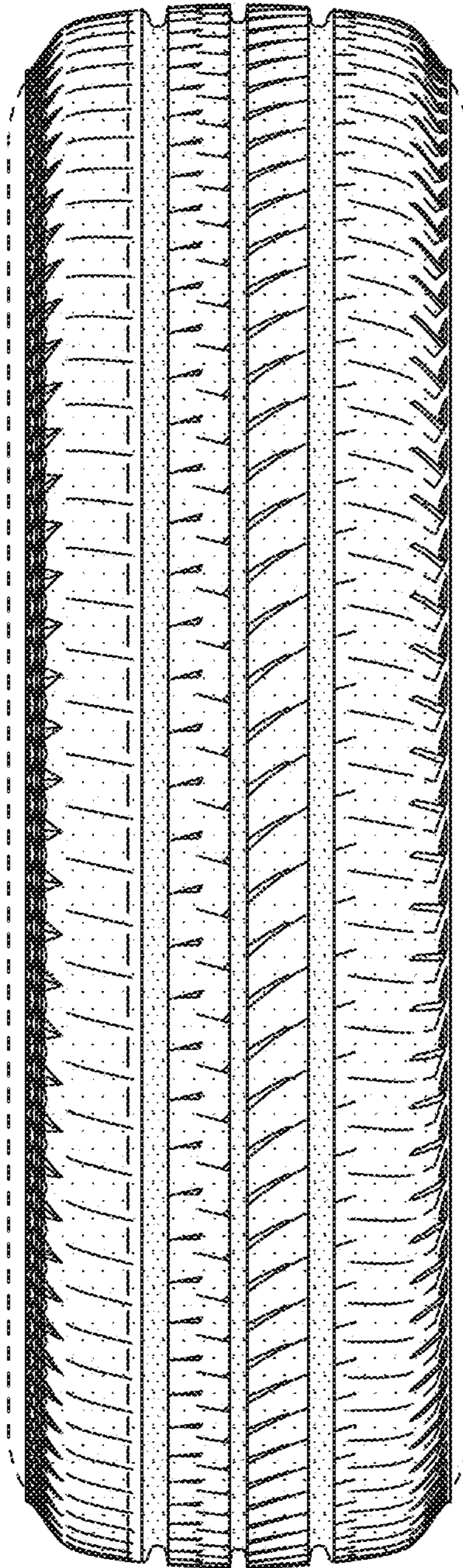

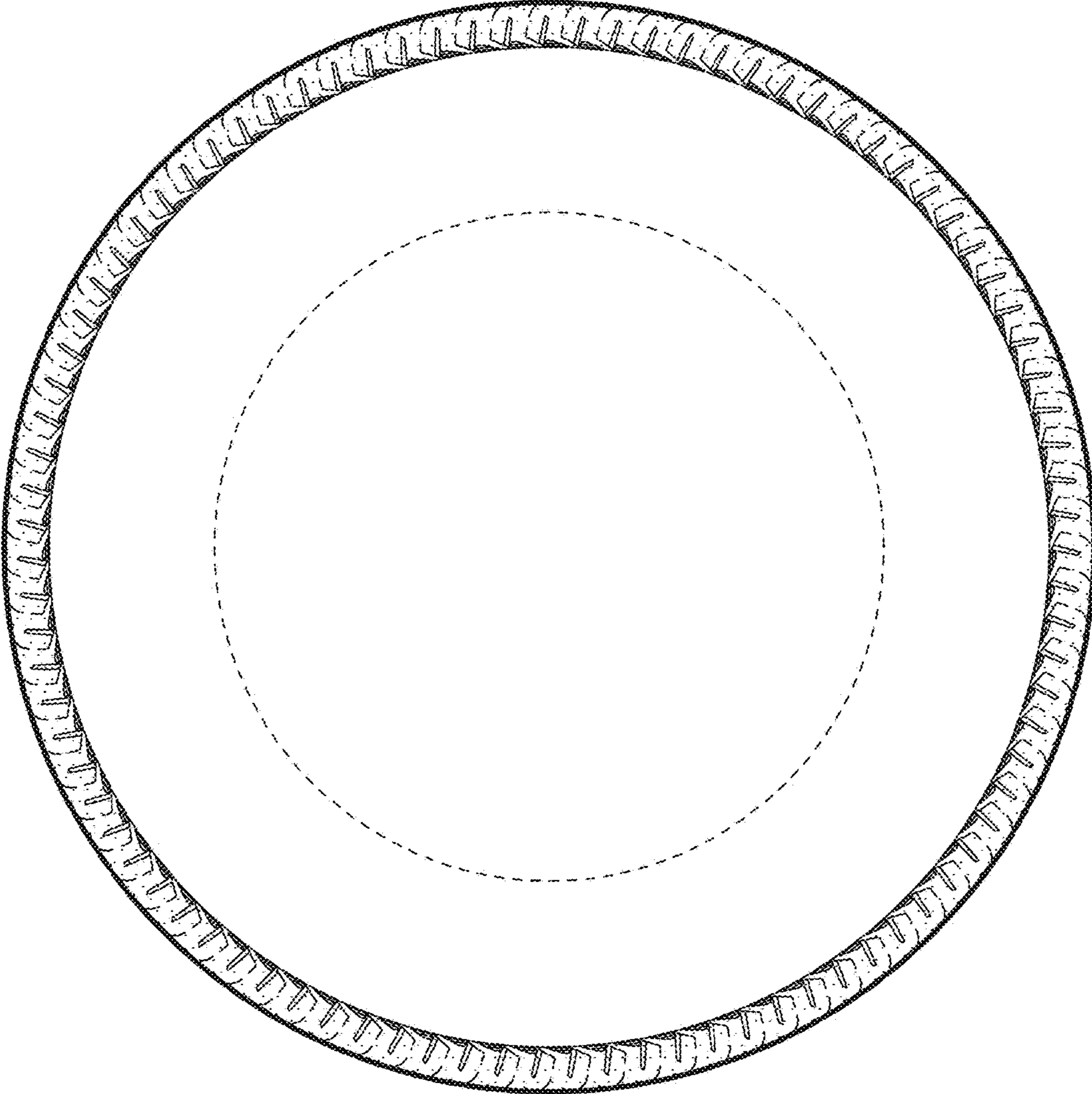

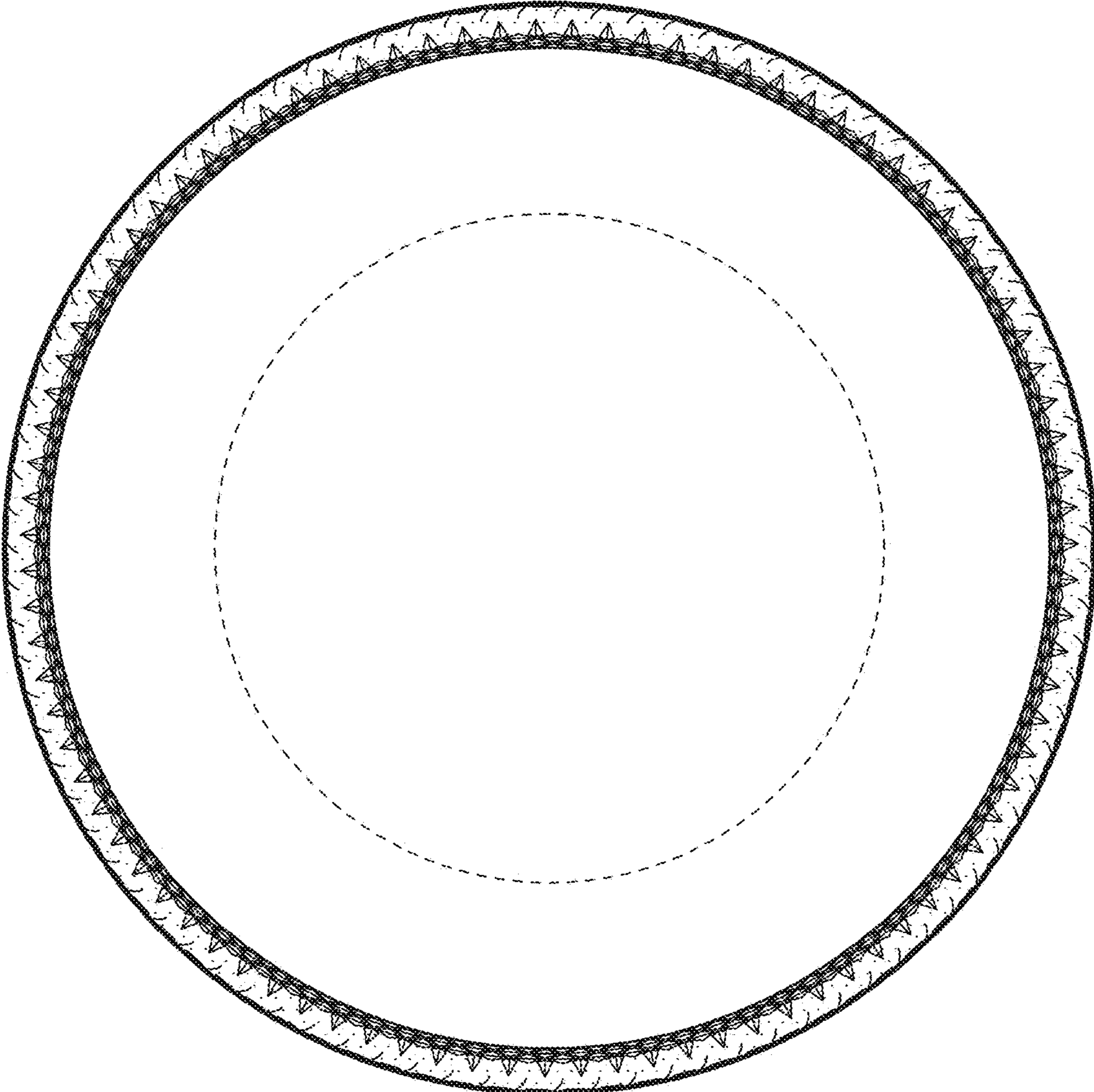

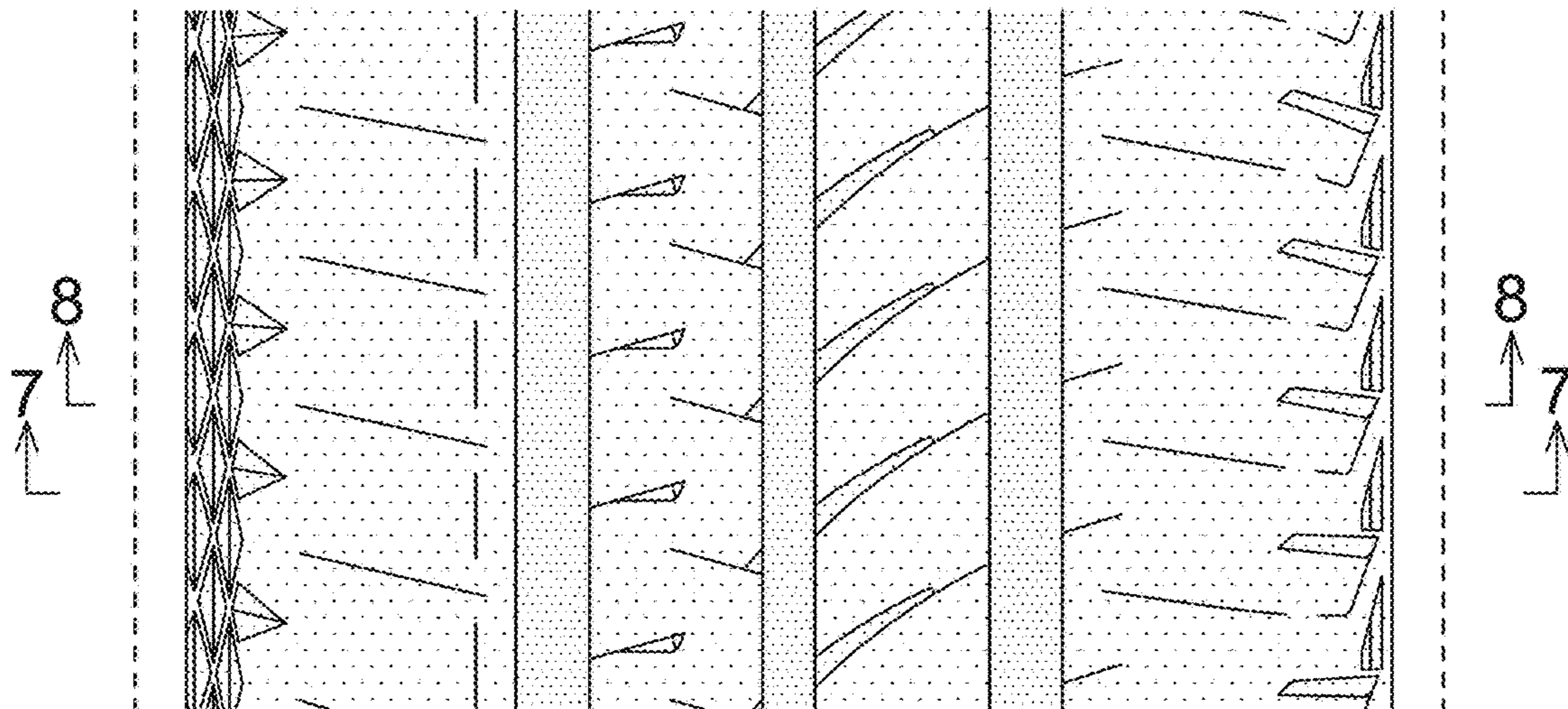

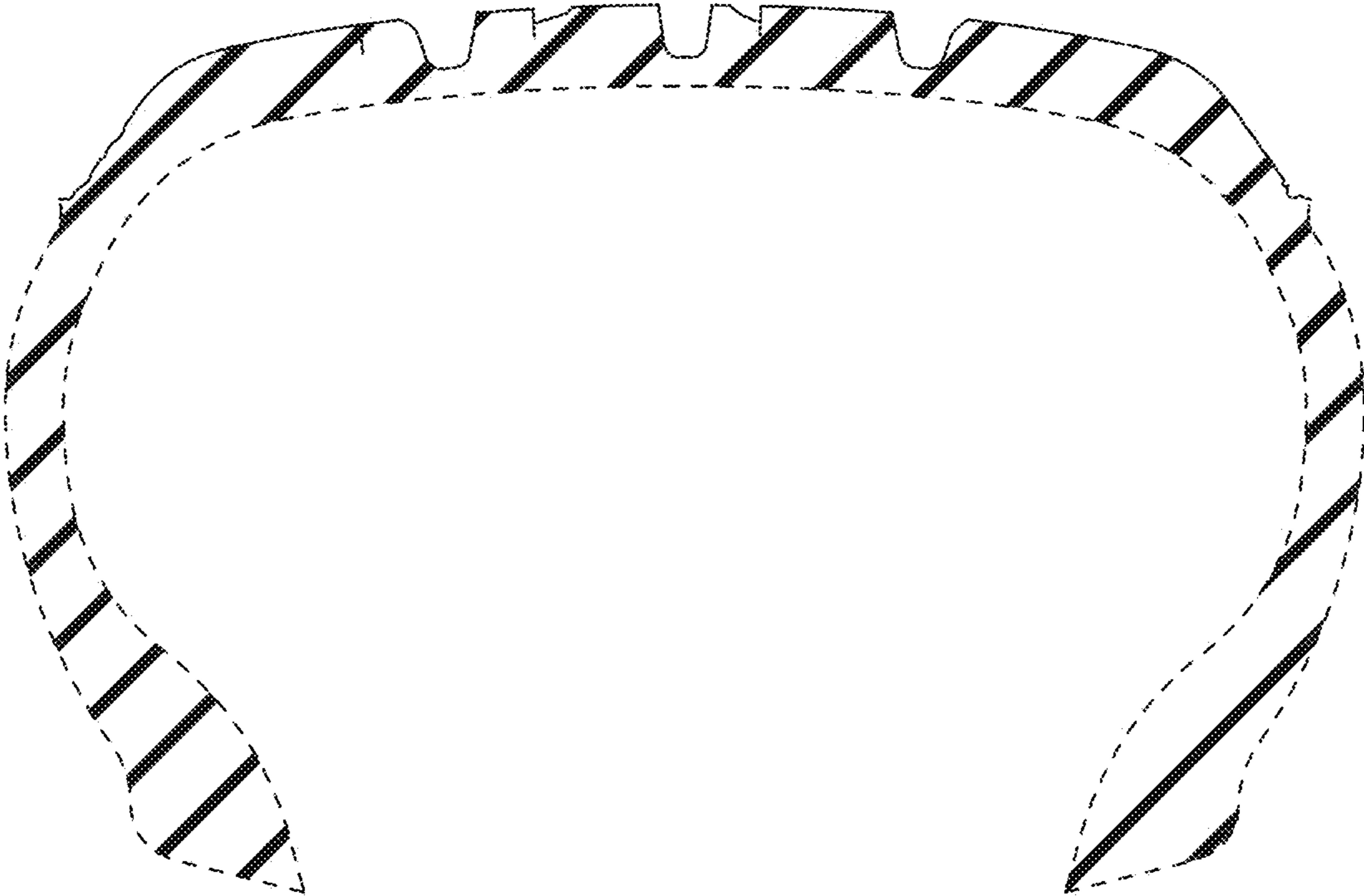
