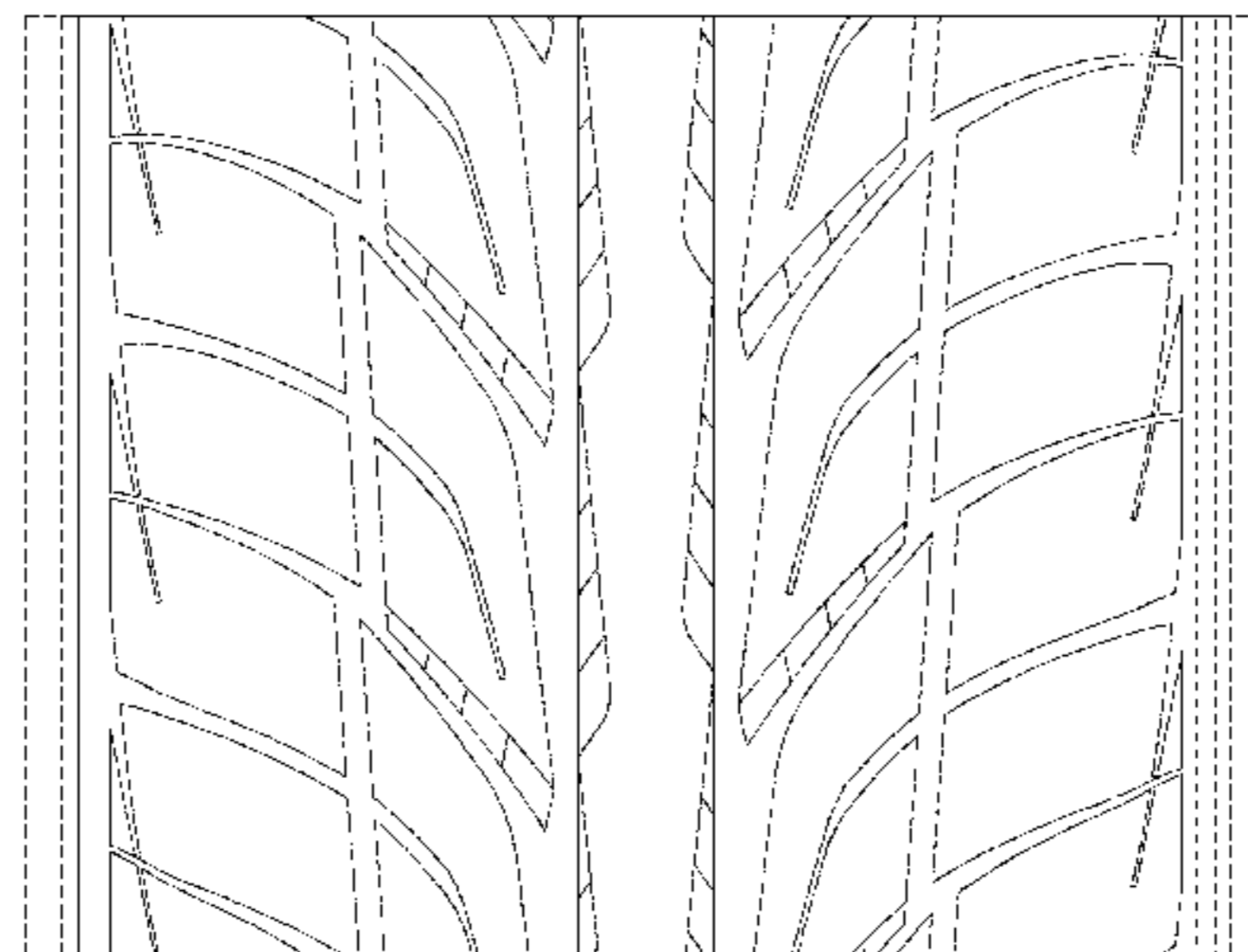
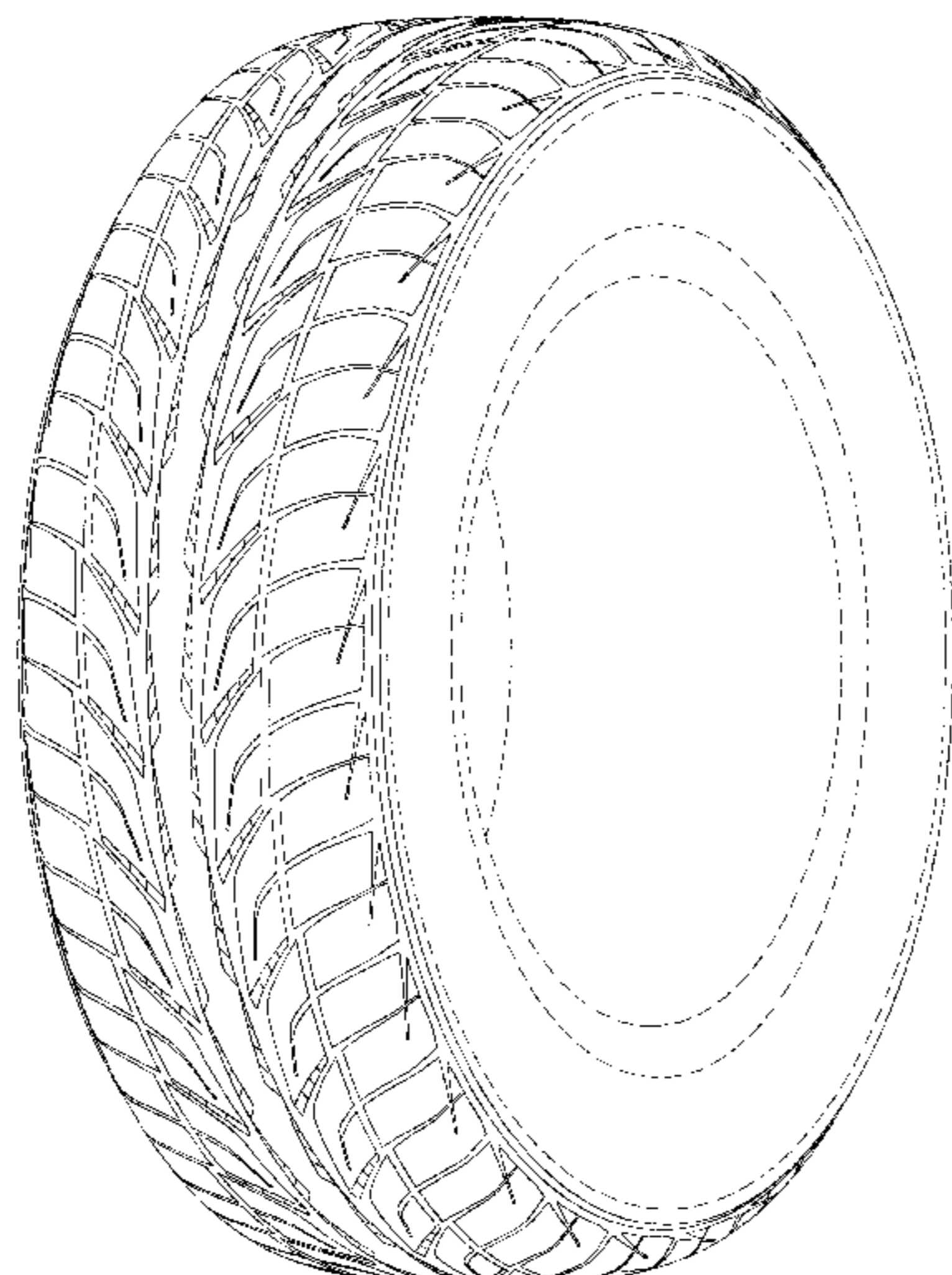
In the drawings, the broken lines showing portions of the sidewall and inner bead depict portions of the tire that form no part of the claimed design.

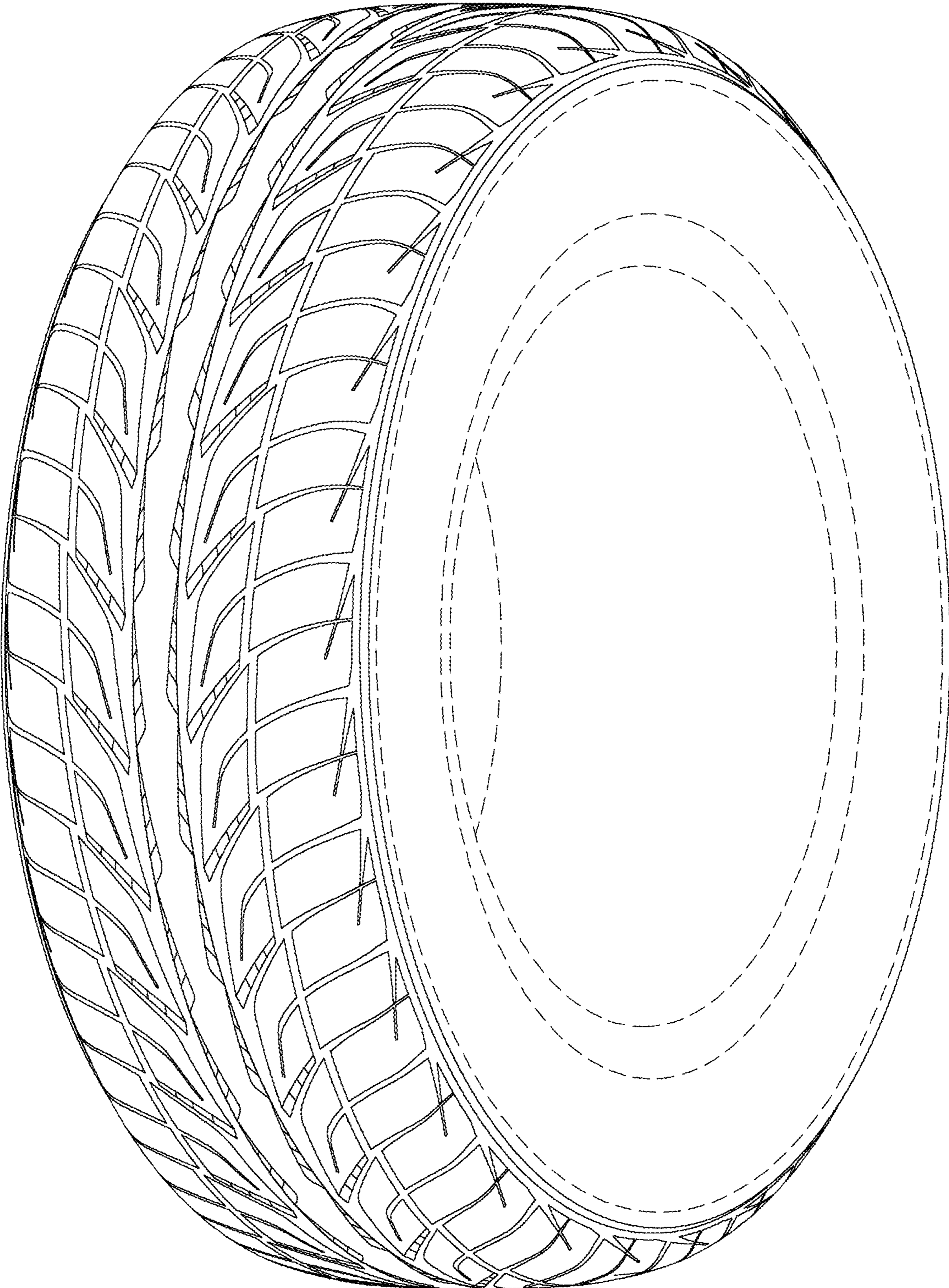

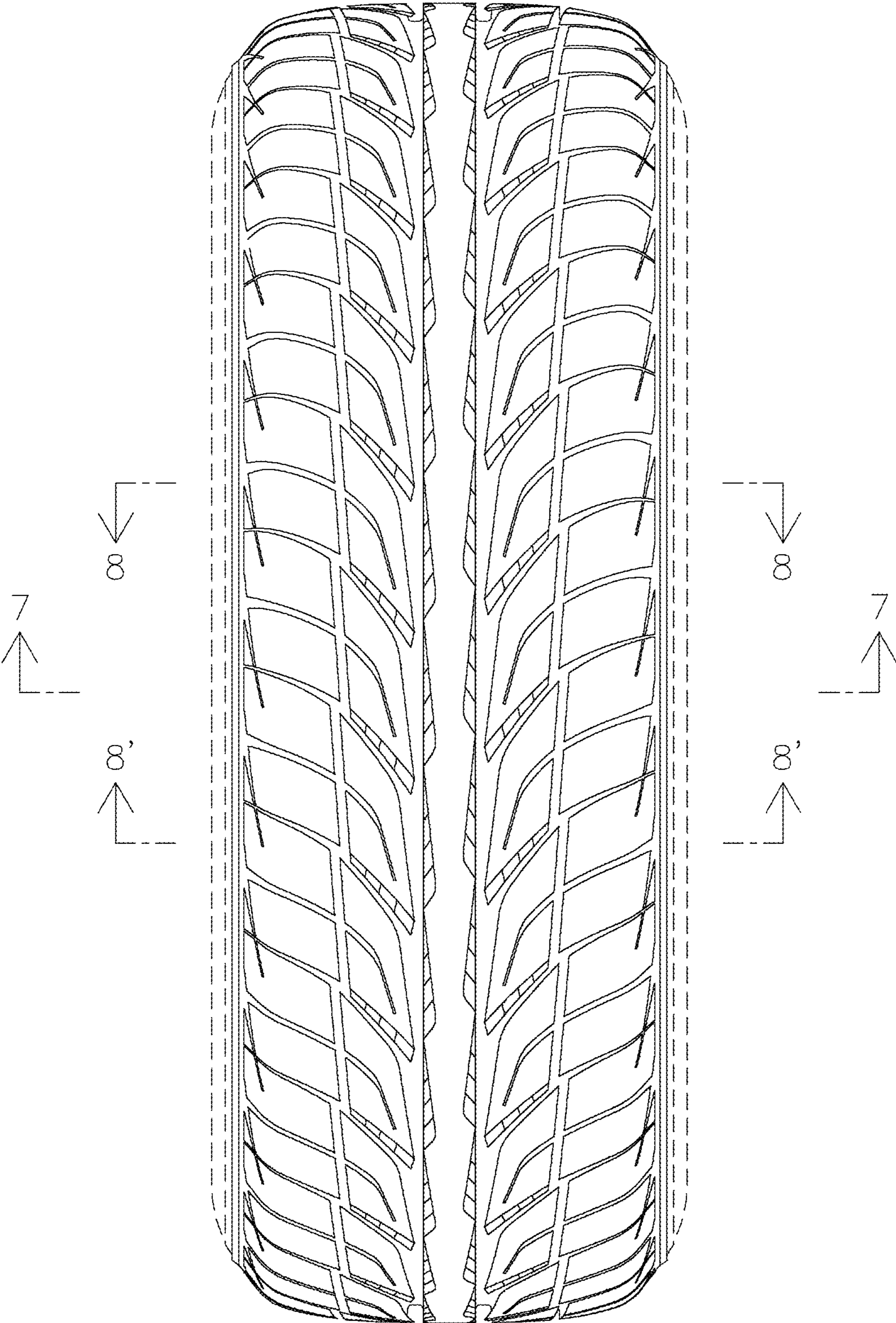

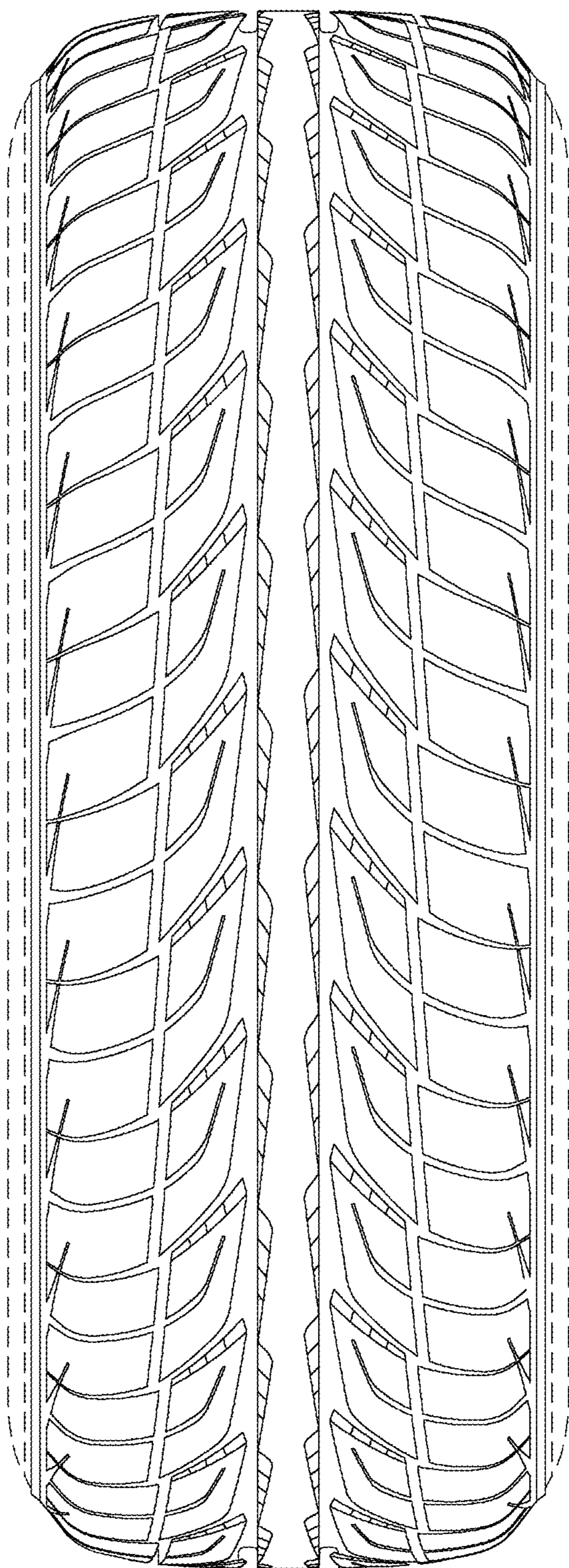

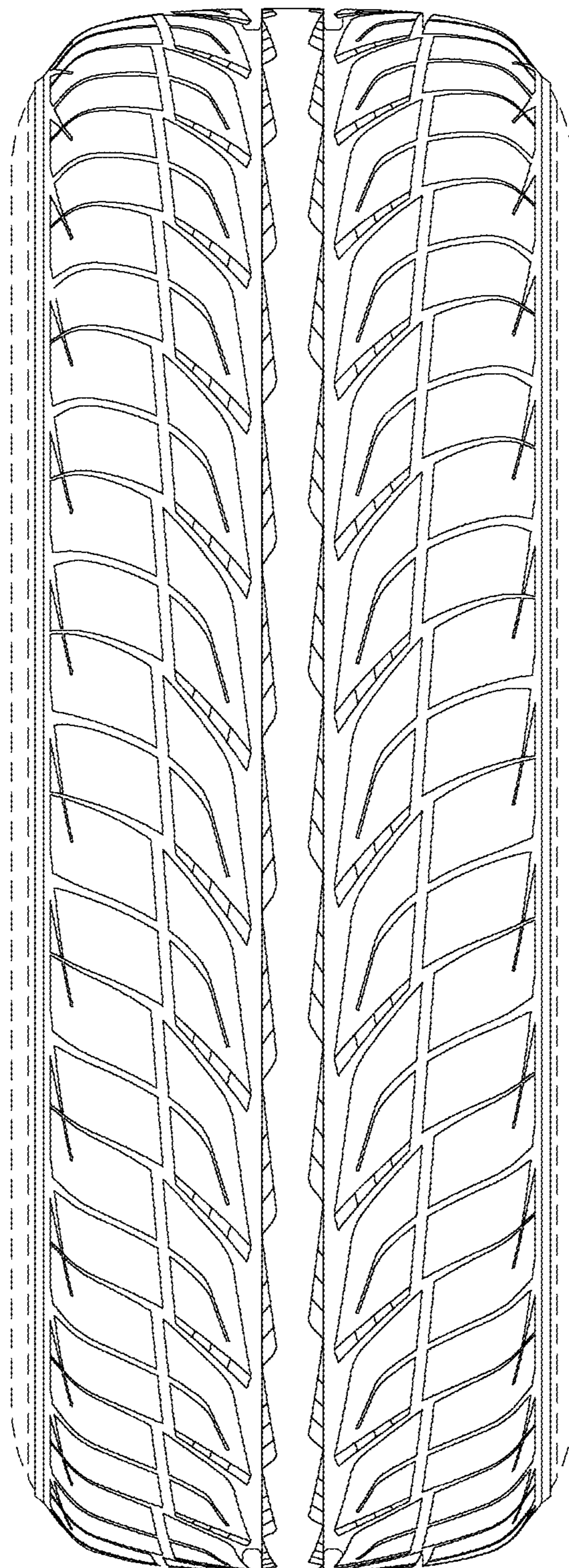

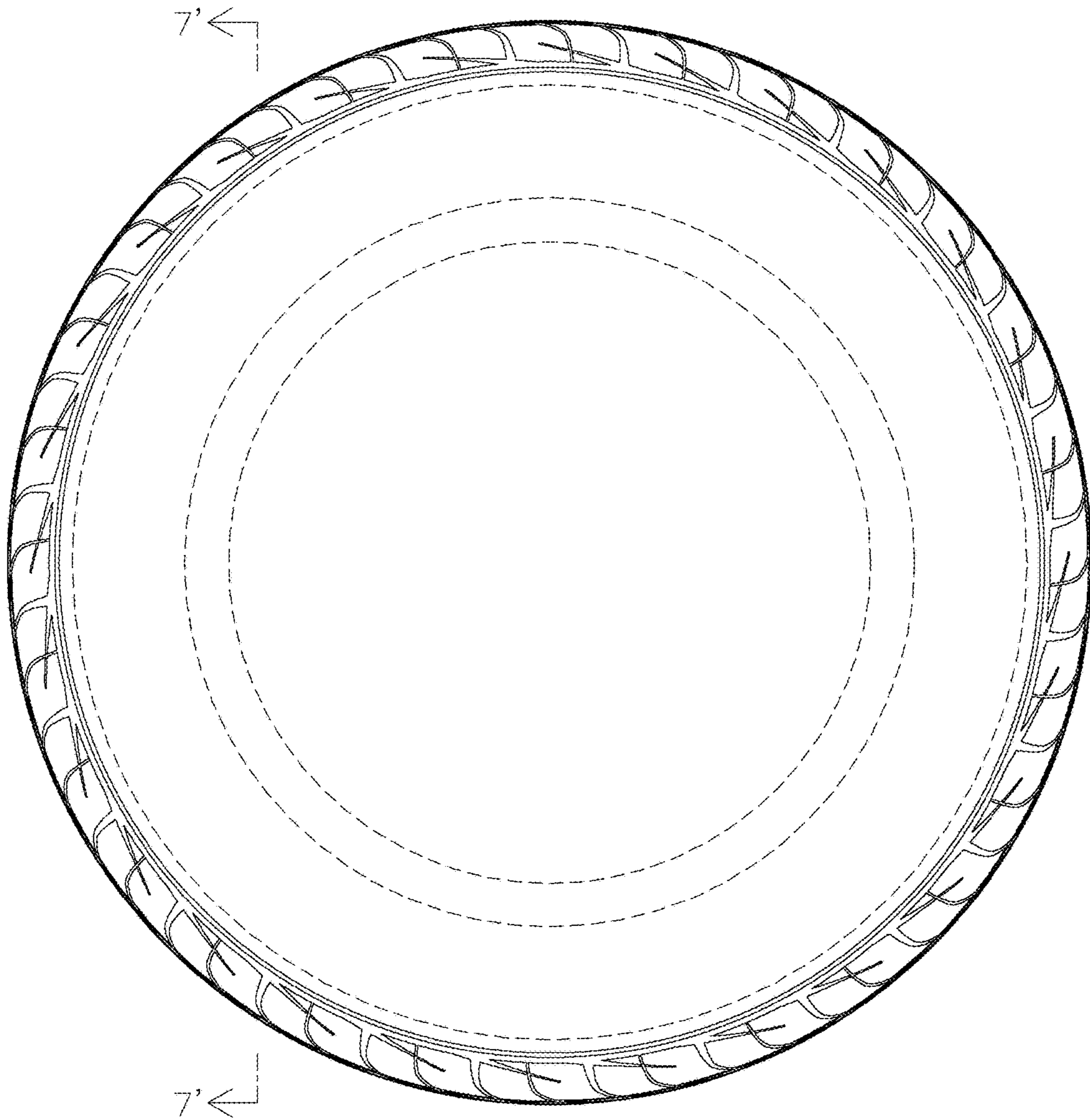

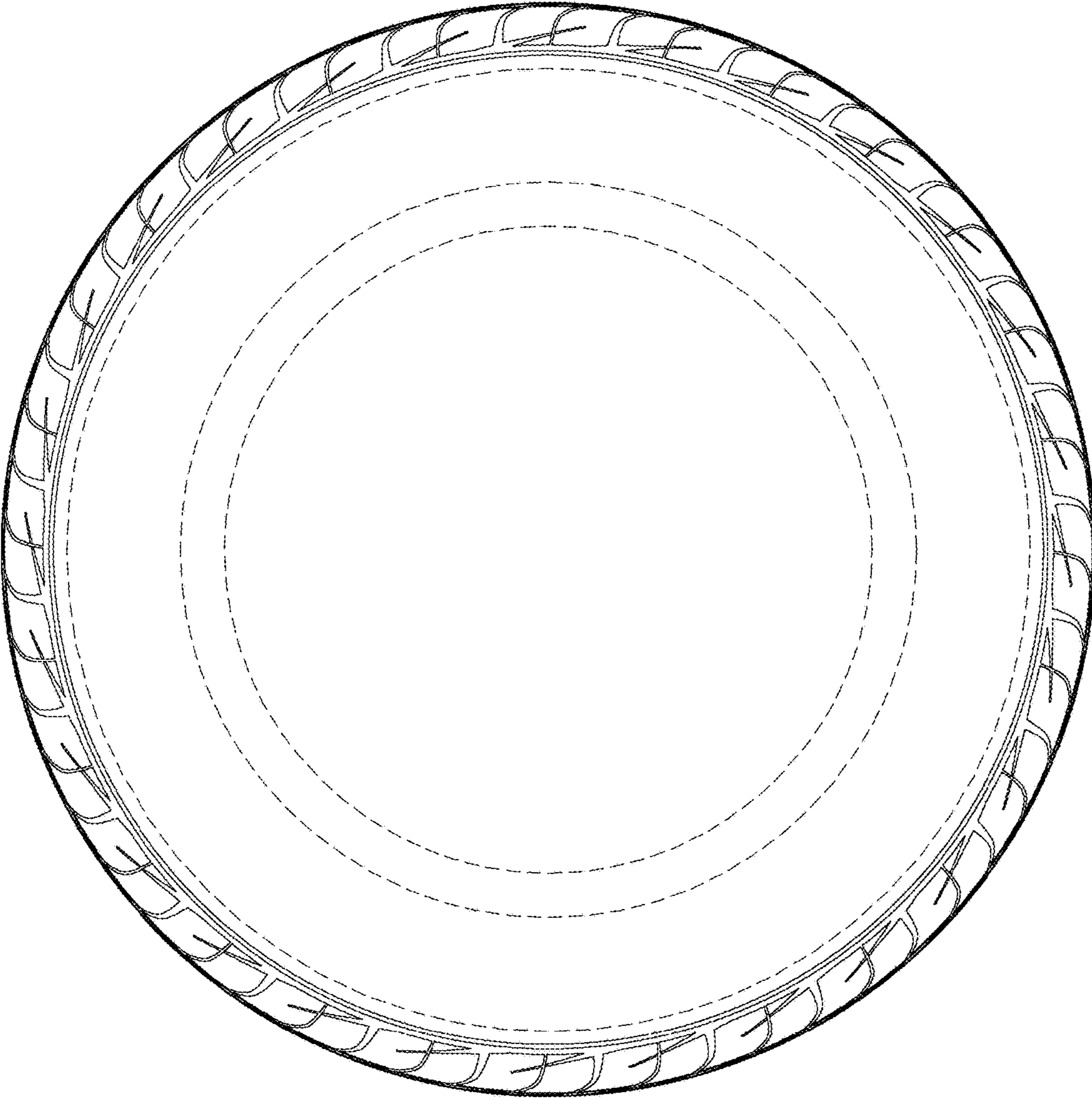

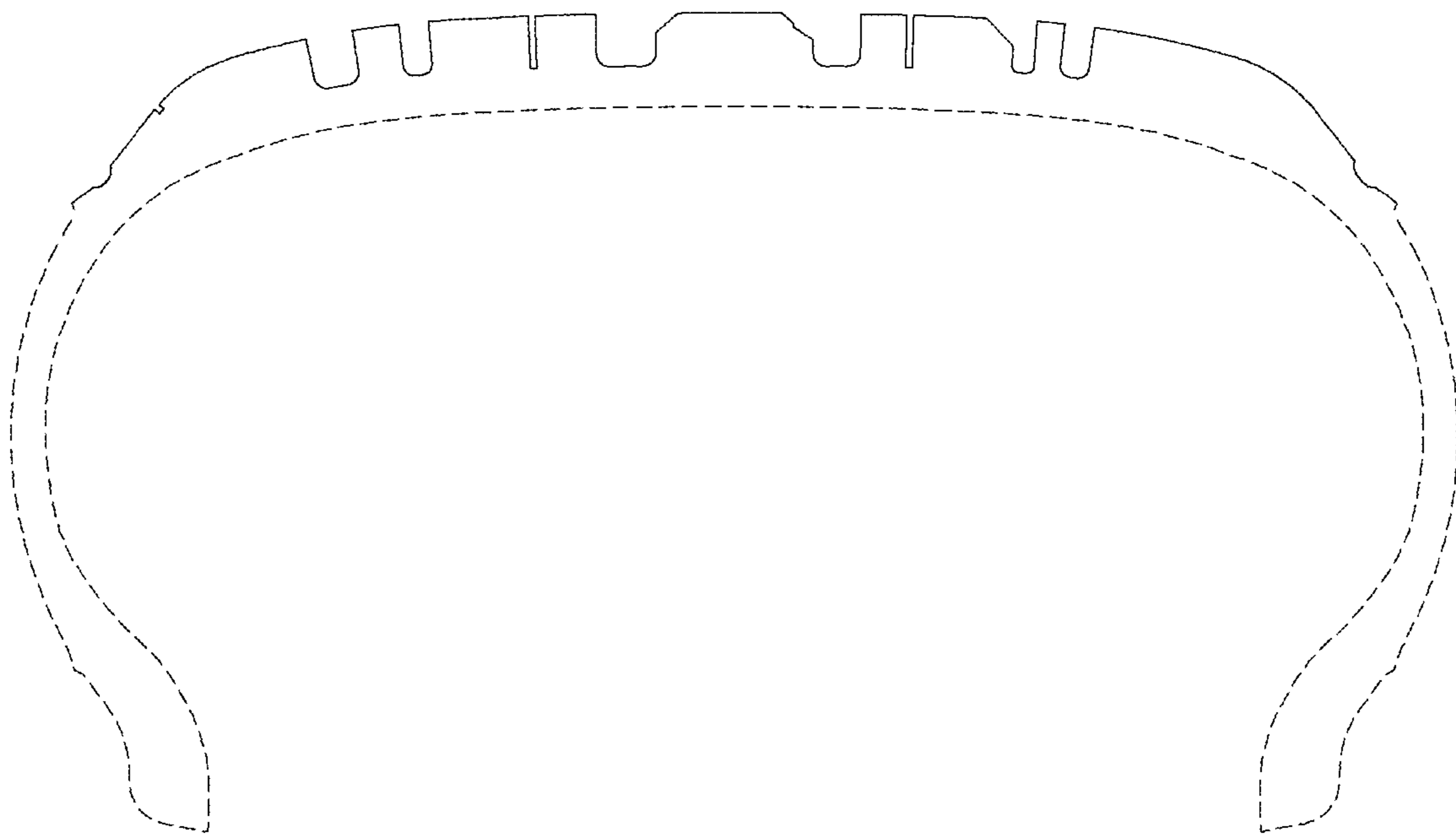

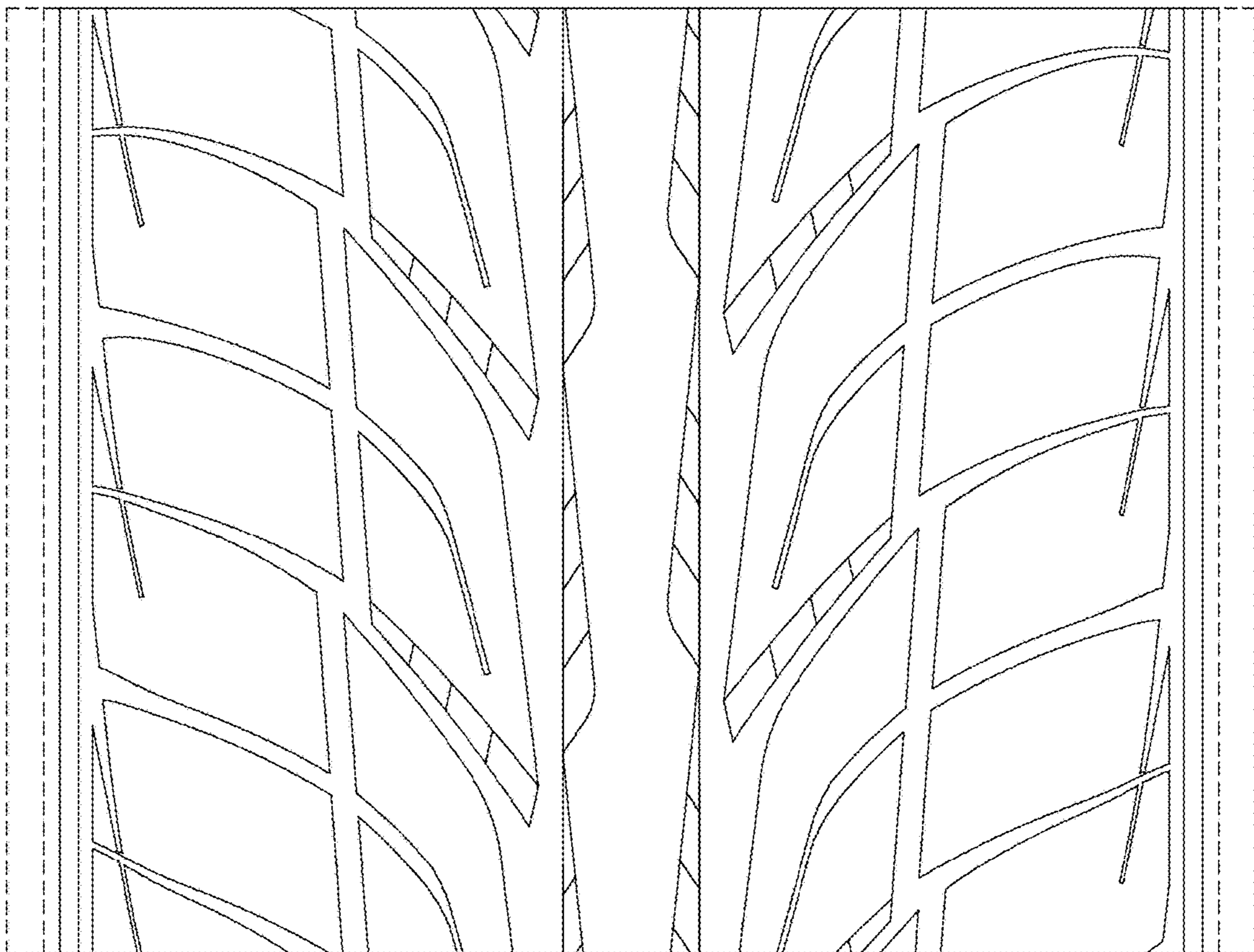
