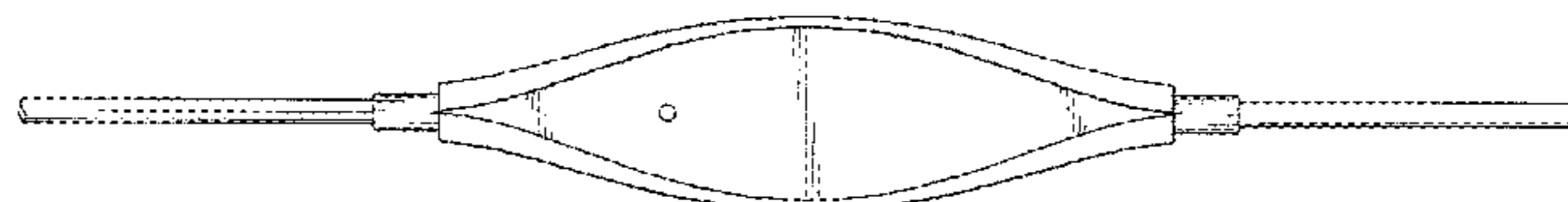
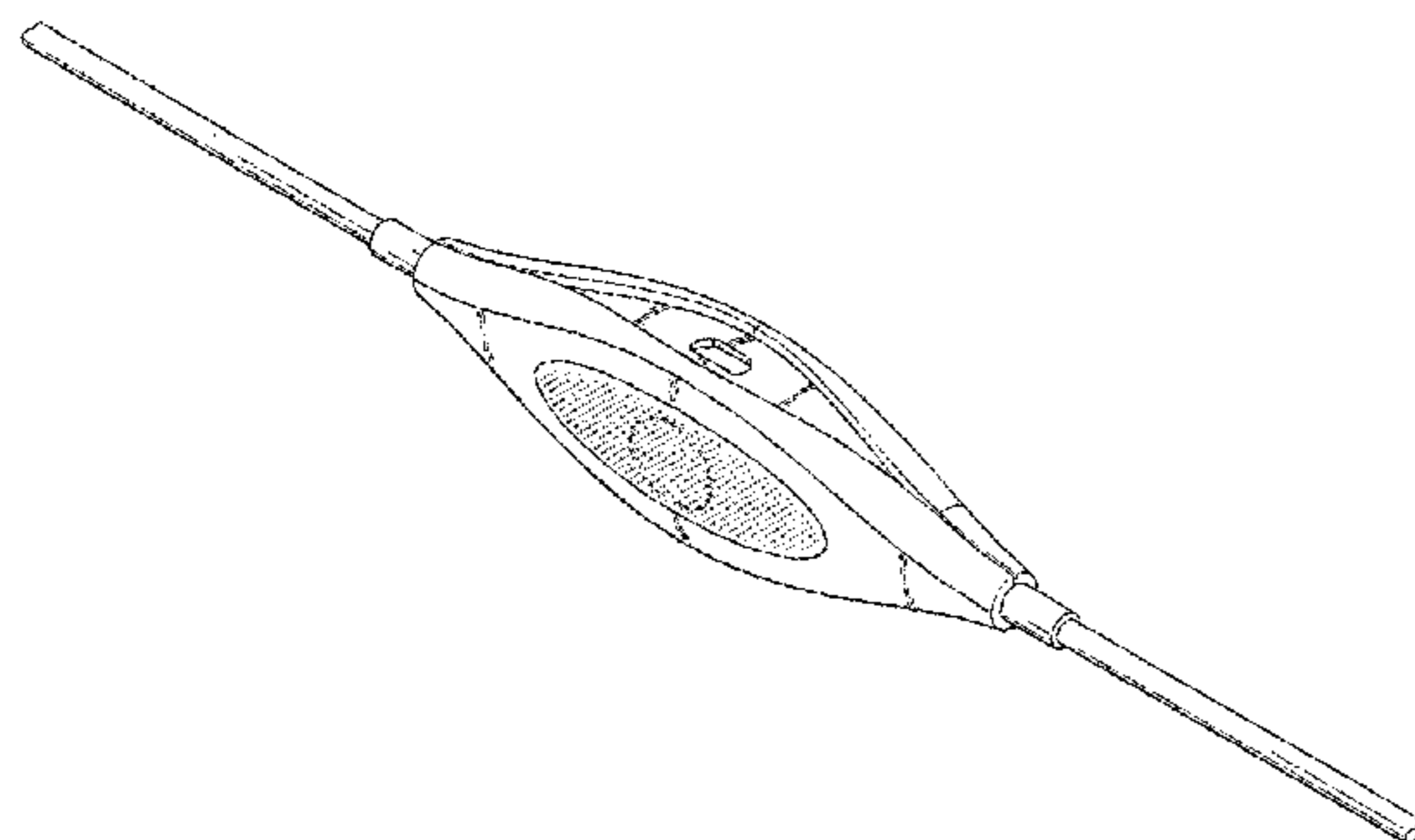
FIG. 1 is a front perspective view of a sound device according to the design;

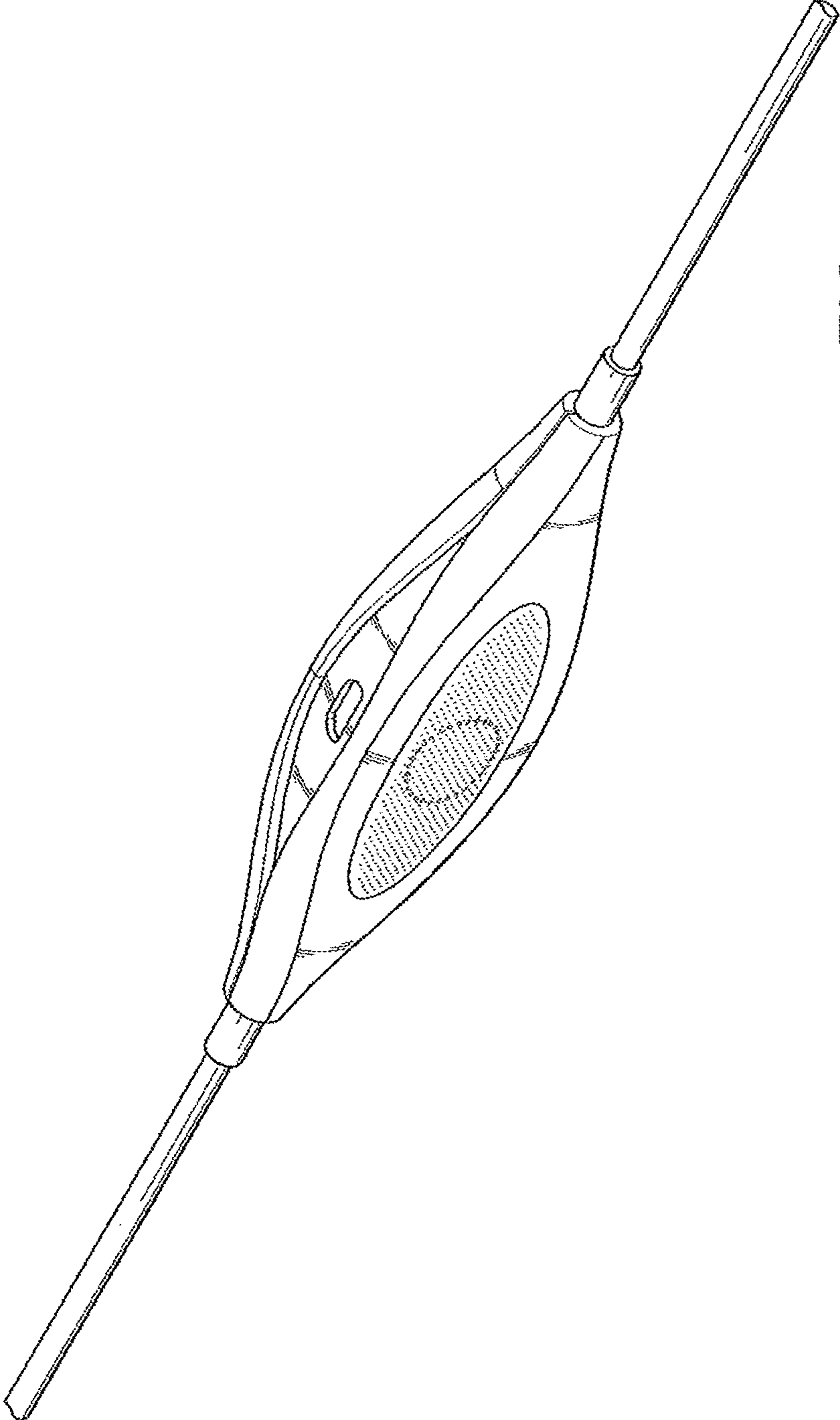

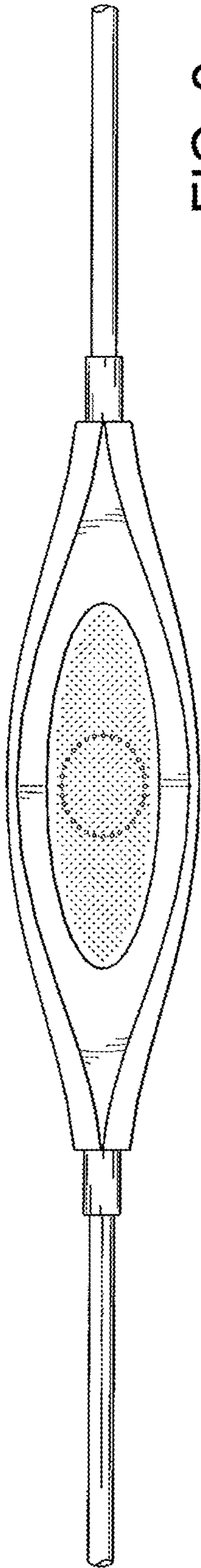

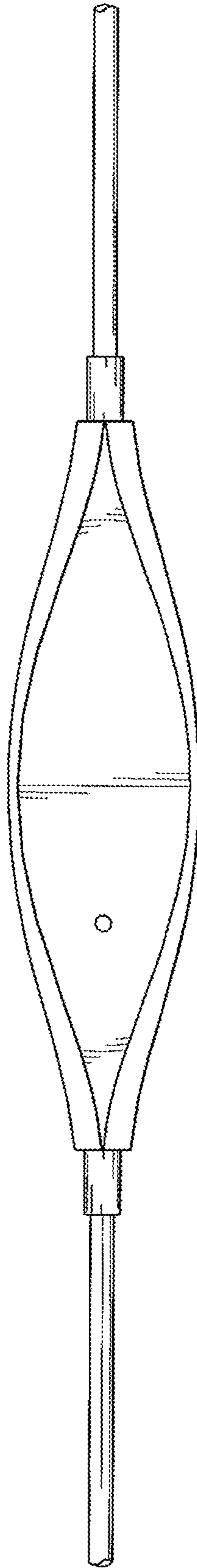

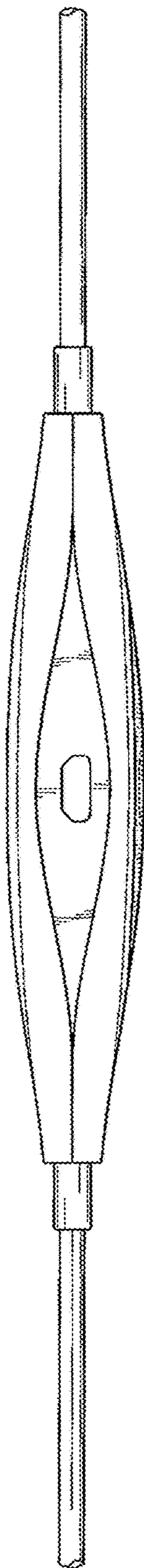

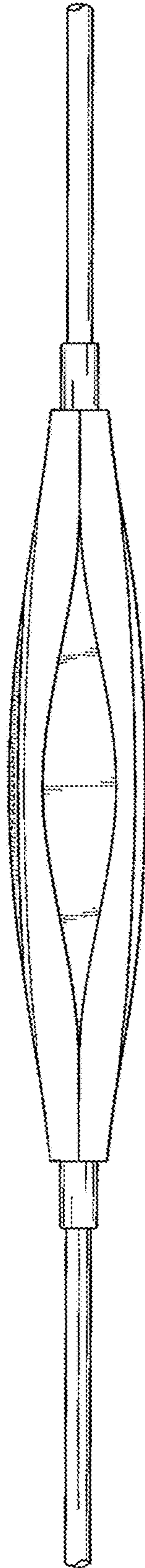

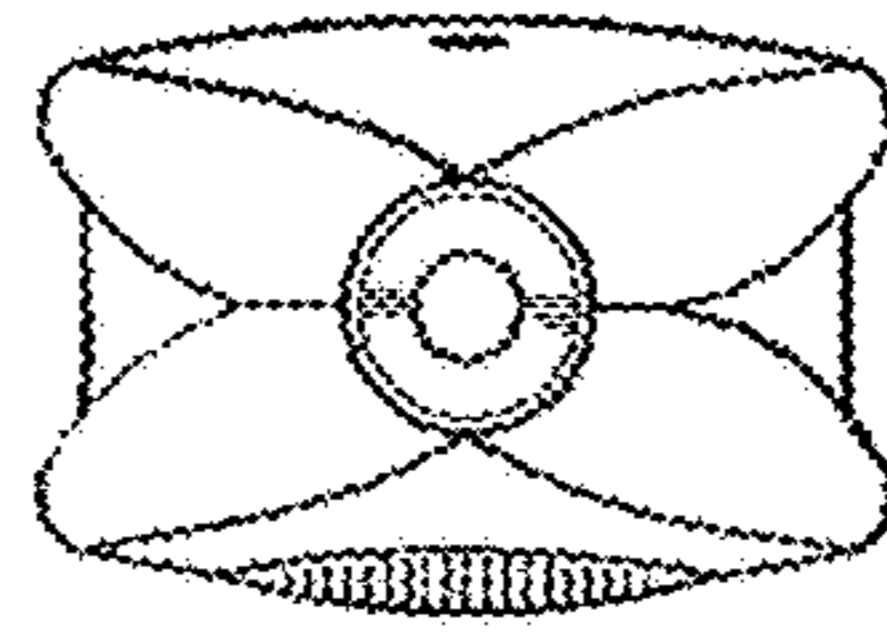

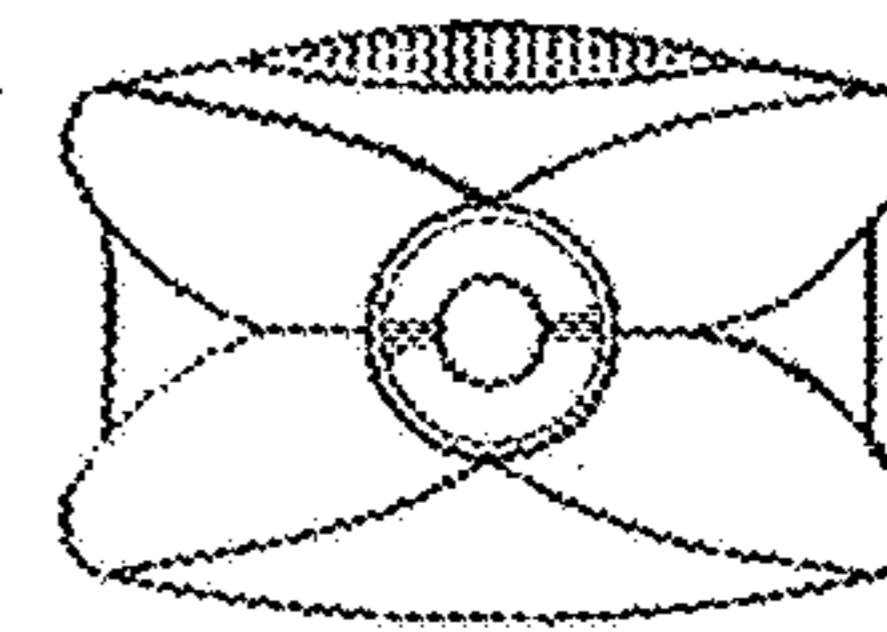
