(57) **CLAIM**

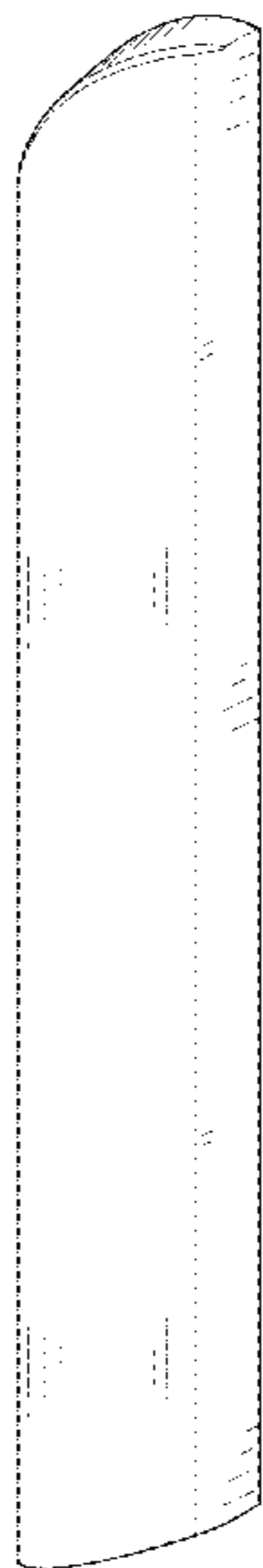
The ornamental design for an antenna pipe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an antenna pipe showing my new design.  
FIG. 2 is a right elevational view thereof;  
FIG. 3 is a left elevational view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is rear elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is another perspective view showing the antenna pipe.  
The features shown in broken lines in FIG. 5 illustrate portions of the antenna pipe. The features shown in broken lines in FIG. 7 illustrate environmental structure. None of the broken lines form part of the claimed design.

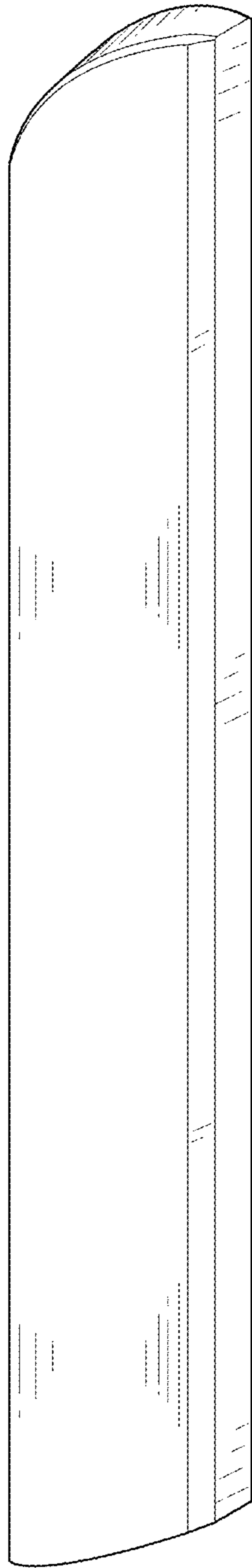

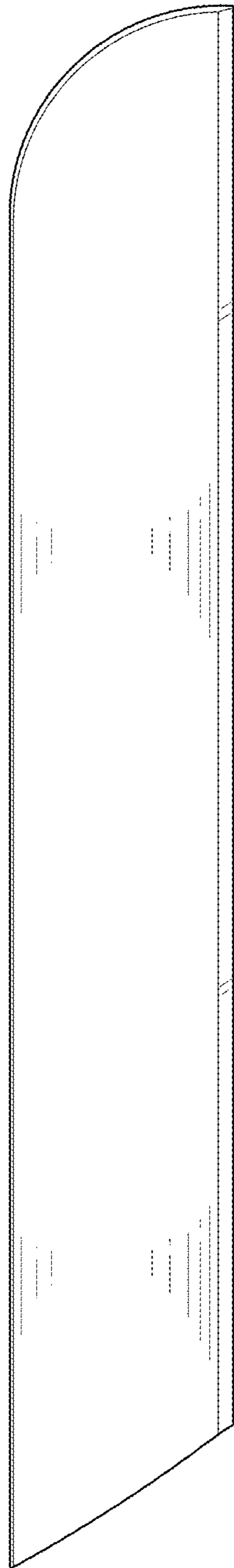

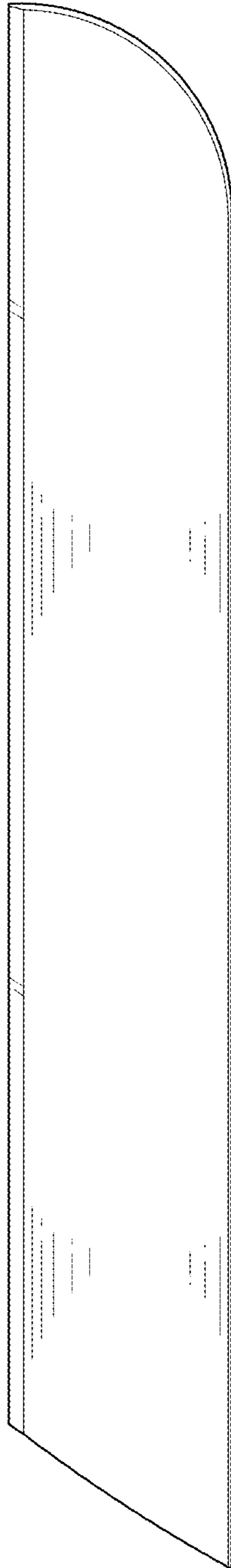

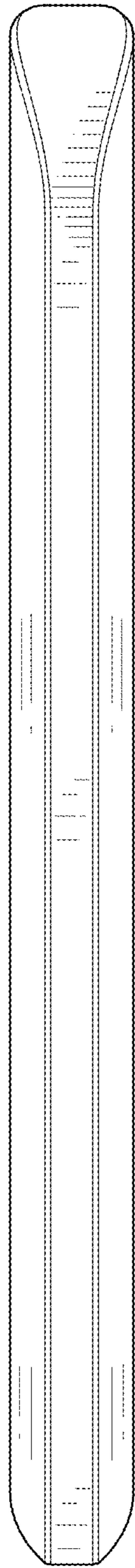

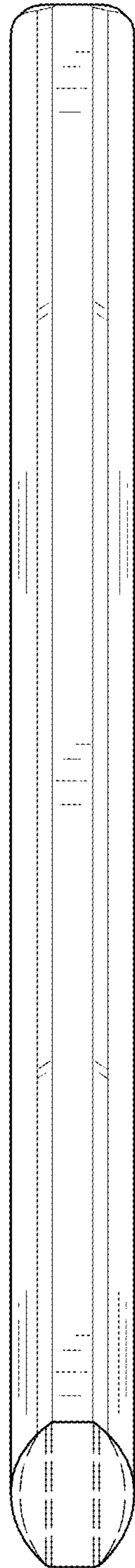

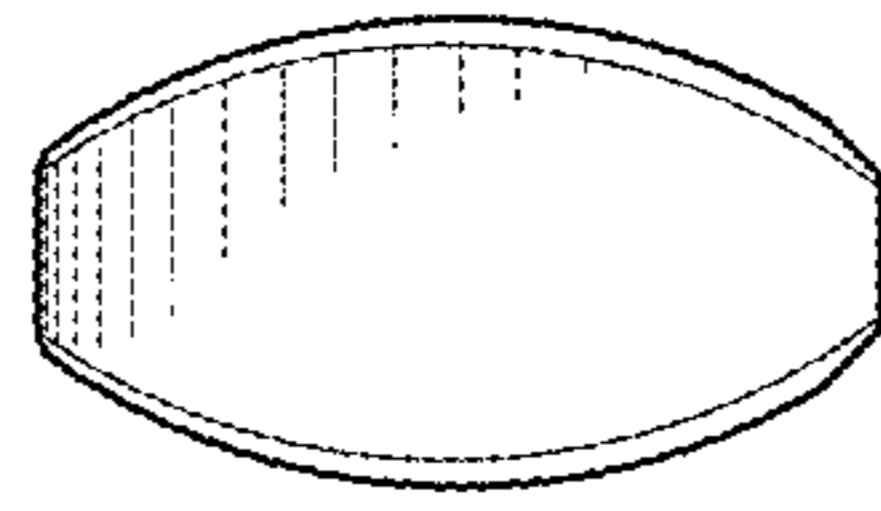

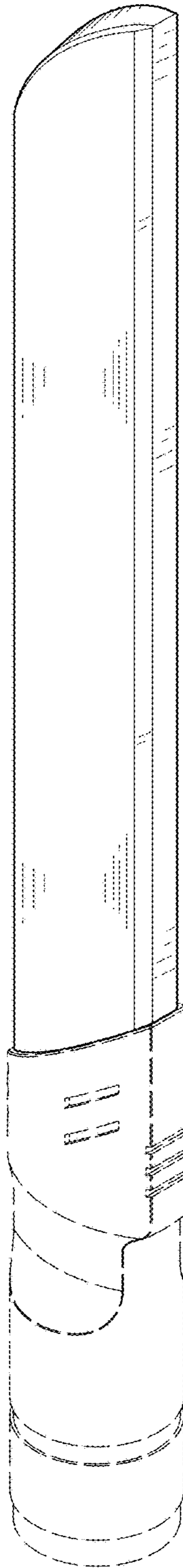
