The broken lines in the drawings represent portions of the mobile phone that form no part of the claimed design.

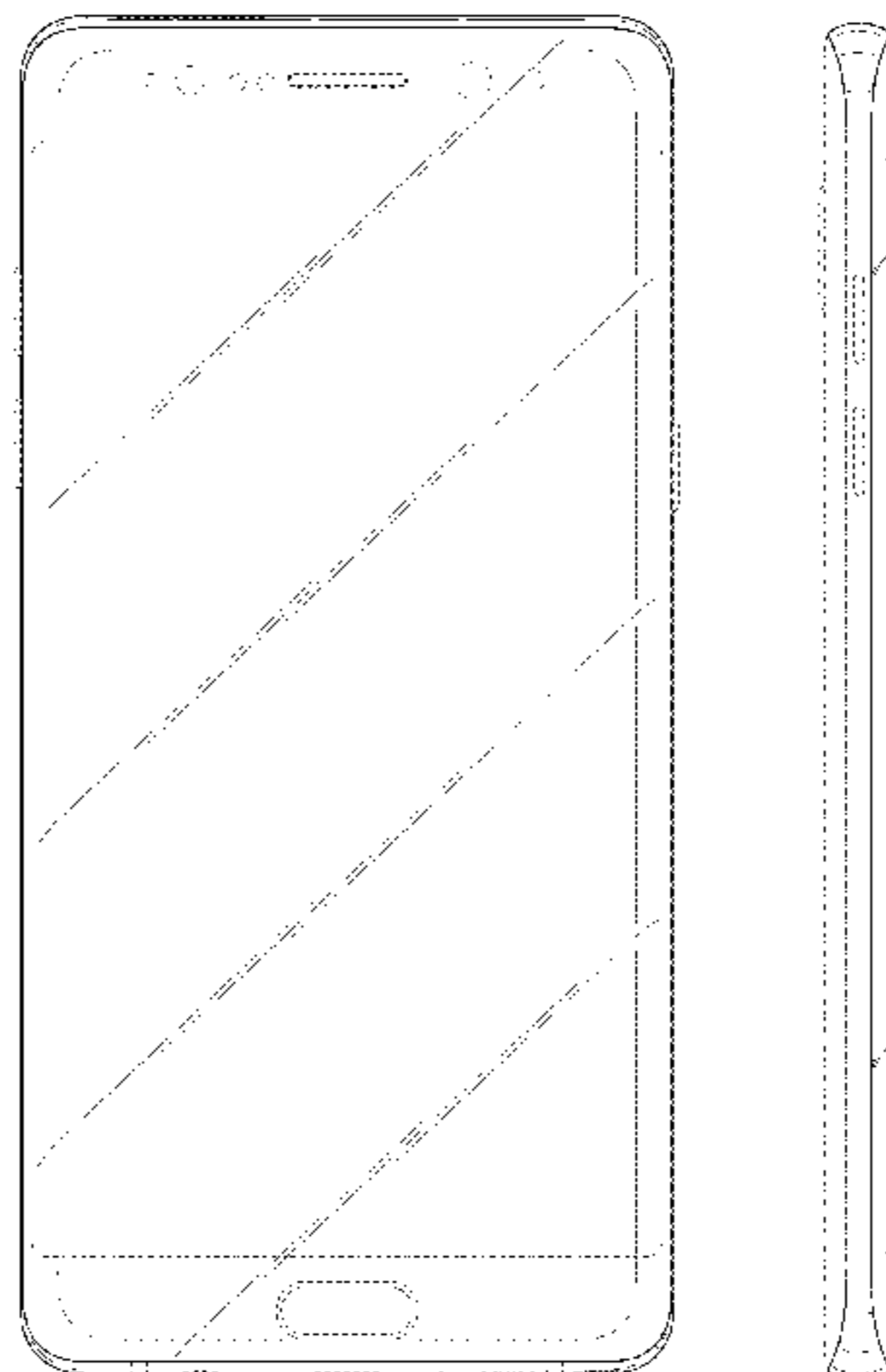

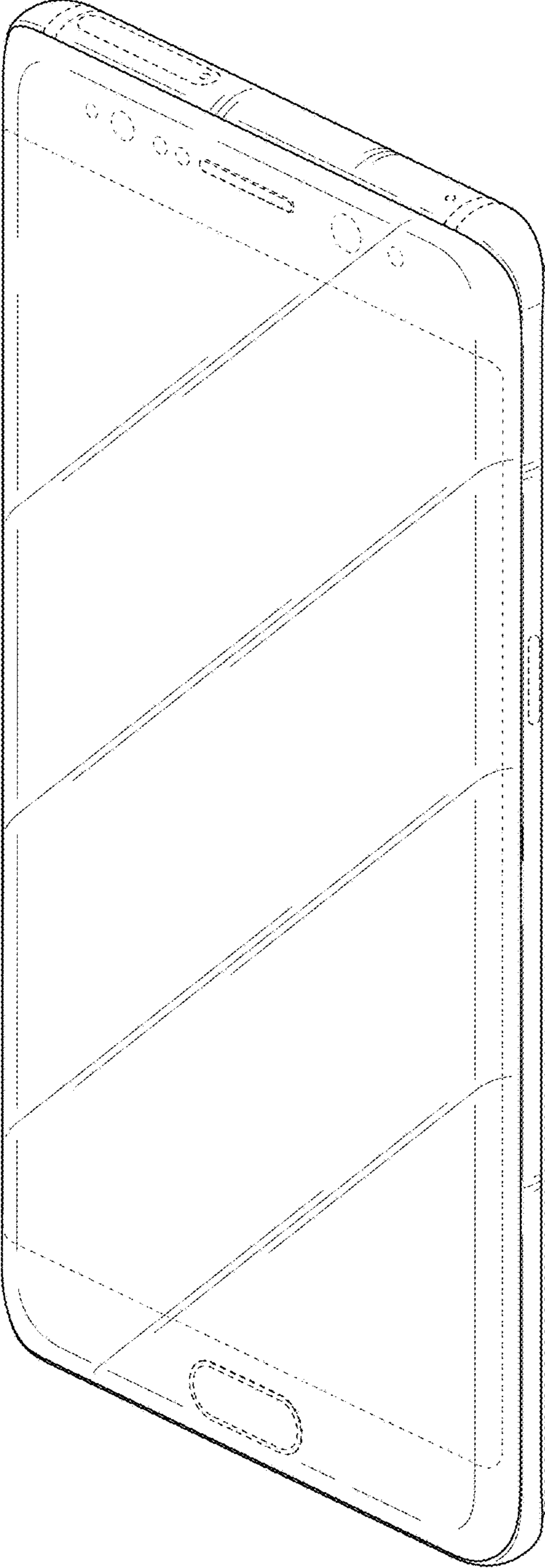

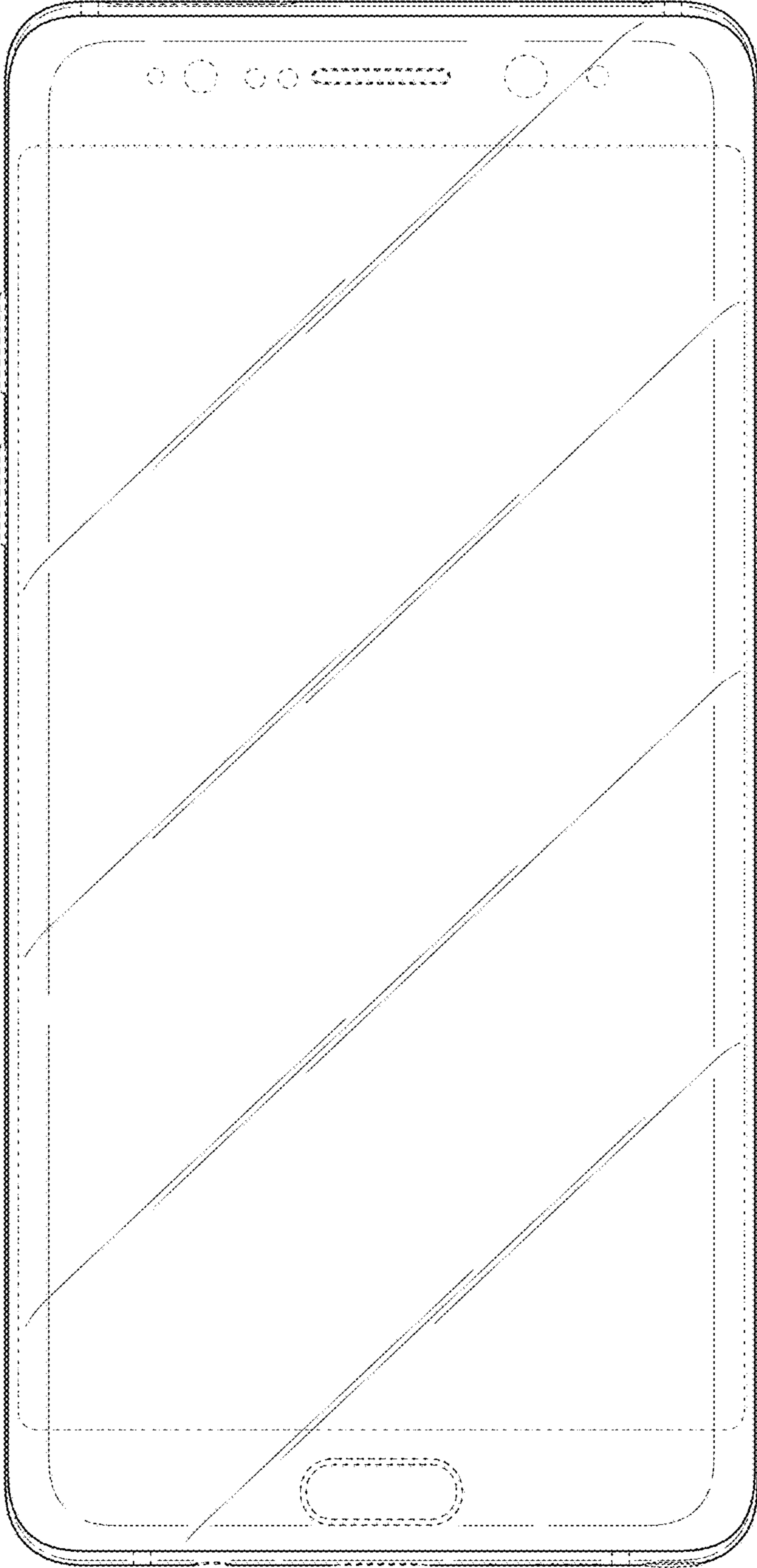

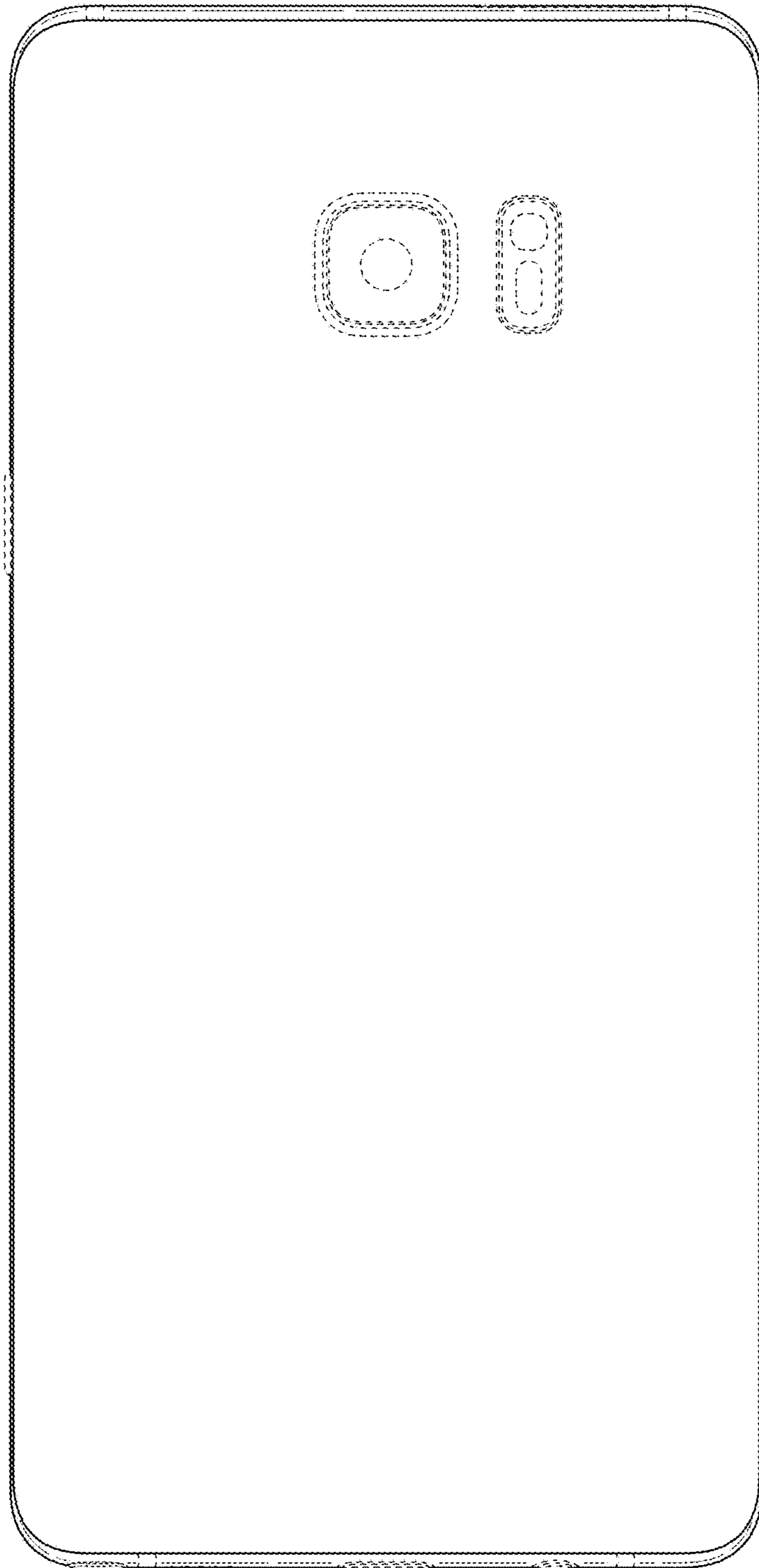

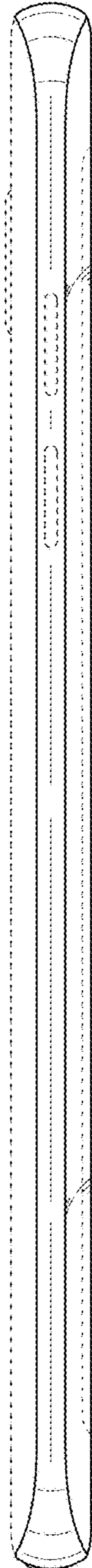

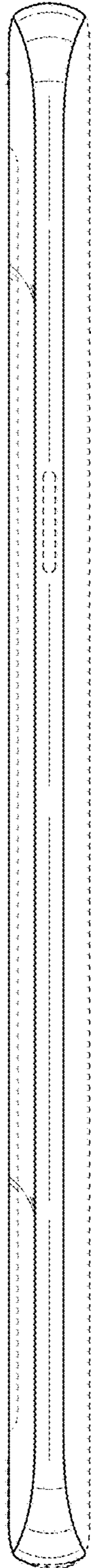

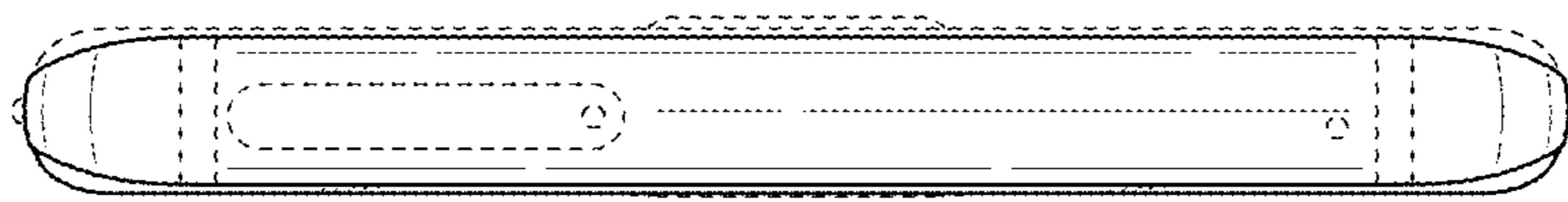

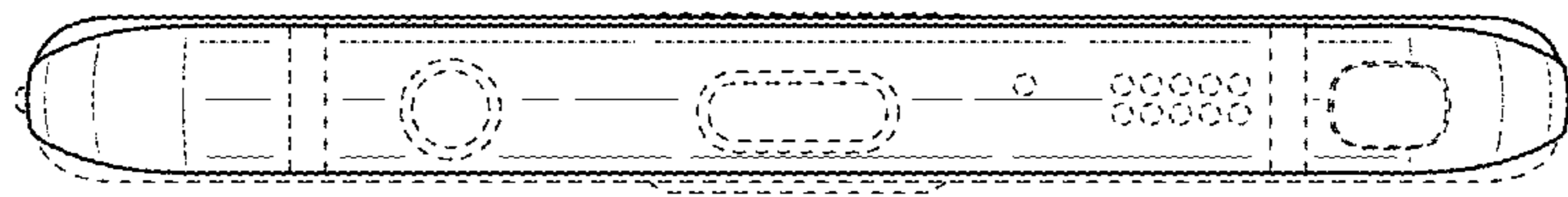

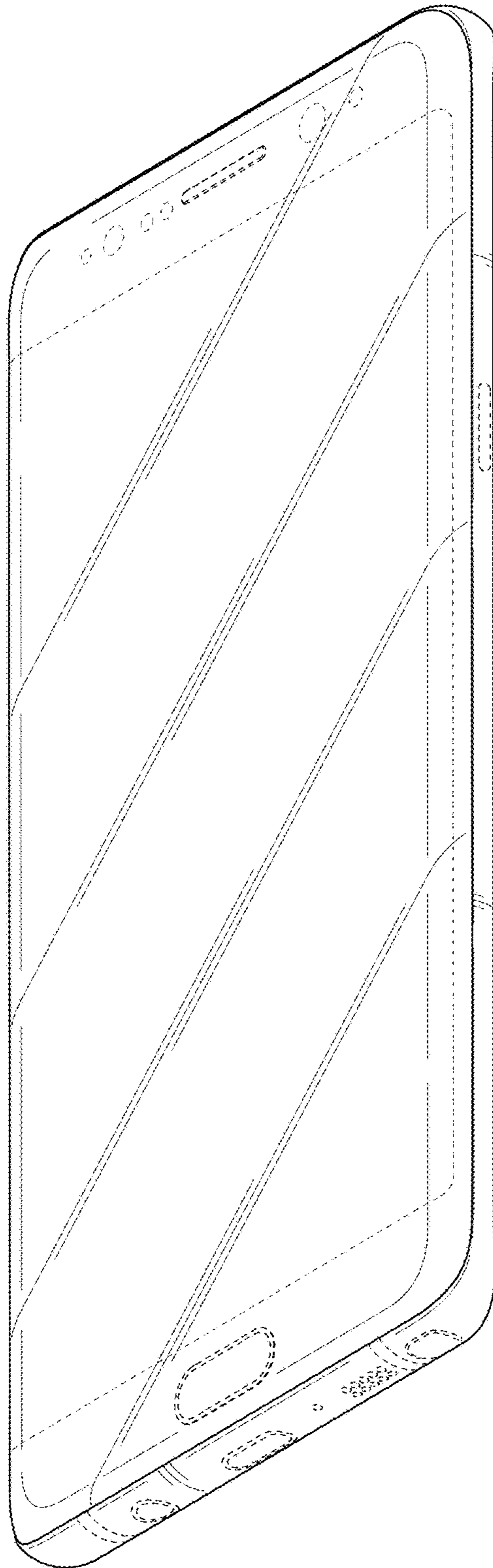
