FIG. 10 is a tenth image in a sequence thereof;

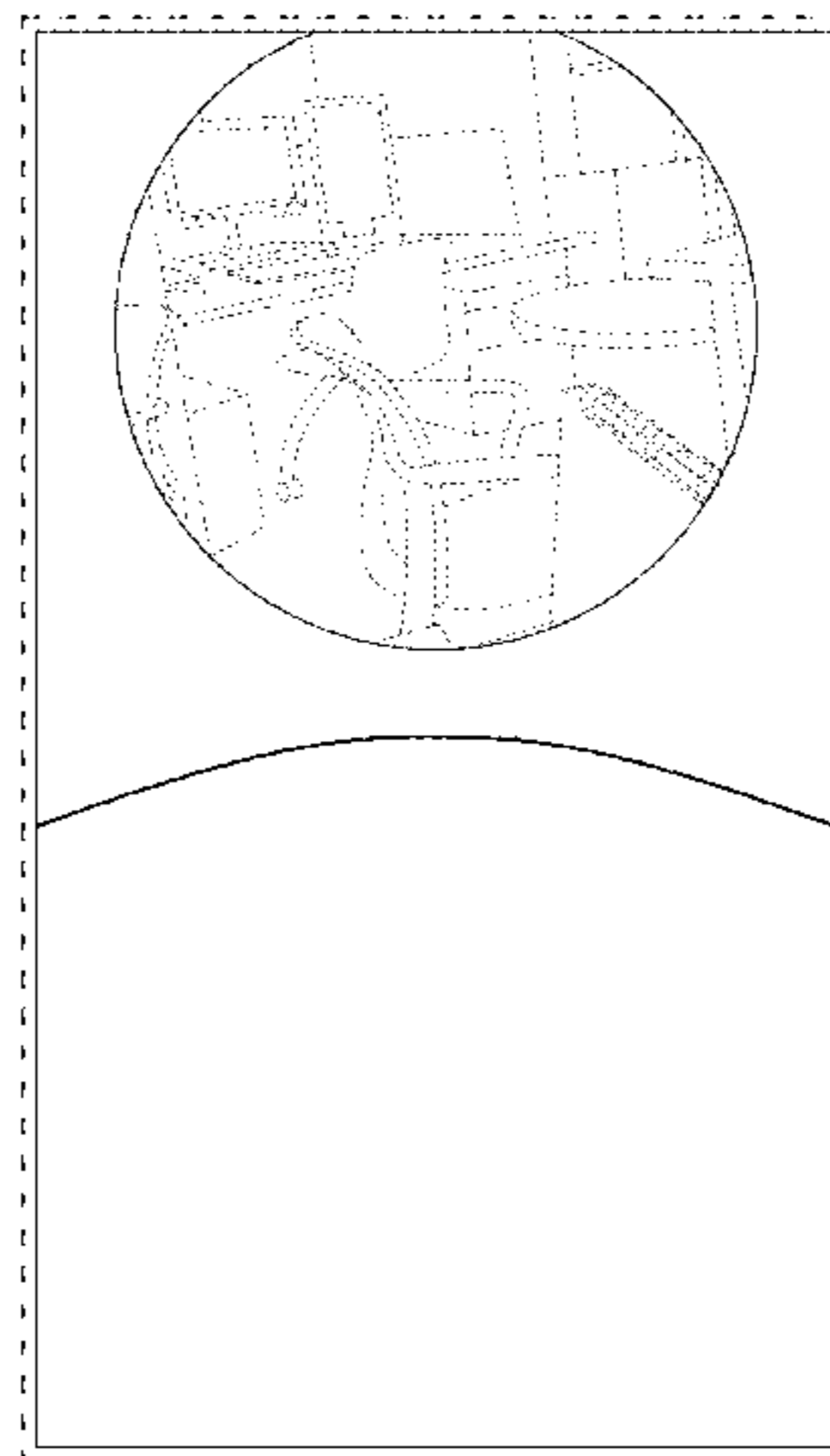
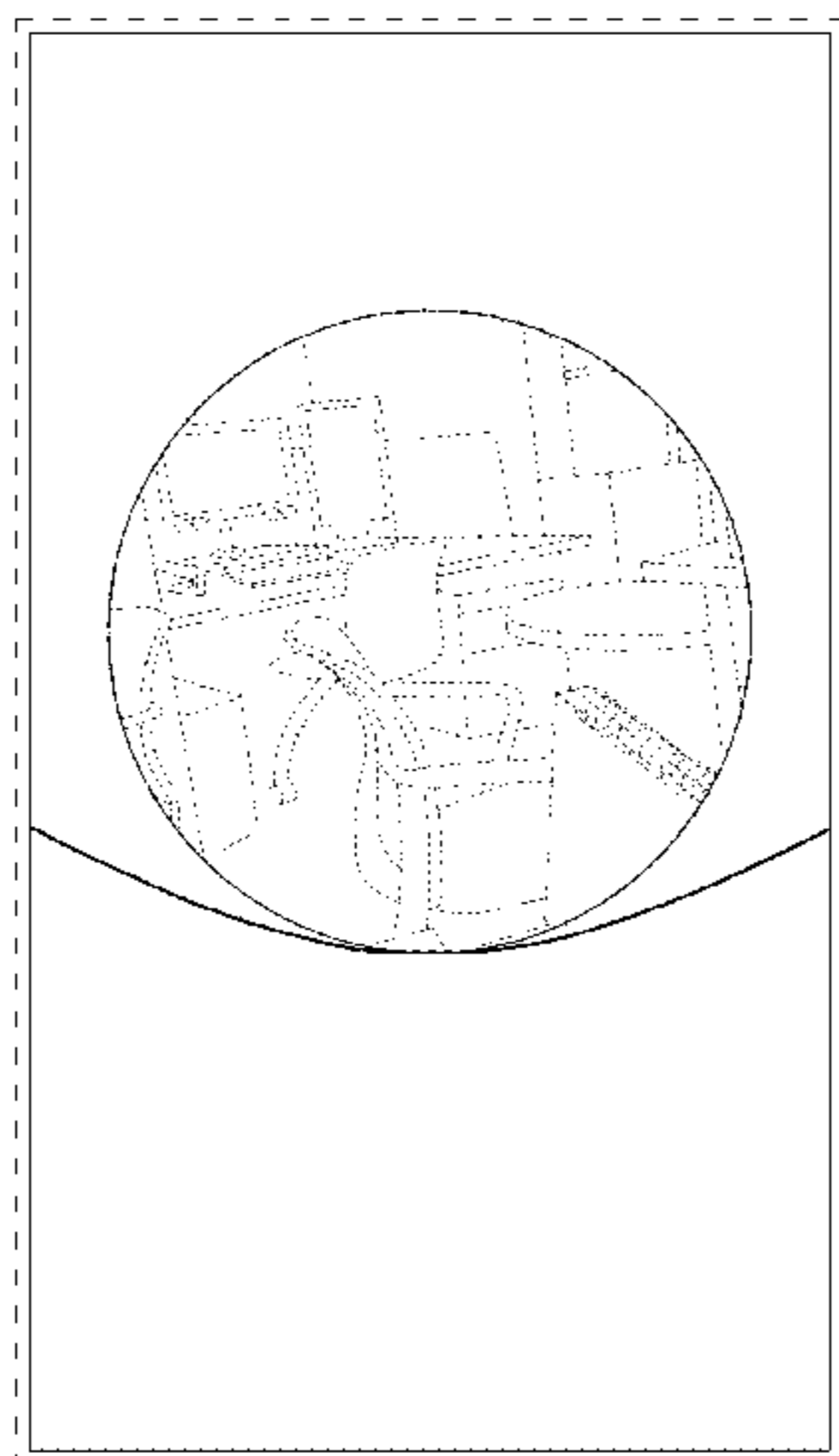
FIG. 11 is an eleventh image in a sequence thereof; and,

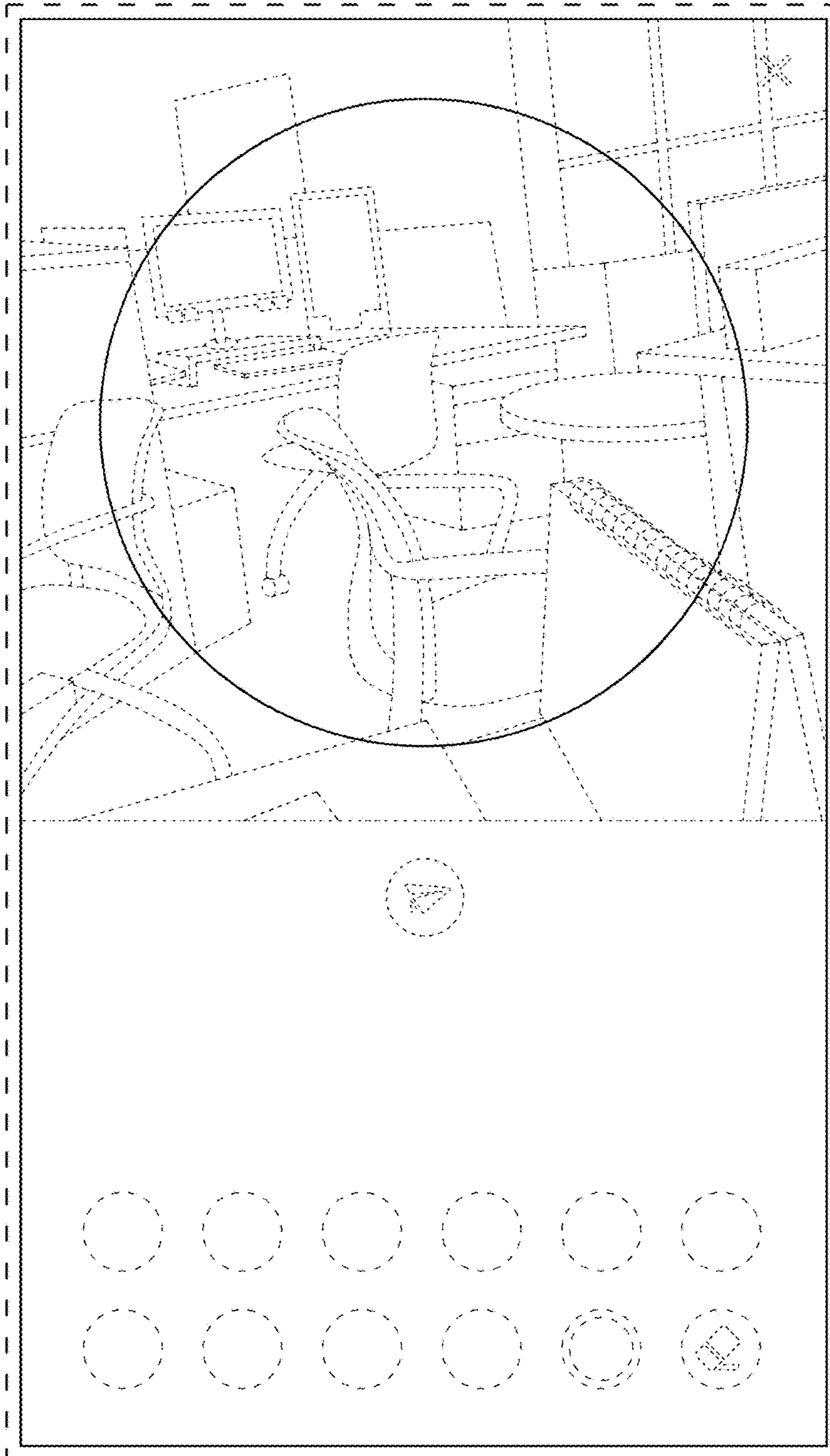

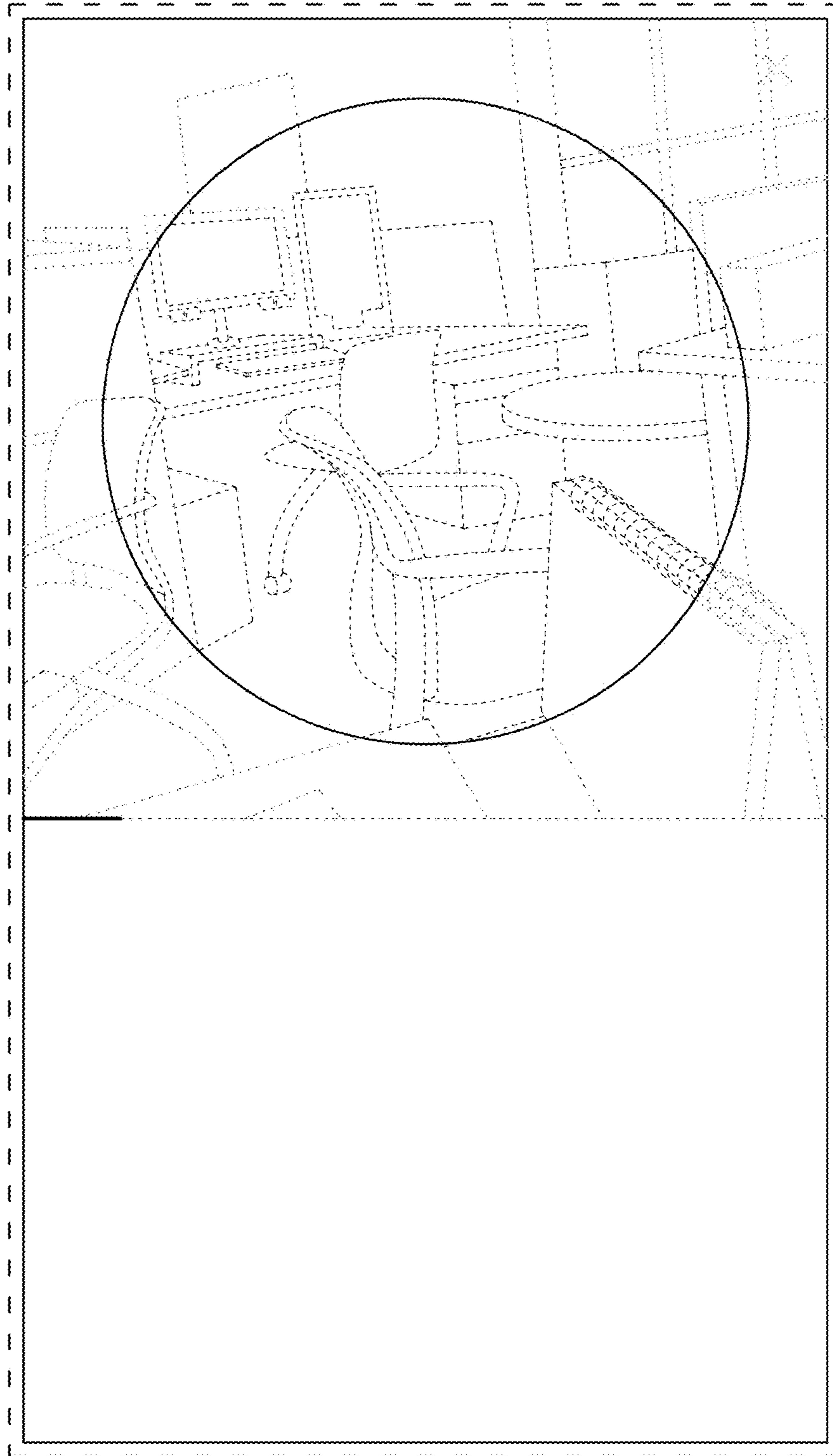

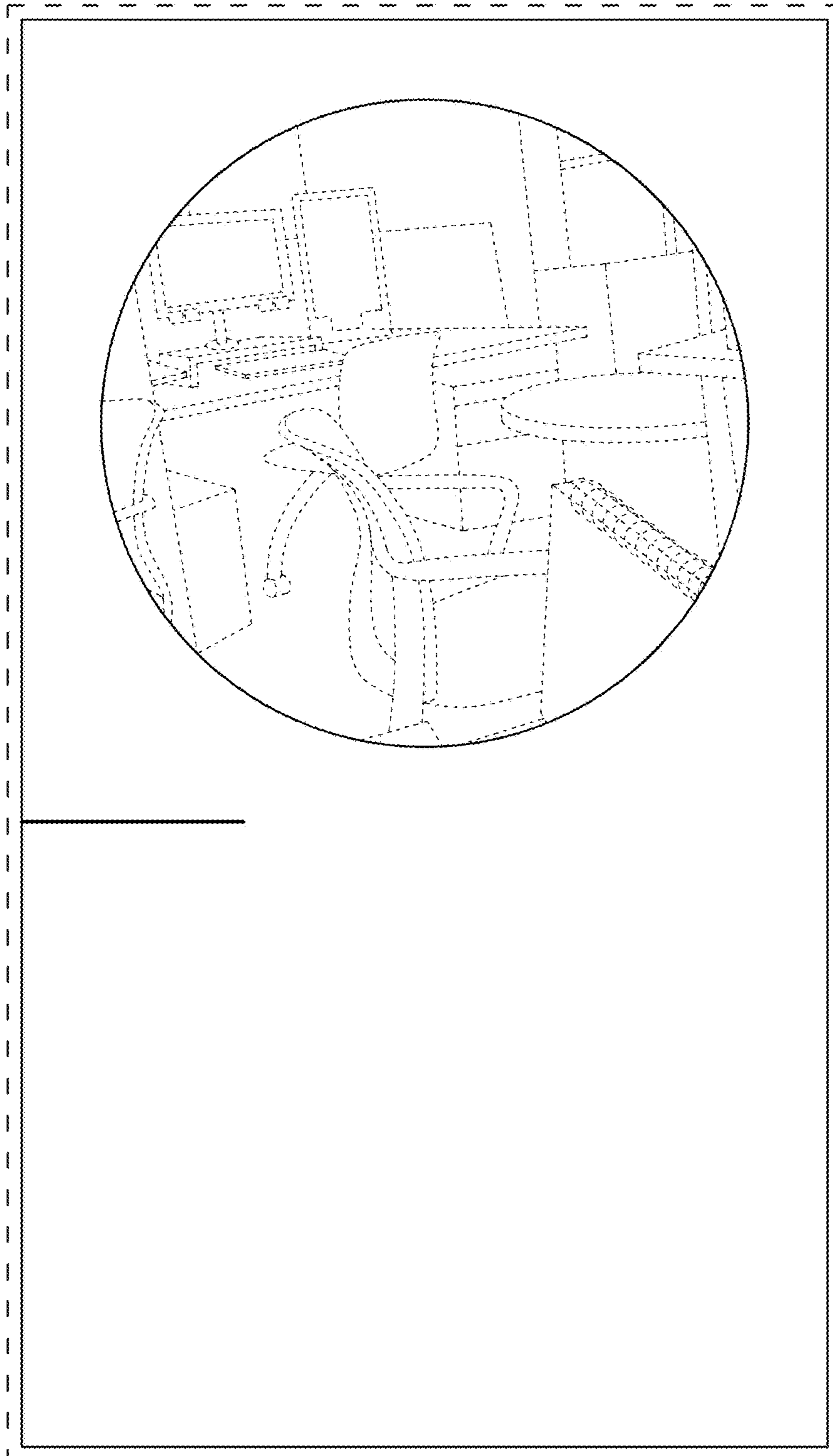

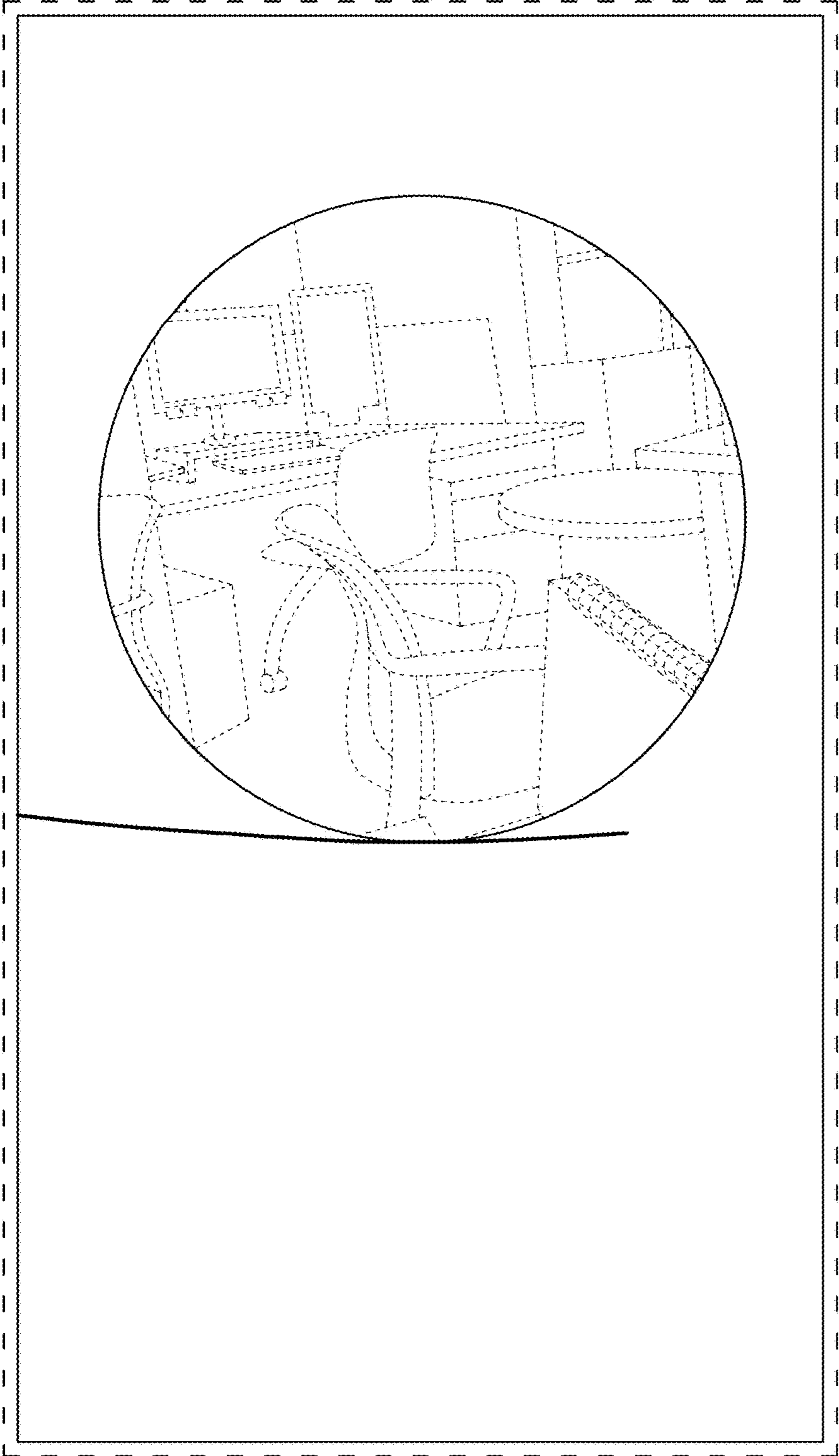

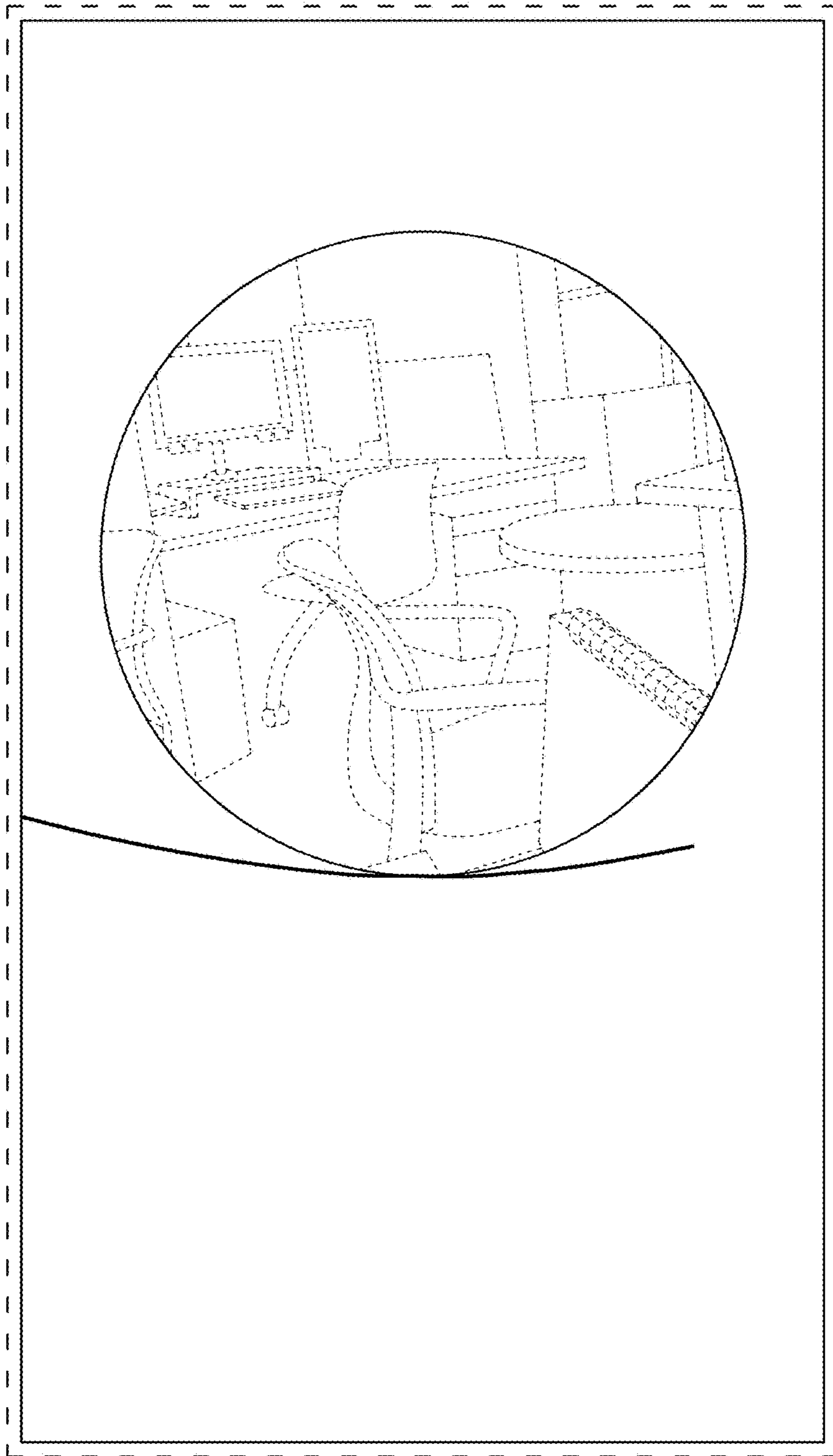

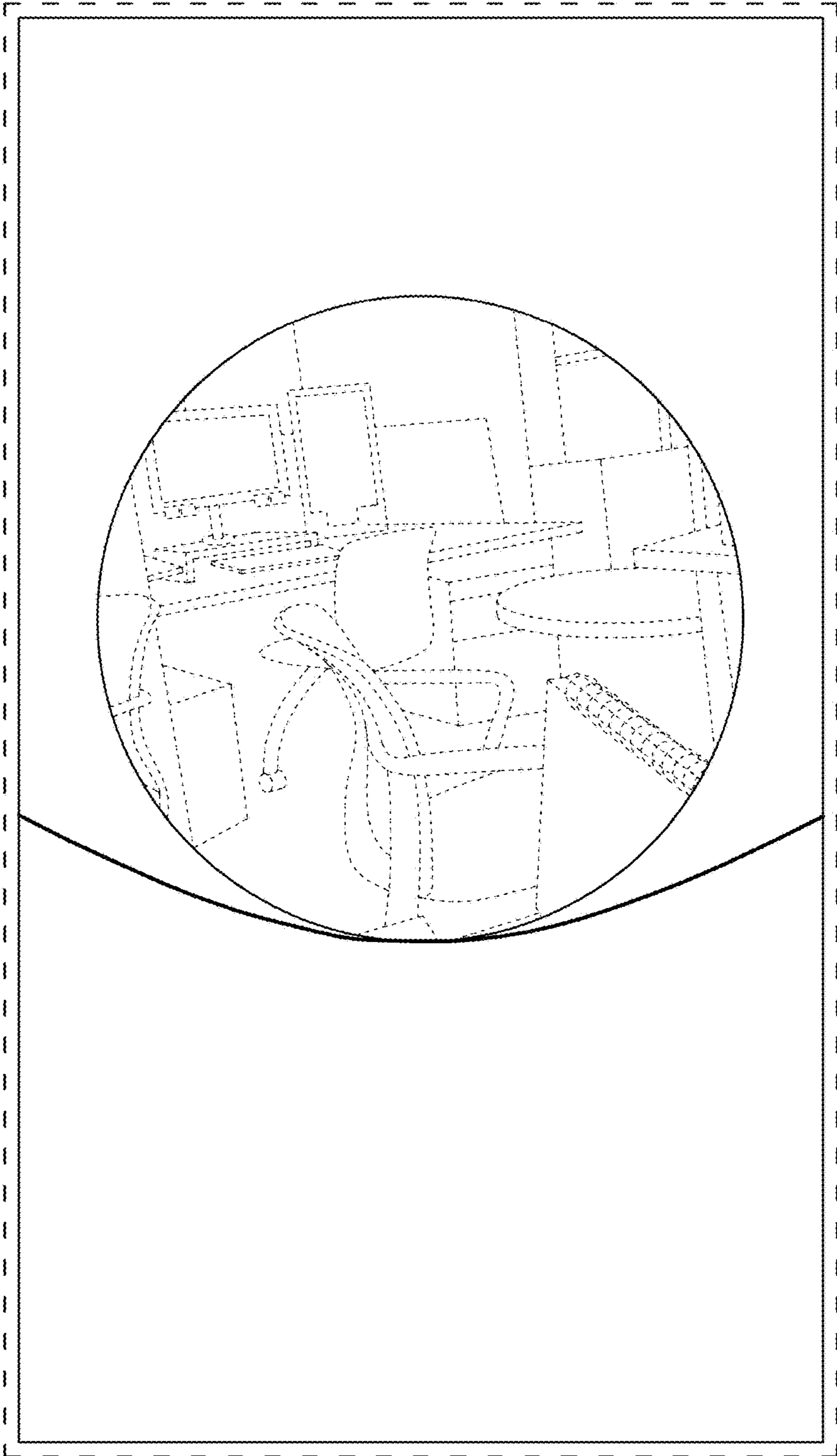

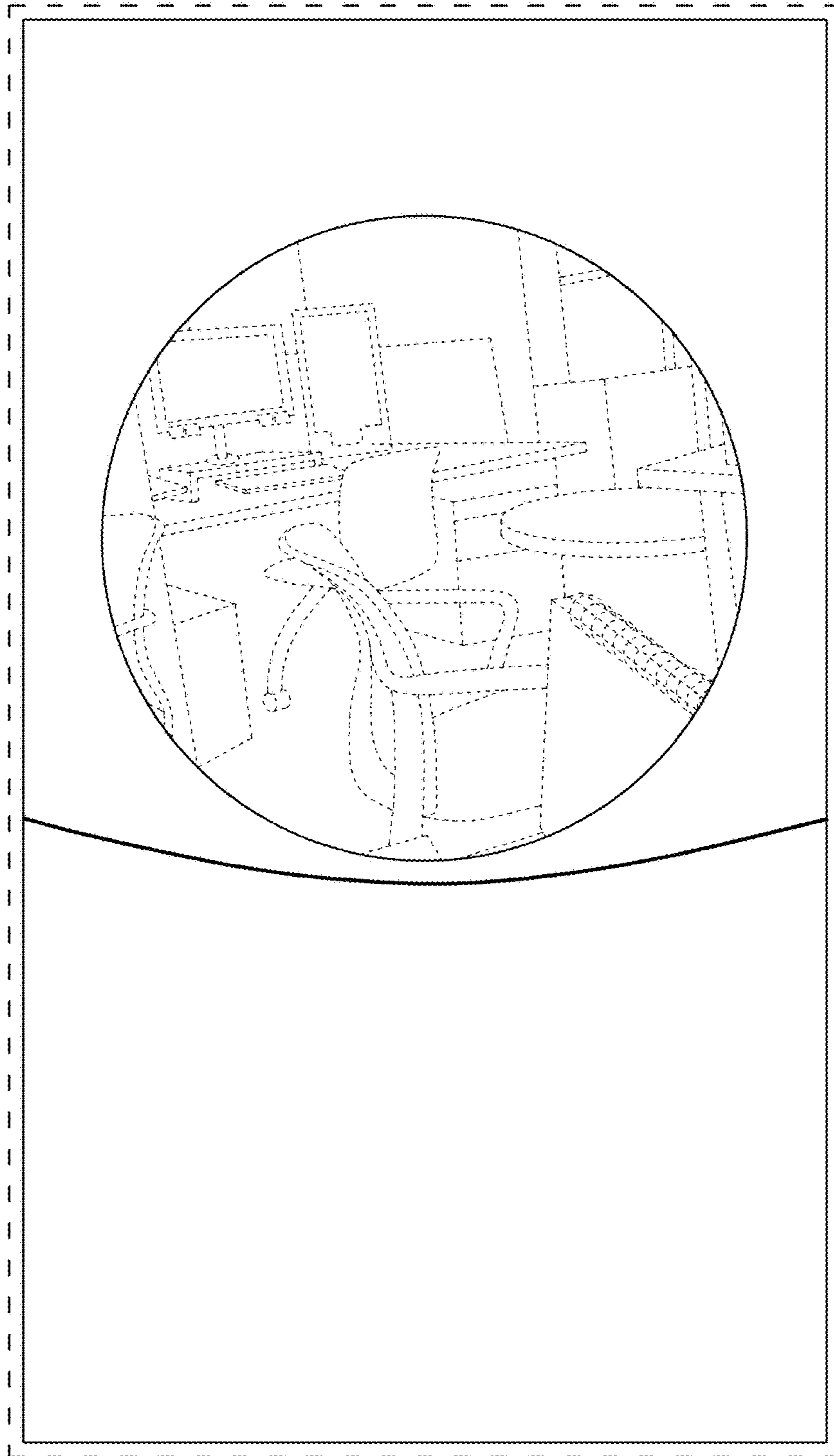

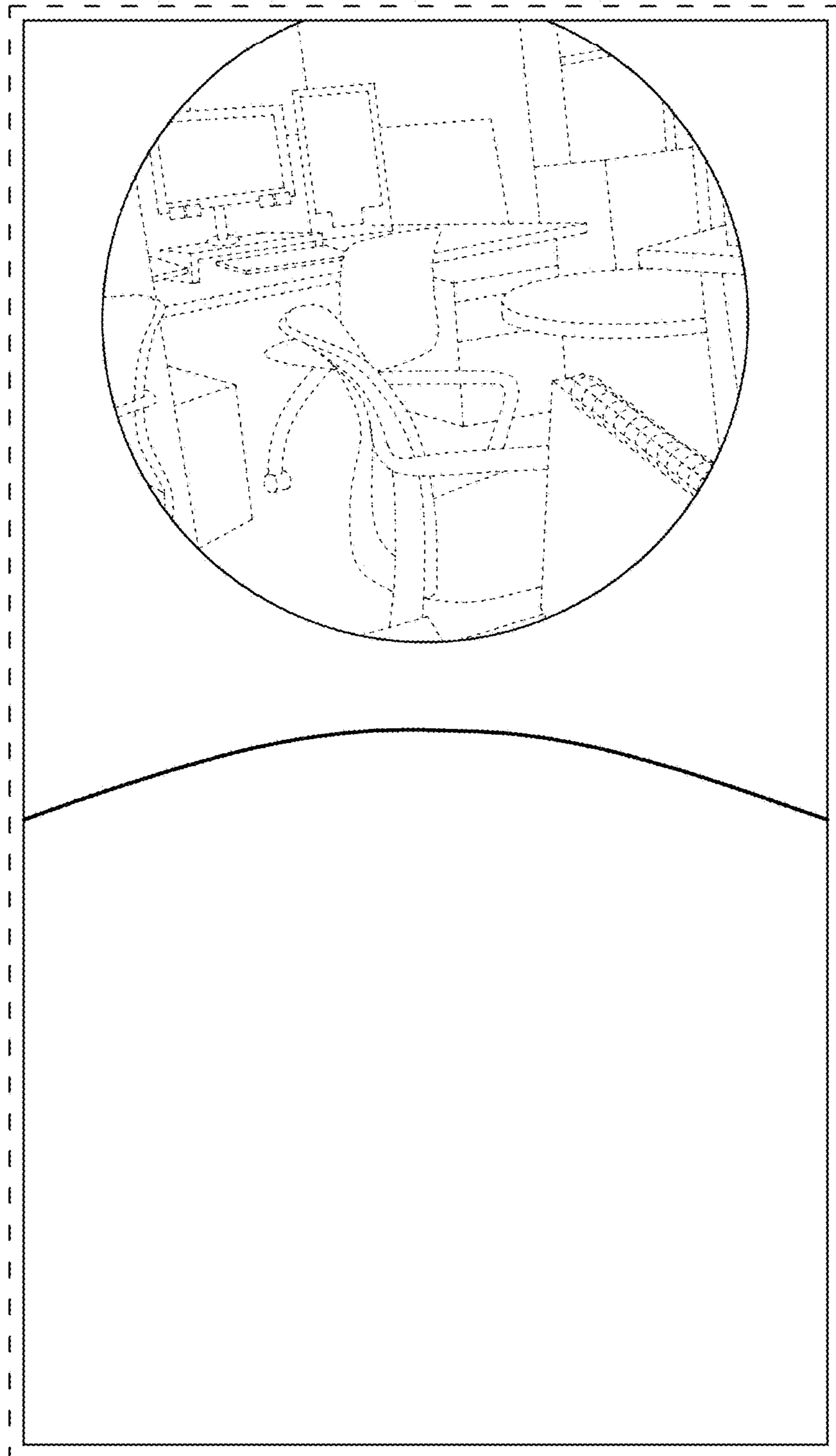

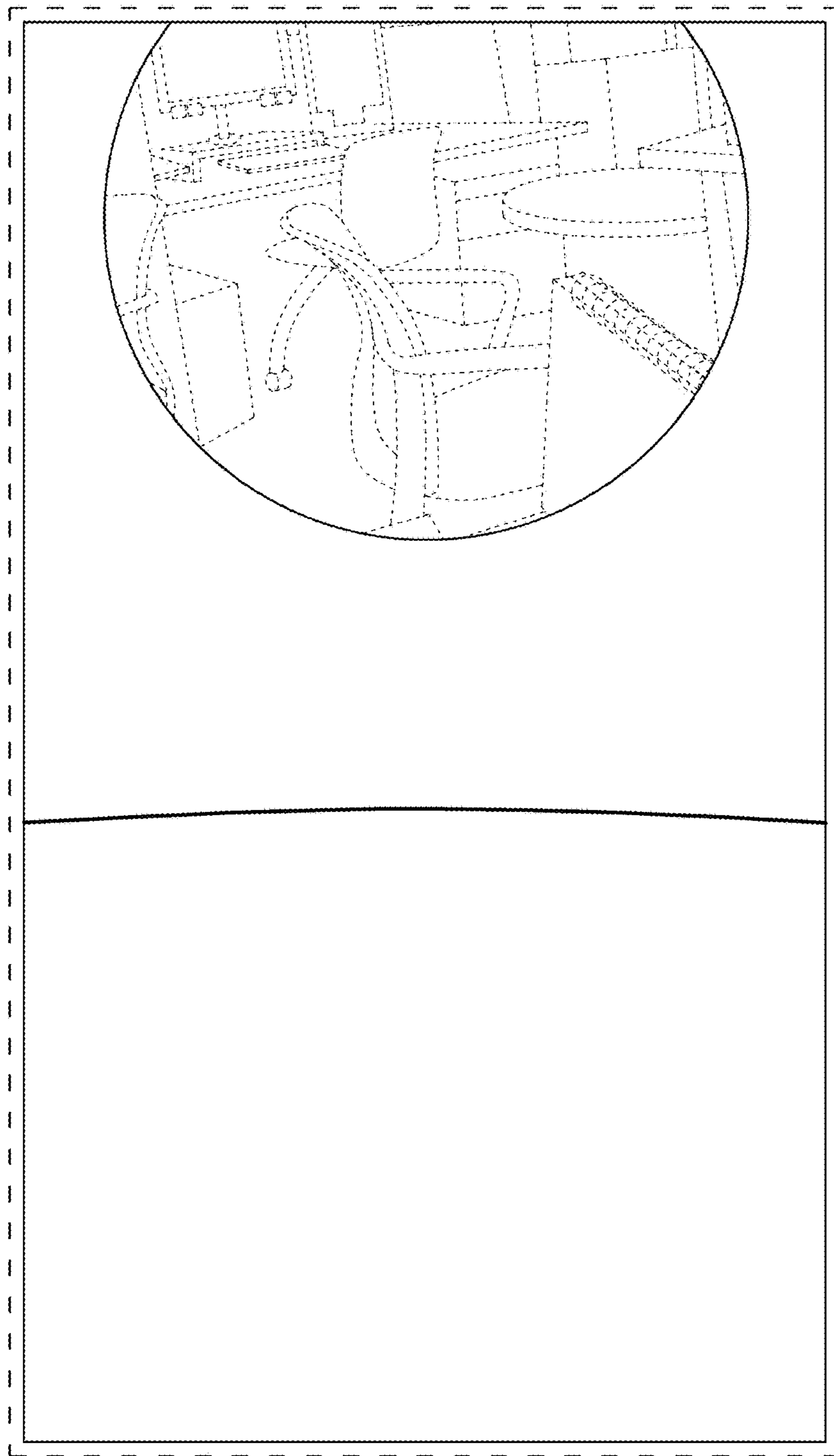

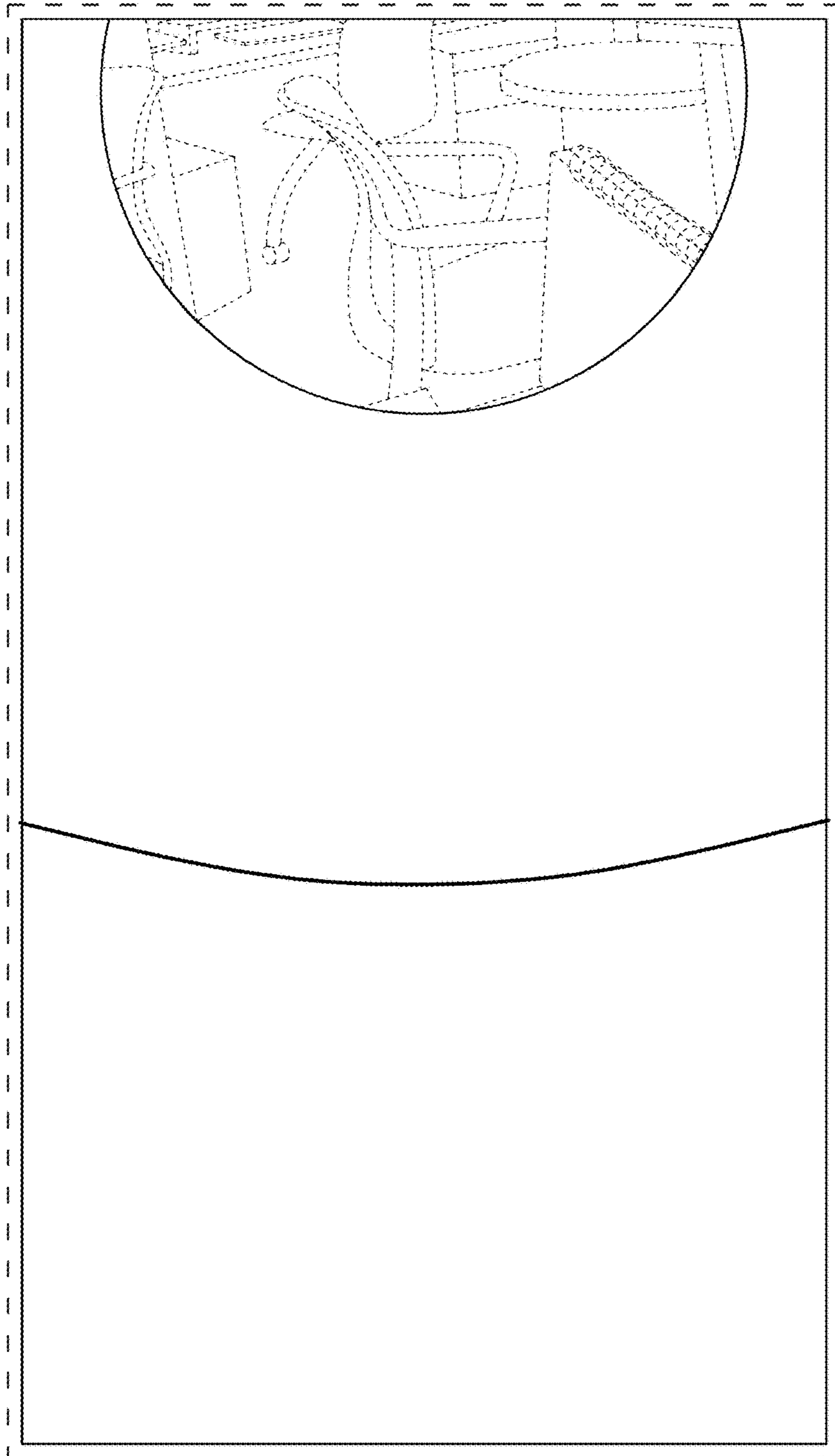

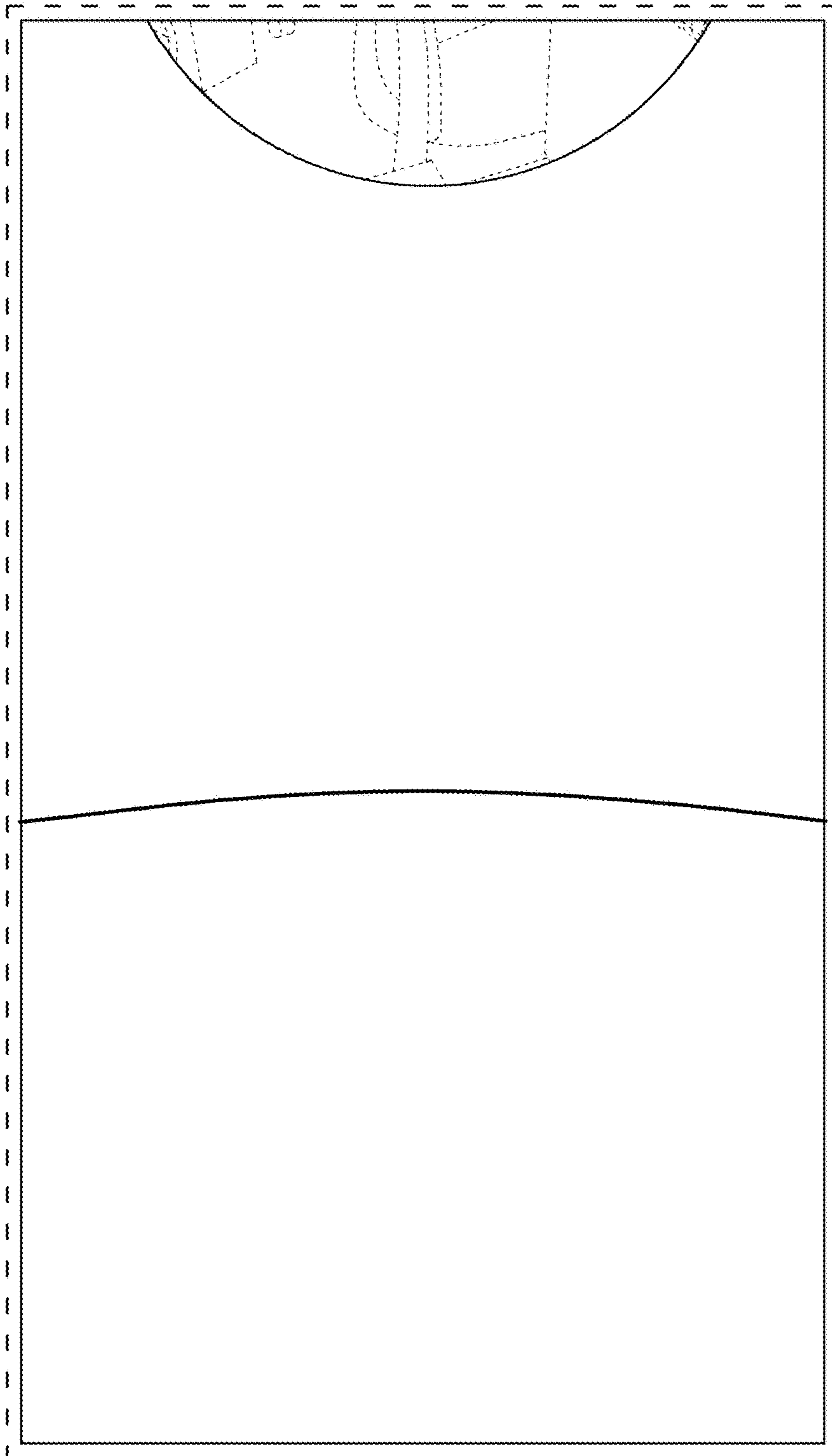
