**DESCRIPTION**

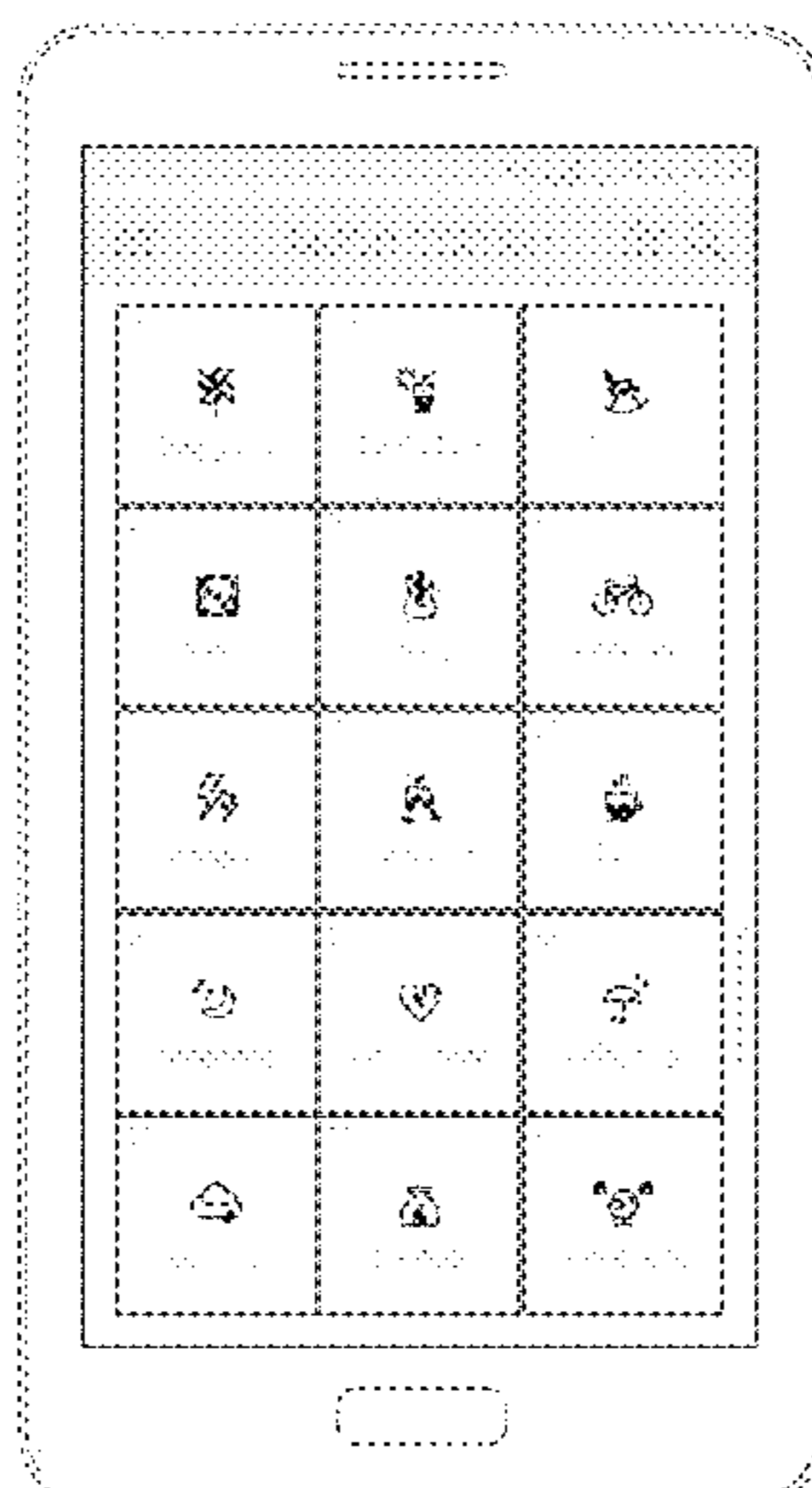

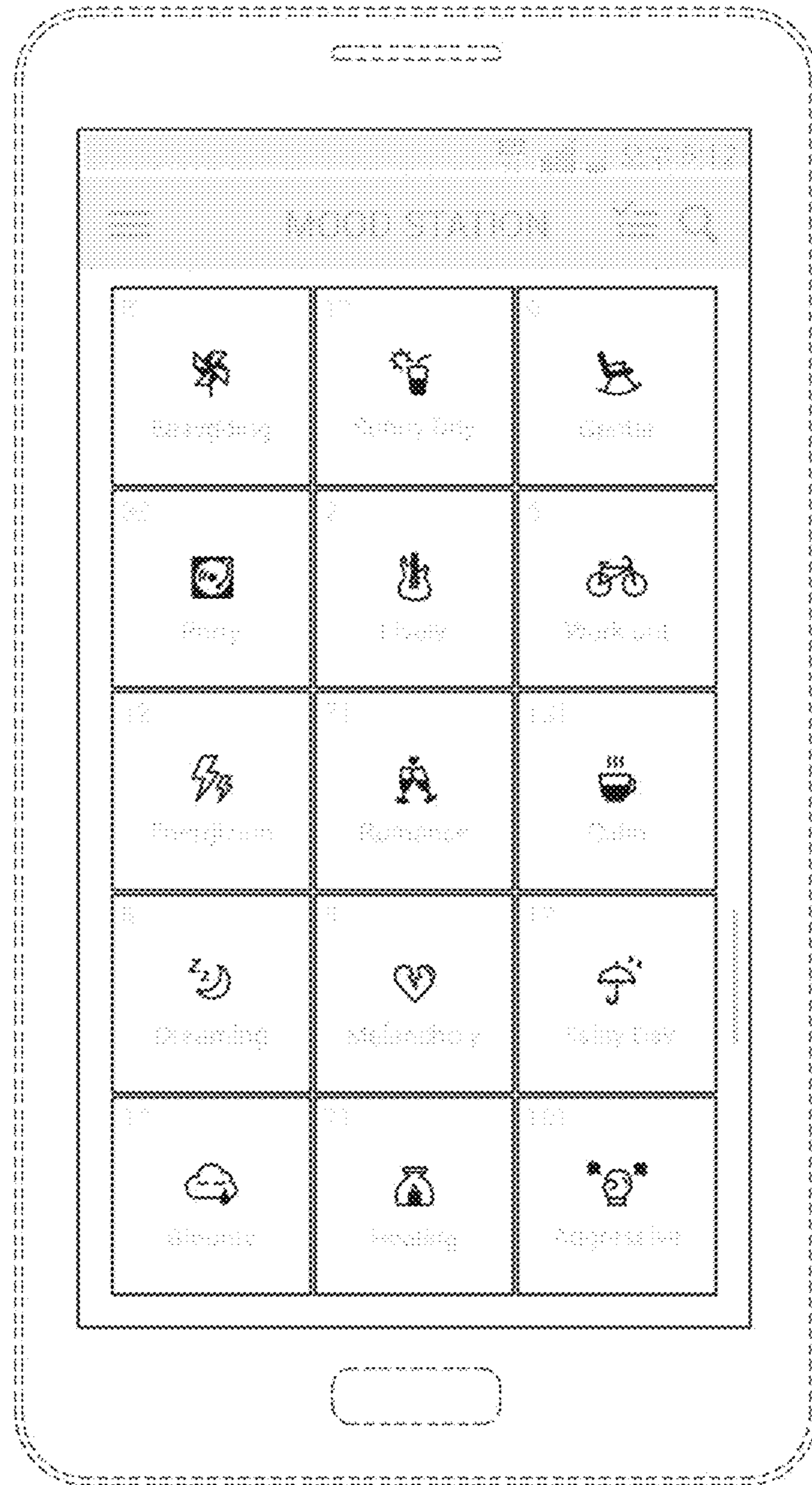
