DESCRIPTION

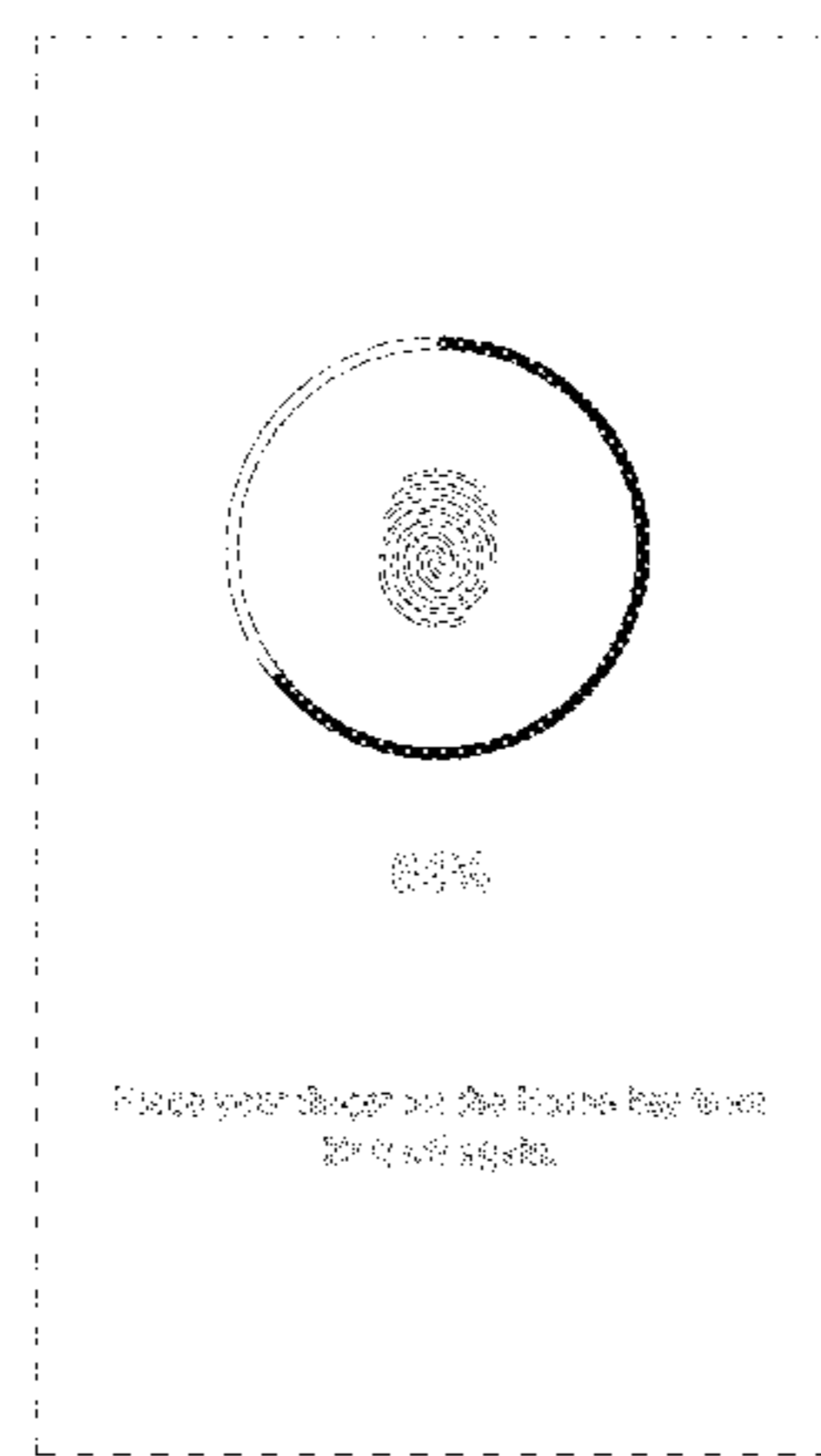
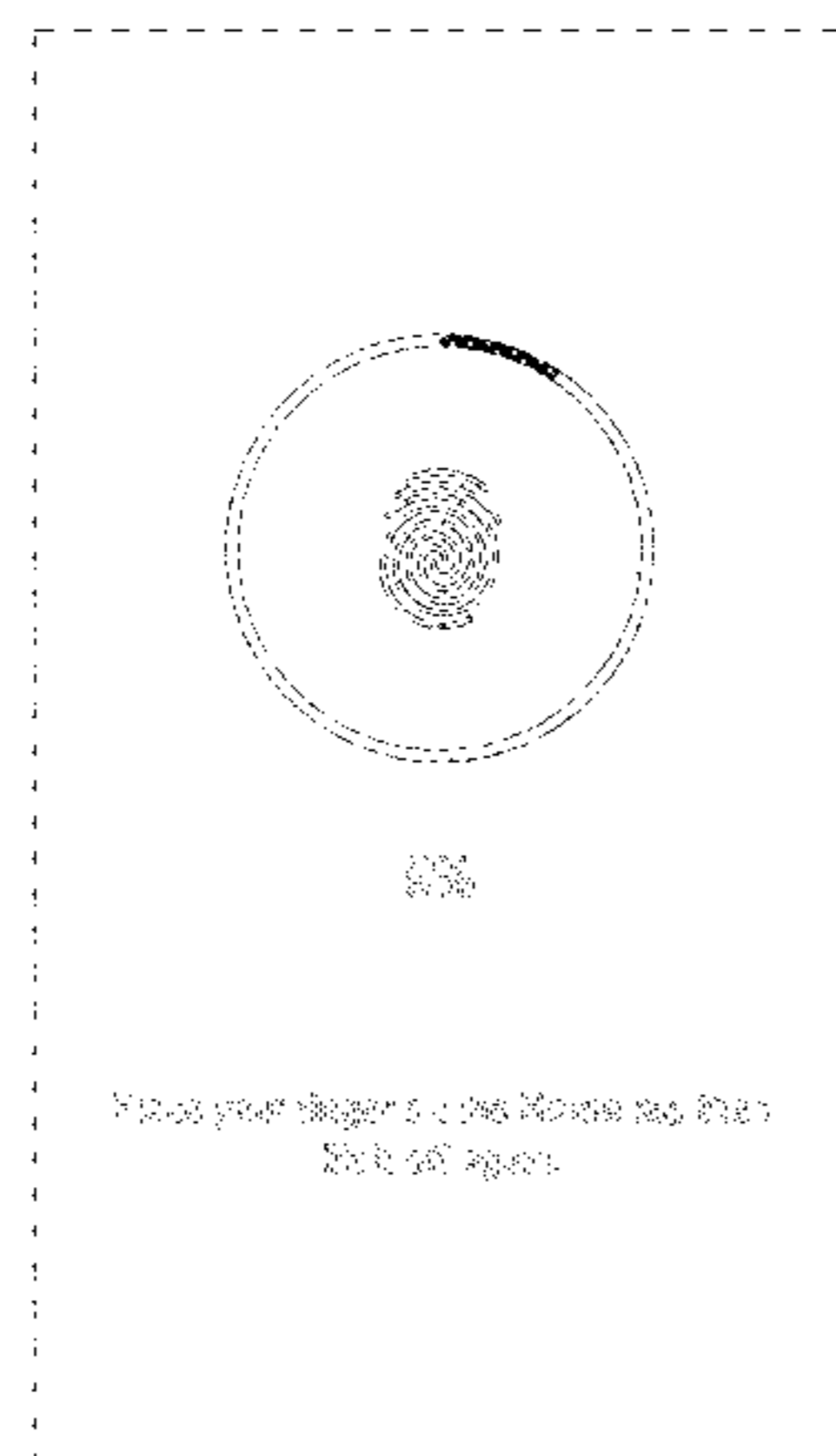
FIG. 1 is a first image in a sequence for a display screen or portion thereof with animated graphical user interface showing our new design;

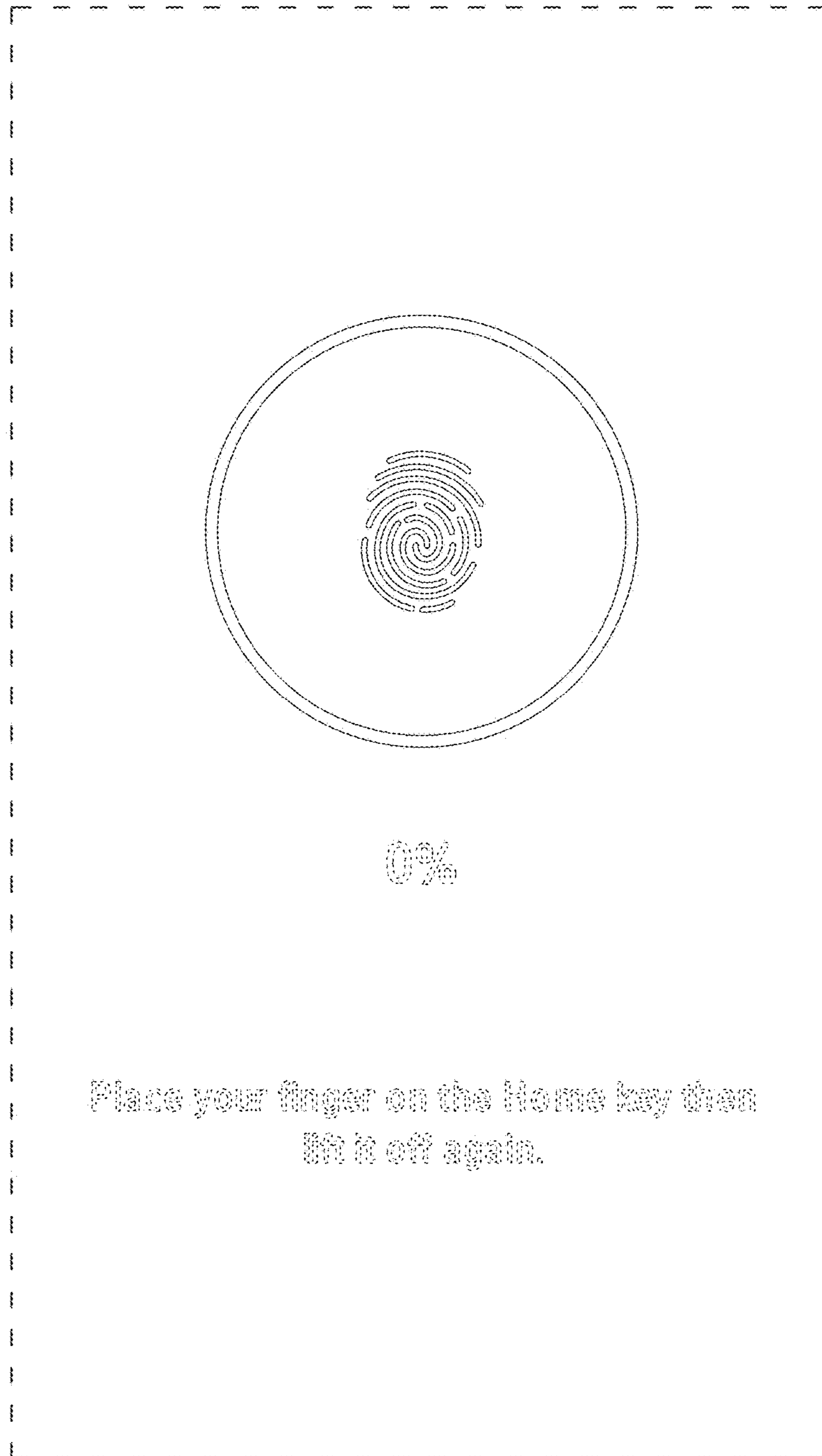
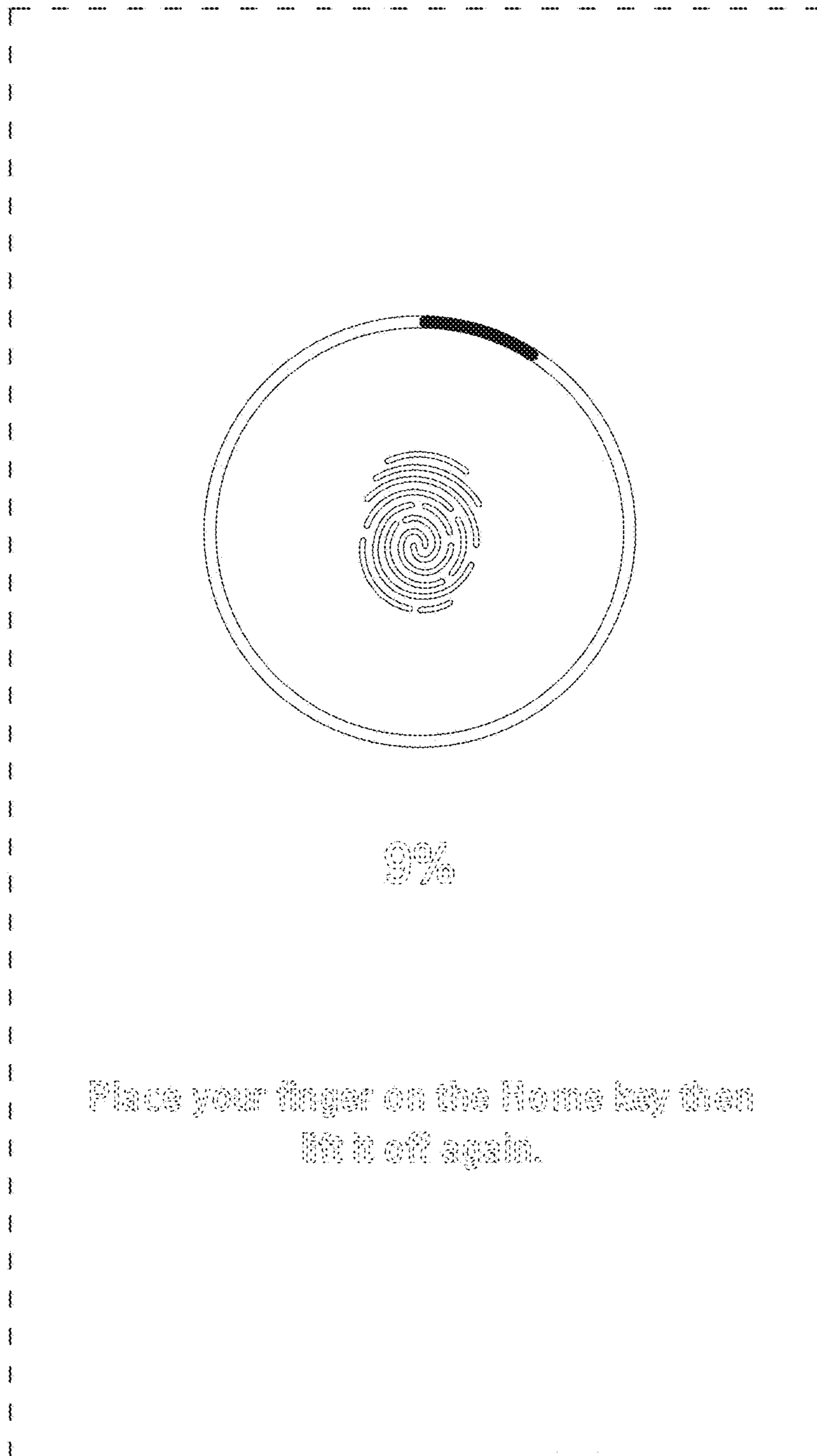

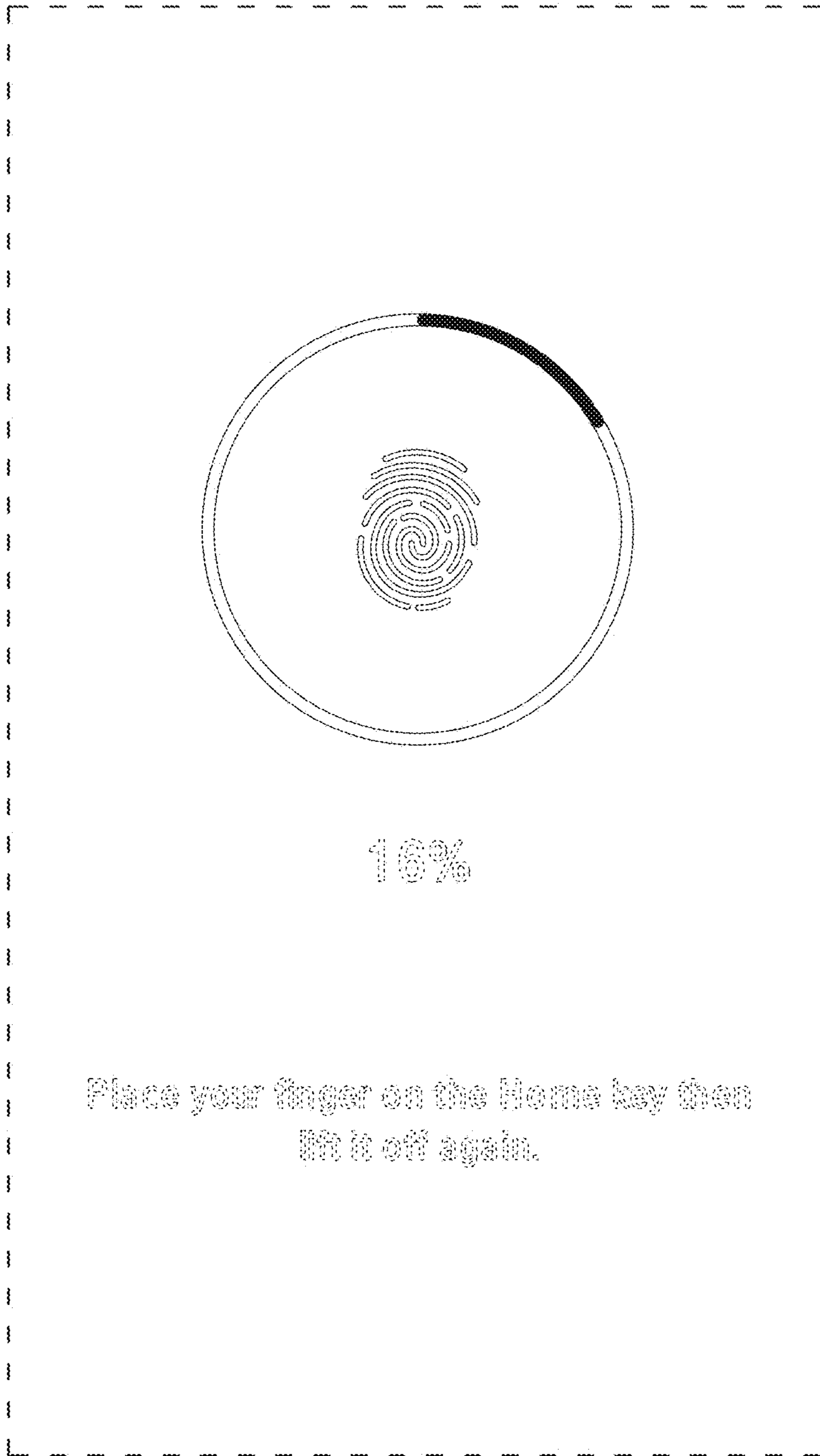

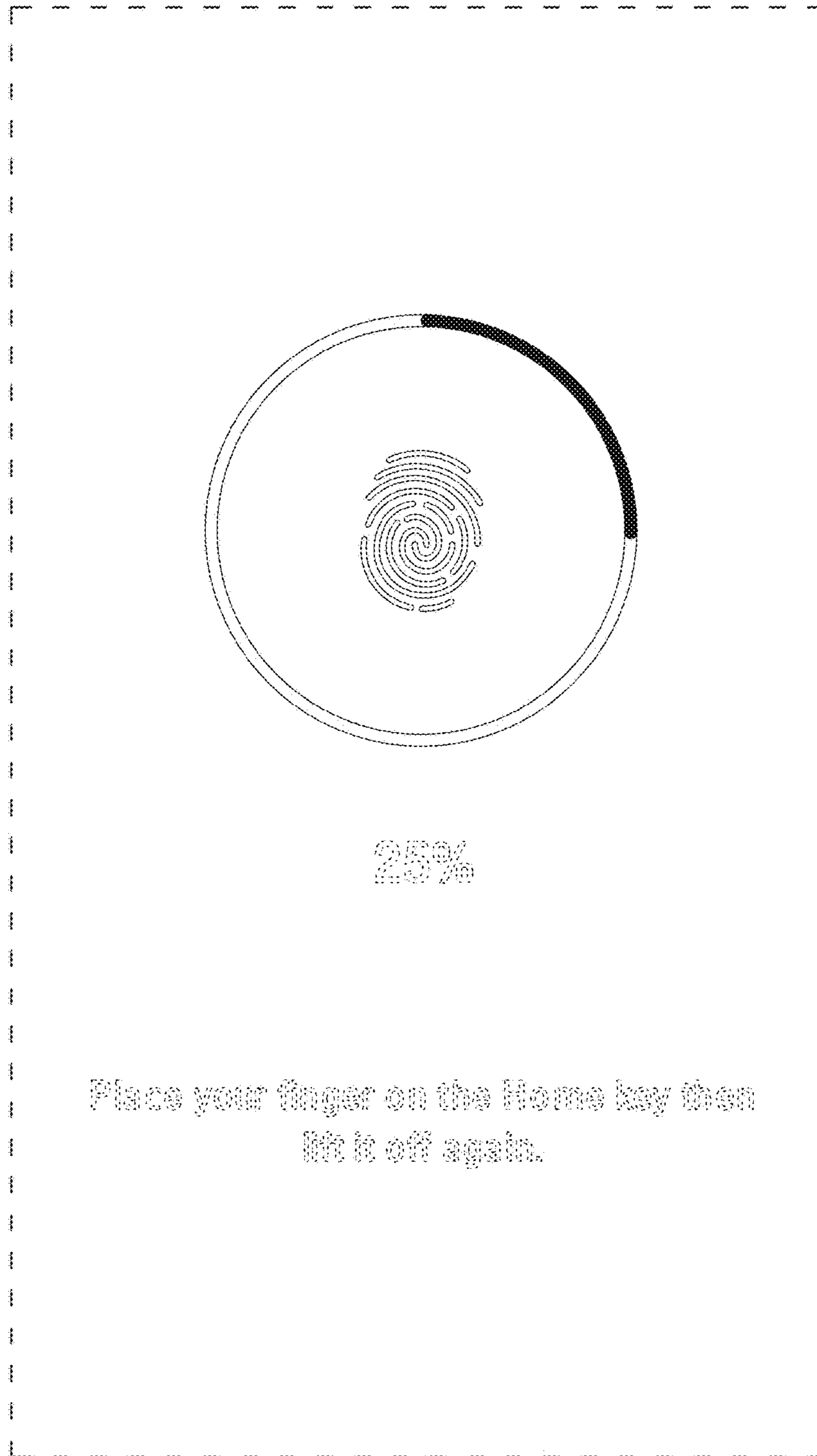

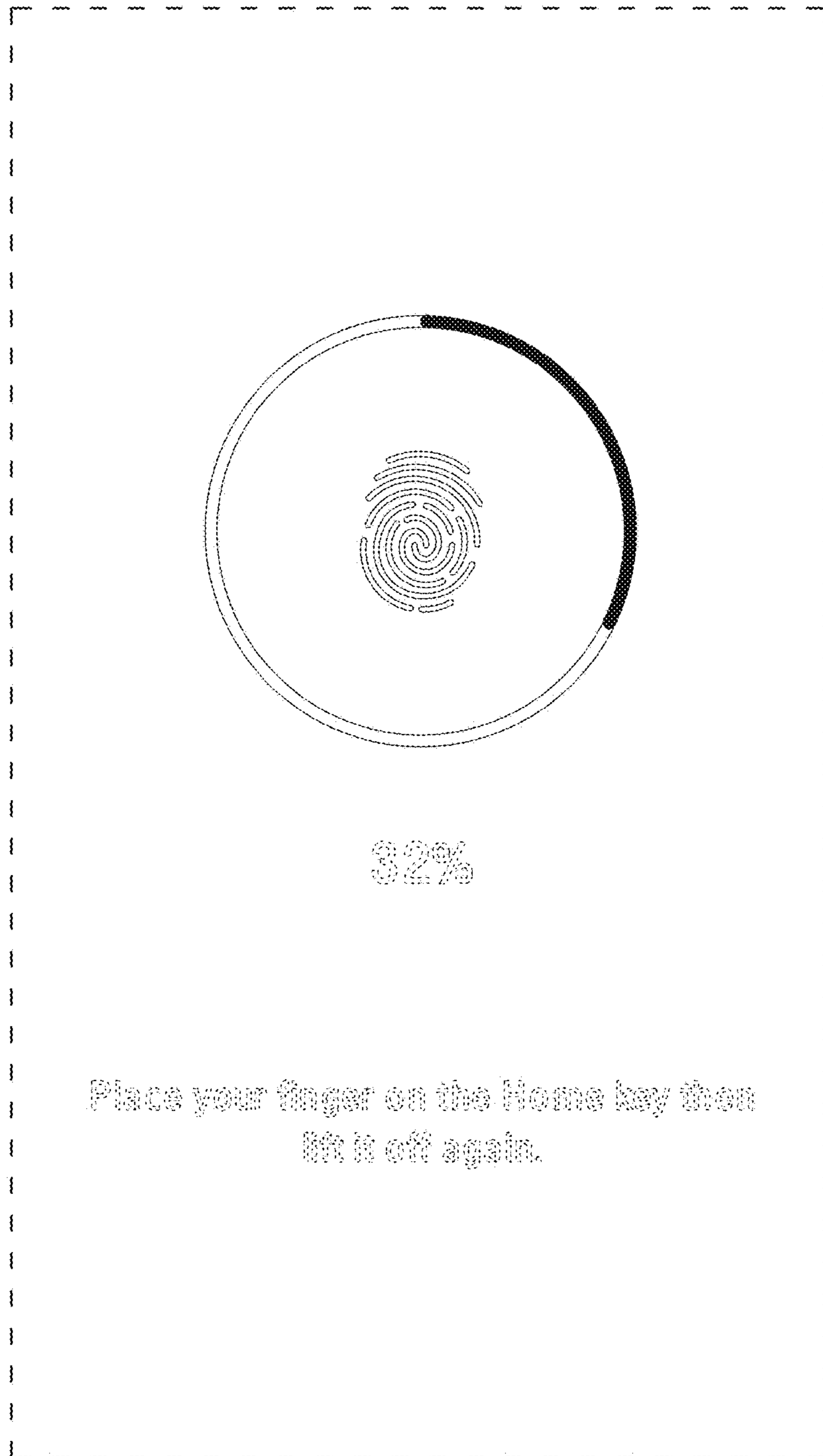

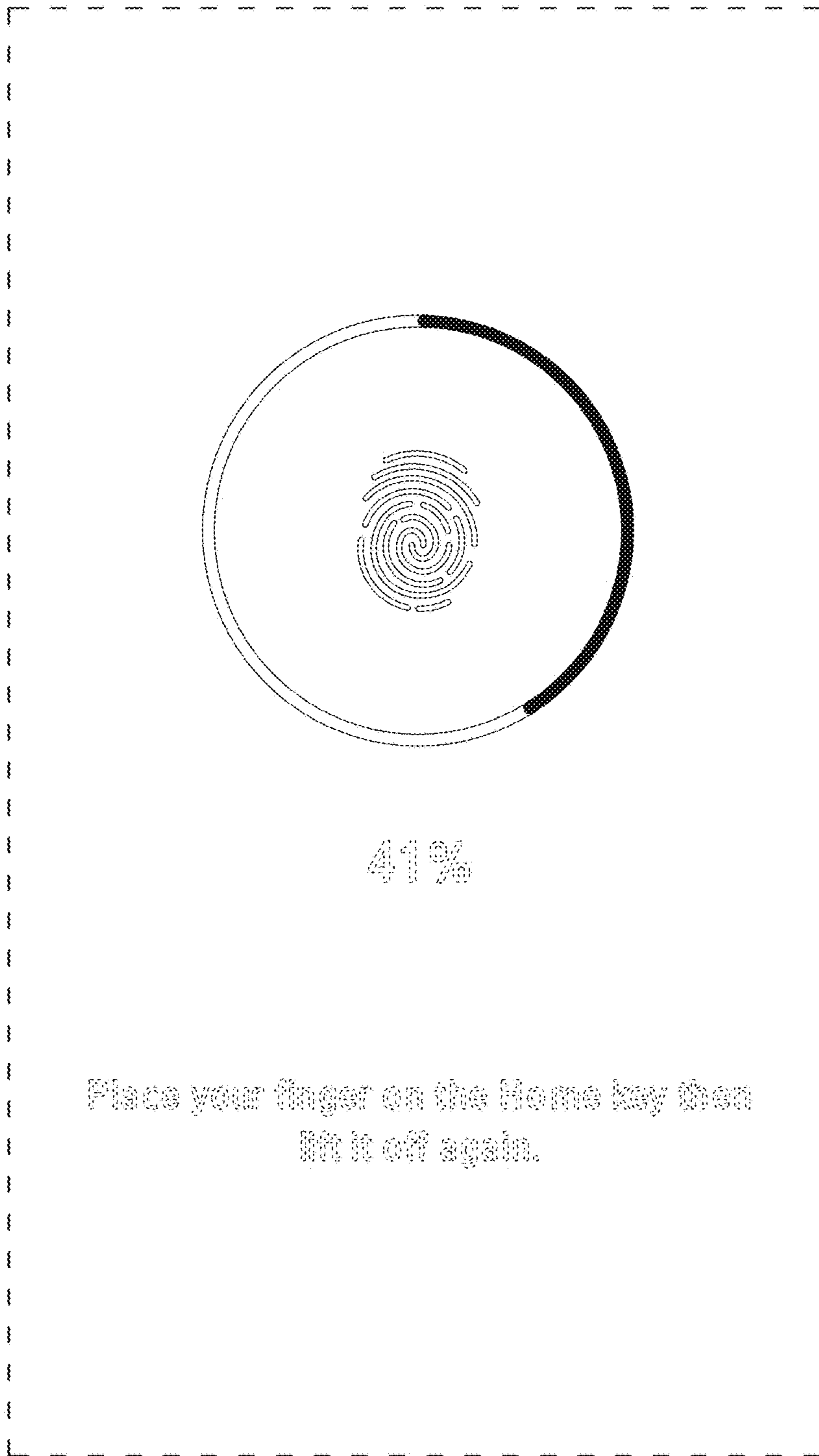

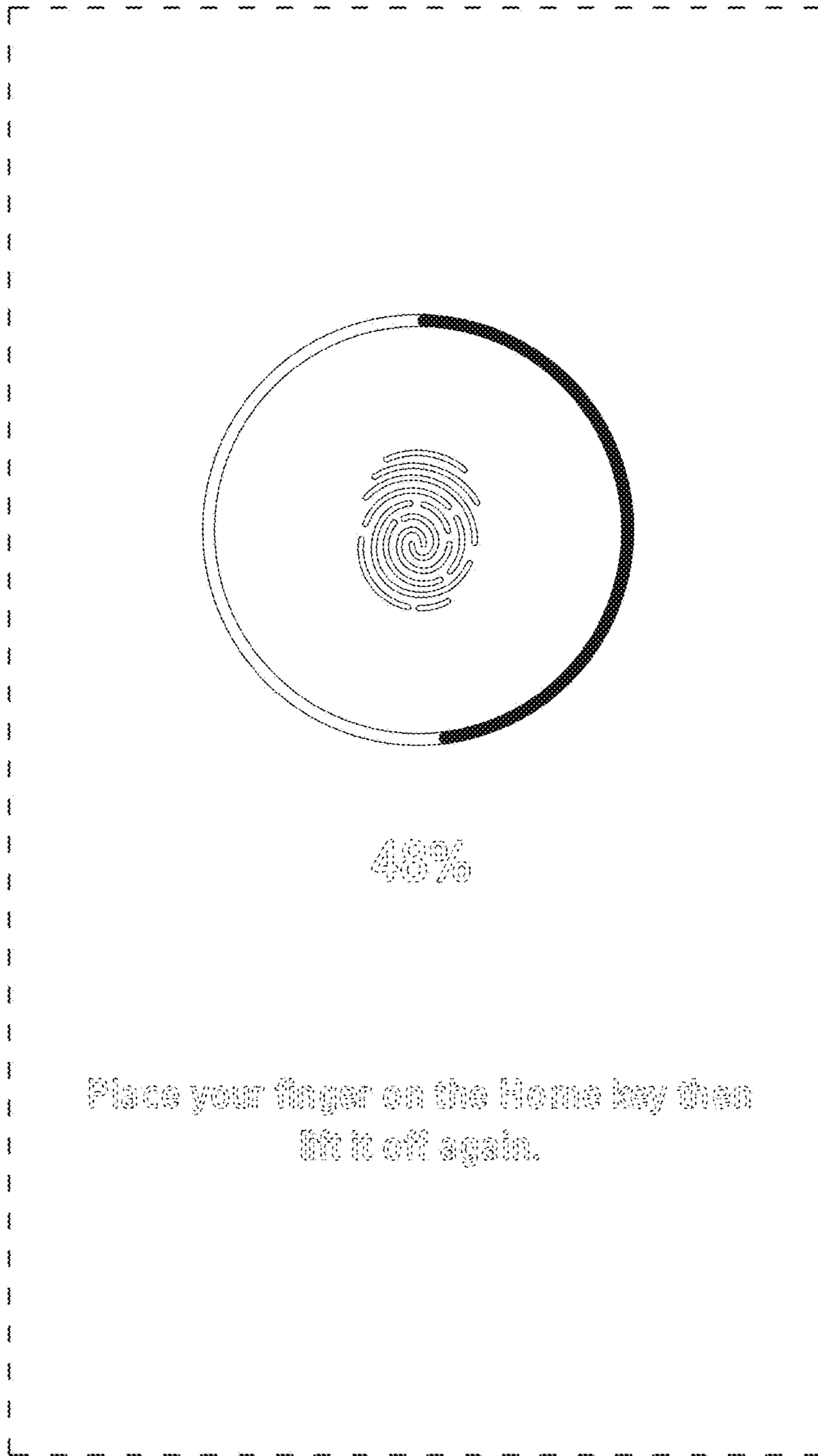

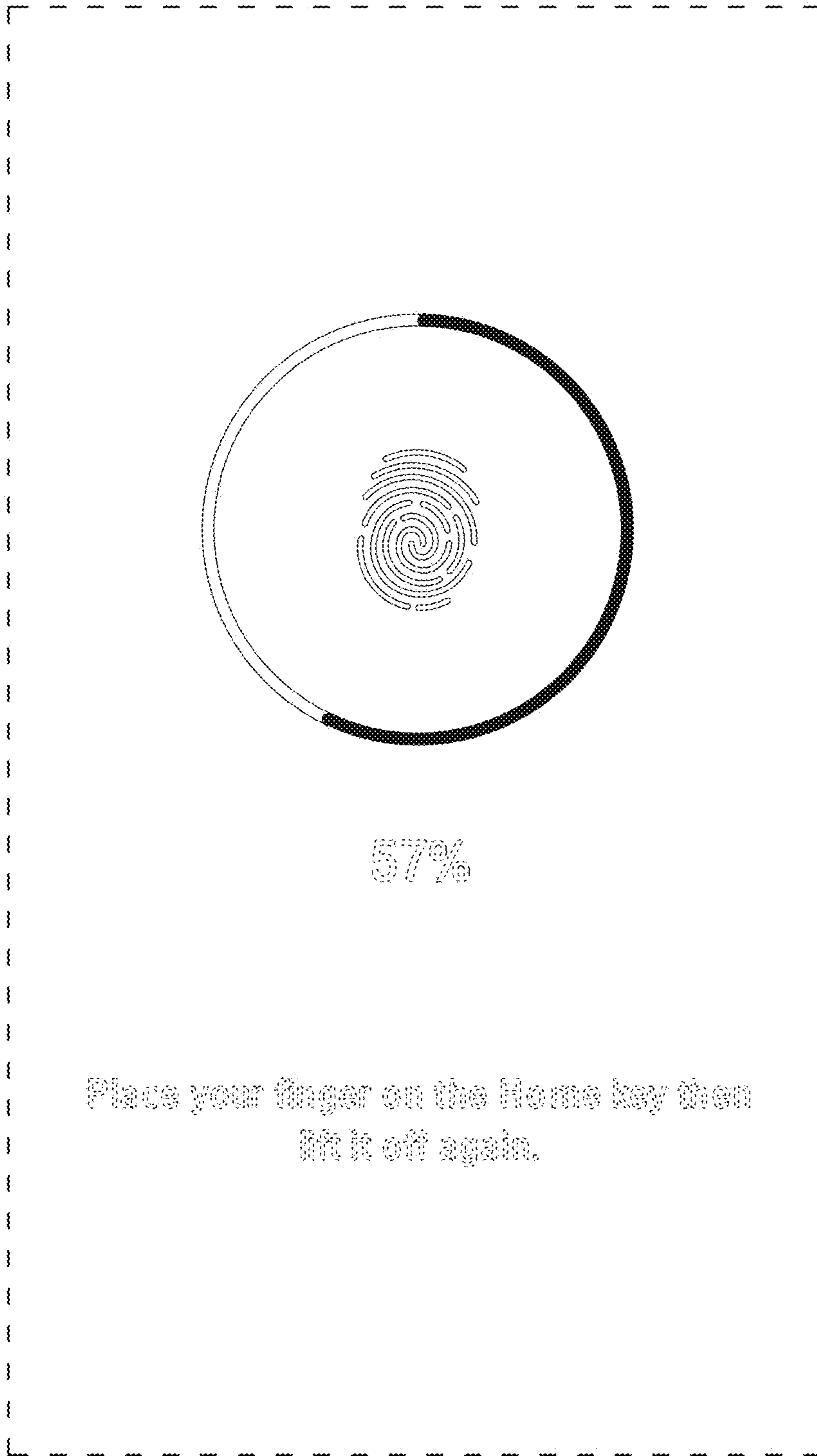

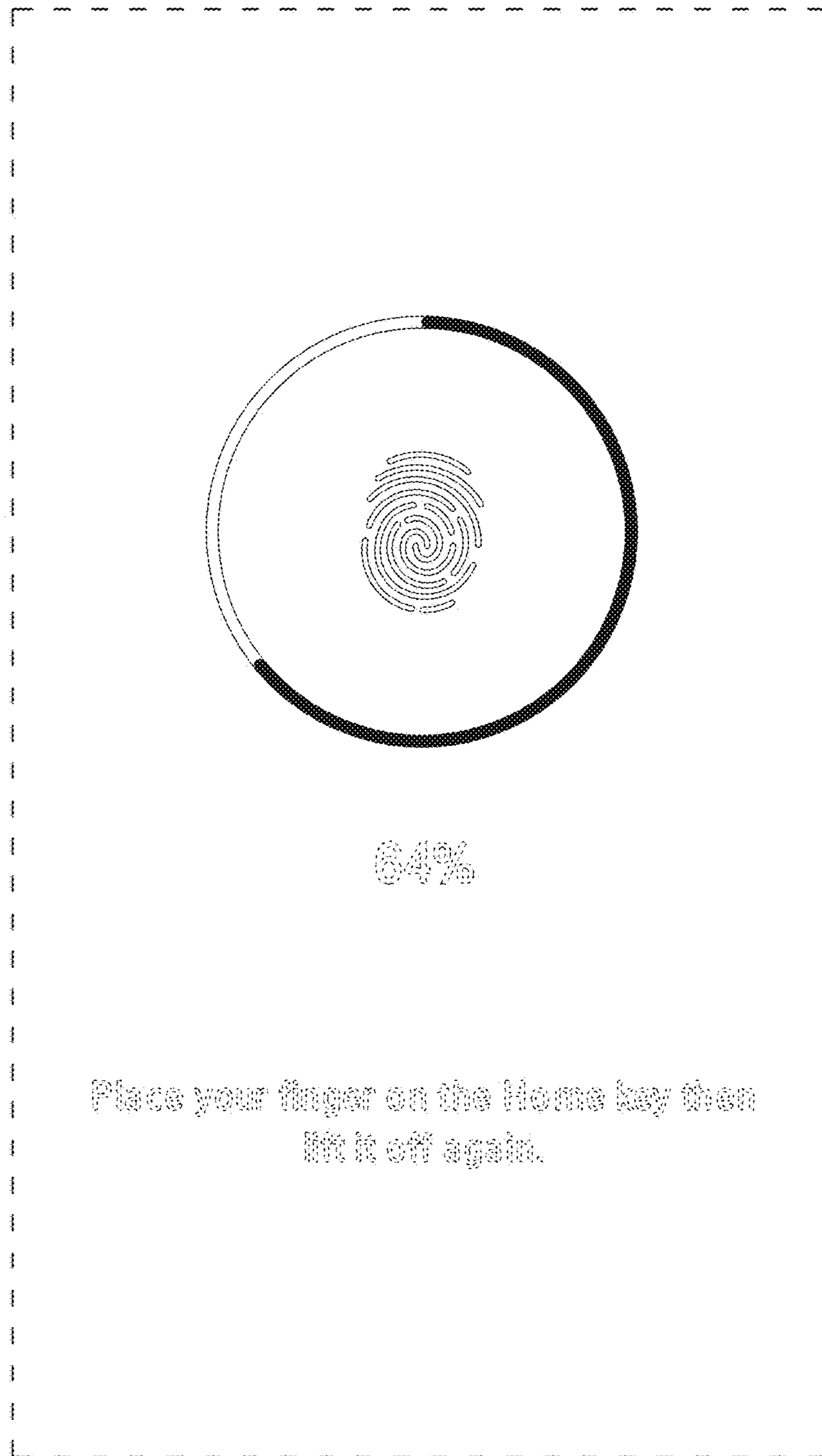

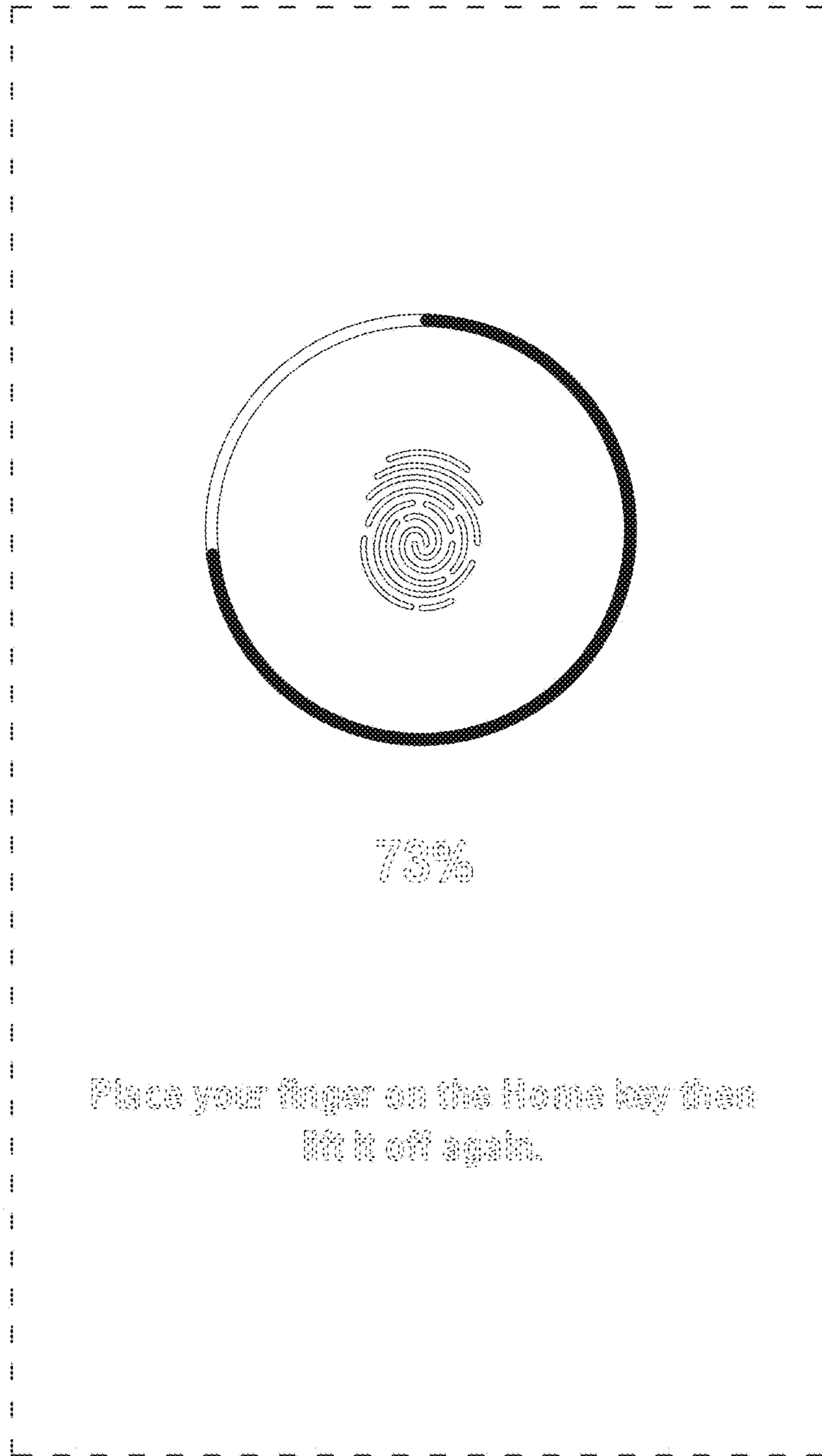
