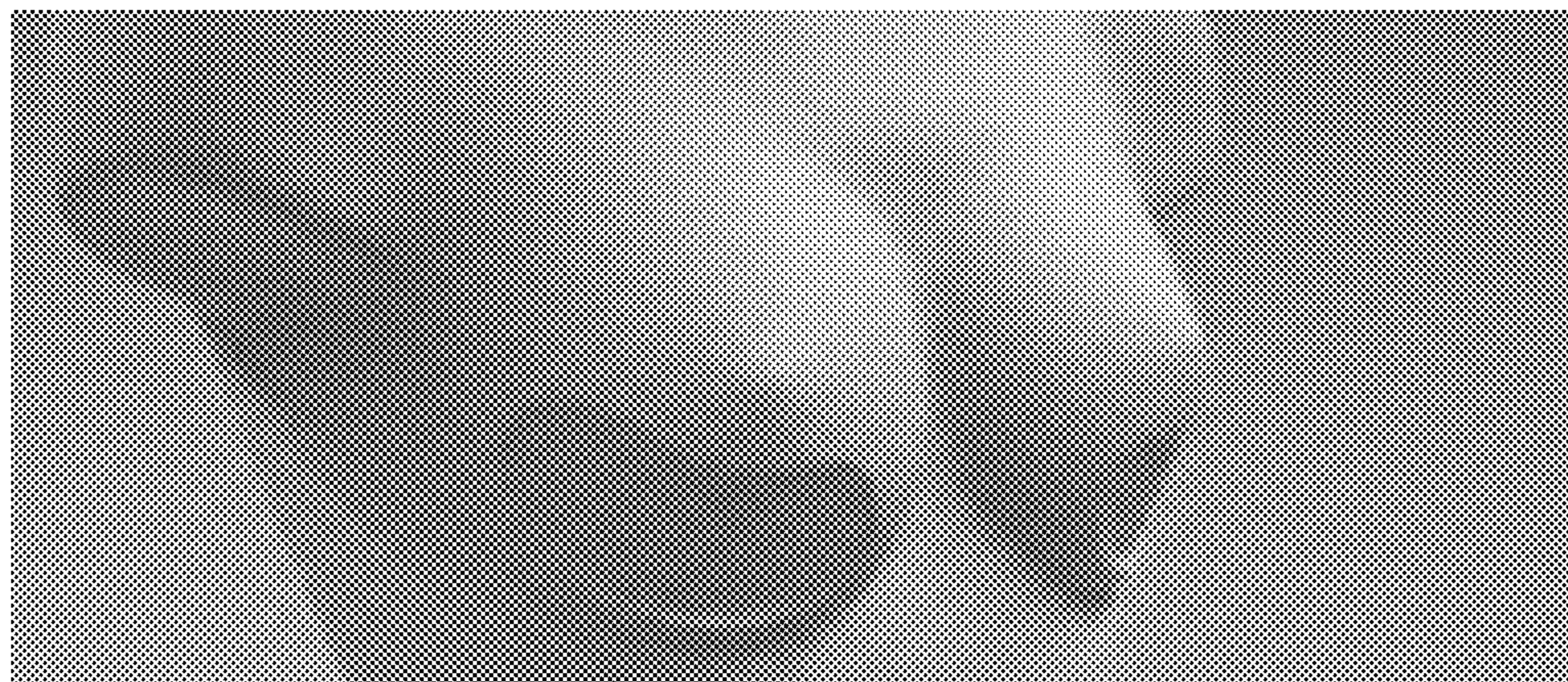
(57) **CLAIM**

The ornamental design for mannequin torso with cut-outs, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a design for mannequin torso with cut-outs for inlays according to the present disclosure.  
FIG. 2 is a left side view of the design for mannequin torso with cut-outs for inlays of FIG. 1.  
FIG. 3 is a right side view of the design for mannequin torso with cut-outs for inlays of FIG. 1; and,  
FIG. 4 is a front perspective view of the design for mannequin torso with cut-outs for inlays of FIG. 1.

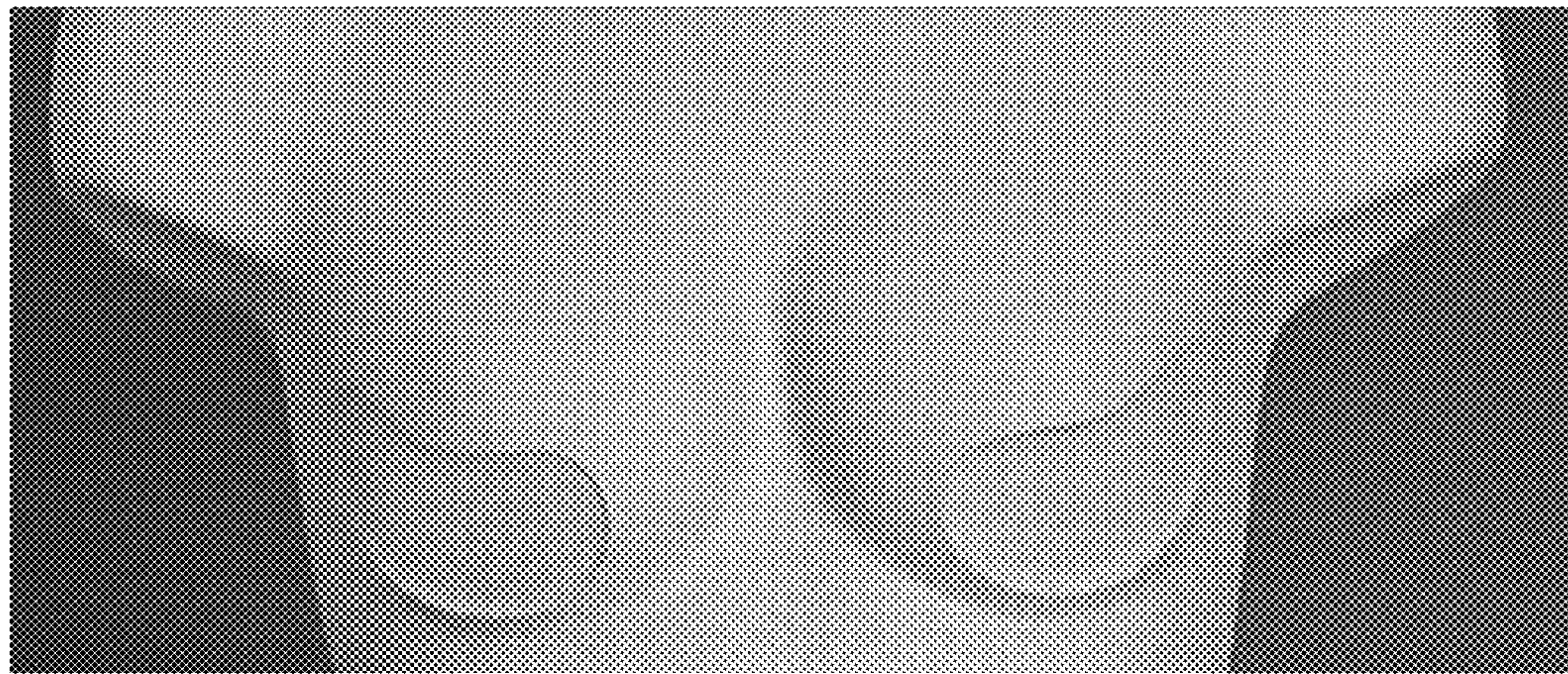

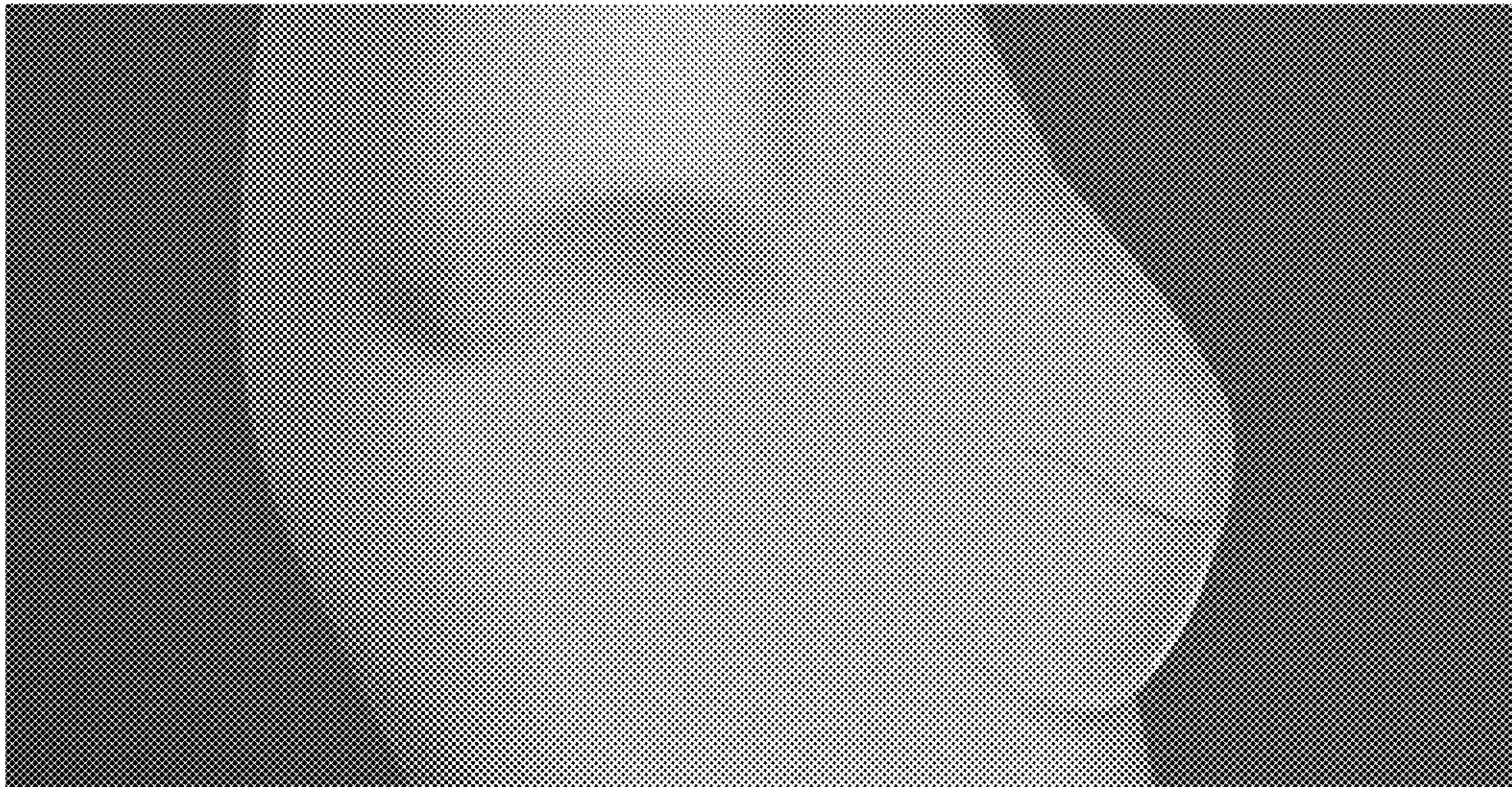

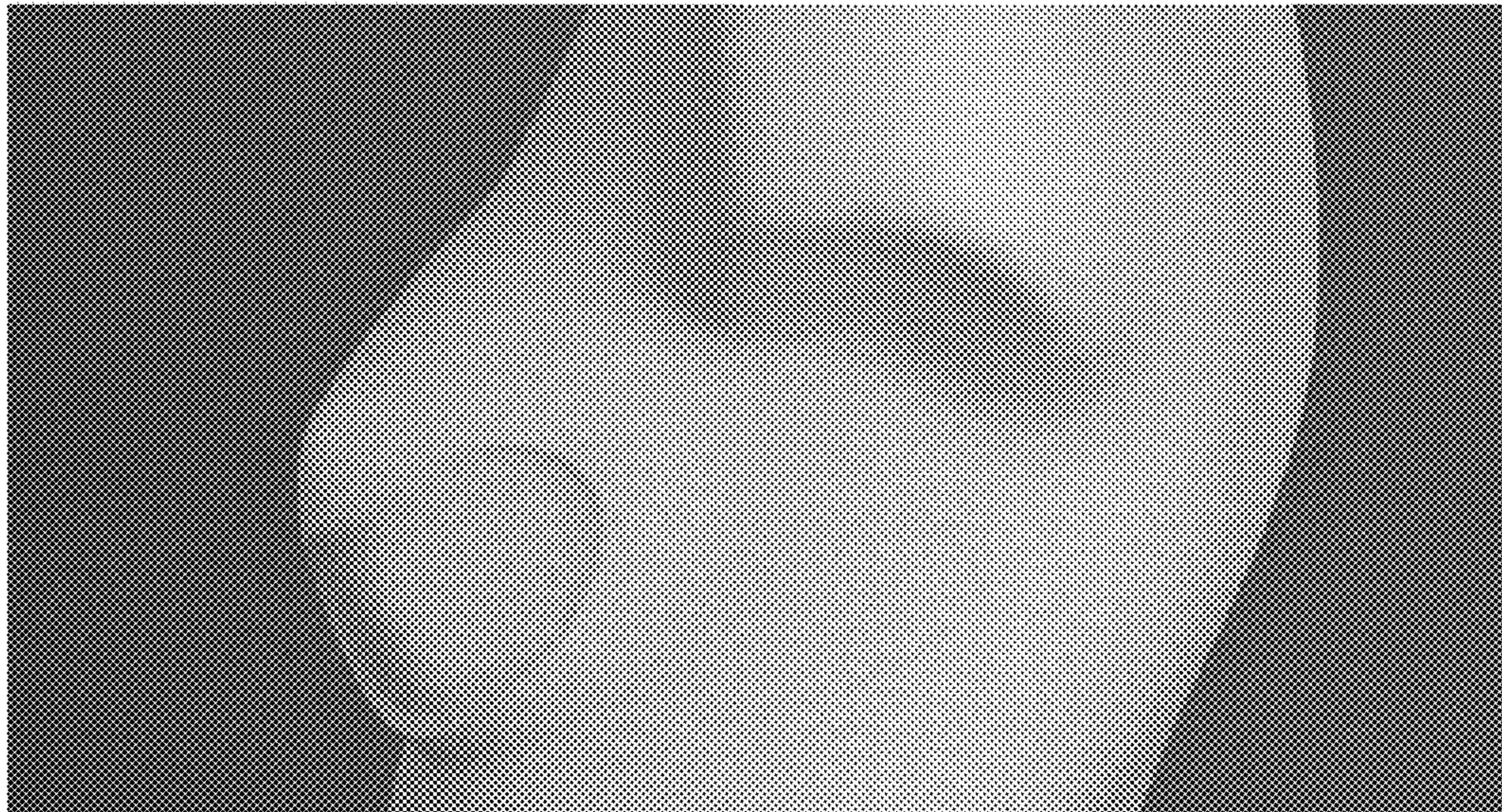

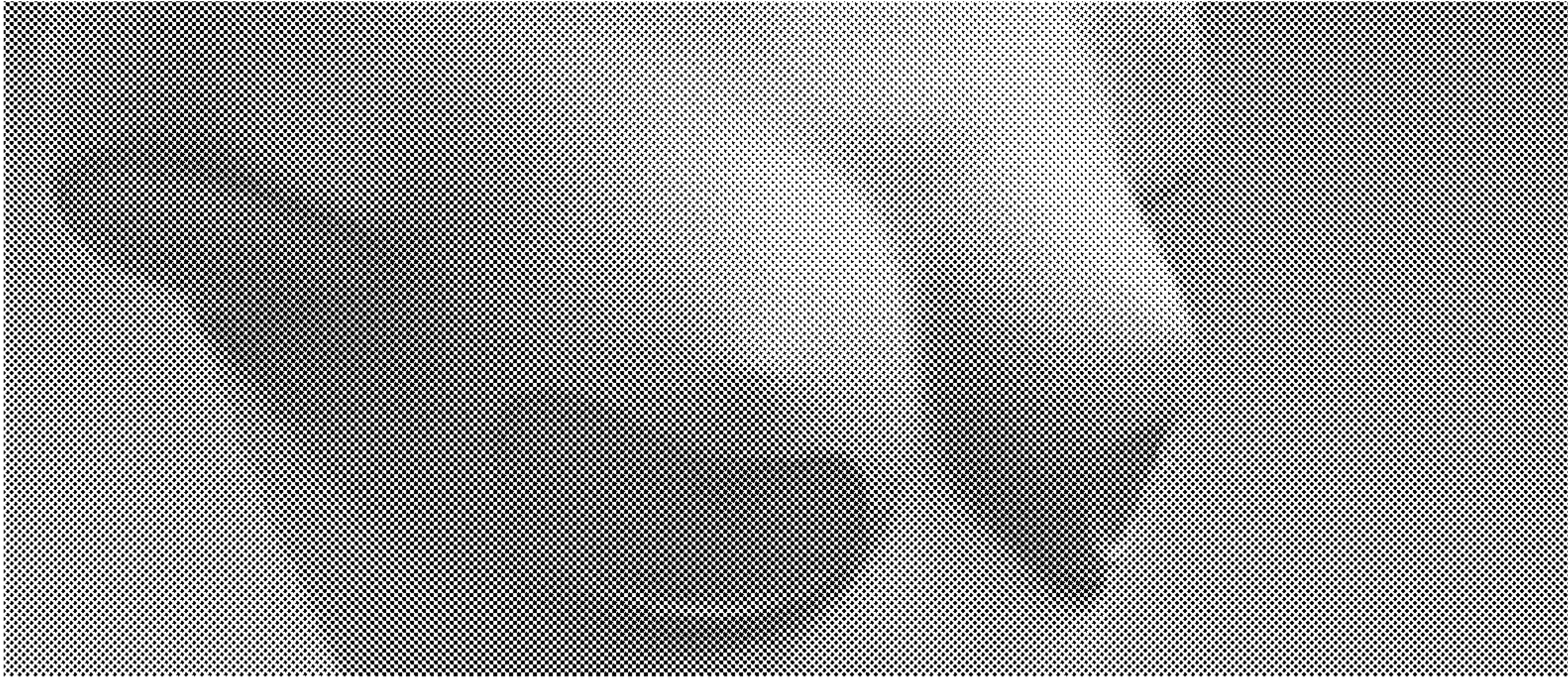
