**DESCRIPTION**

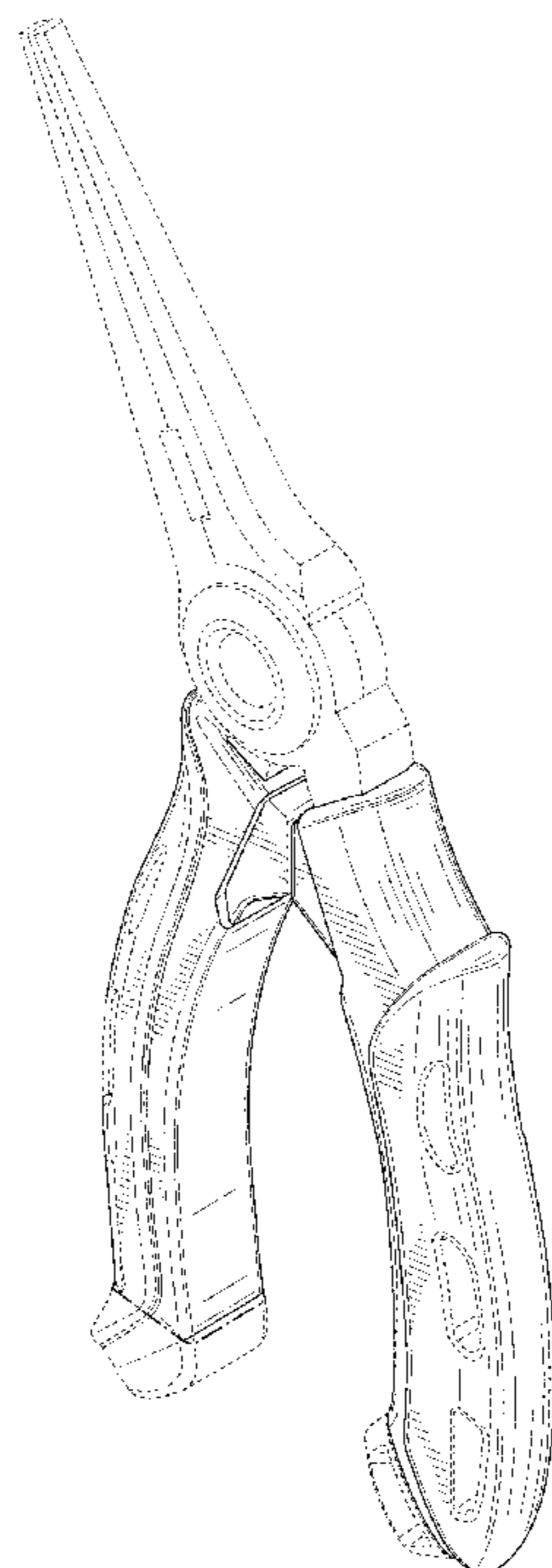
FIG. 1 is a perspective view of the fishing pliers according to the present invention;

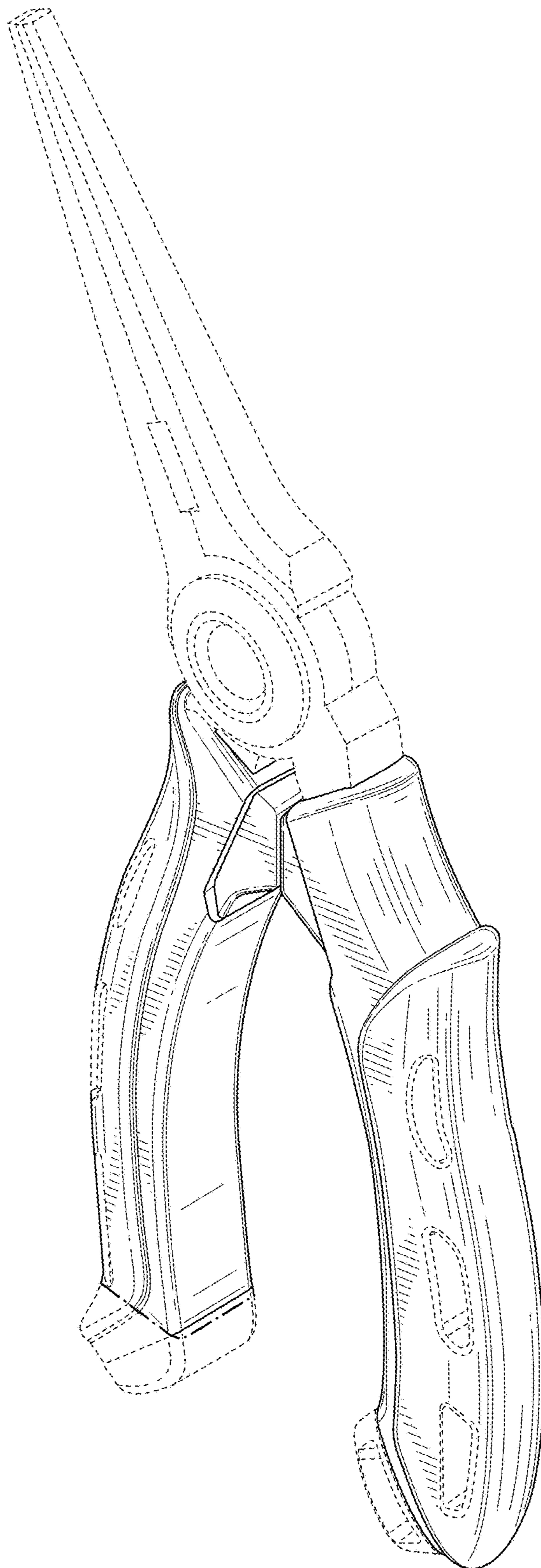

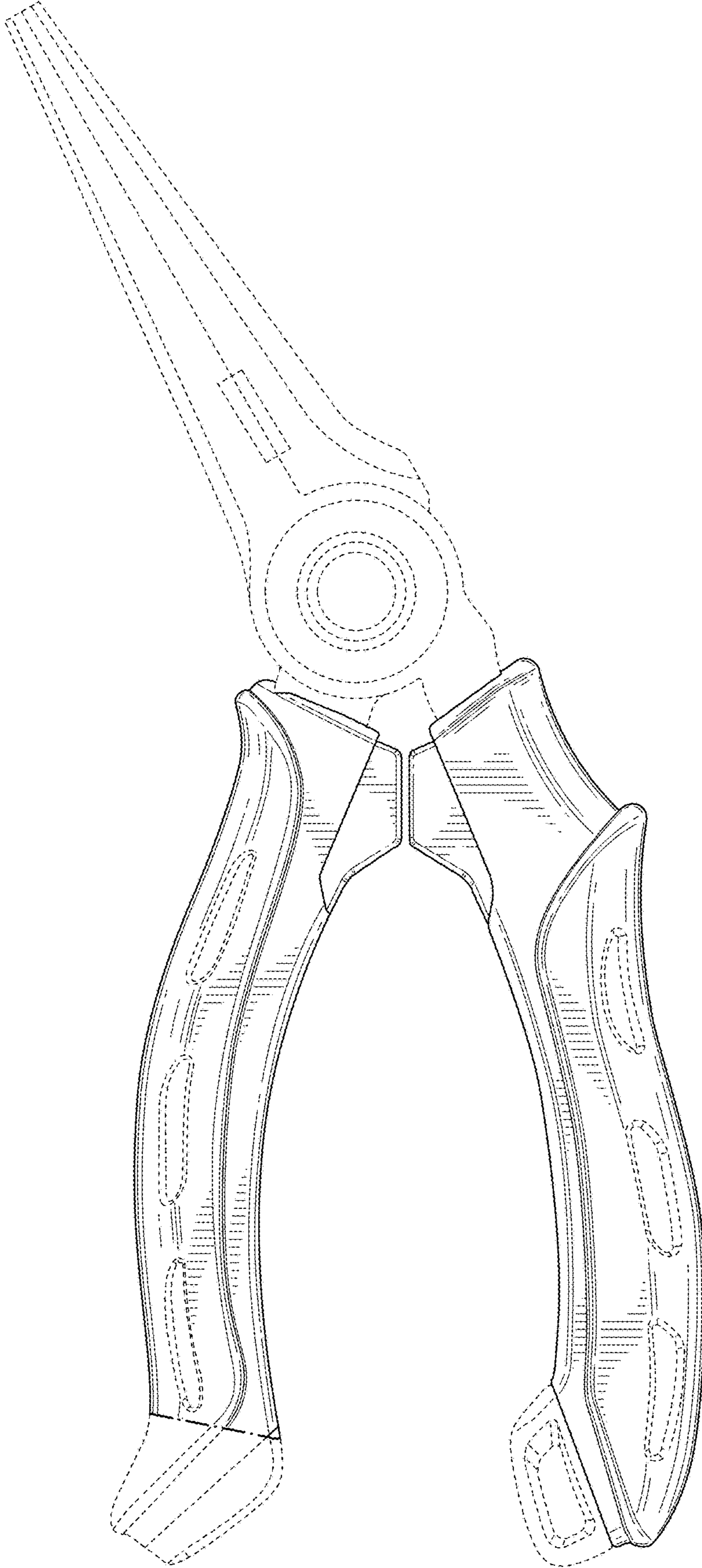

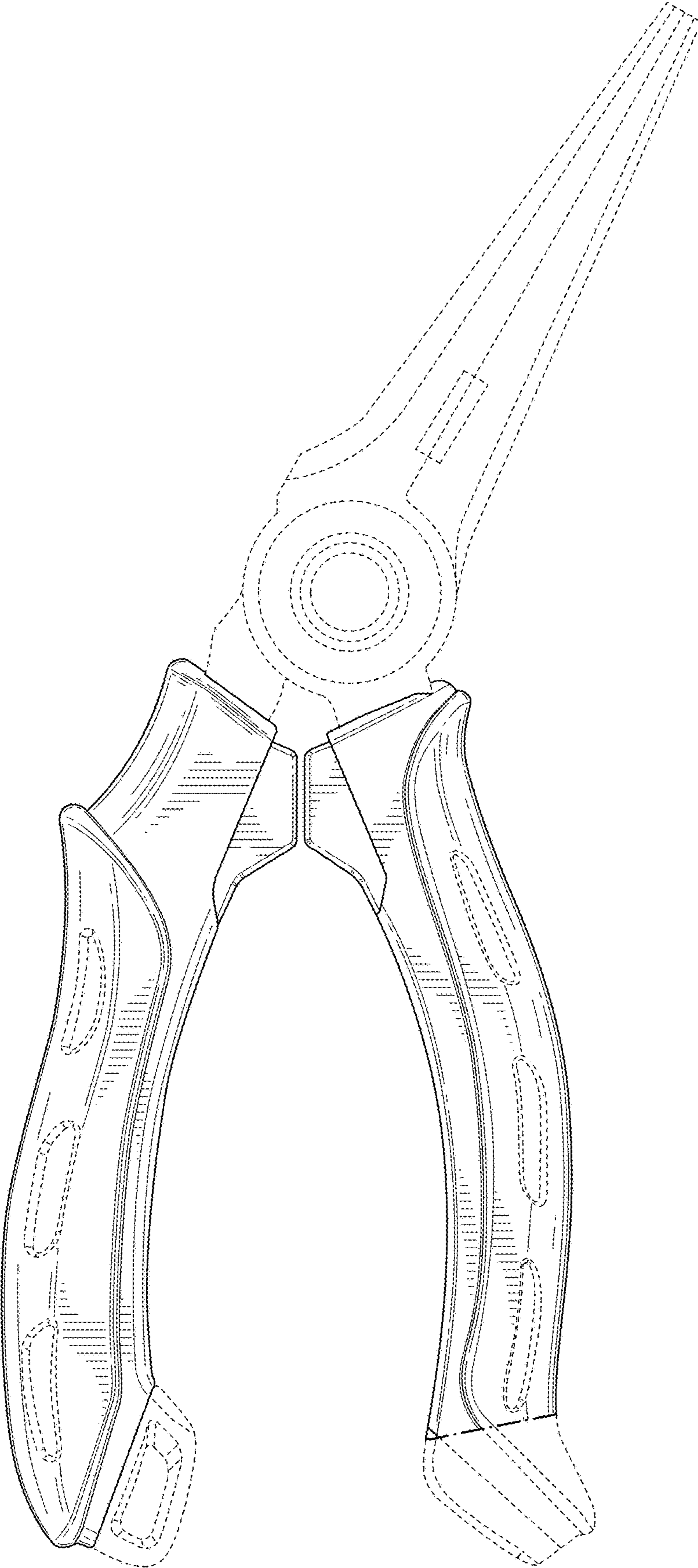

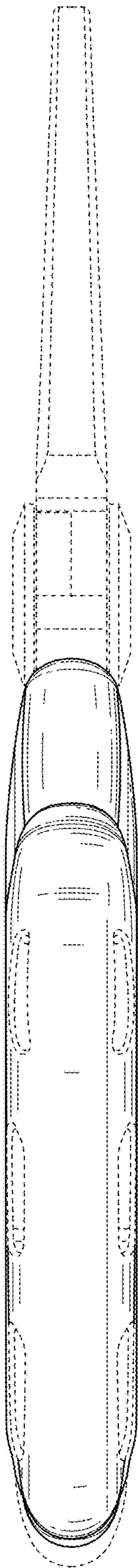

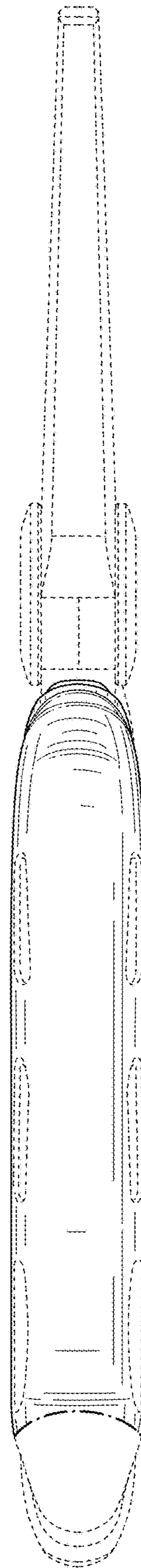
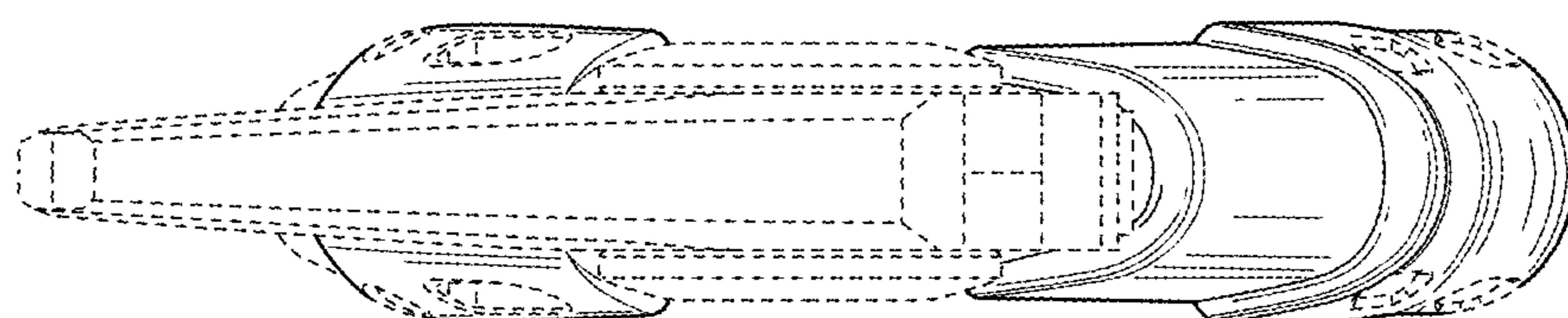
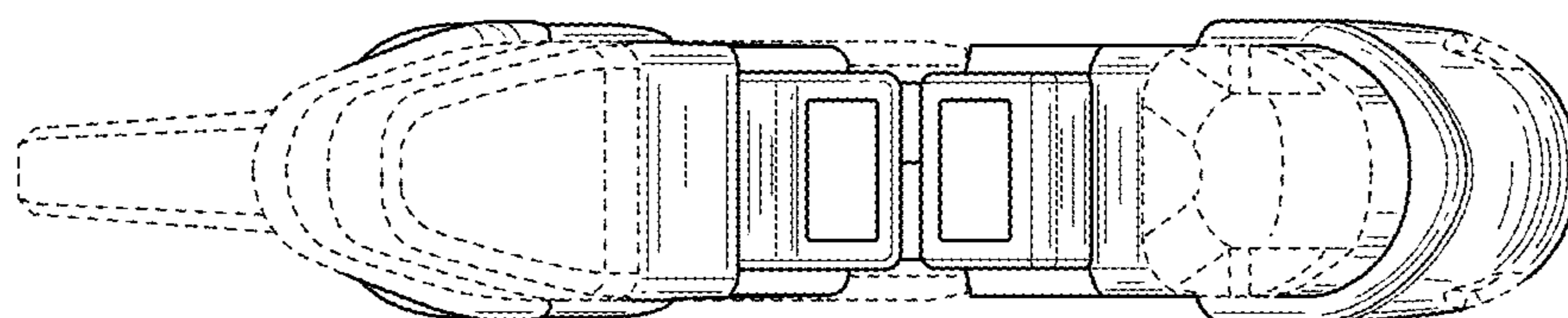
