The ornamental design for a top sheet for an absorbent pad, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a top sheet for an absorbent pad showing our new design; FIG. 2 is a top plan view of the top sheet for an absorbent pad of FIG. 1; and, FIG. 3 is a bottom plan view of the top sheet for an absorbent pad of FIG. 1.

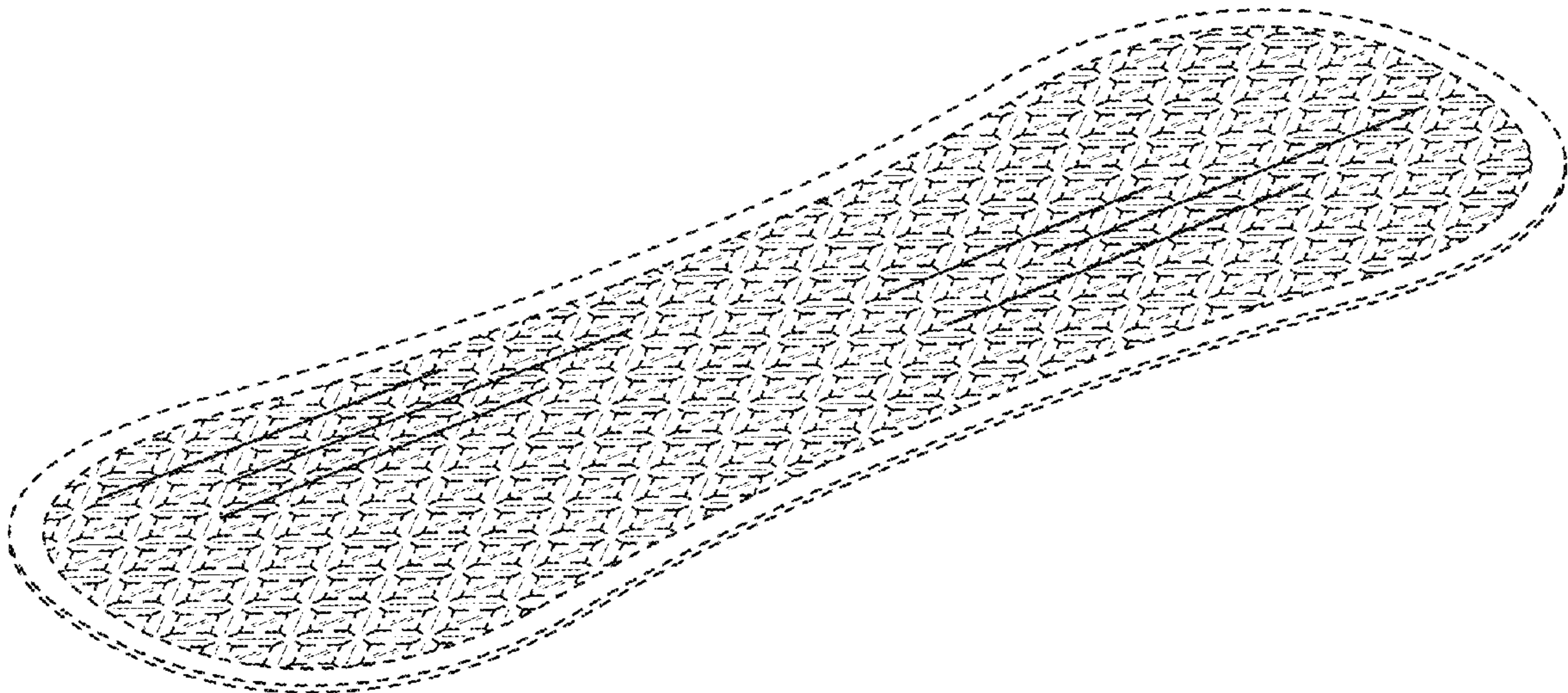

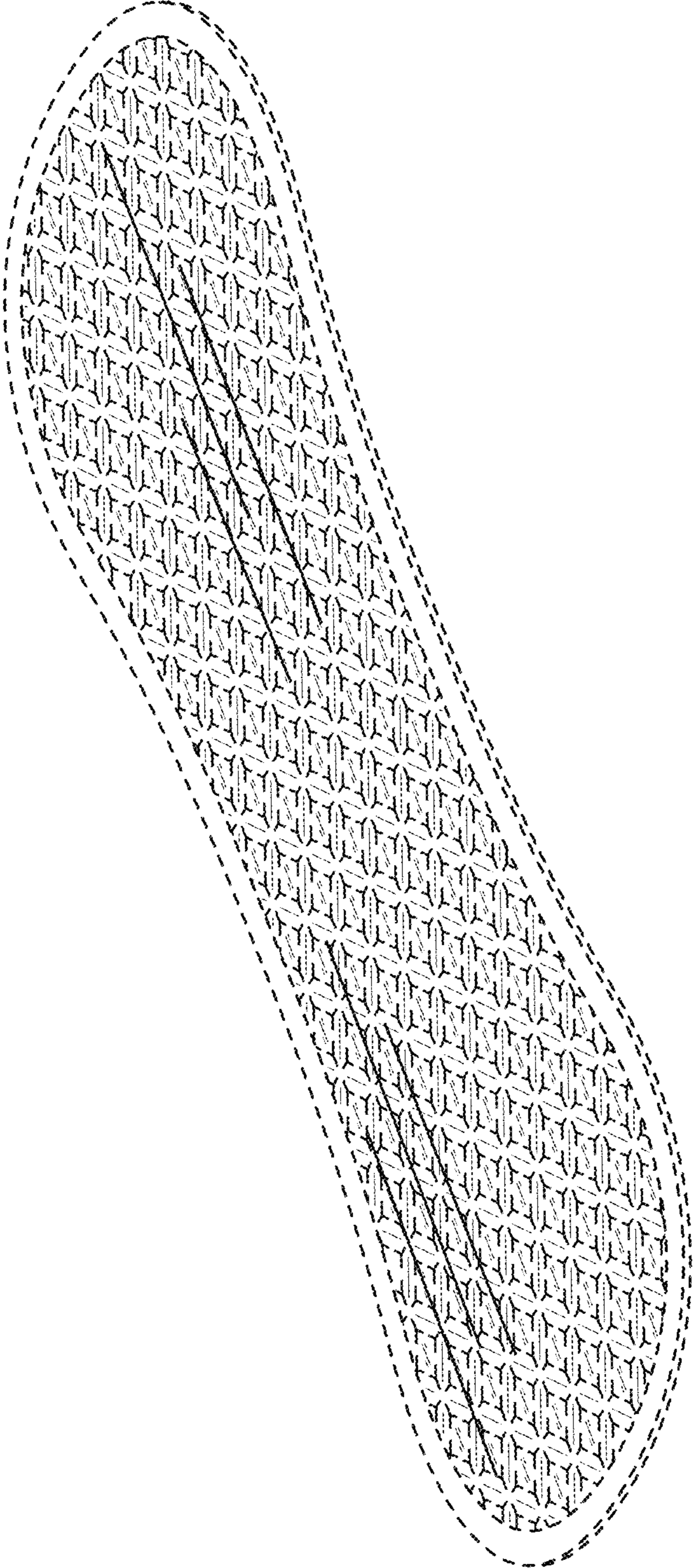

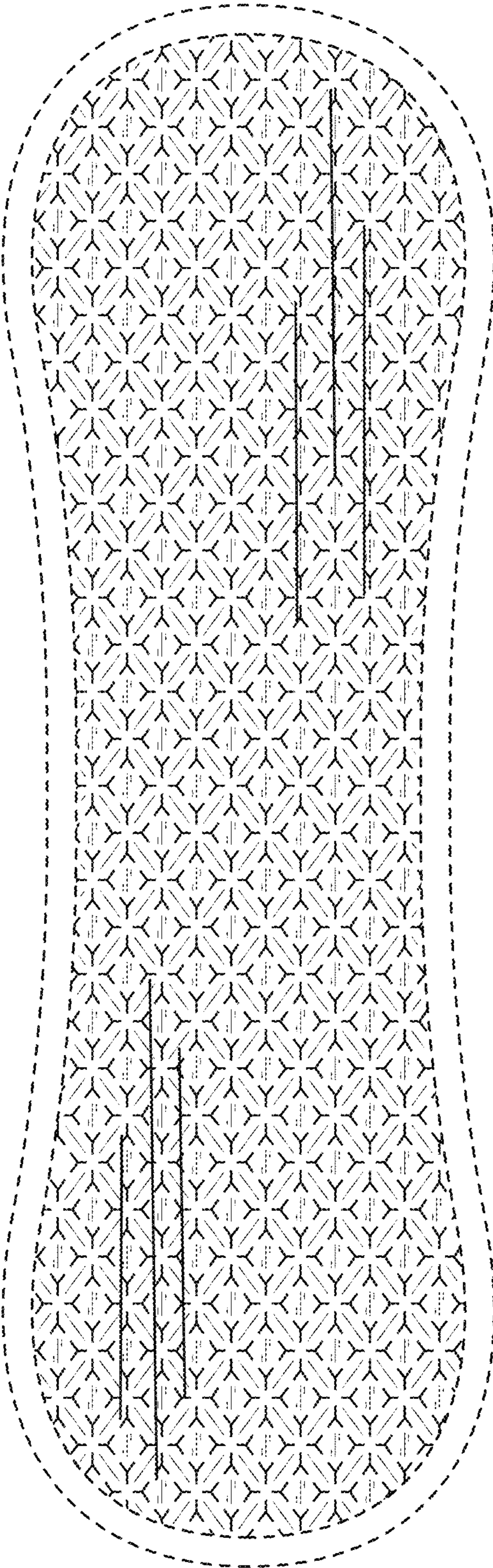
