DESCRIPTION

FIG. 1 is a front perspective view of an x-ray apparatus showing my new design;

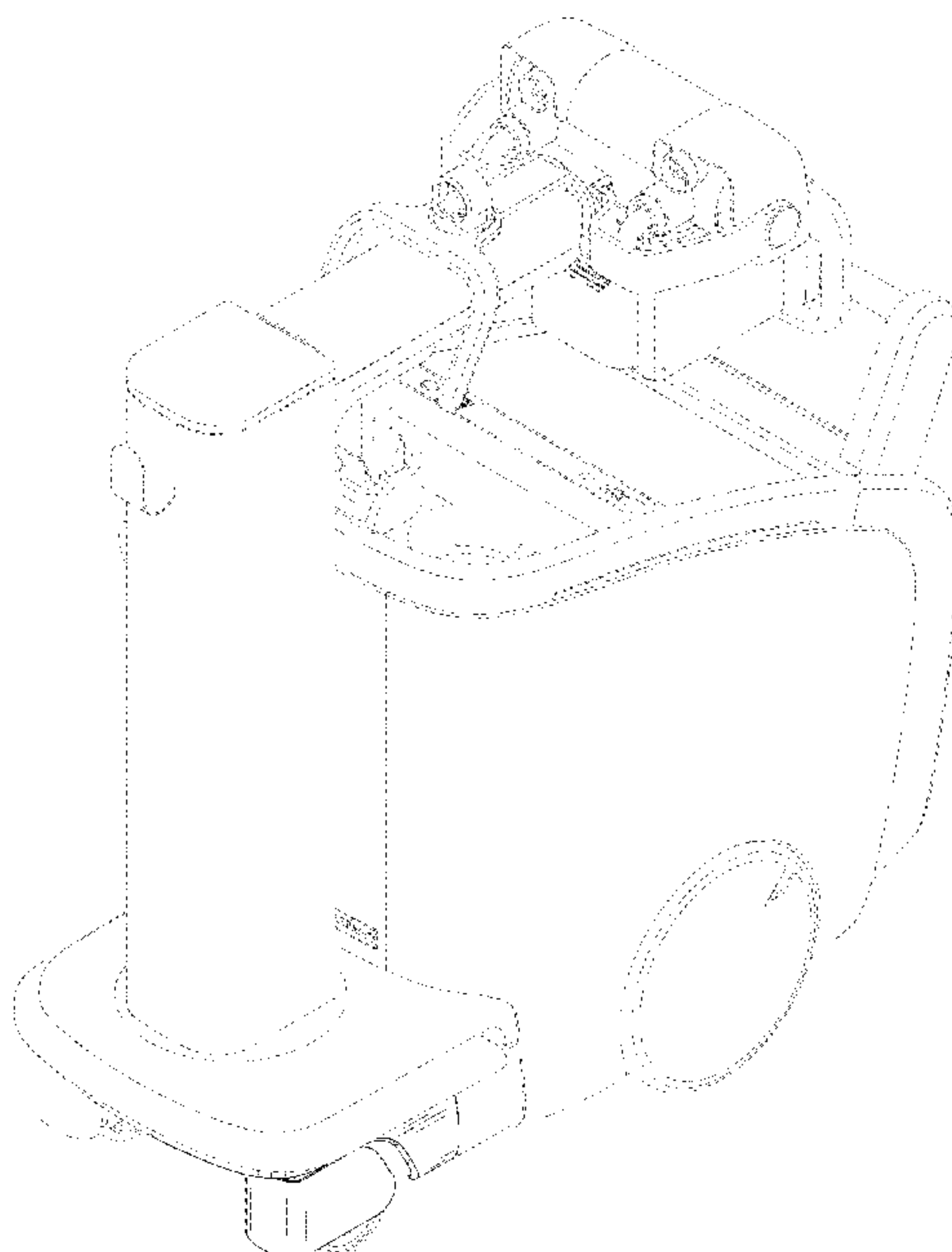

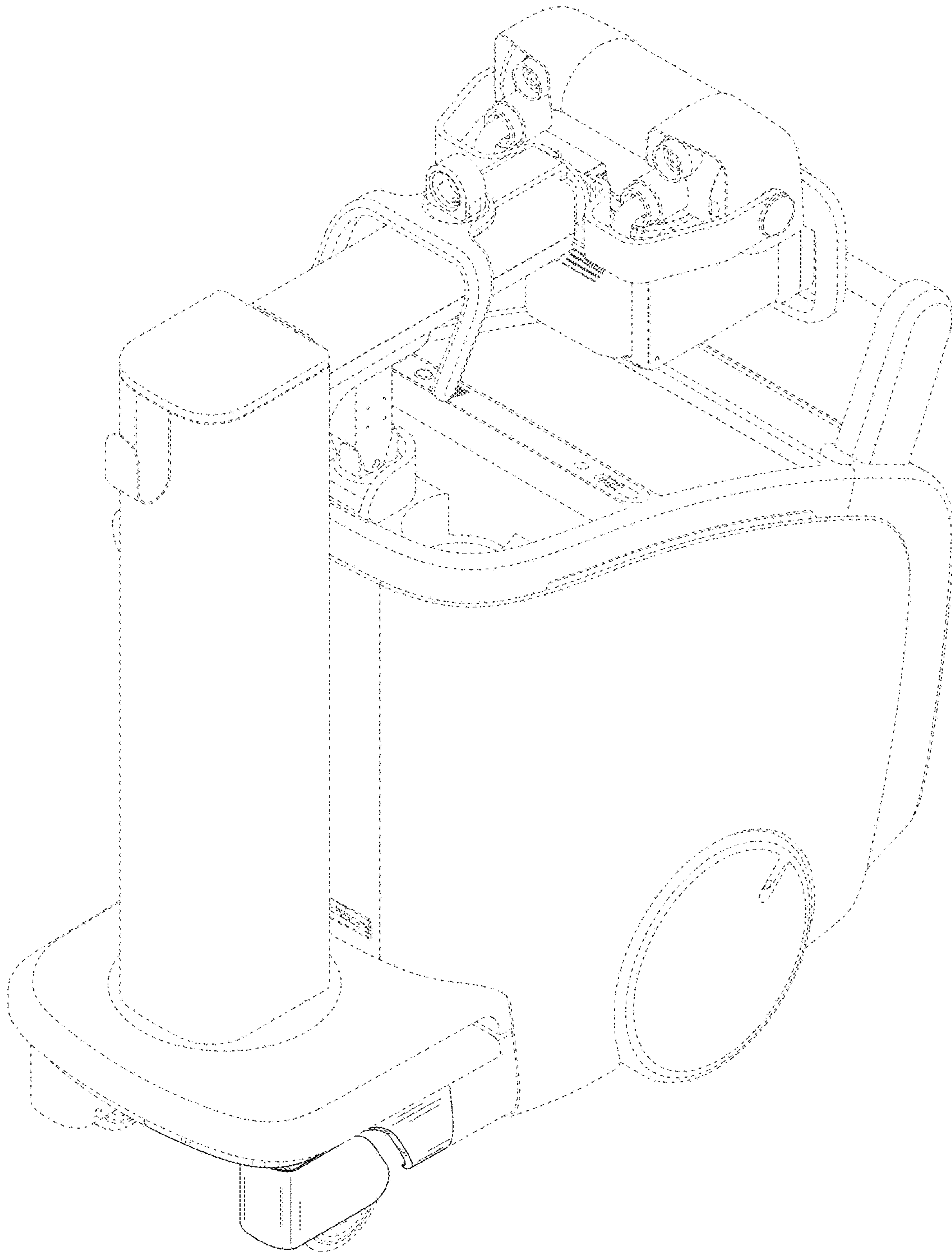

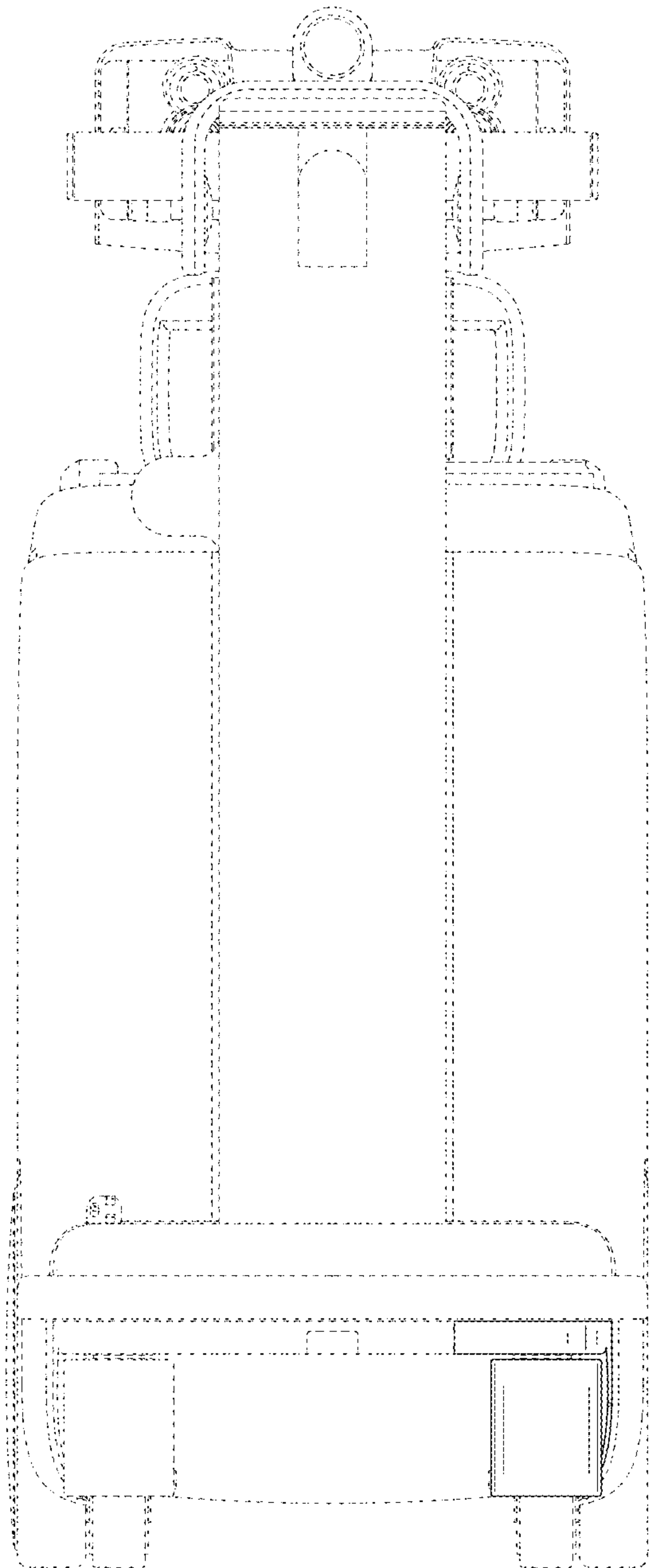

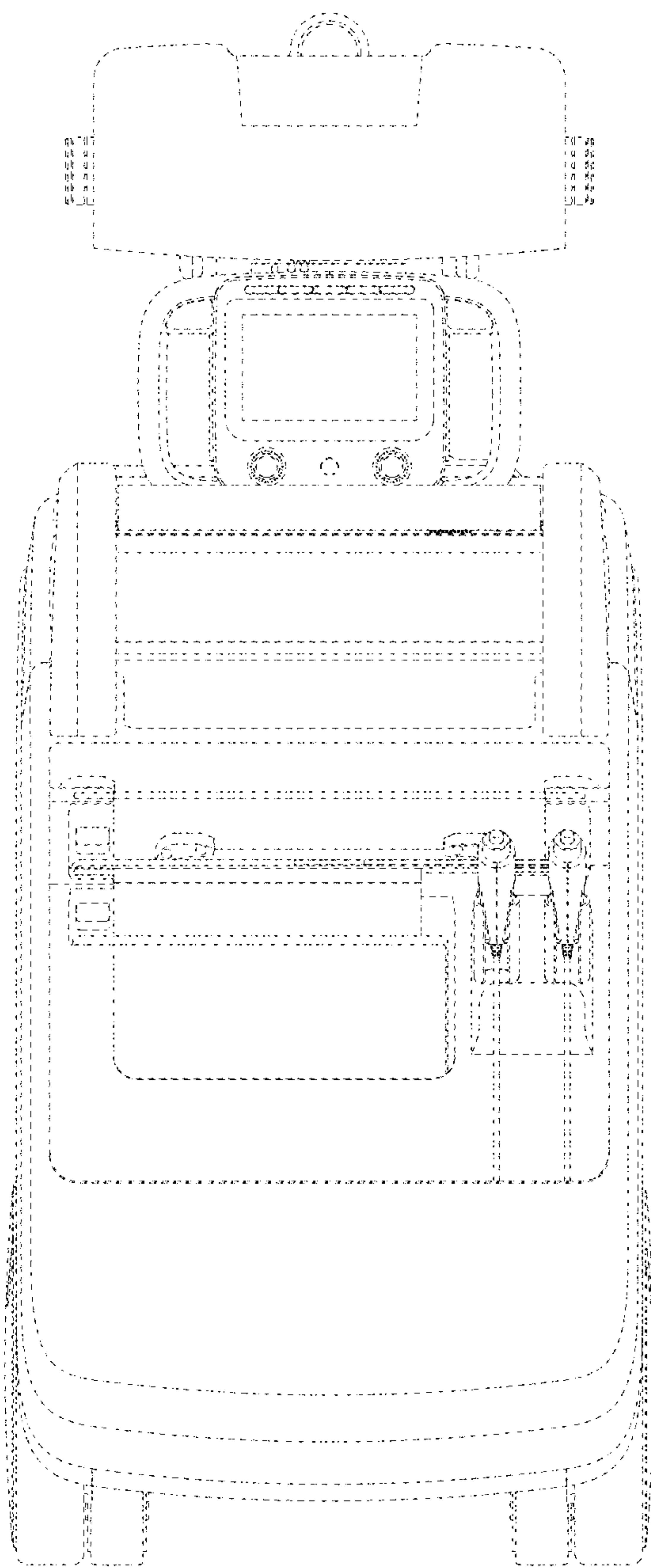

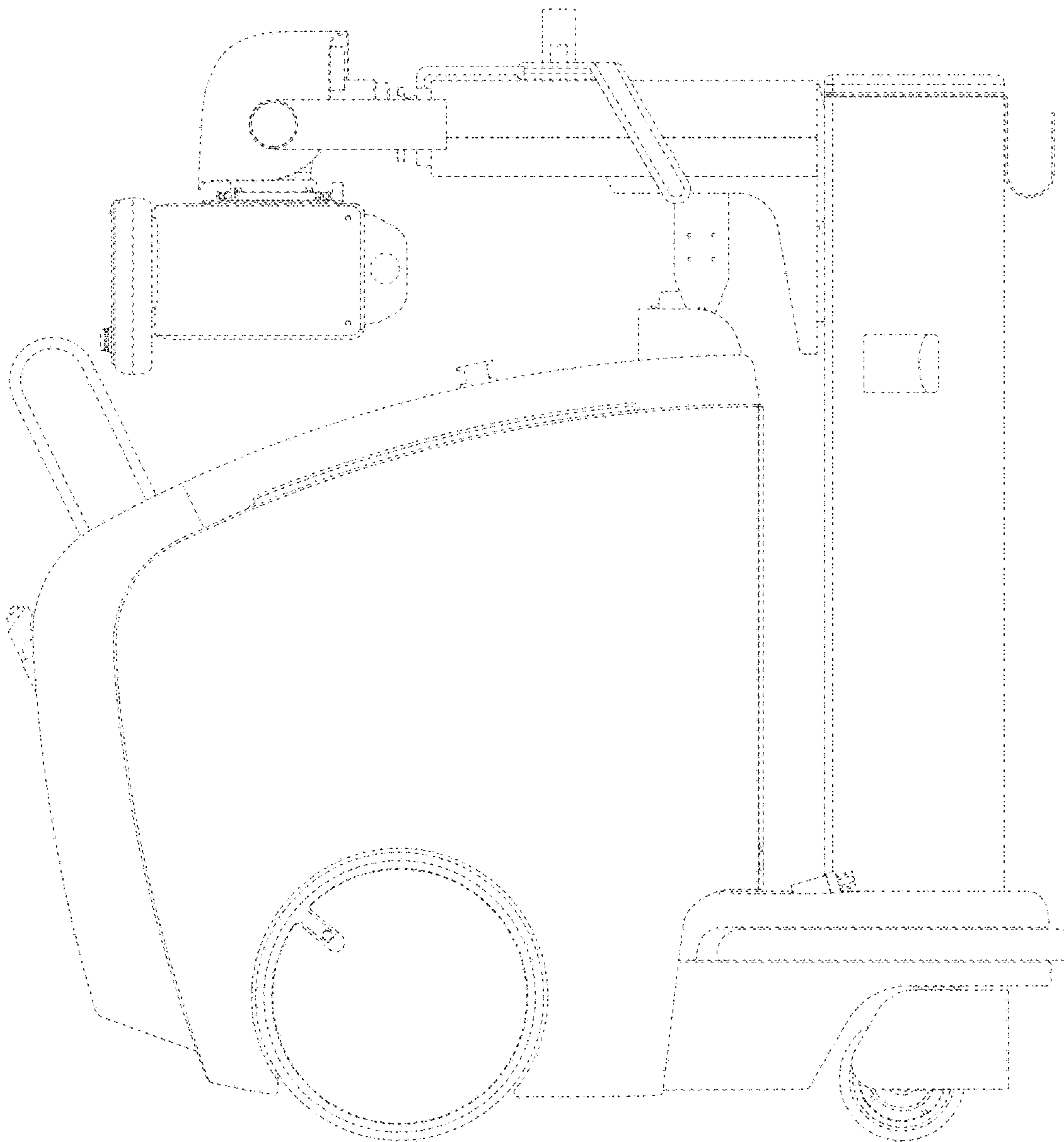

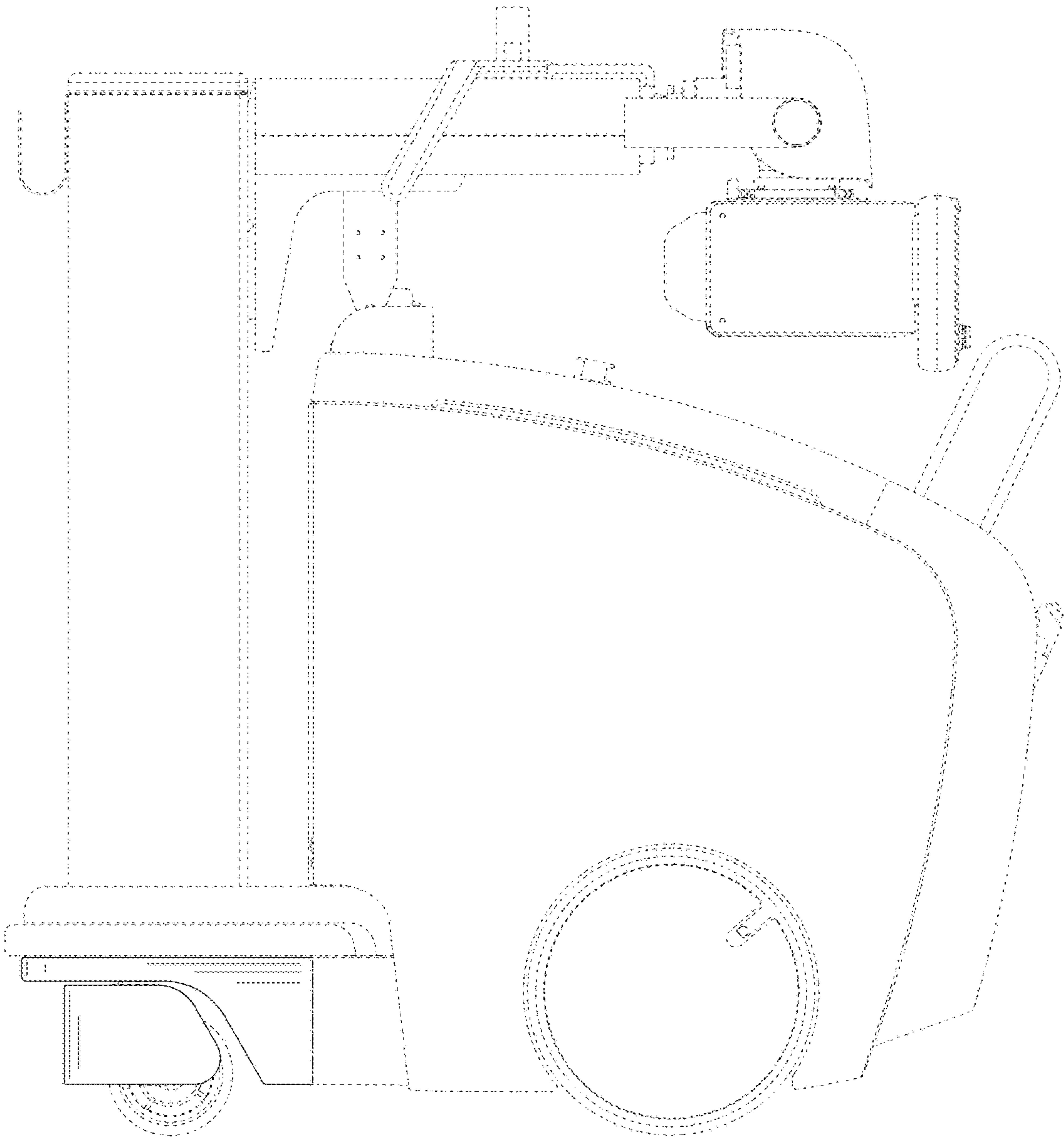

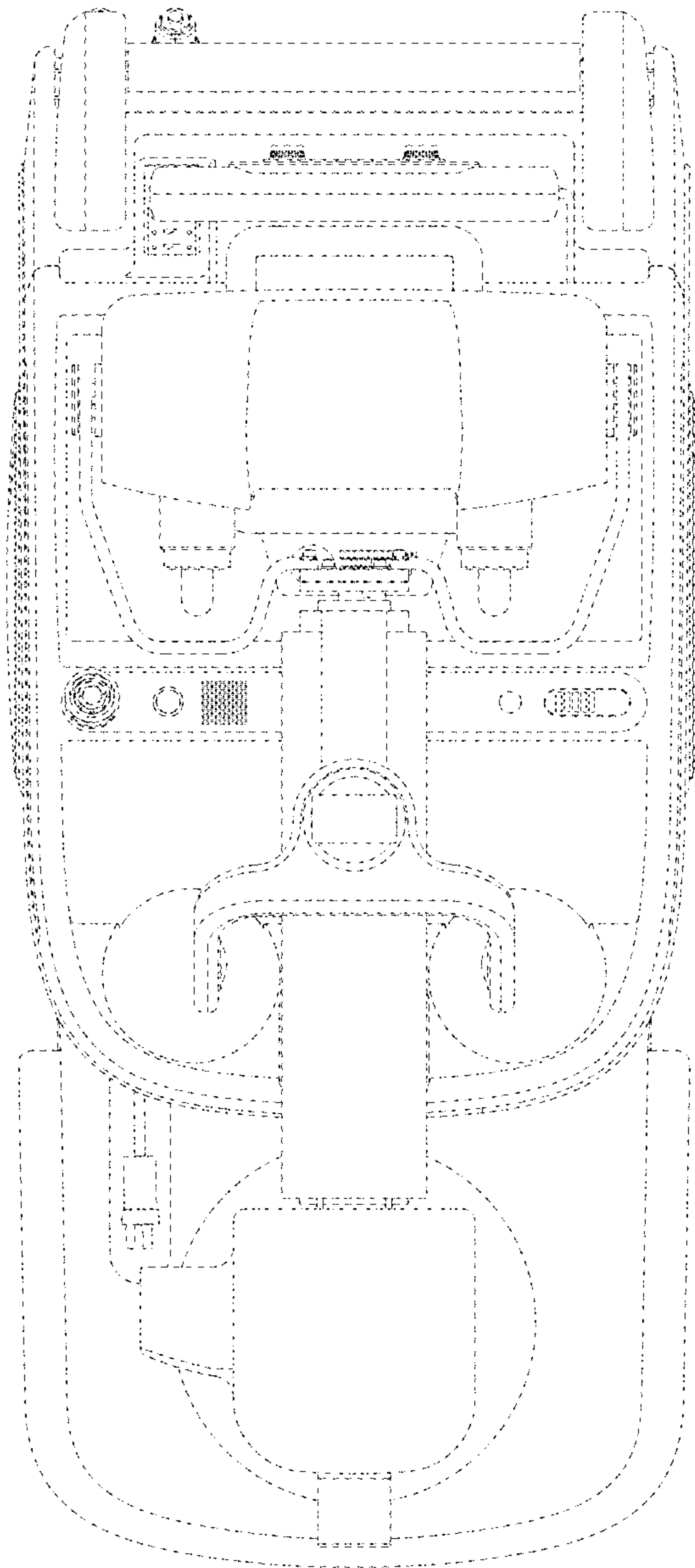

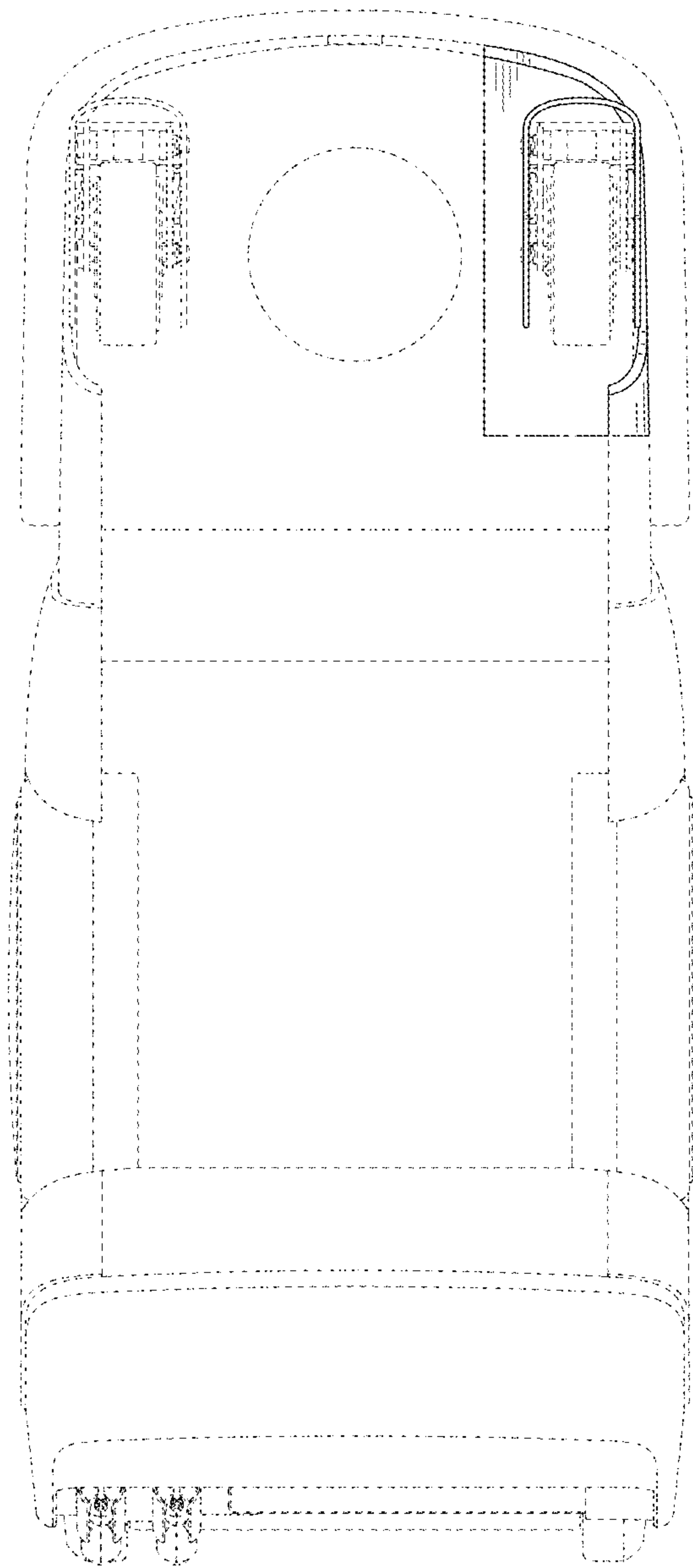
