**DESCRIPTION**

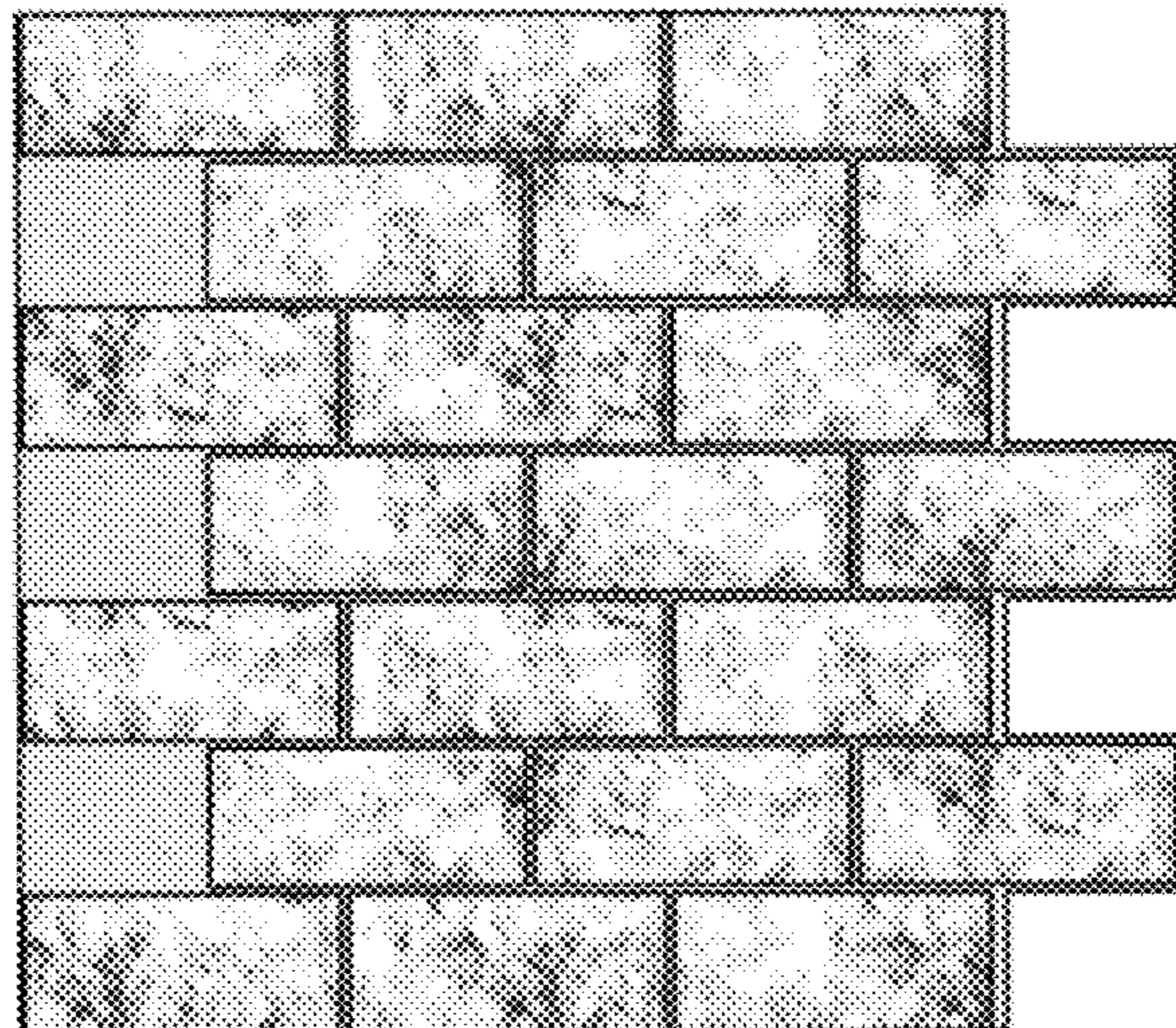
FIG. 1 is a top plan view of a building panel showing my new design;

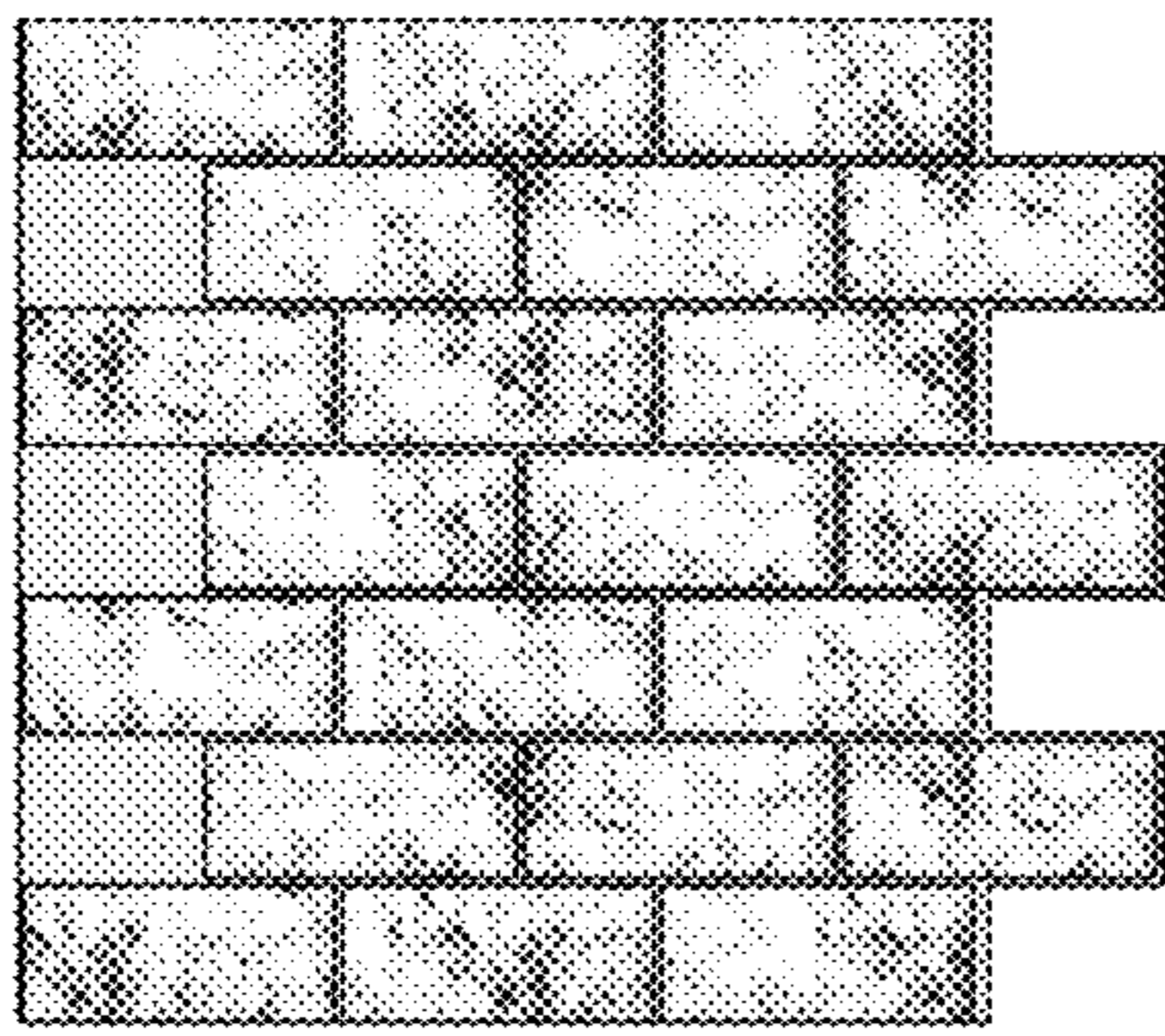

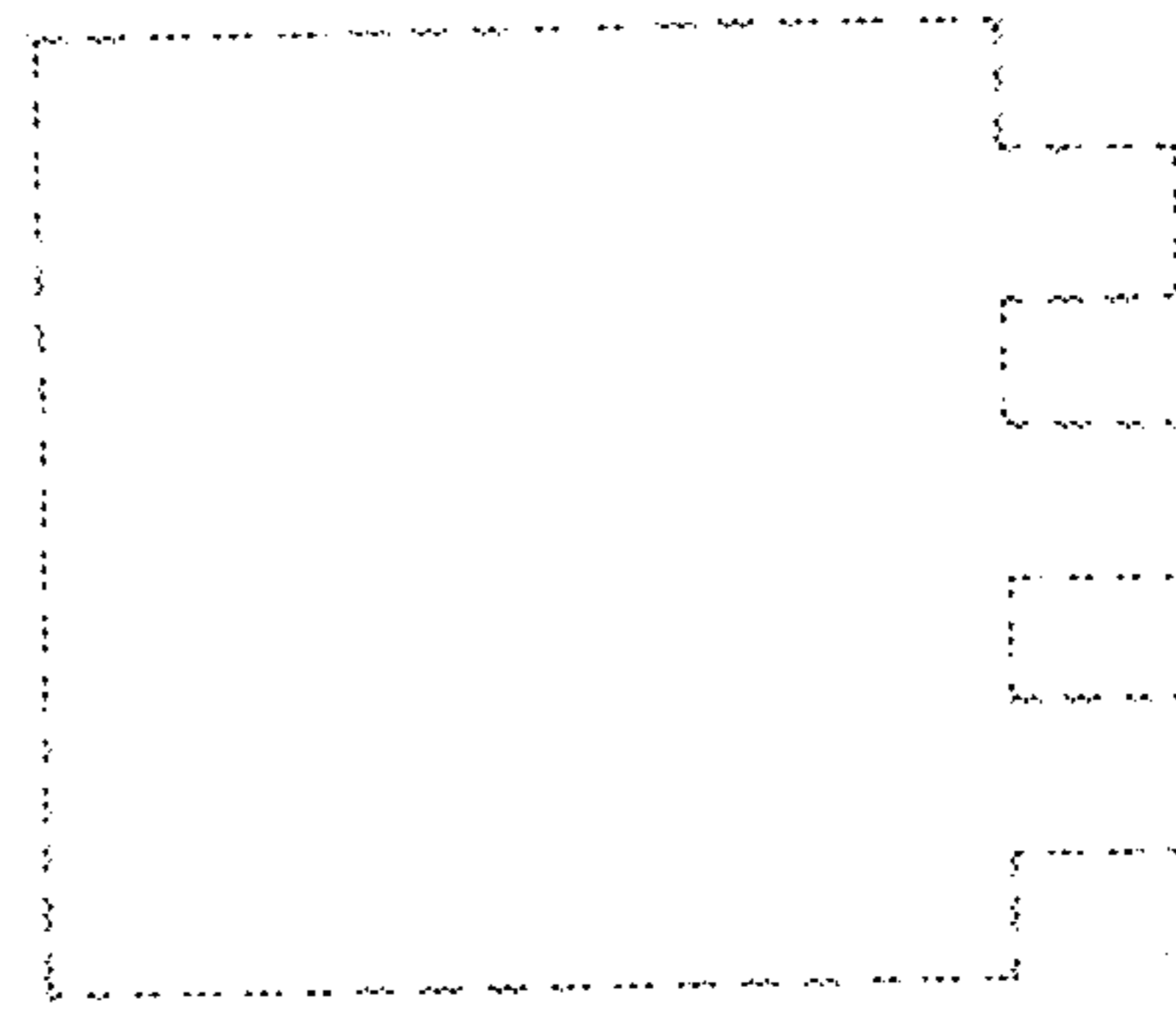

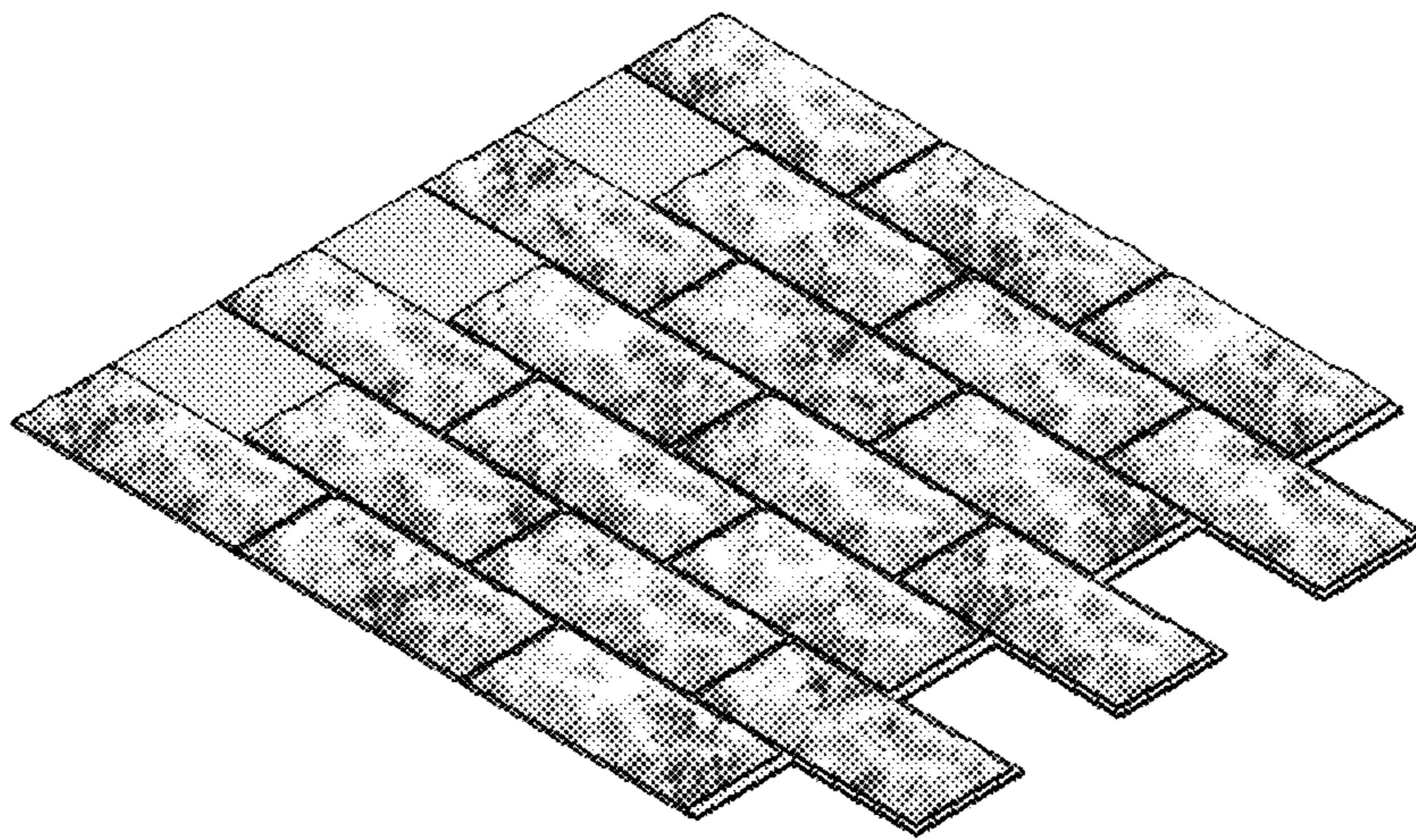

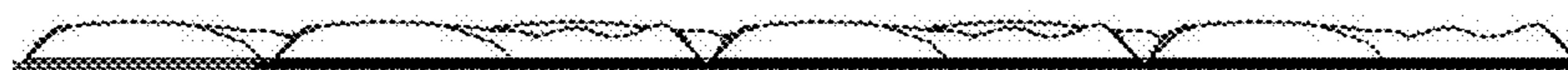

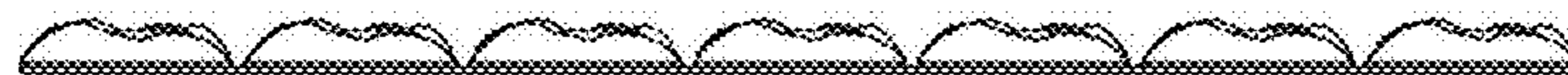
