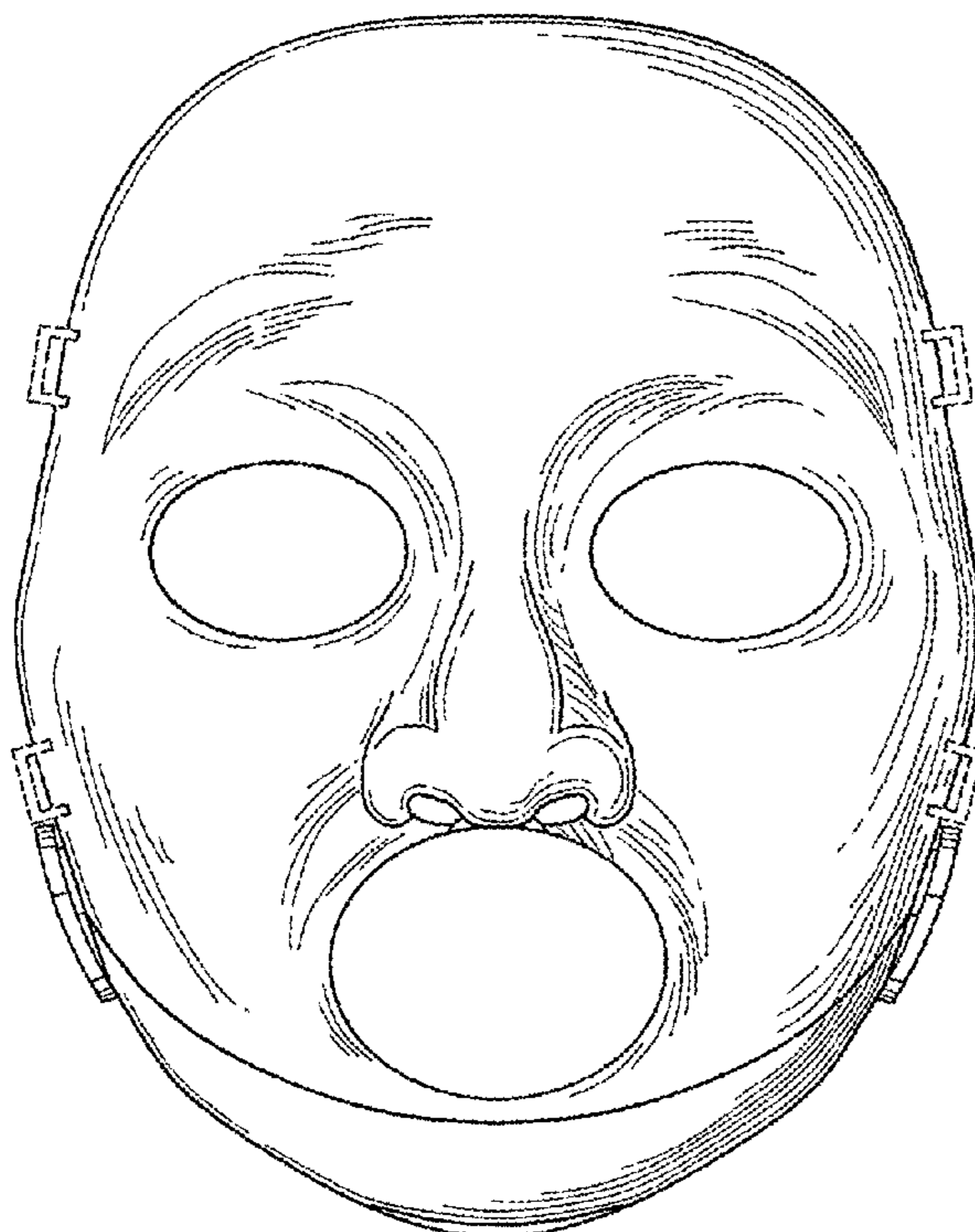
(57) **CLAIM**

The ornamental design for a anti-aging face mask, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of my new design for a  
anti-aging face mask.  
FIG. 2 is back side elevation view of FIG. 1.  
FIG. 3 is a right side elevation view of FIG. 1, the left side  
being a mirror image thereof.  
FIG. 4 is top plan view of FIG. 1.  
FIG. 5 is bottom plan view of FIG. 1.  
FIG. 6 is a front isometric view of FIG. 1; and,  
FIG. 7 is a front isometric view of the embodiment in FIG.  
1 with the jaw hinge in an alternate open position.  
The portion of the anti-aging face mask depicted in broken

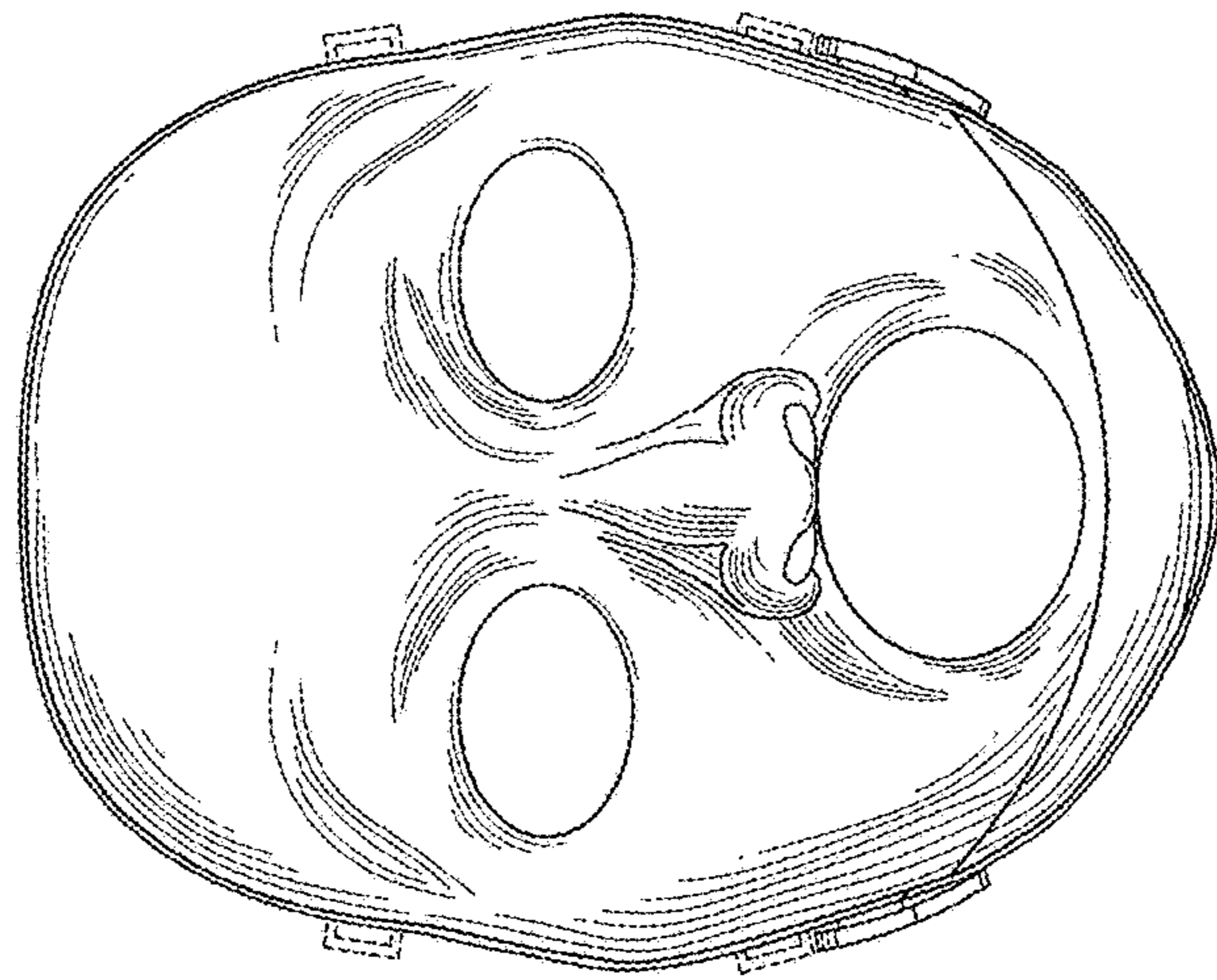

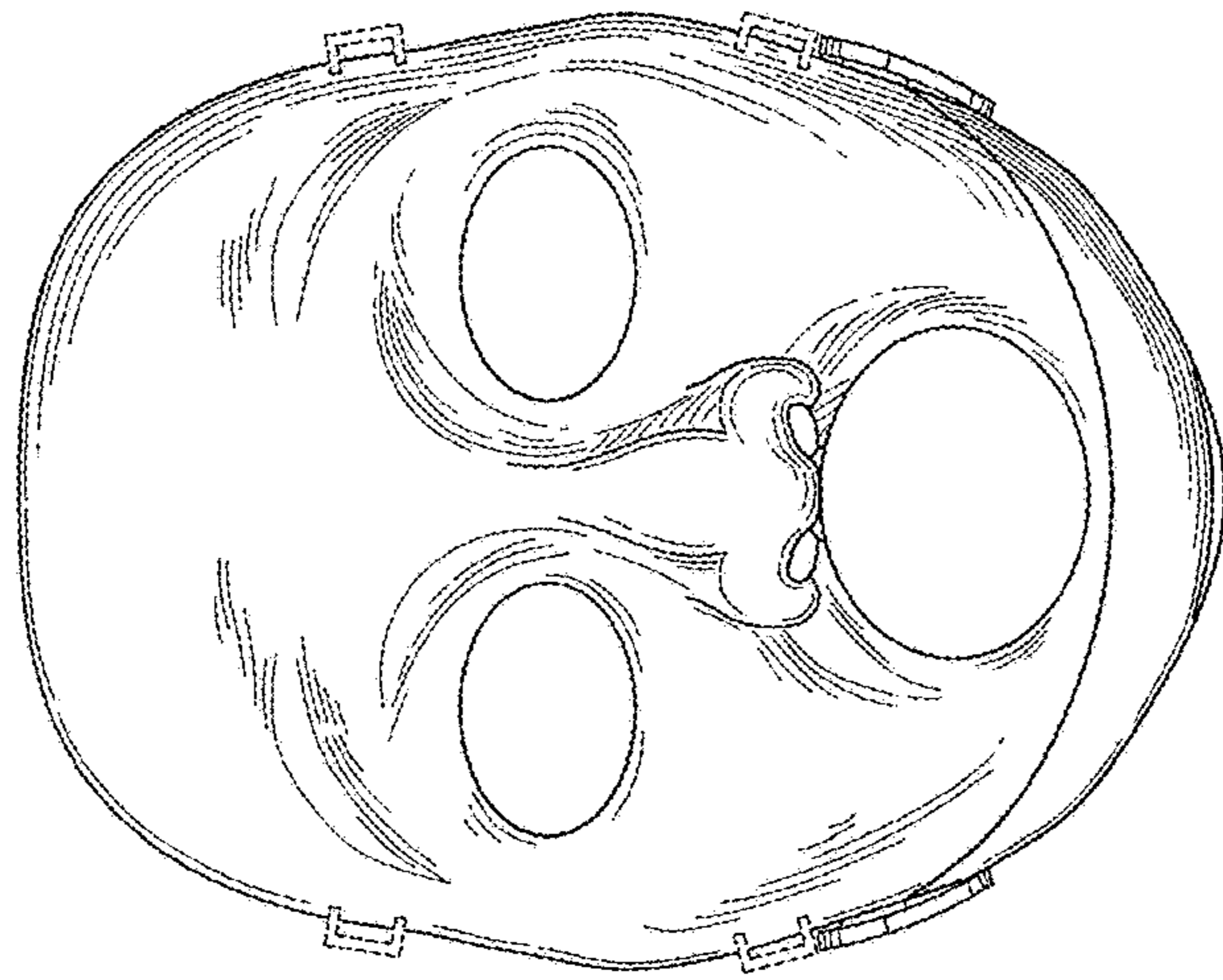

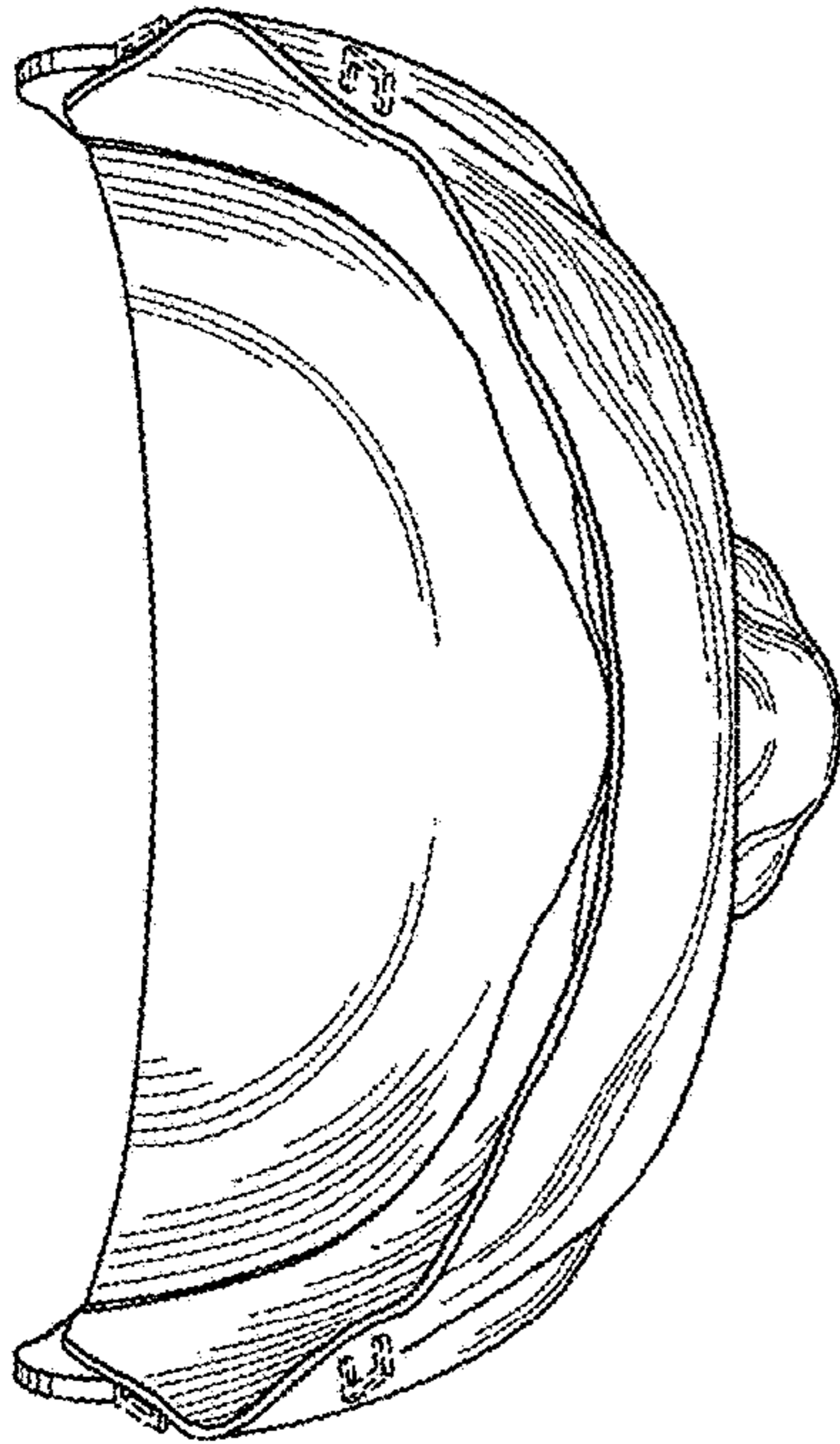

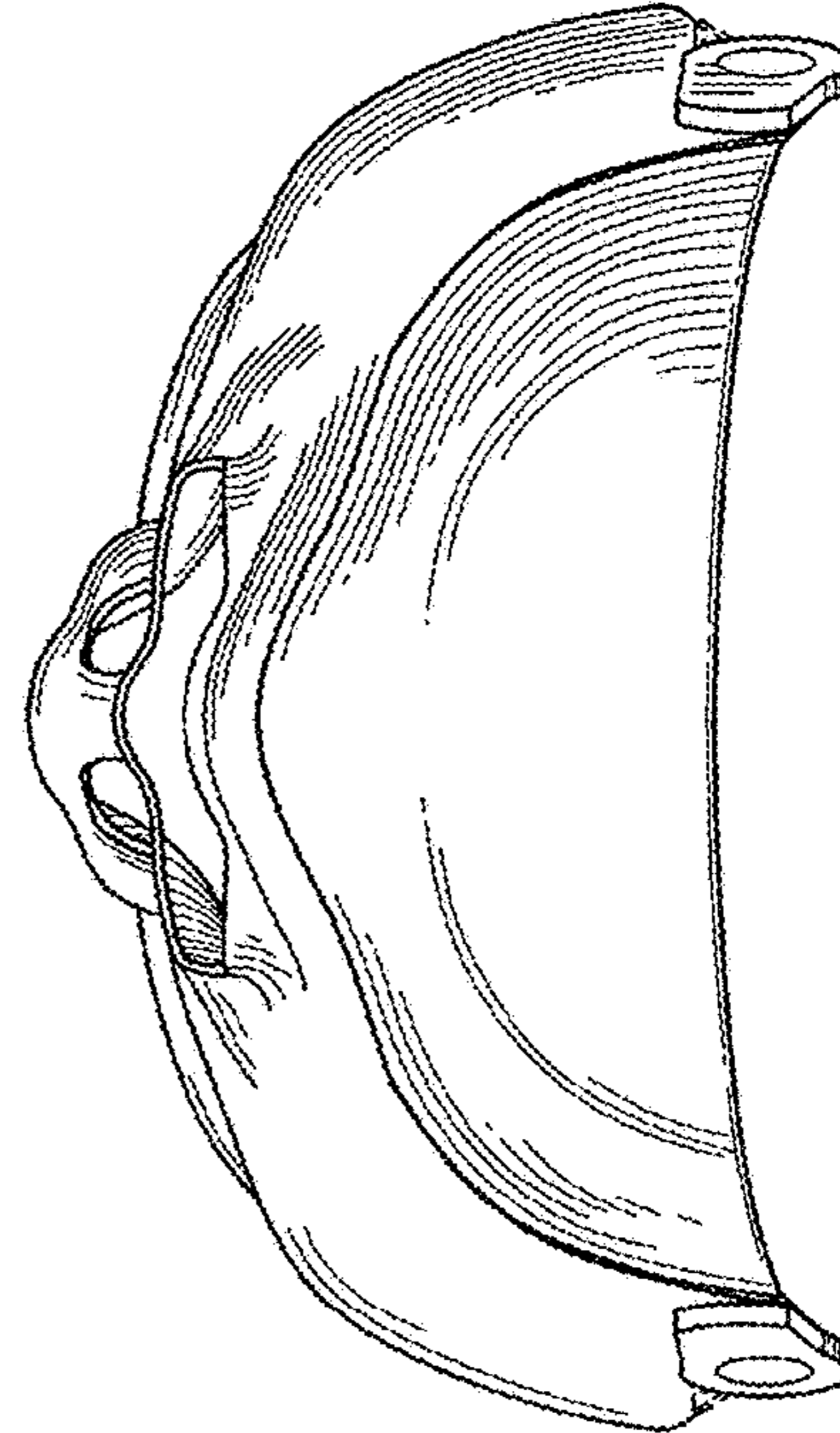

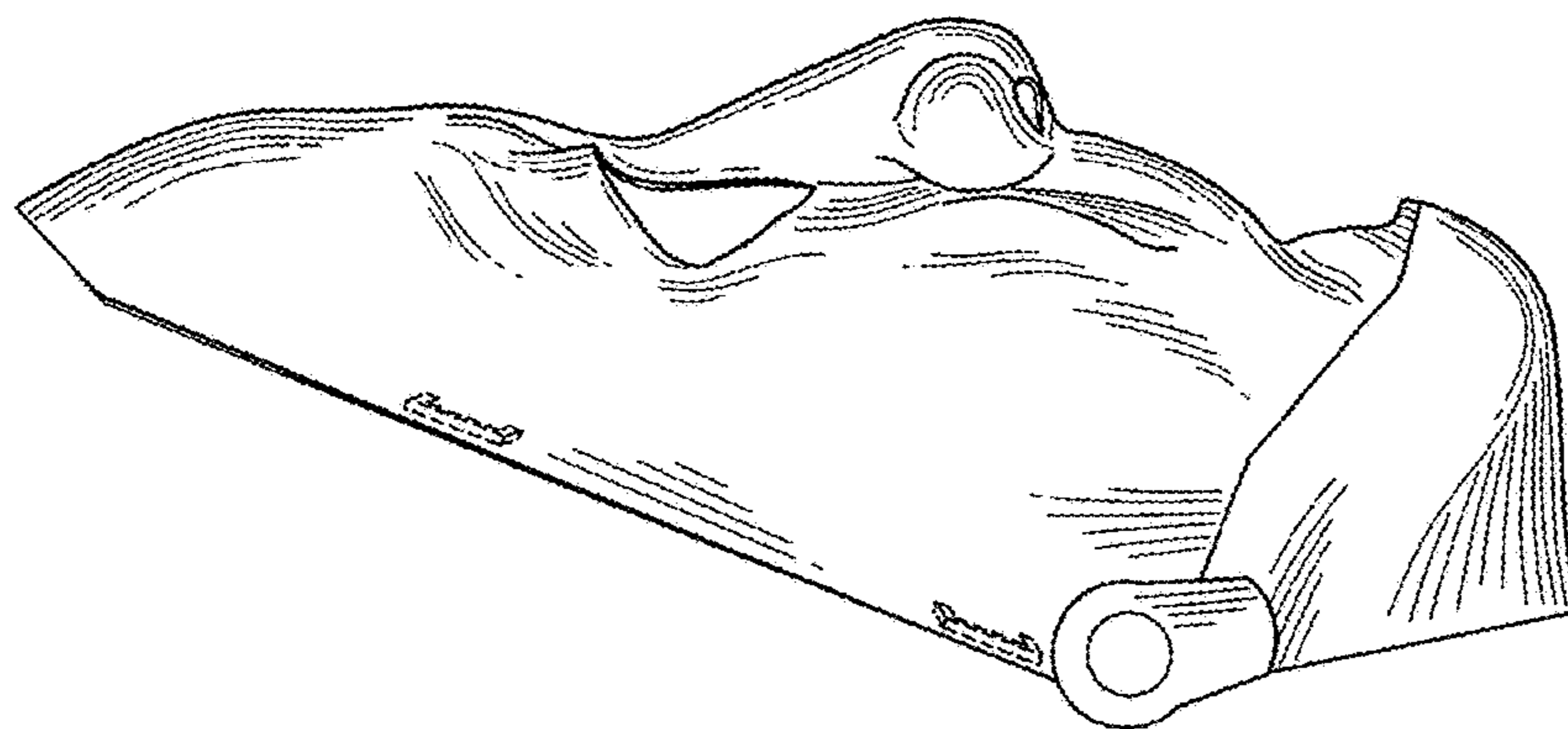

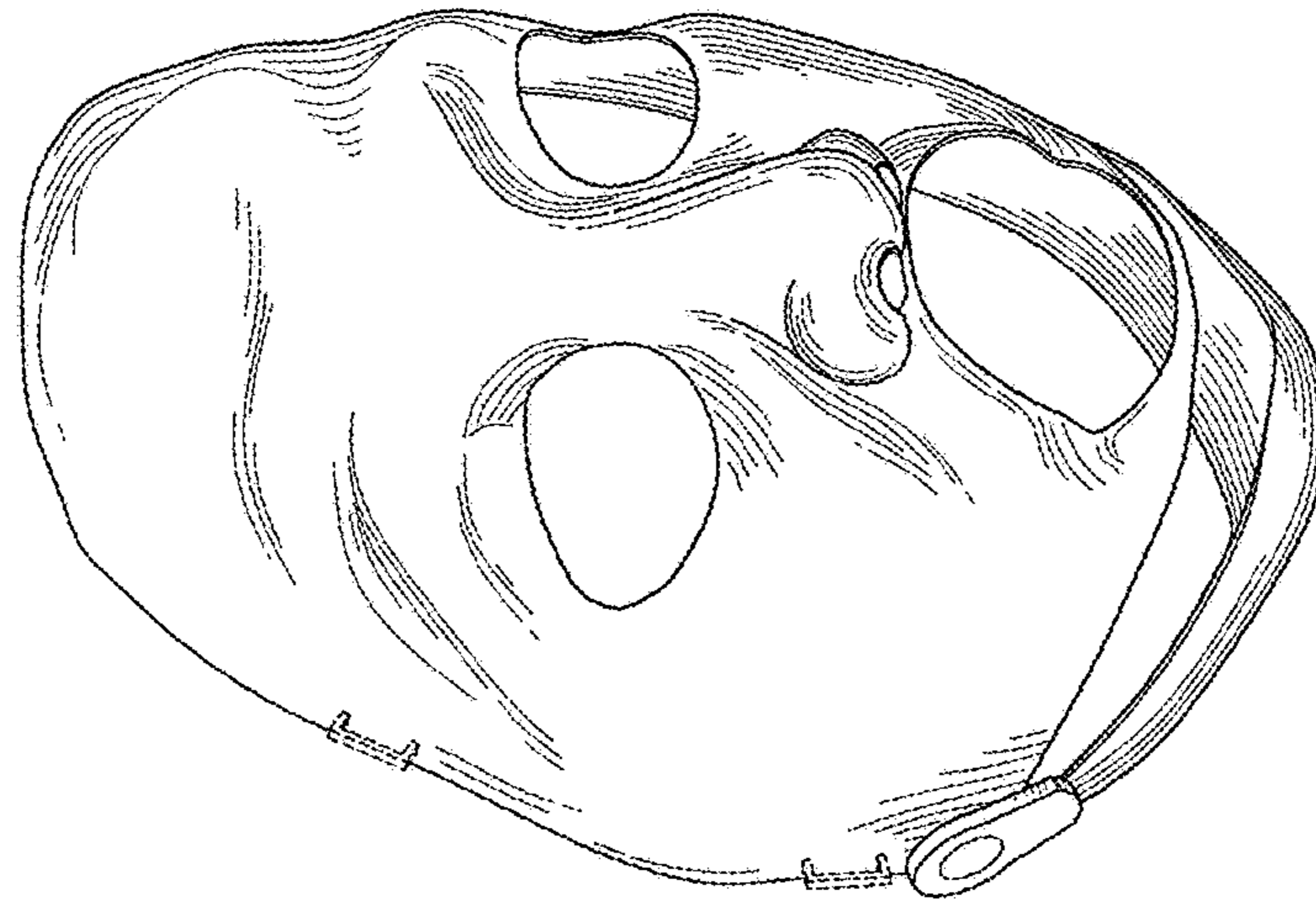

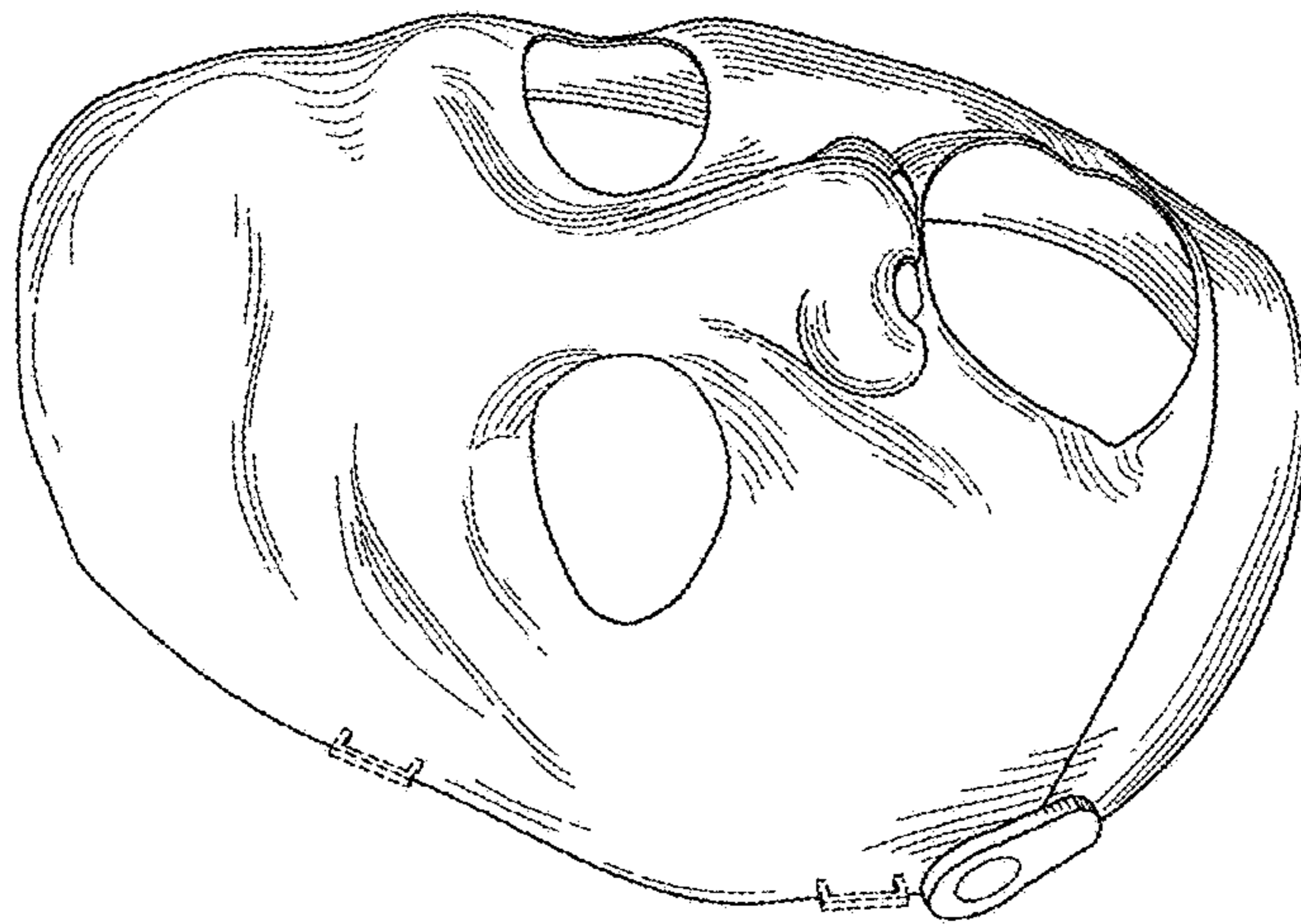
