The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of the pants according to the present design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a left side view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a back view thereof; and,
 FIG. 6 is a front view of the pants, showing an alternative configuration.

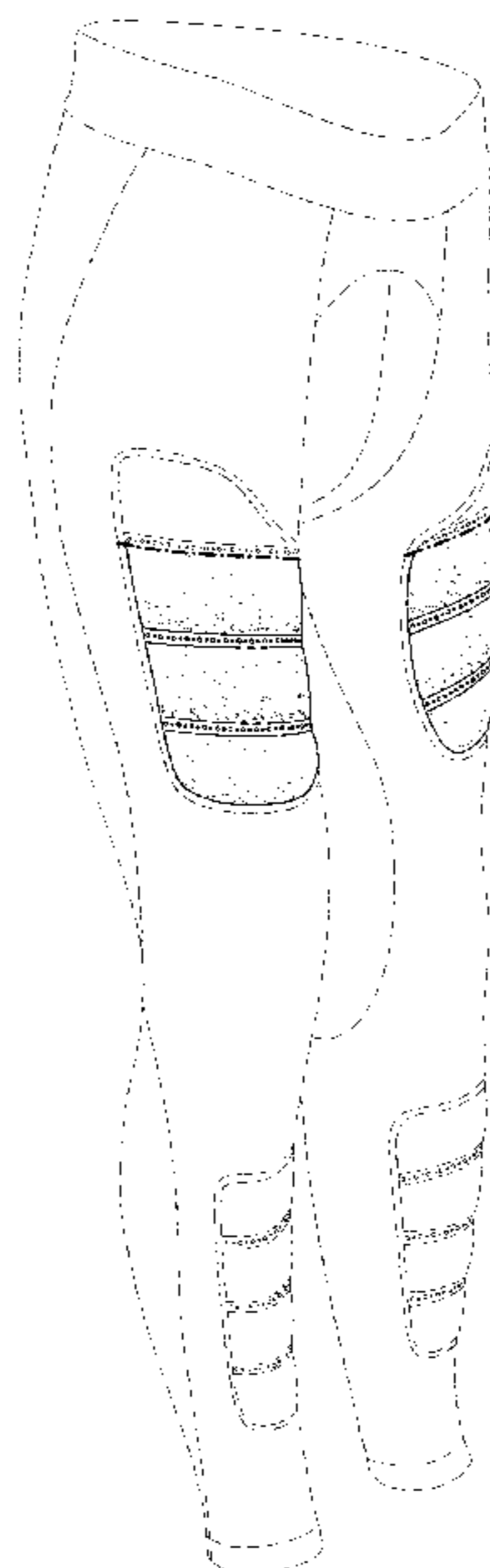

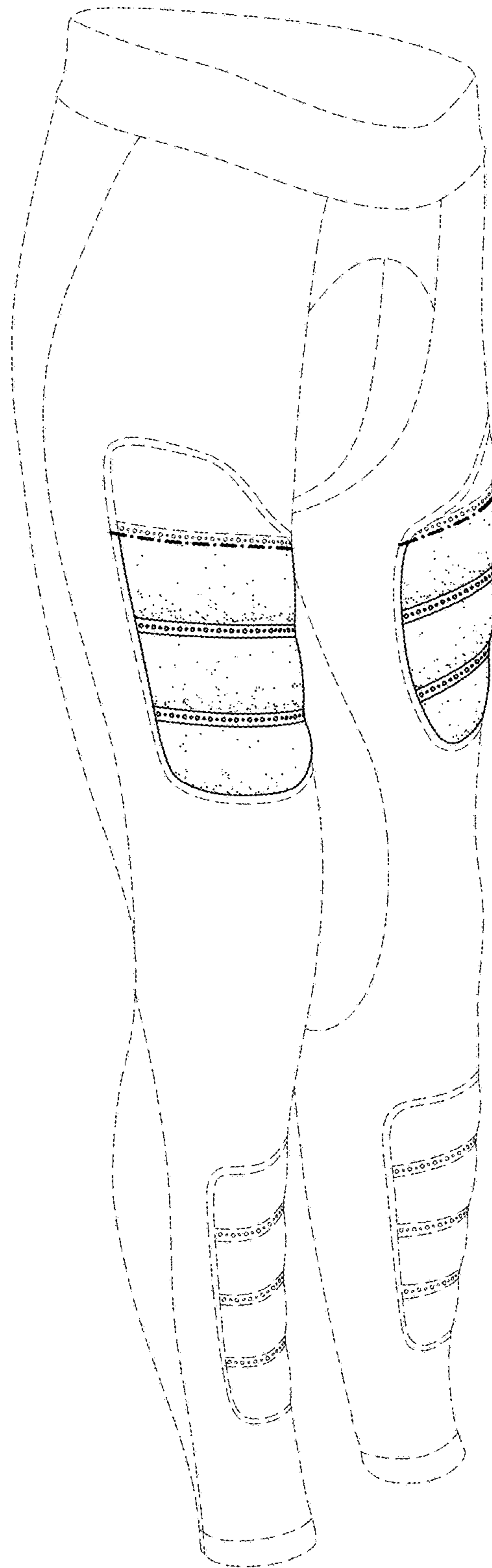

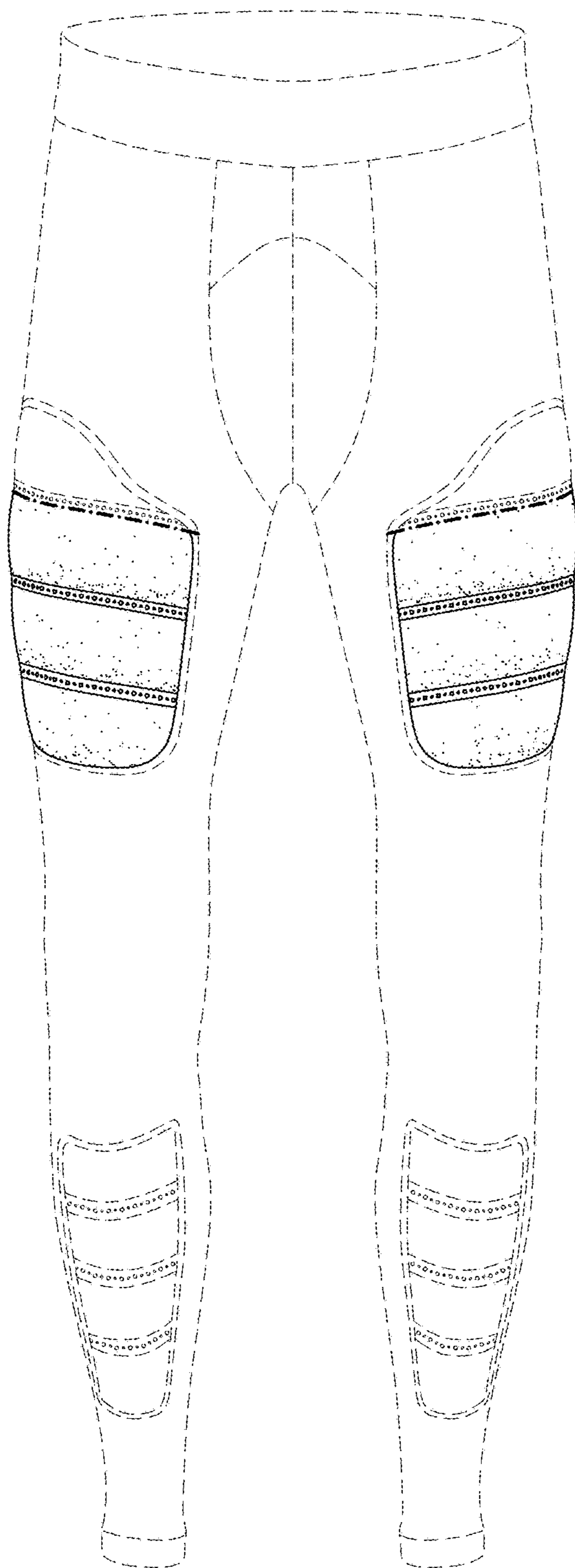

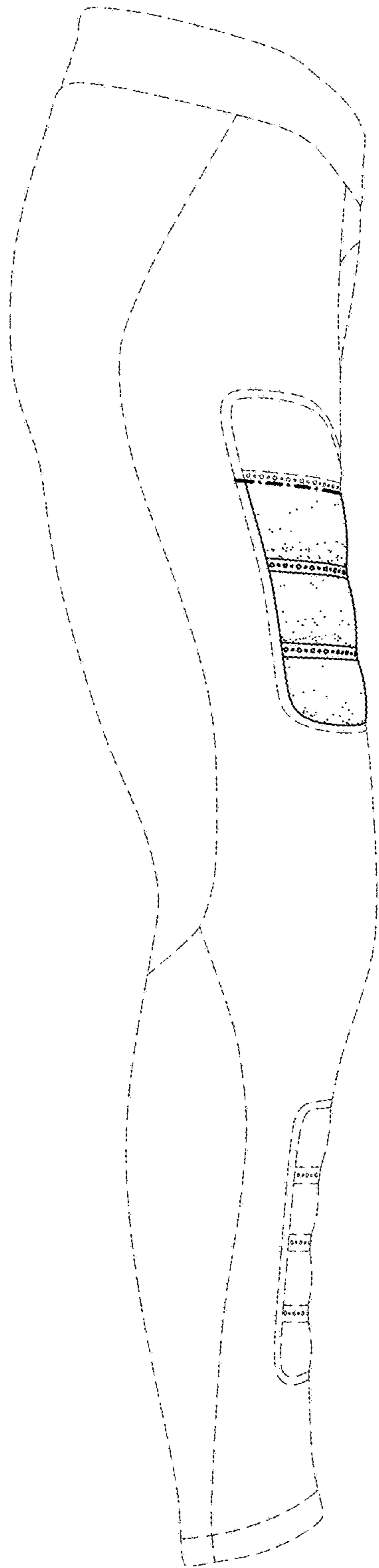

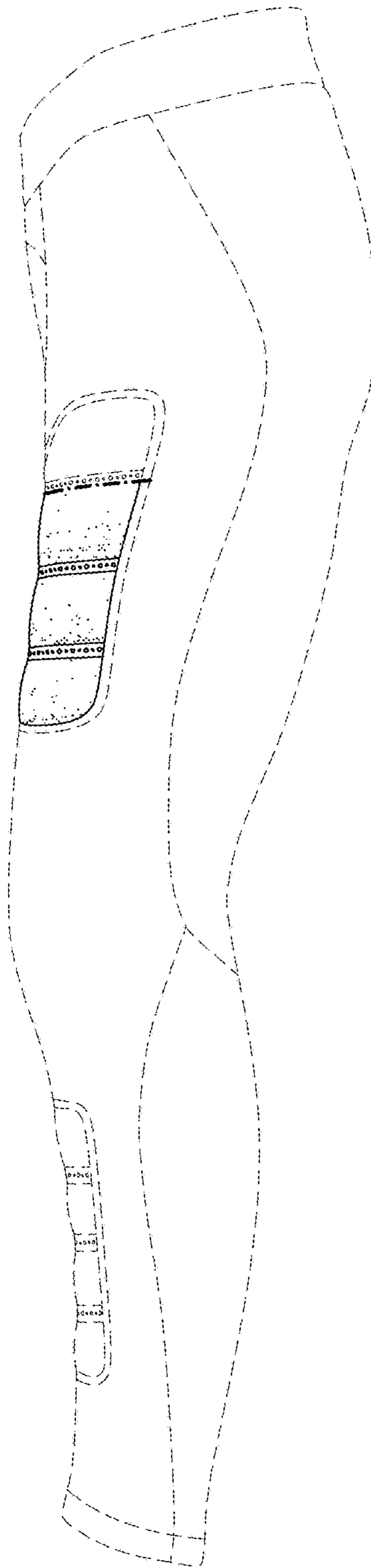

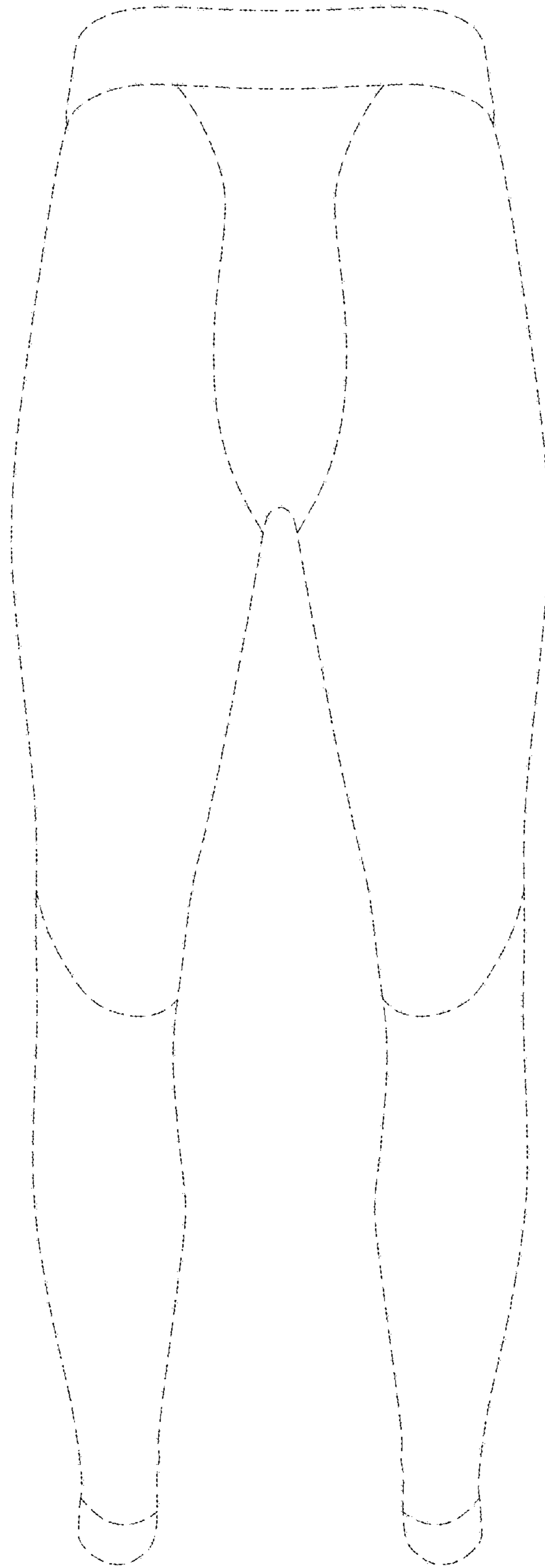

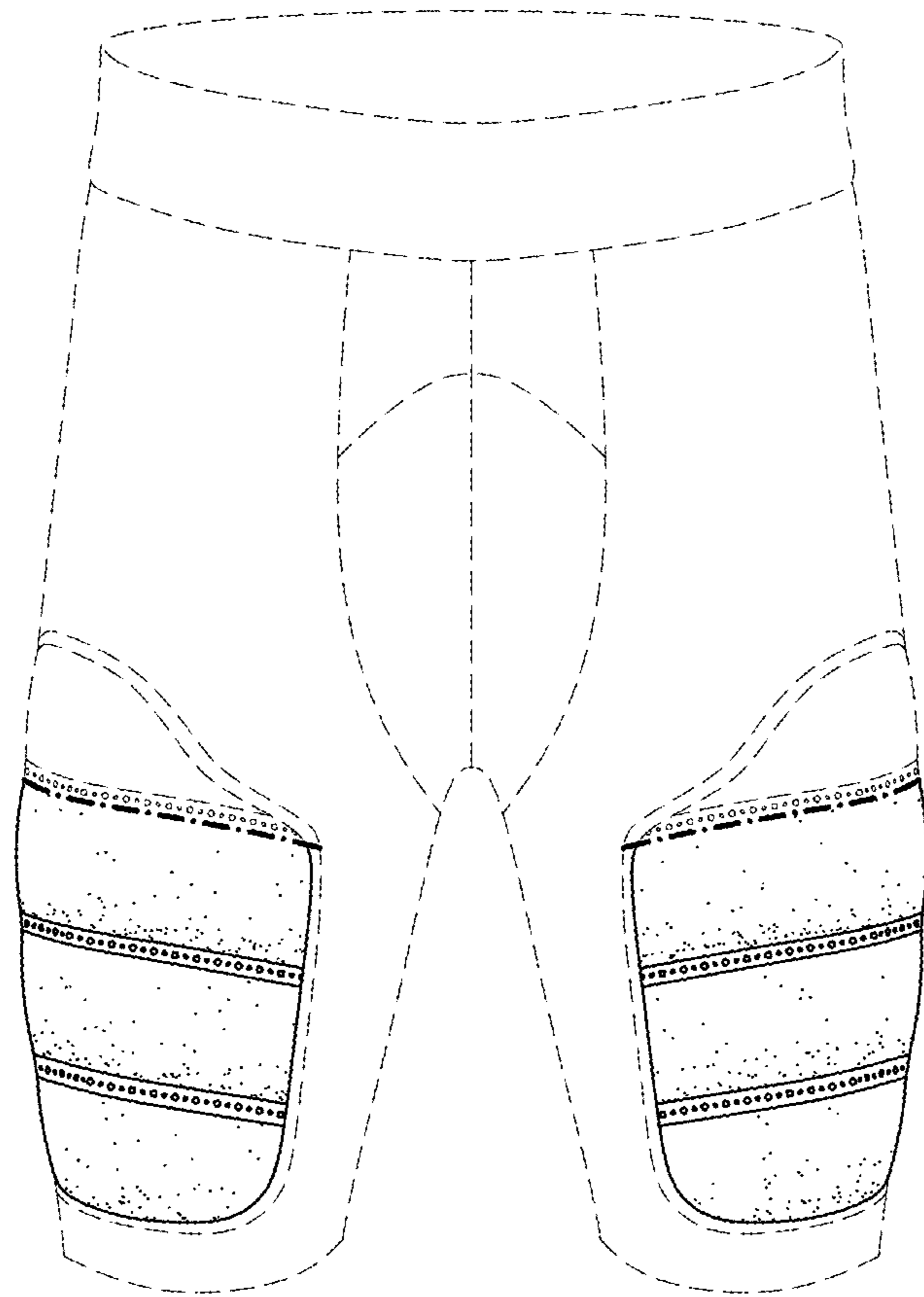
