DESCRIPTION

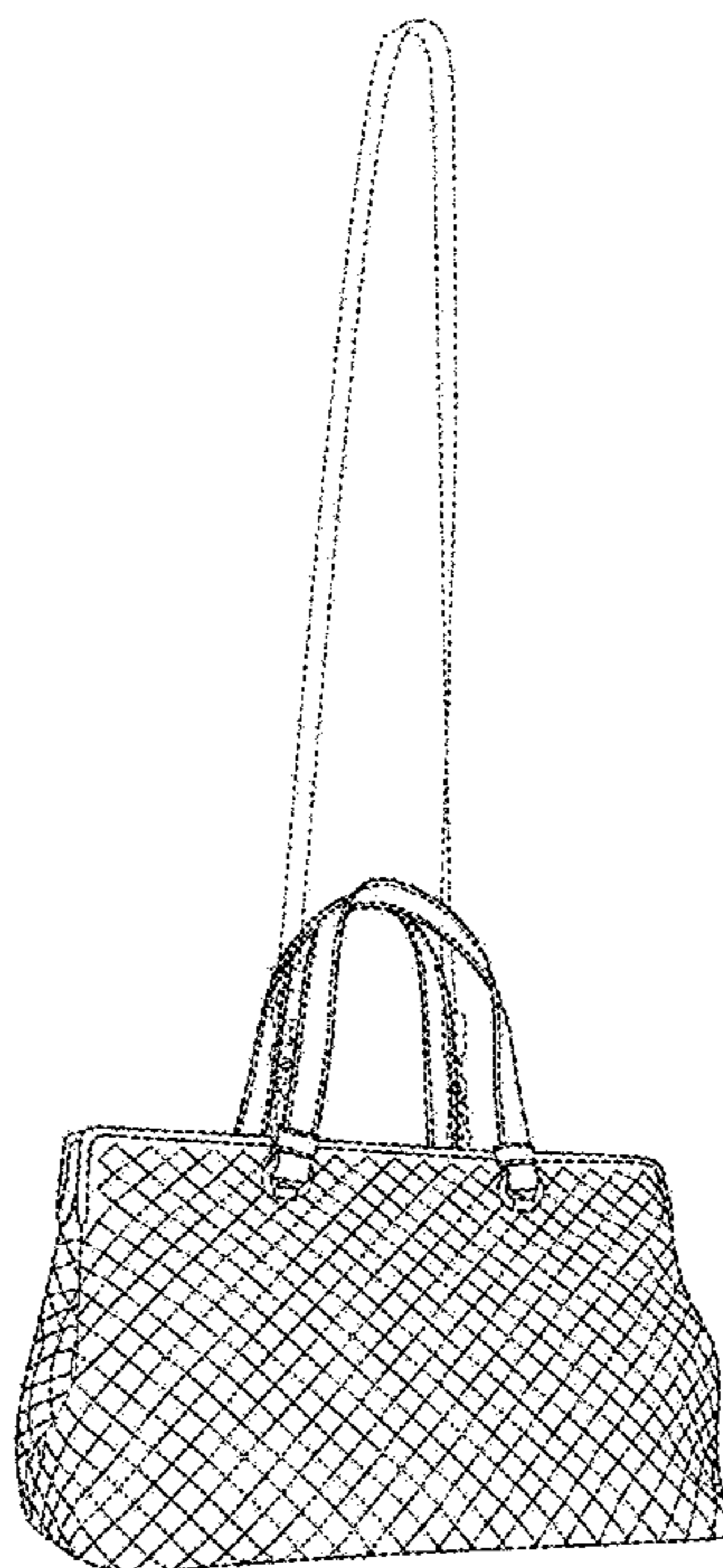
FIG. 1 is a front perspective view of the handbag according to the design;

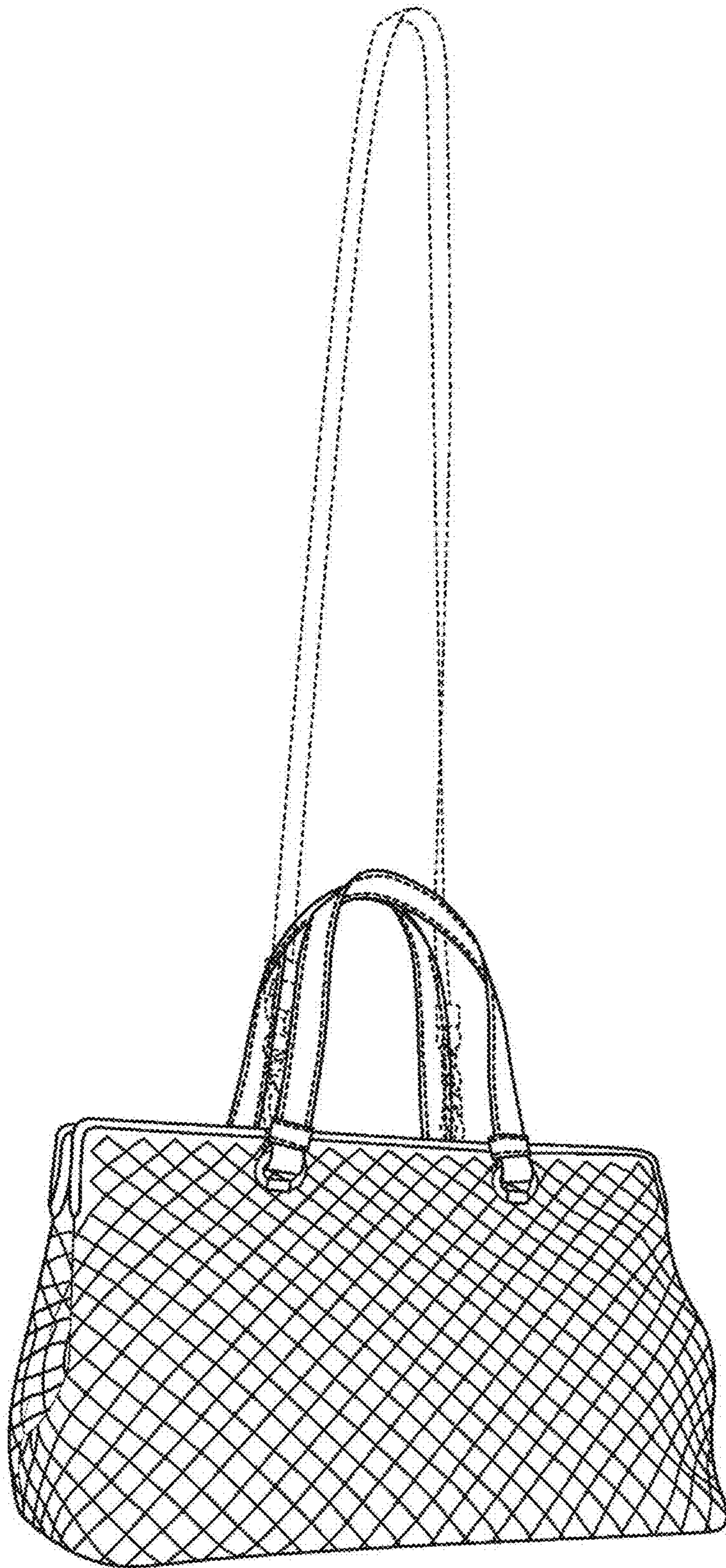

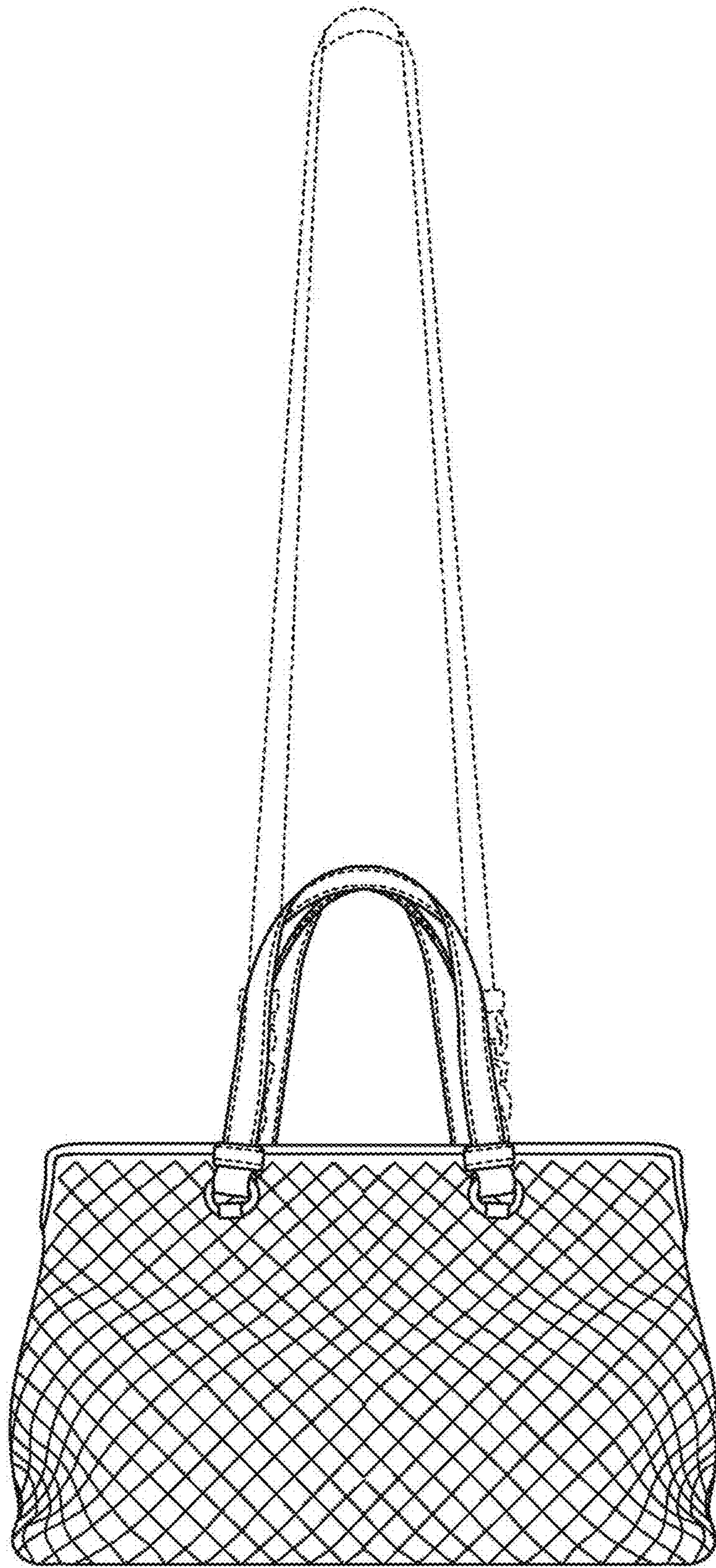

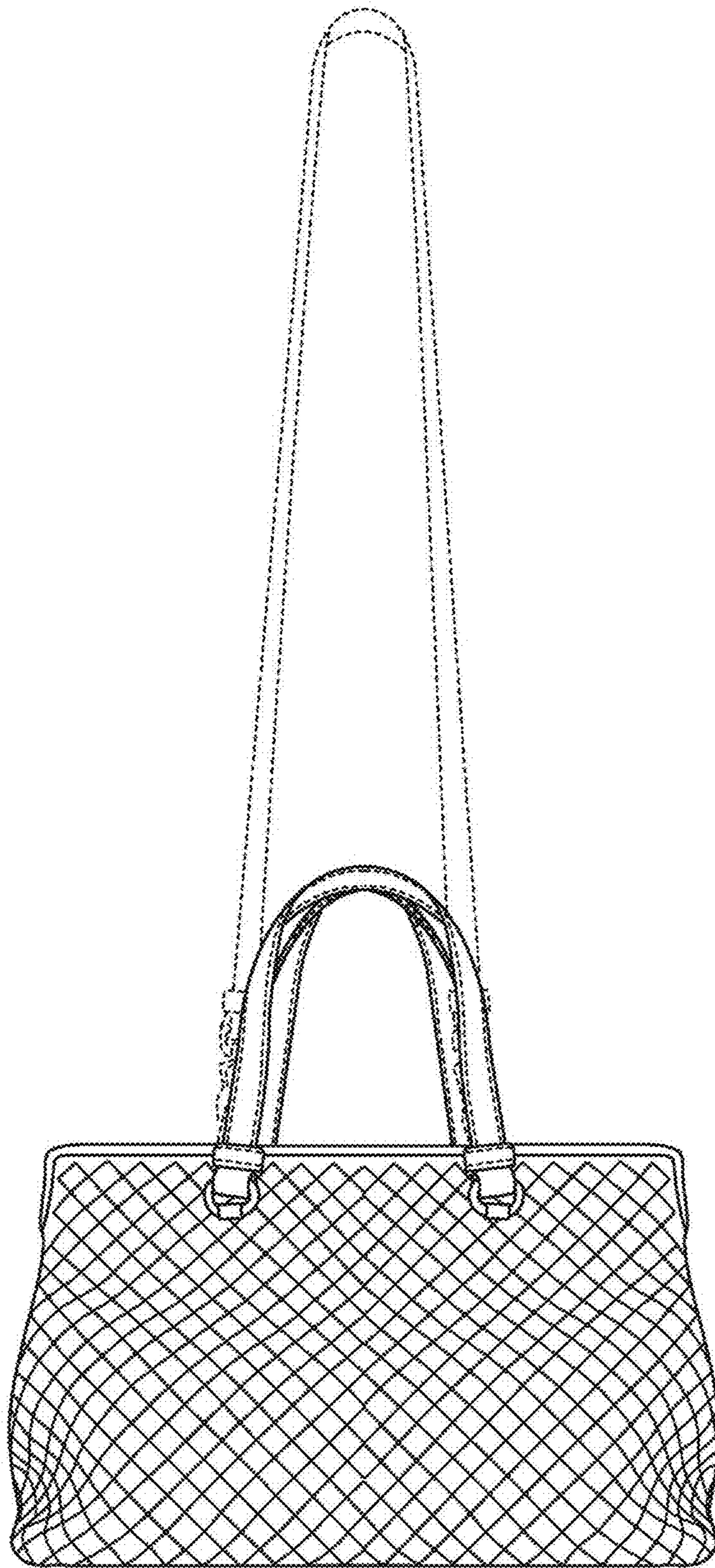

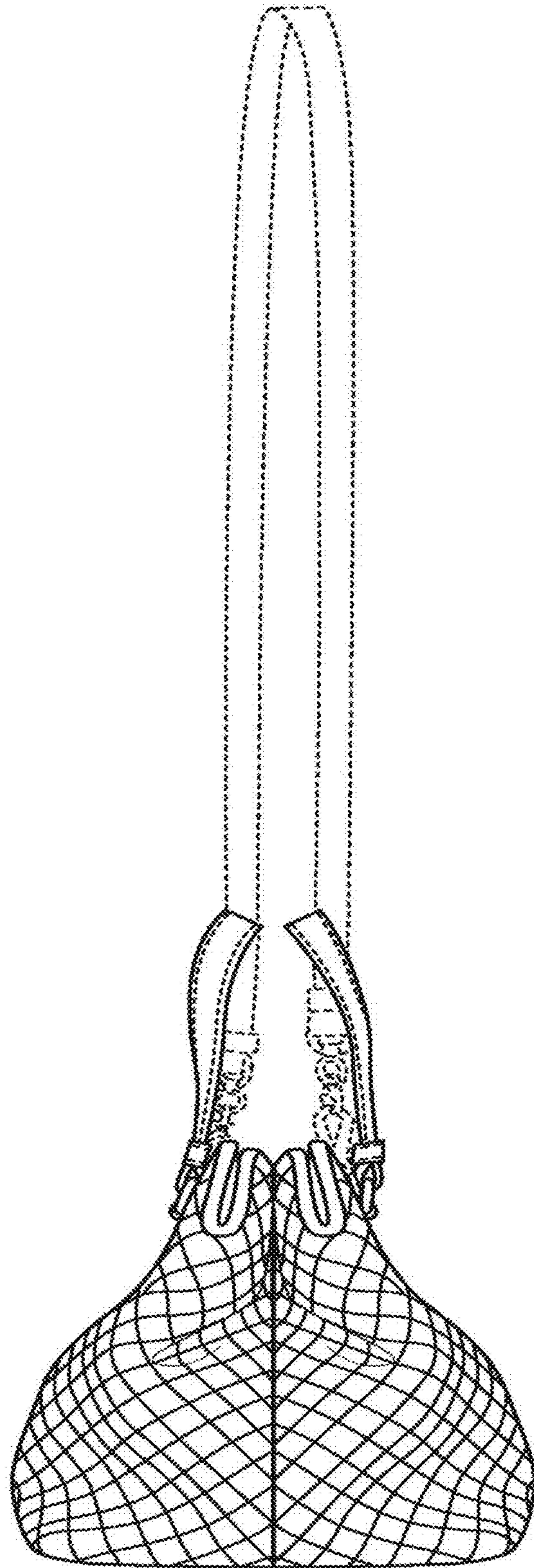

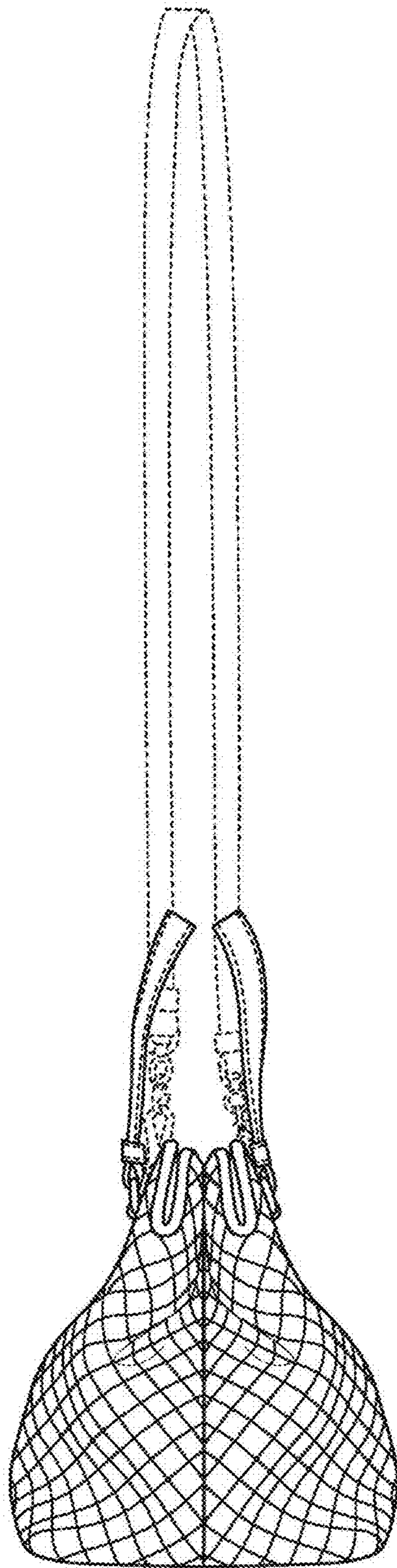

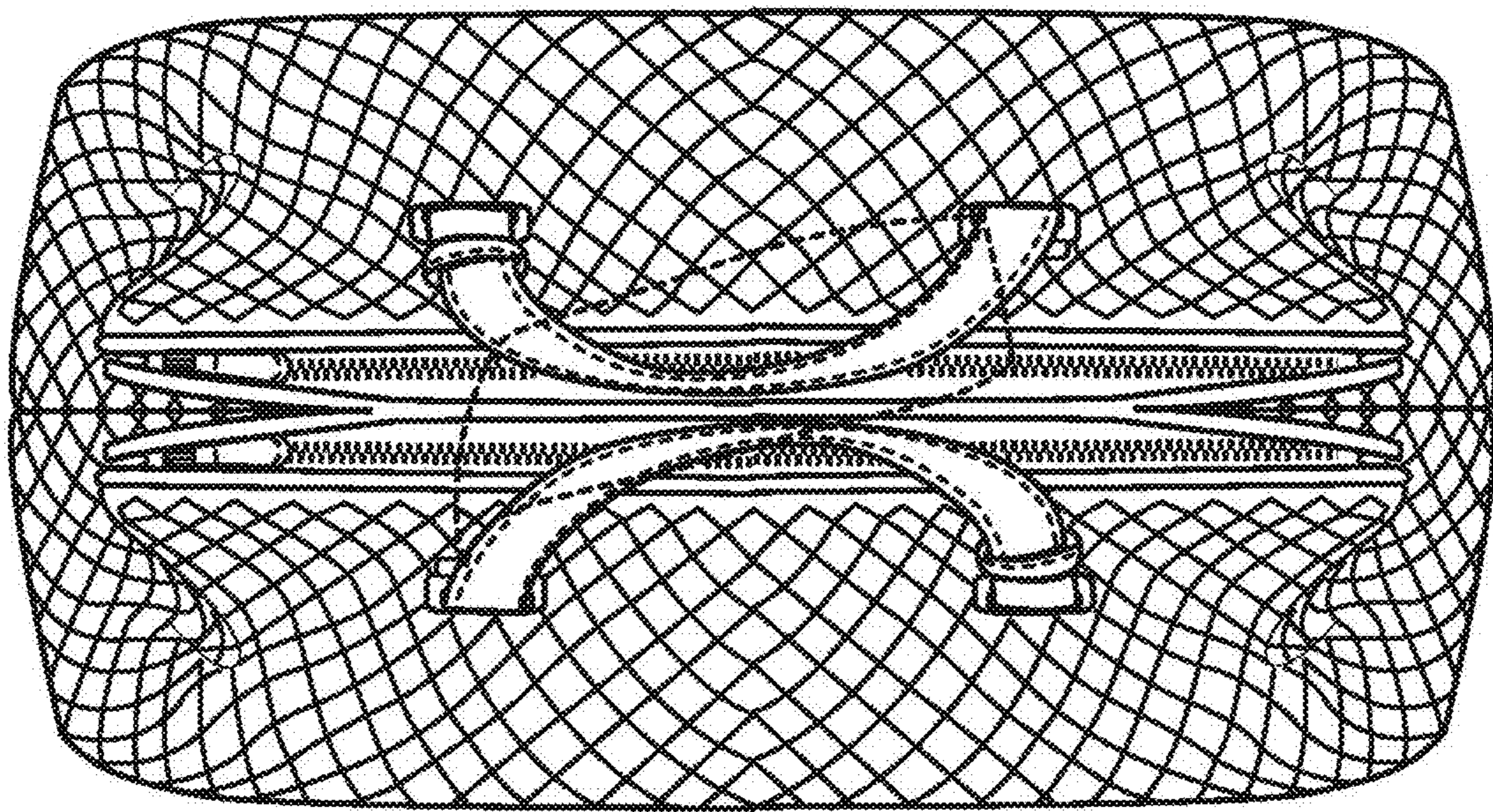

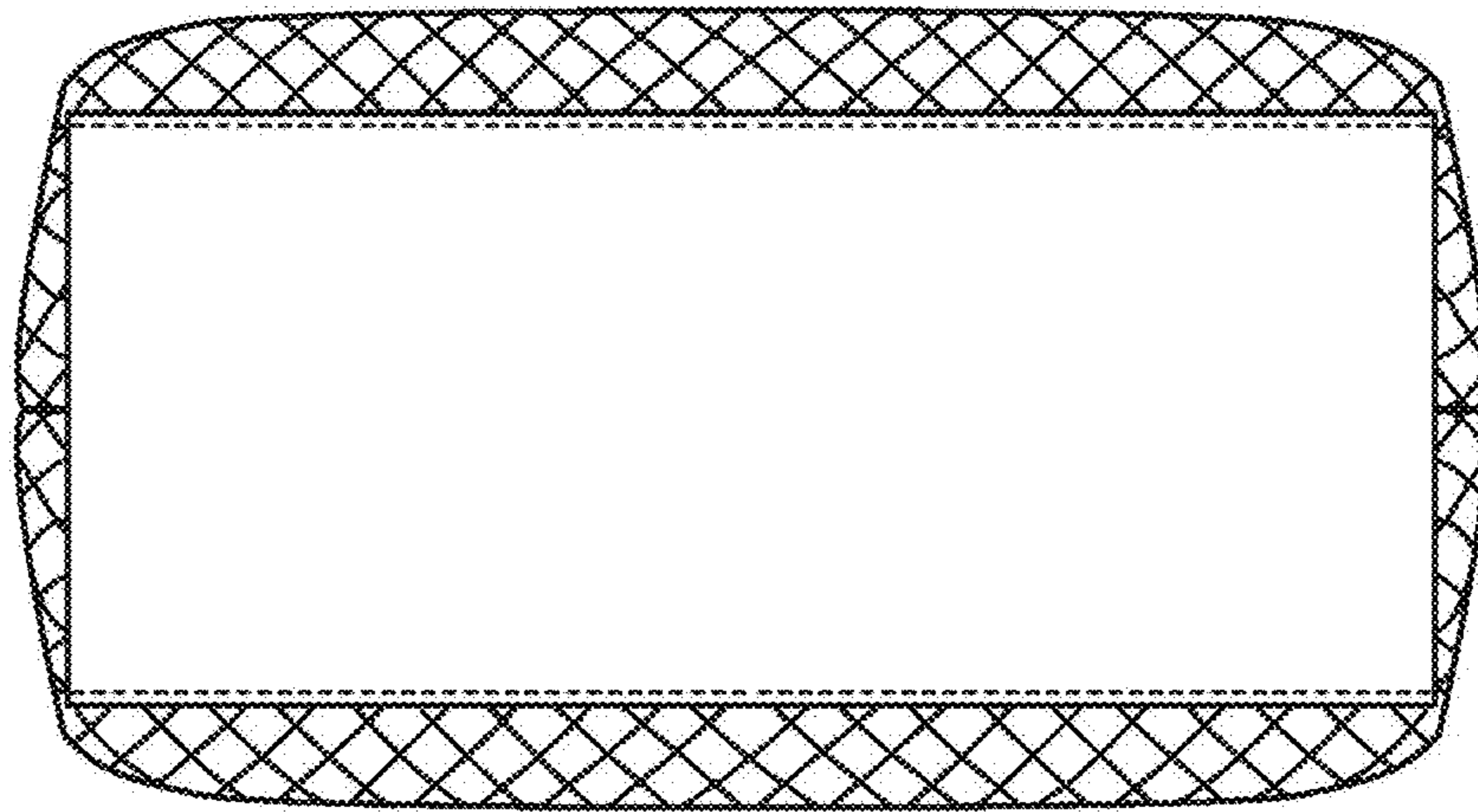
