(57) **CLAIM**

The ornamental design for a jack mounted storage box, as shown and described.

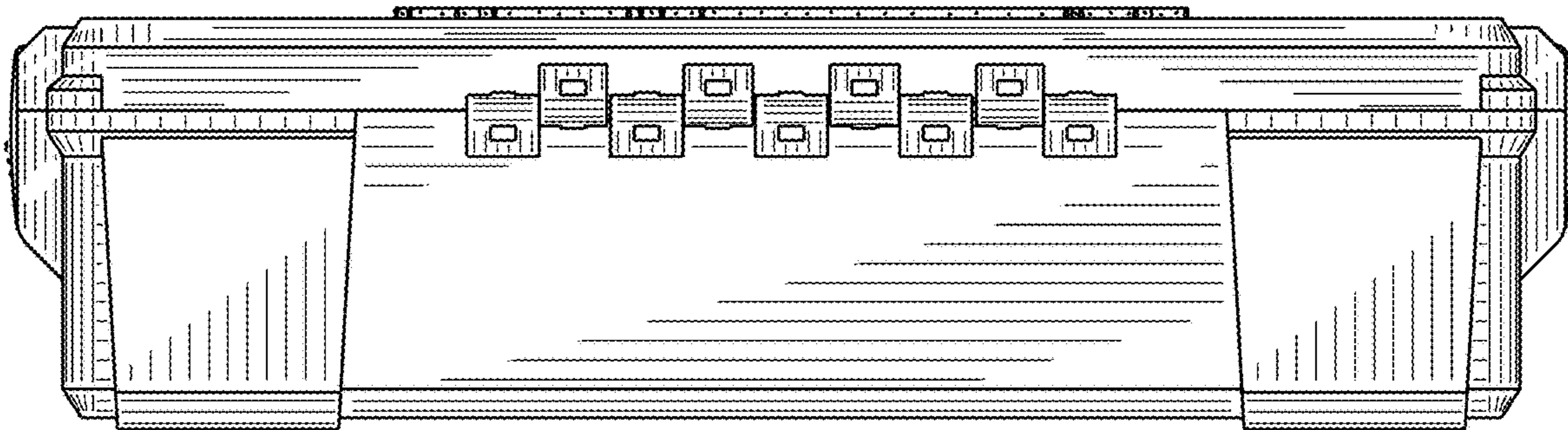
DESCRIPTION

FIG. 1 is a top plan view of the jack mounted storage box; FIG. 2 is a left side elevation view of the jack mounted storage box; FIG. 3 is a right side elevation view of the jack mounted storage box; FIG. 4 is a bottom plan view of the jack mounted storage box; FIG. 5 is a front side elevation view of the jack mounted storage box; FIG. 6 is a back side elevation view of the jack mounted storage box; and, FIG. 7 is a top side perspective view of the jack mounted storage box.

The registered trademark HI-LIFT and Design® (U.S. Trademark Registration Serial No. 804,605) owned by The Bloomfield Manufacturing Company, Inc. forms part of the claimed design.

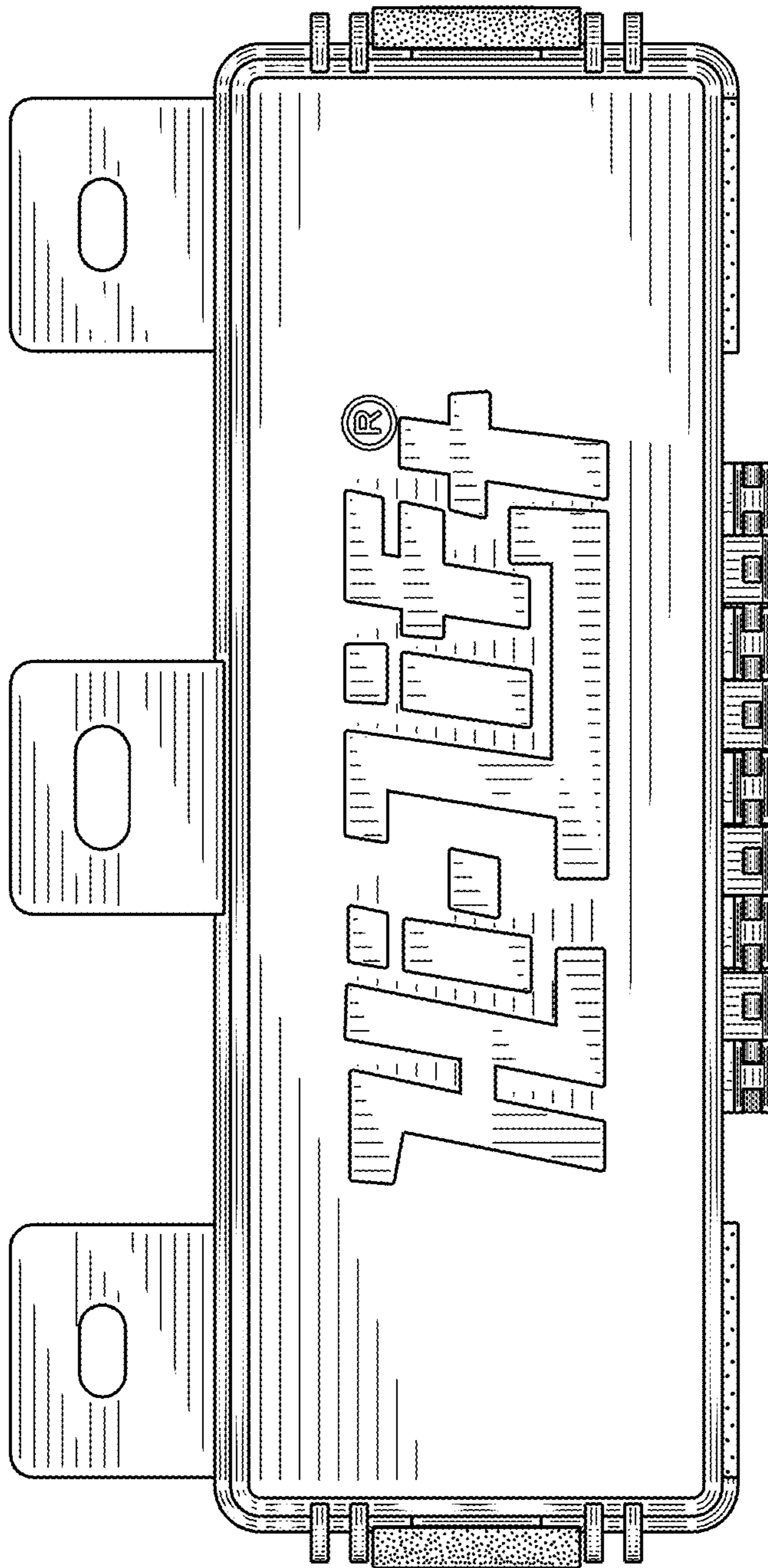

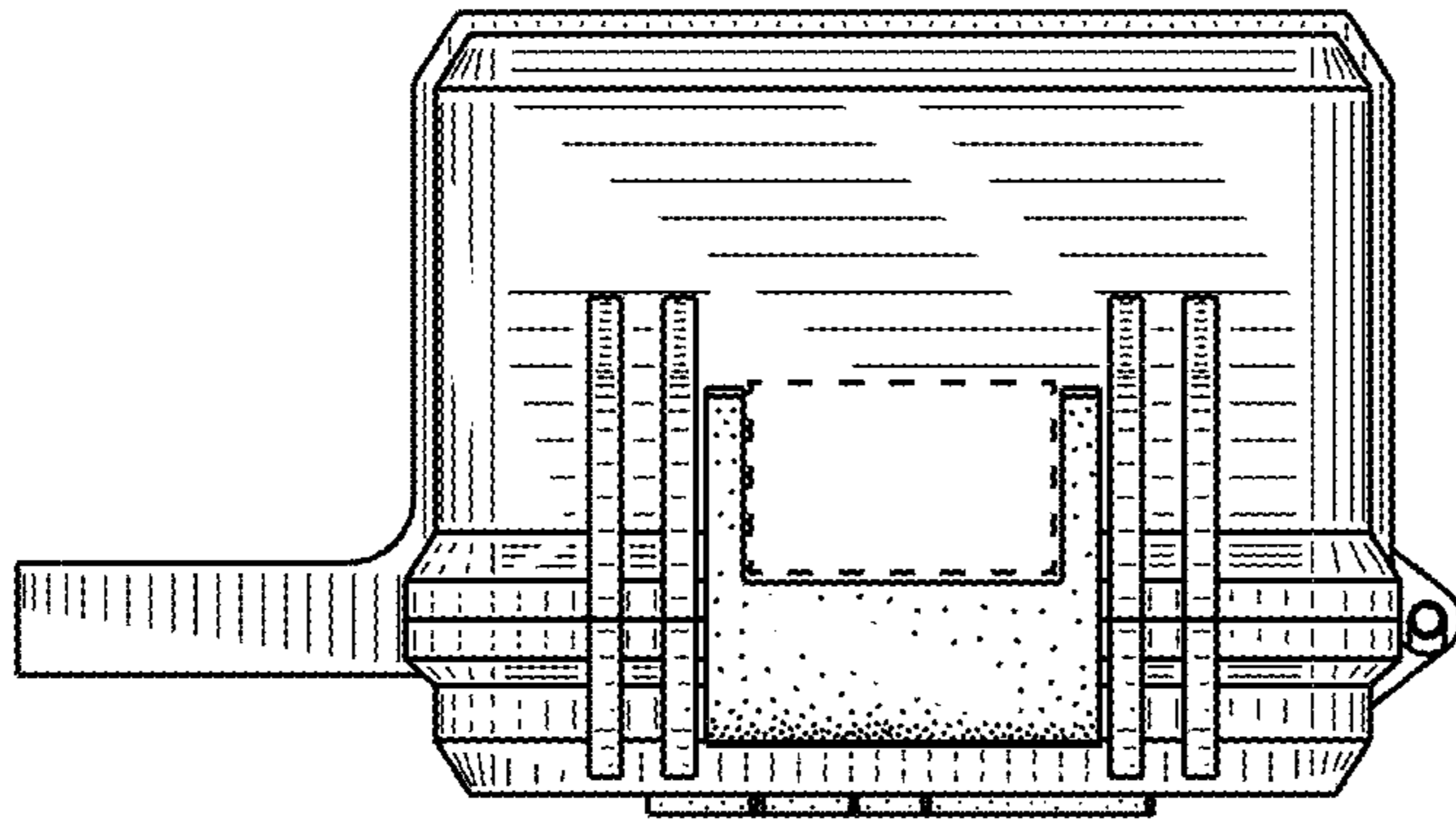

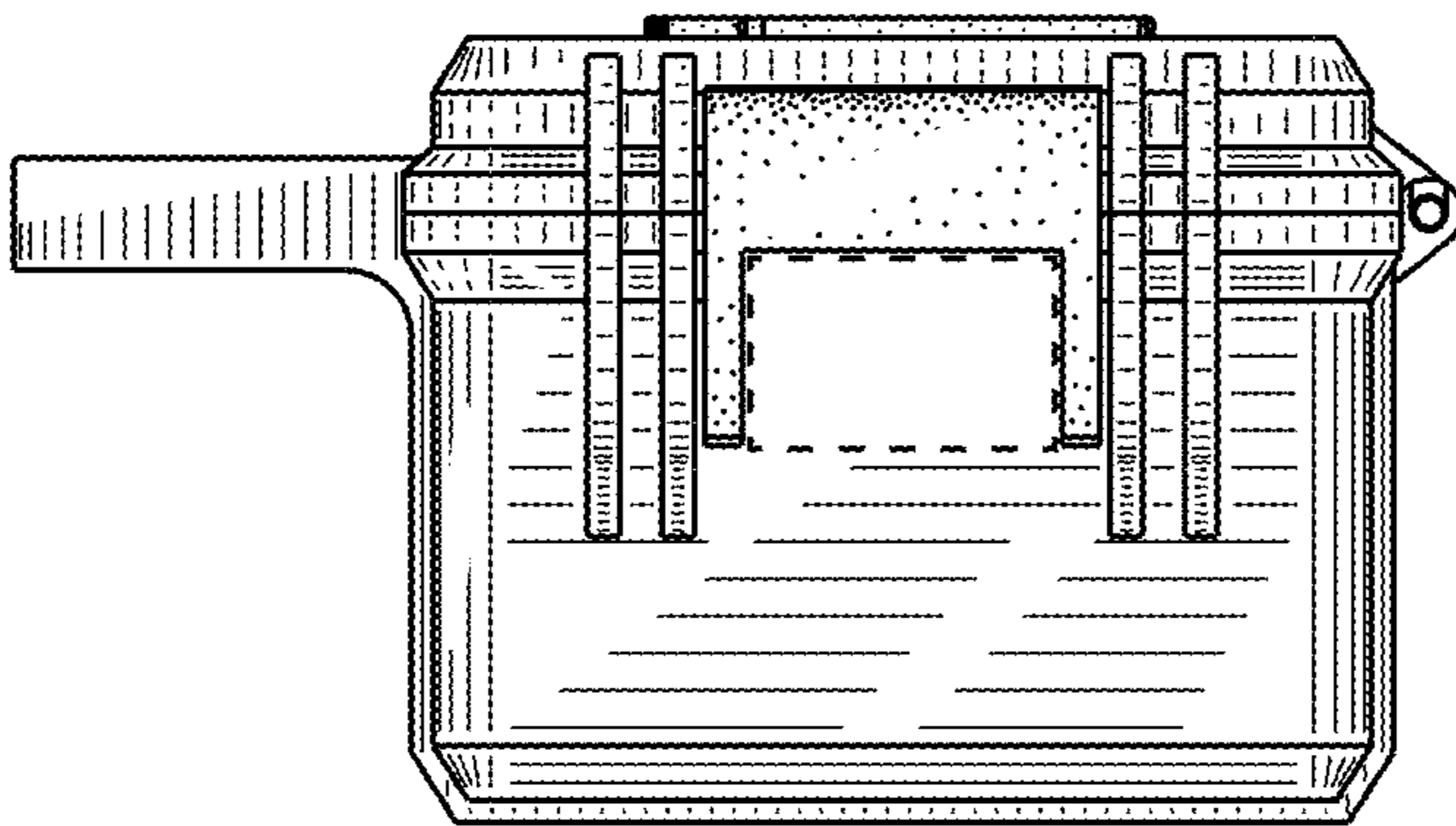

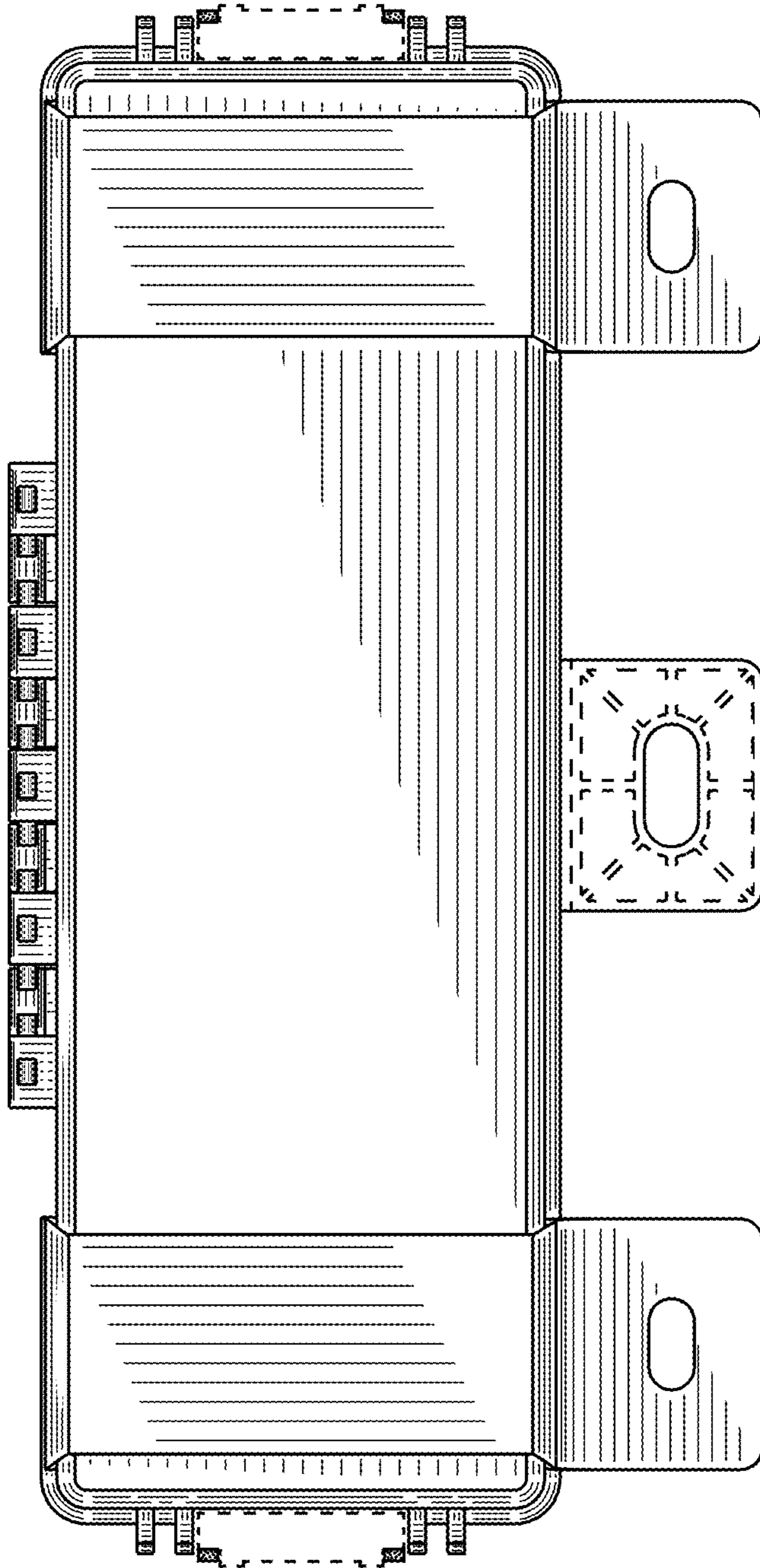

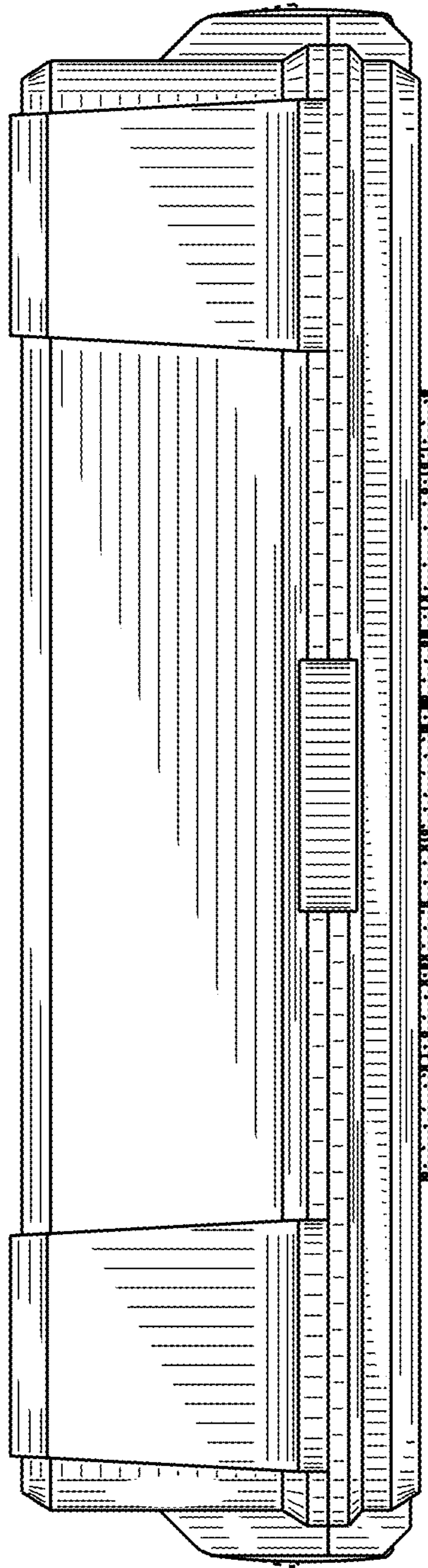

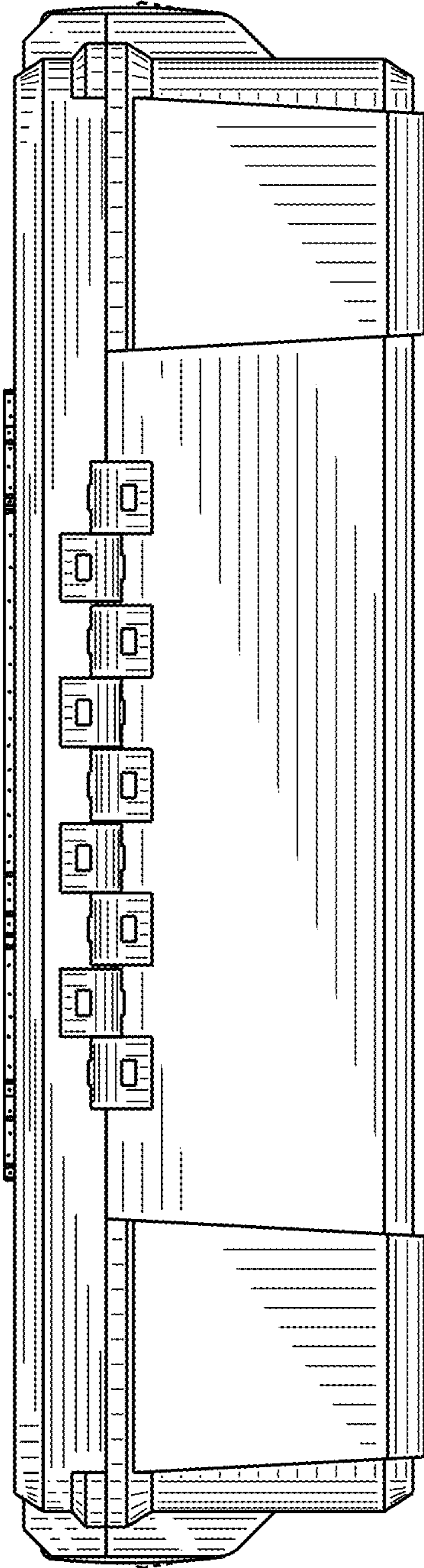

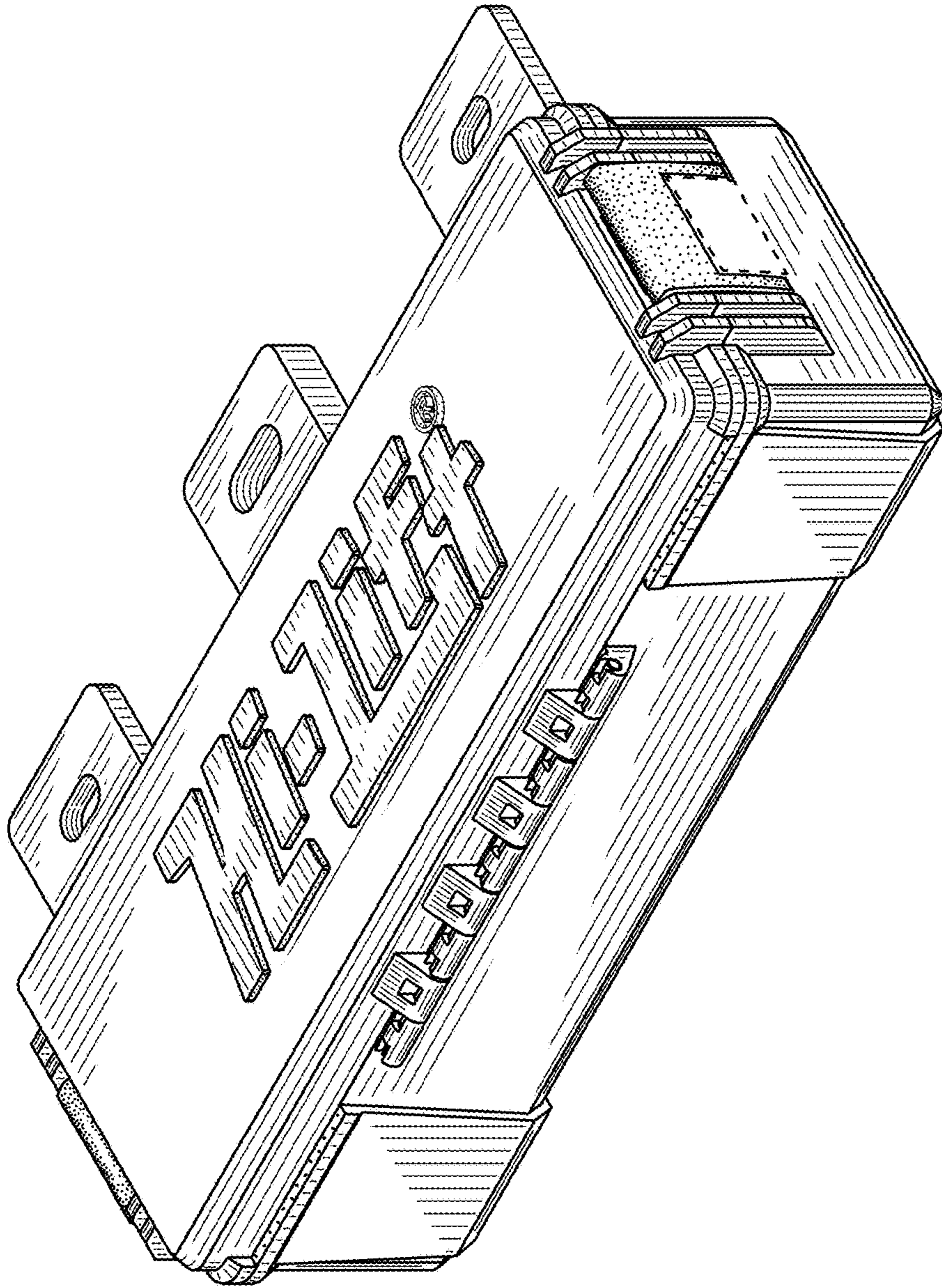
