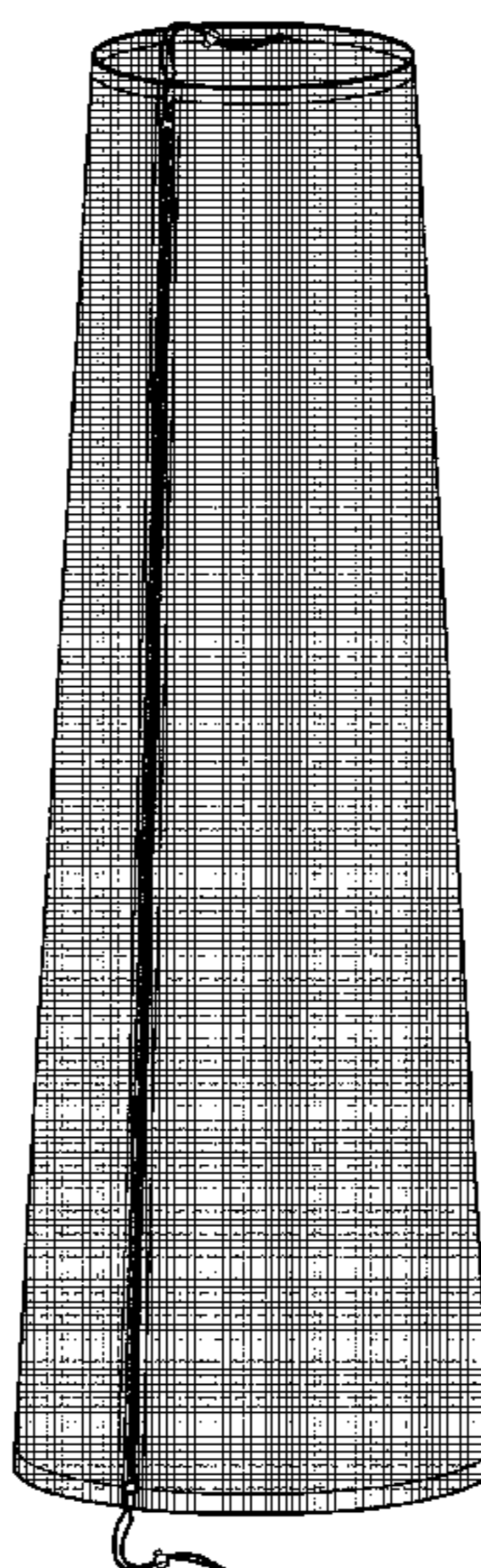
(57) **CLAIM**

The ornamental design for a shrub cover, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of the subject design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is right side elevational view thereof; FIG. 5 is rear elevational view thereof; FIG. 6 is top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a front perspective view of the subject design shown deployed on a shrub. The shrub cover is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

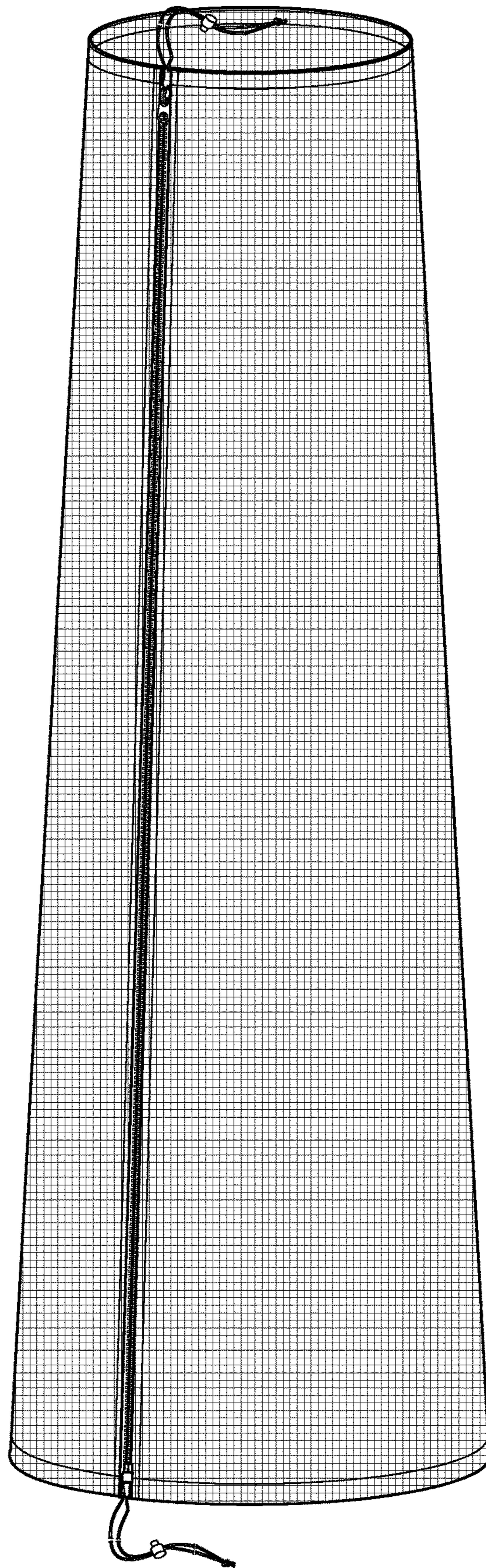

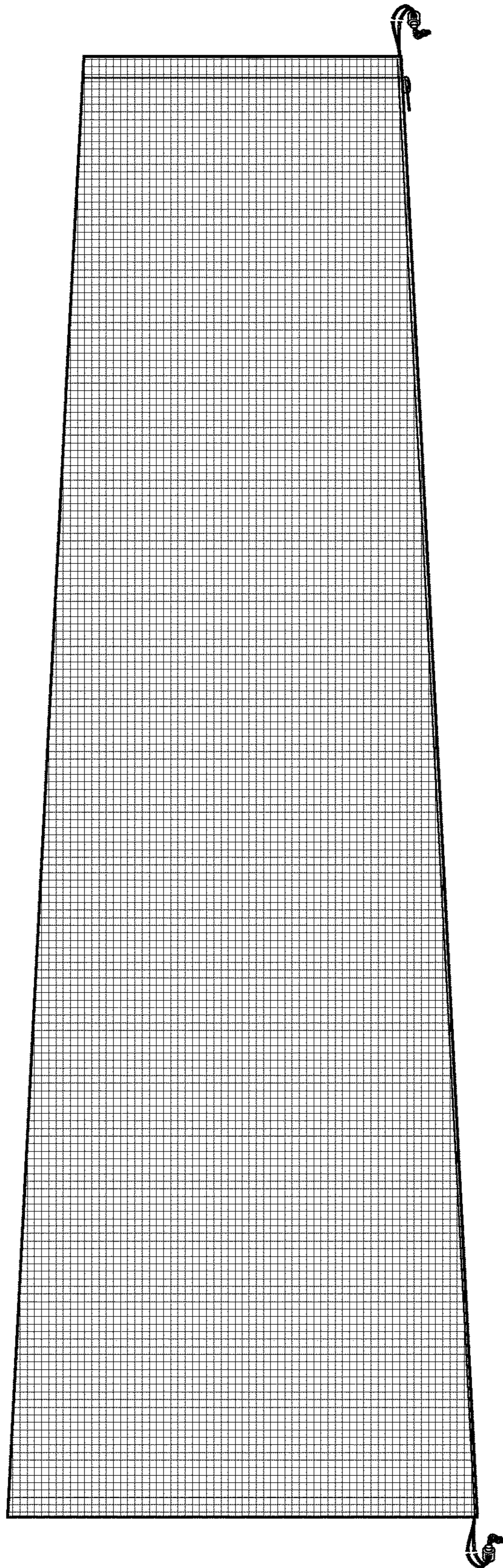

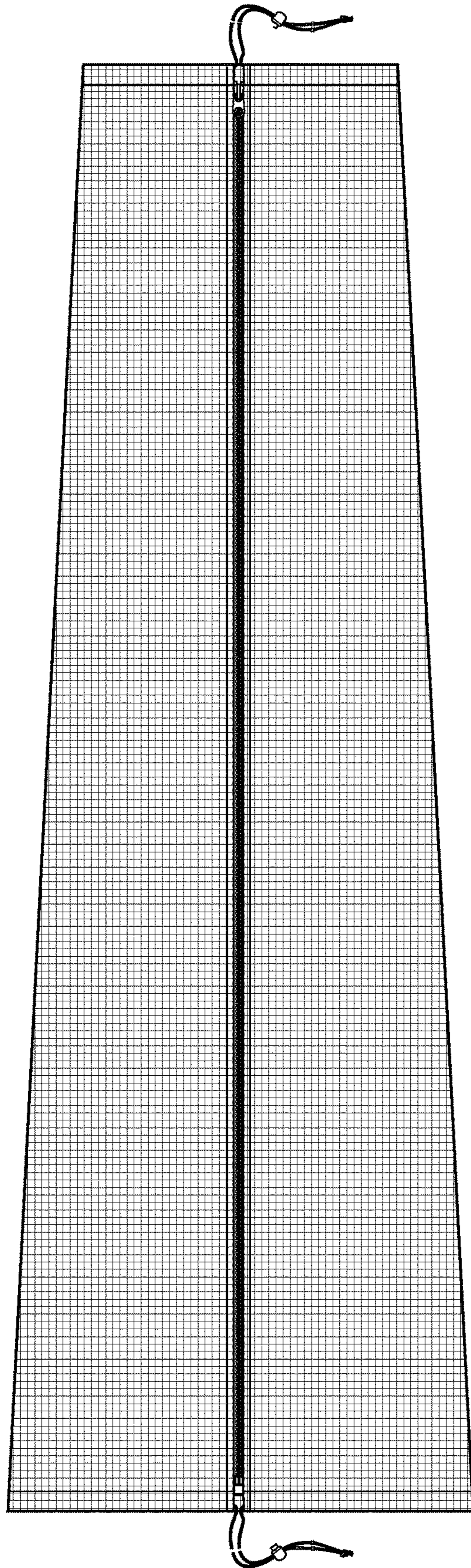

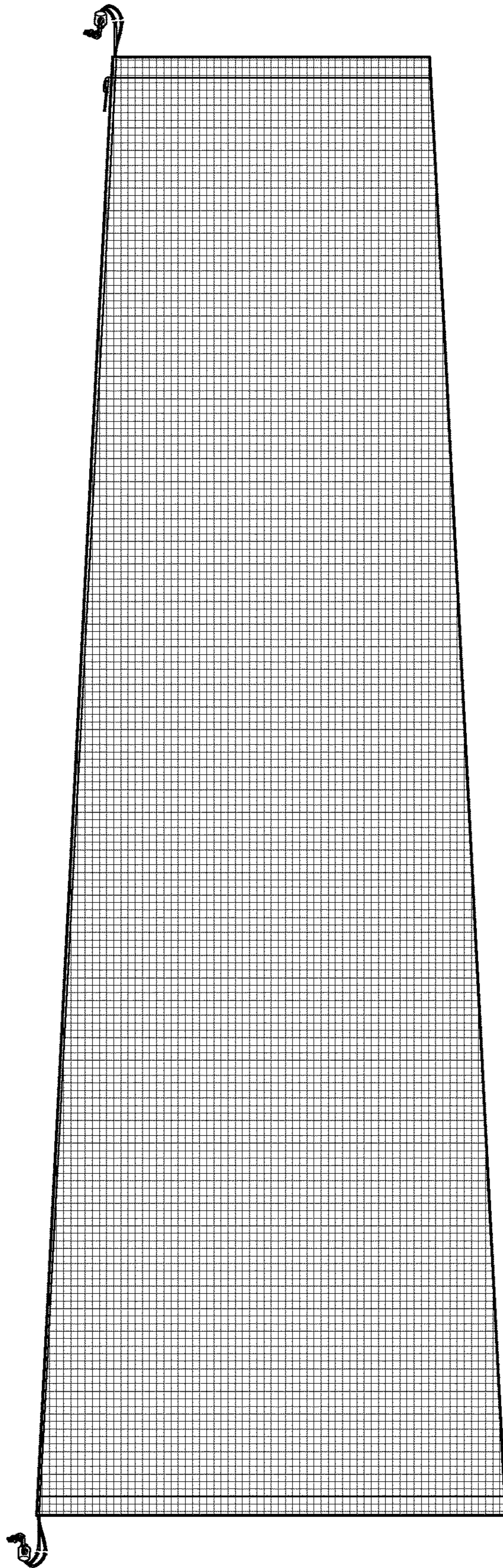

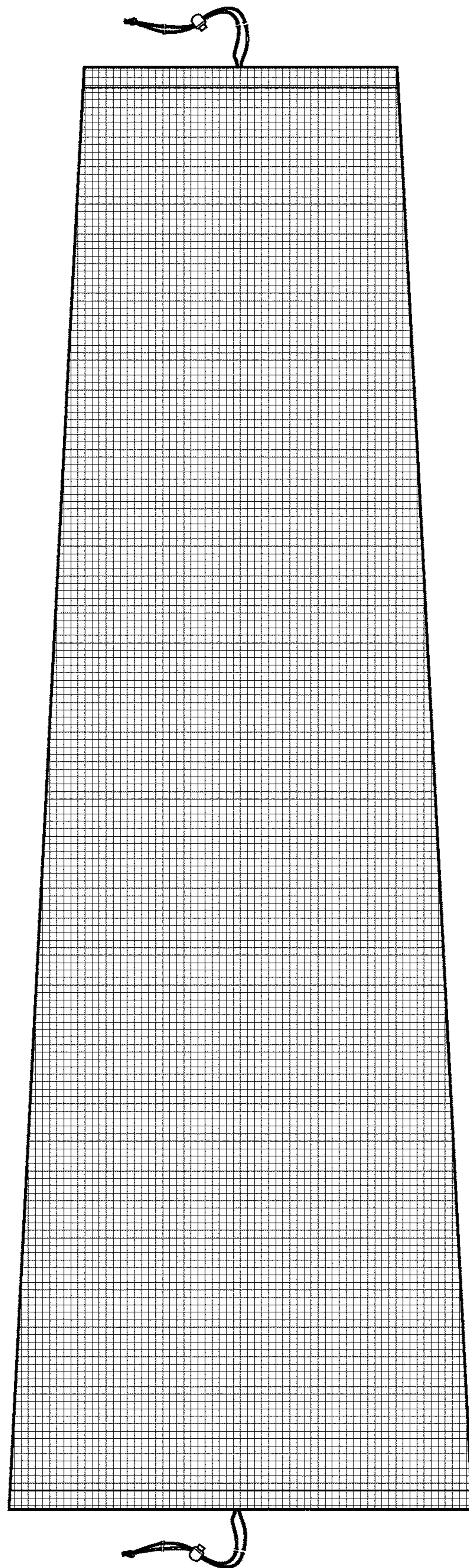

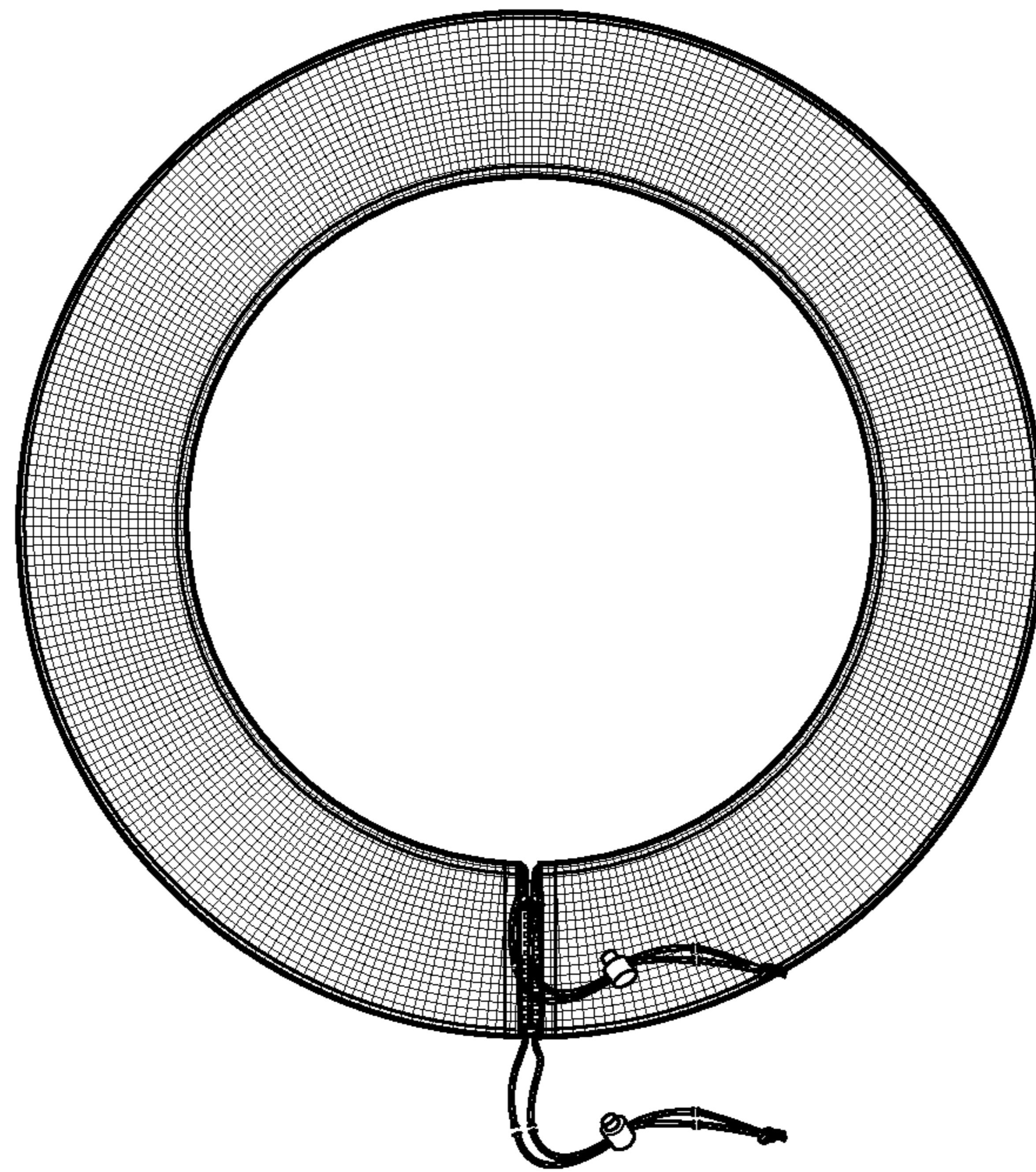

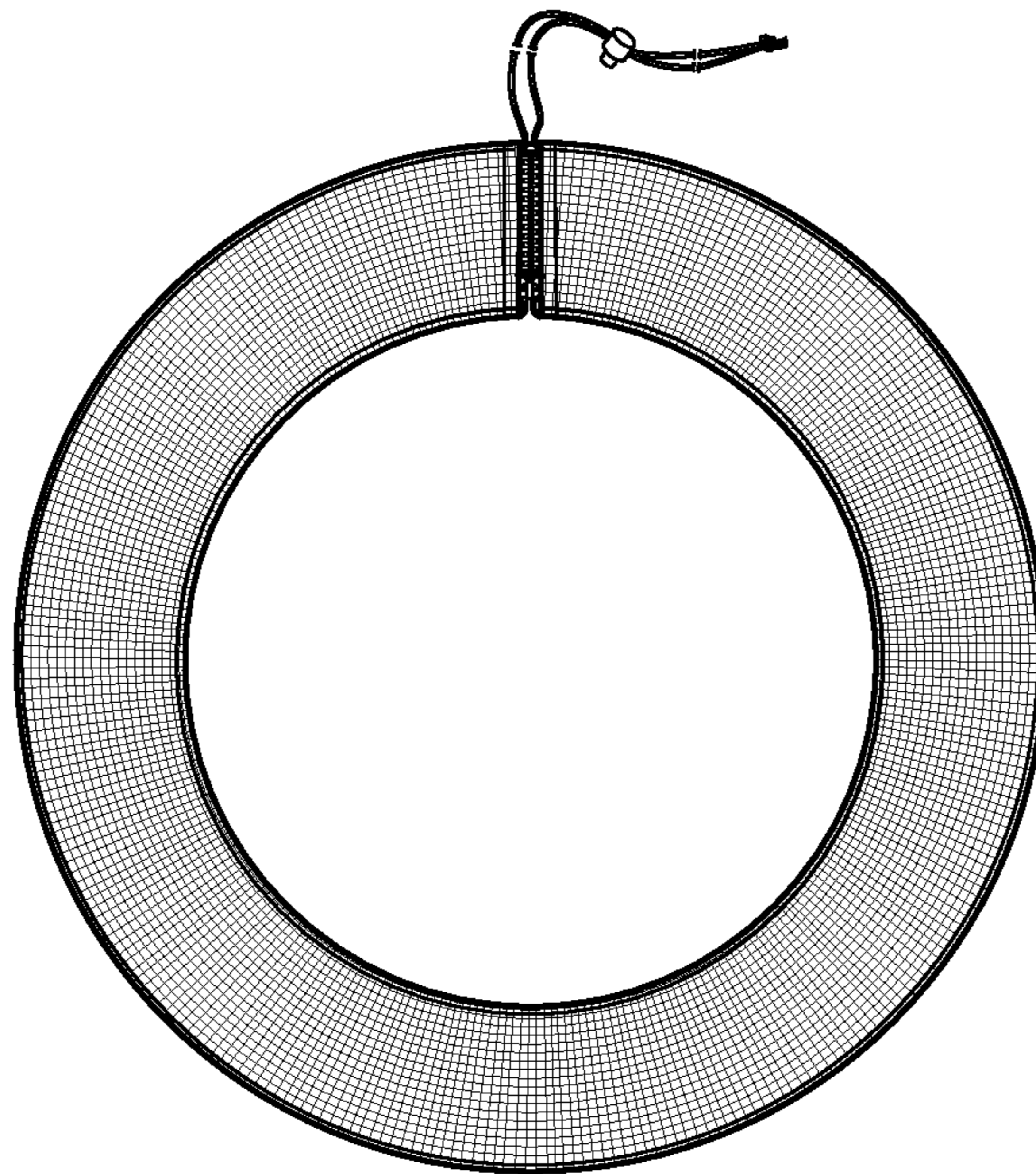

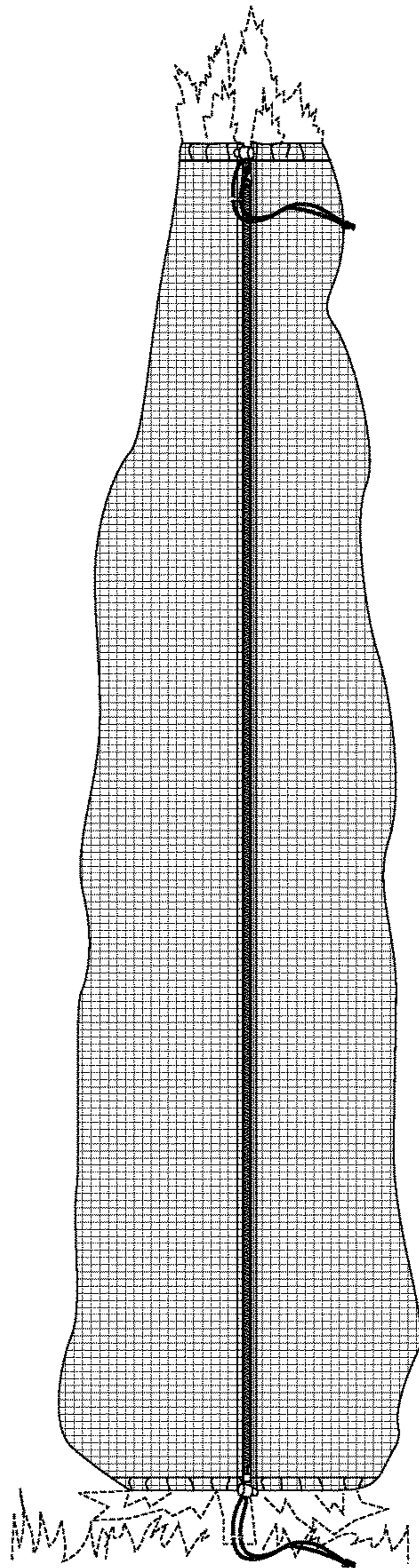
