FIG. 3 is a top view of the watch of FIG. 1 with the dial at a third position.

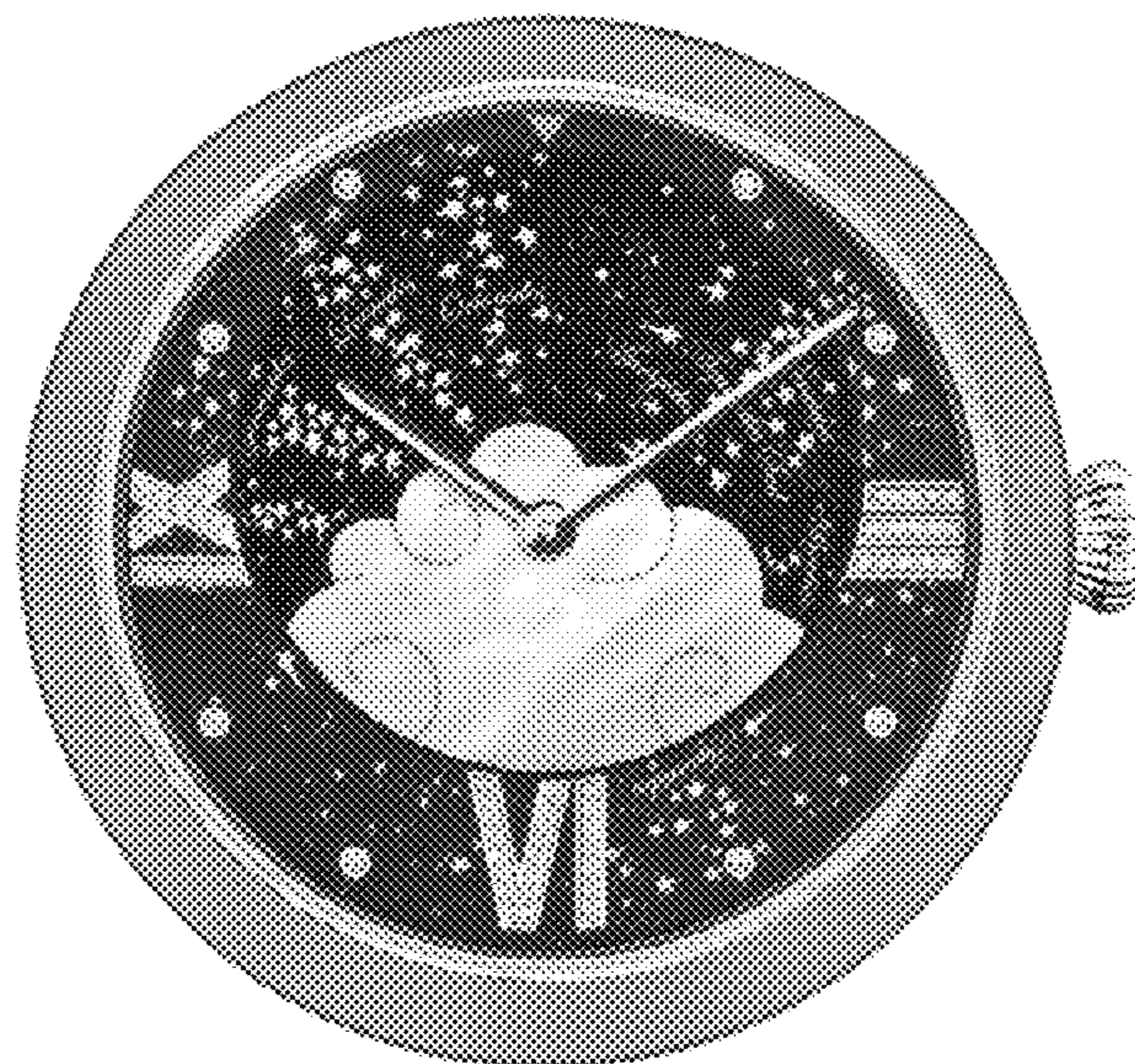
FIG. 4 is a top view of the watch of FIG. 1 with the dial at a fourth position.

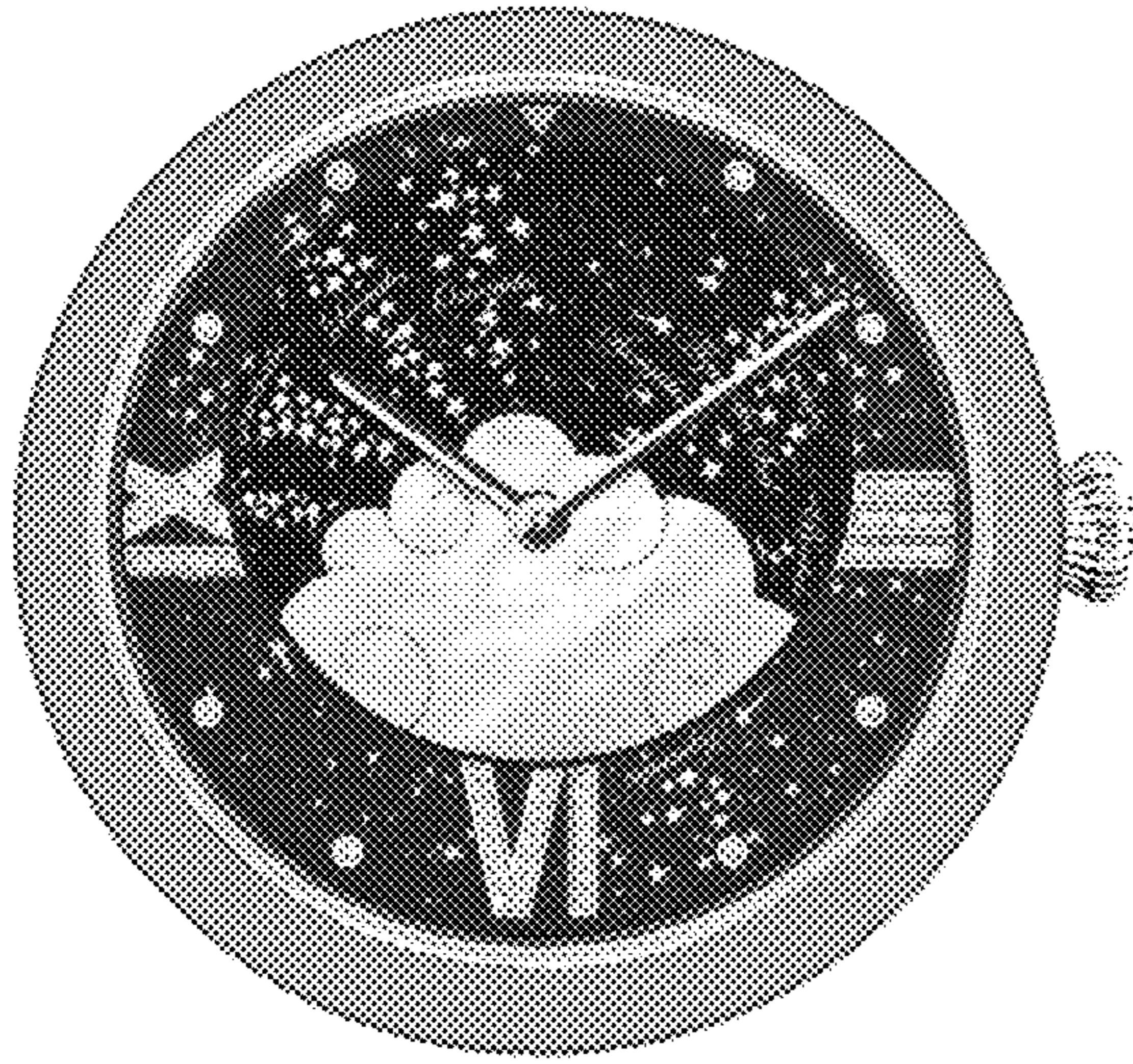

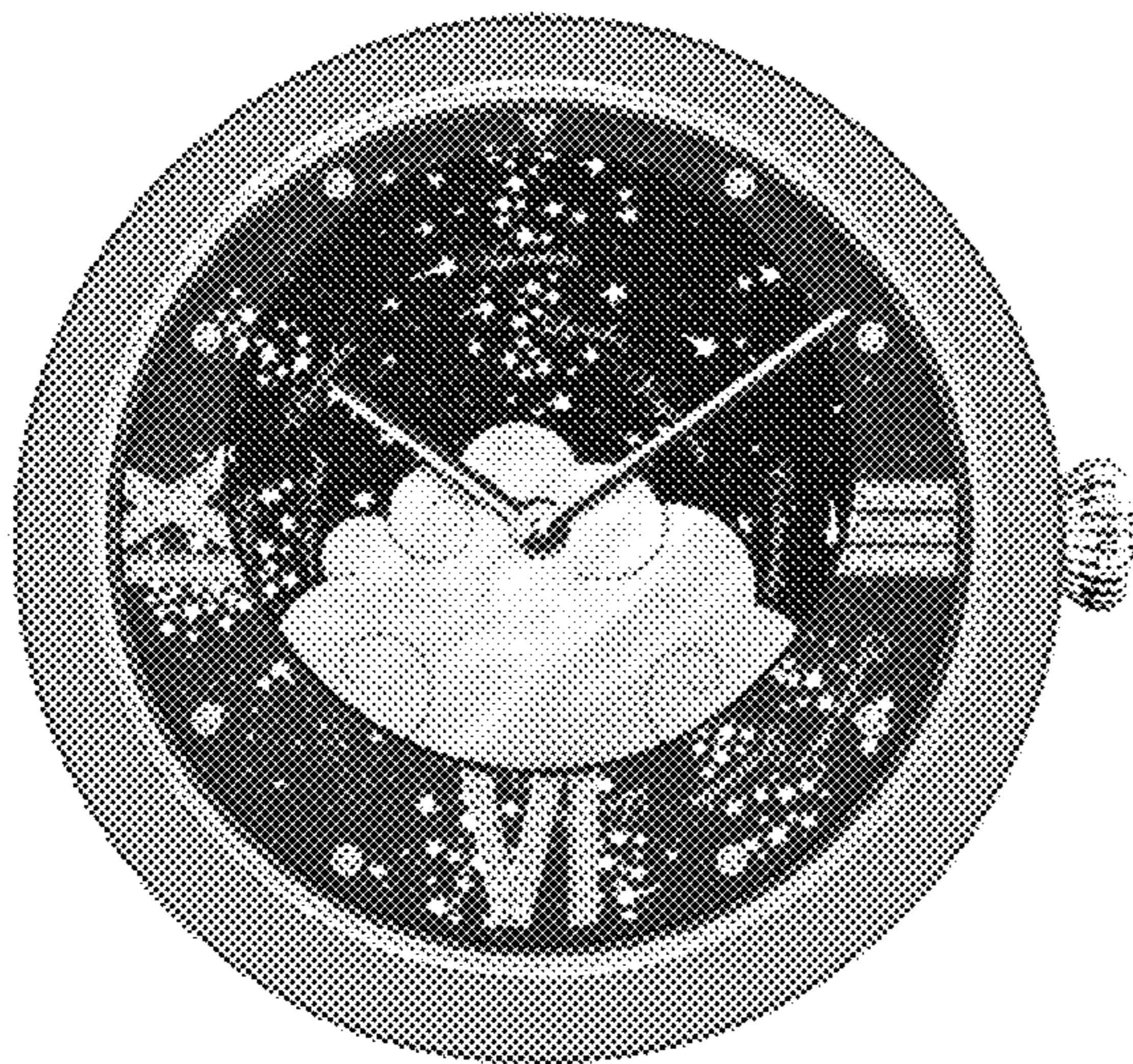

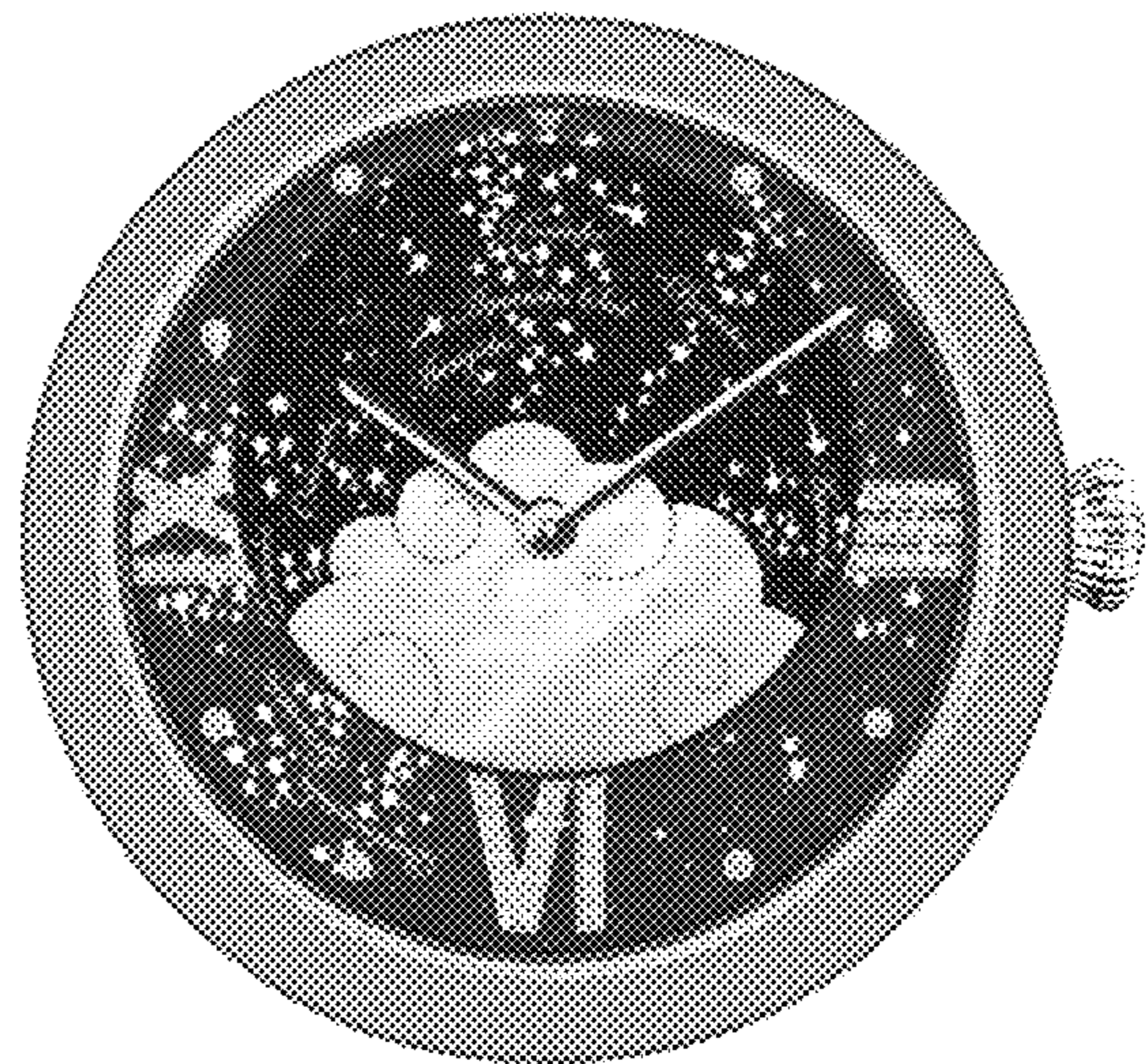

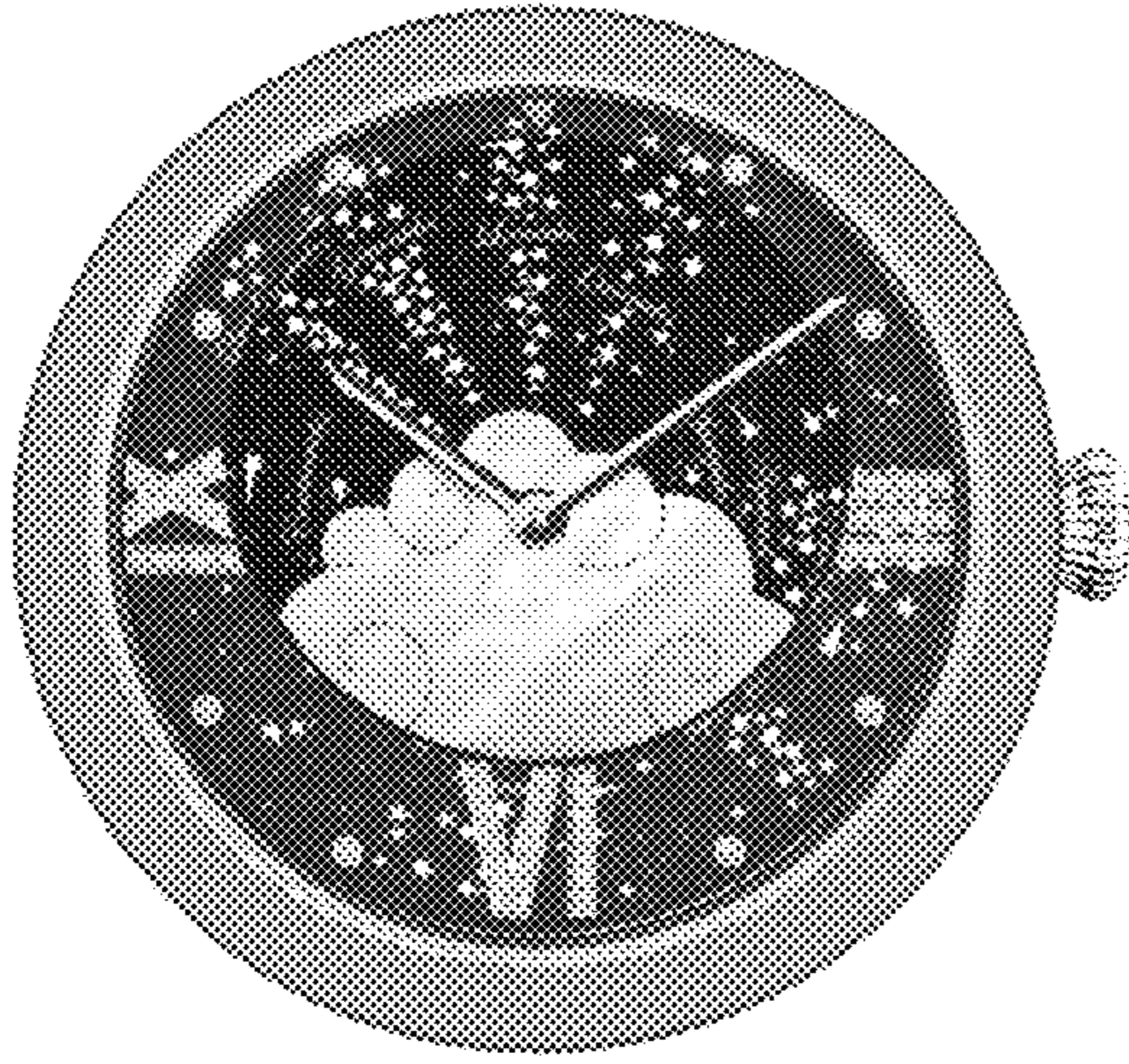

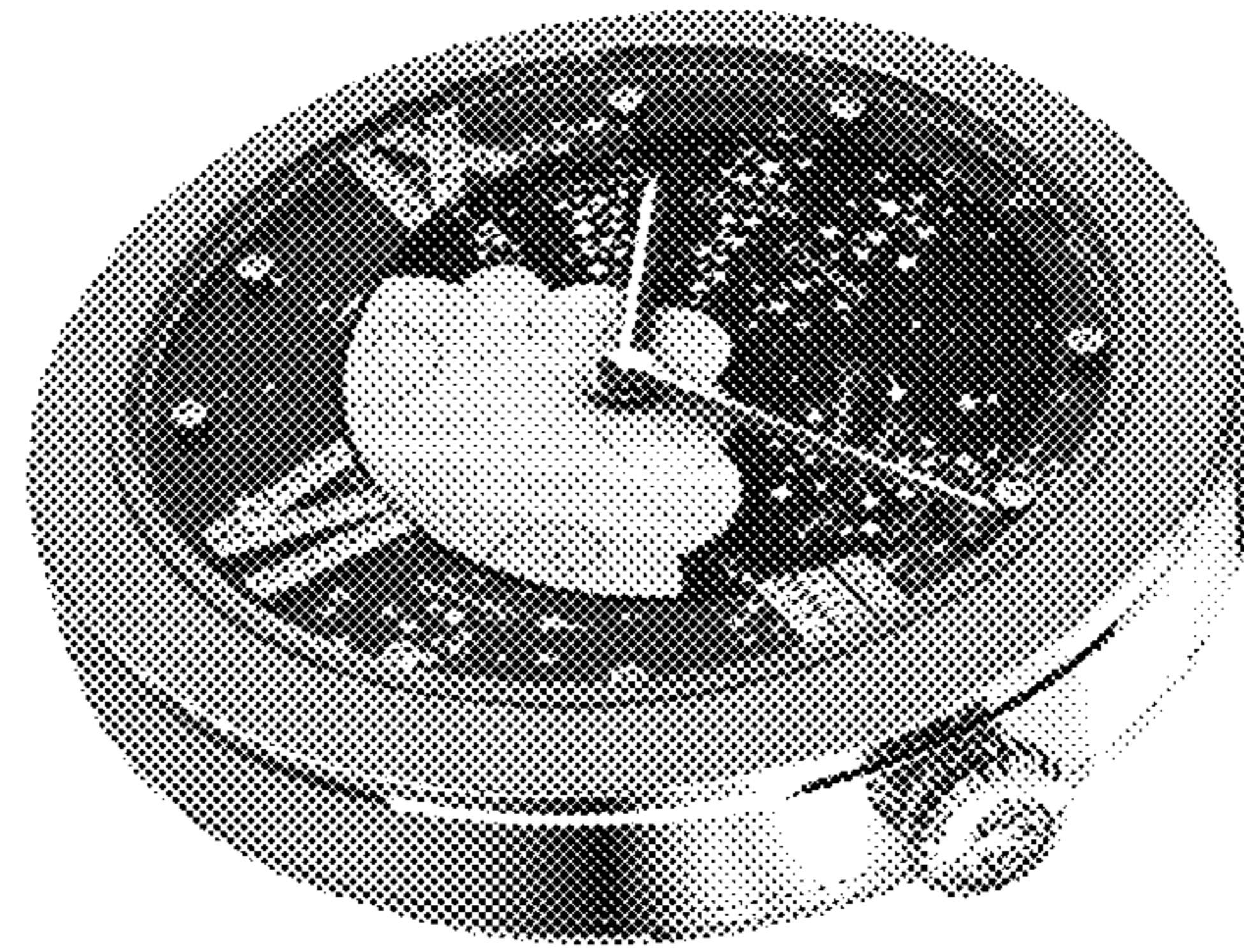

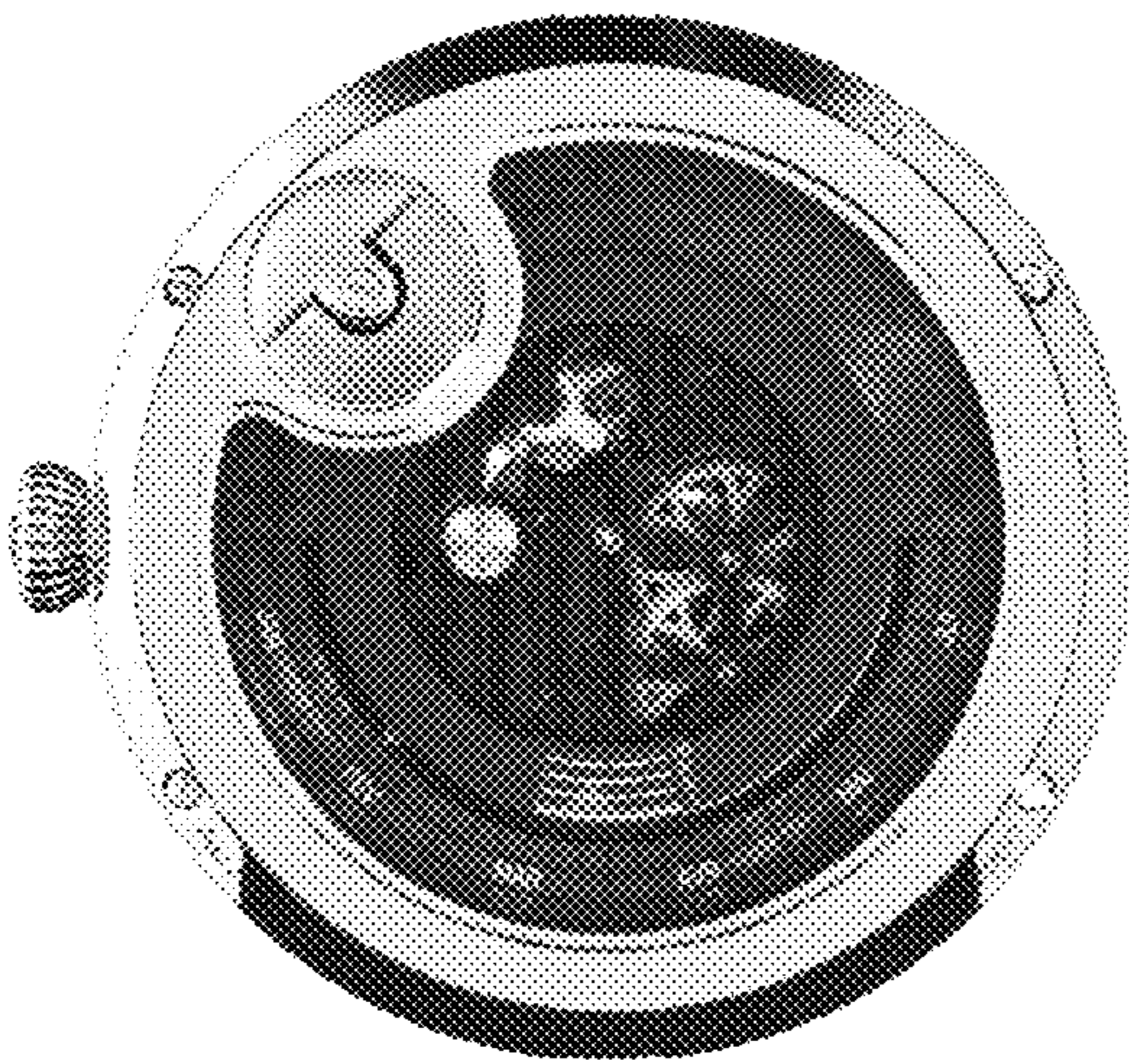
